(57) **CLAIM**

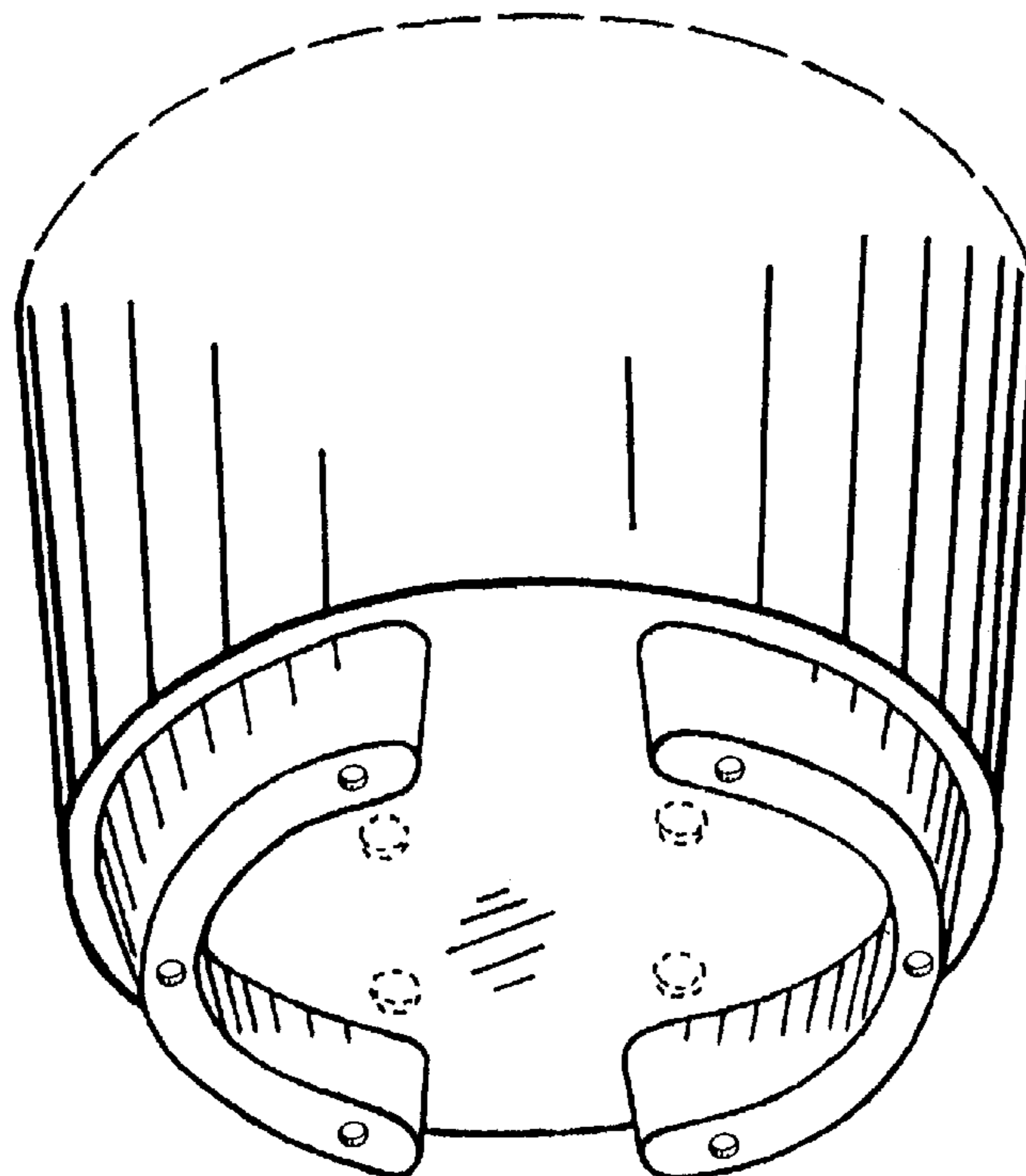
The ornamental design for a two arc leg plant pot, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a two arc leg plant pot shown from the side and bottom;
FIG. 2 is a cross-sectional view thereof, taken along line 2—2 of FIG. 4;
FIG. 3 is a right side elevation view thereof, the left side elevation view being identical thereto;
FIG. 4 is a front elevation view thereof, the rear elevation view being identical thereto;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a top plan view thereof.

The broken line showing of environmental structure is for illustrative purposes only and forms no part of the claimed design.

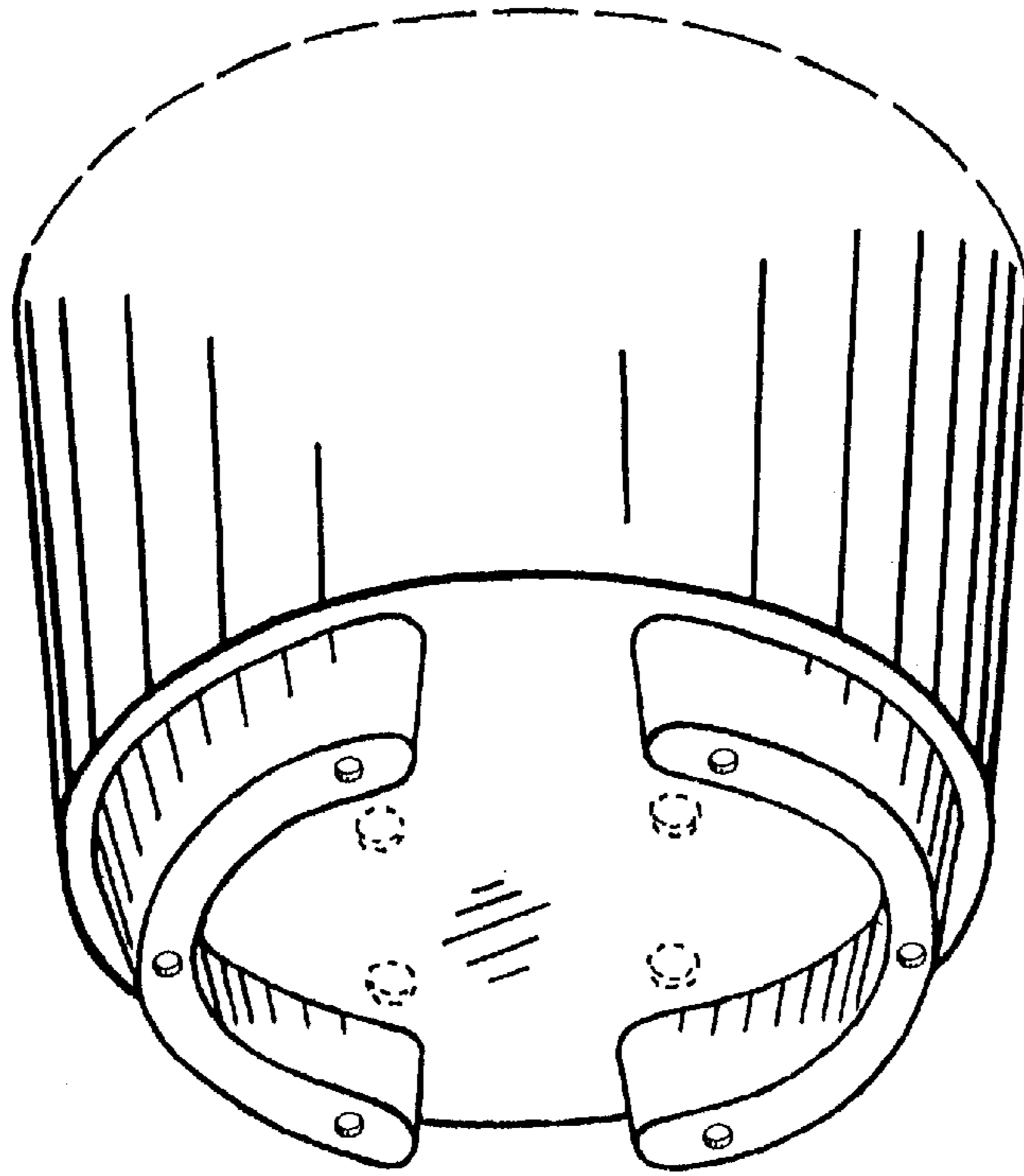

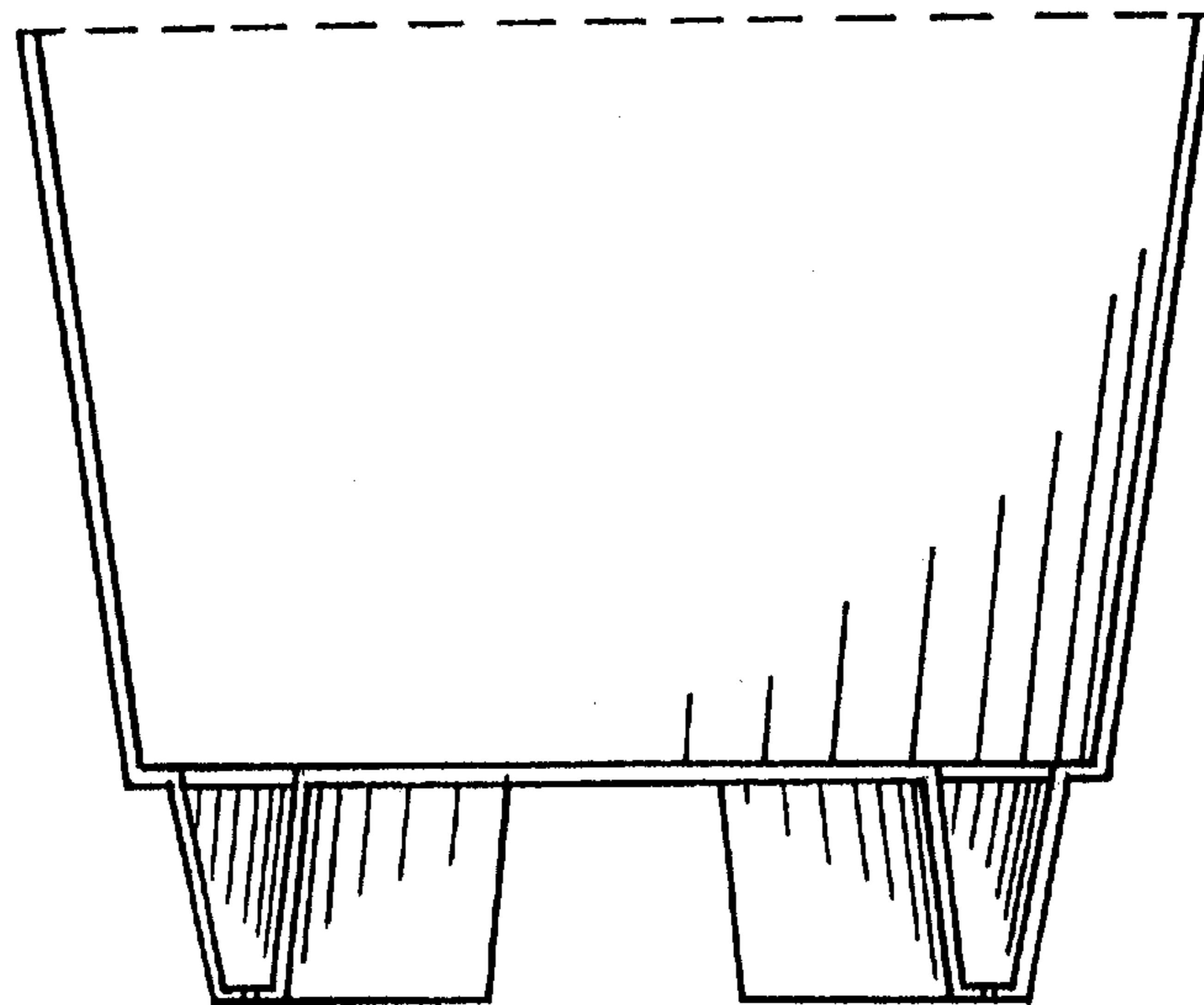

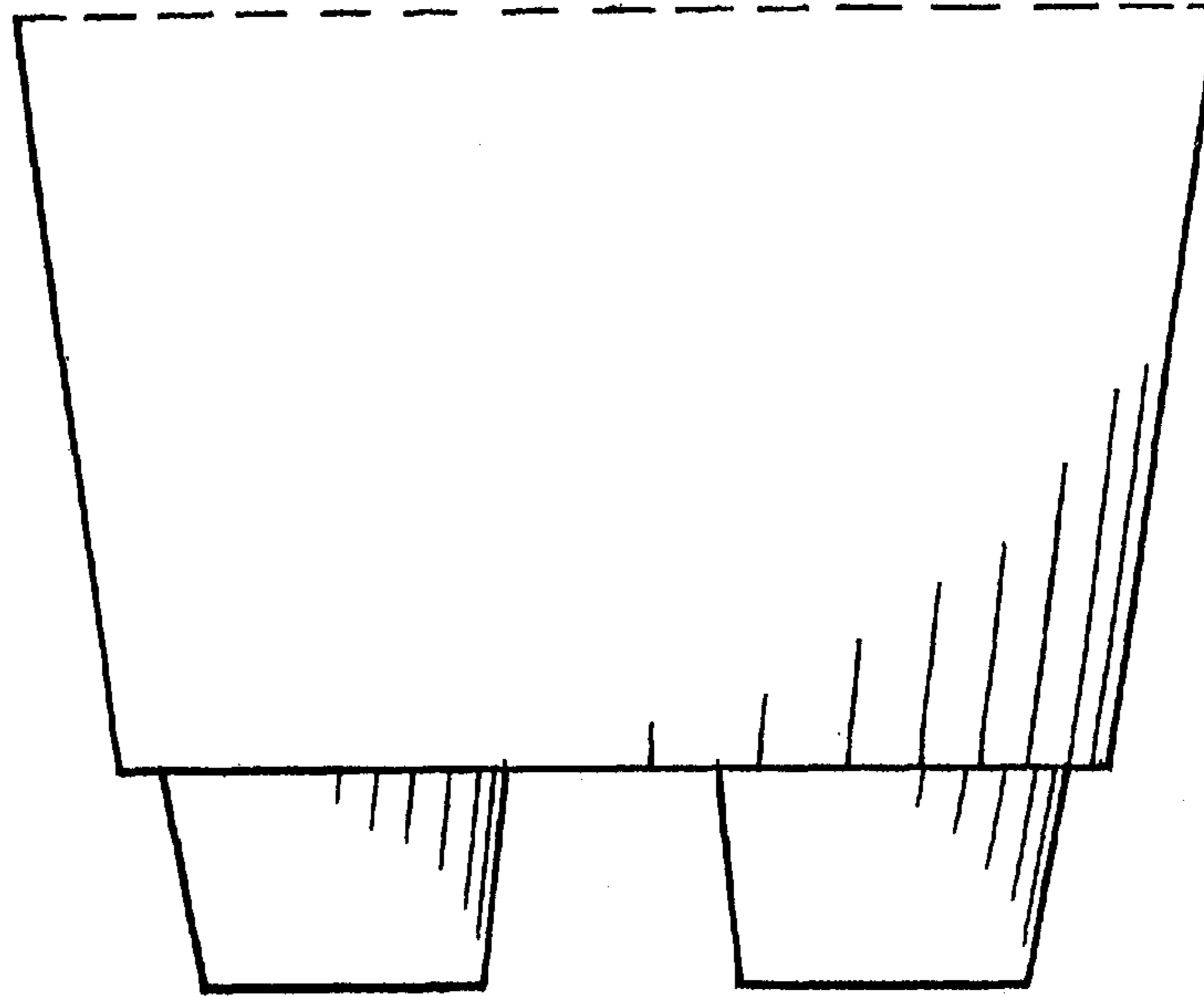

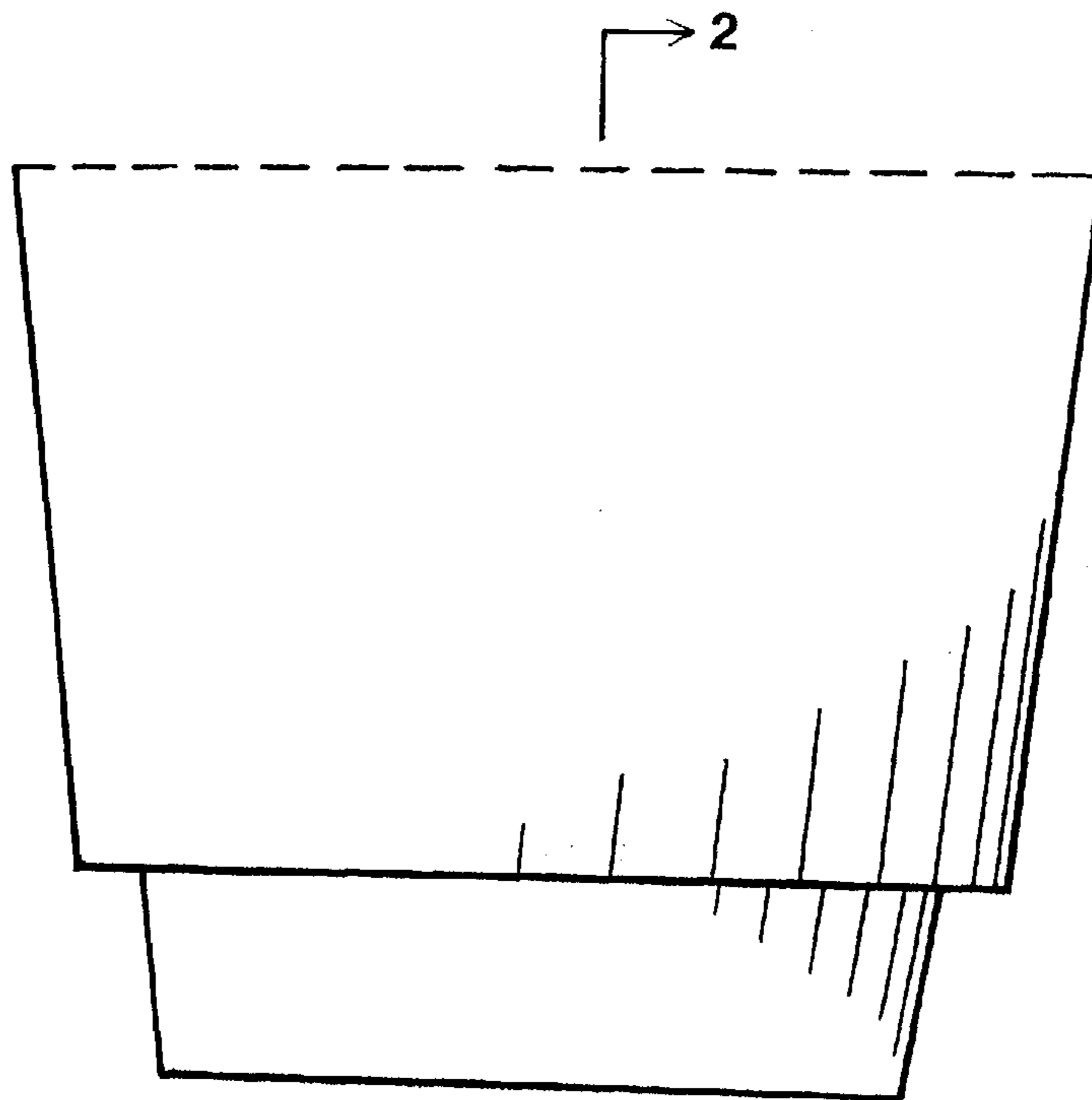

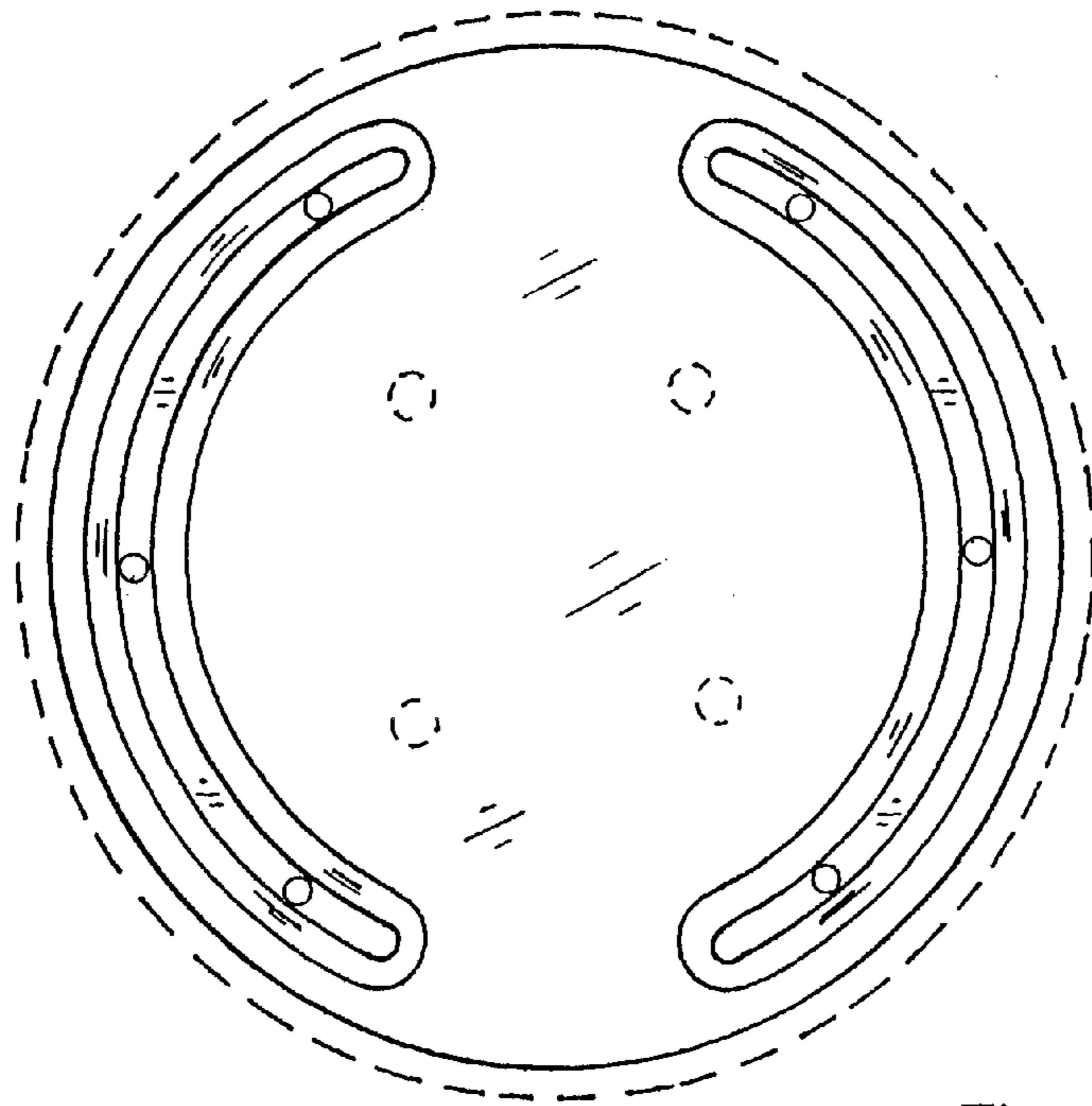

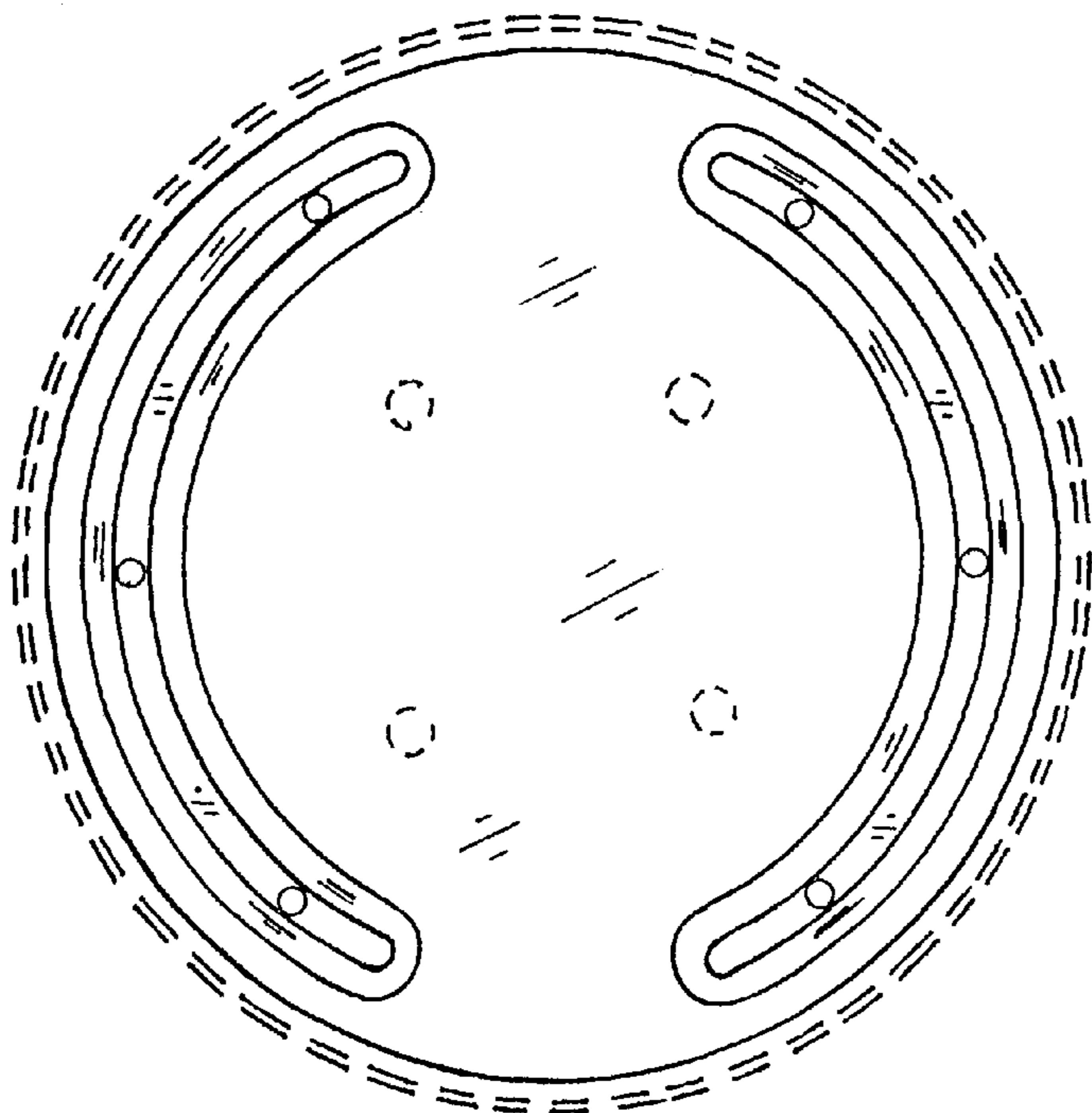
