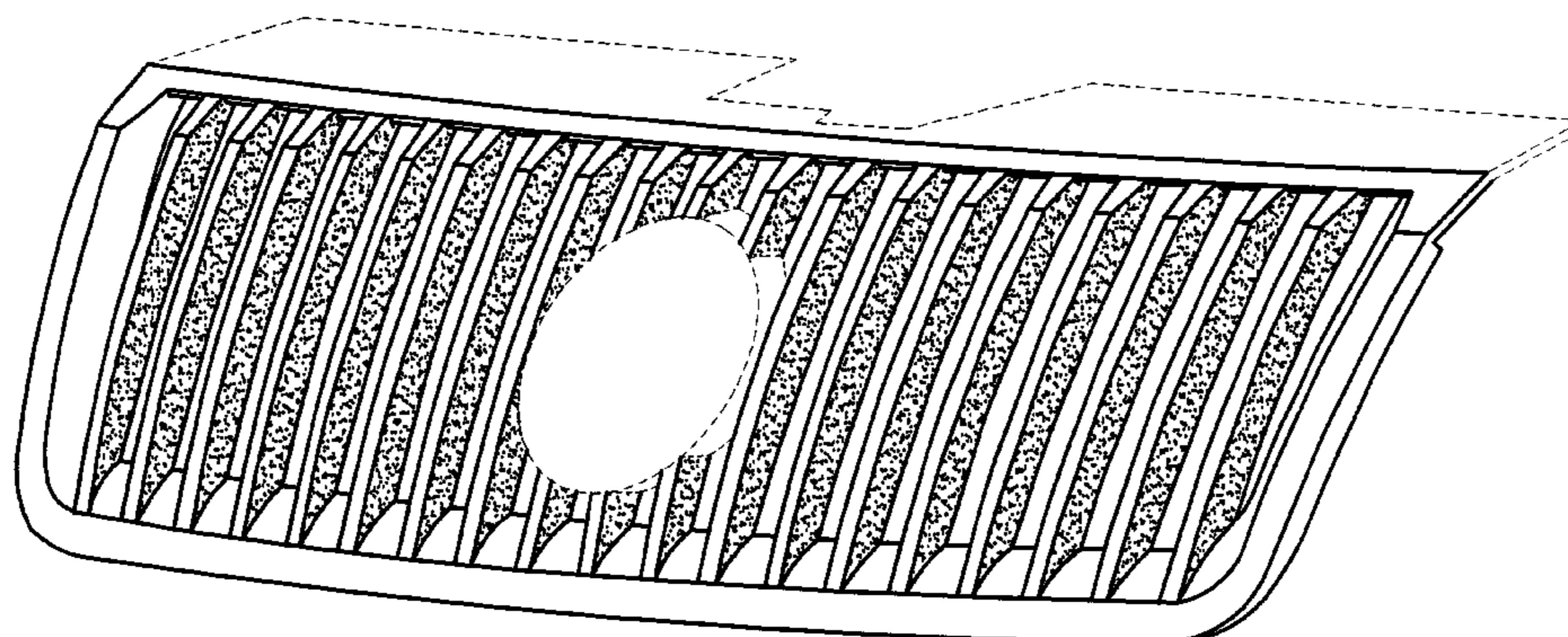
(57) **CLAIM**

The ornamental design for an automobile grille, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an automobile grille attached to a vehicle, no part of the vehicle is claimed; FIG. 2 is a perspective view of the automobile grille; FIG. 3 is a front elevational view of the automobile grille; FIG. 4 is a left side elevational view of the automobile grille (the right side view is a mirror of the left side view and is not shown); and, FIG. 5 is a top plan view of the automobile grille. The broken lines shown throughout the drawing are for illustrative purposes only and form no part of the claimed design.

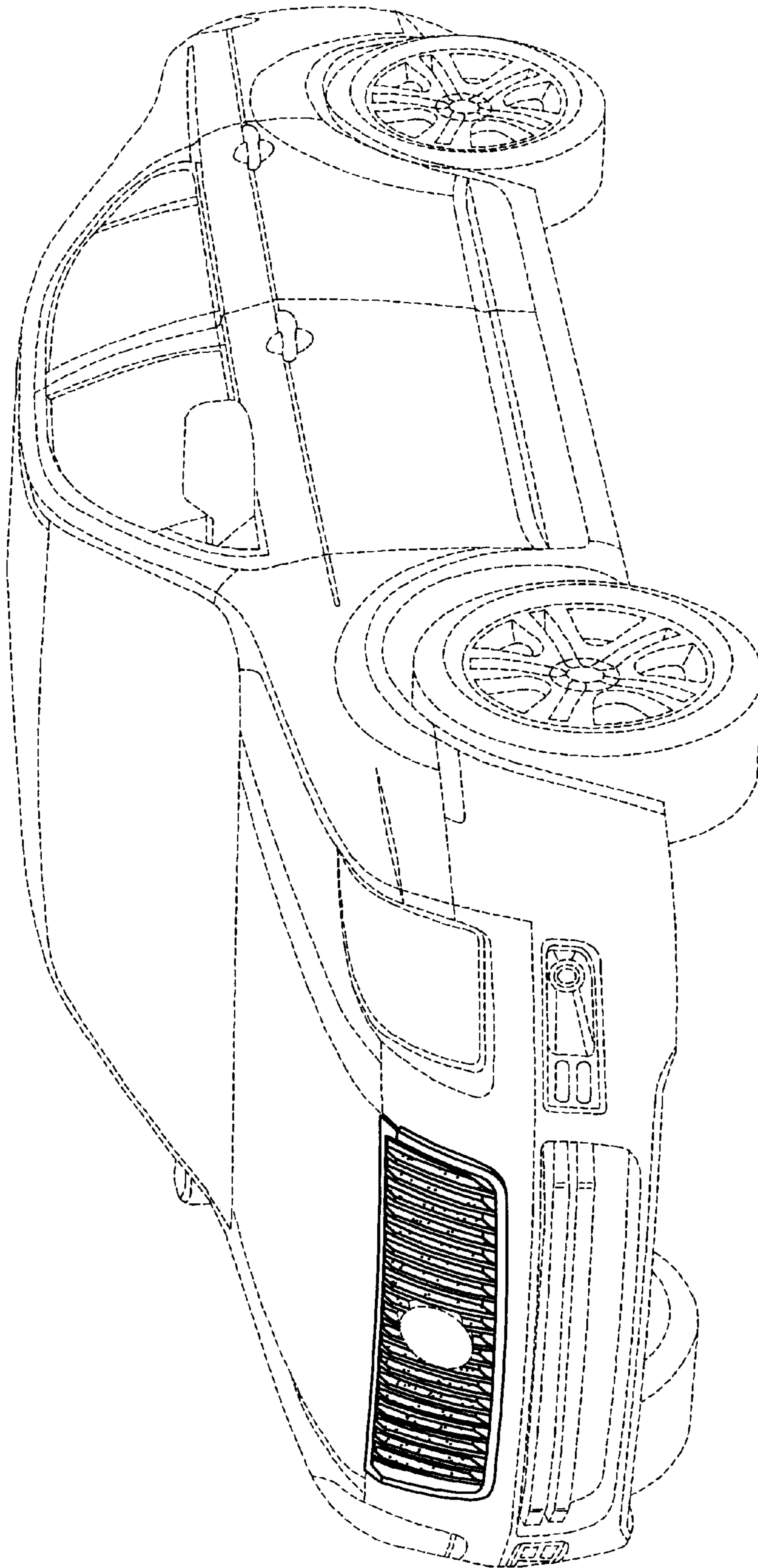

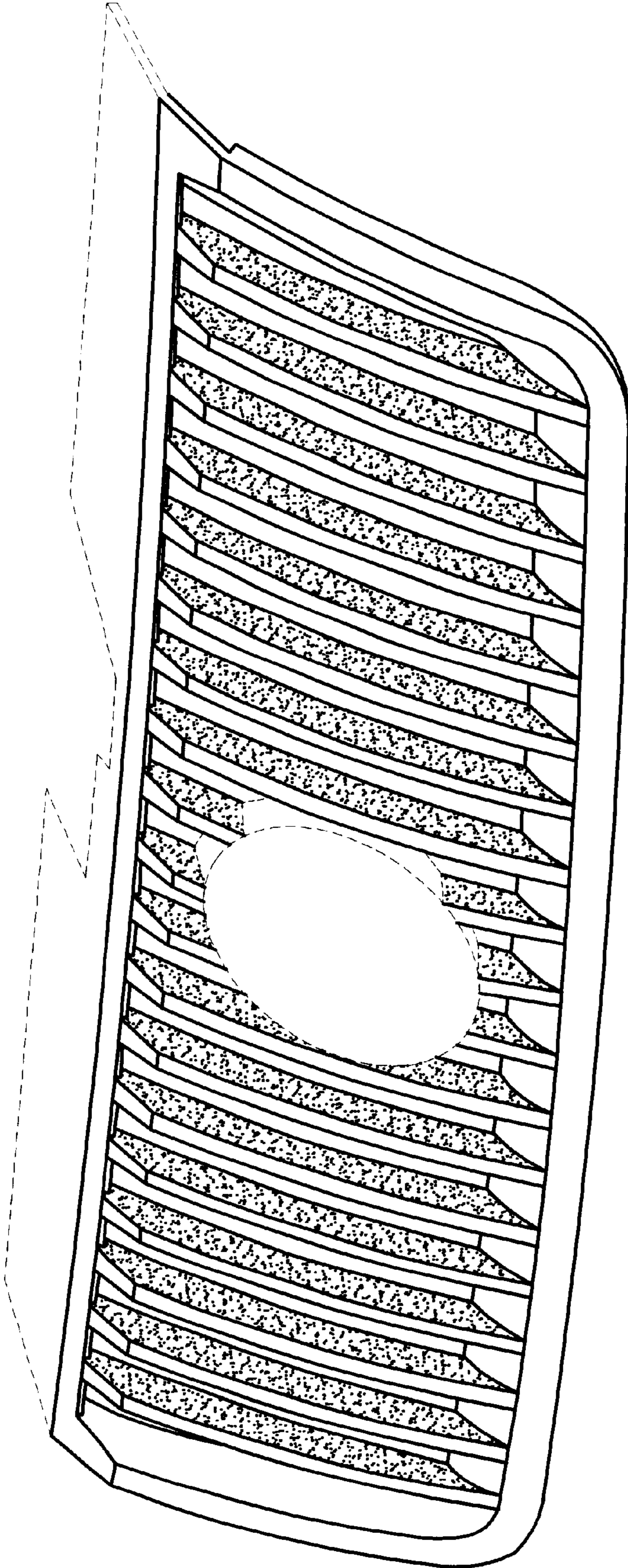

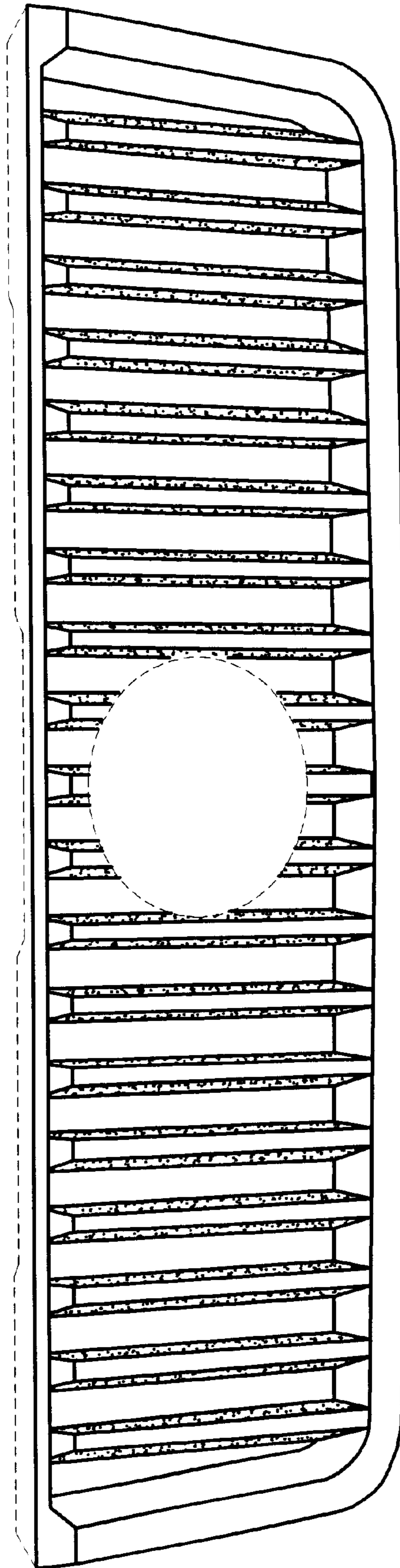

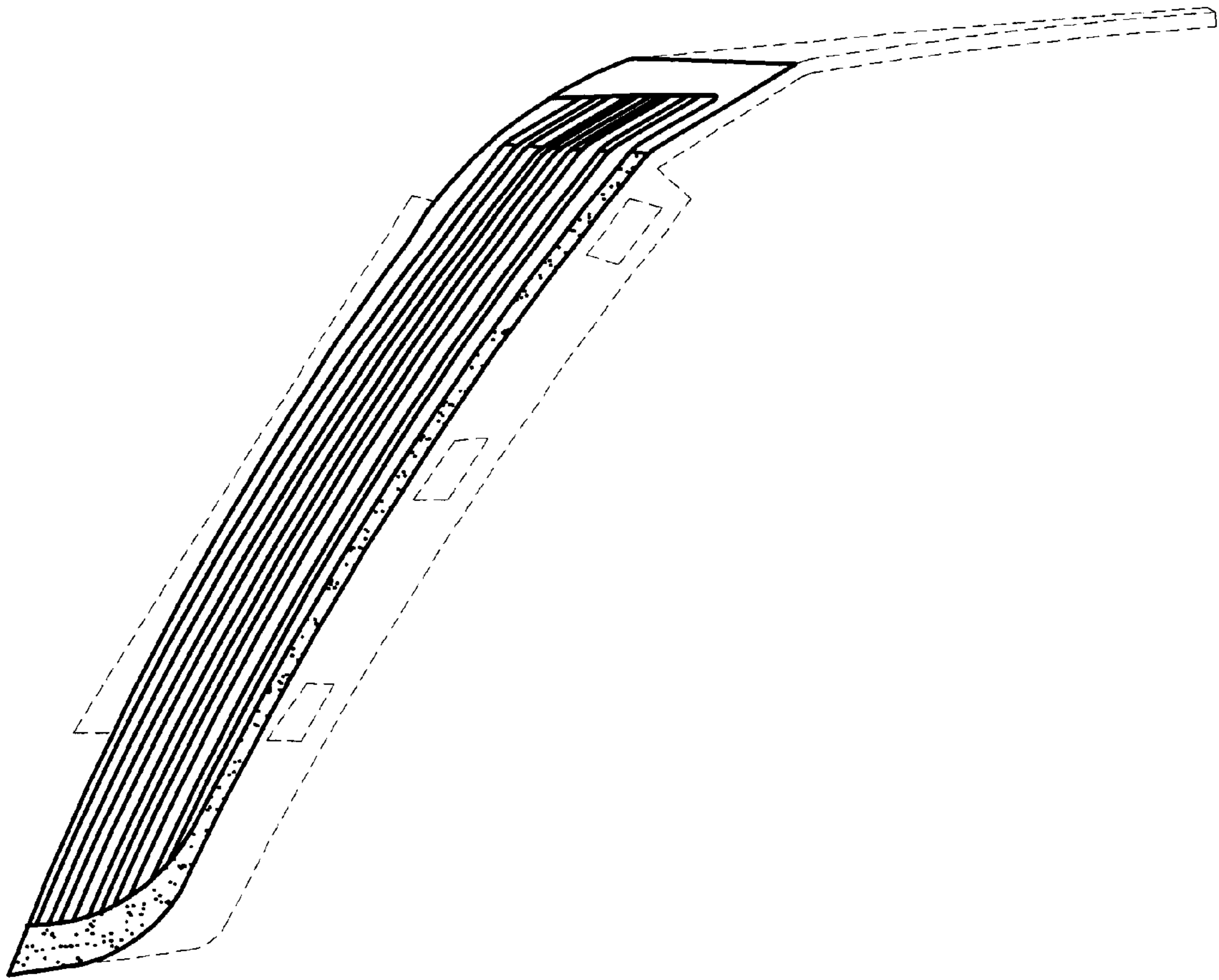

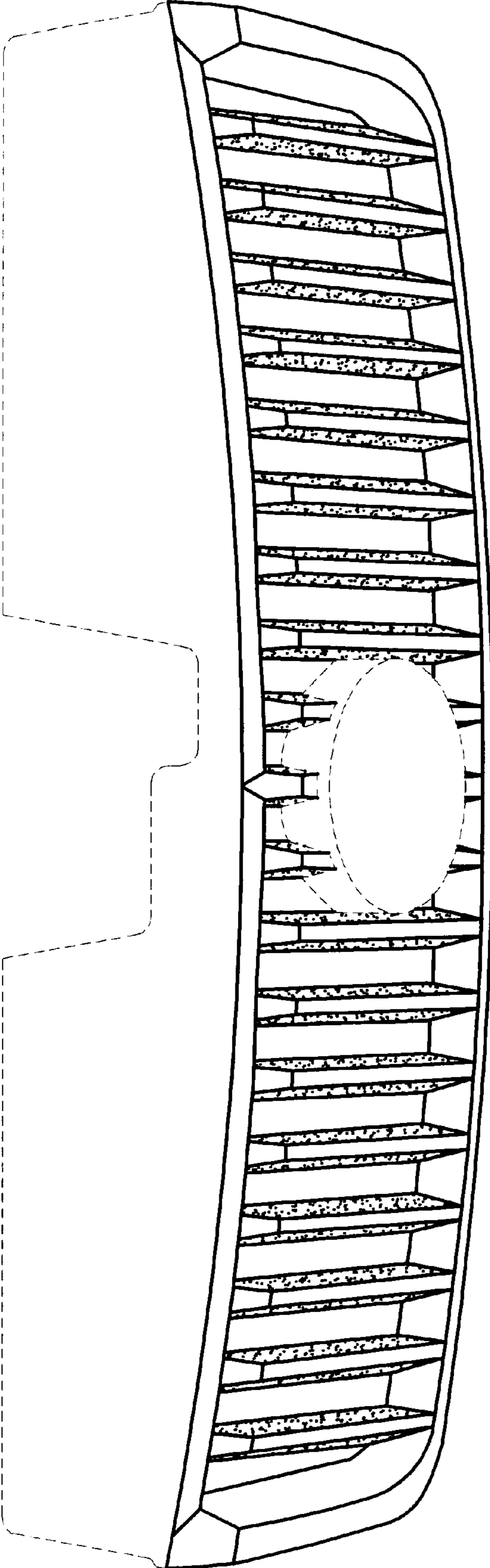
