(57) **CLAIM**

The ornamental design for a microphone boom for a communications headset, as shown and described.

DESCRIPTION

This application is related to U.S. design patent application Ser. Nos. 29/255,421 and 29/255,432 filed concurrently herewith.

FIG. 1 is an upper right front perspective view of a microphone boom for a communications headset showing our new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a rear elevation view thereof;

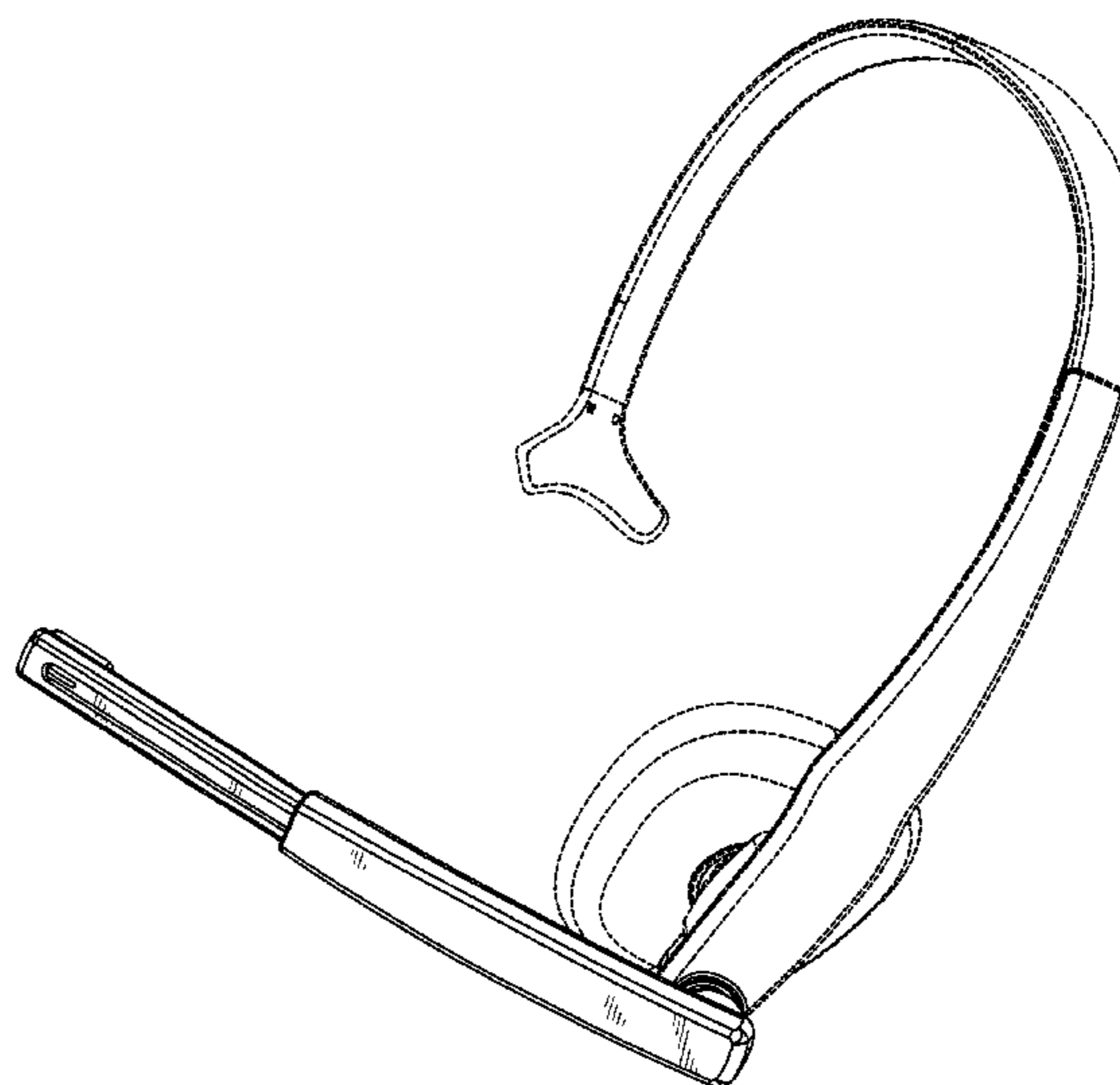
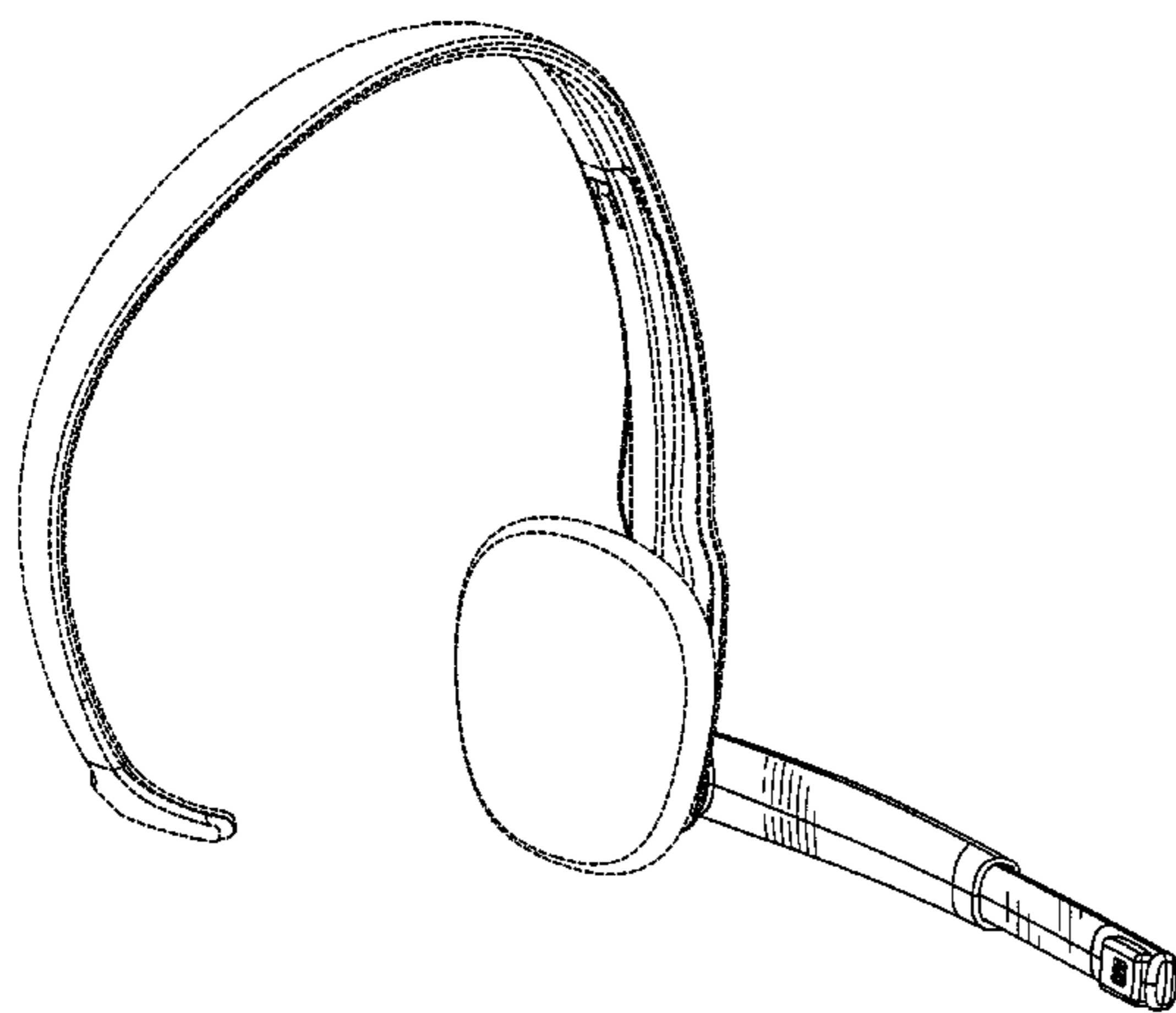
FIG. 6 is a right side elevation view thereof; and,

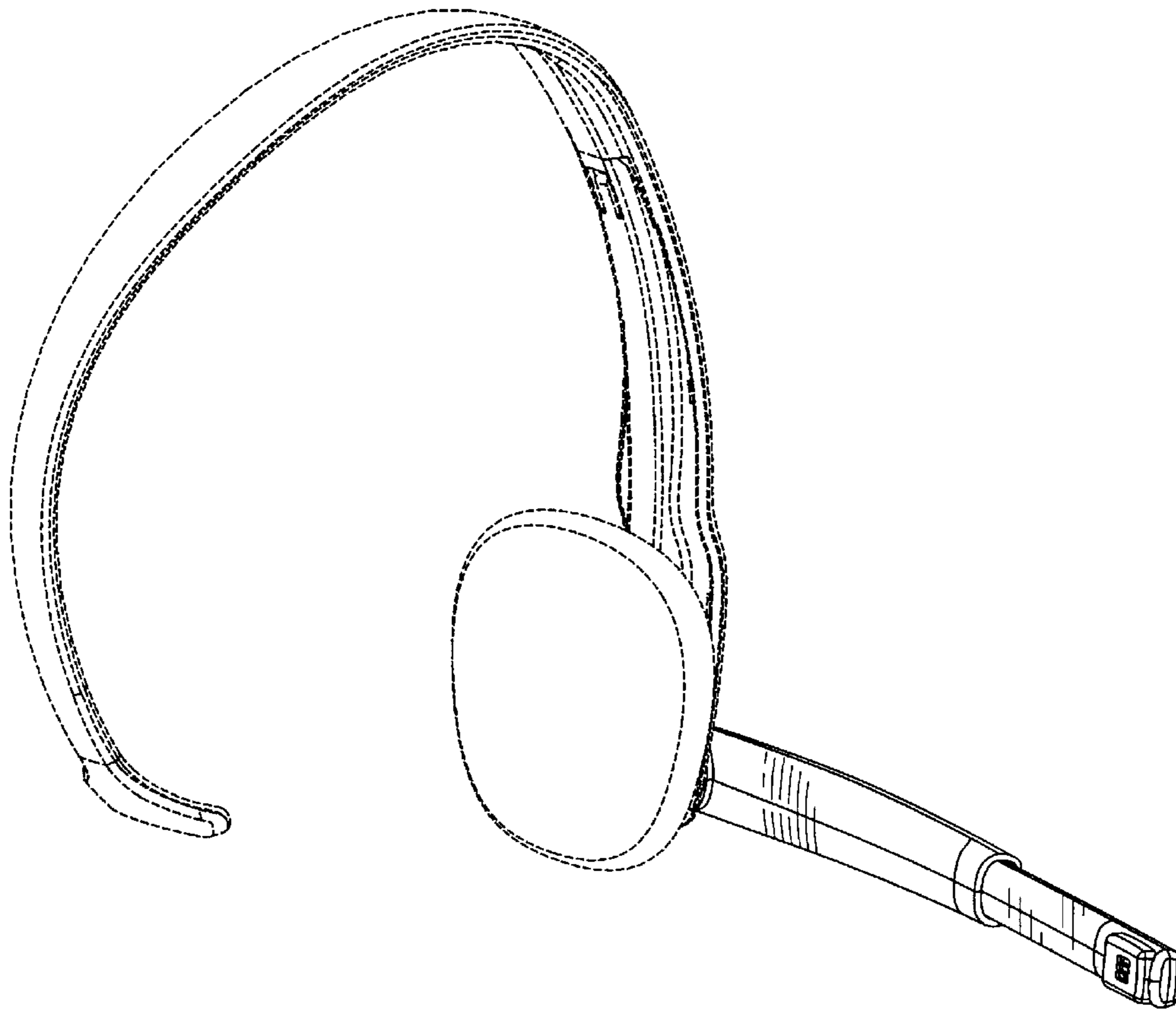

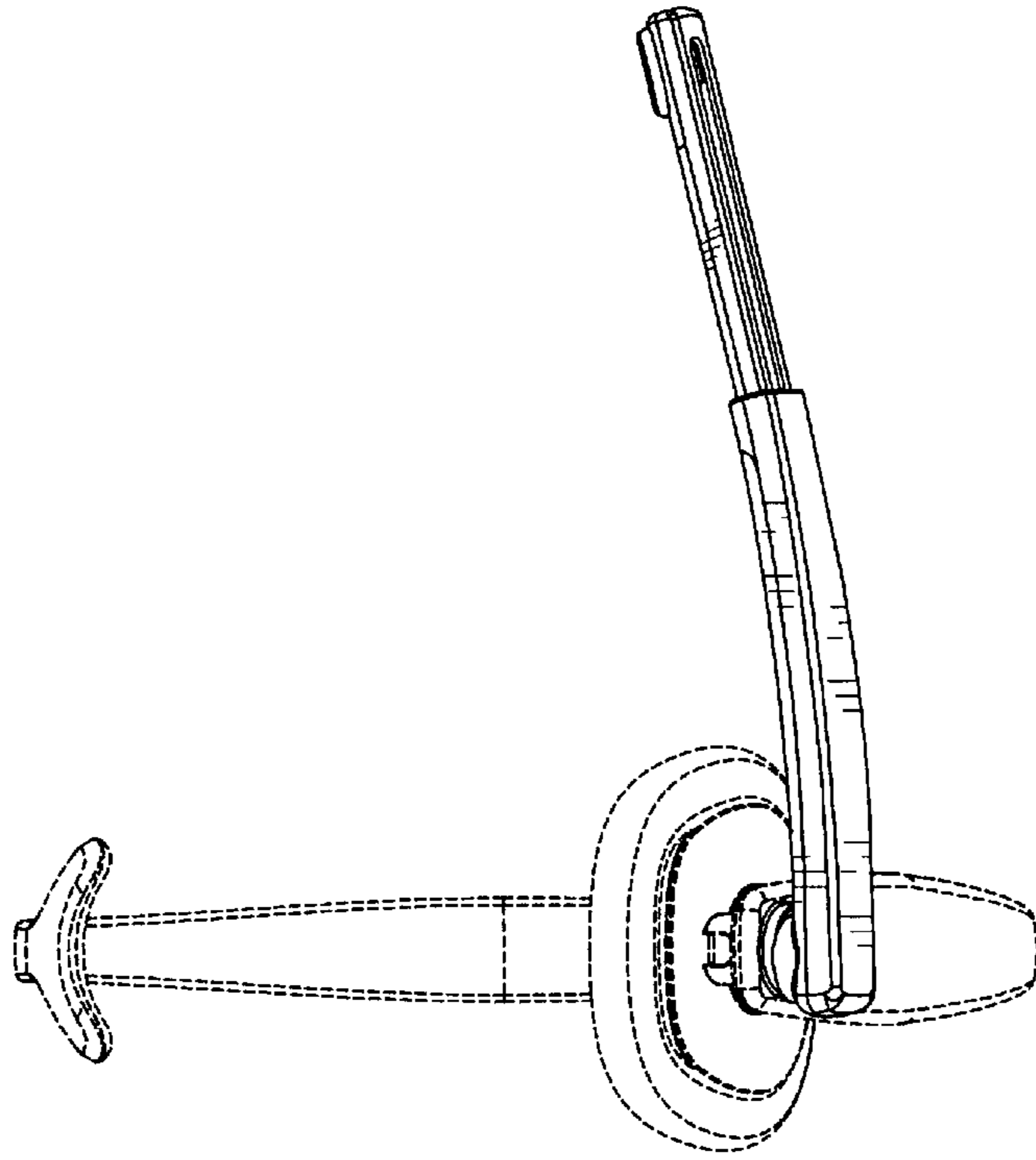

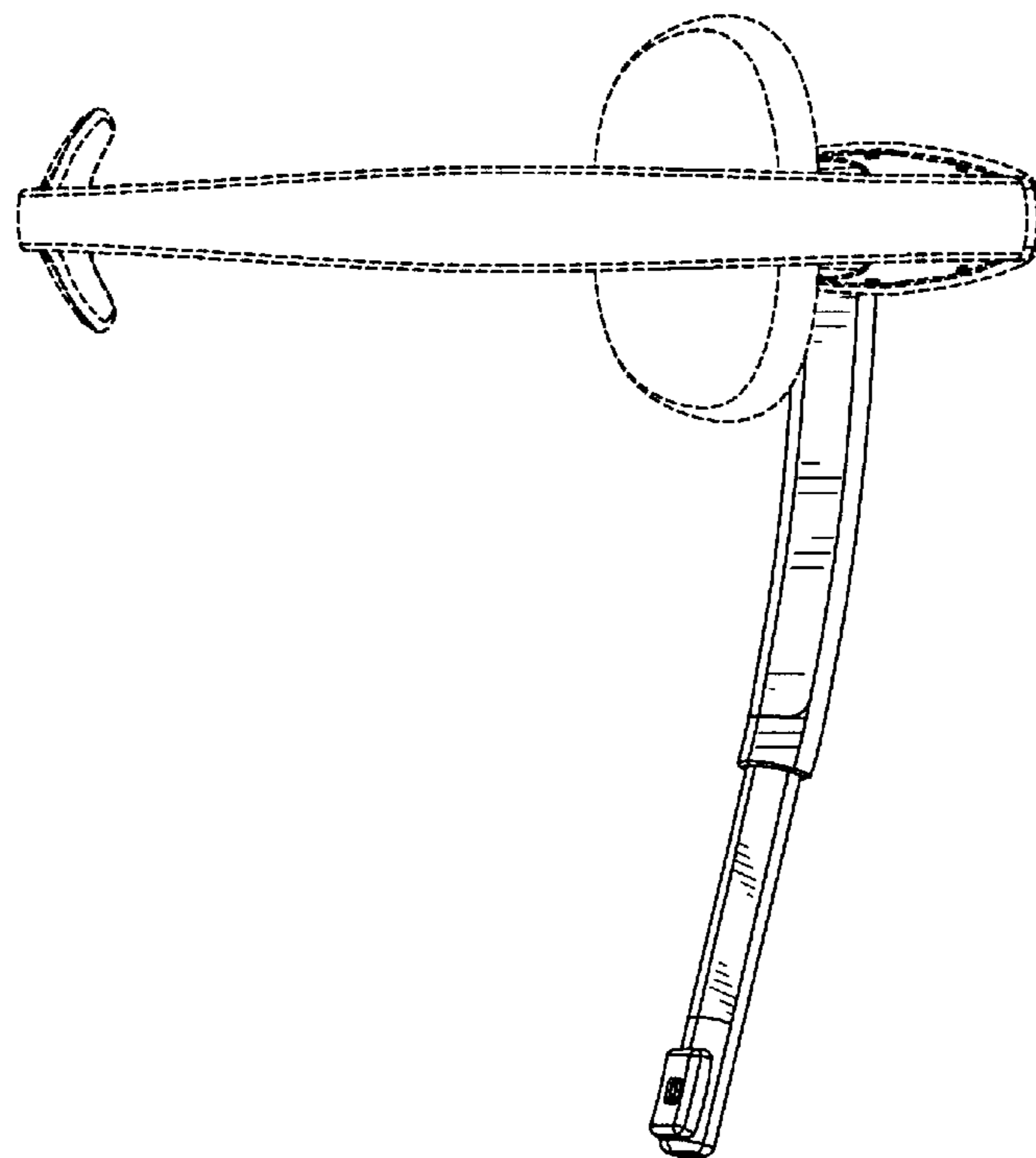

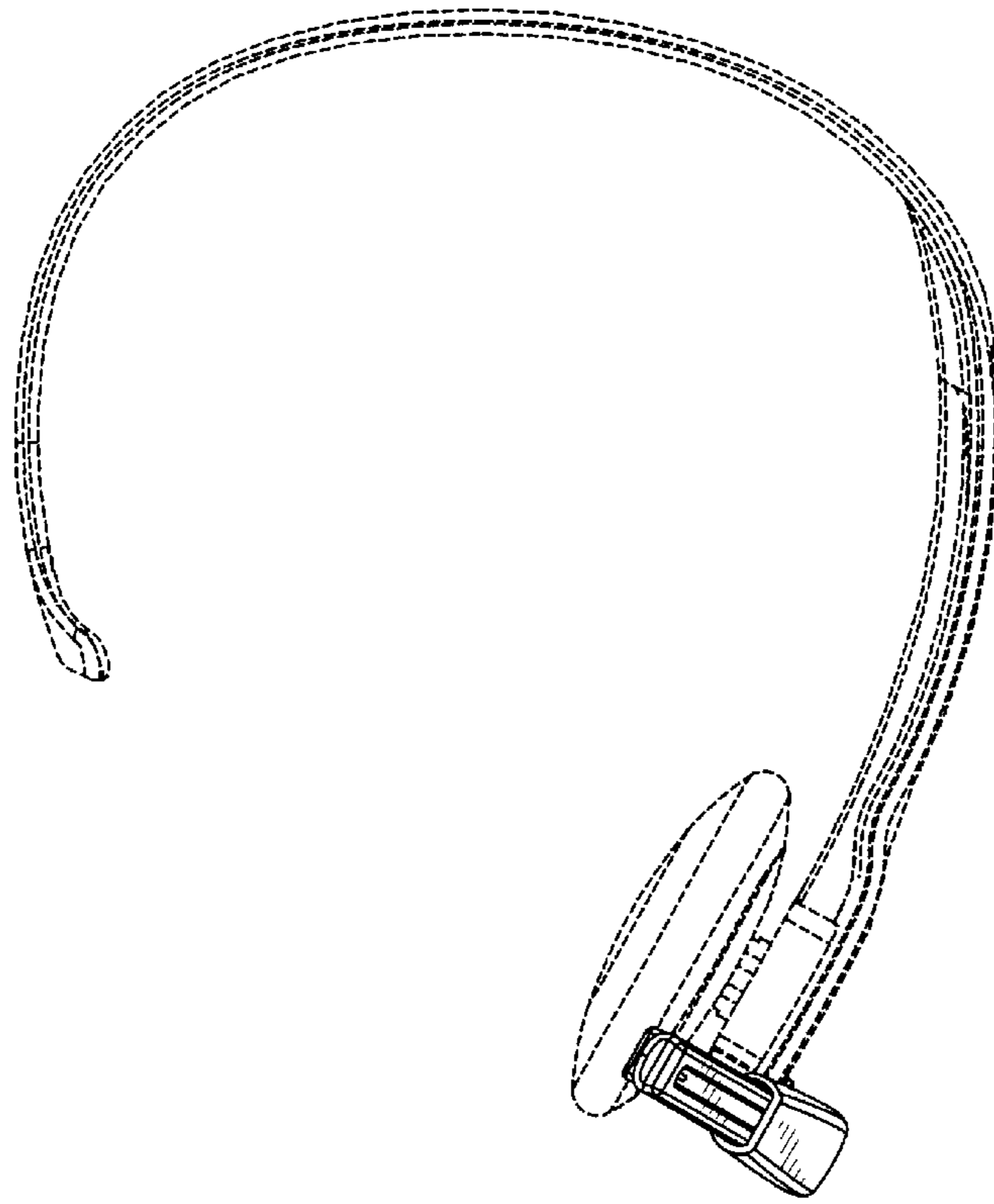

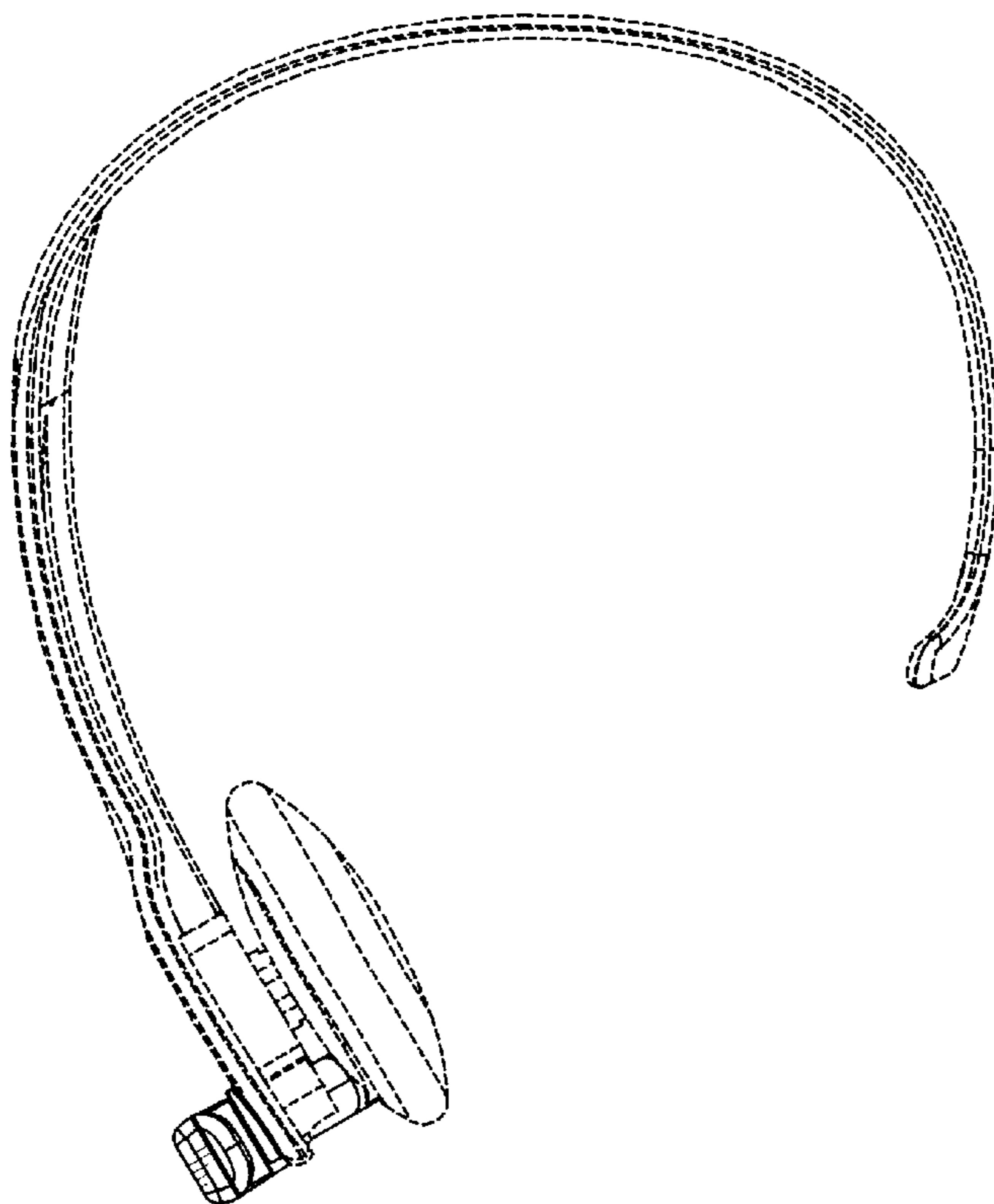

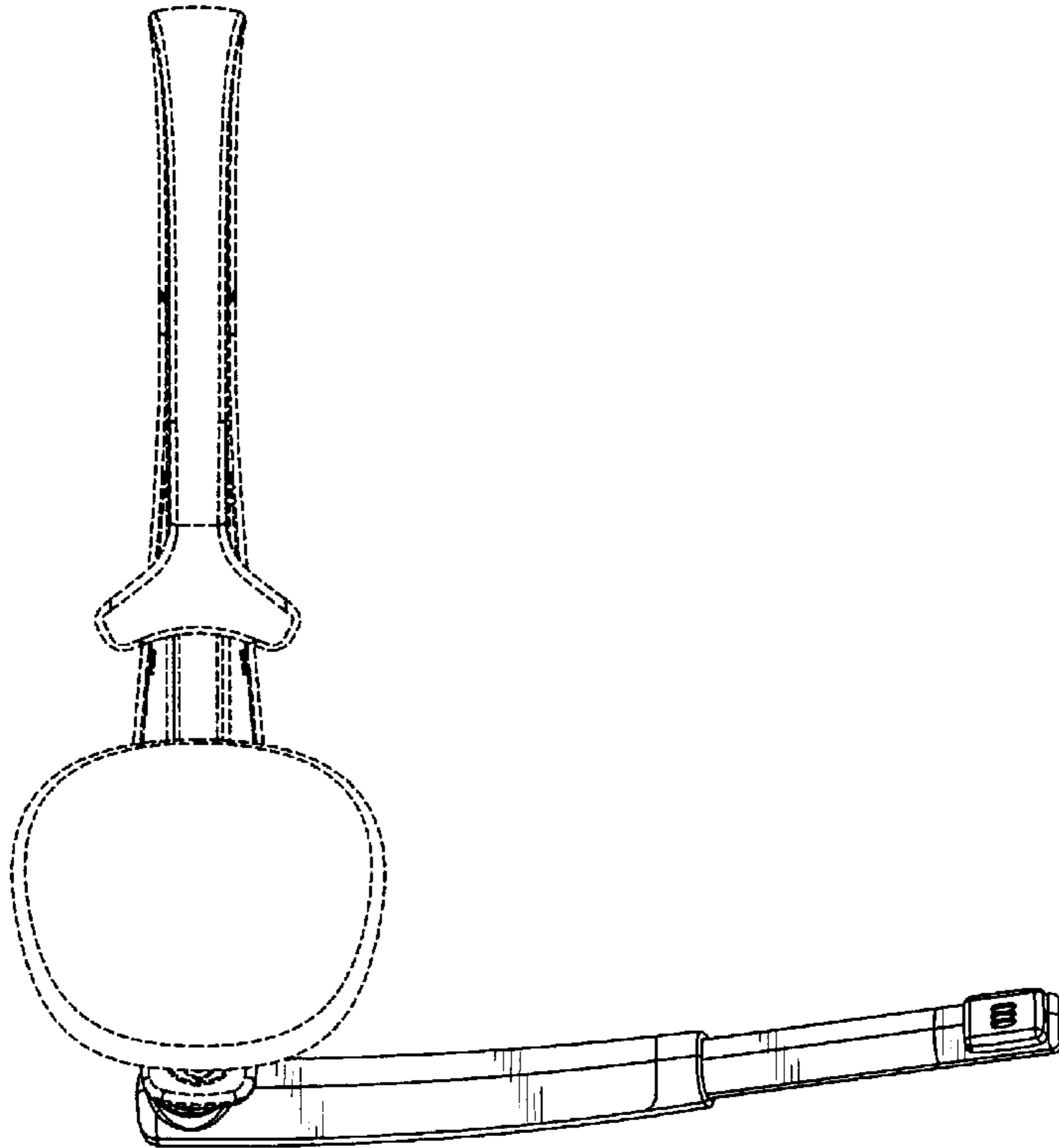

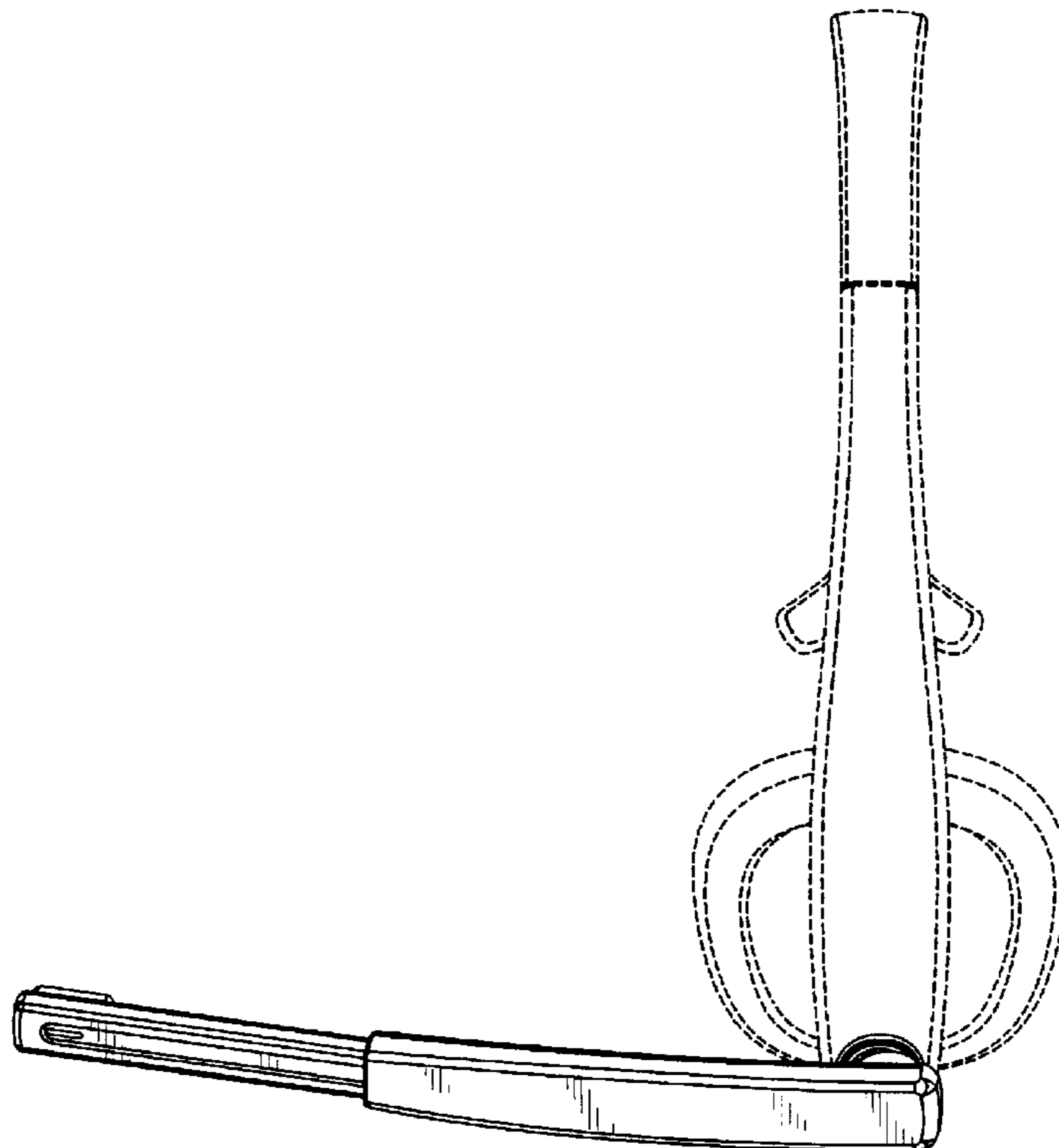

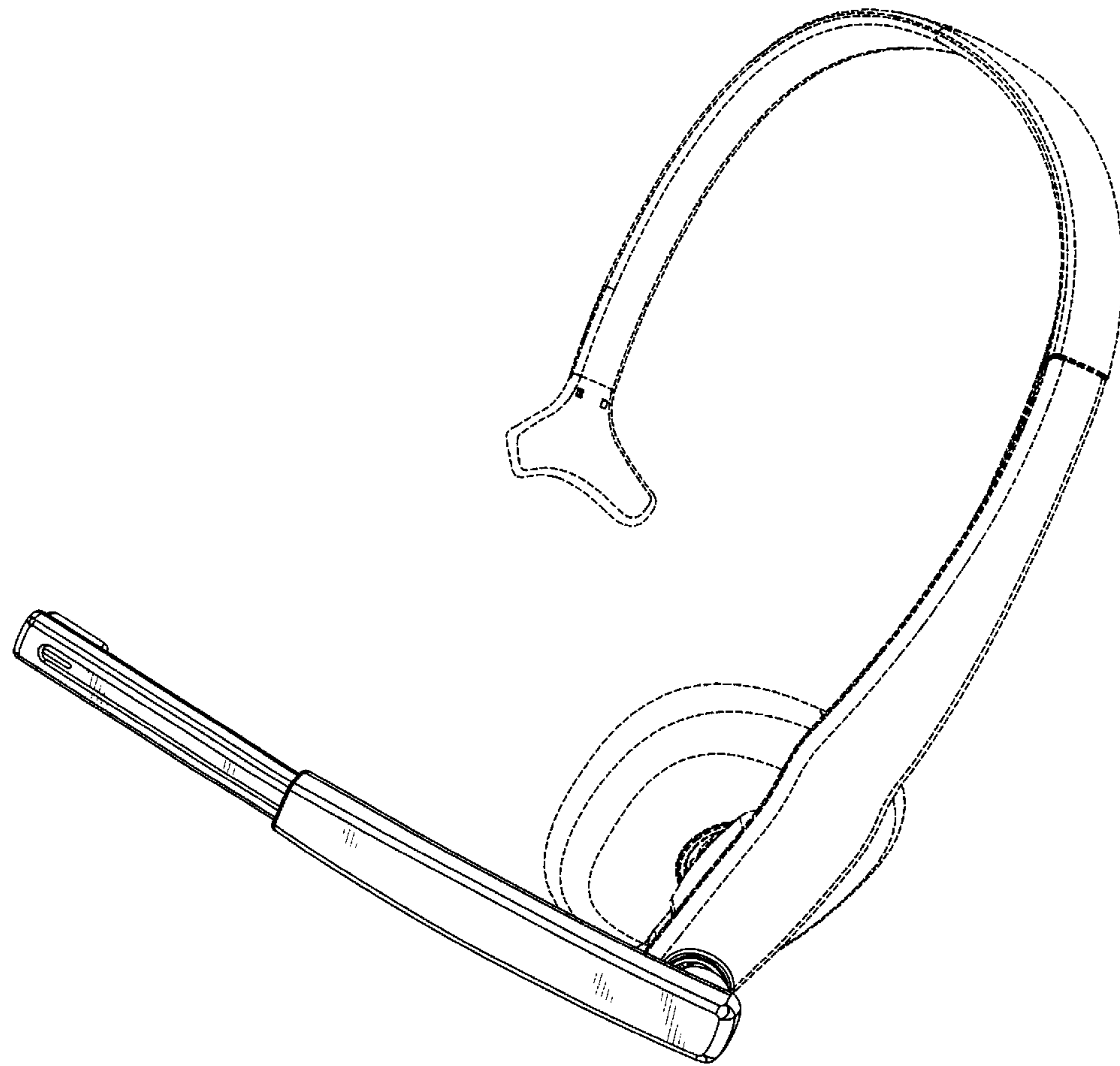
