FIG. 4 is a Right Side View thereof;

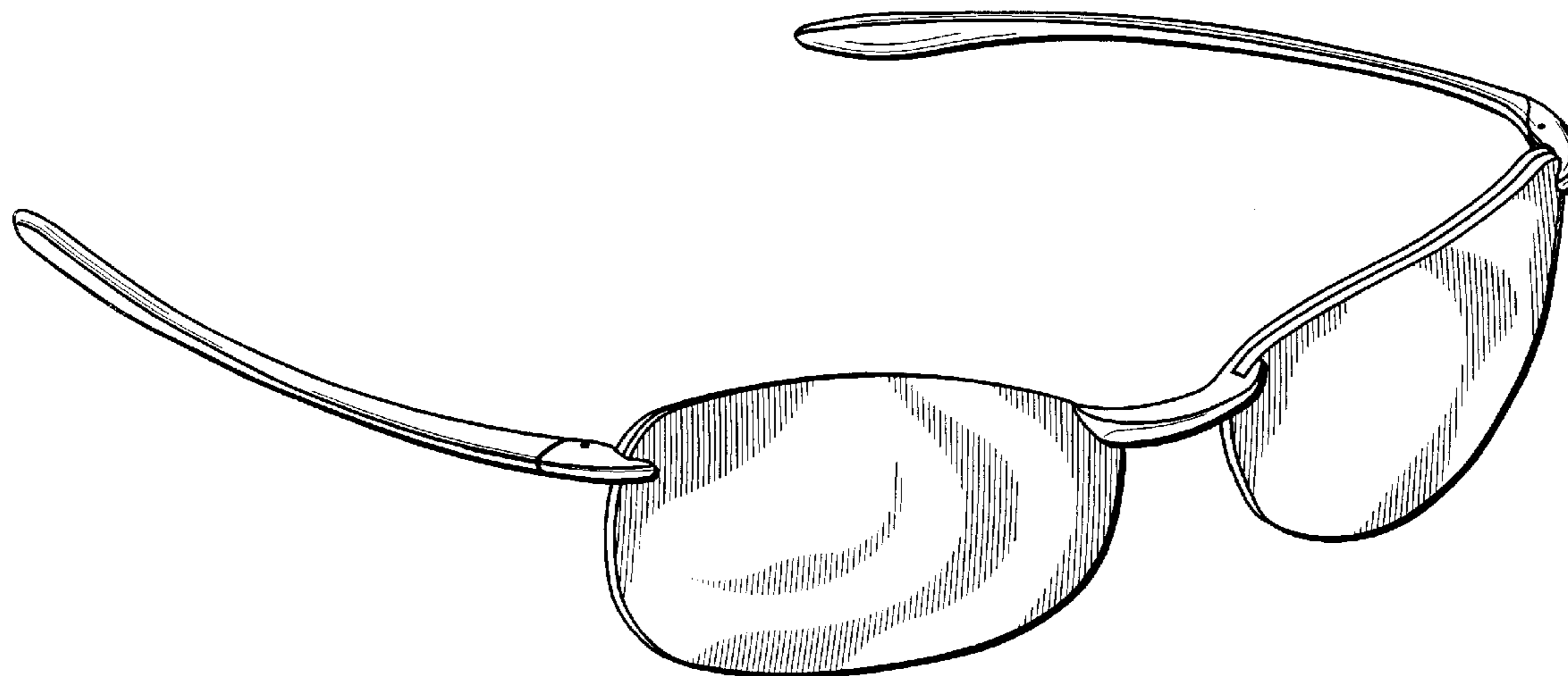
FIG. 5 is a Rear View thereof;

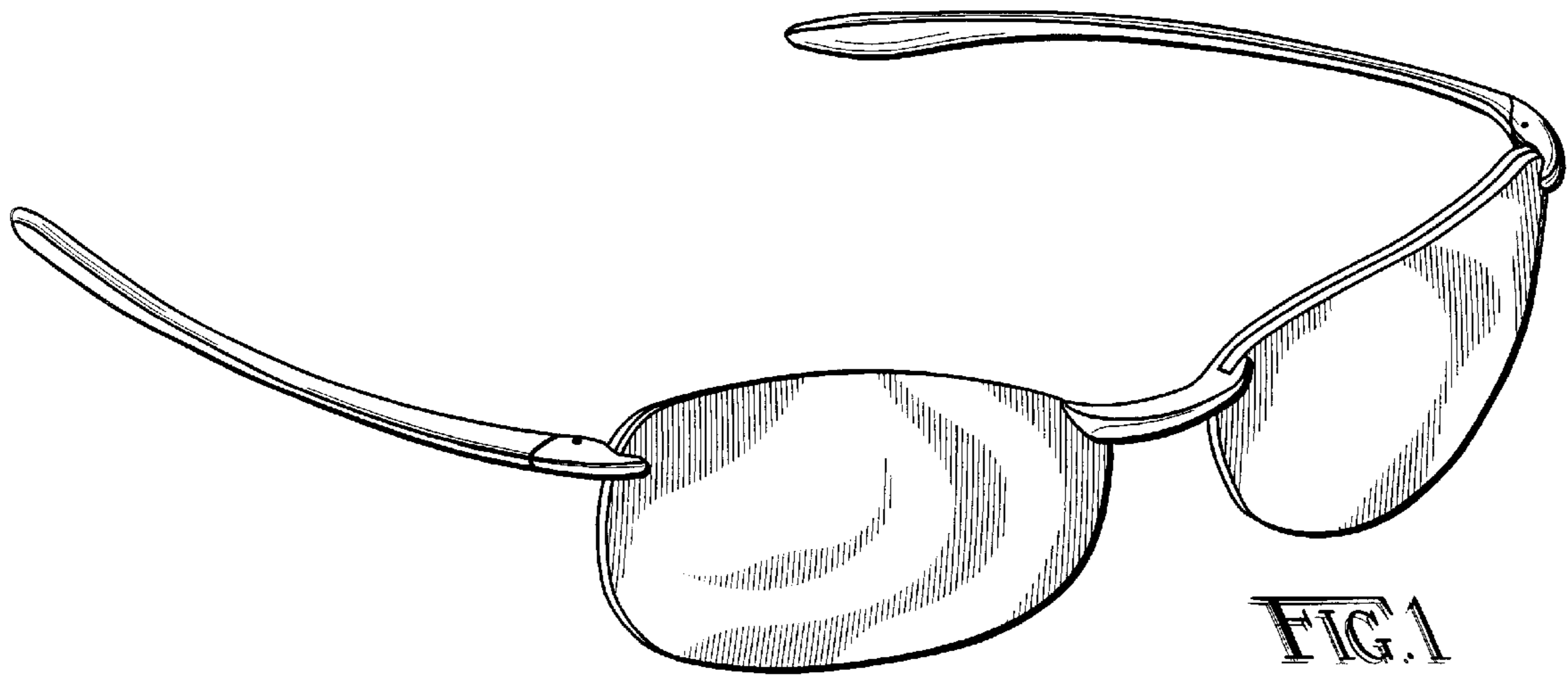

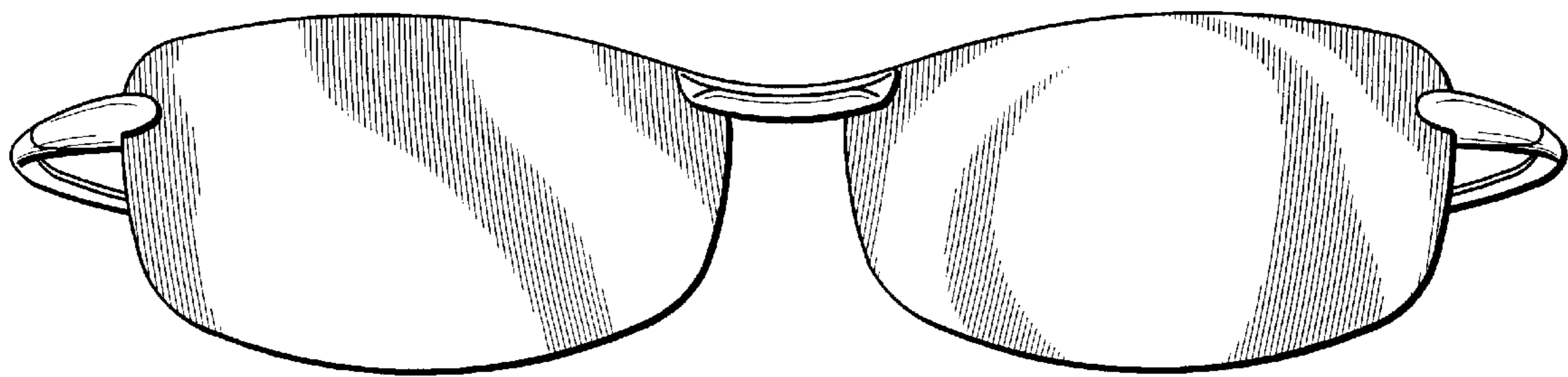

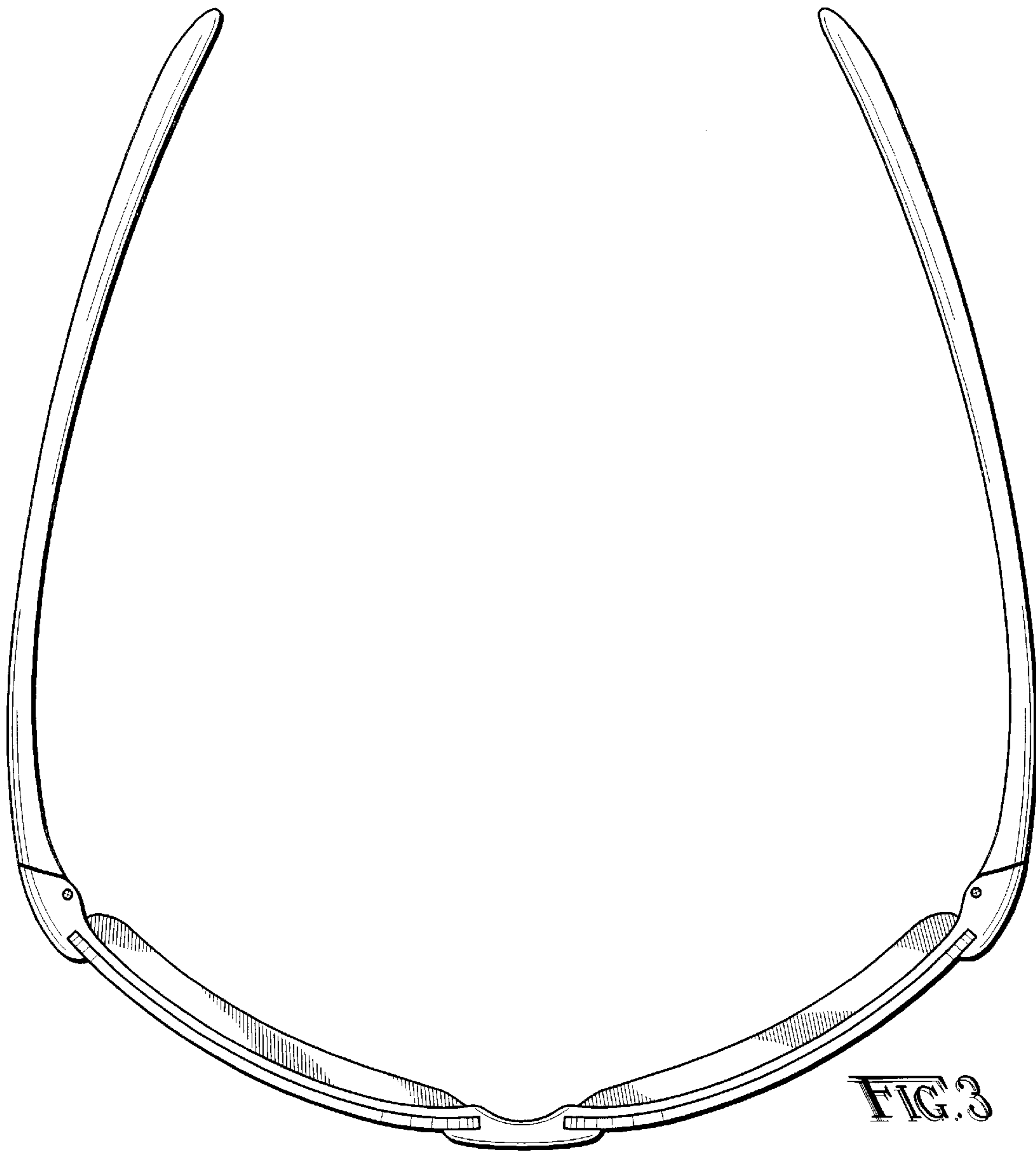

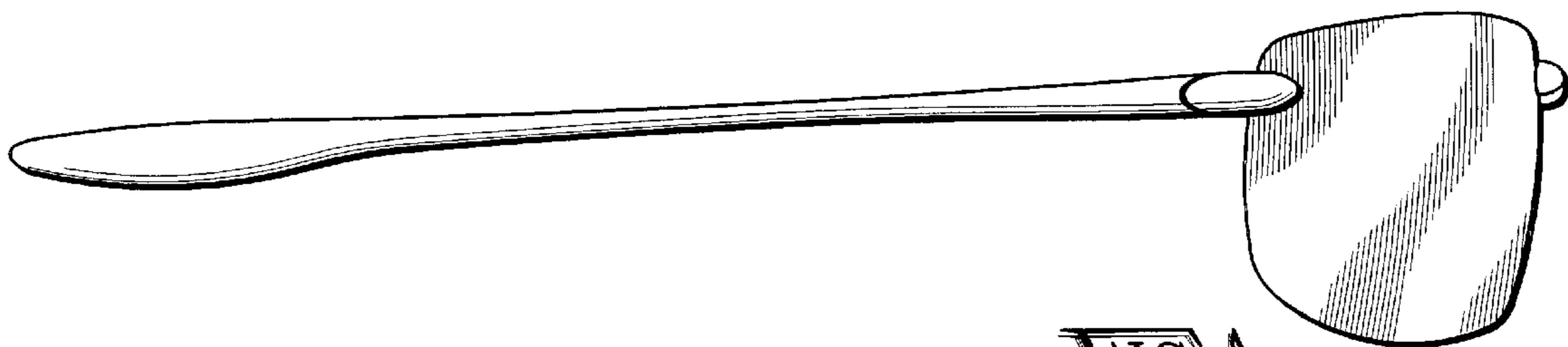

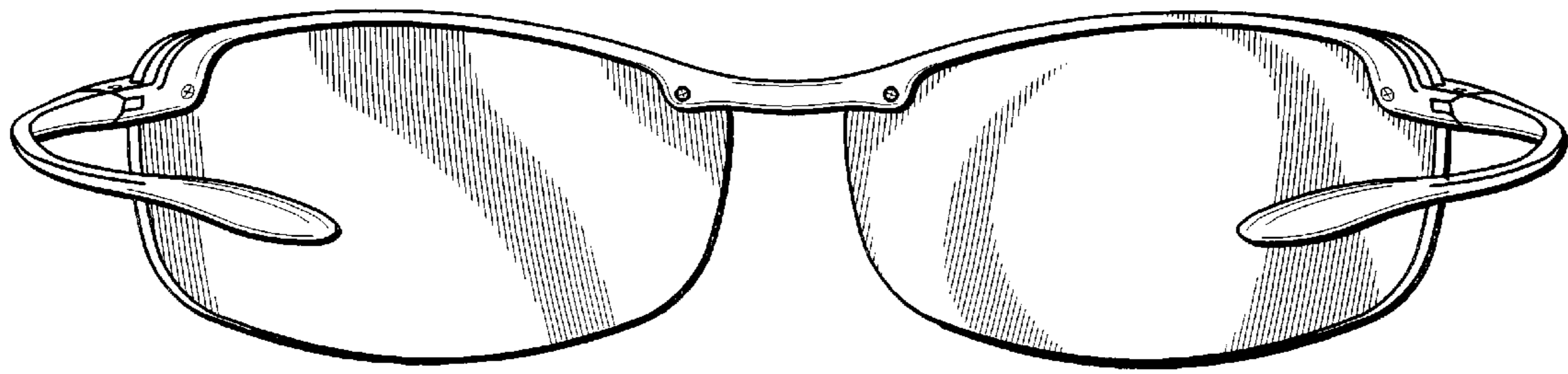

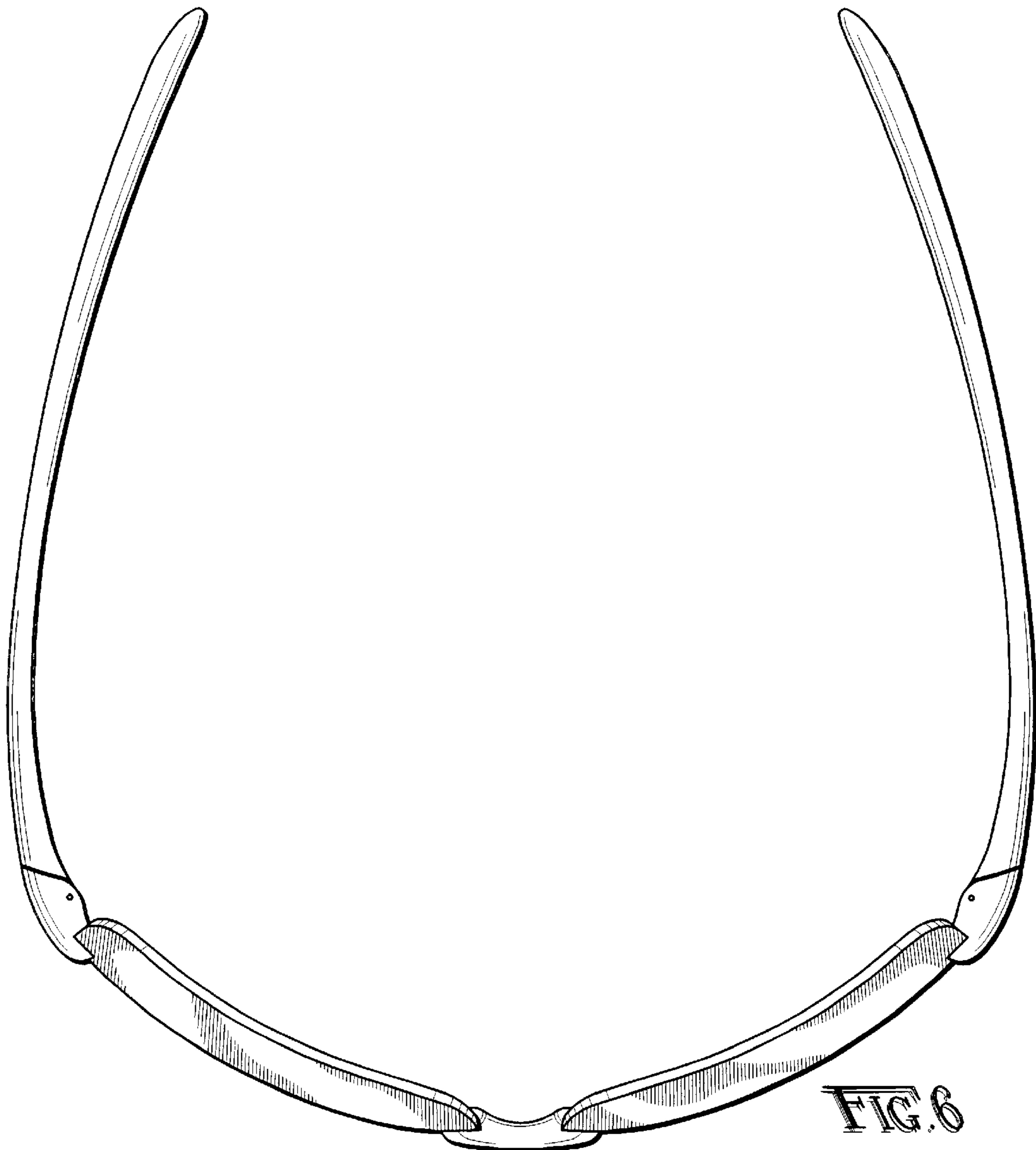
