FIG. 4 is an exploded right side view thereof;

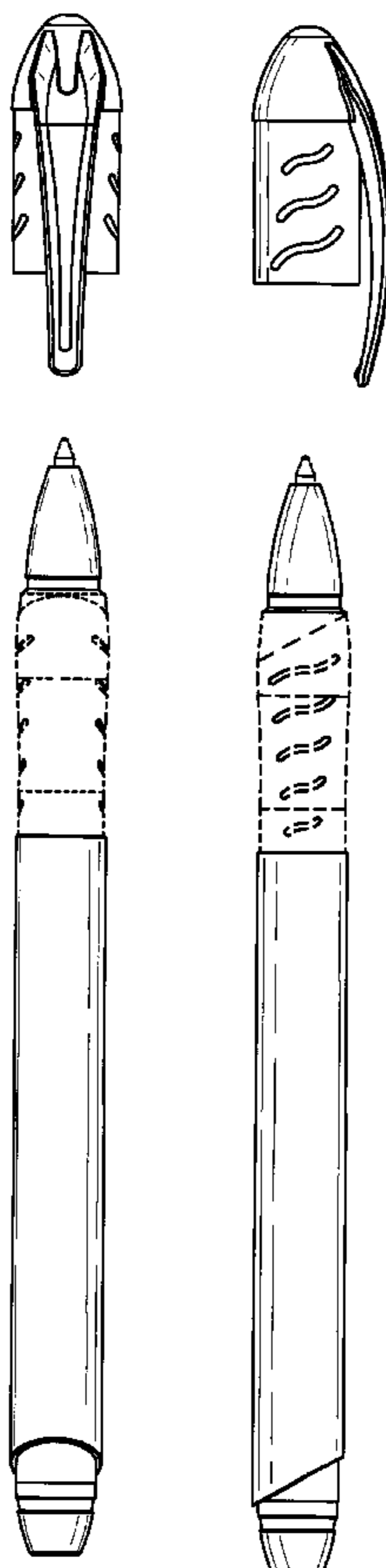
FIG. 5 is an exploded left side view thereof;

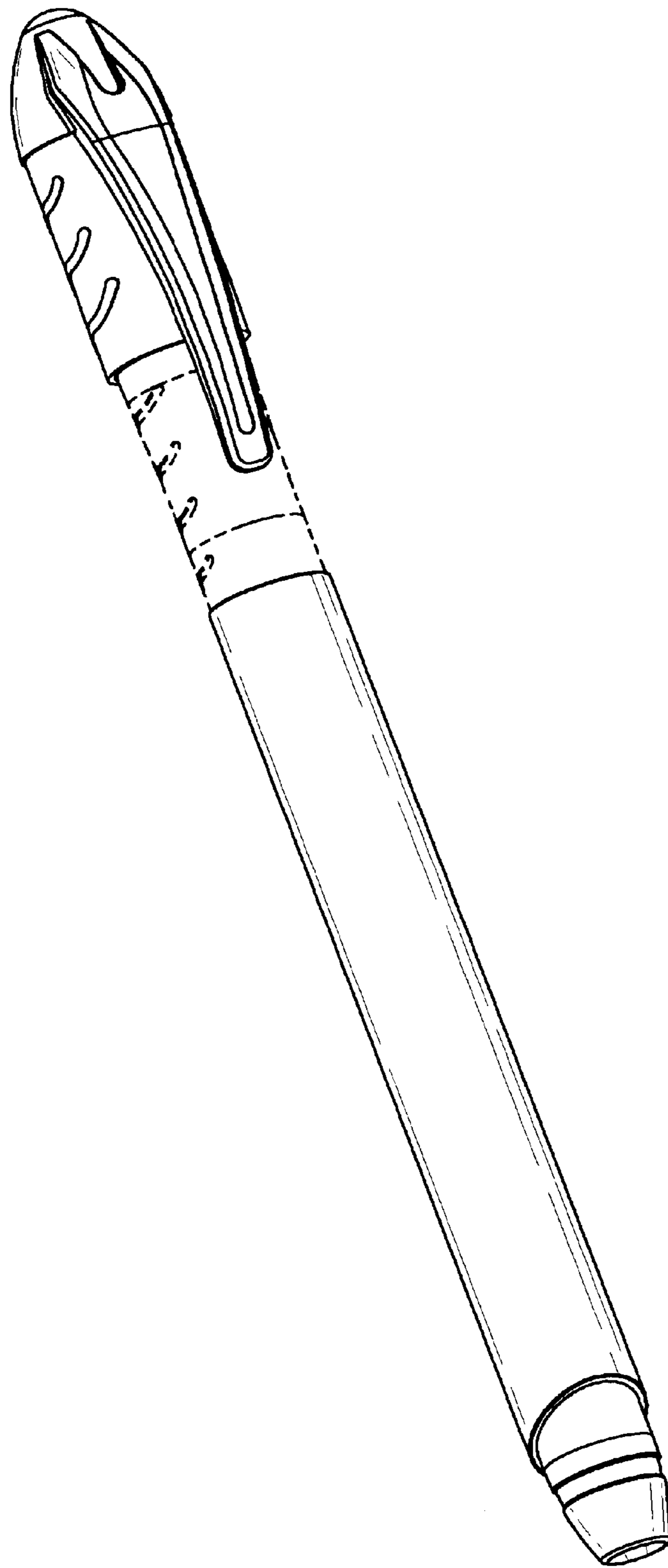

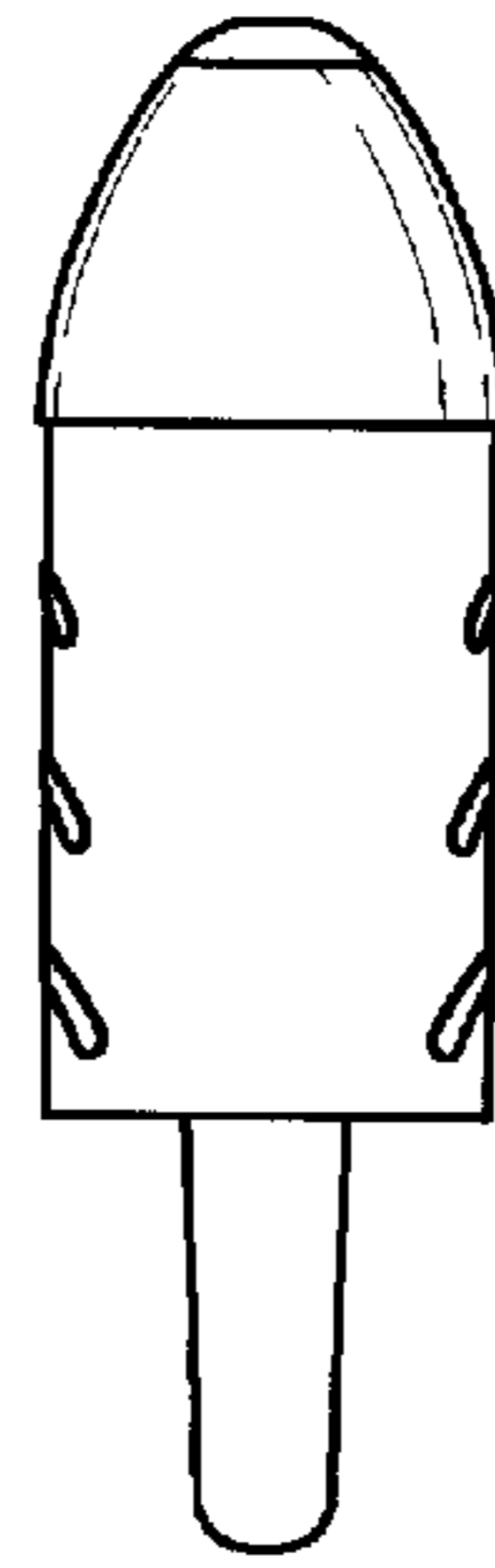
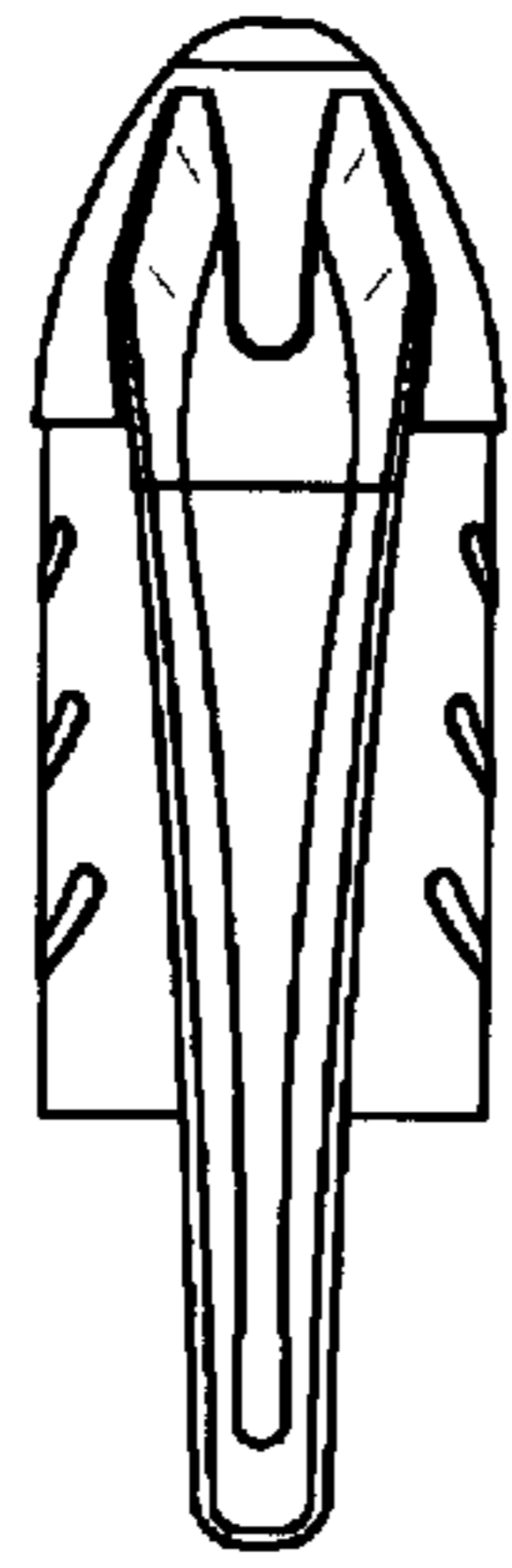

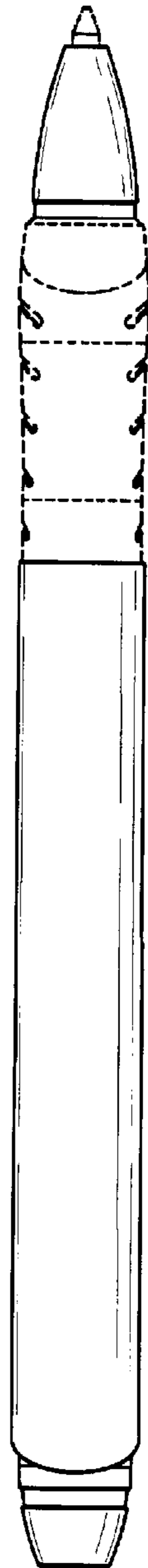
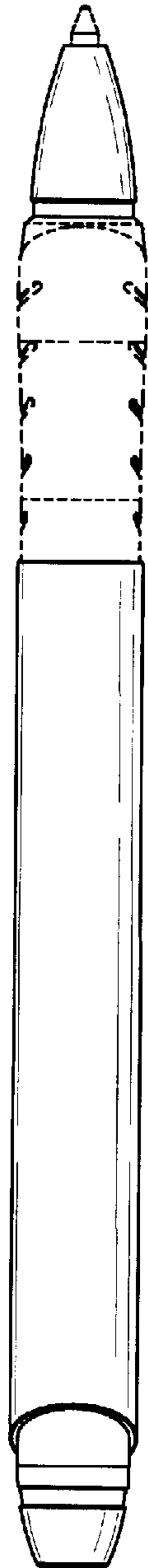

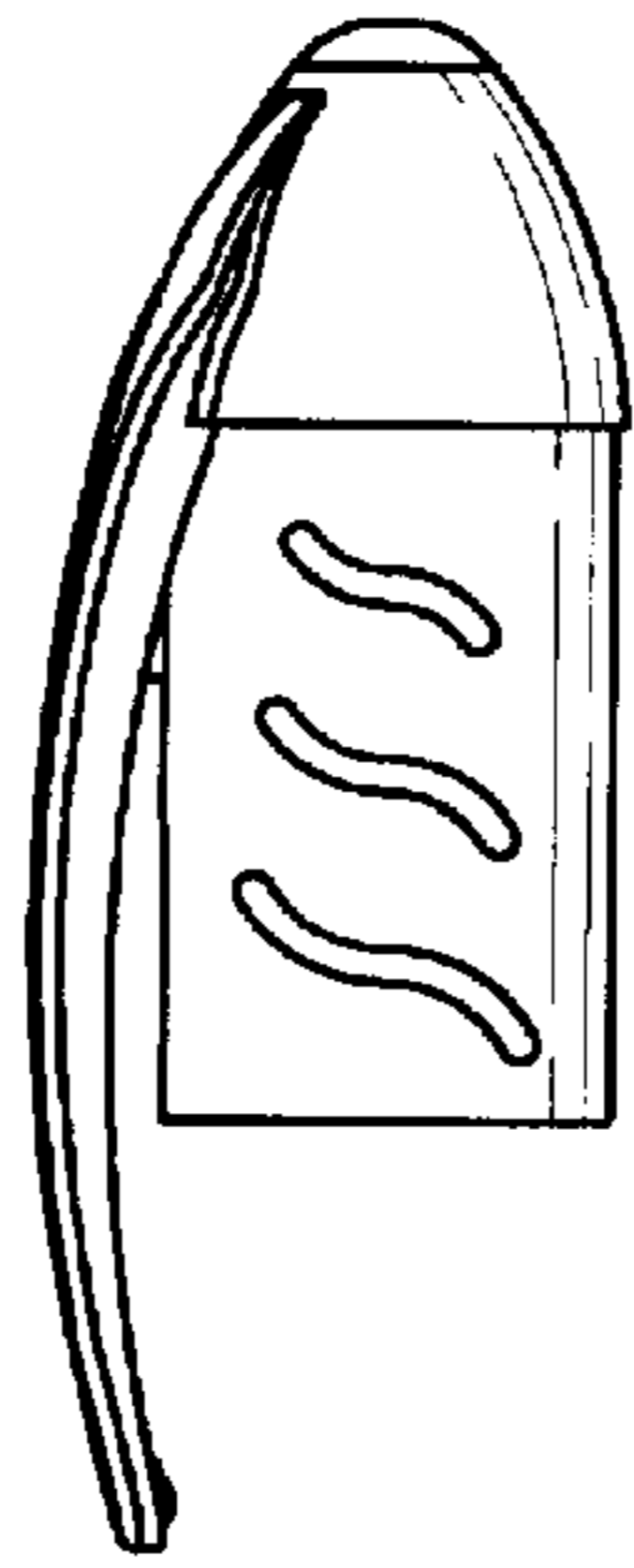
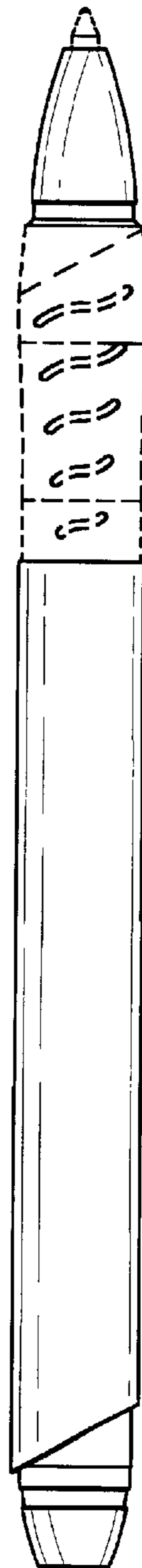
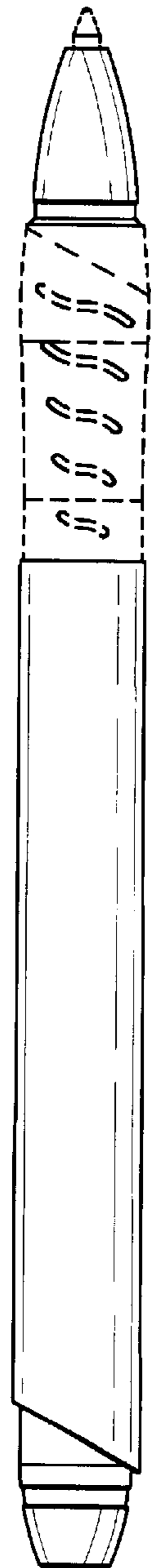
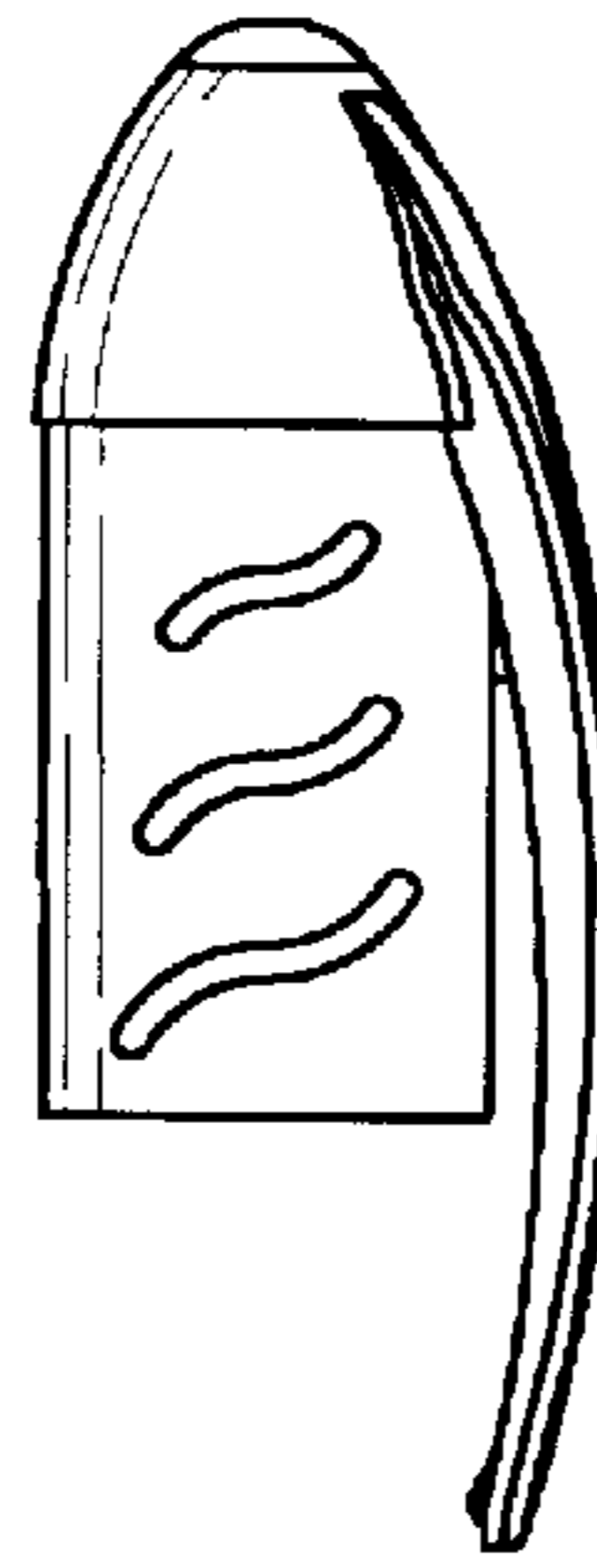

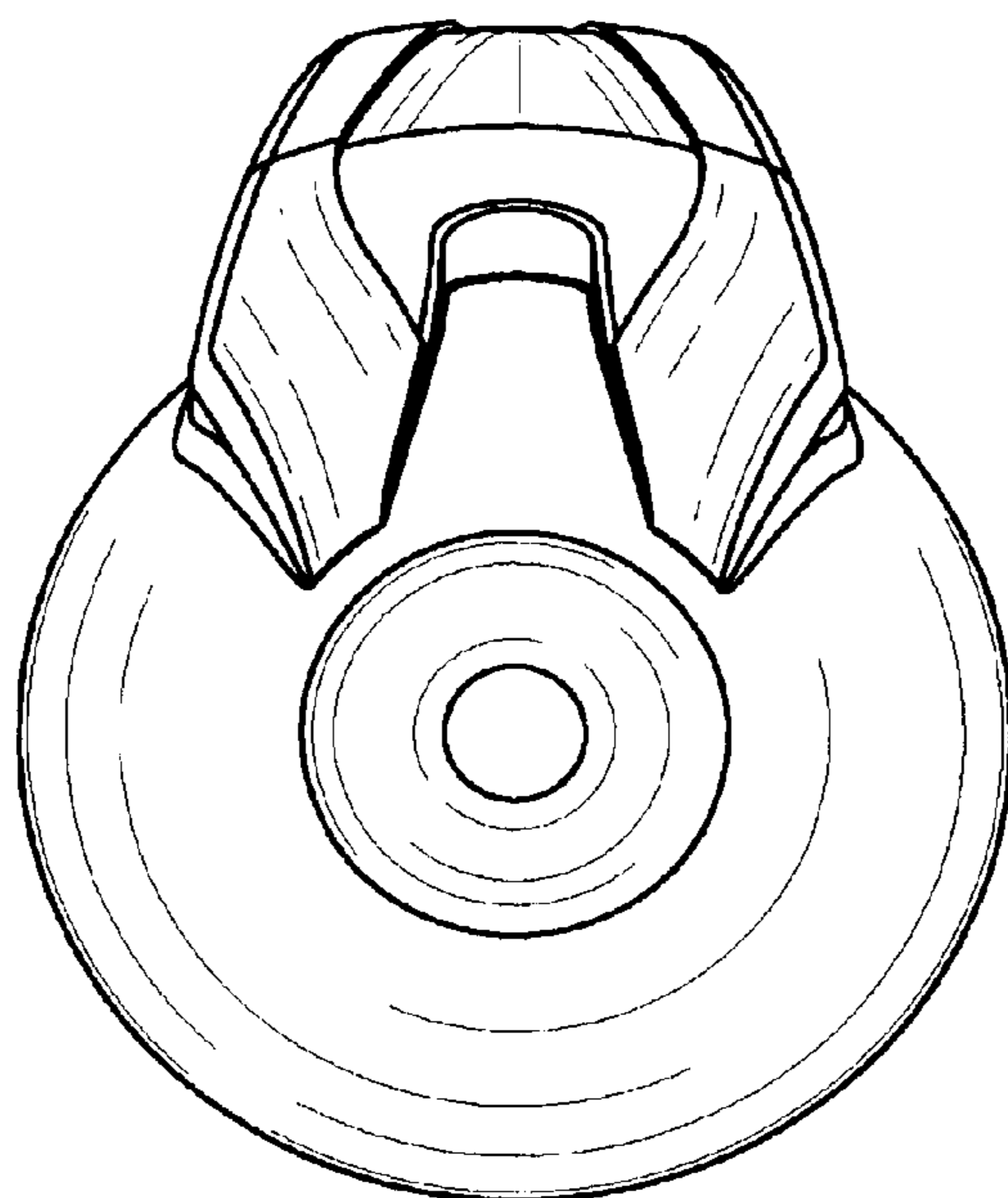

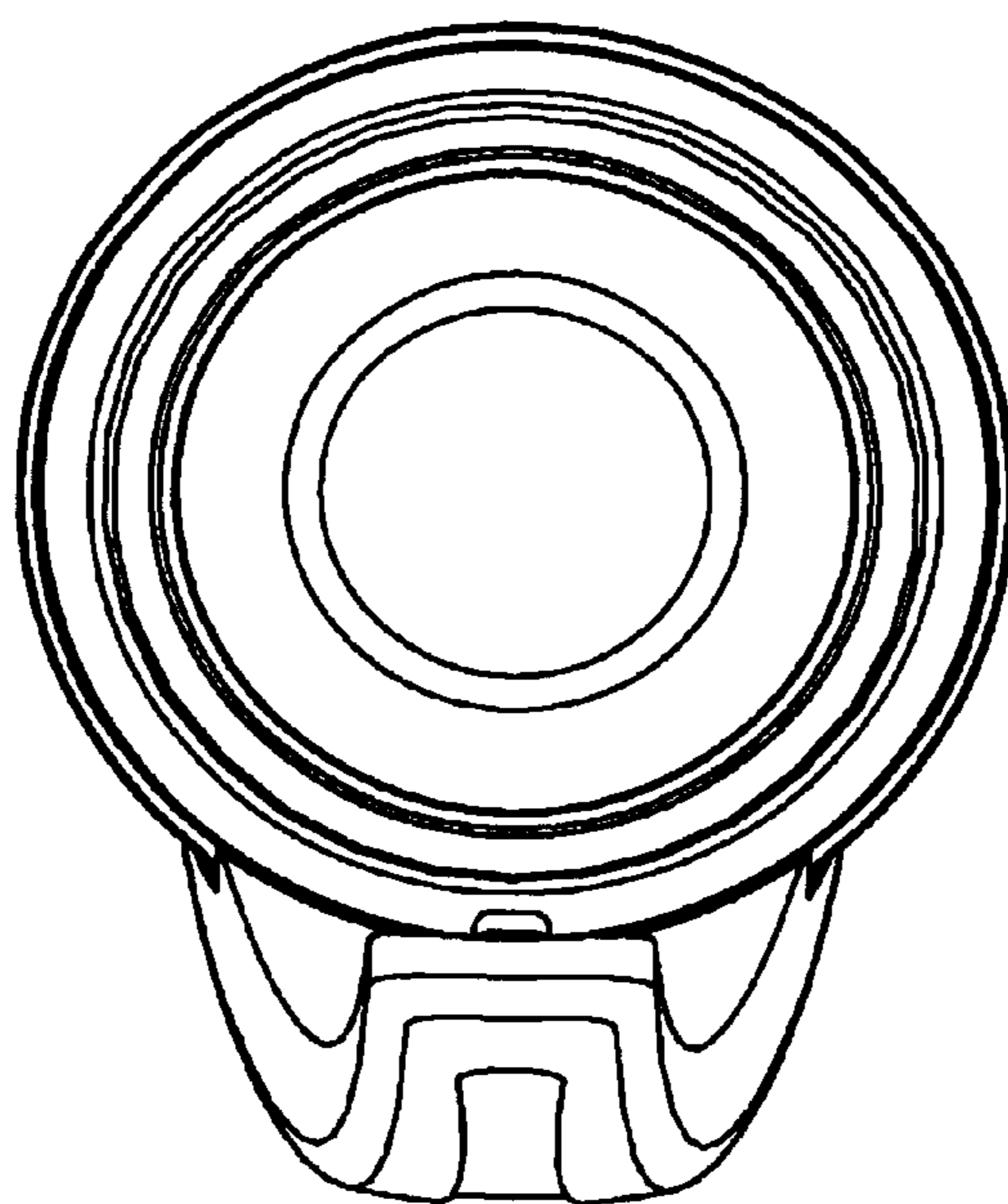
