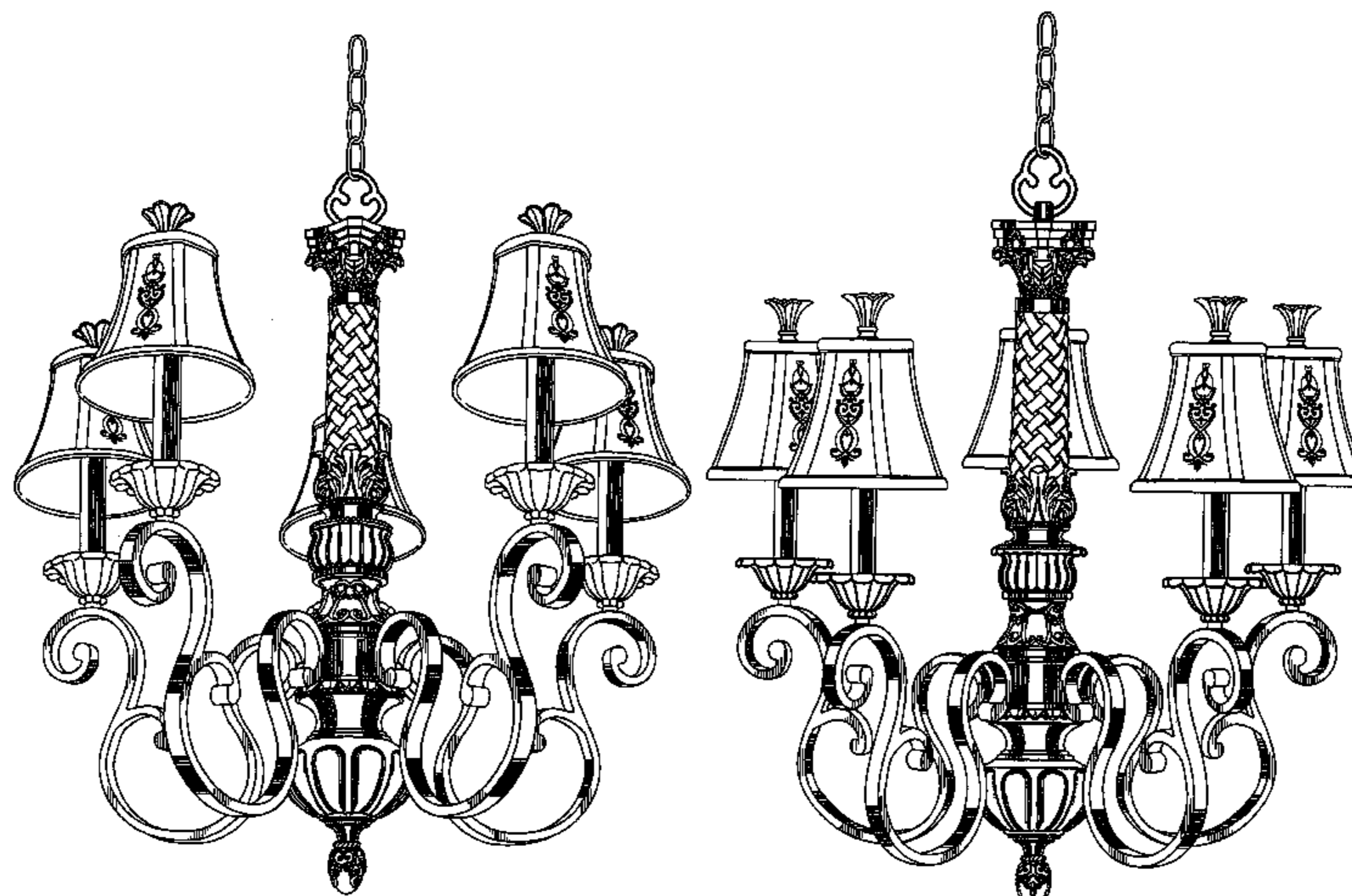
(57) **CLAIM**

The ornamental design for a chandelier, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from below of a chandelier in accordance with my design;  
FIG. 2 is a top plan view of the chandelier in accordance with my design;  
FIG. 3 is a bottom plan view of the chandelier in accordance with my design;  
FIG. 4 is a side elevation view taken 144 degrees from the front view of the chandelier in accordance with my design;  
FIG. 5 is a front elevation view of the chandelier in accordance with my design;  
FIG. 6 is a side elevation view taken 288 degrees from the front view of the chandelier in accordance with my design;  
FIG. 7 is a back elevation view of the chandelier in accordance with my design; and,  
FIG. 8 is a side elevation view taken 90 degrees from the front view of the chandelier in accordance with my design, the opposite side being a mirror image.

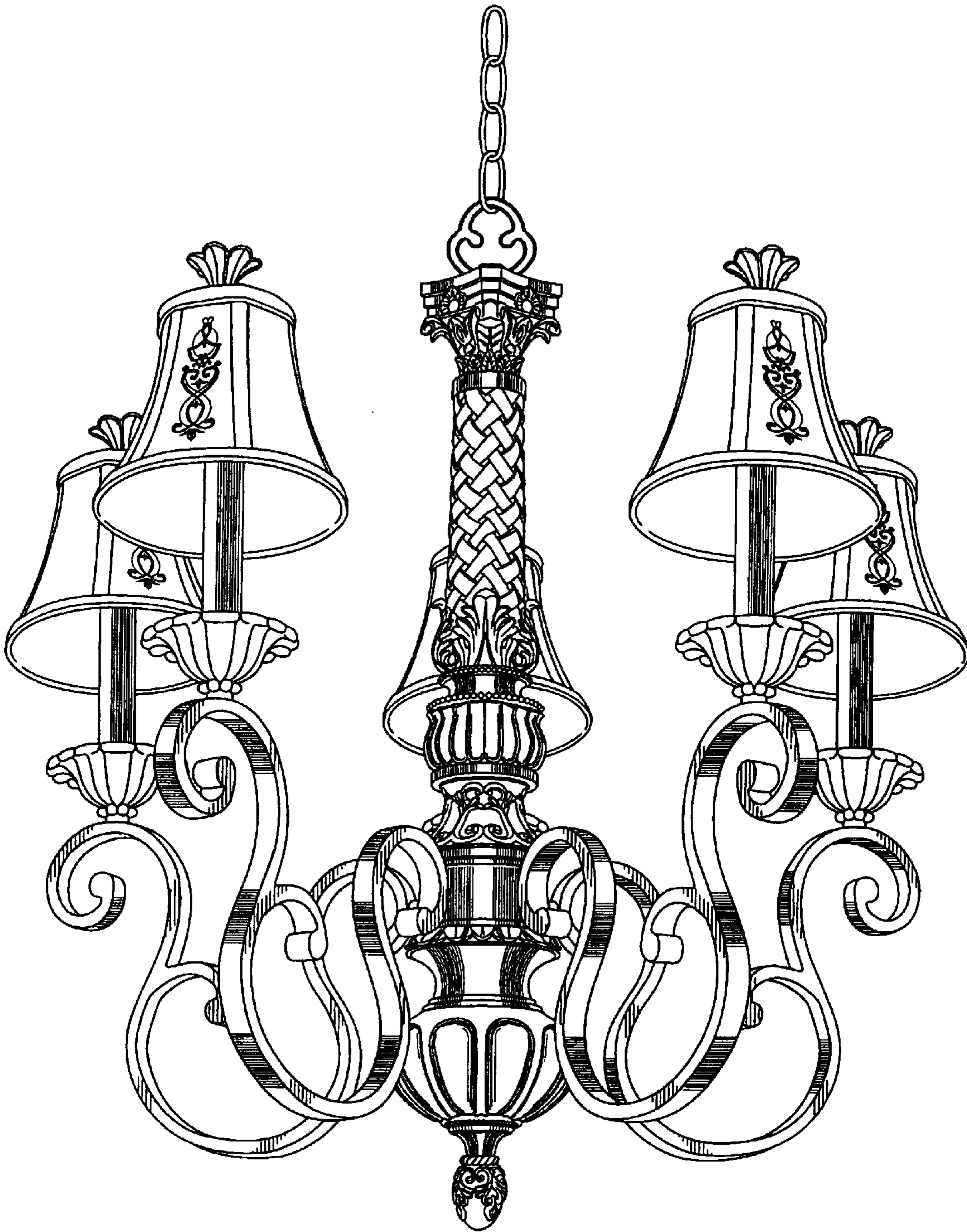

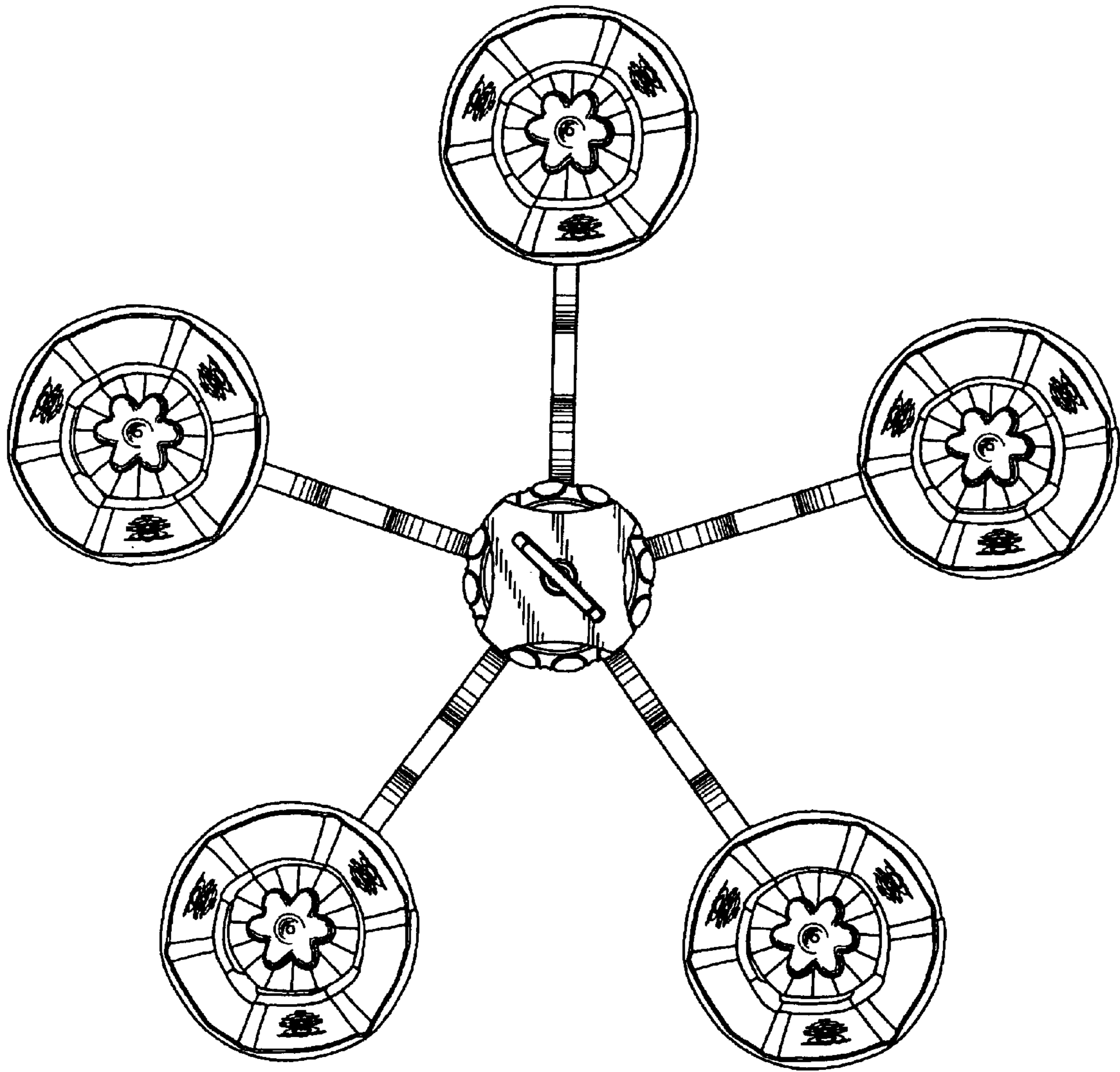

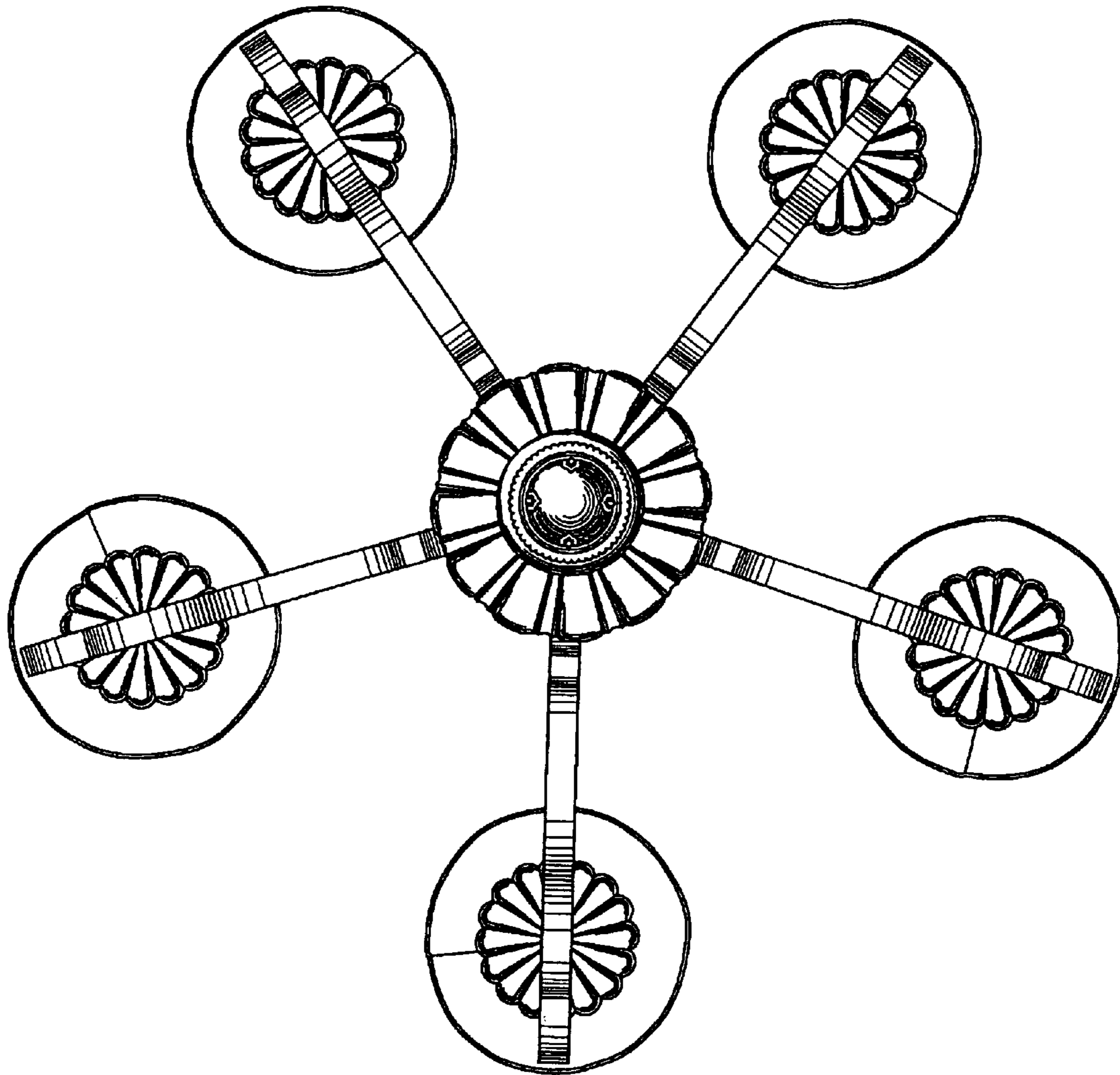

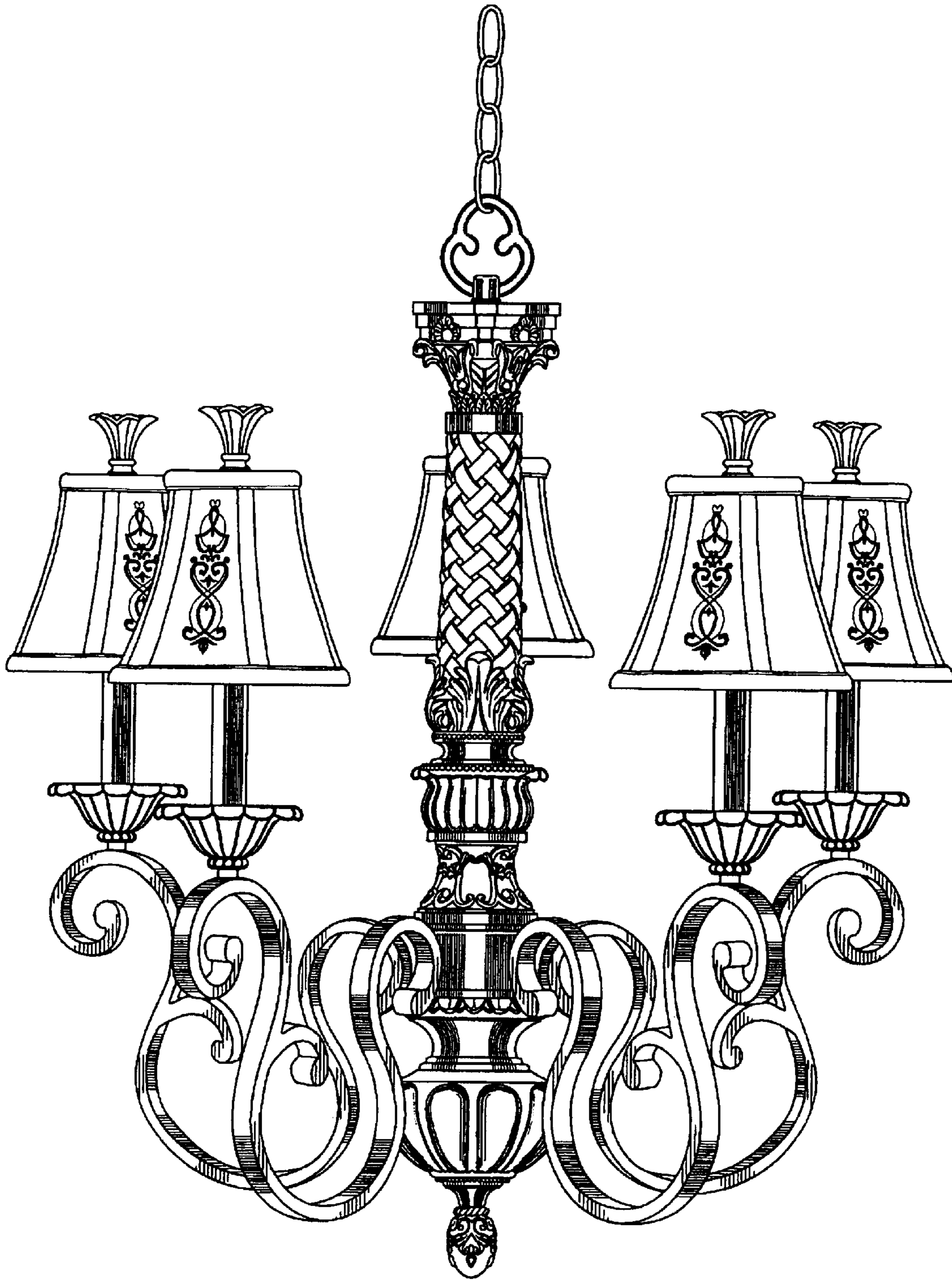




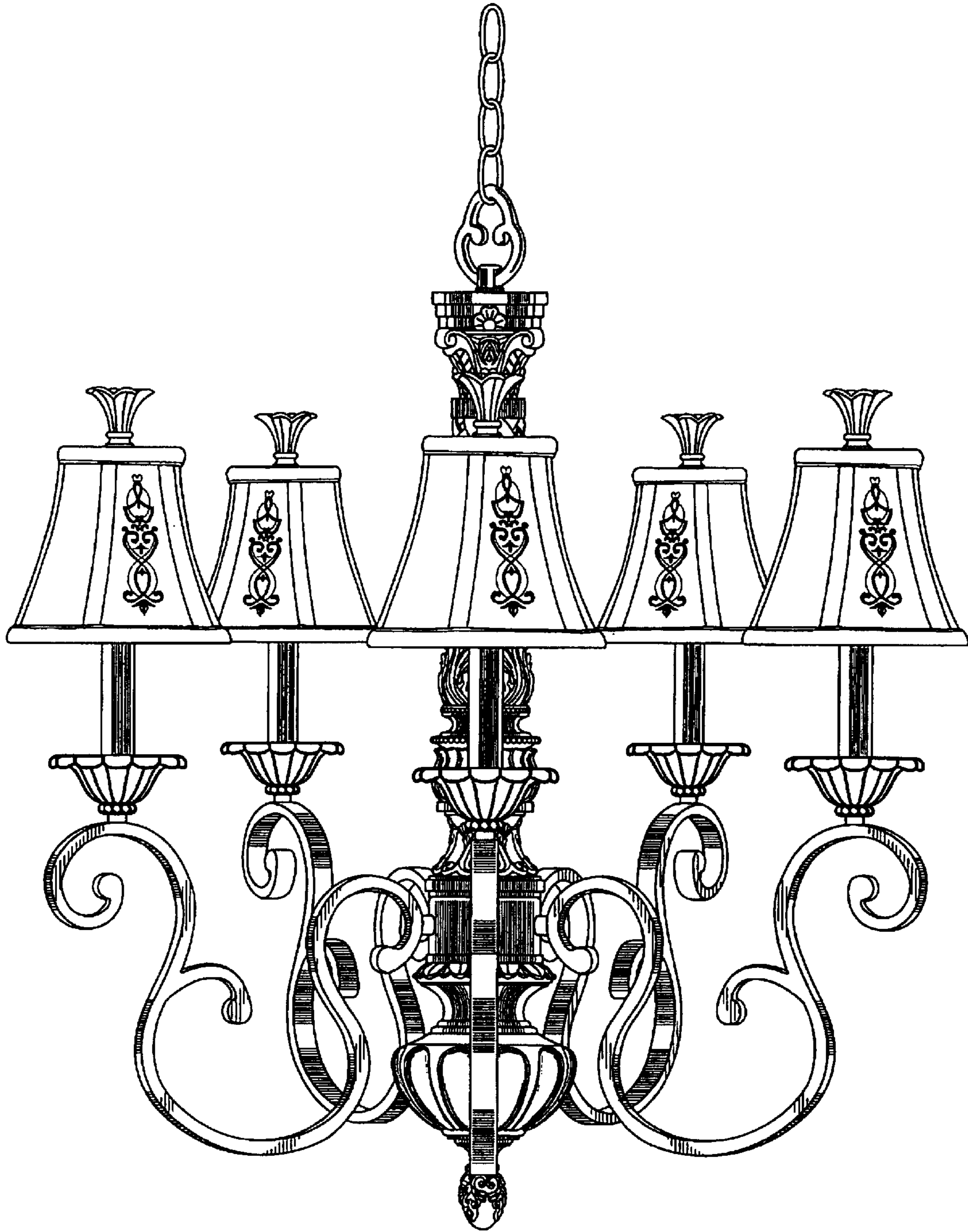

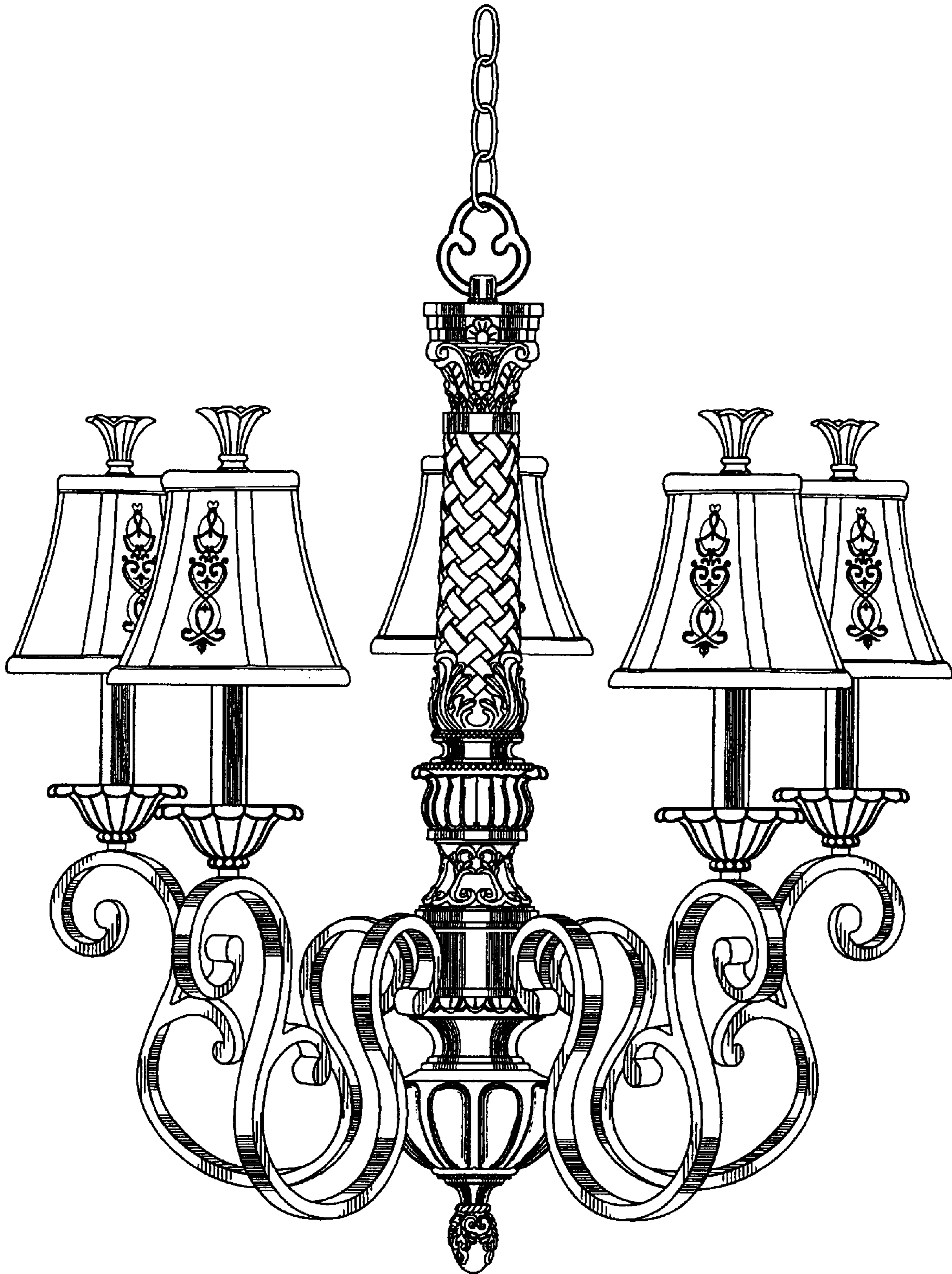

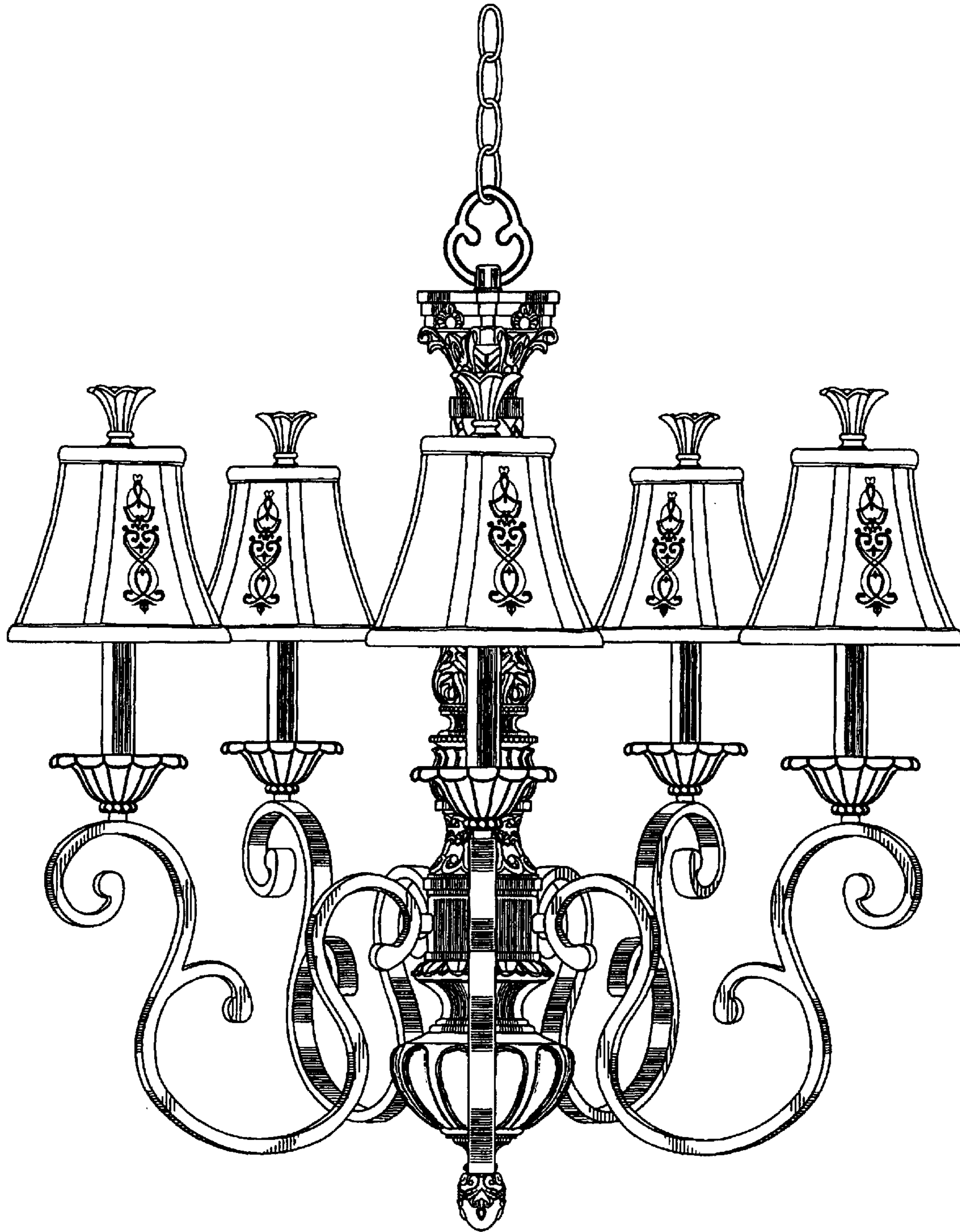

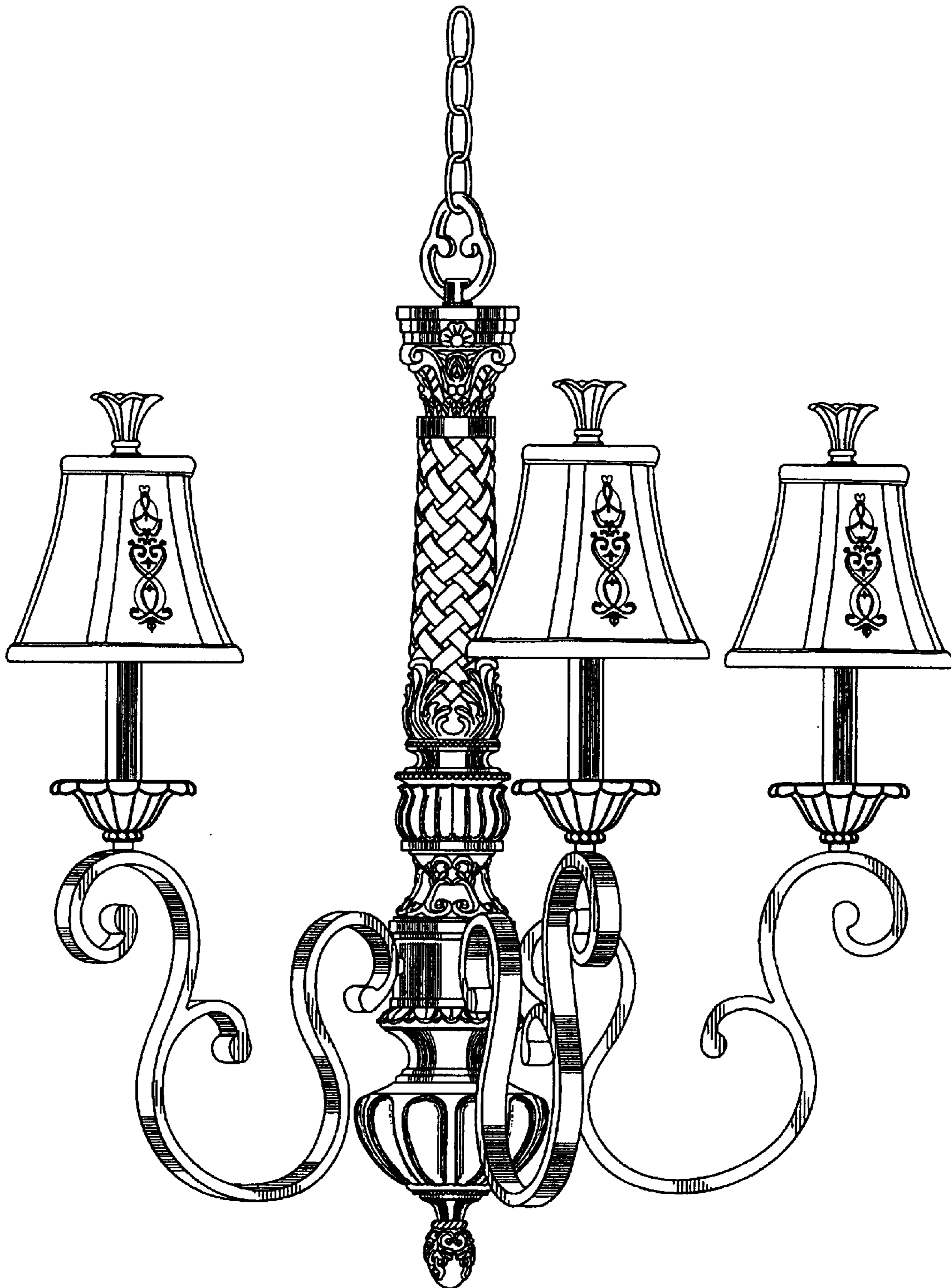
