The ornamental design for a pendant light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pendant light showing the new design;

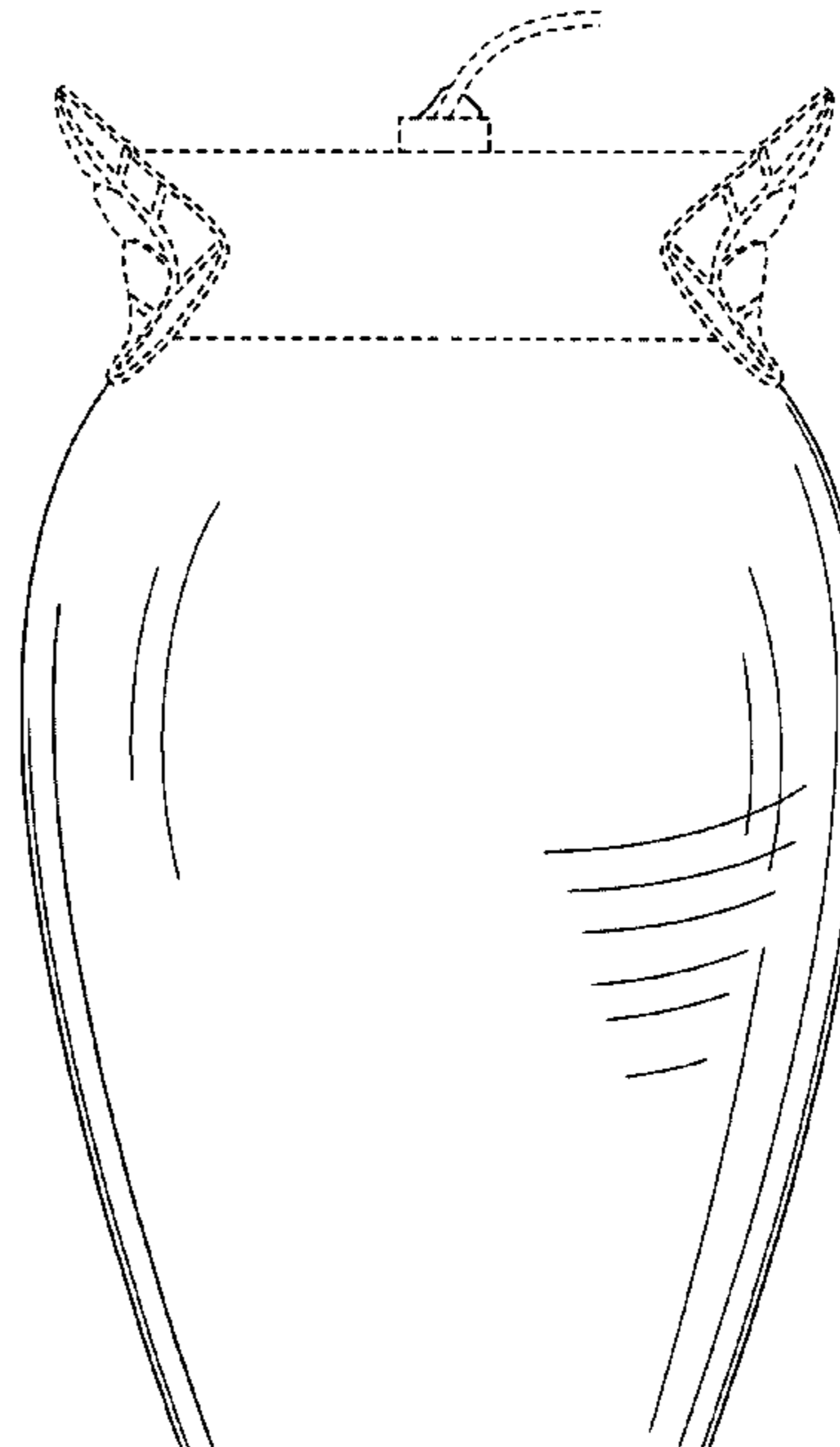
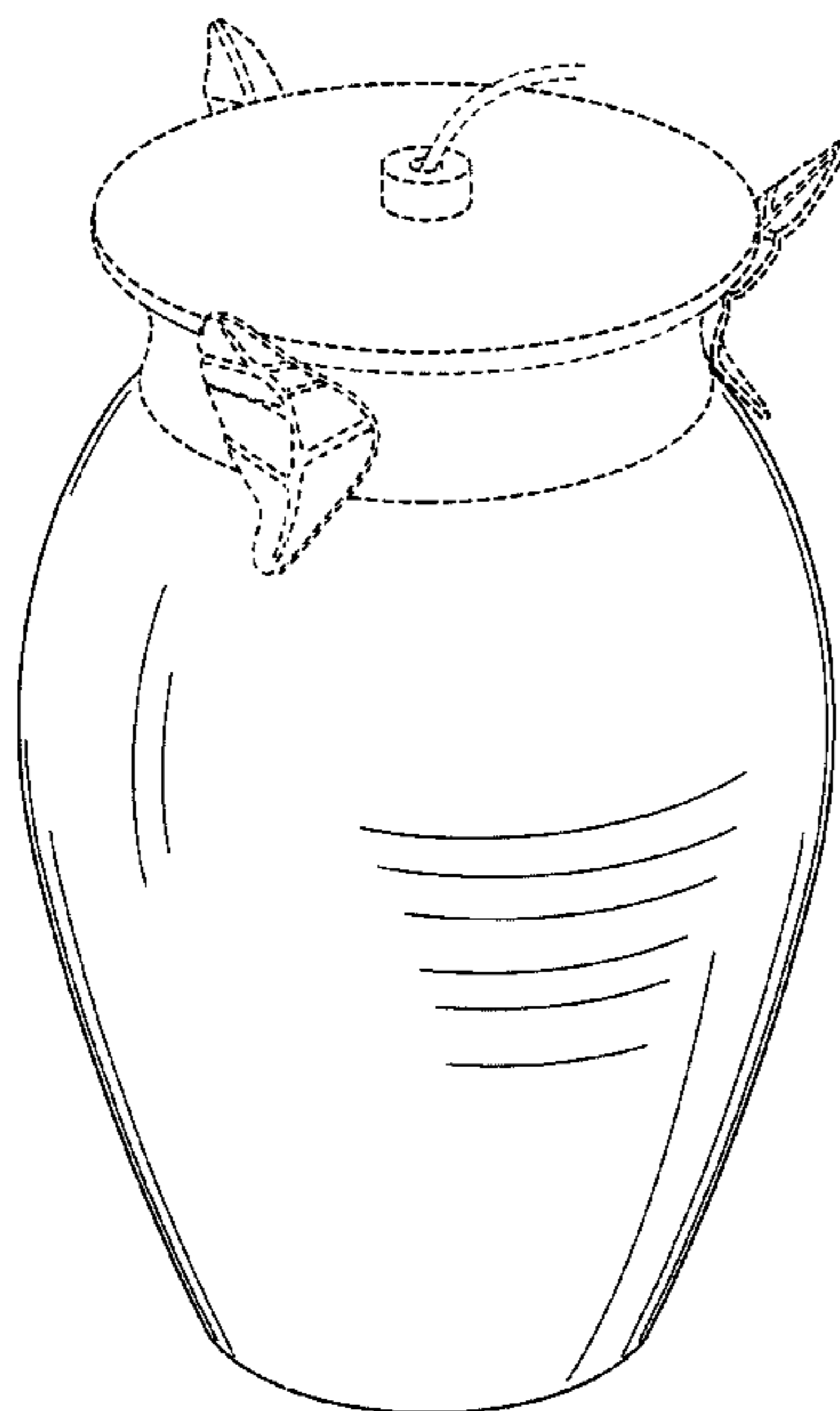
FIG. 2 is a side elevational view of the pendant light as shown in FIG. 1;

FIG. 3 is an opposite side elevational view of the pendant light as shown in FIG. 1; and,

FIG. 4 is a bottom view of the pendant light as shown in FIG. 1.

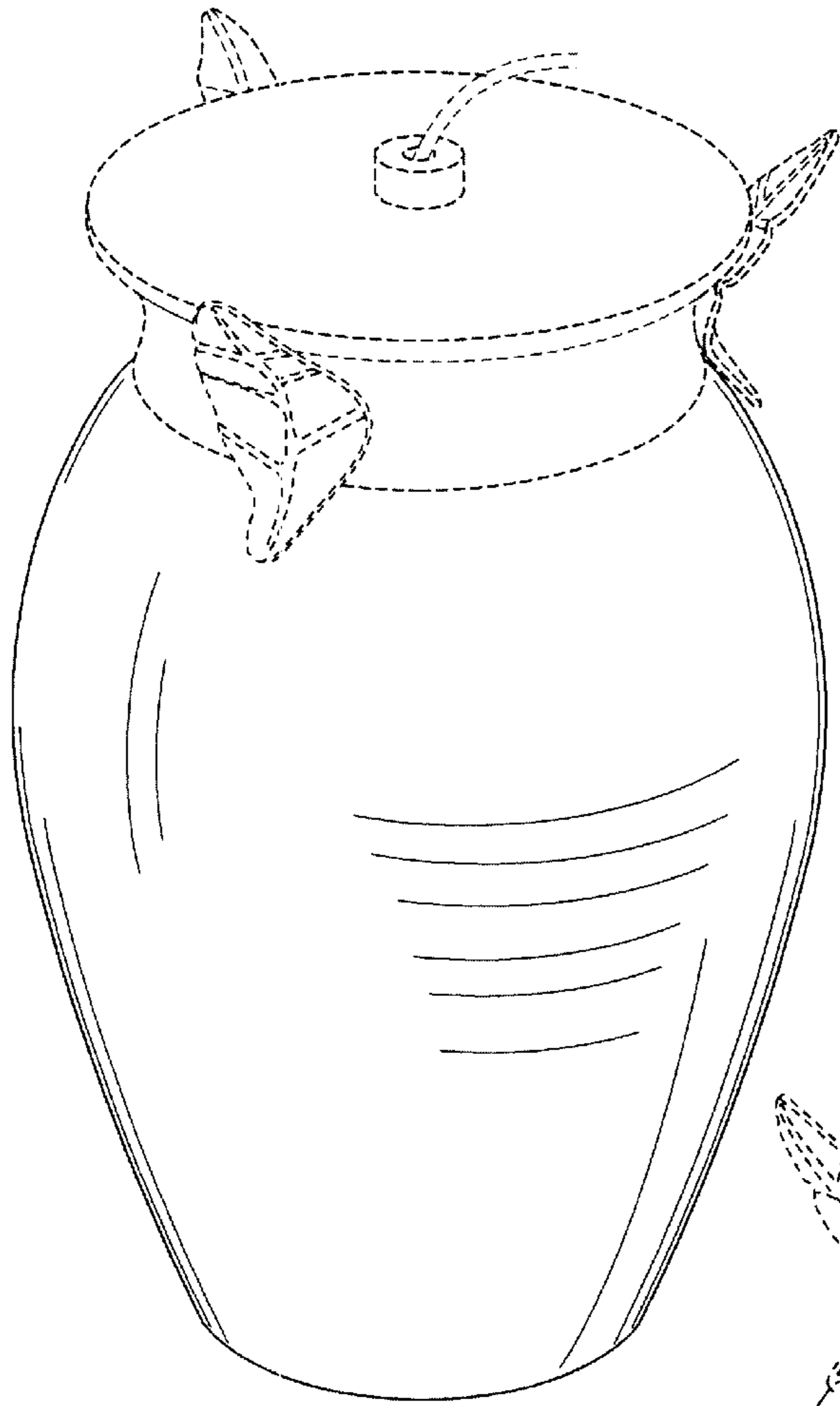

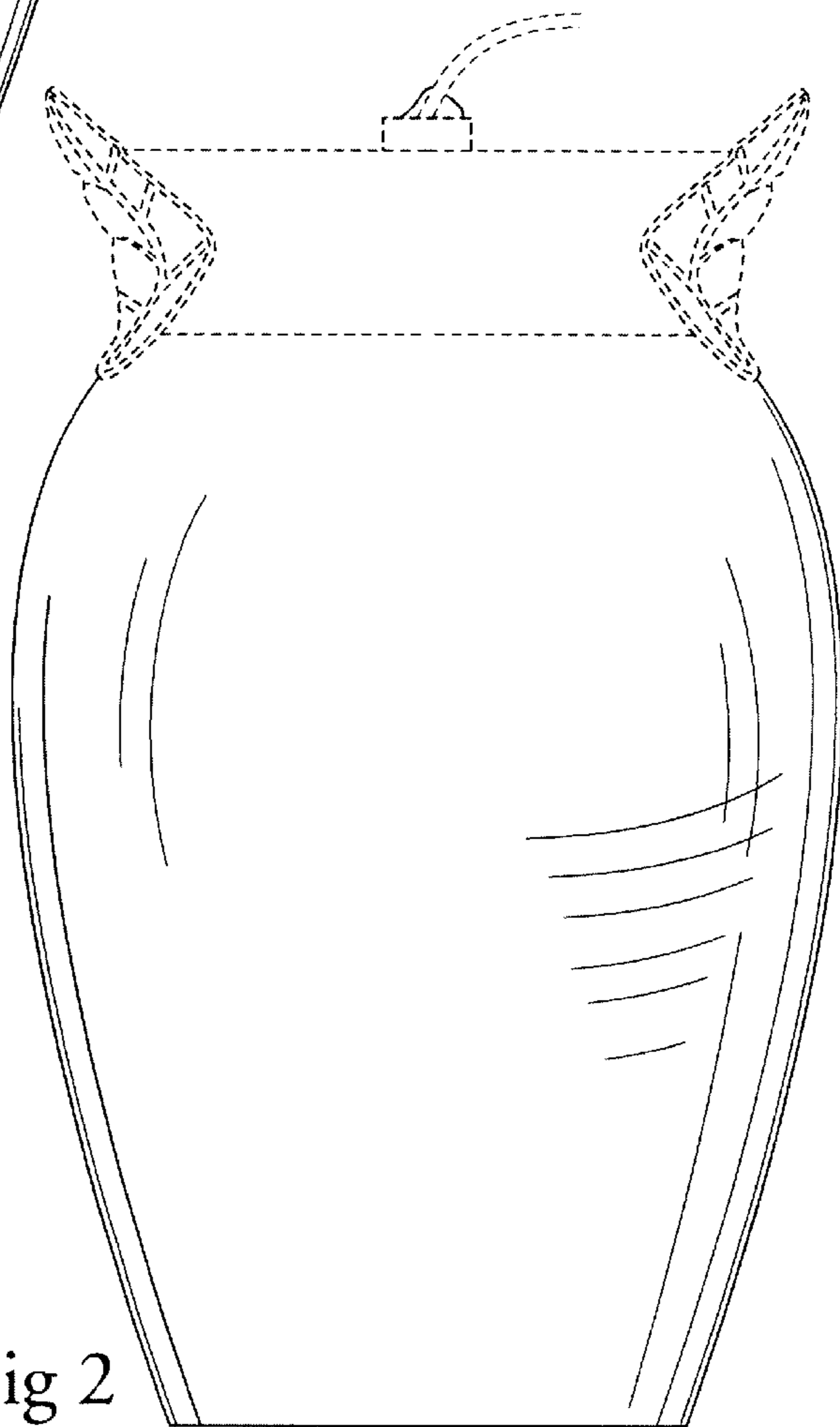

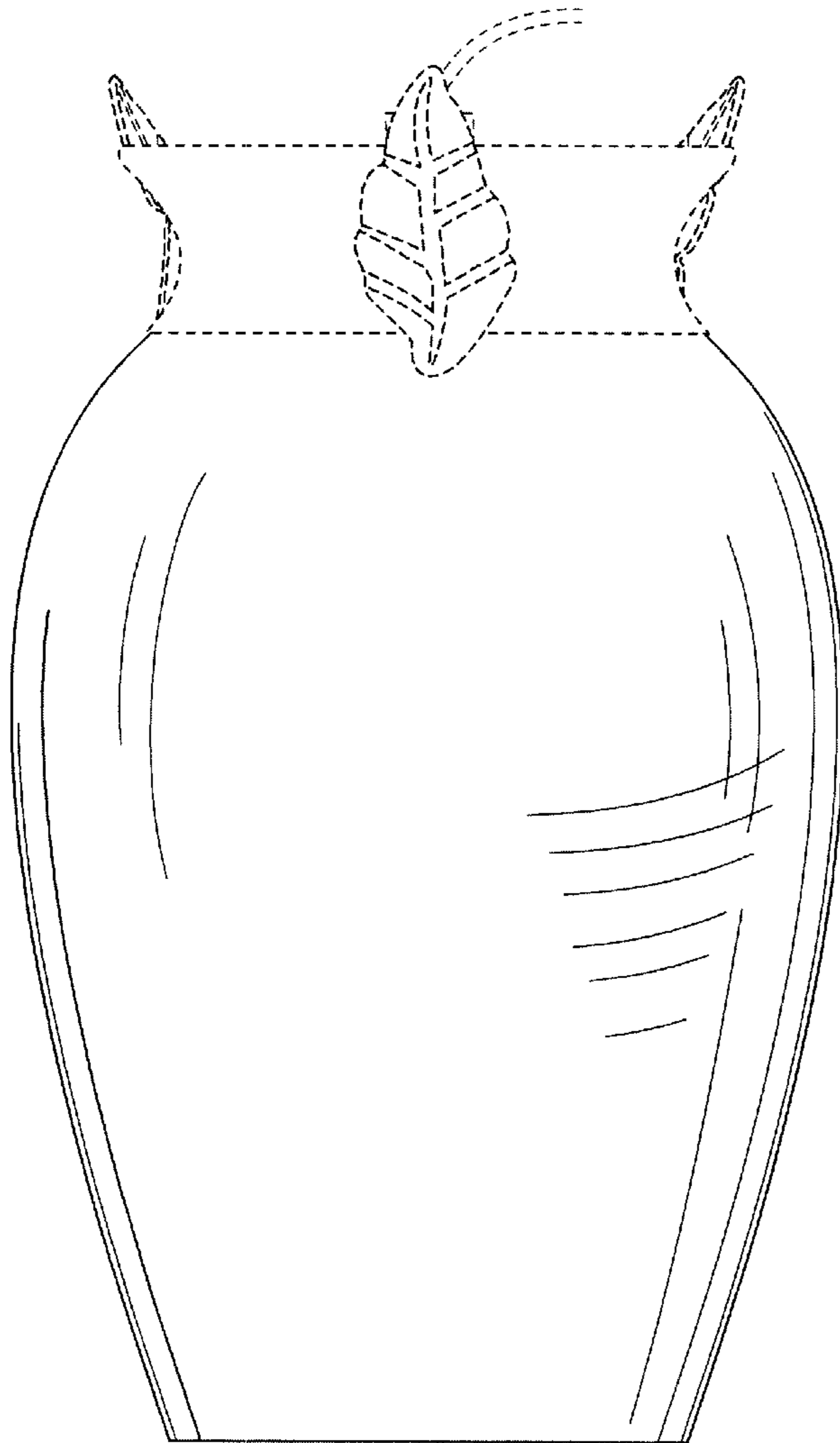

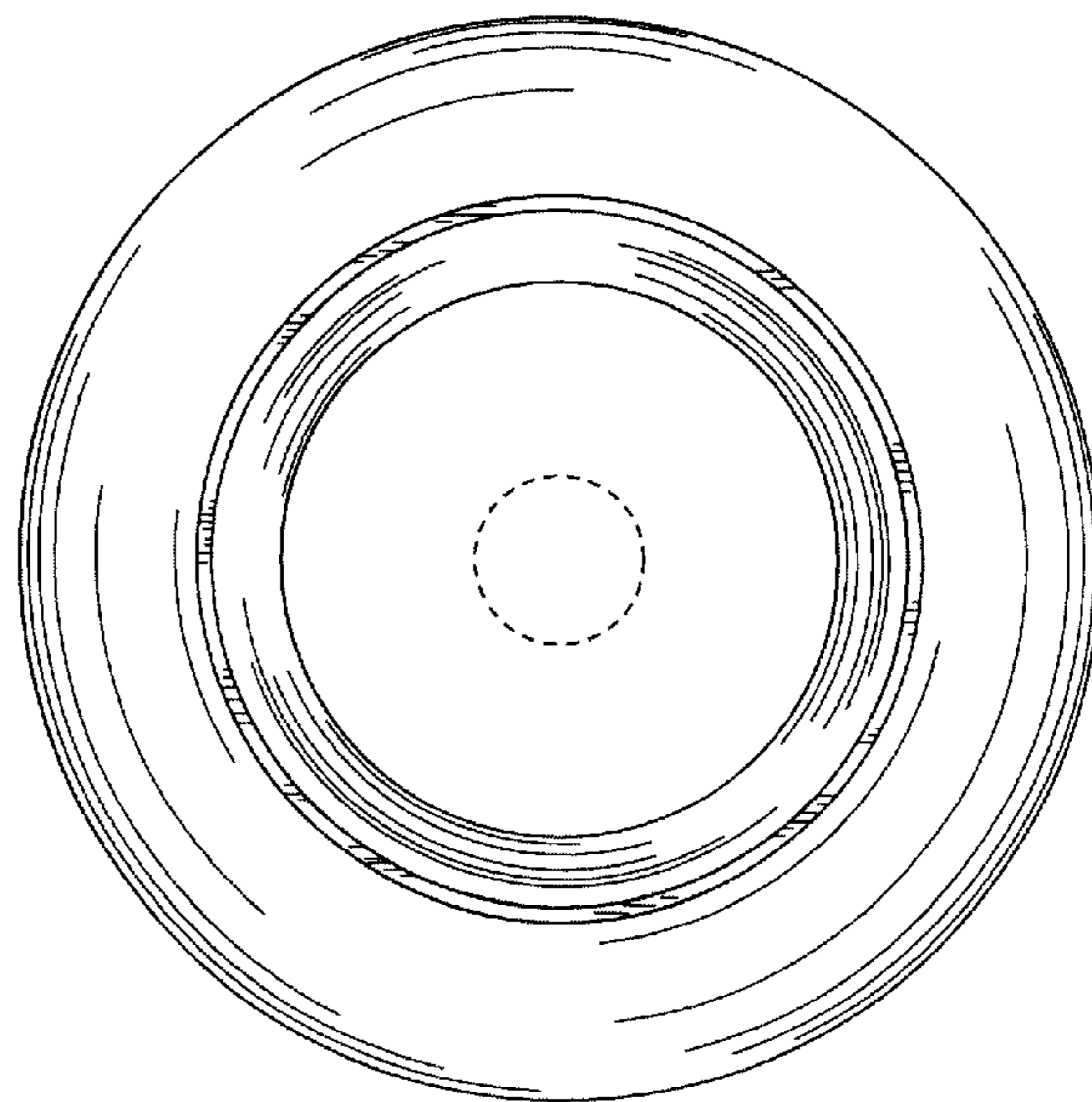
