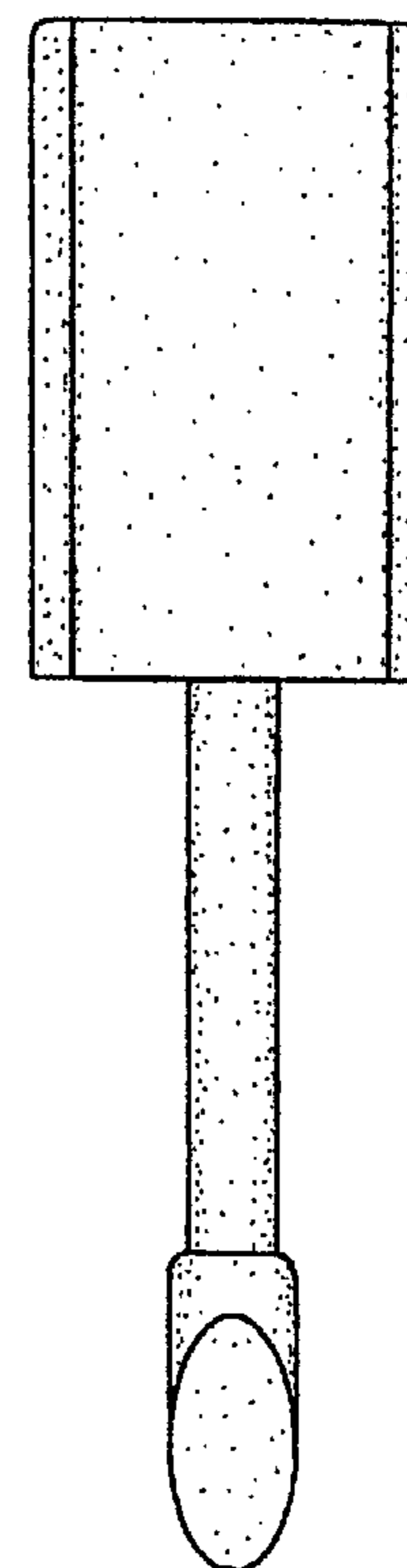
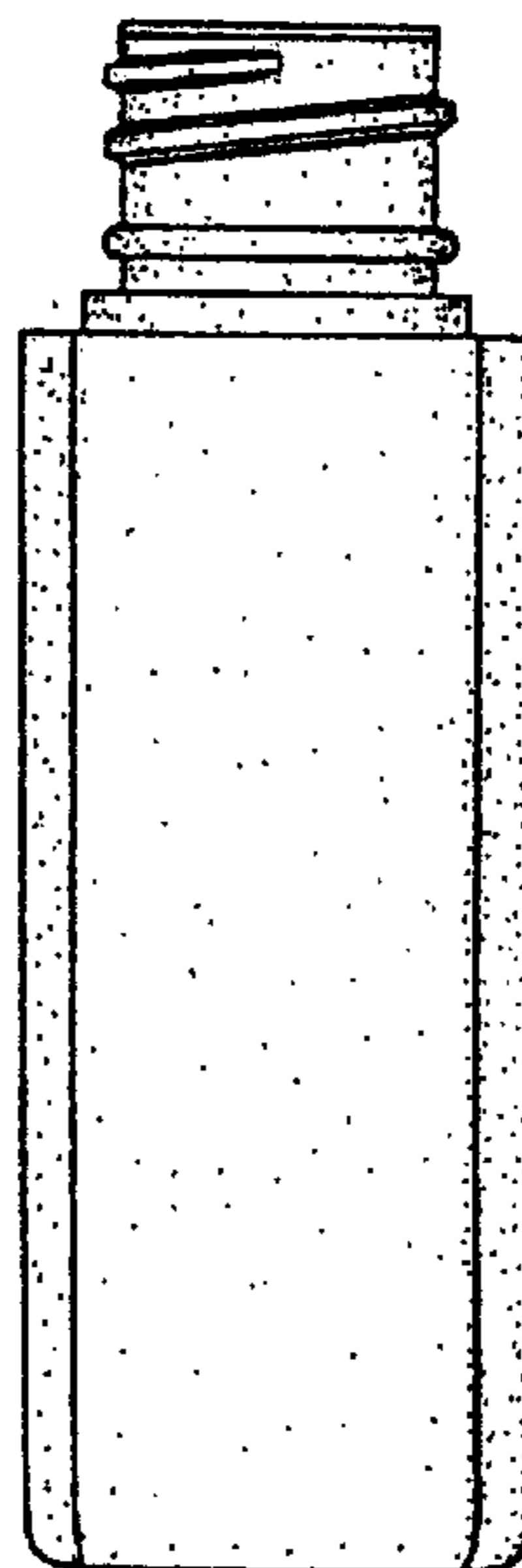
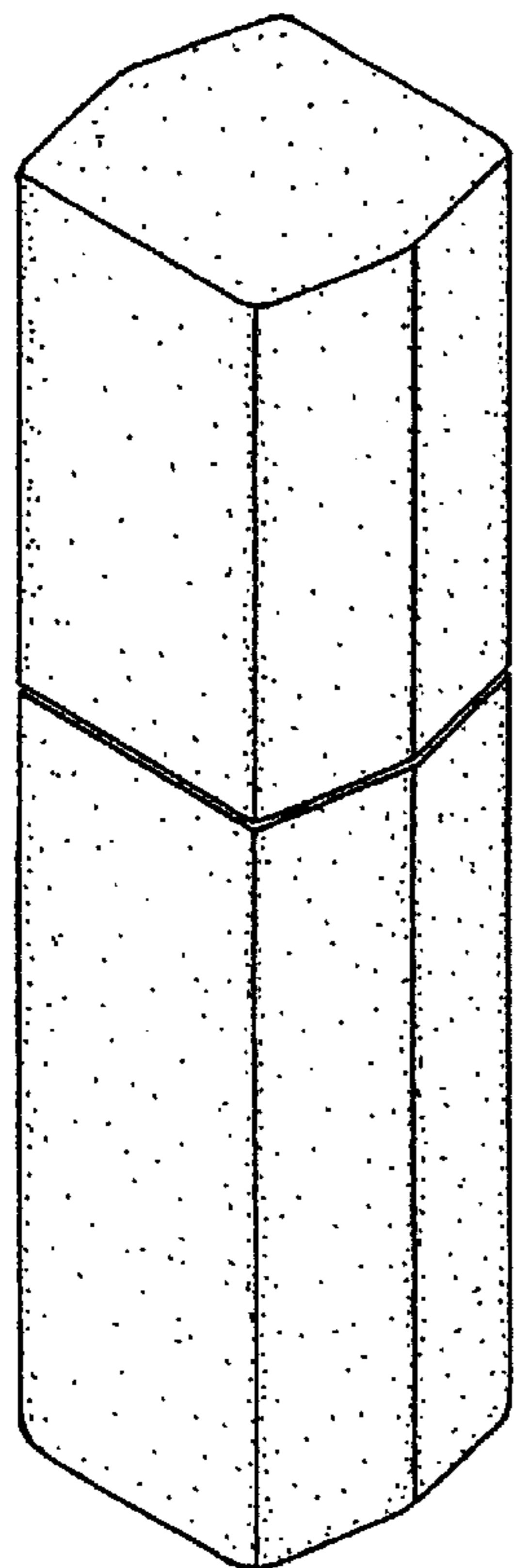
(57) **CLAIM**

The ornamental design for a container for lip gloss, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container for lip gloss showing our new design;  
 FIG. 2 is a front view thereof, a rear view being the same as the front view;  
 FIG. 3 is a right side view thereof, a left side view being the same as the right side view;  
 FIG. 4 is a plan view thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is a right side view of a main member of the container for lip gloss;  
 FIG. 7 is a front view of a cap of the container for lip gloss; and,  
 FIG. 8 is a left side view of the cap of the container for lip gloss.  
 For convenience of illustration, the cap and main member of the container are disclosed separately.

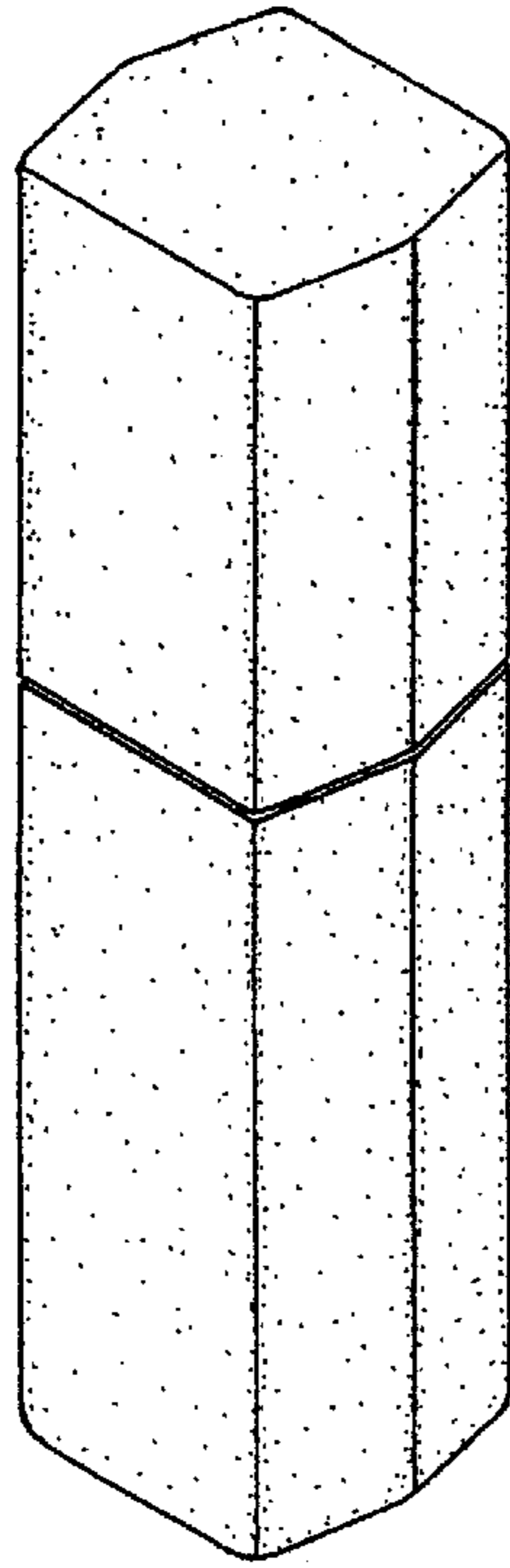

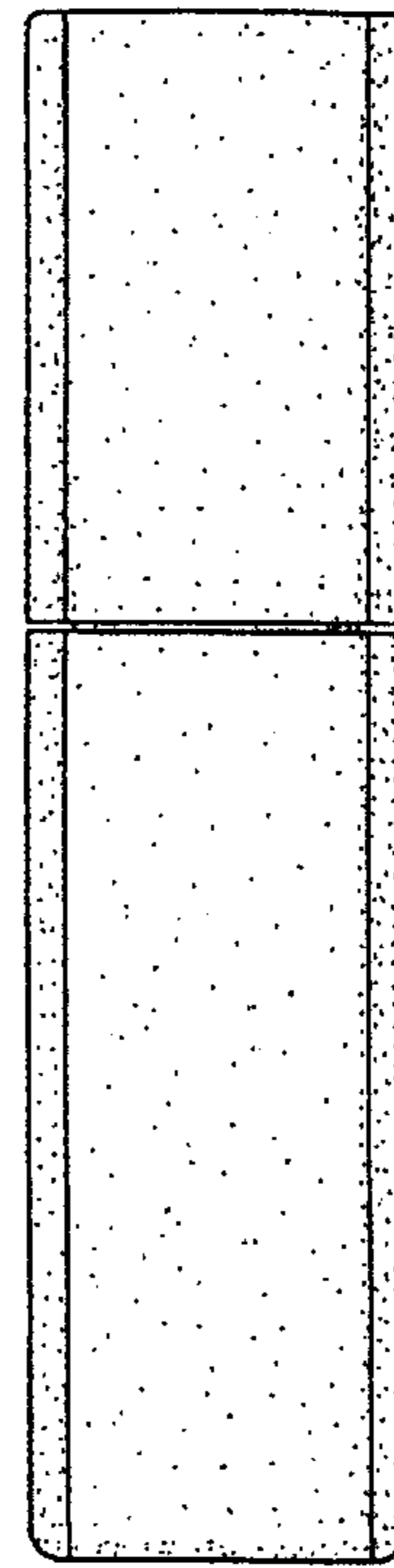

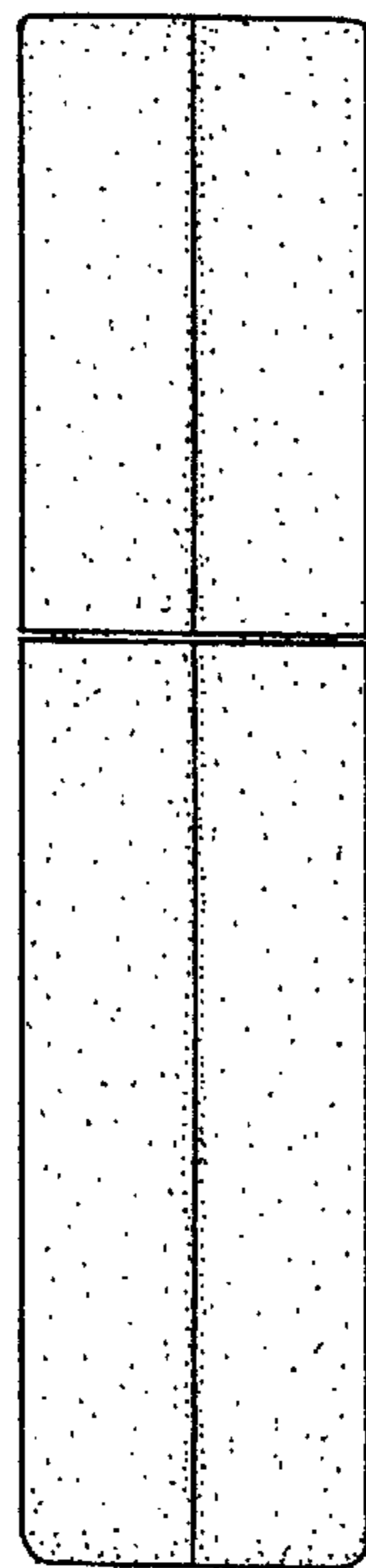

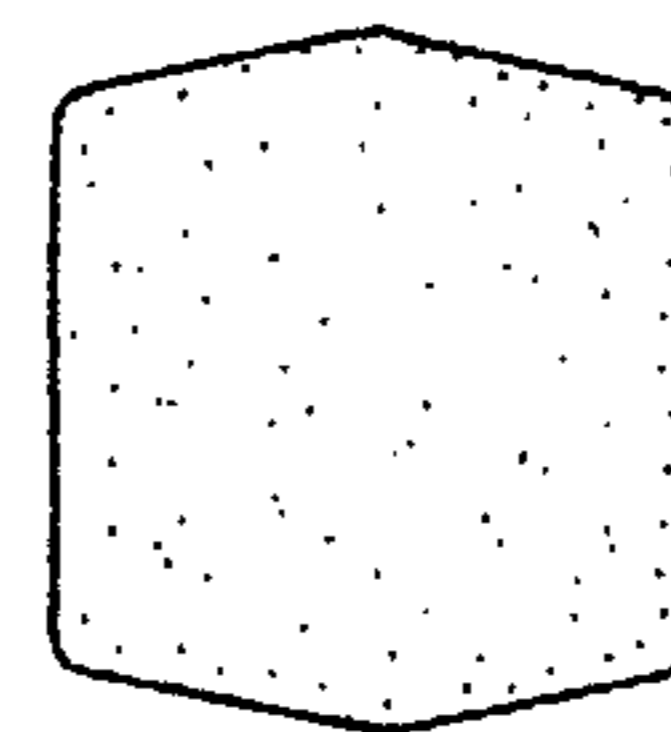

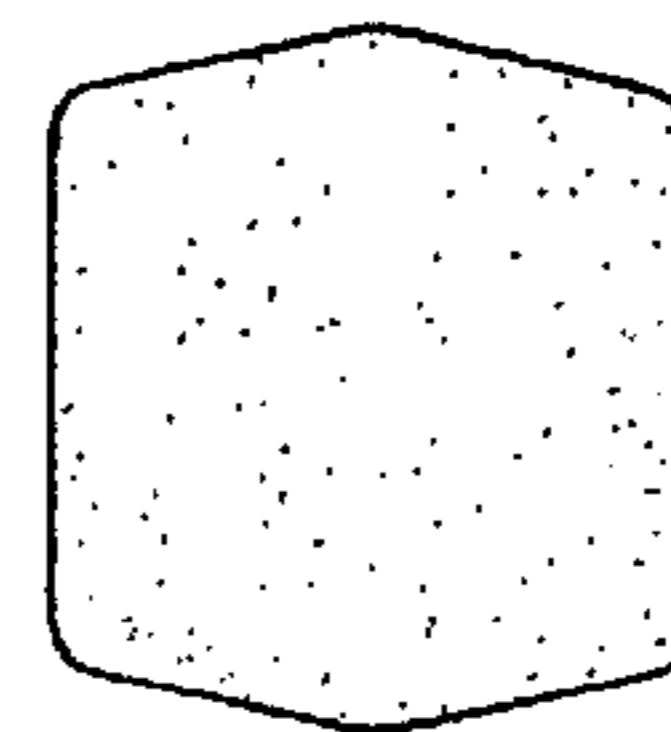

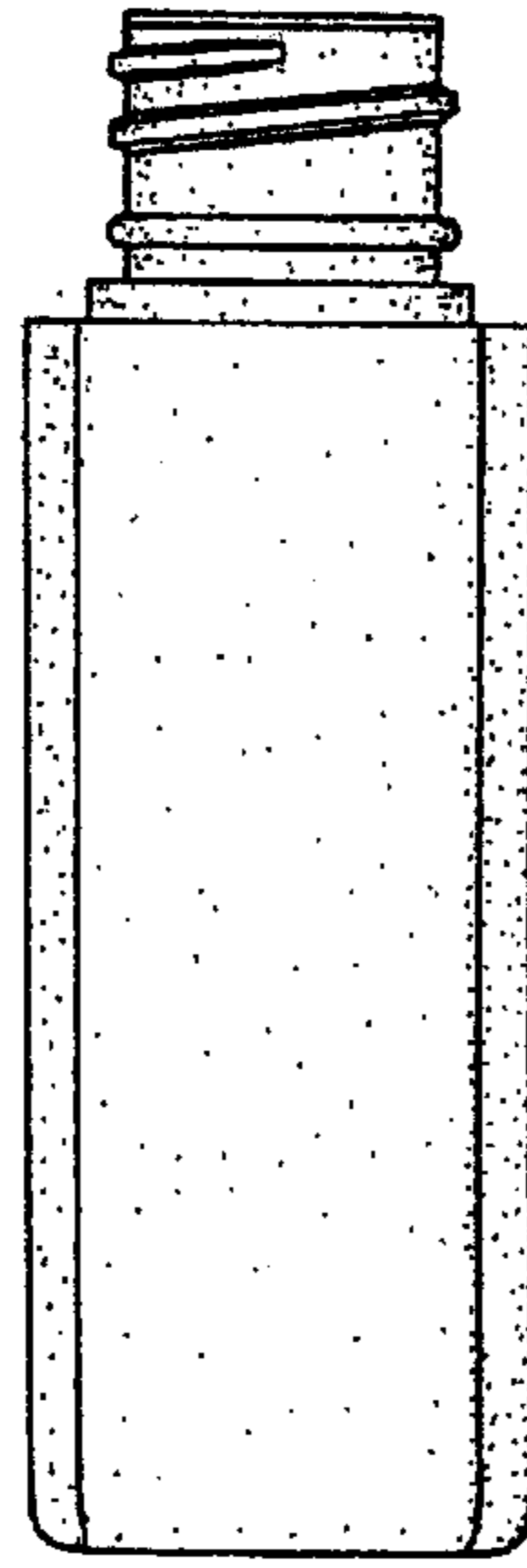

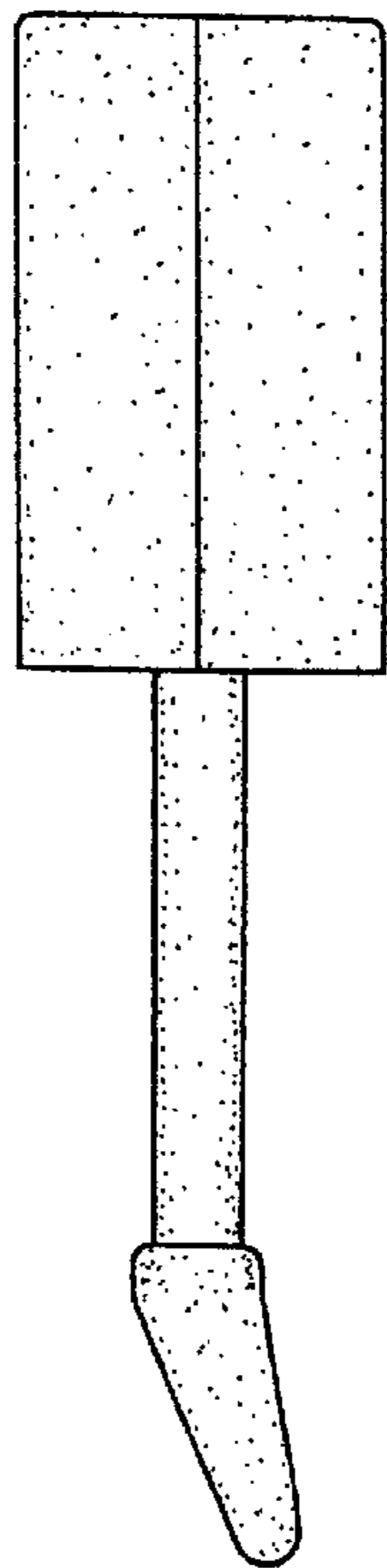

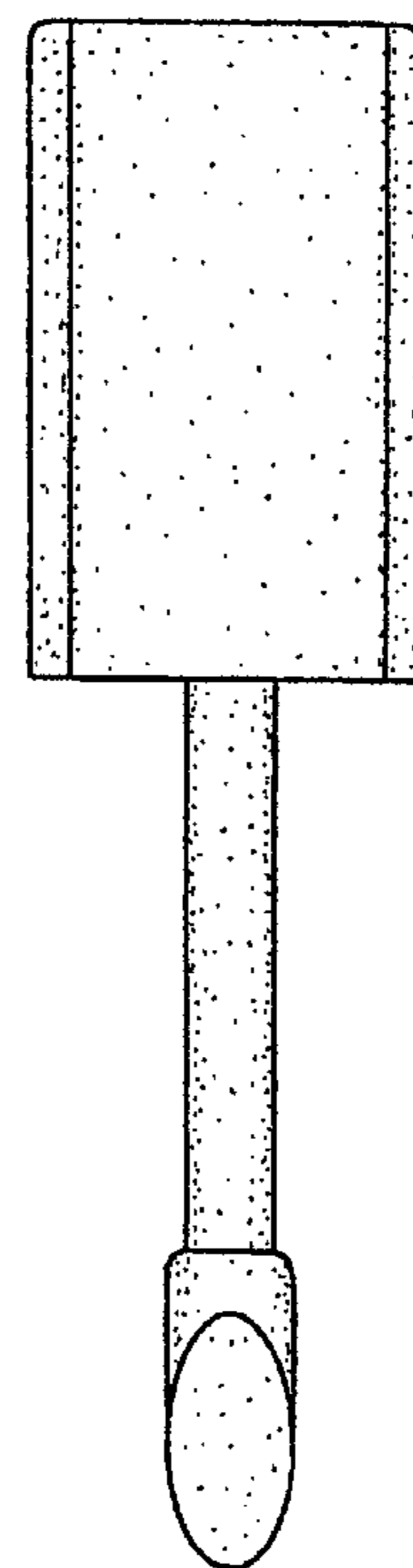
