DESCRIPTION

FIG. 1 is a perspective view of a hoist showing our new design;

FIG. 2 is a front elevational view of FIG. 1;

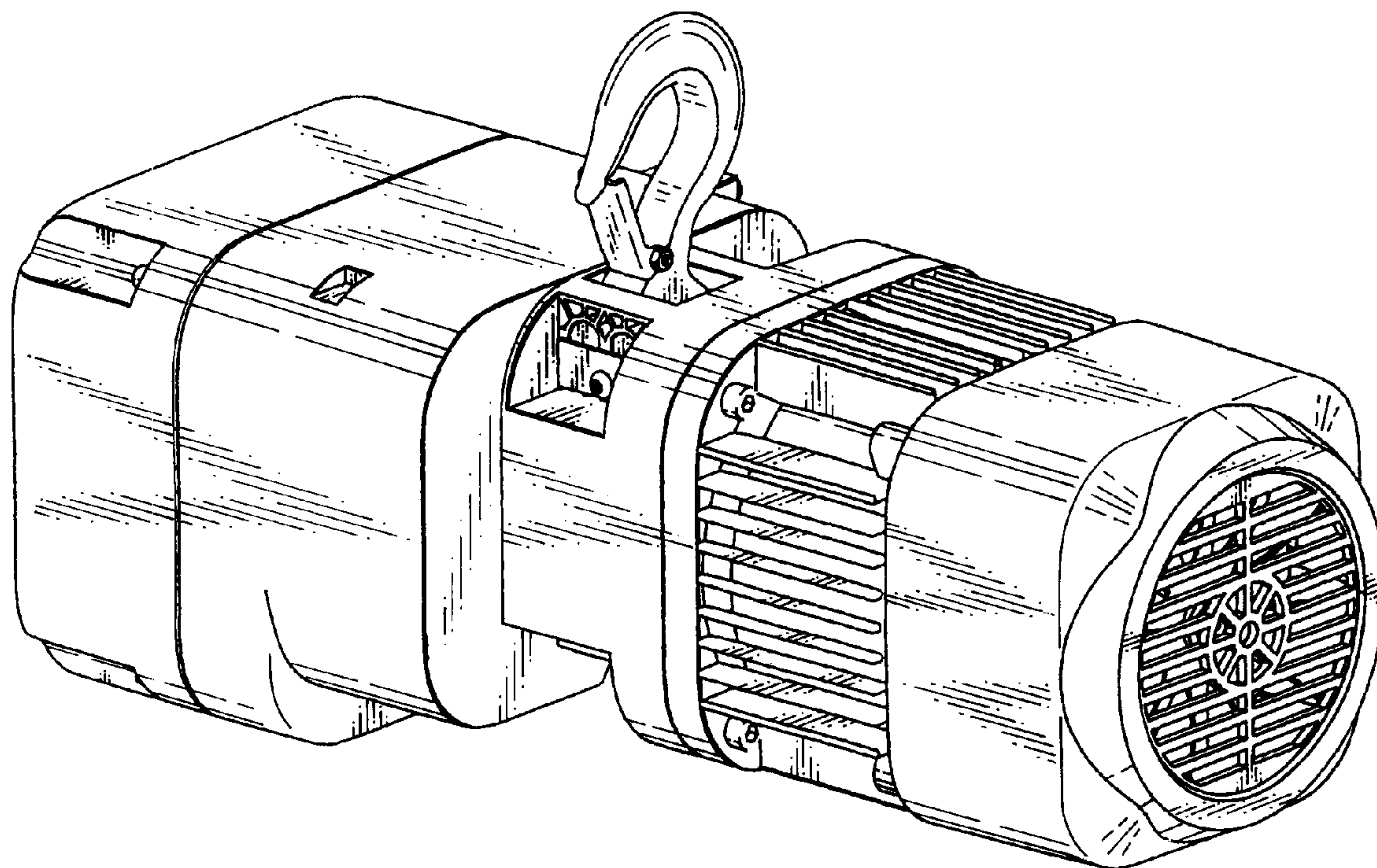

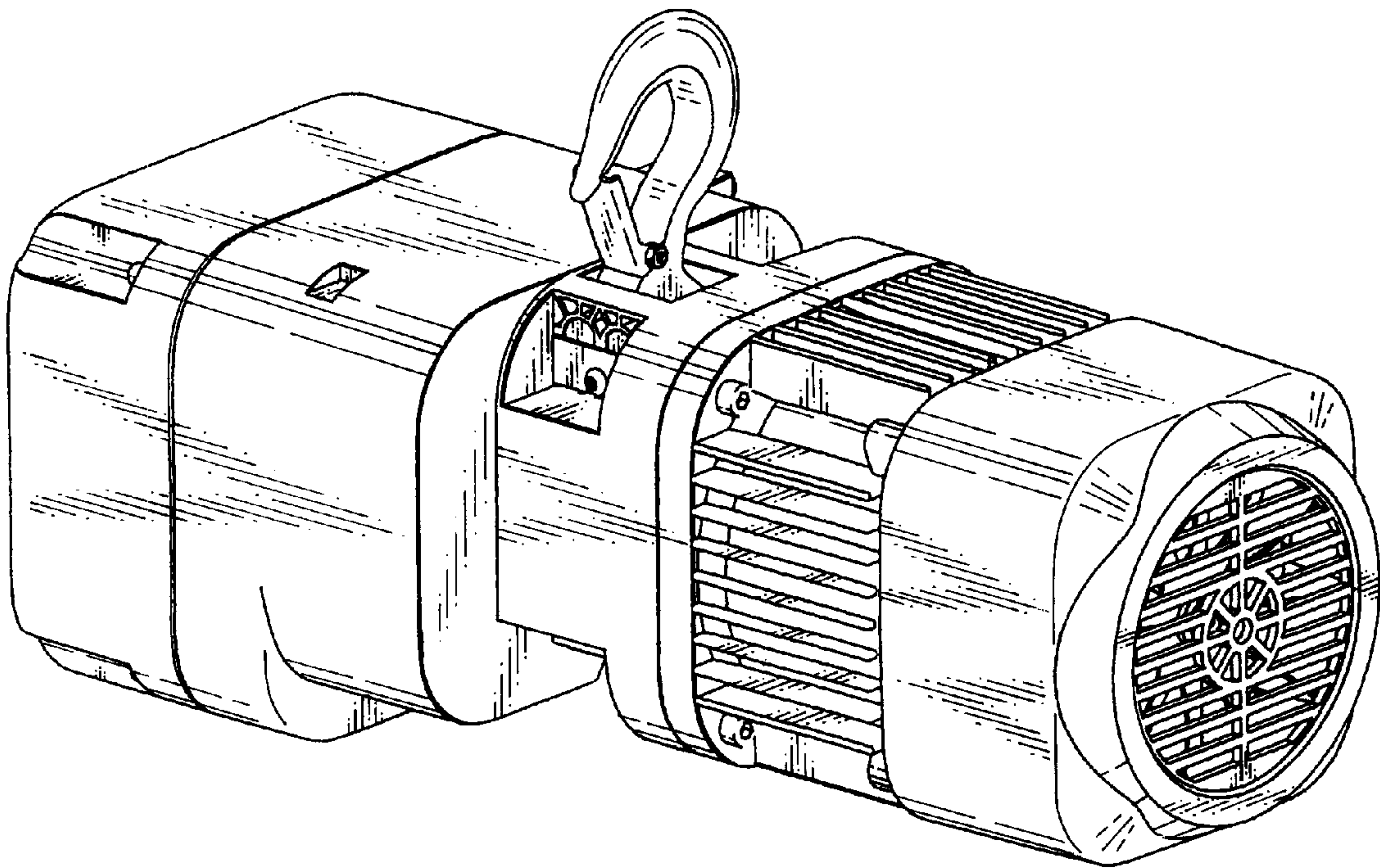

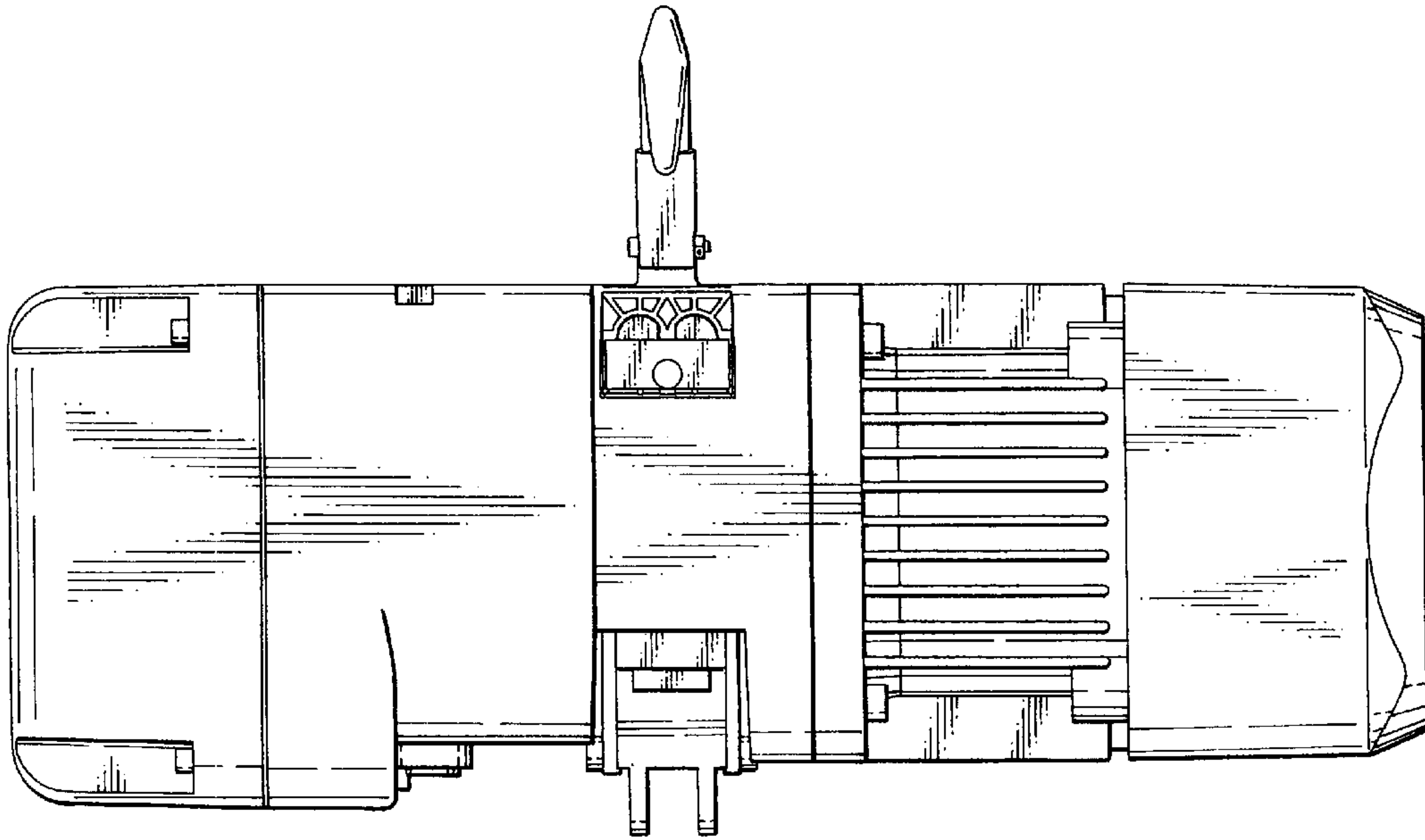

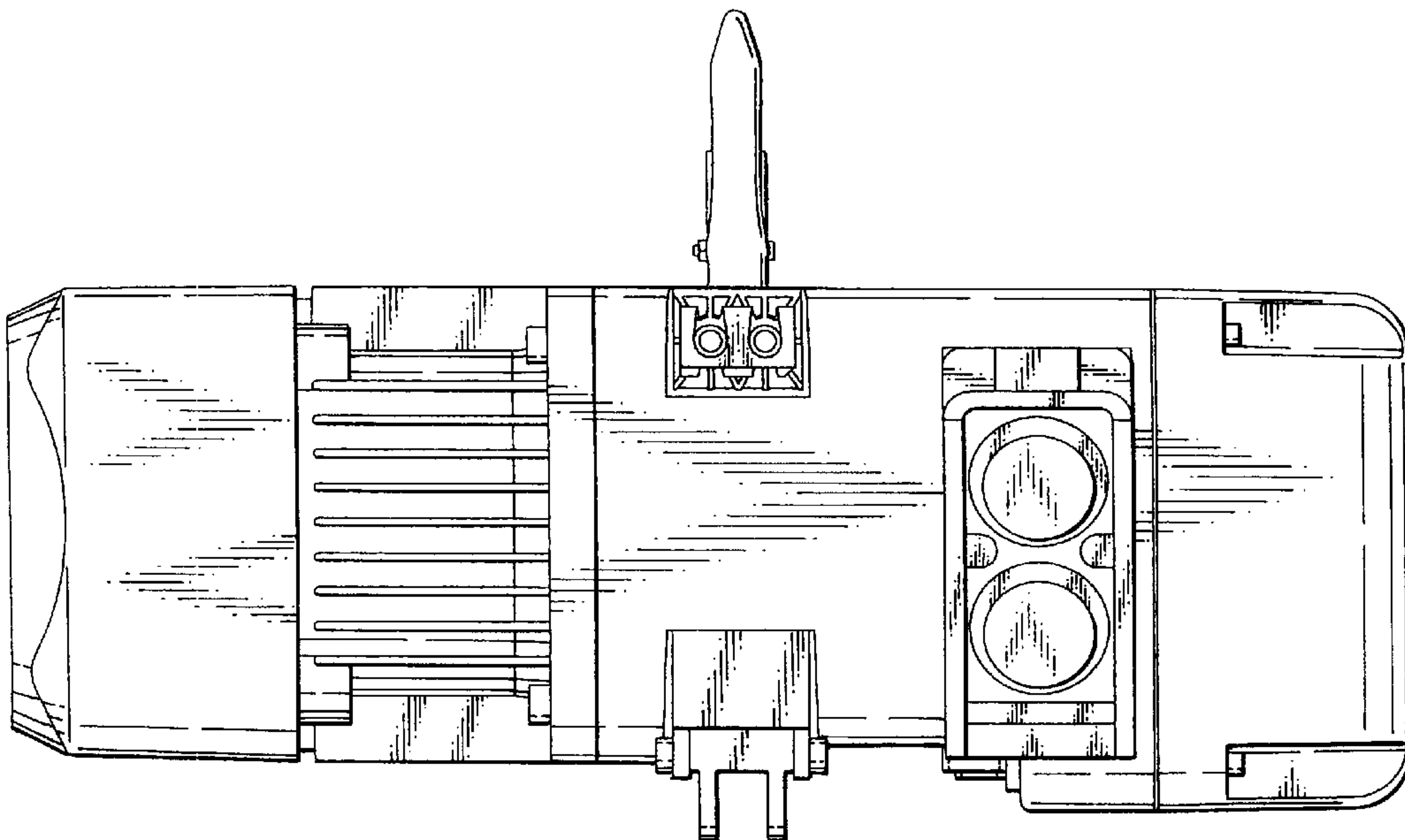

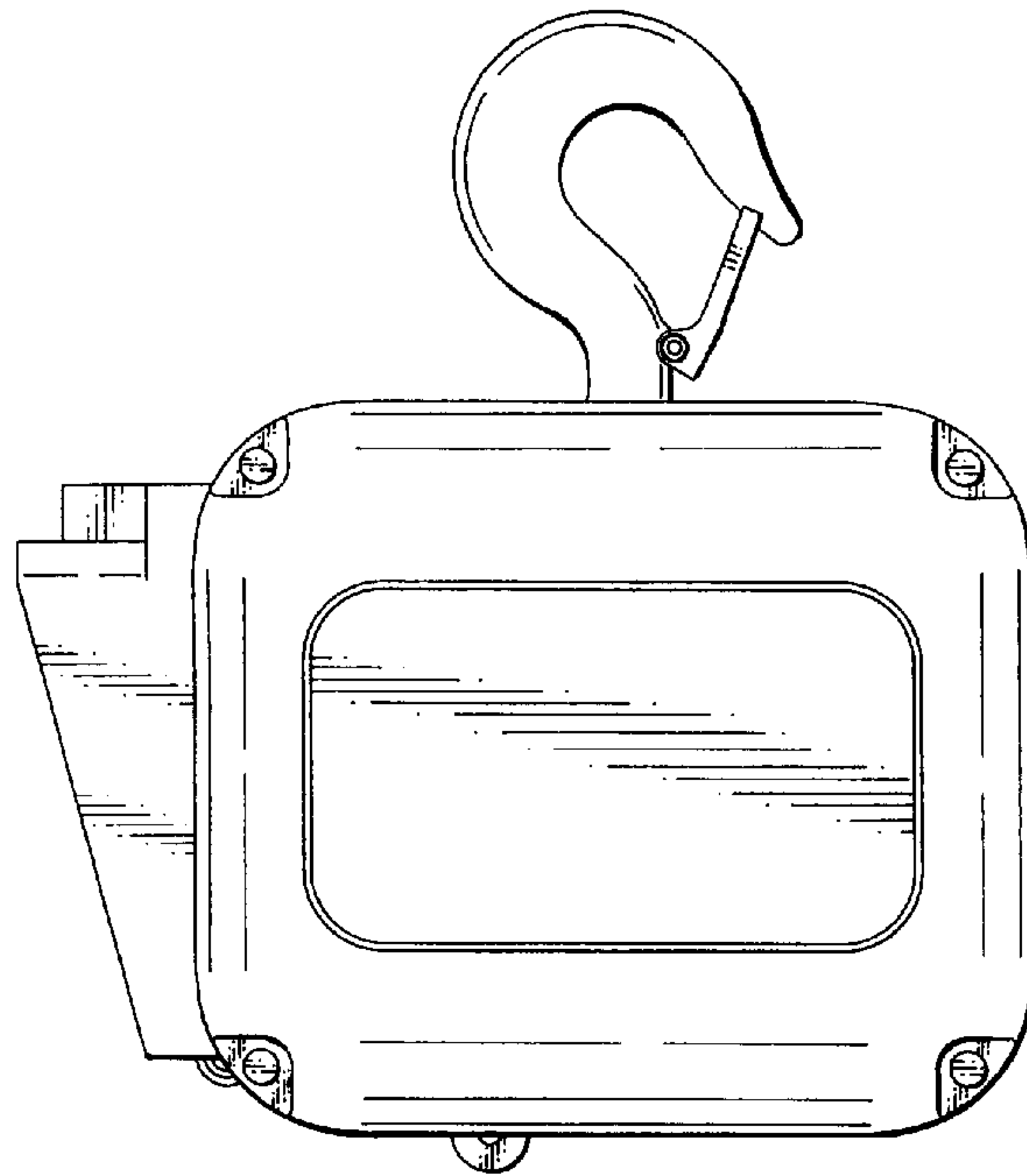

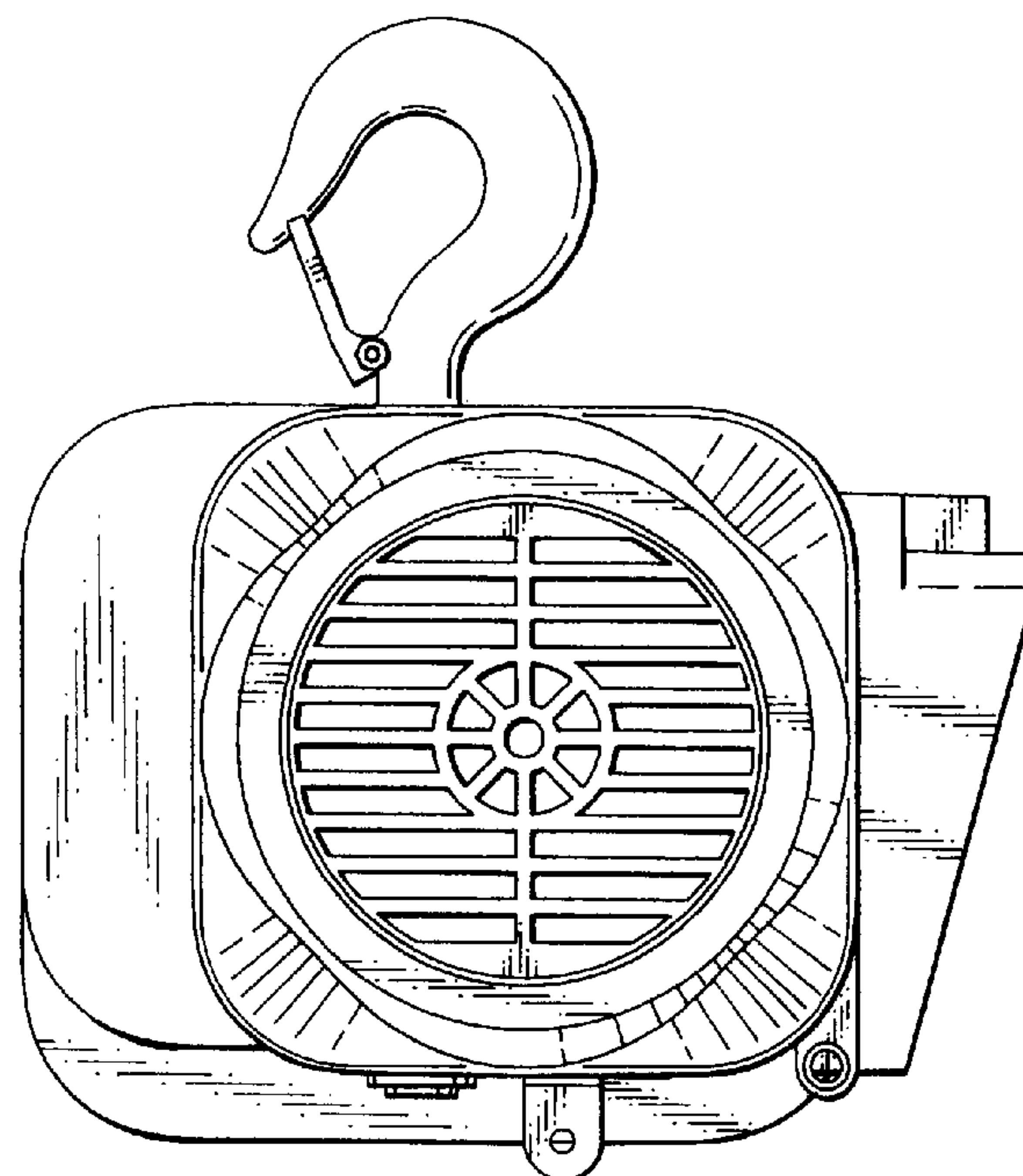

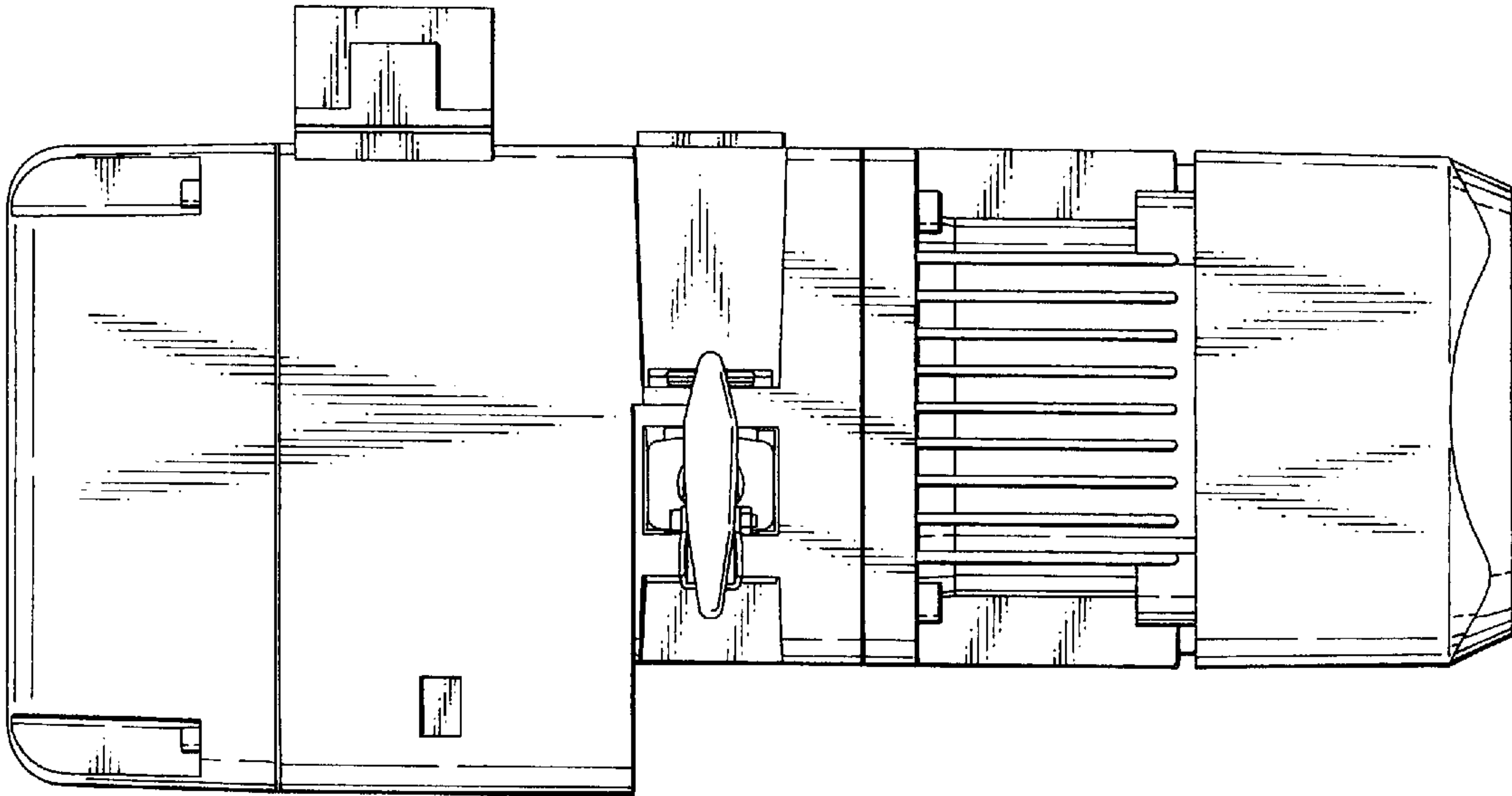
