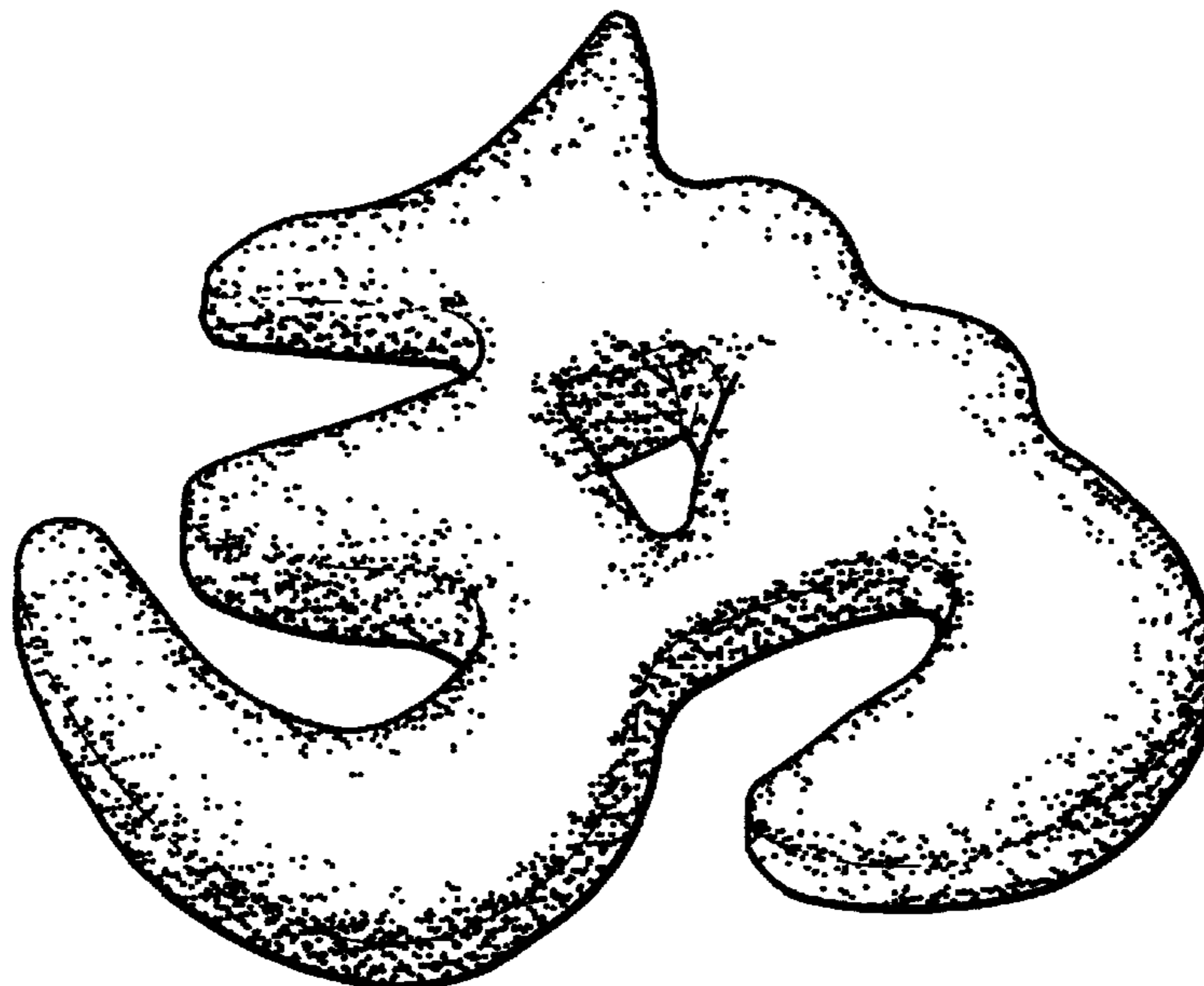

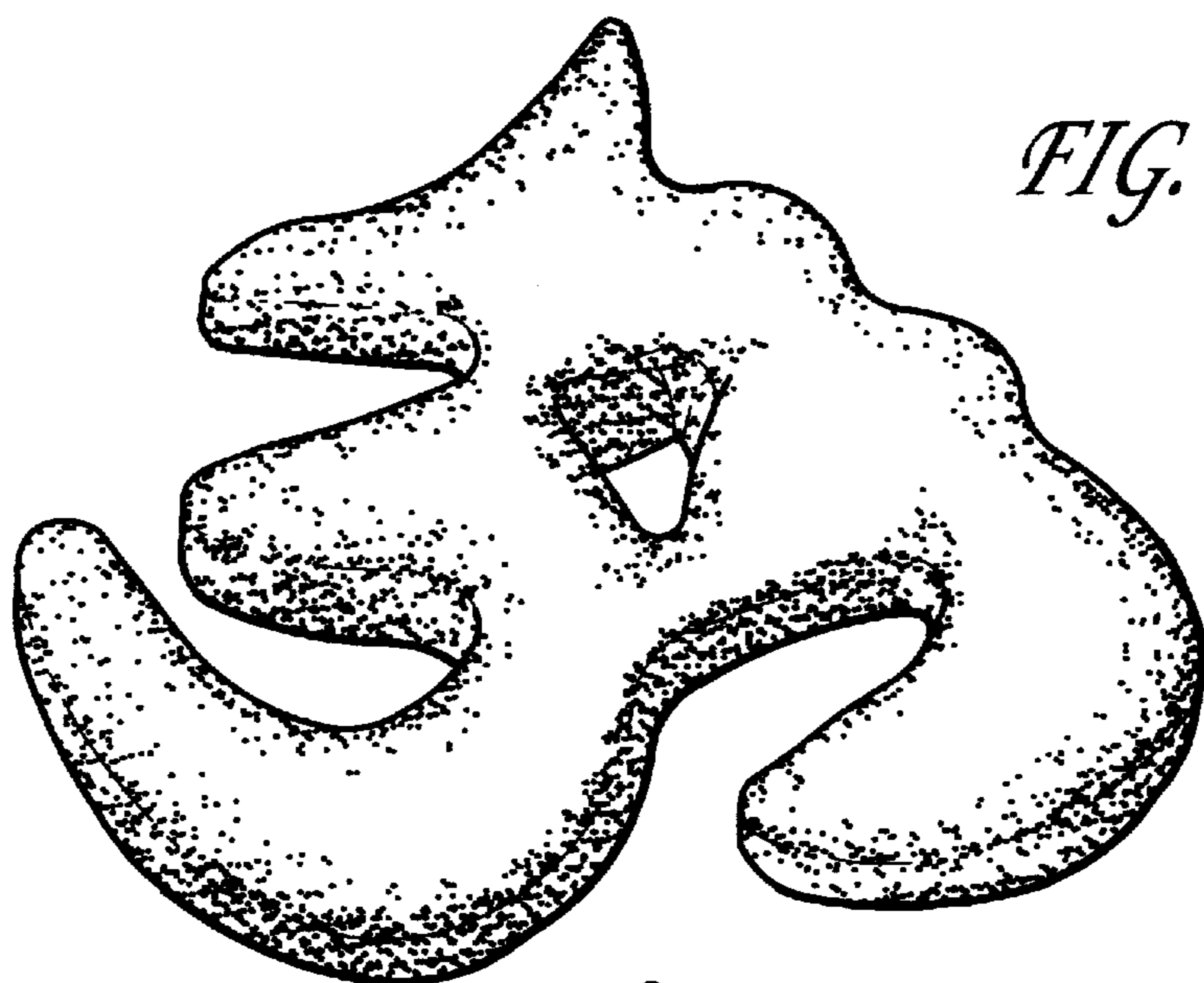
The ornamental design for a edible food product, as shown and described.

**DESCRIPTION**

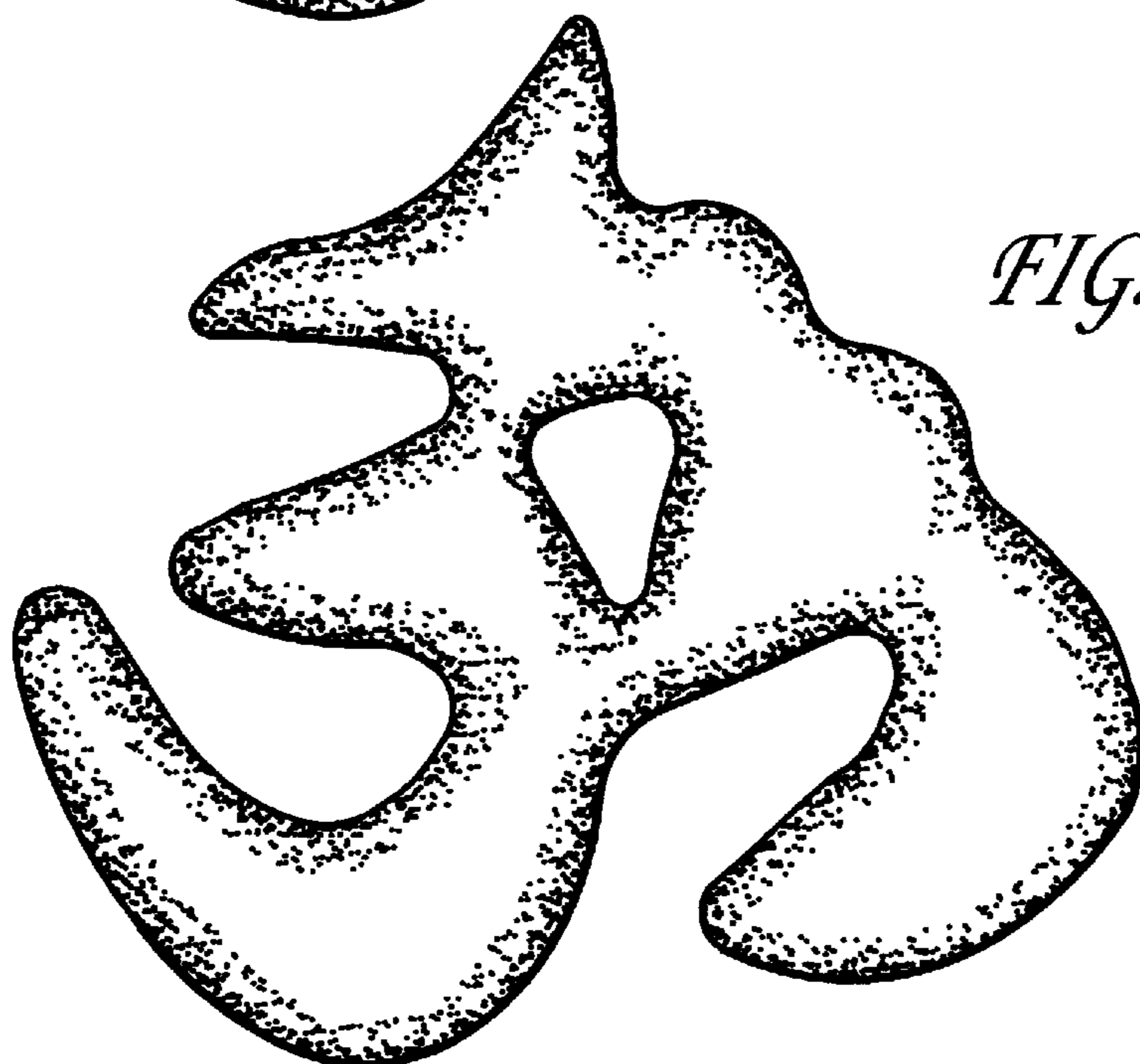
FIG. 1 is a perspective view of my edible food product.

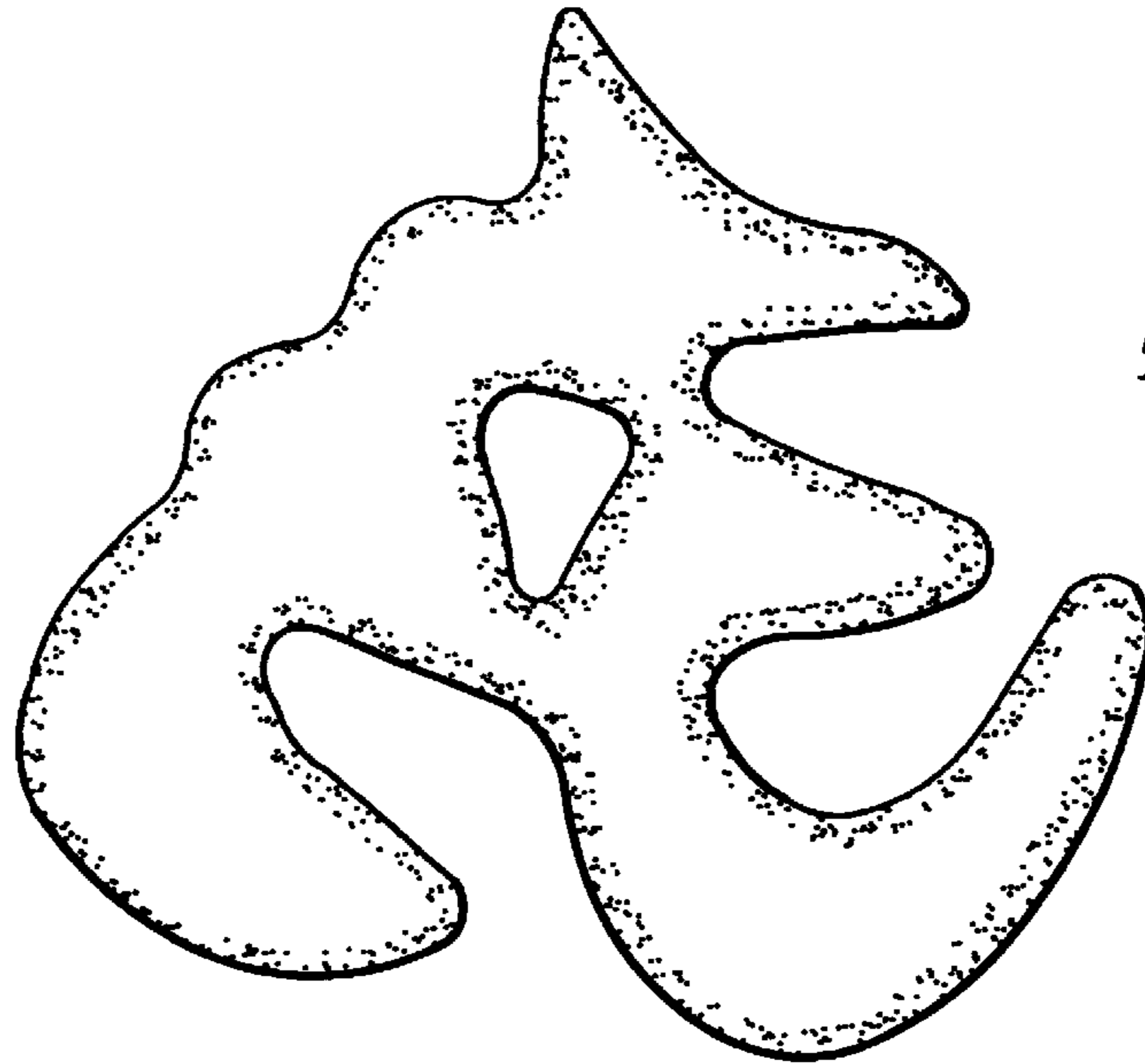

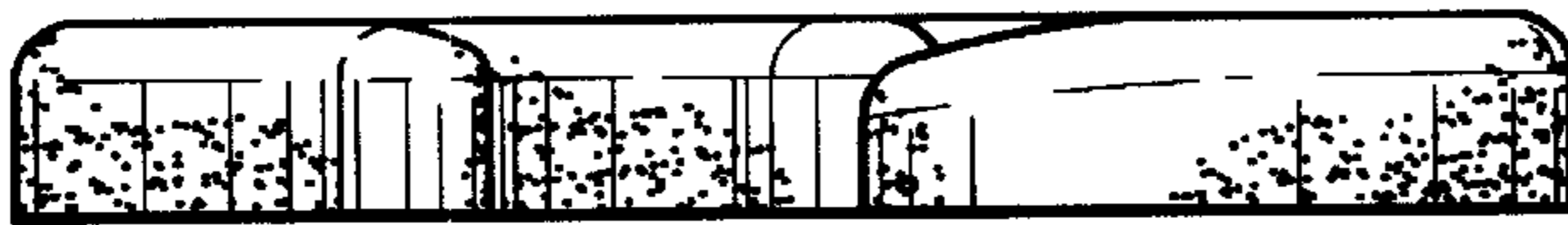
