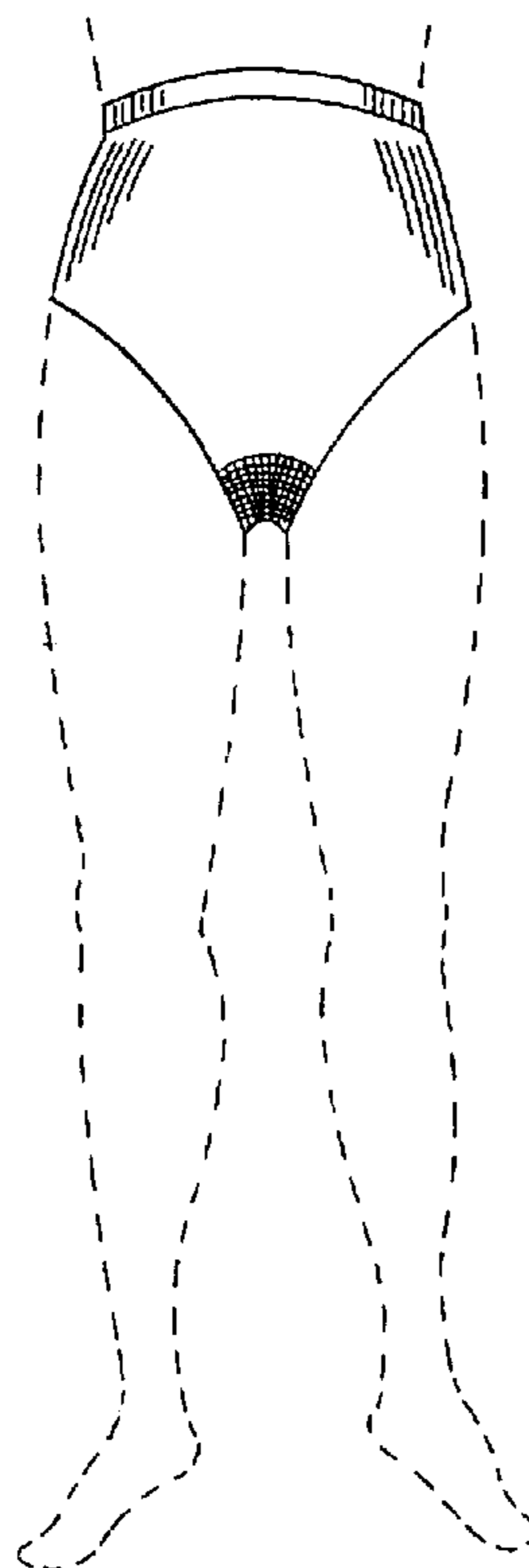
(57) **CLAIM**

DESCRIPTION

FIG. 1: is a front elevational view of a seamless one-piece body garment showing my invention;

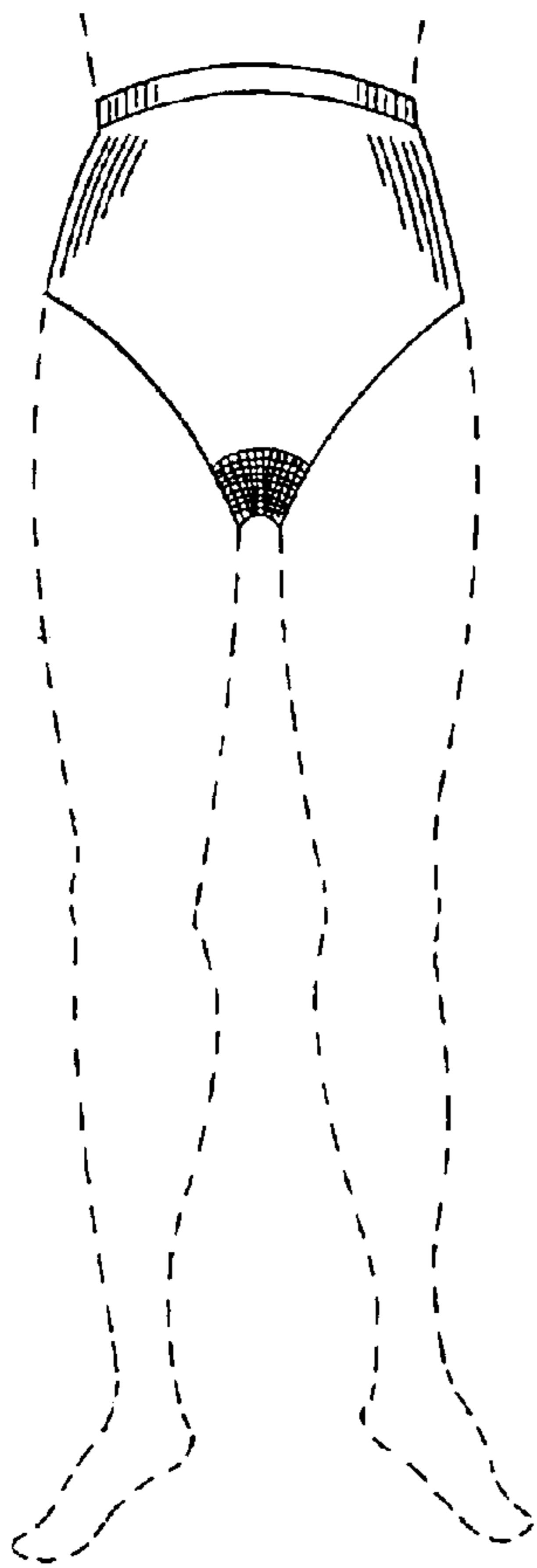

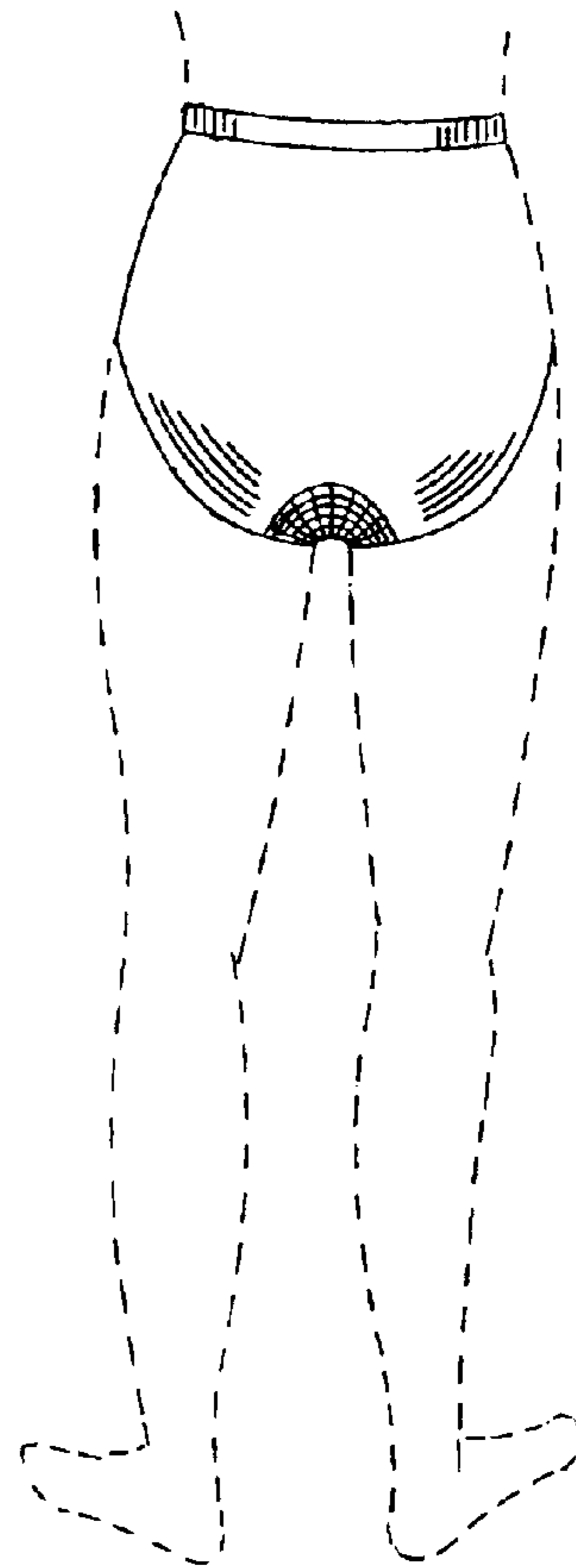

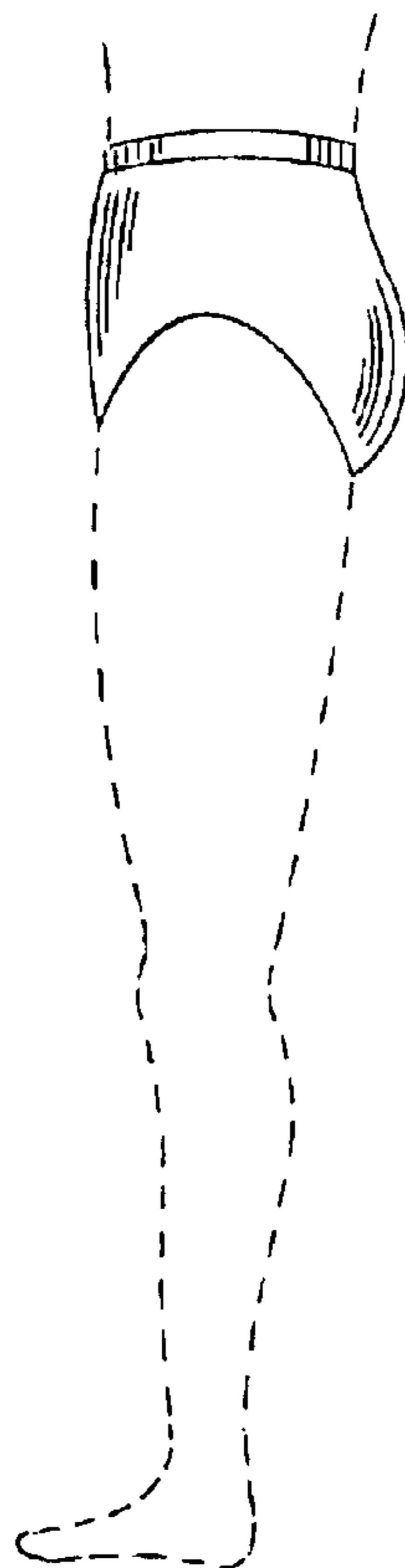
