DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 5 is a right side elevation view thereof;

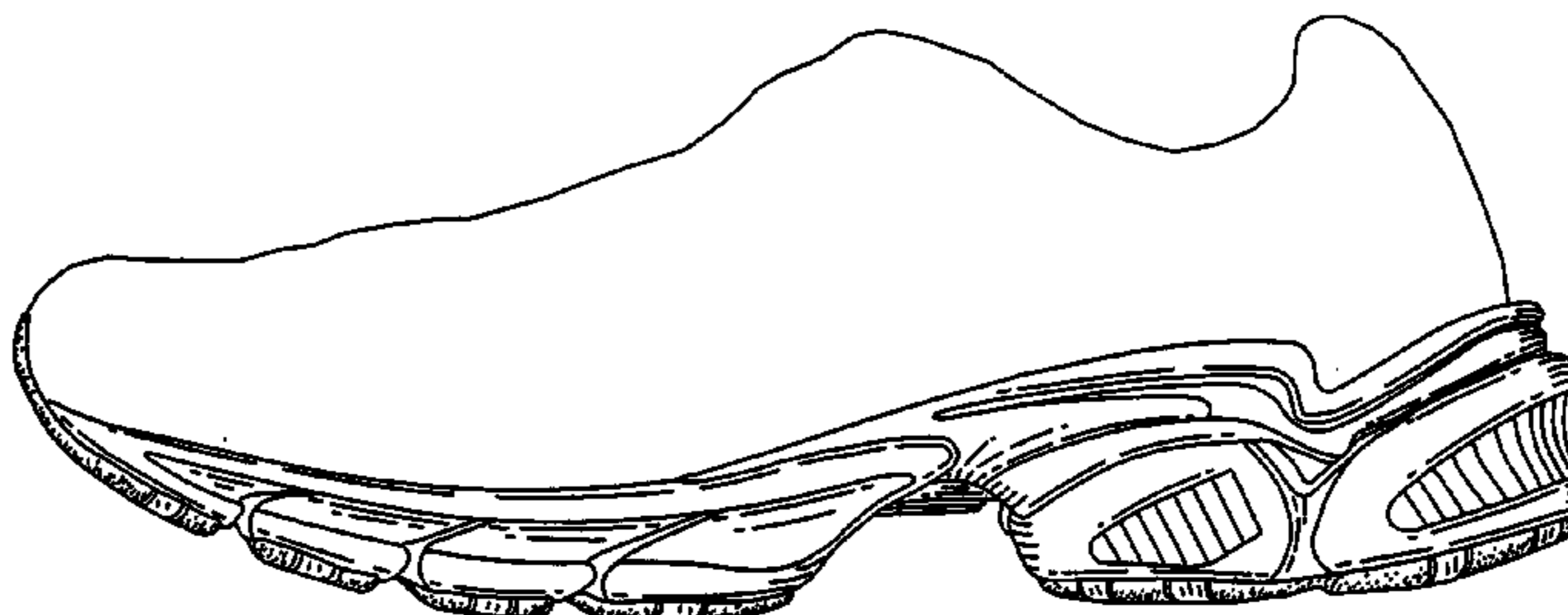
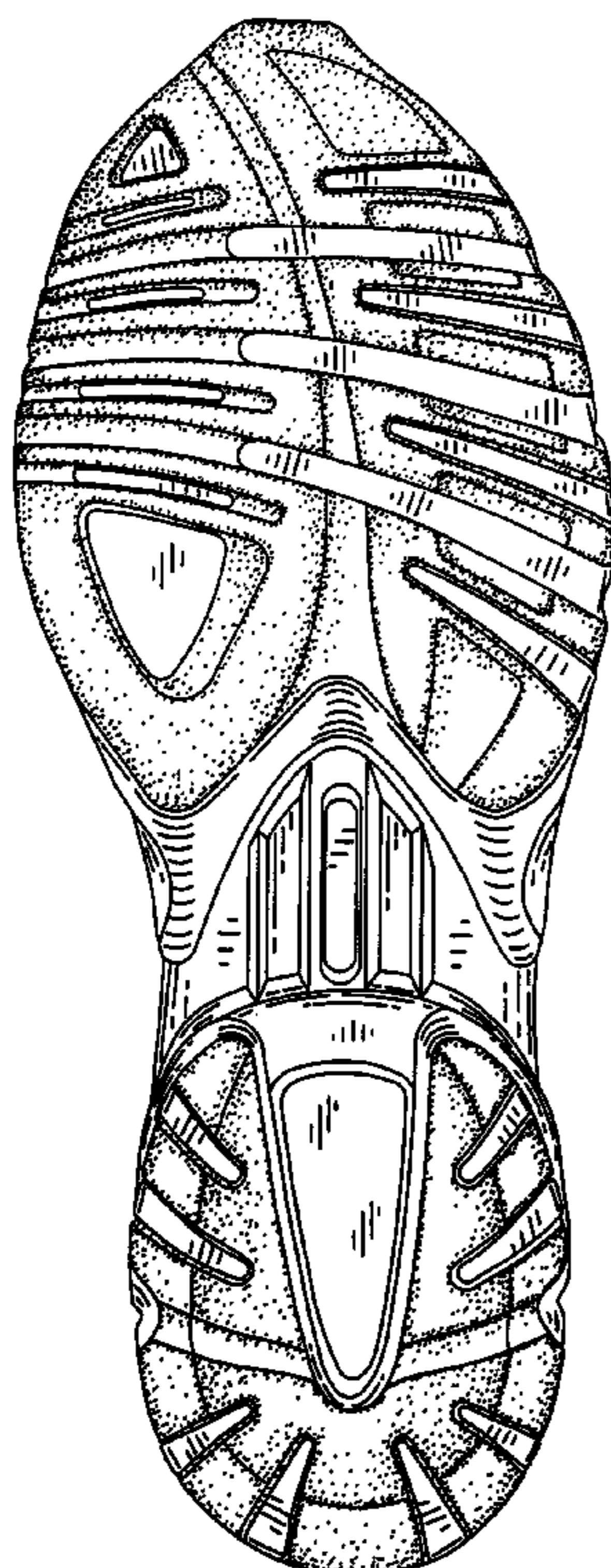
FIG. 6 is a top plan view thereof;

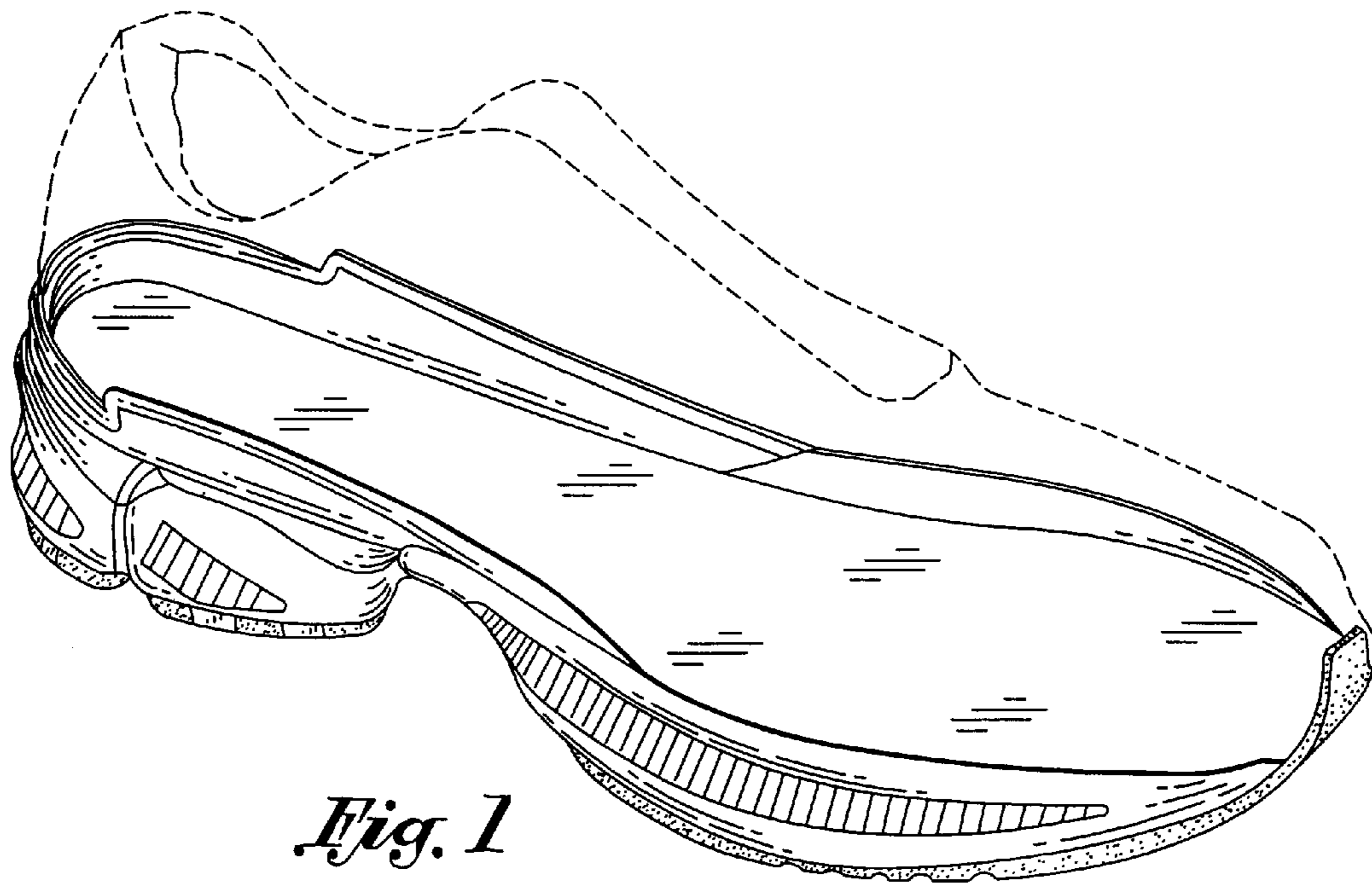

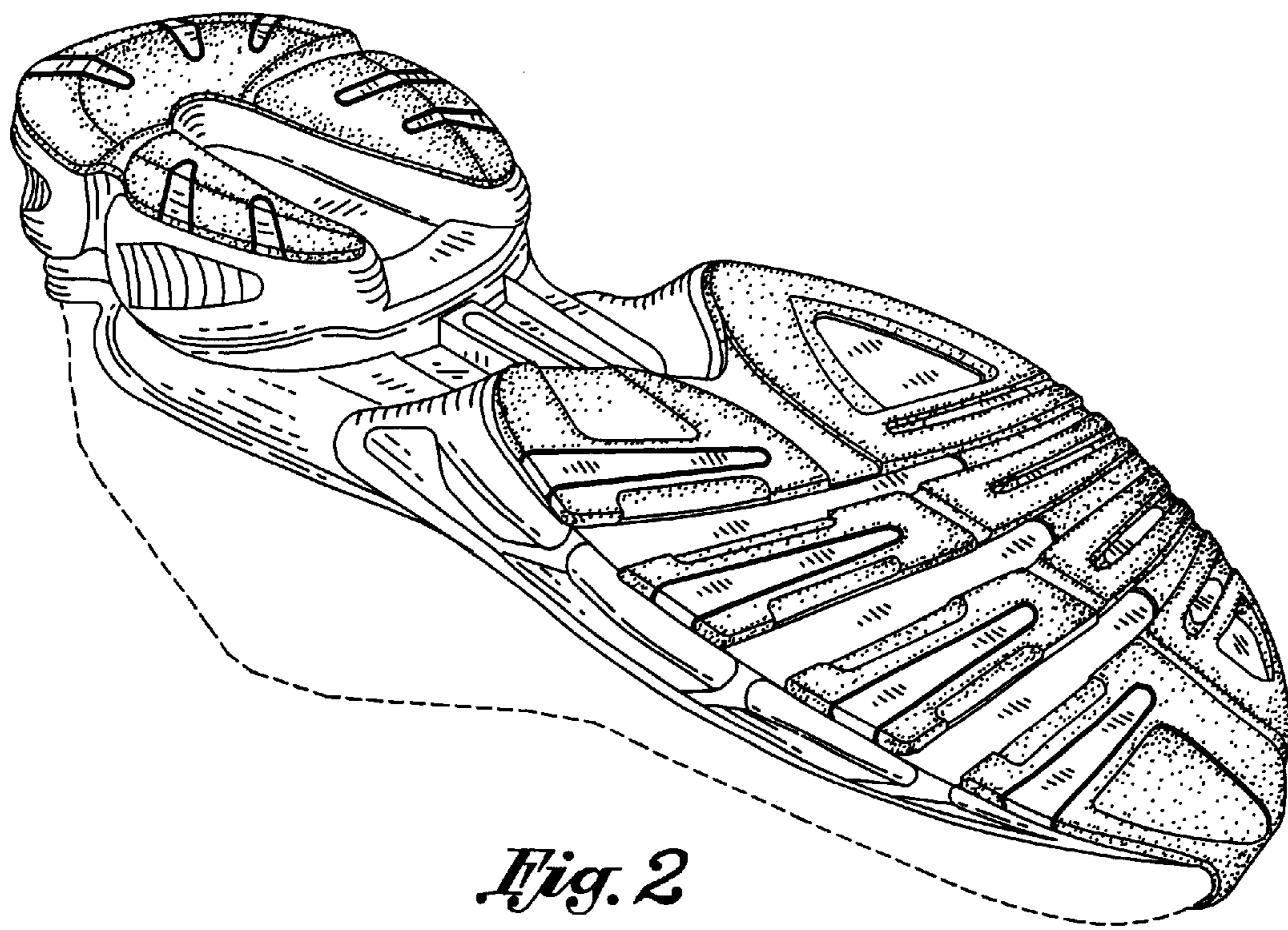

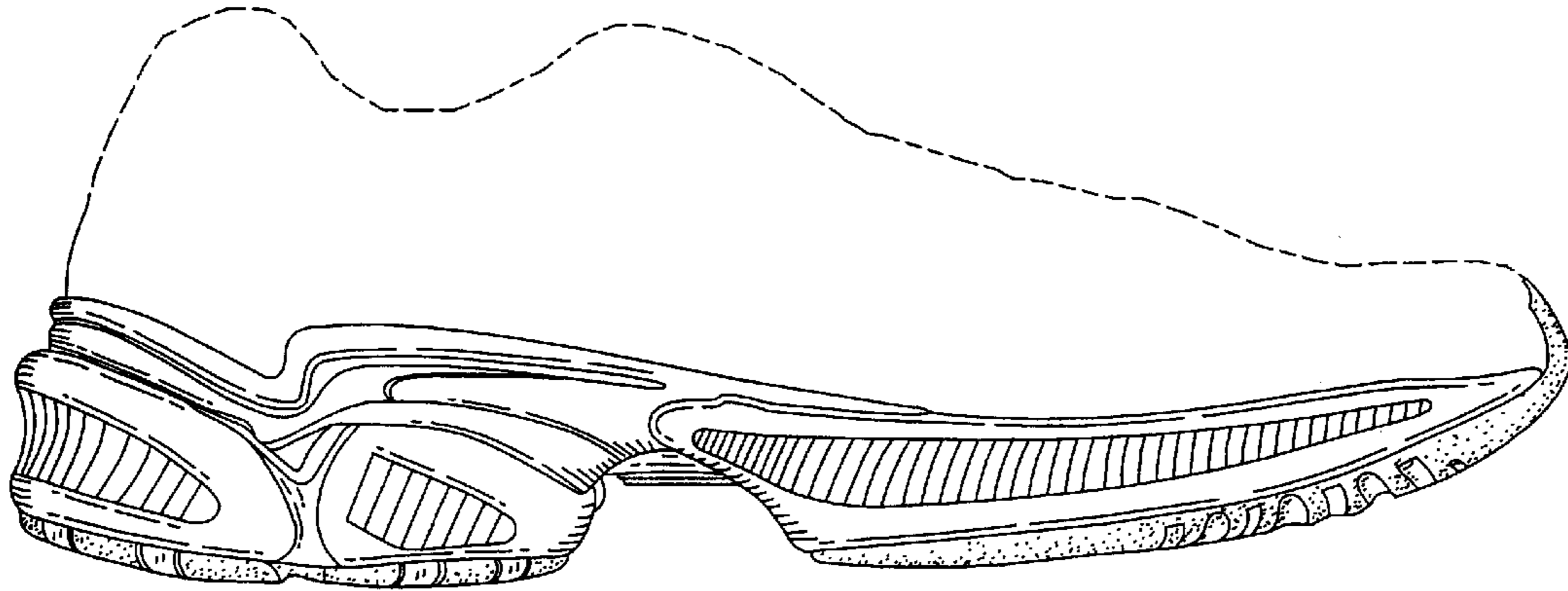

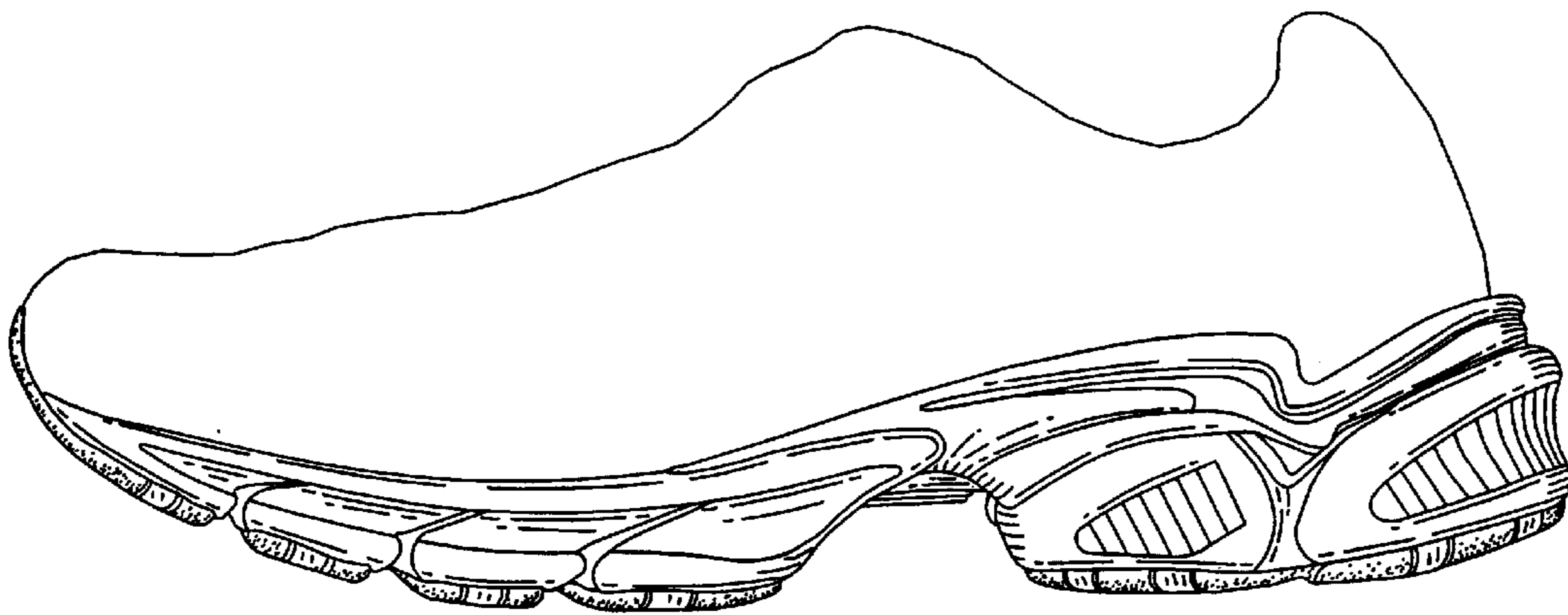

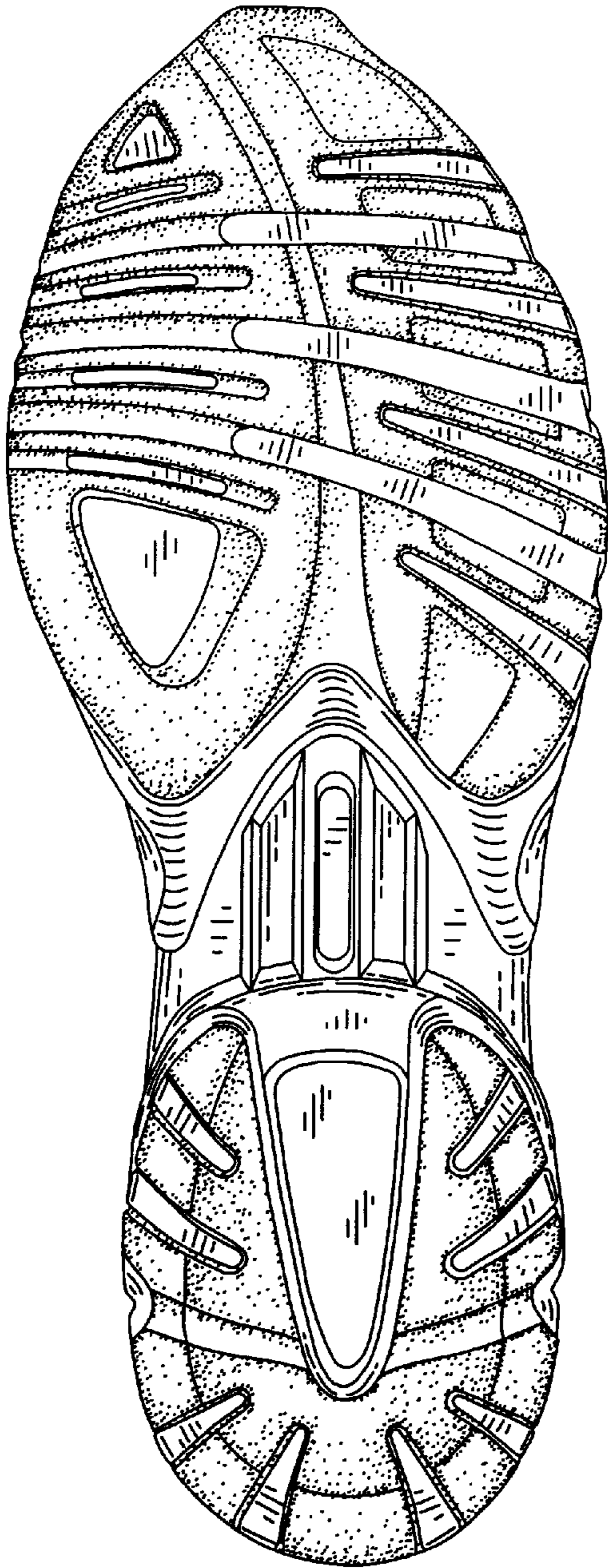

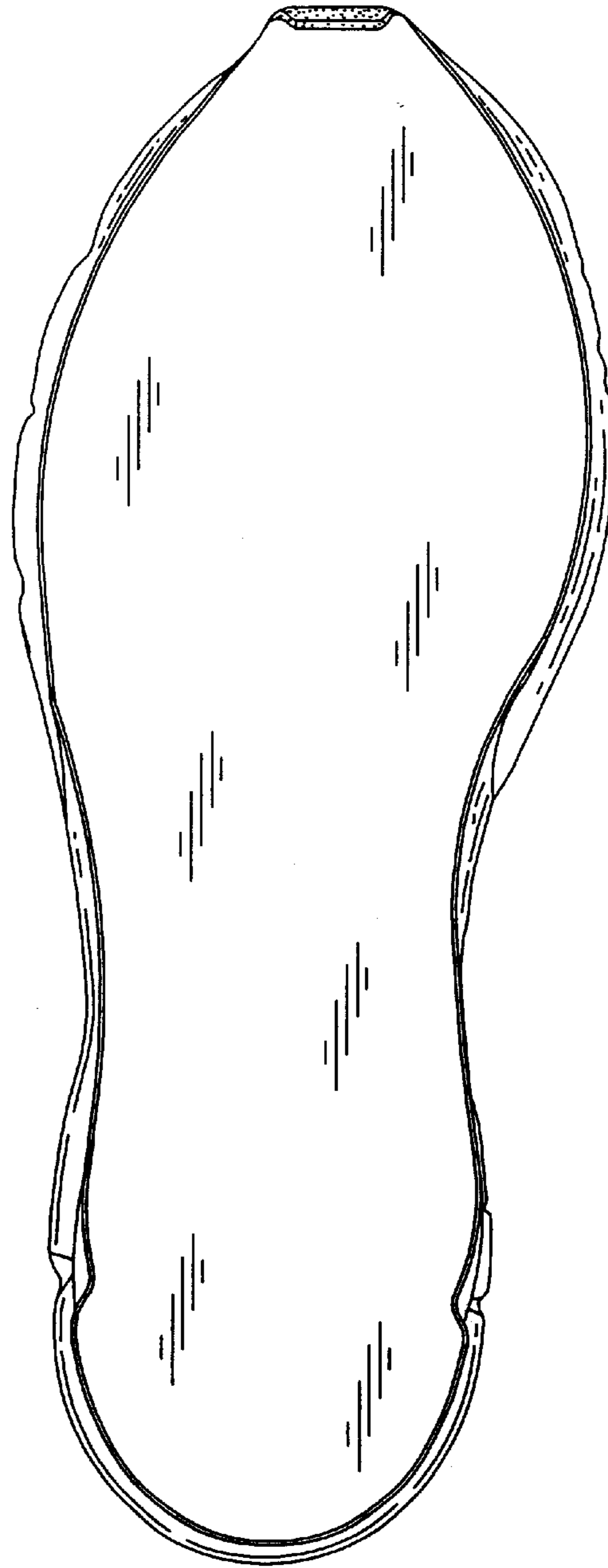

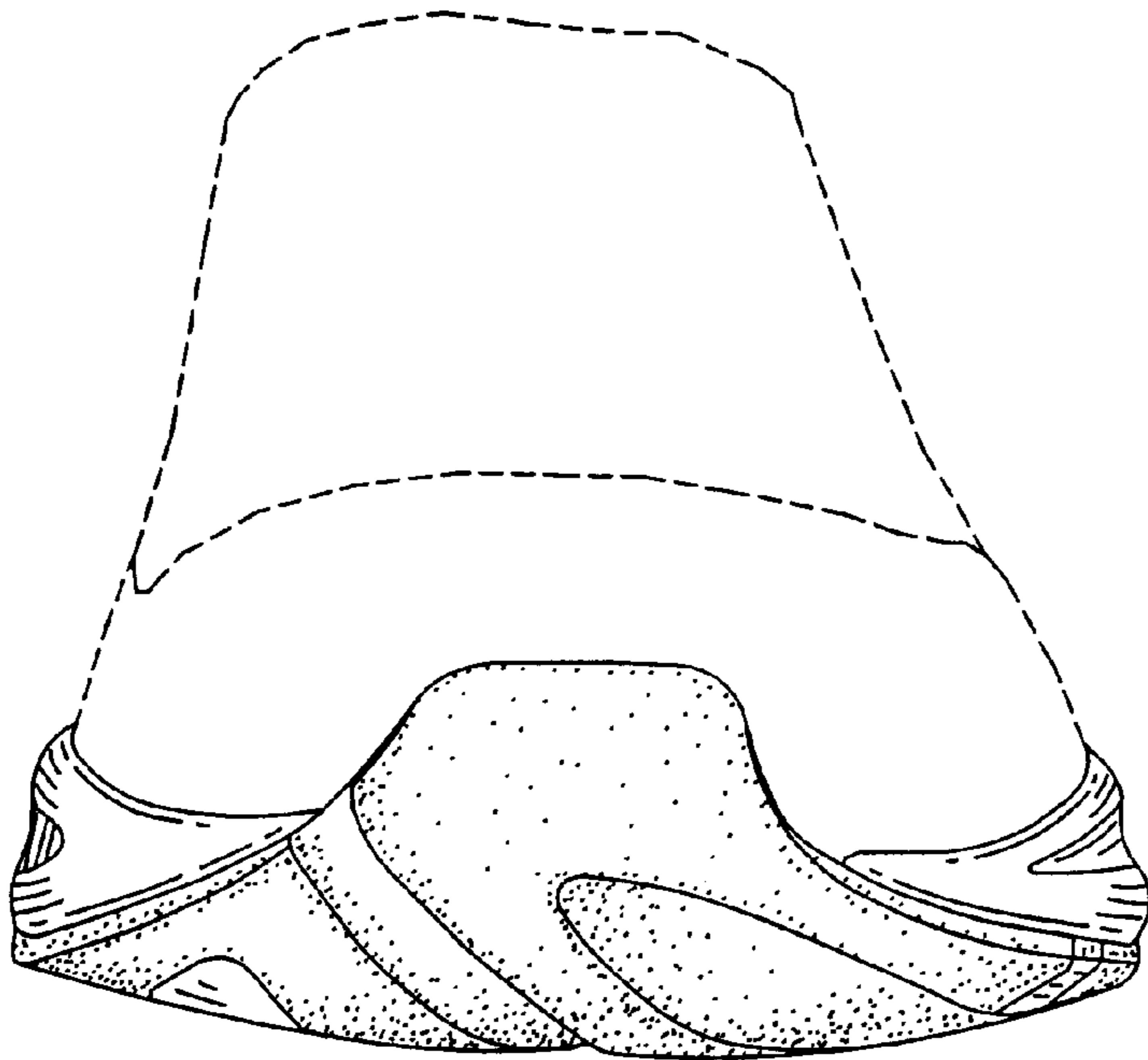

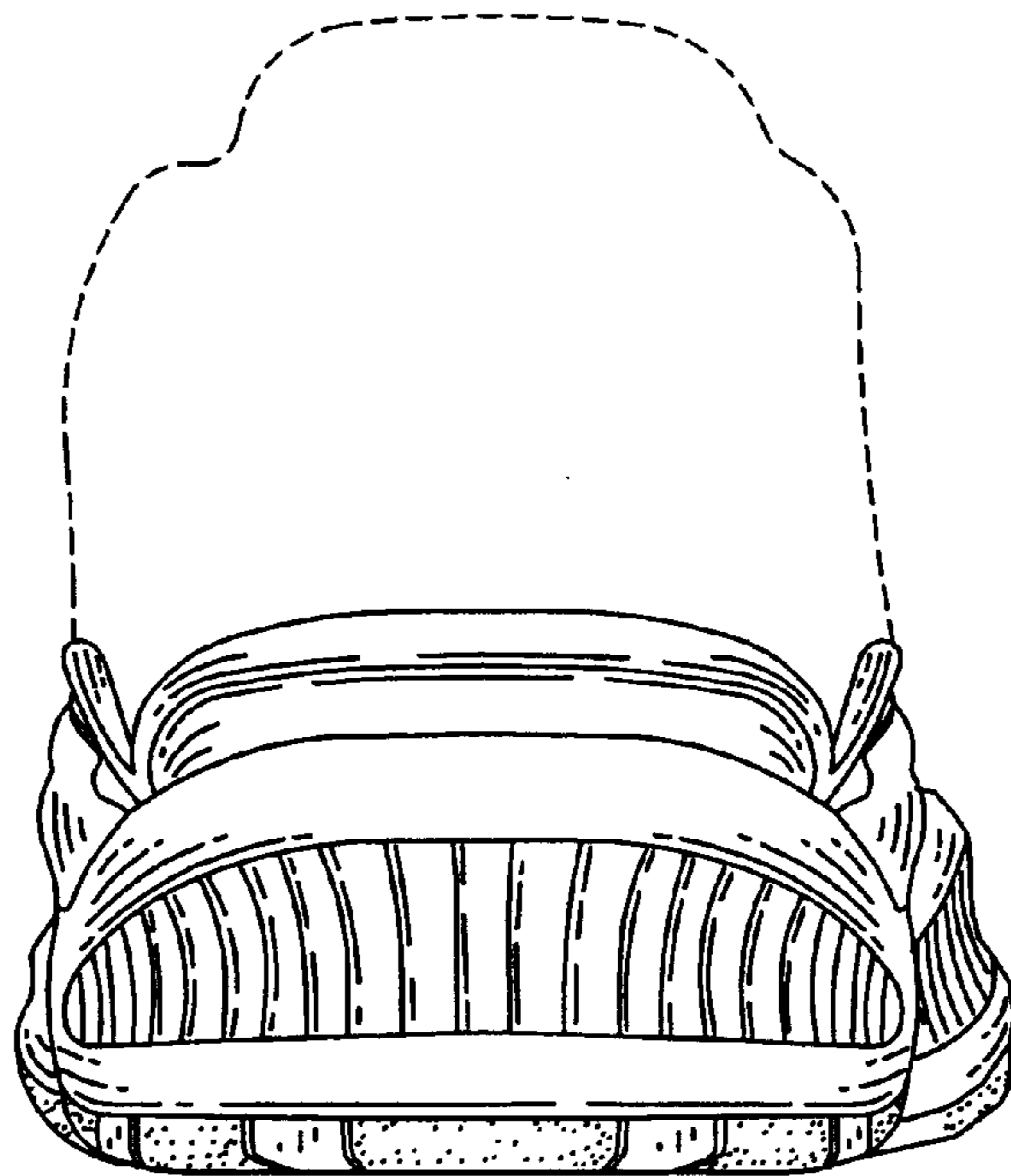
