FIG. 1 is a front perspective view of a towel bar showing my design;

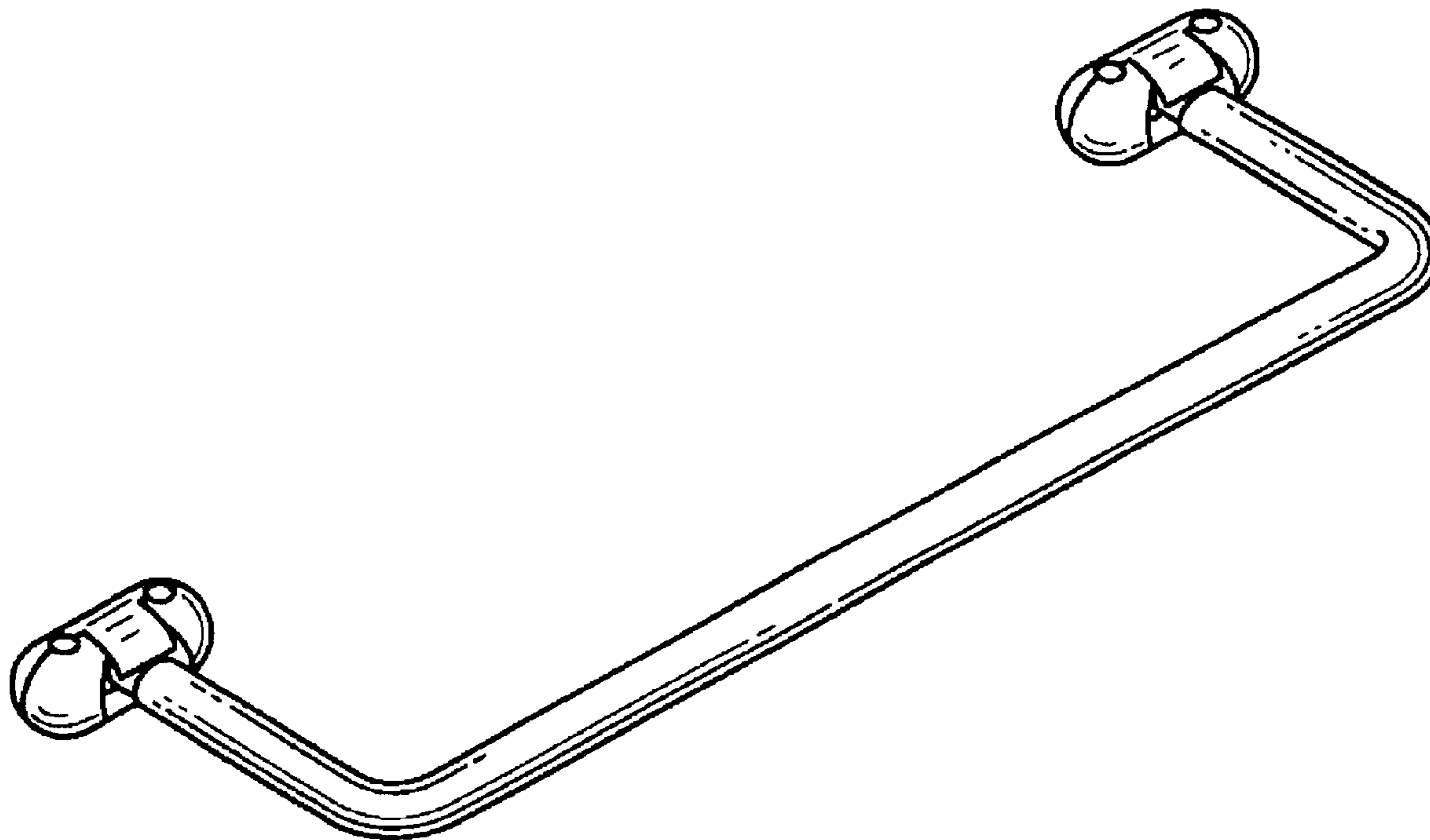
FIG. 2 is a top plan view thereof;

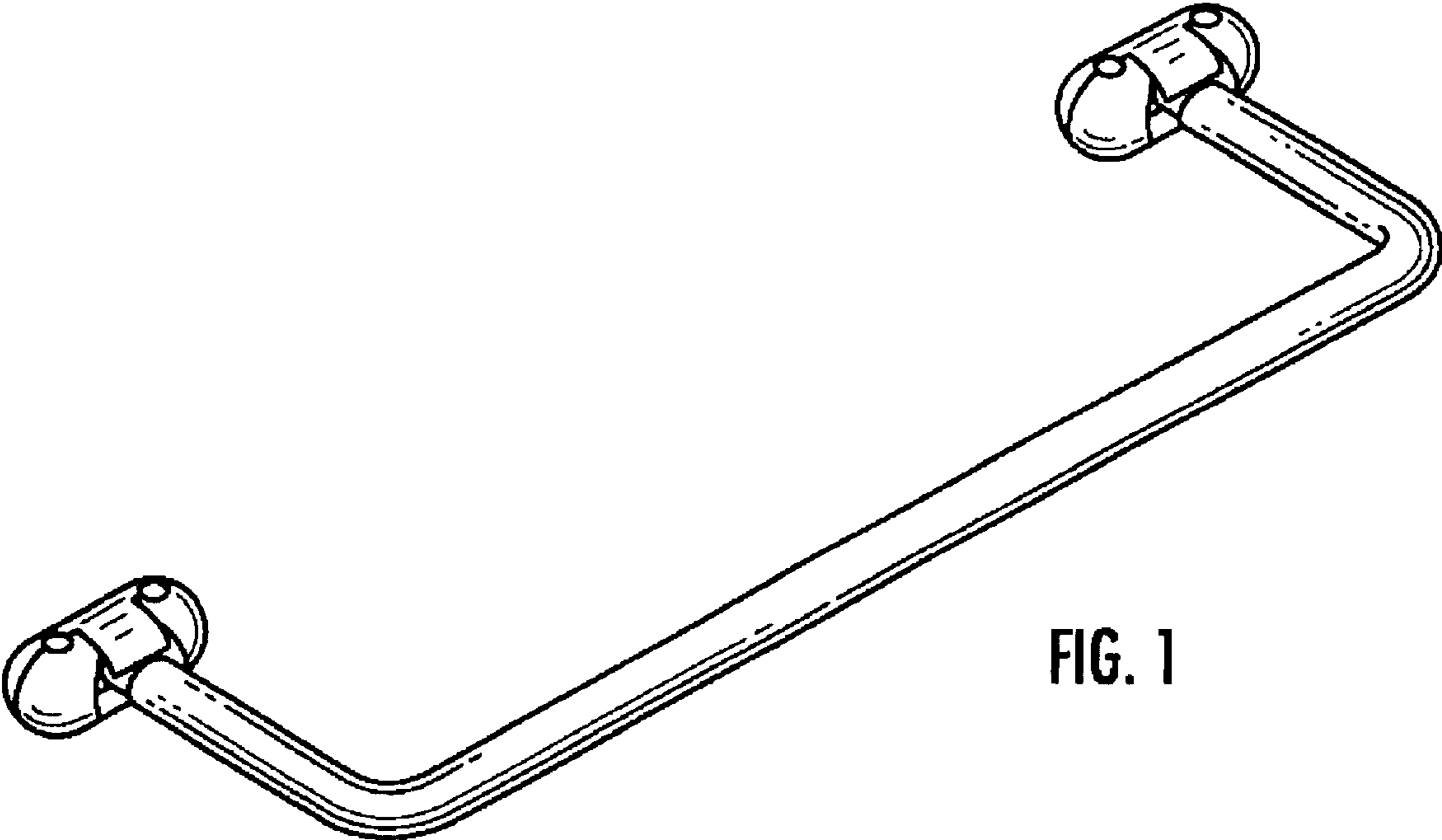

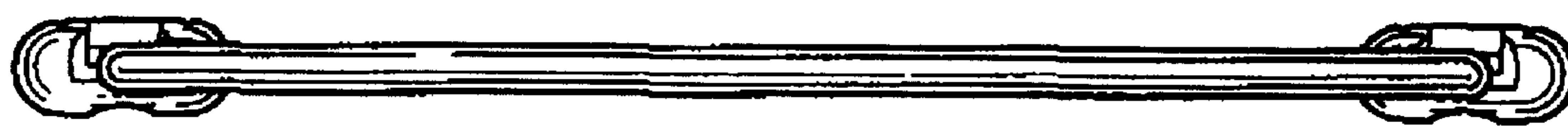

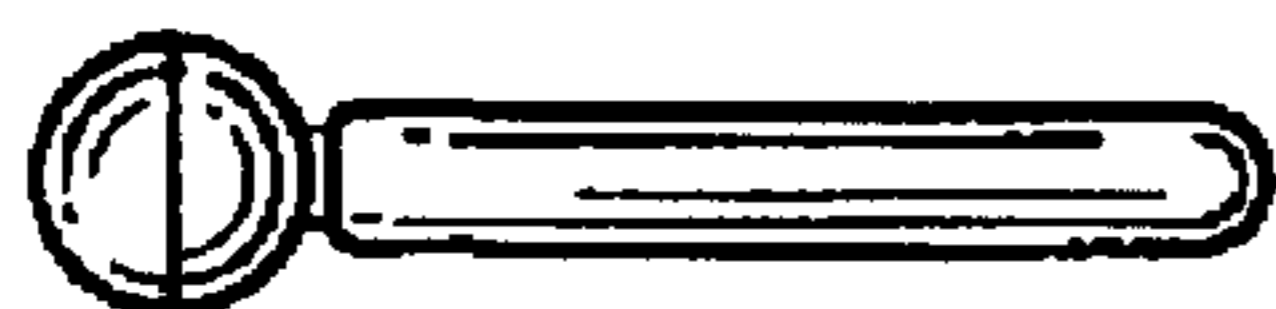

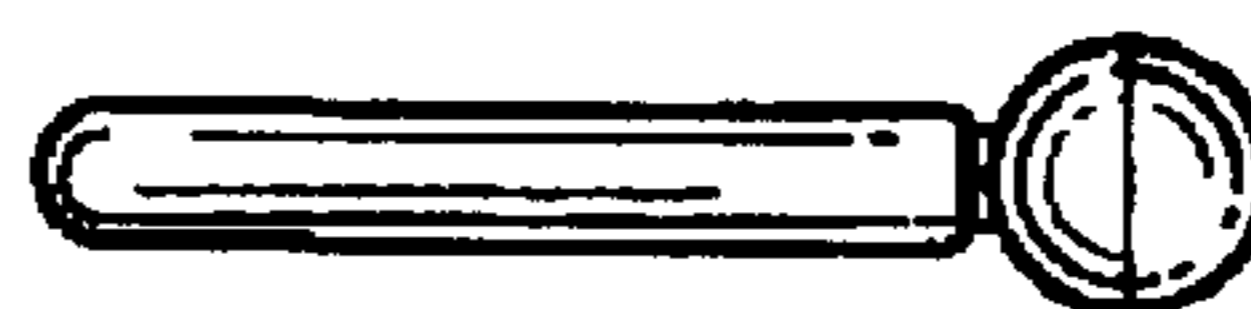
