(57) **CLAIM**

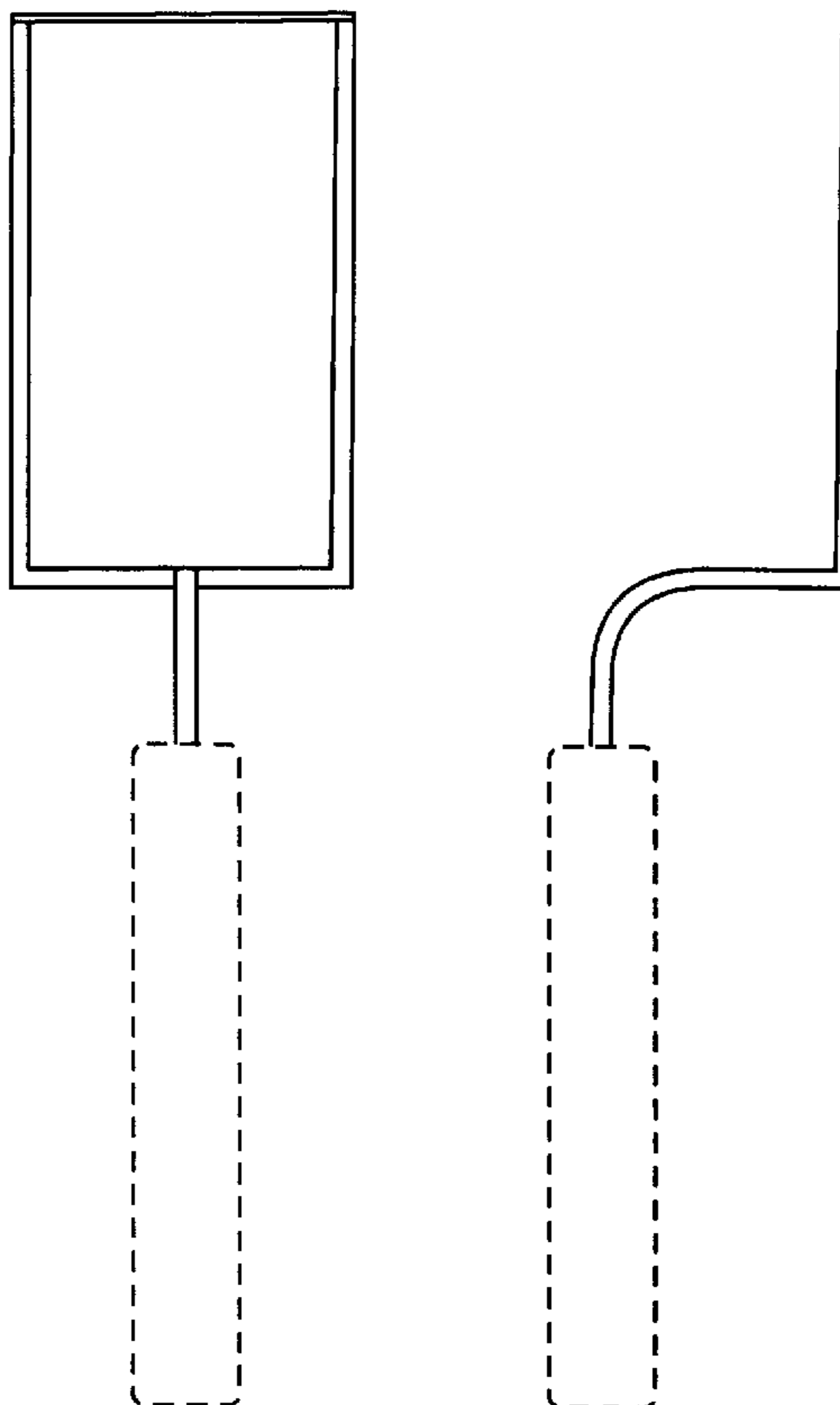
The ornamental design of a spatula, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the spatula;  
 FIG. 2 is a side view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a back elevational view thereof;  
 FIG. 6 is a top plan view of a variant of the spatula of FIG. 1, wherein the border at the side and back edges of the spatulated area is raised;  
 FIG. 7 is a side view of the spatula of FIG. 6;  
 FIG. 8 is a bottom plan view of the spatula of FIG. 6;  
 FIG. 9 is a front elevational view of the spatula of FIG. 6;  
 FIG. 10 is a back elevational view of the spatula of FIG. 6;  
 FIG. 11 is an enlarged top view of the beveled front edge of the spatula of FIG. 6; and,  
 FIG. 12 is an enlarged front view of the beveled front edge of the spatula of FIG. 6.

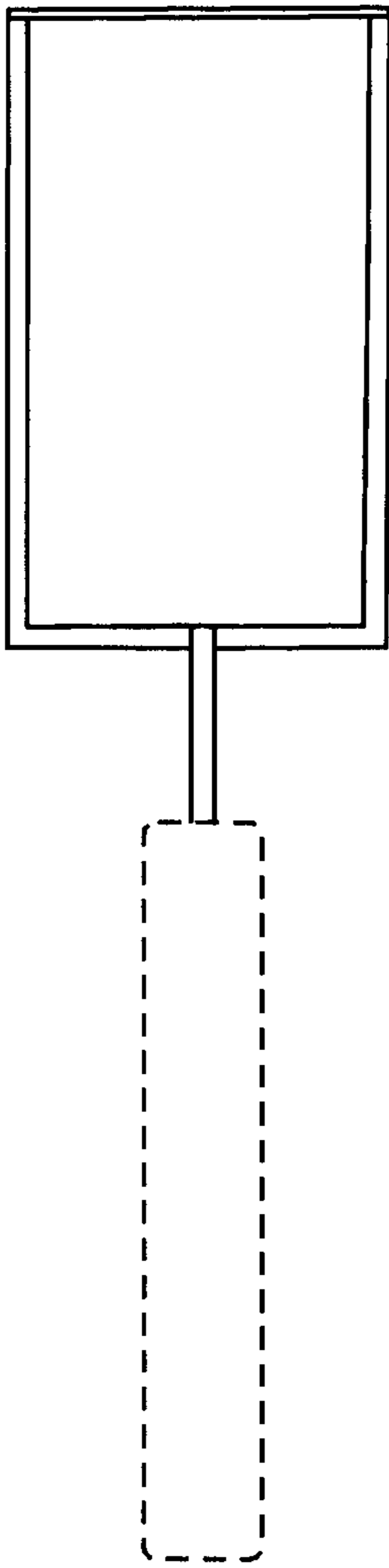

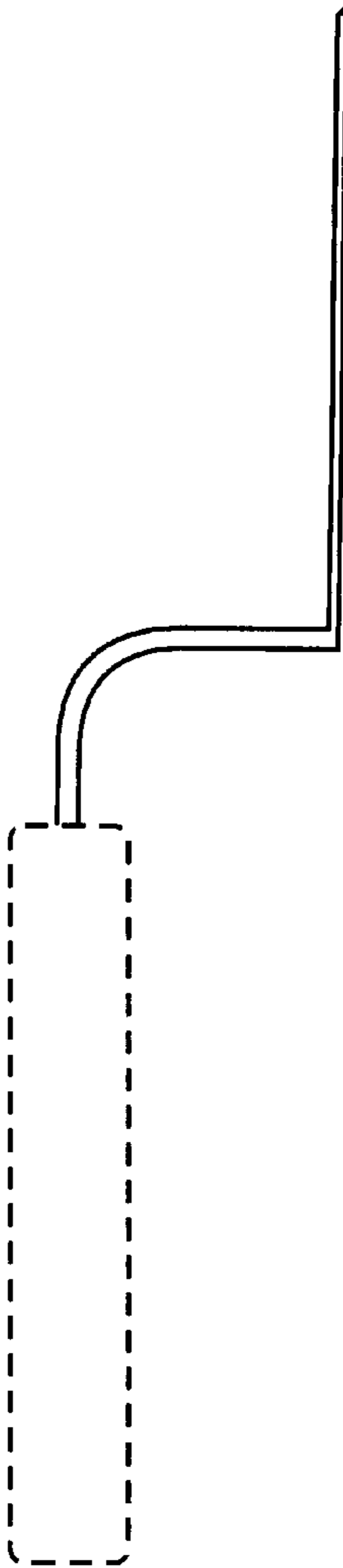

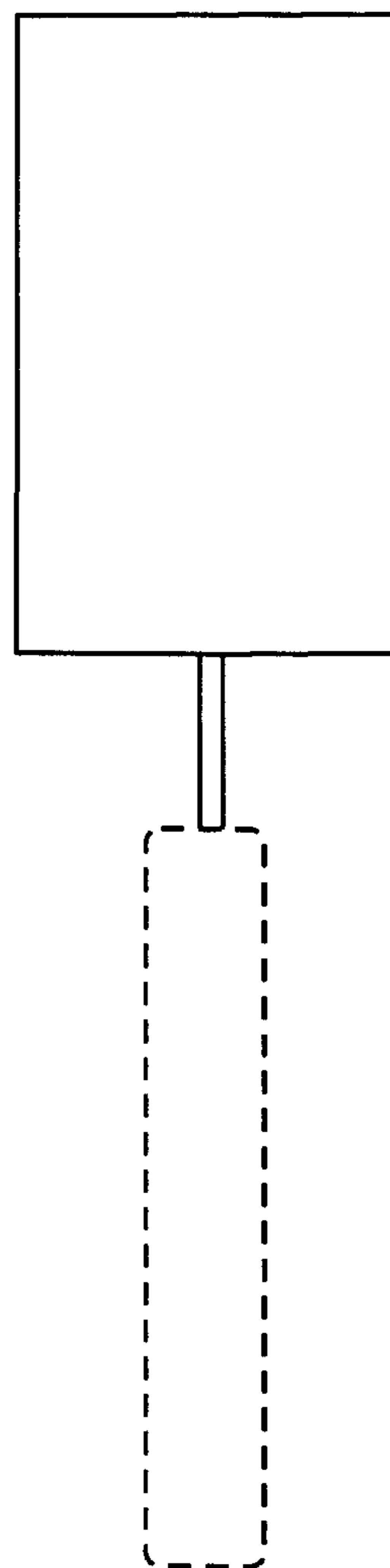

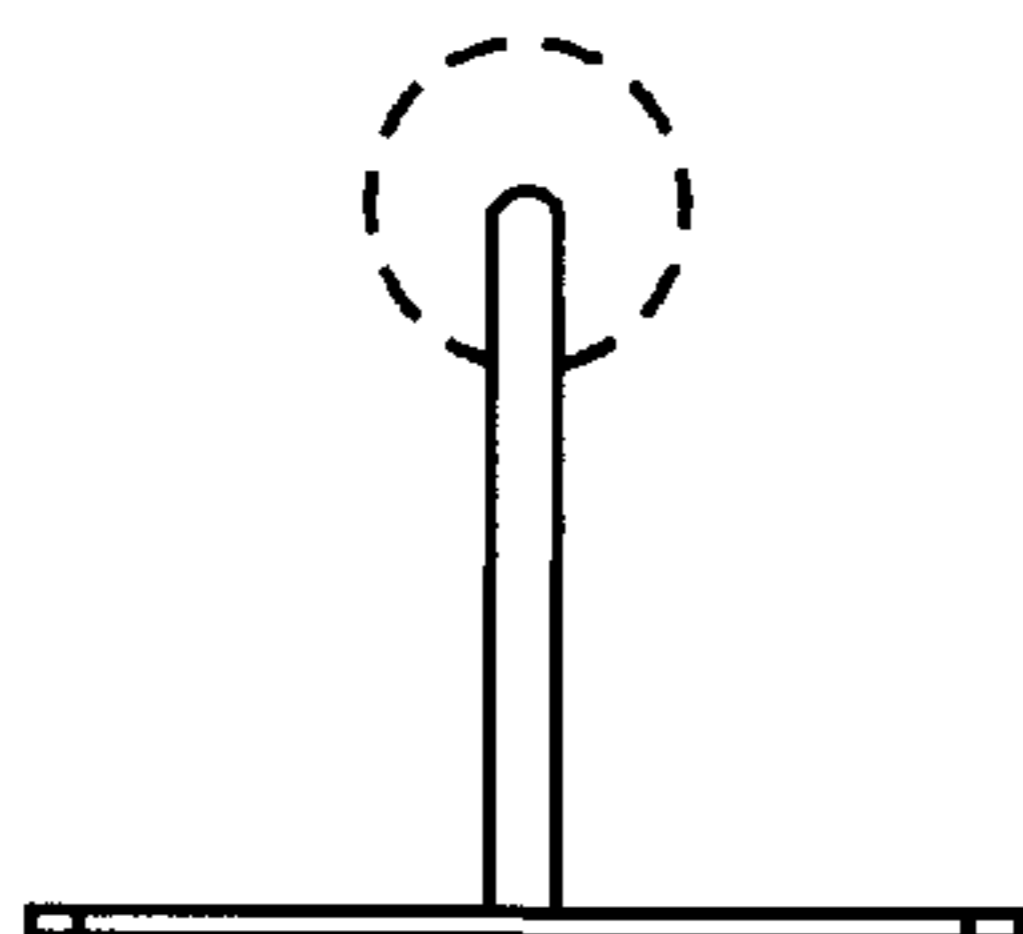

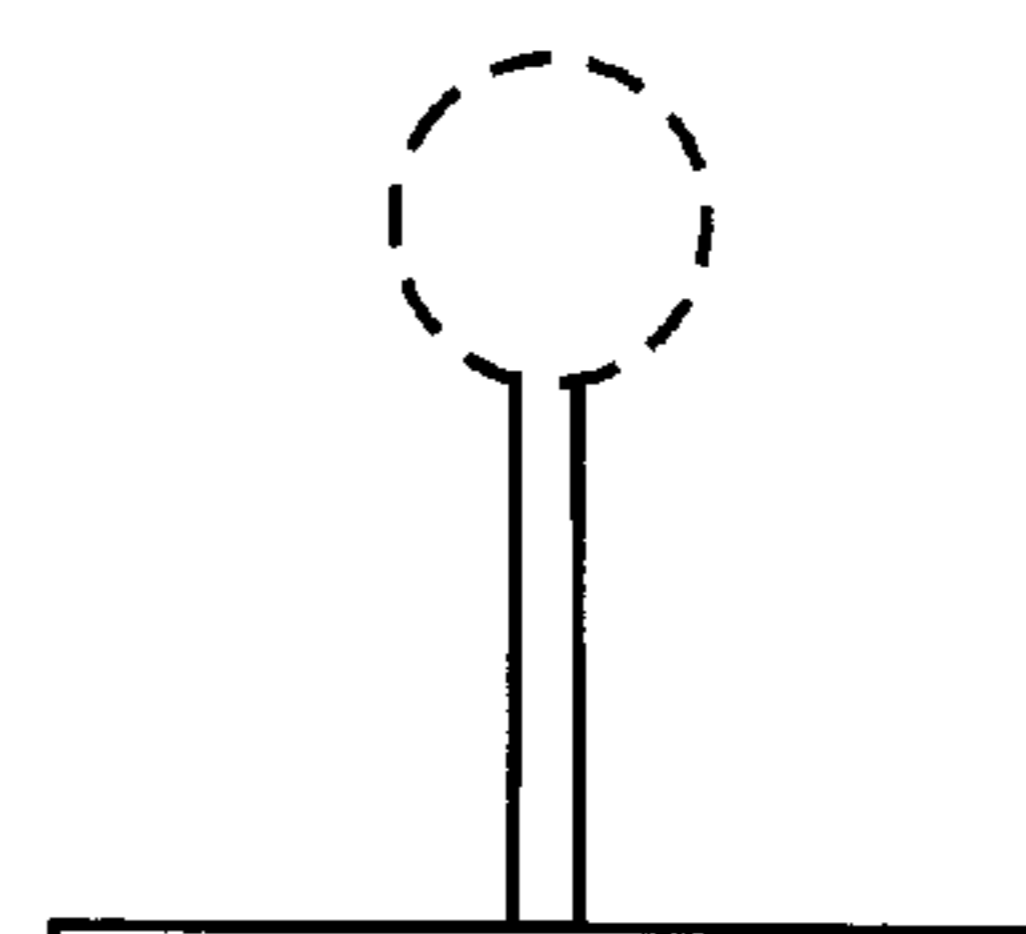

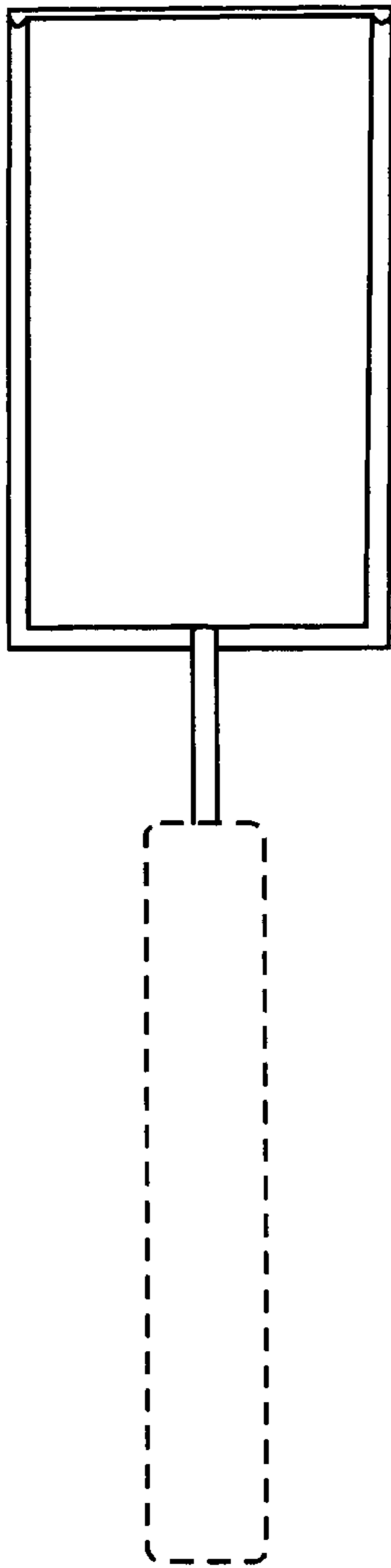

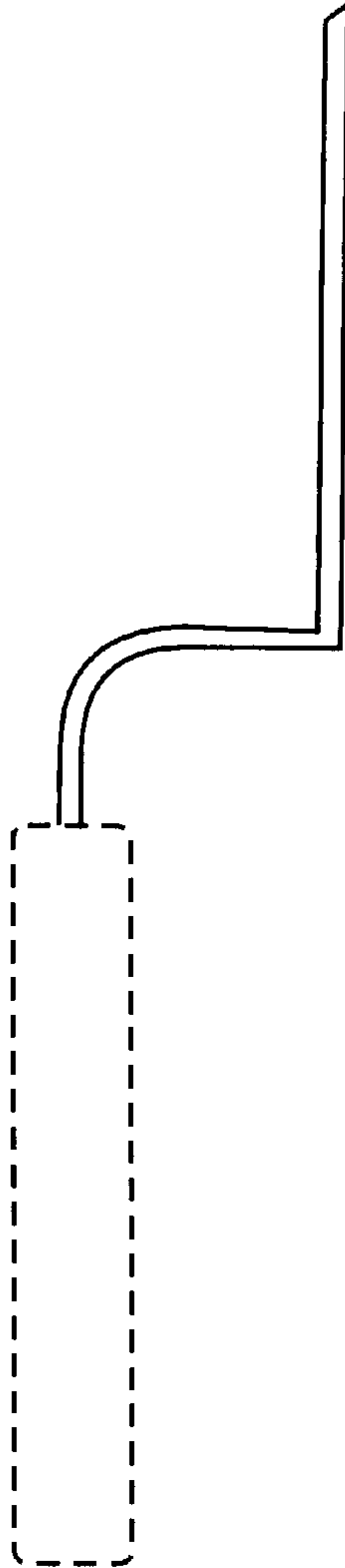

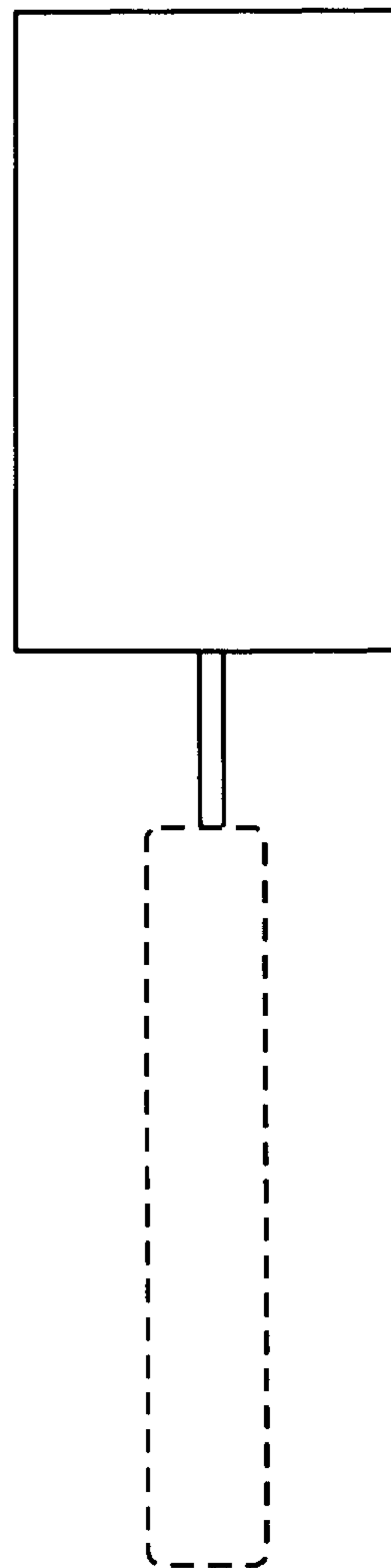

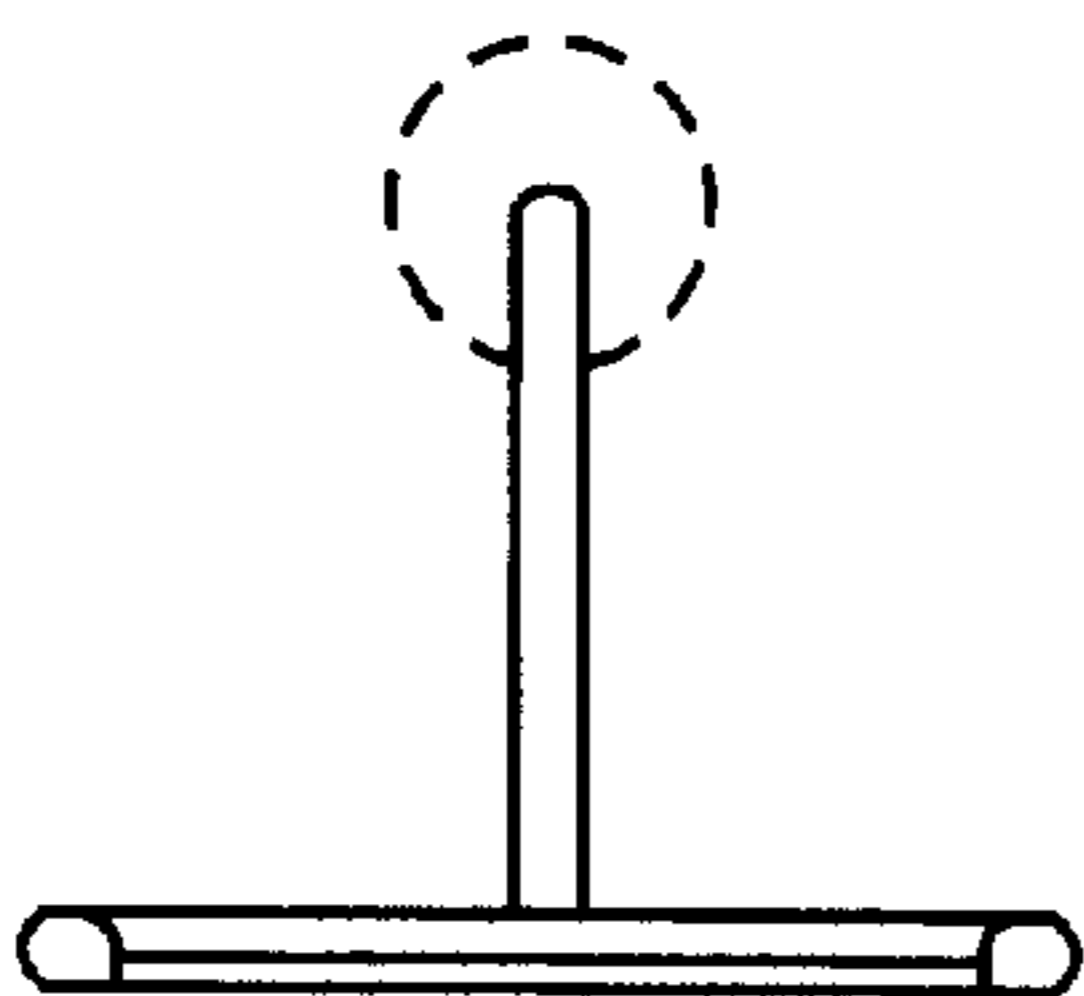

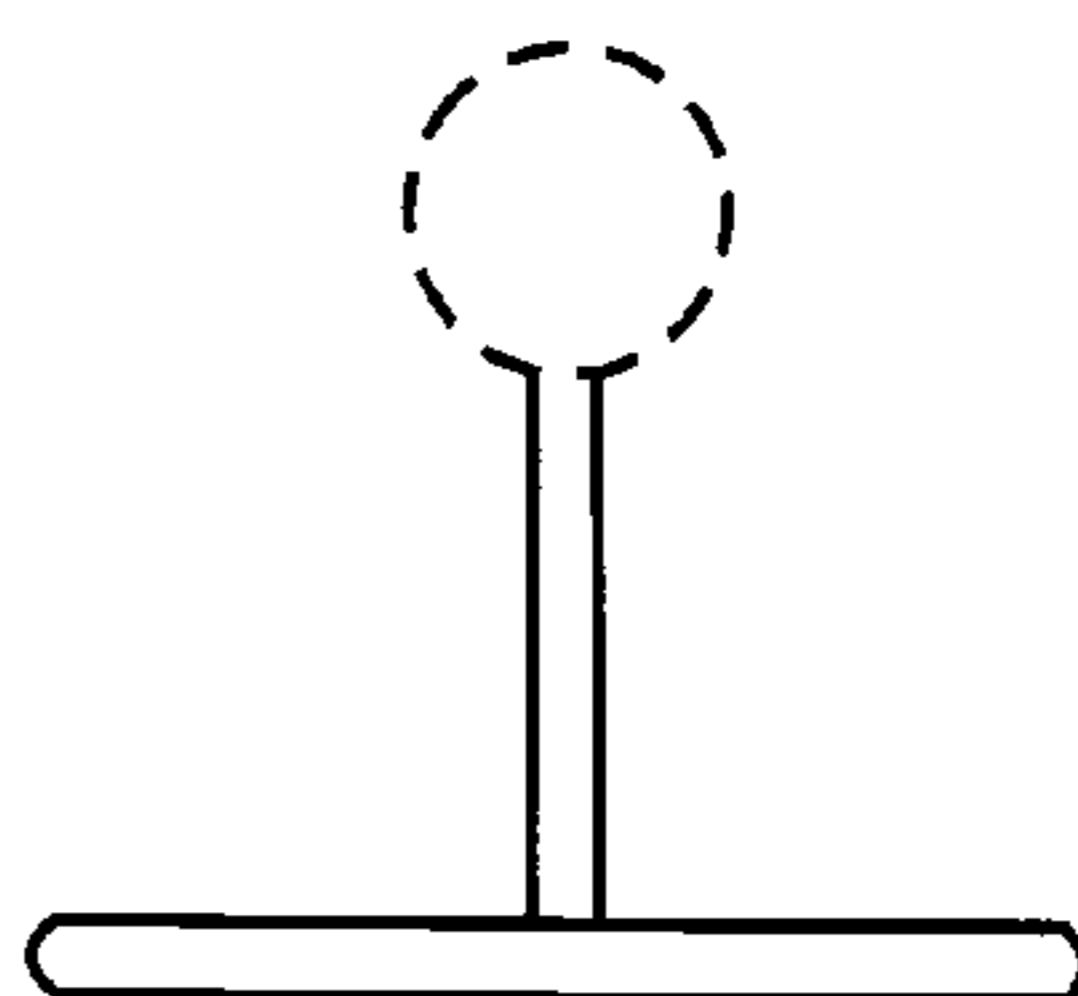

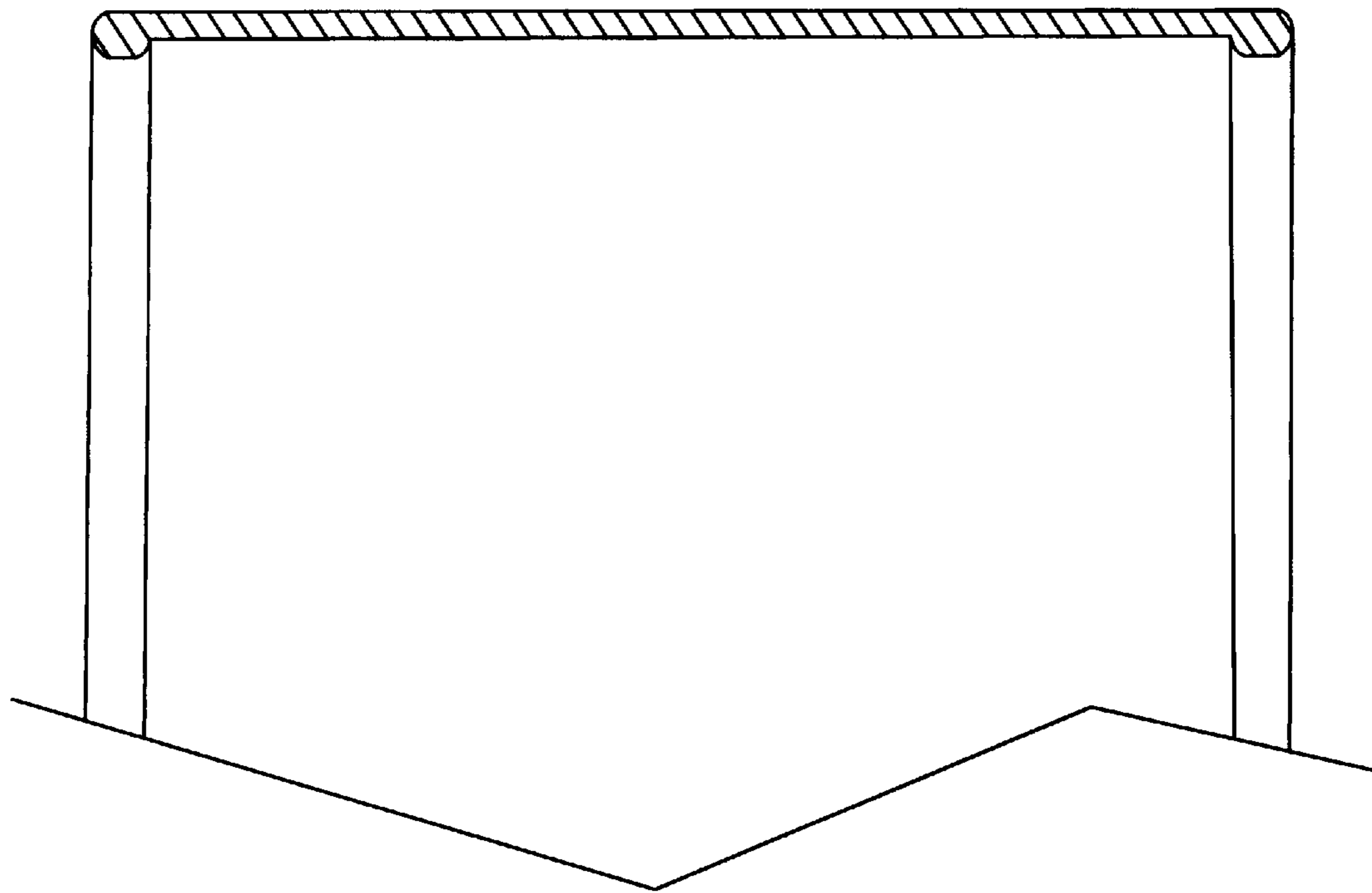
