(57) **CLAIM**

The ornamental design for a “ball-shaped bottle opener assembly for use with a baseball cap,” as shown and described.

FIG. 3 is a bottom plan view thereof;

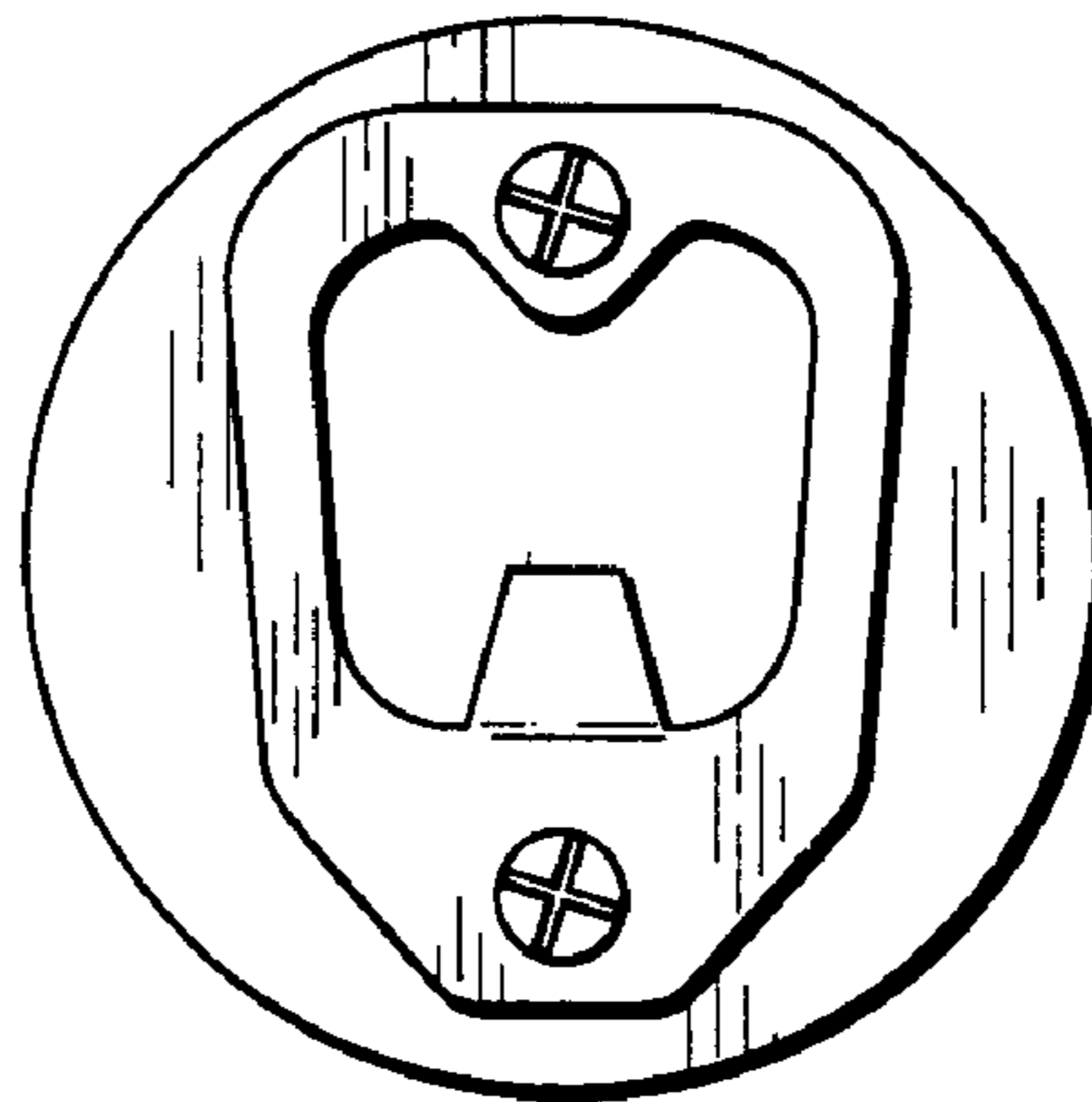
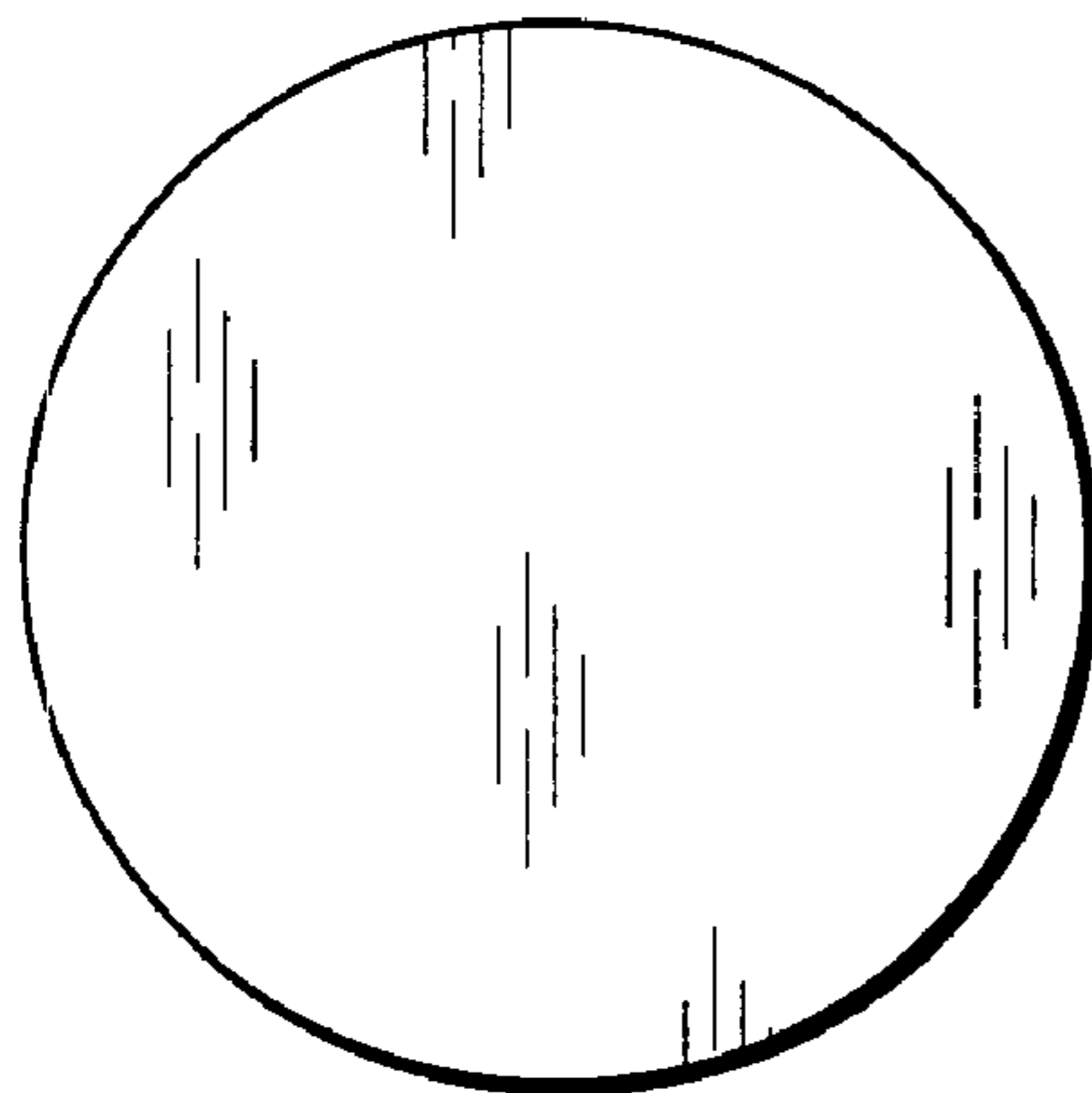
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

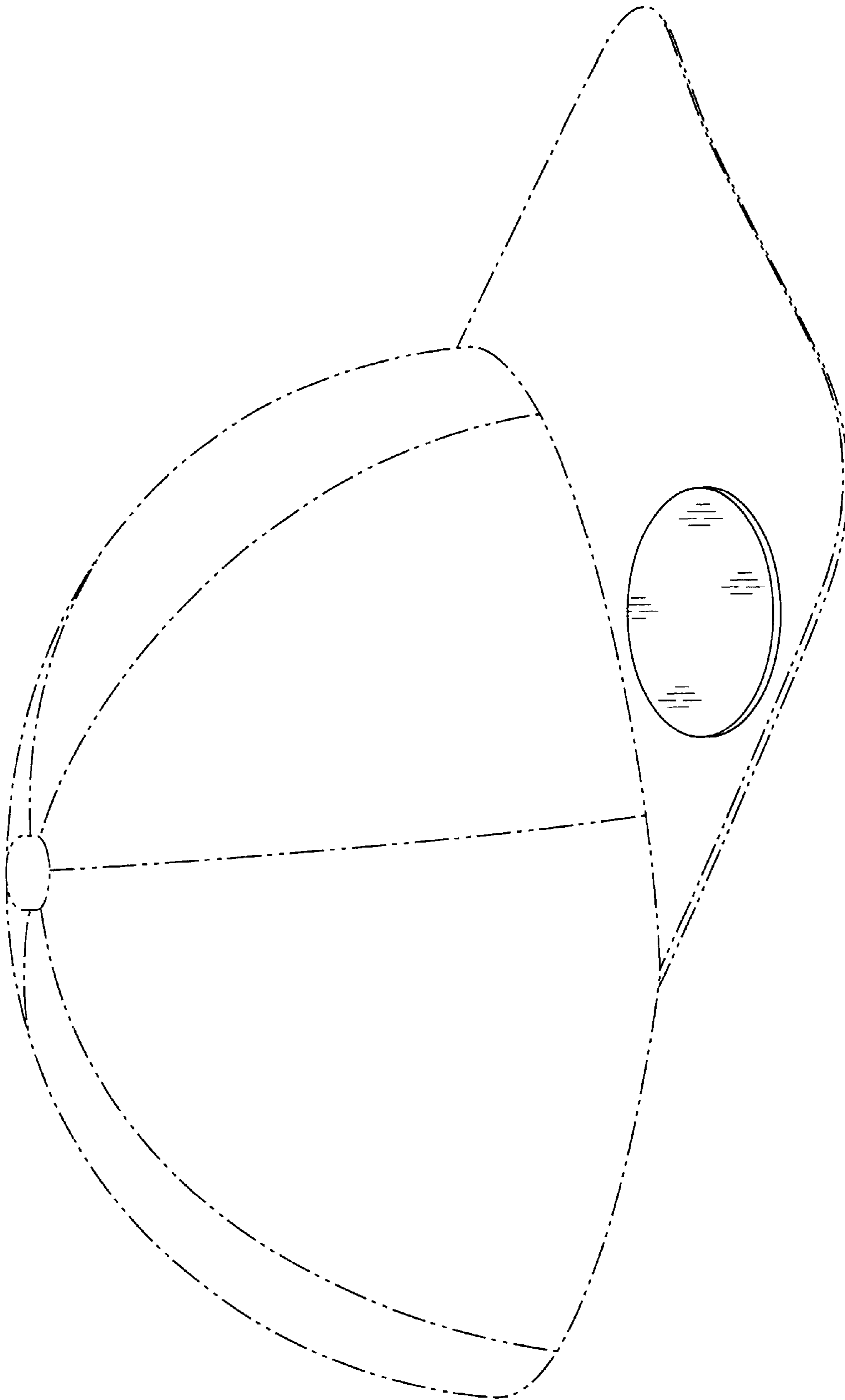

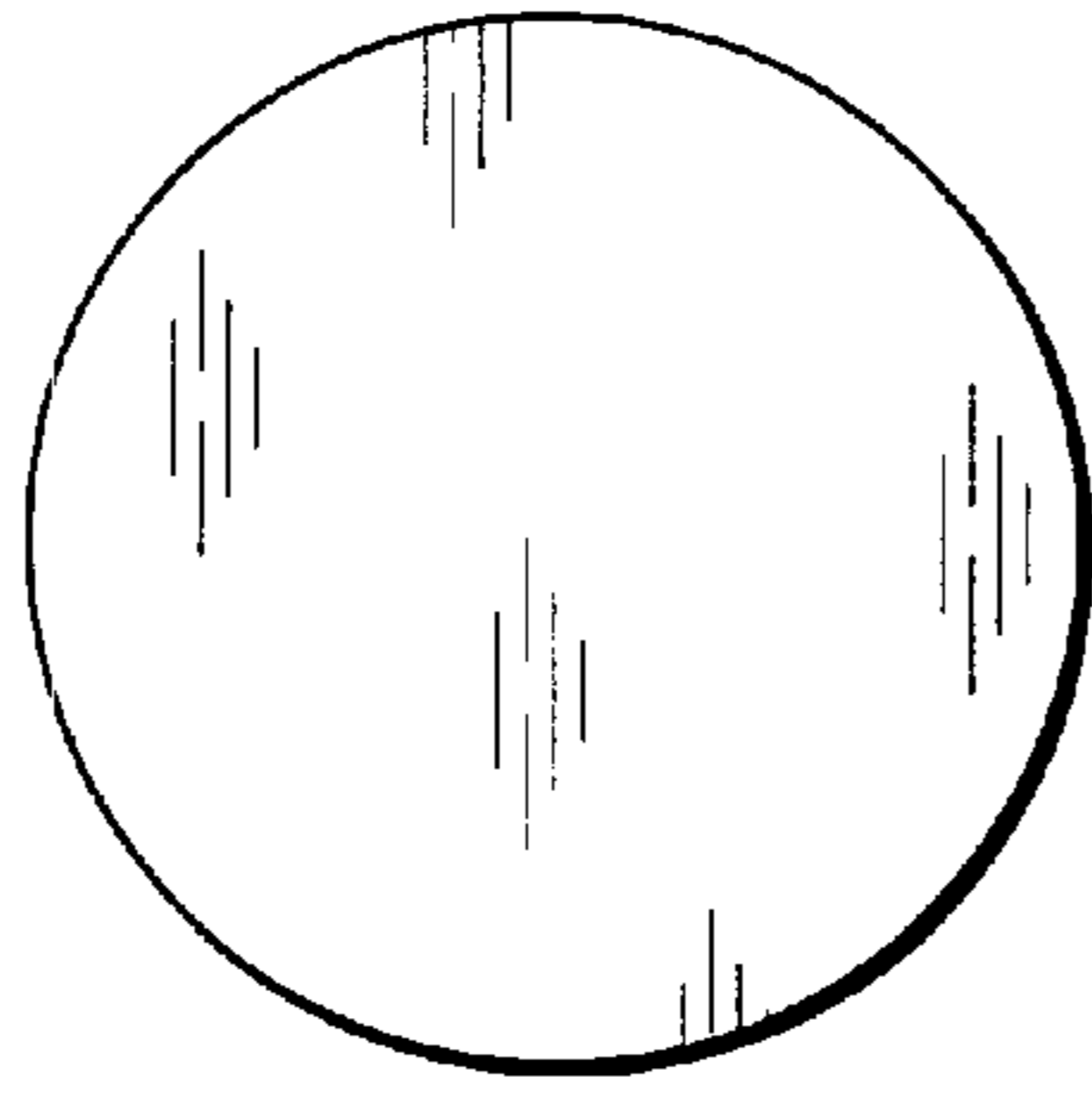

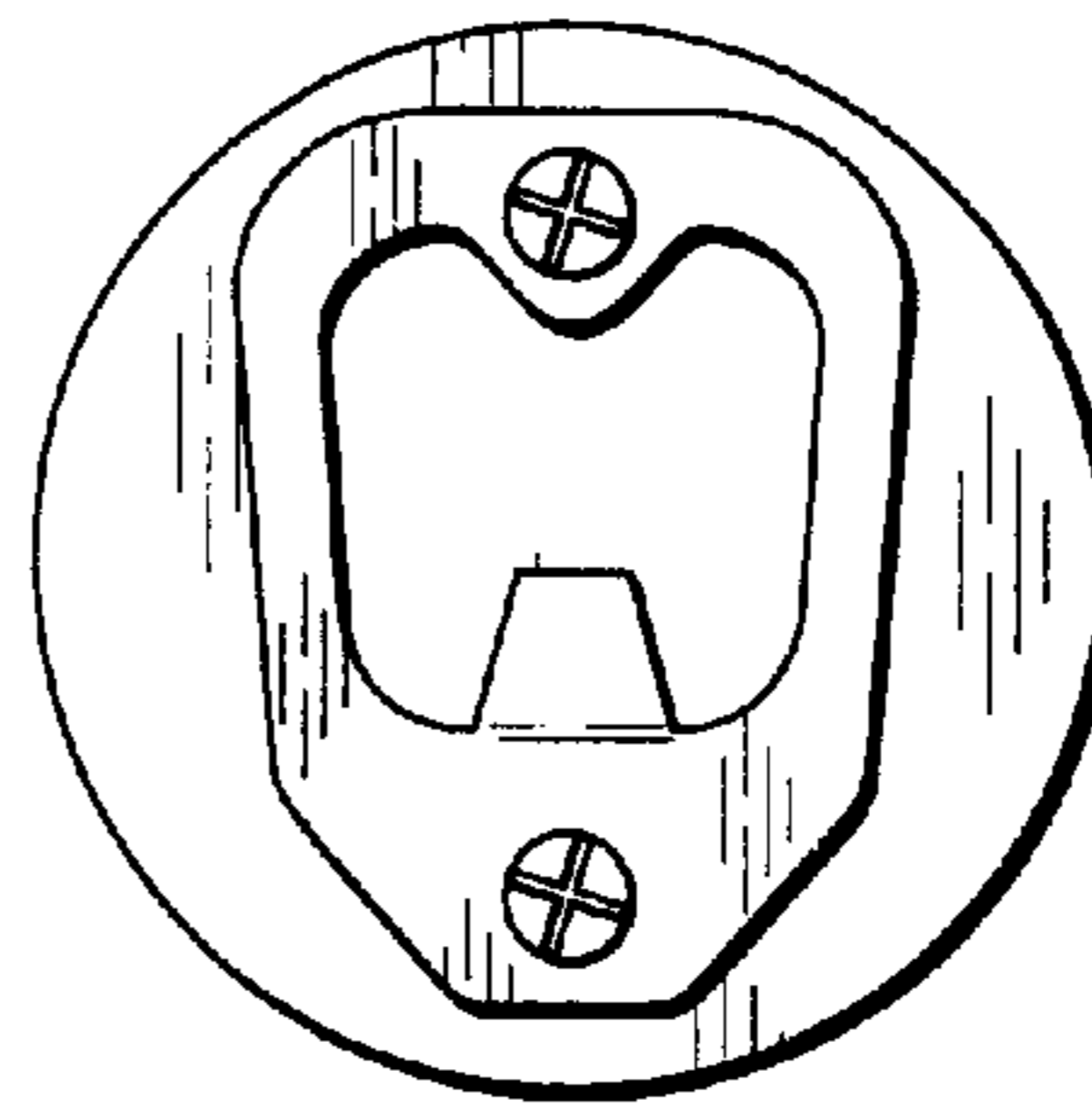

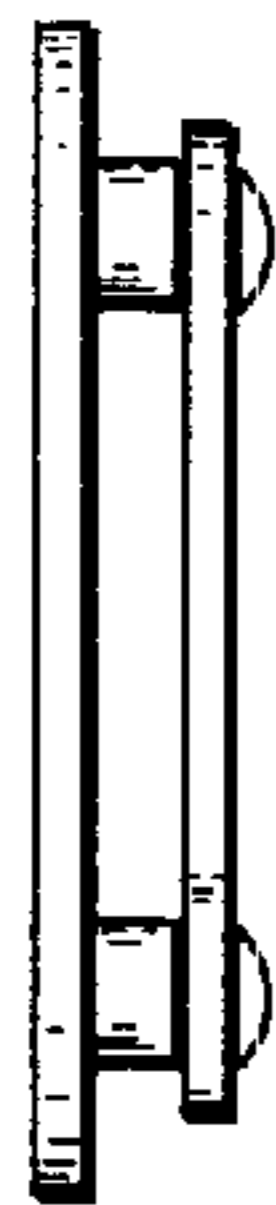
