DESCRIPTION

FIG. 1 is a perspective view of a handle showing my new design;

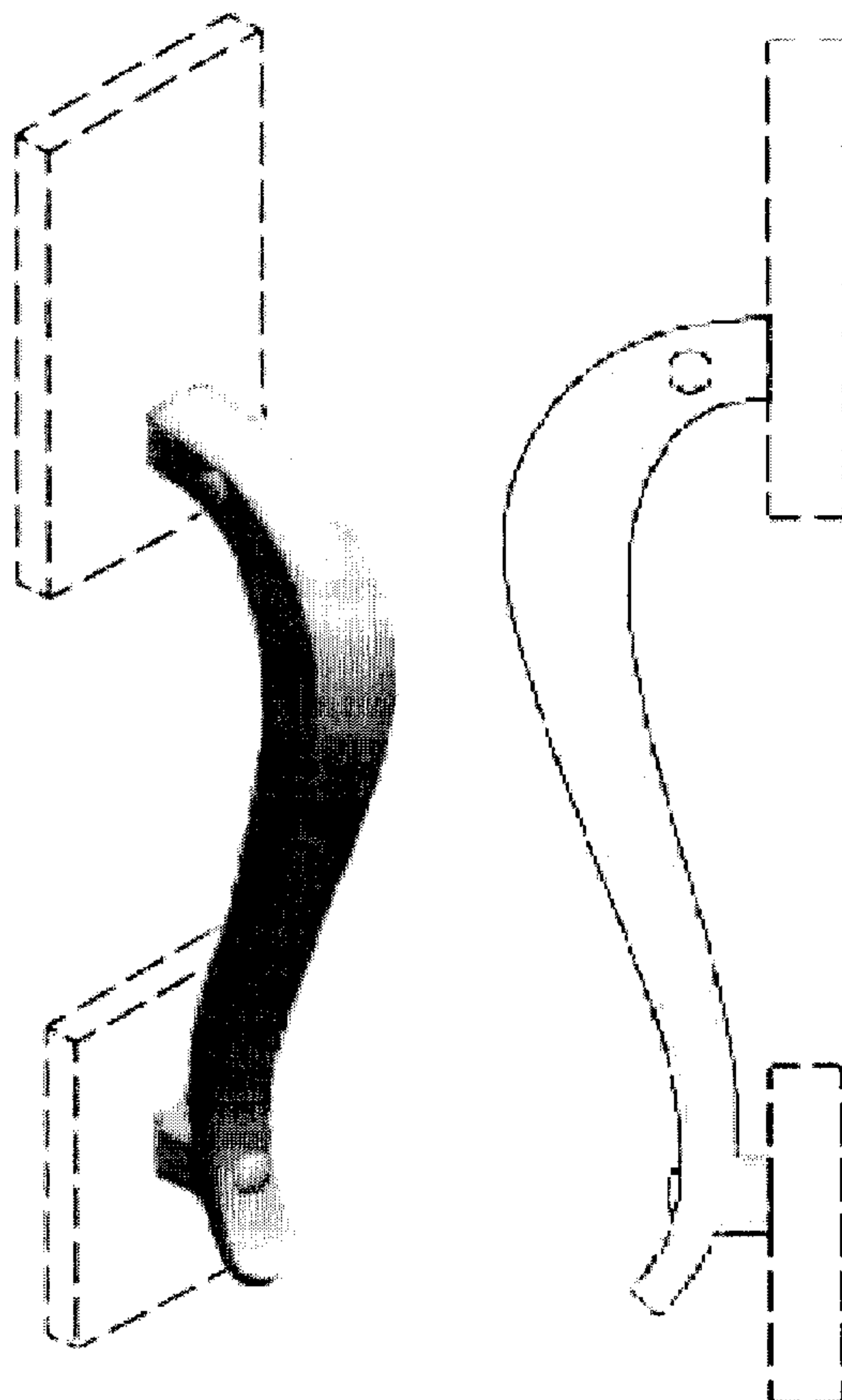

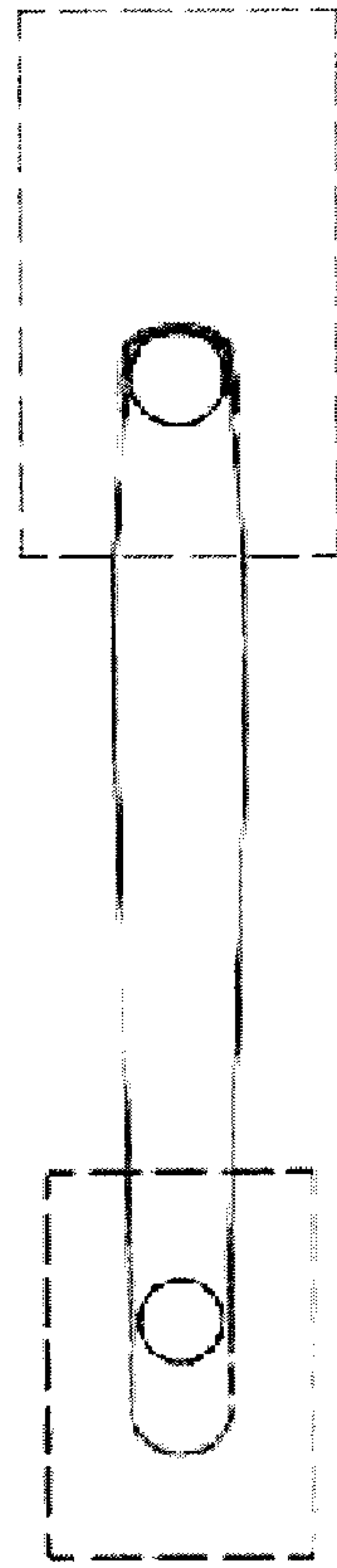

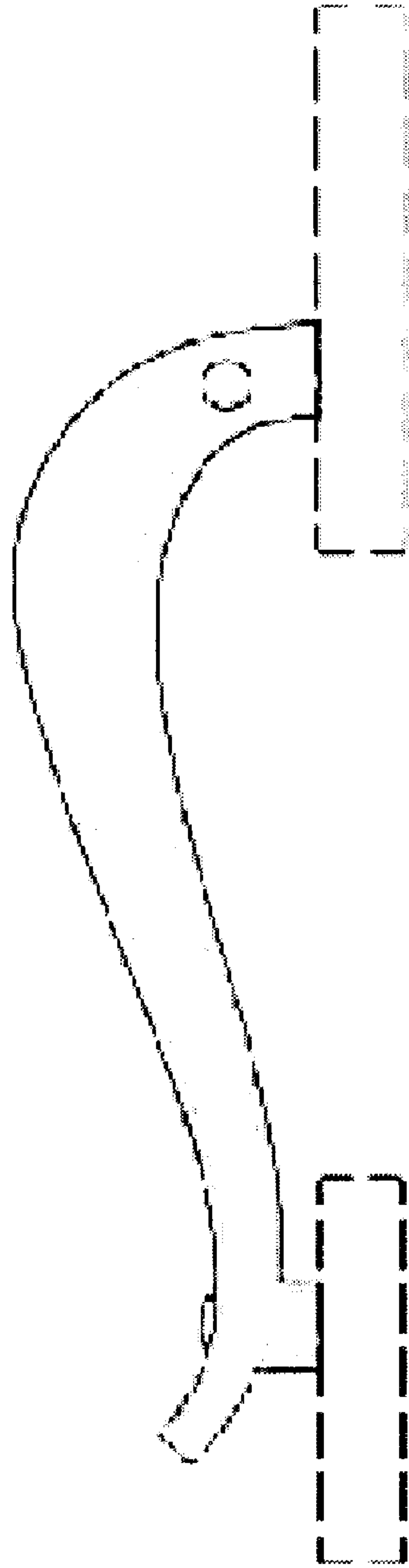
