(57) **CLAIM**

The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment showing my new design for a perfume bottle;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image;
 FIG. 5 is a bottom view plan view thereof;
 FIG. 6 is a front elevational view of a second embodiment showing my new design for a perfume bottle;
 FIG. 7 is a rear elevational view thereof;
 FIG. 8 is a top plan view thereof;
 FIG. 9 is a left side elevational view thereof, the right side elevational view being a mirror image; and,
 FIG. 10 is a bottom plan view thereof.
 The bottle portion of the perfume bottle shown in FIGS. 6-10 is transparent.

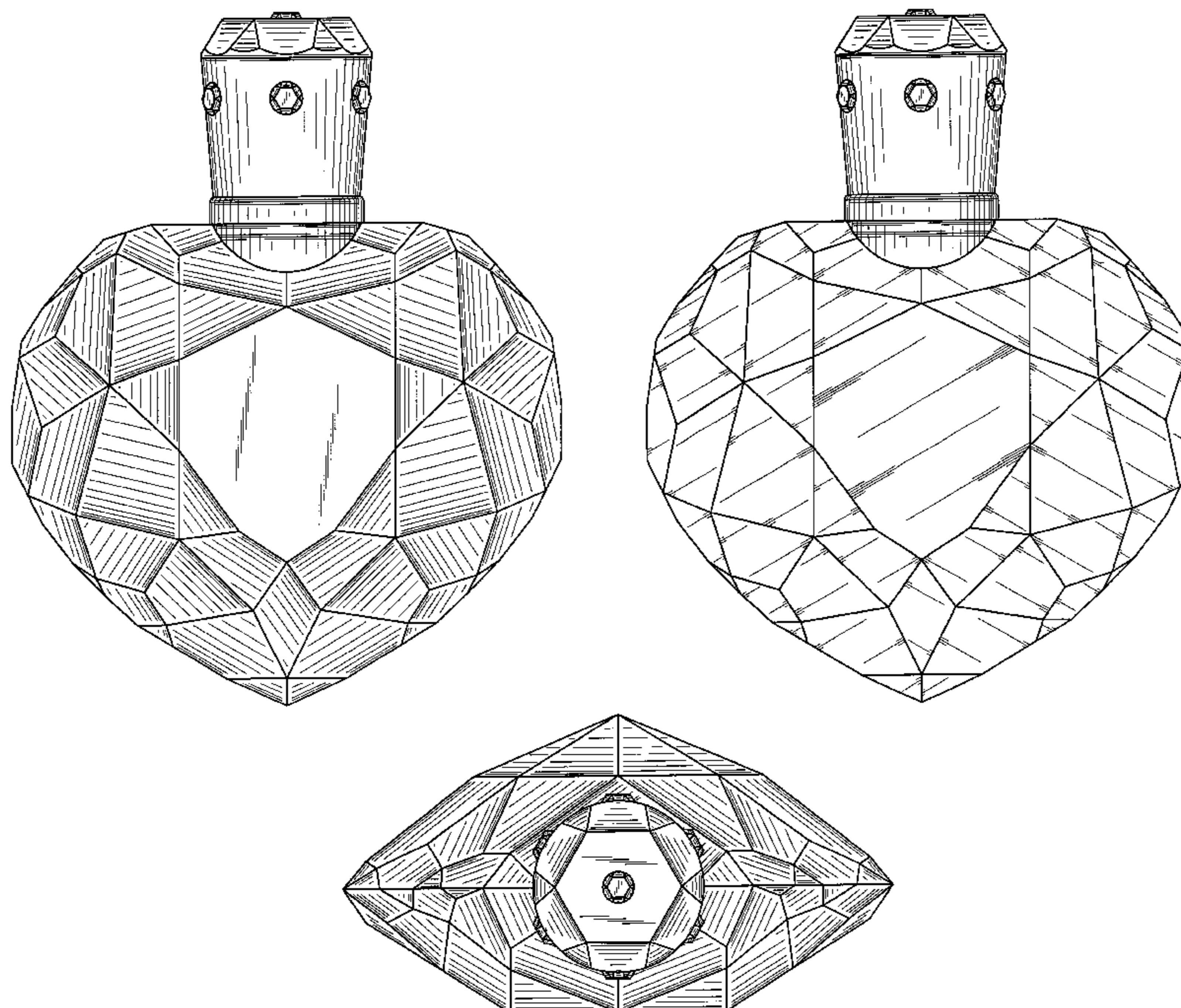

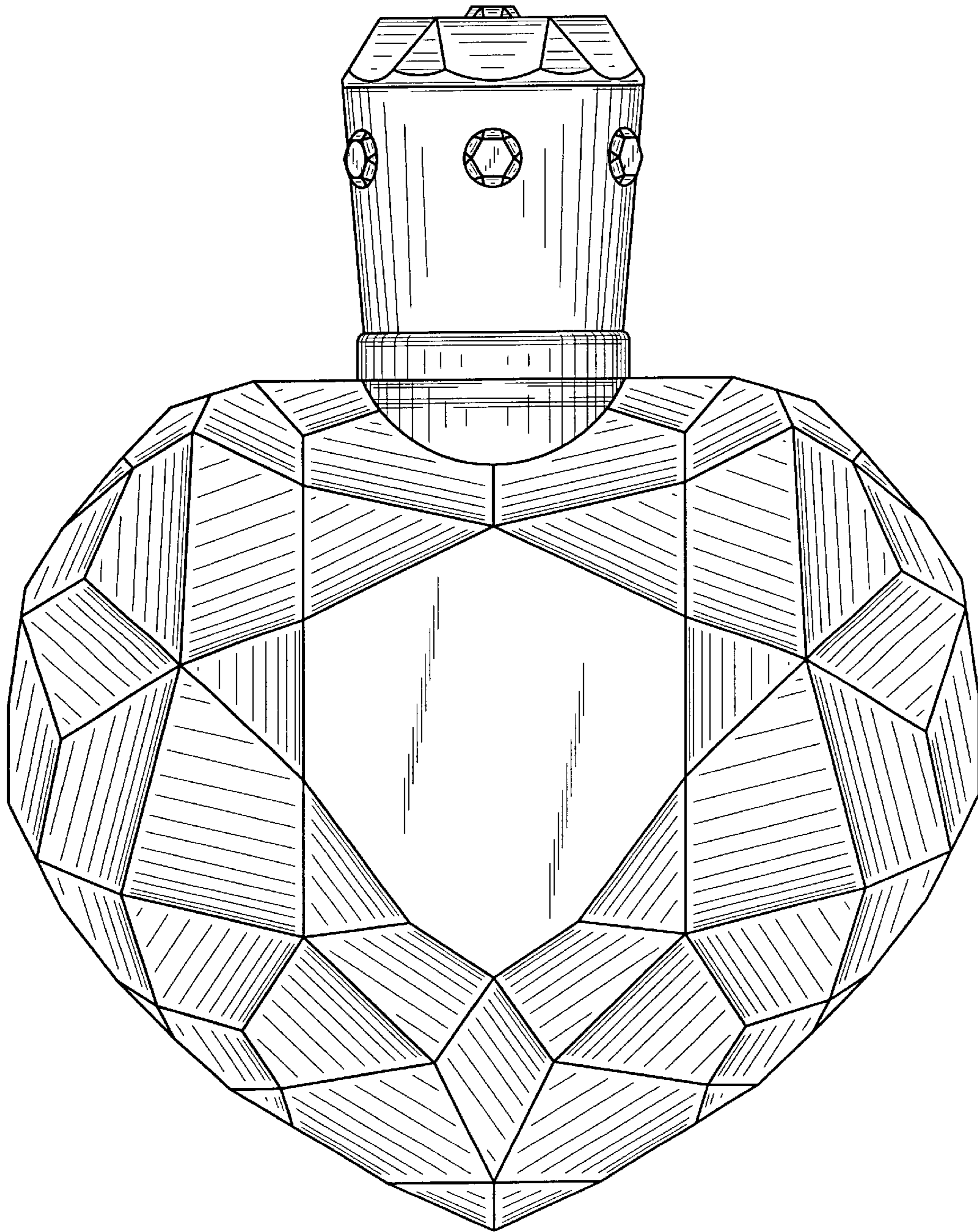

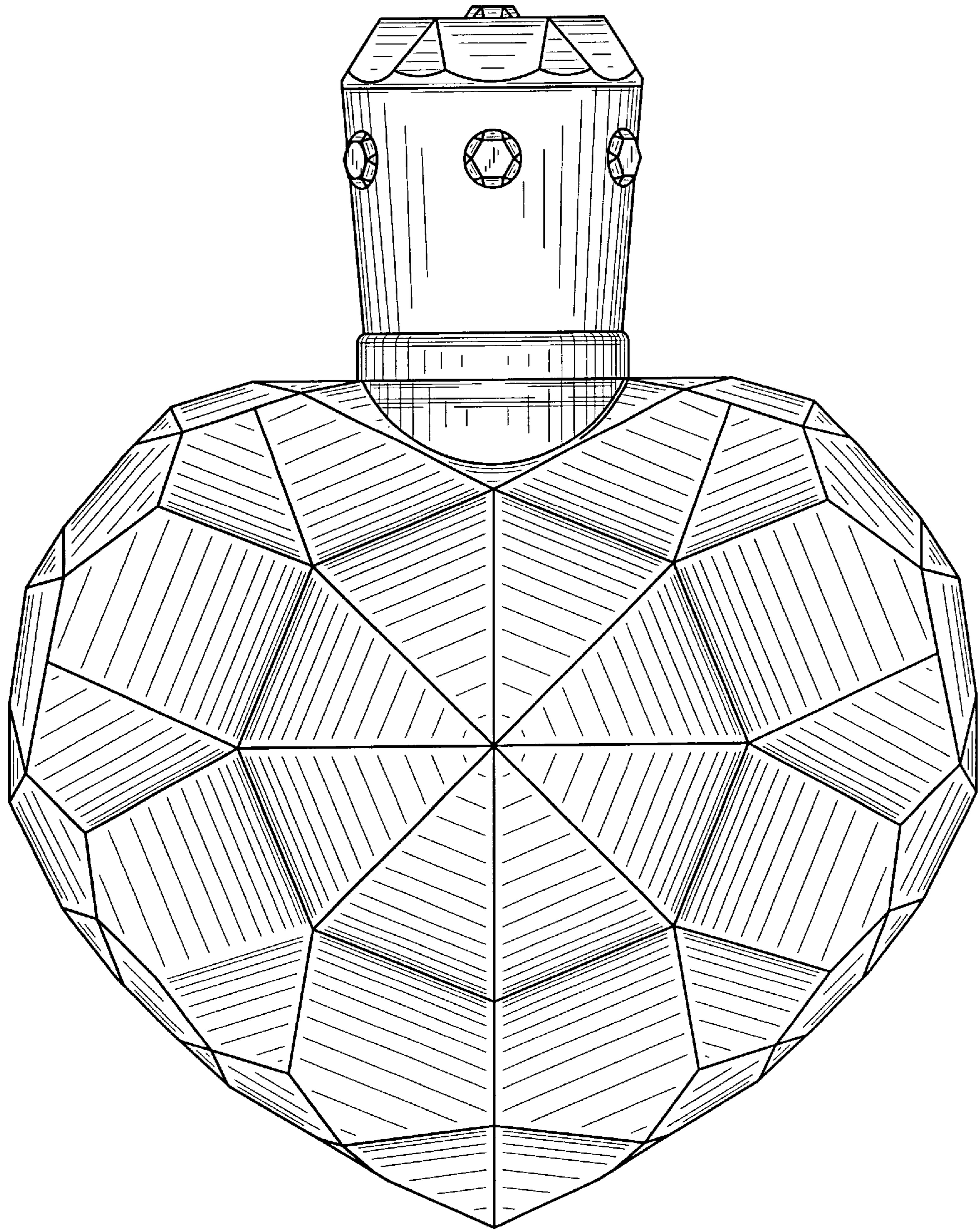

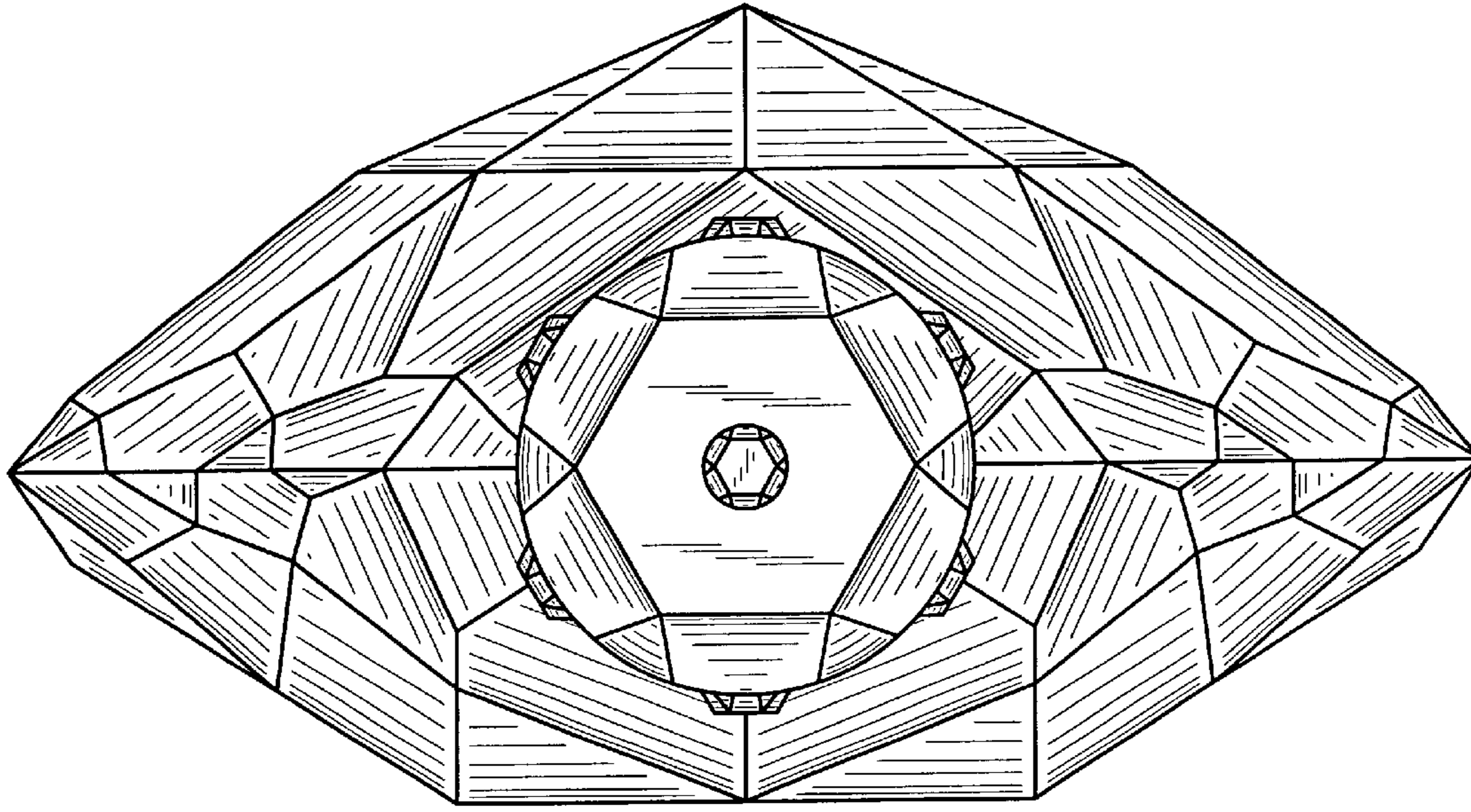

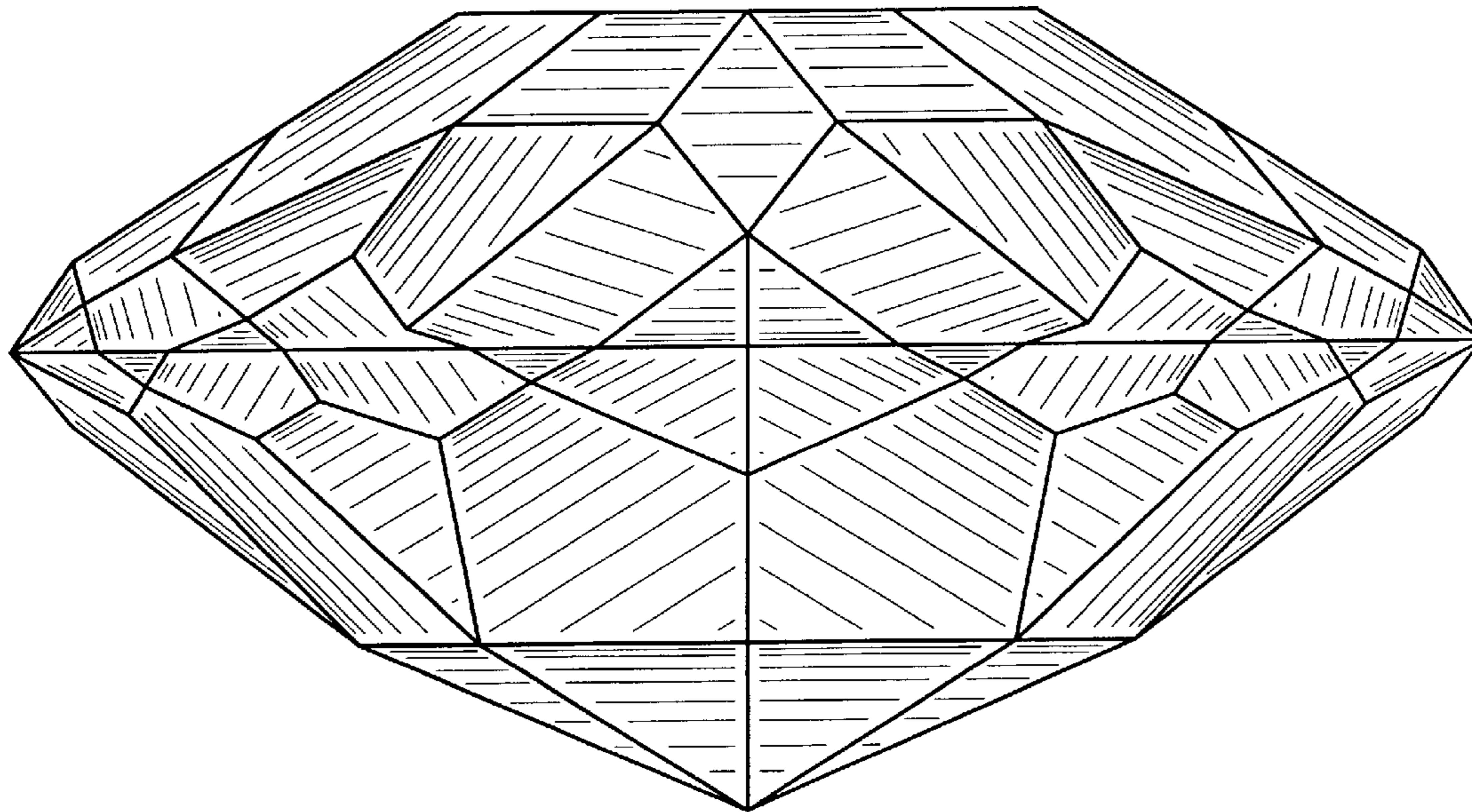

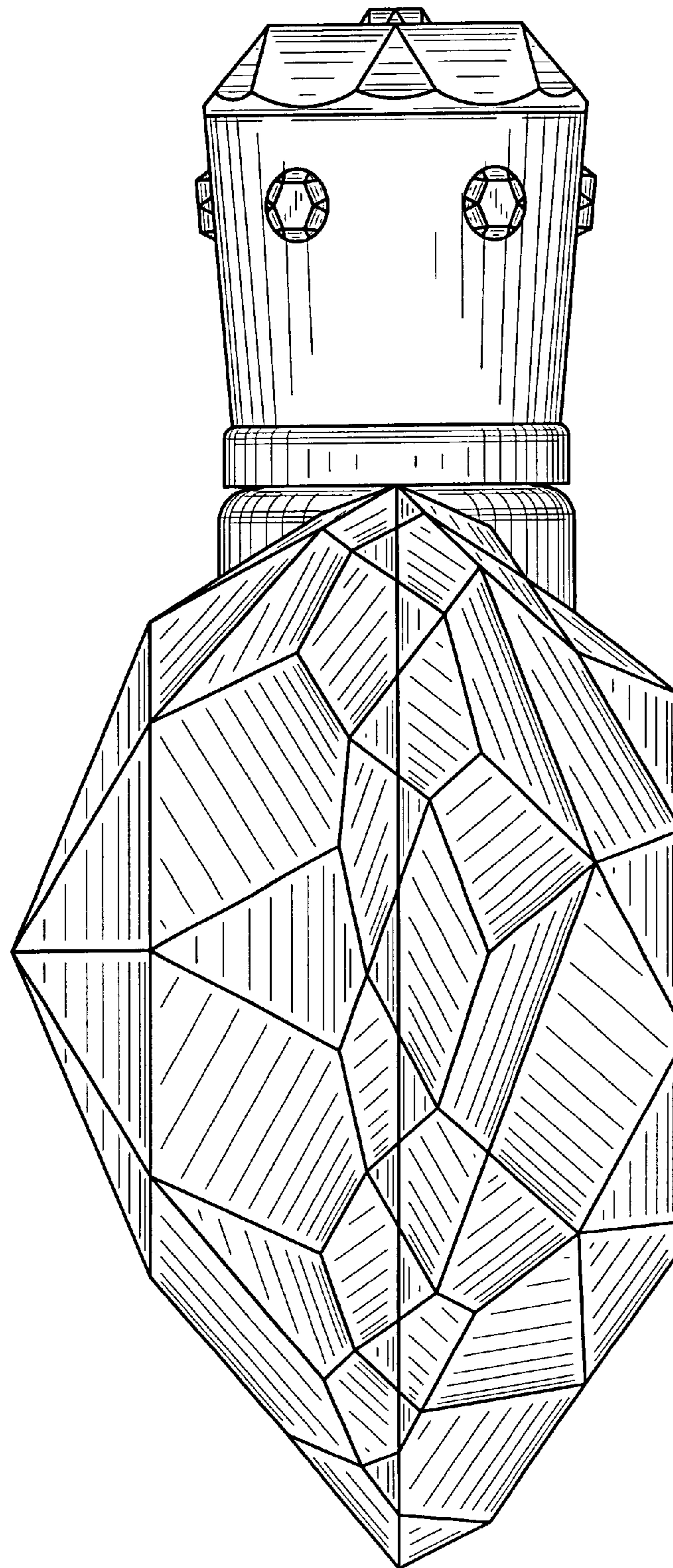

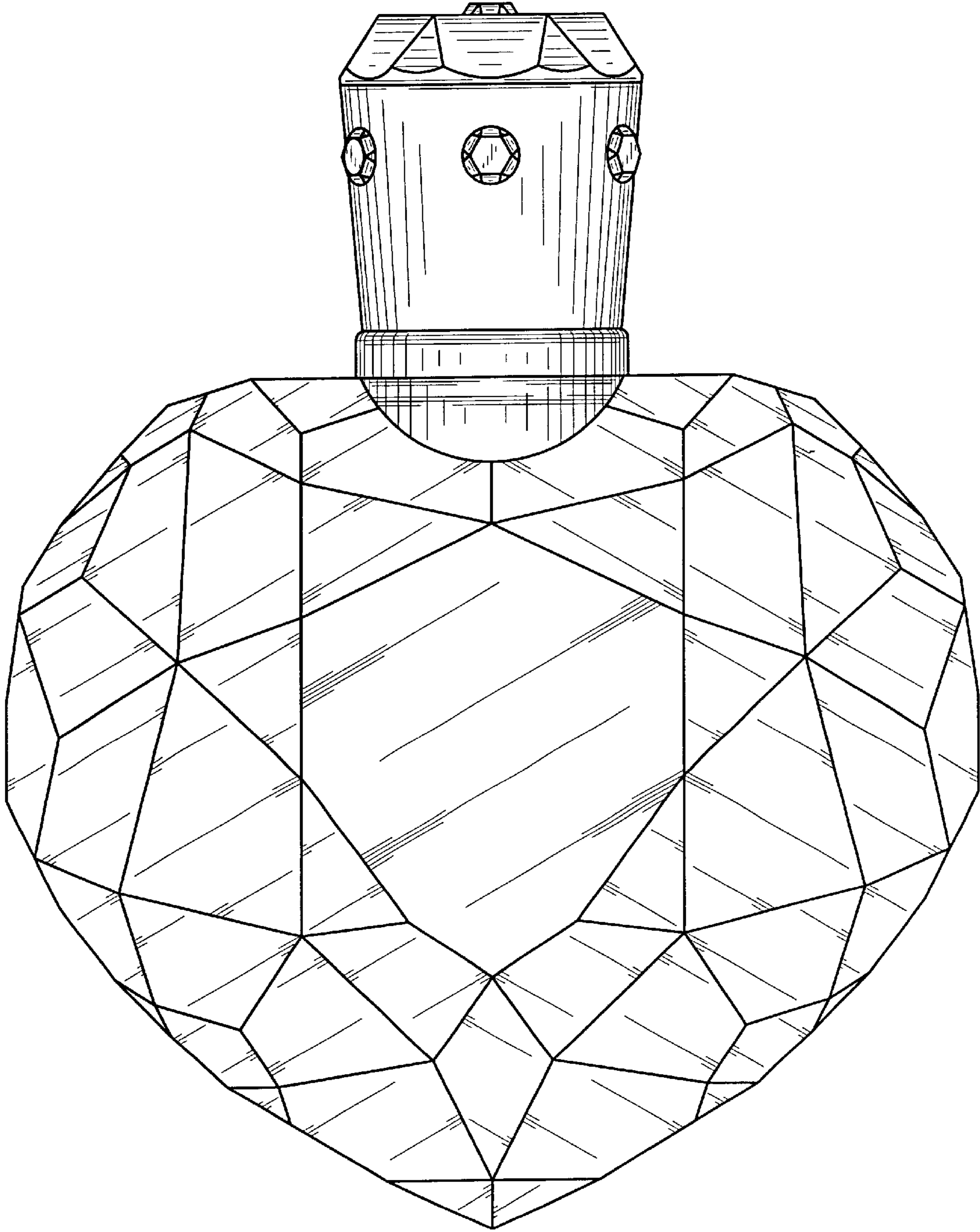

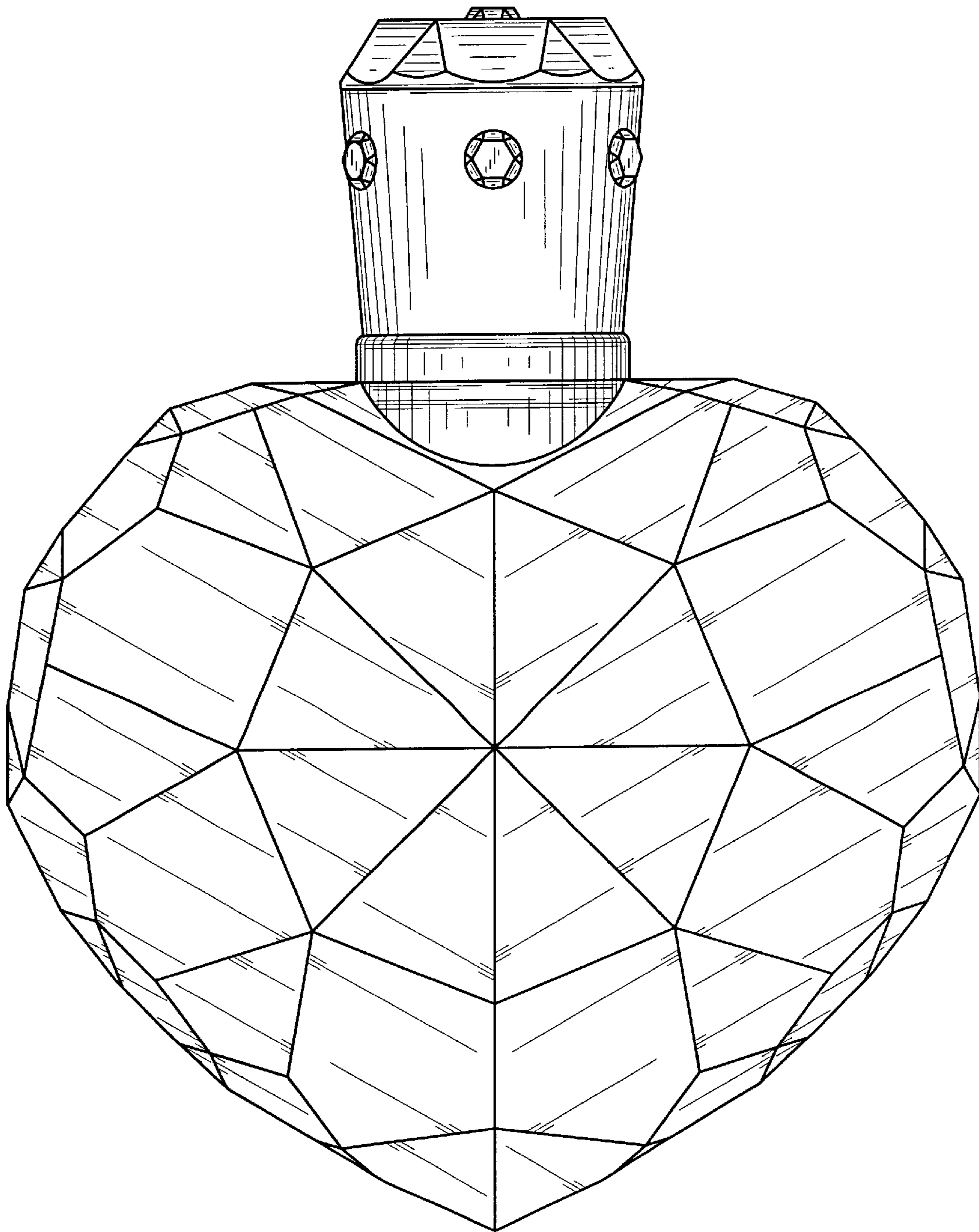

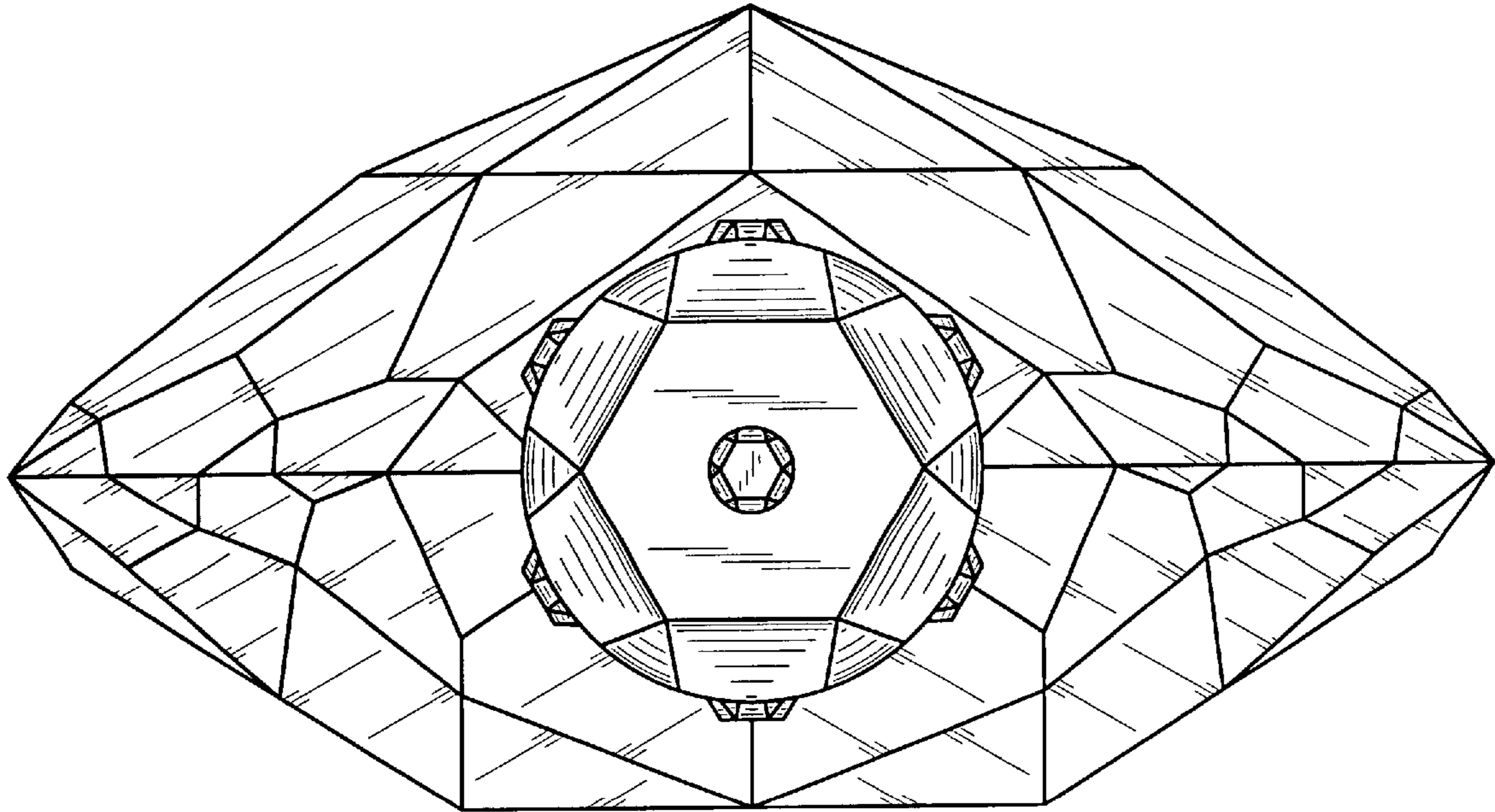

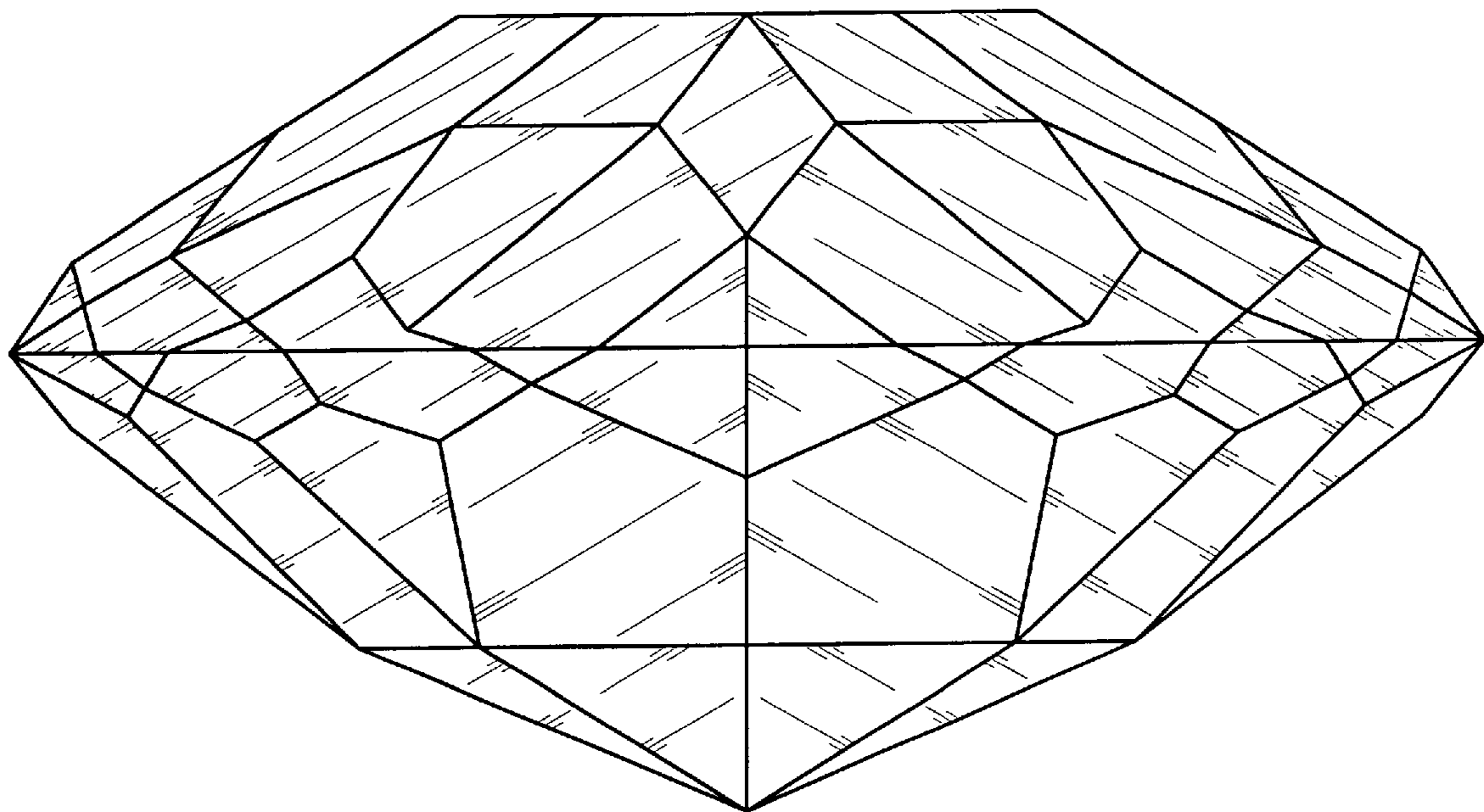
