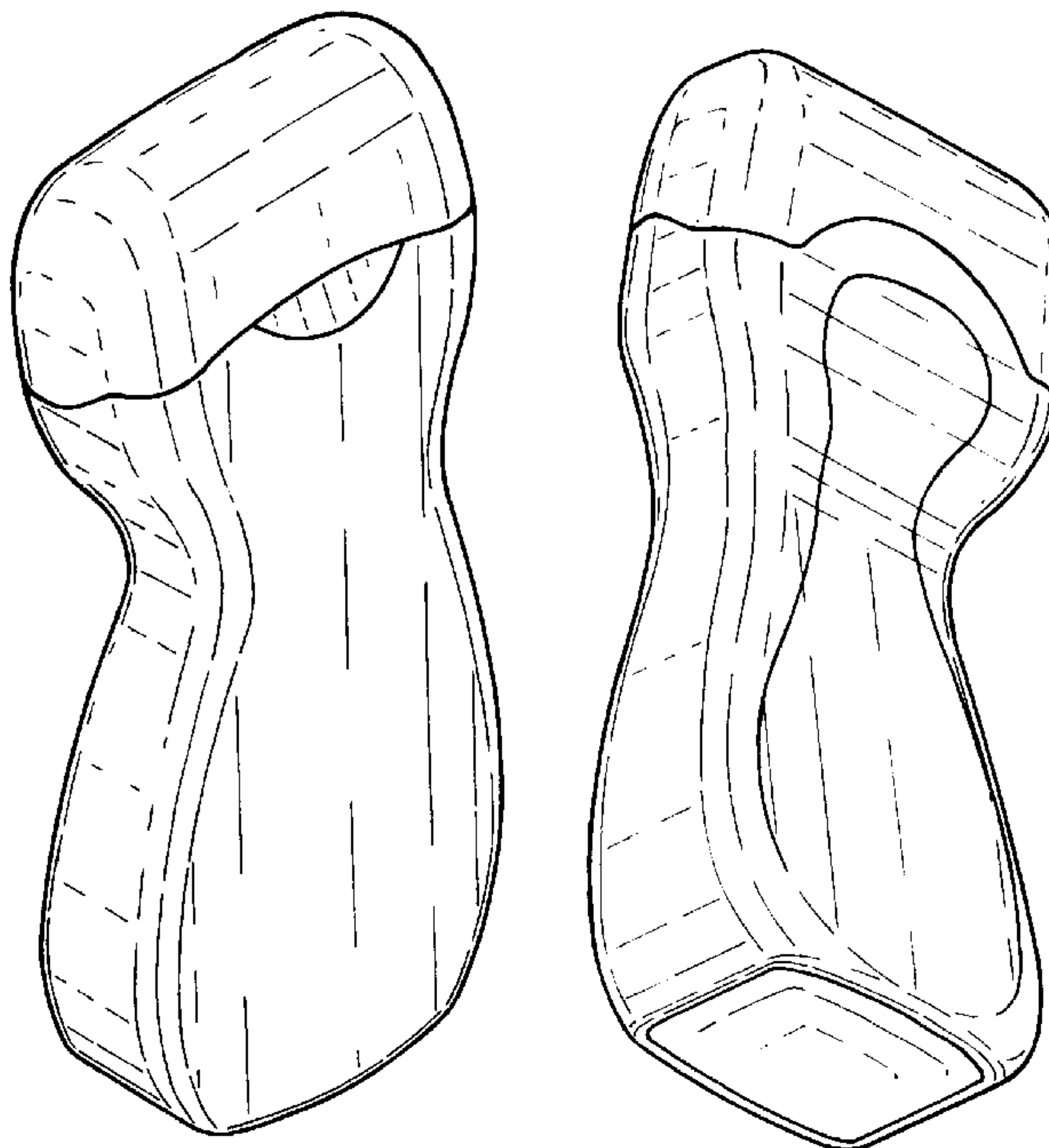
(57) **CLAIM**

The ornamental design for a roll-on bottle device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a roll-on bottle device in accordance with our invention thereof;  
FIG. 2 is an alternate perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,

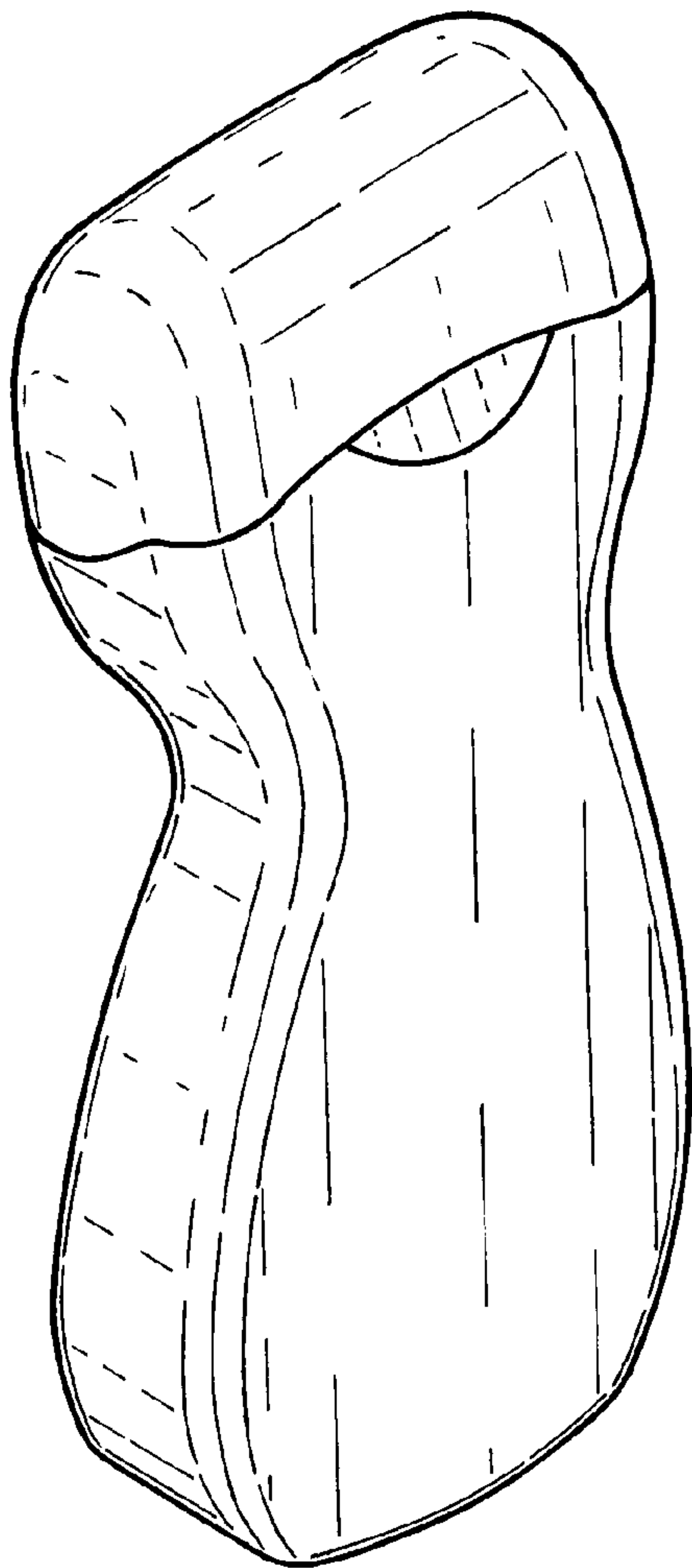

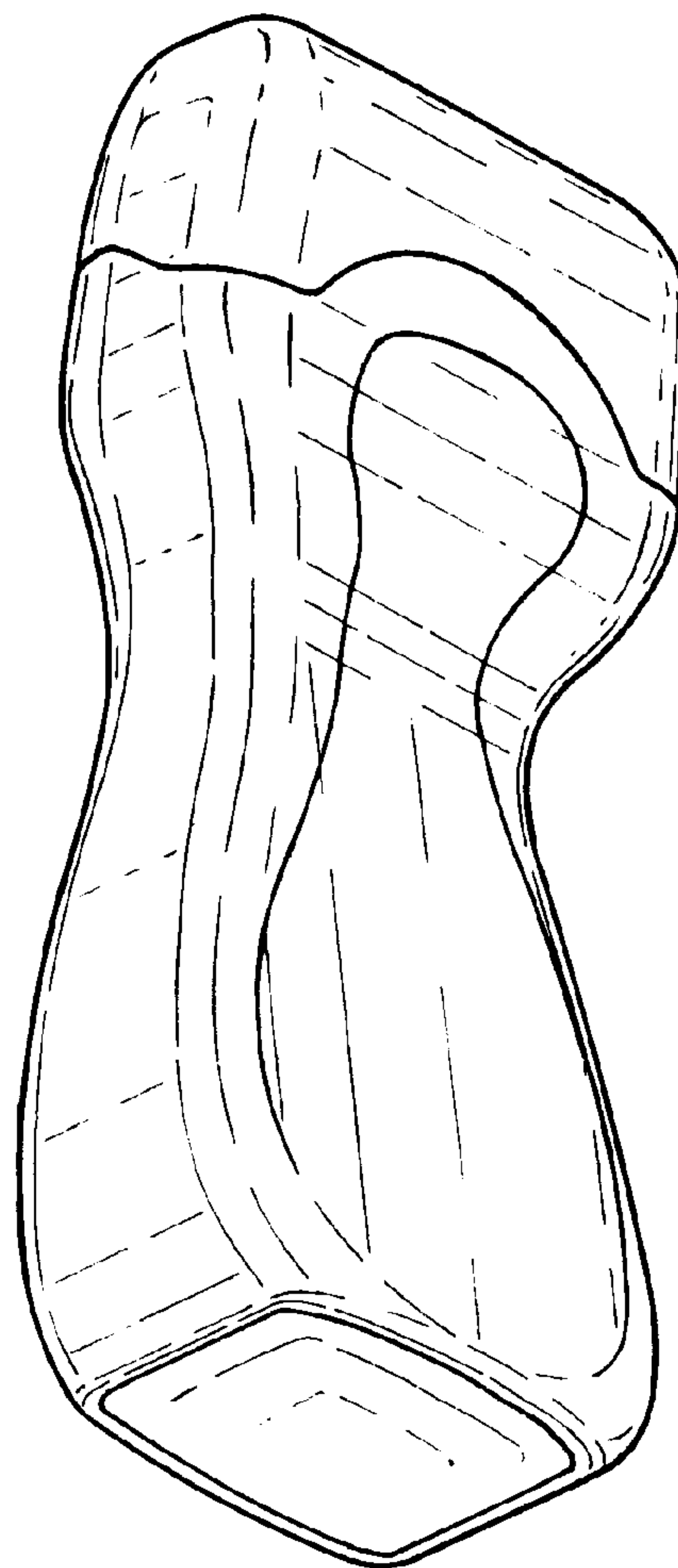

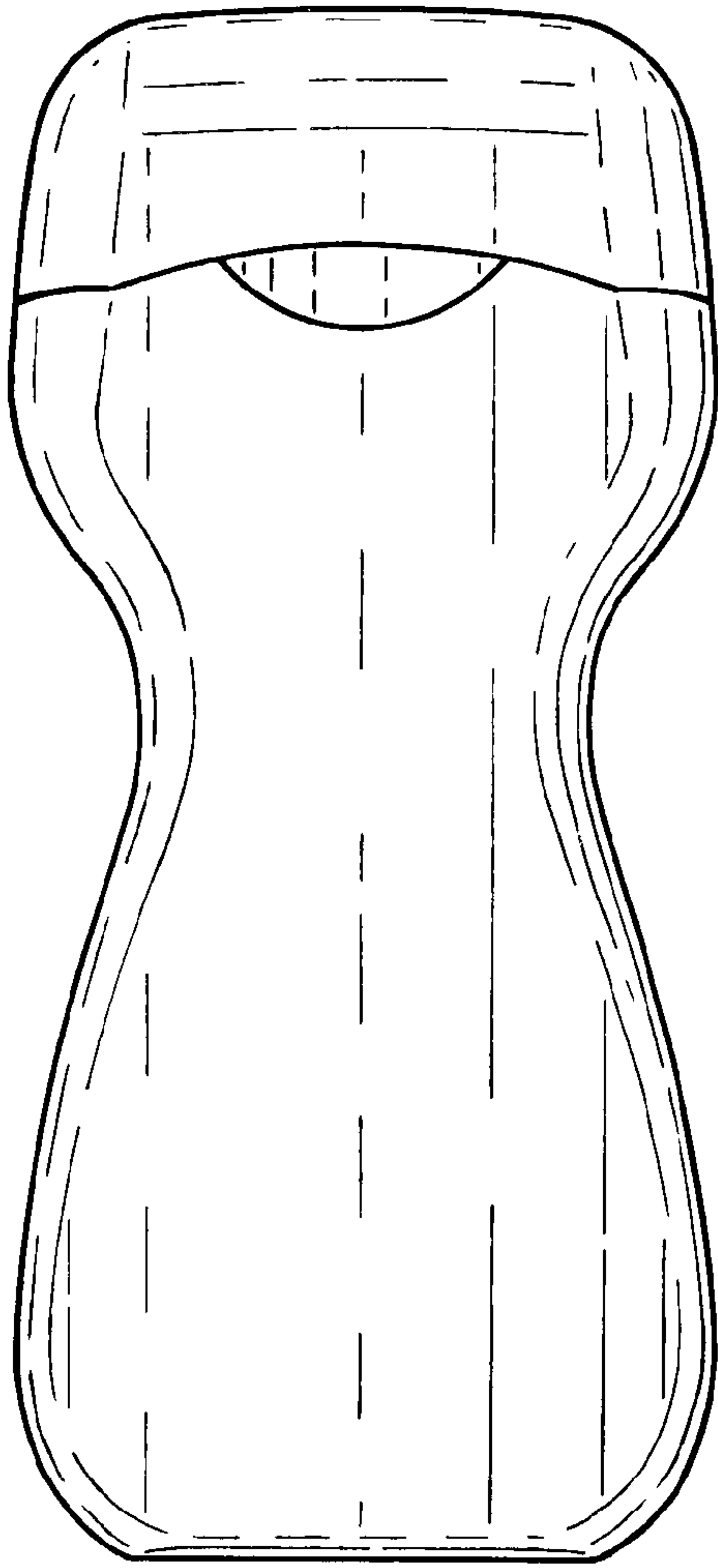

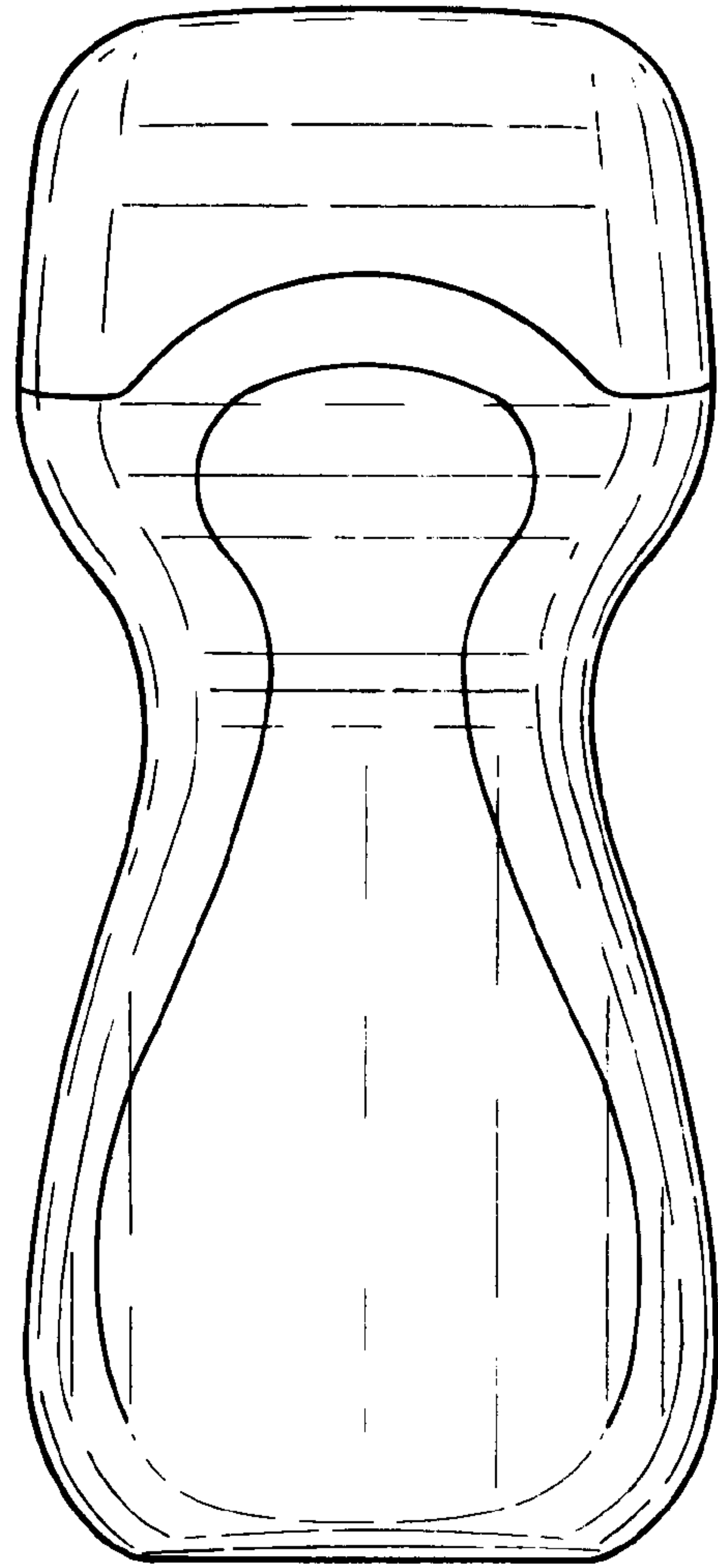

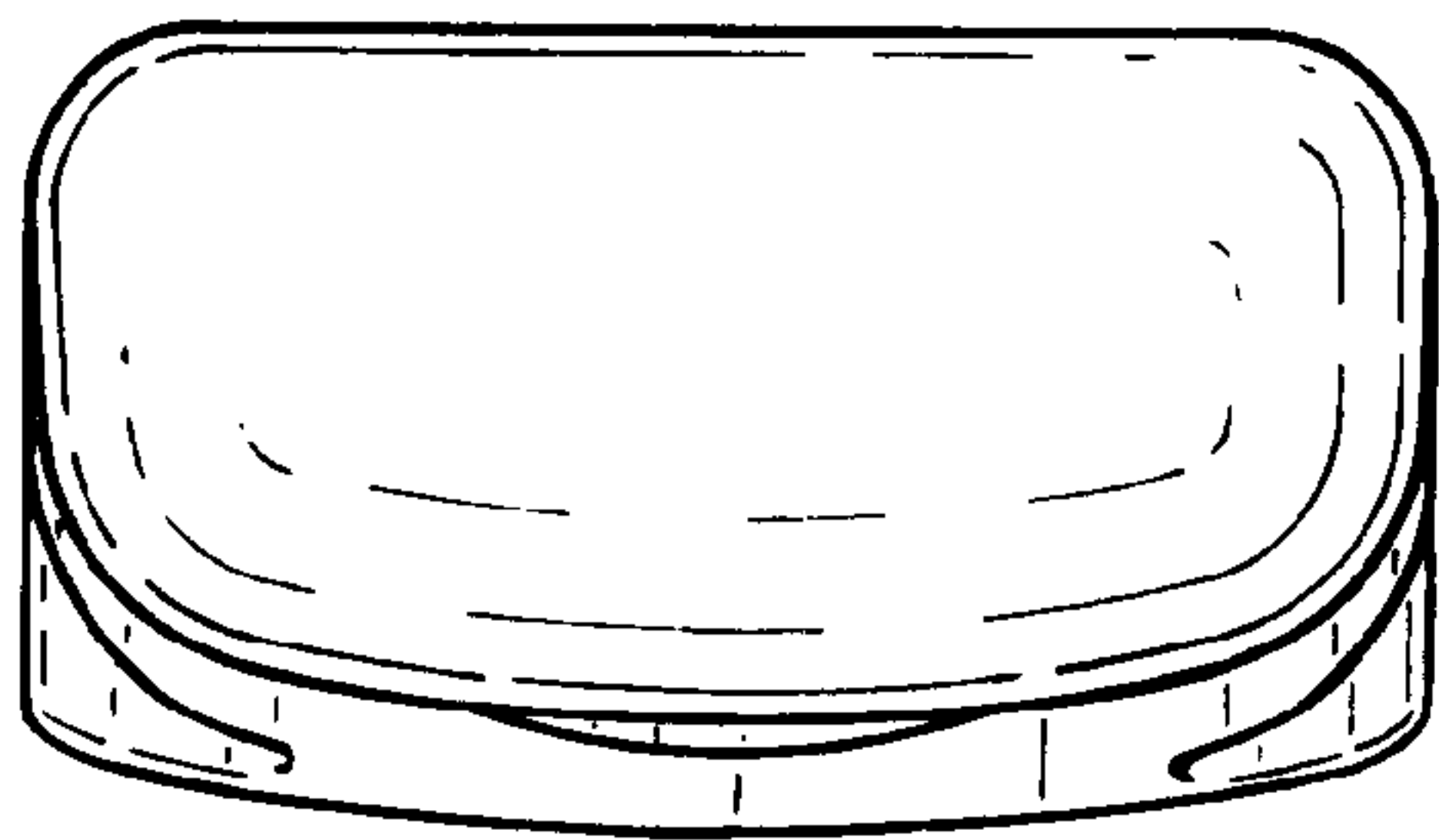

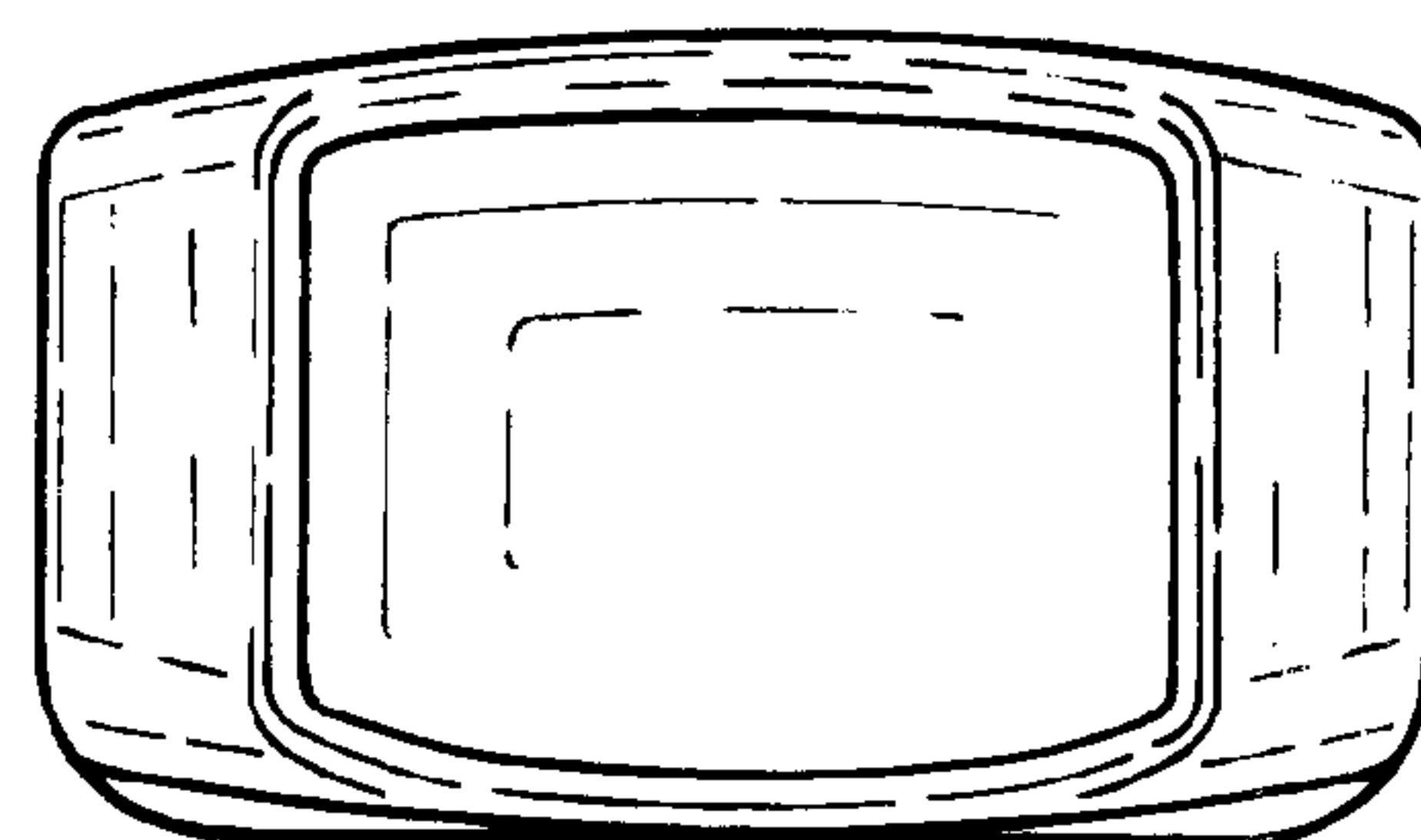

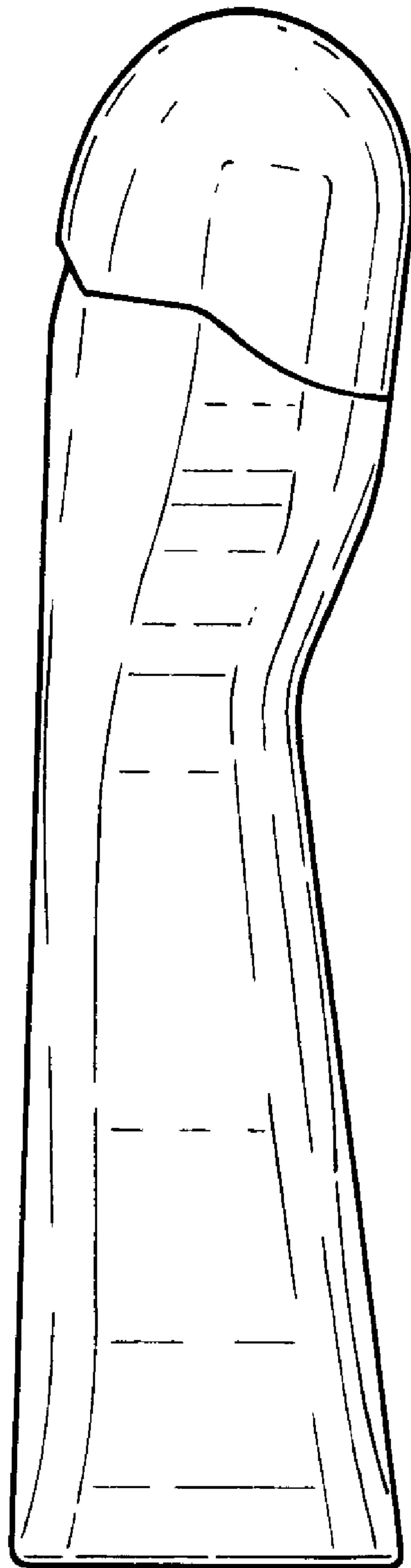
