The ornamental design for watch case with dial, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the watch case with dial of the present invention;

FIG. 2 is a front view of the watch case with dial shown in FIG. 1;

FIG. 3 is a rear view of the watch case with dial shown in FIG. 1;

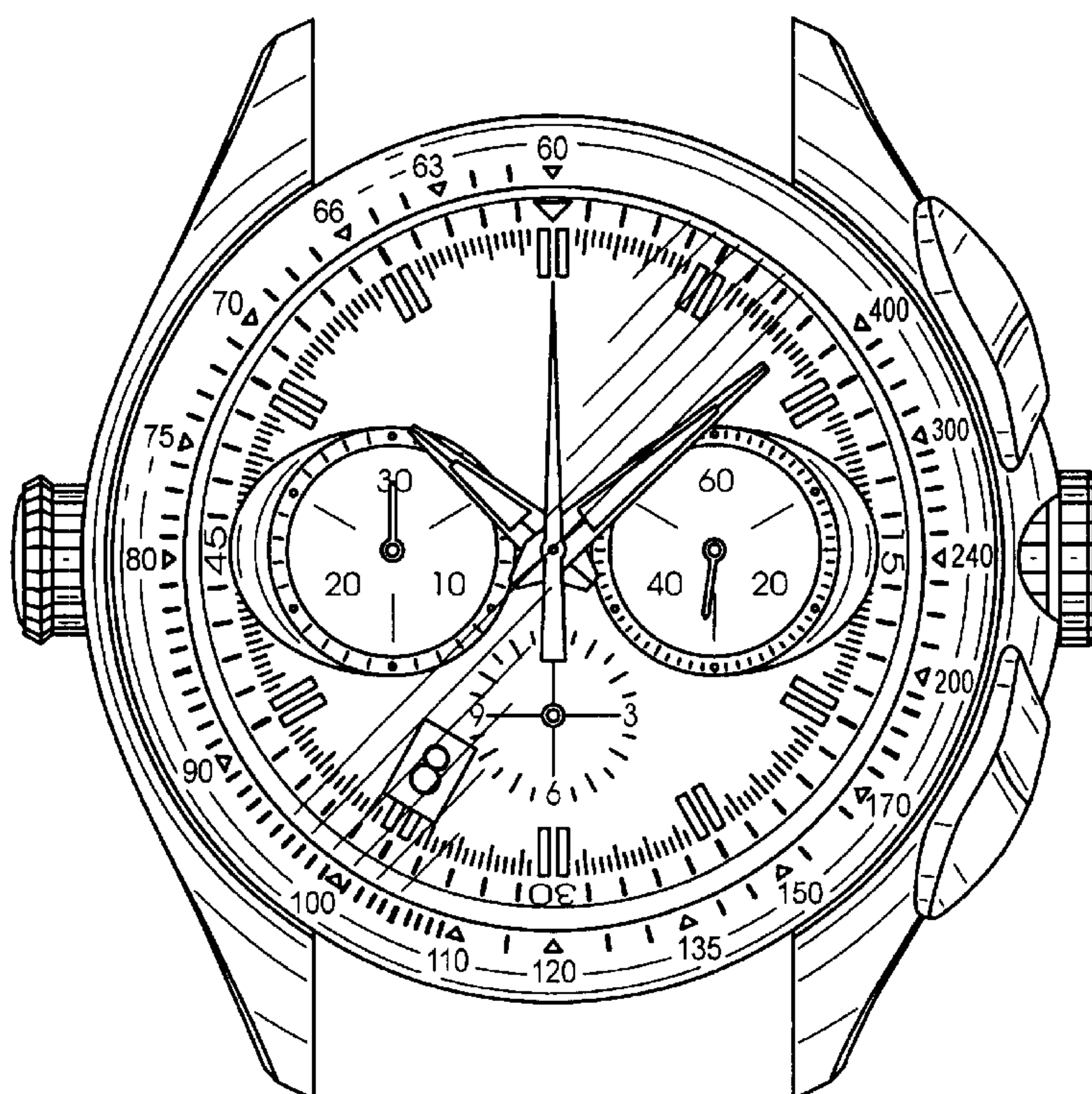
FIG. 4 is a left side elevational view of the watch case with dial shown in FIG. 1;

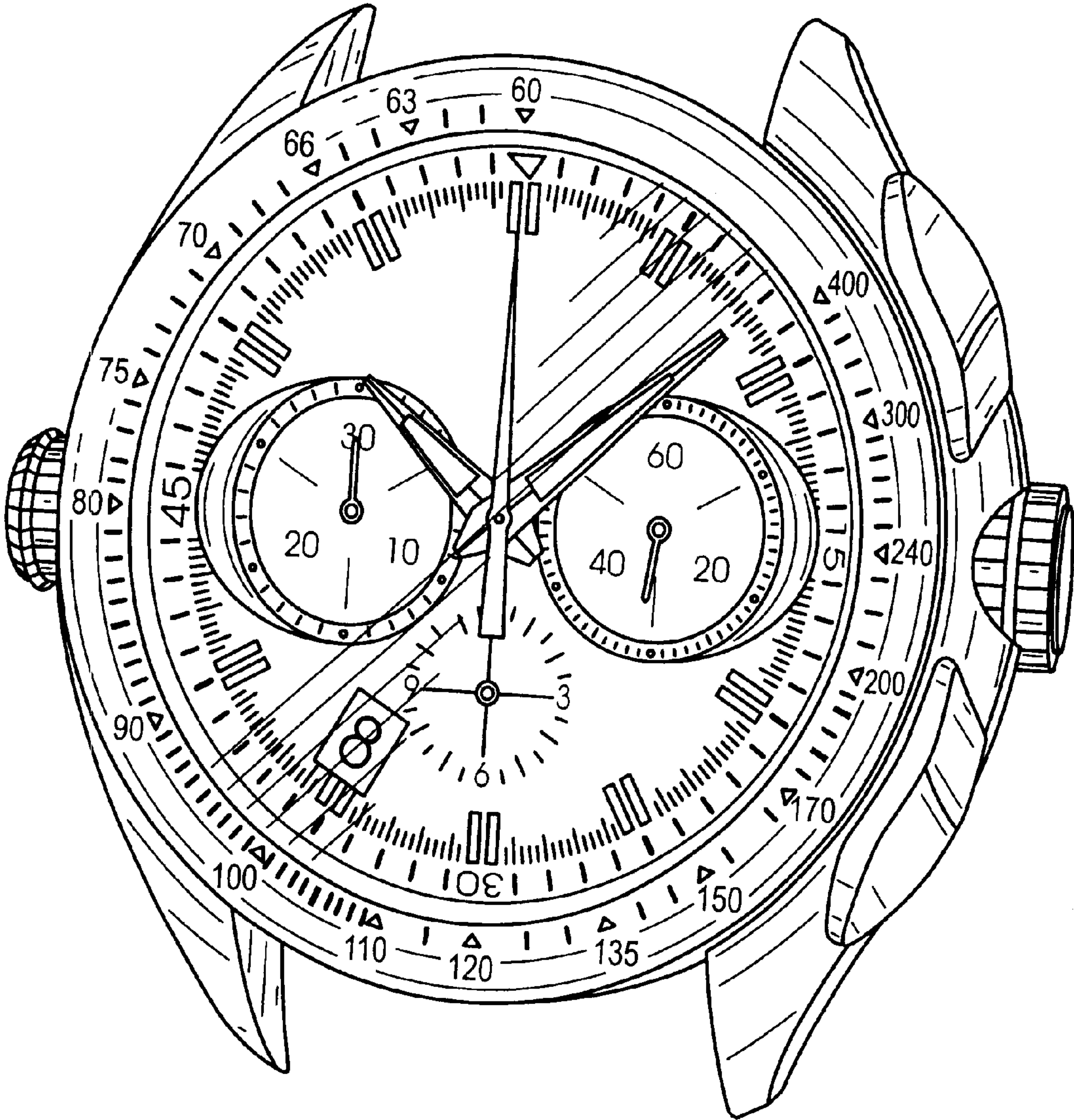

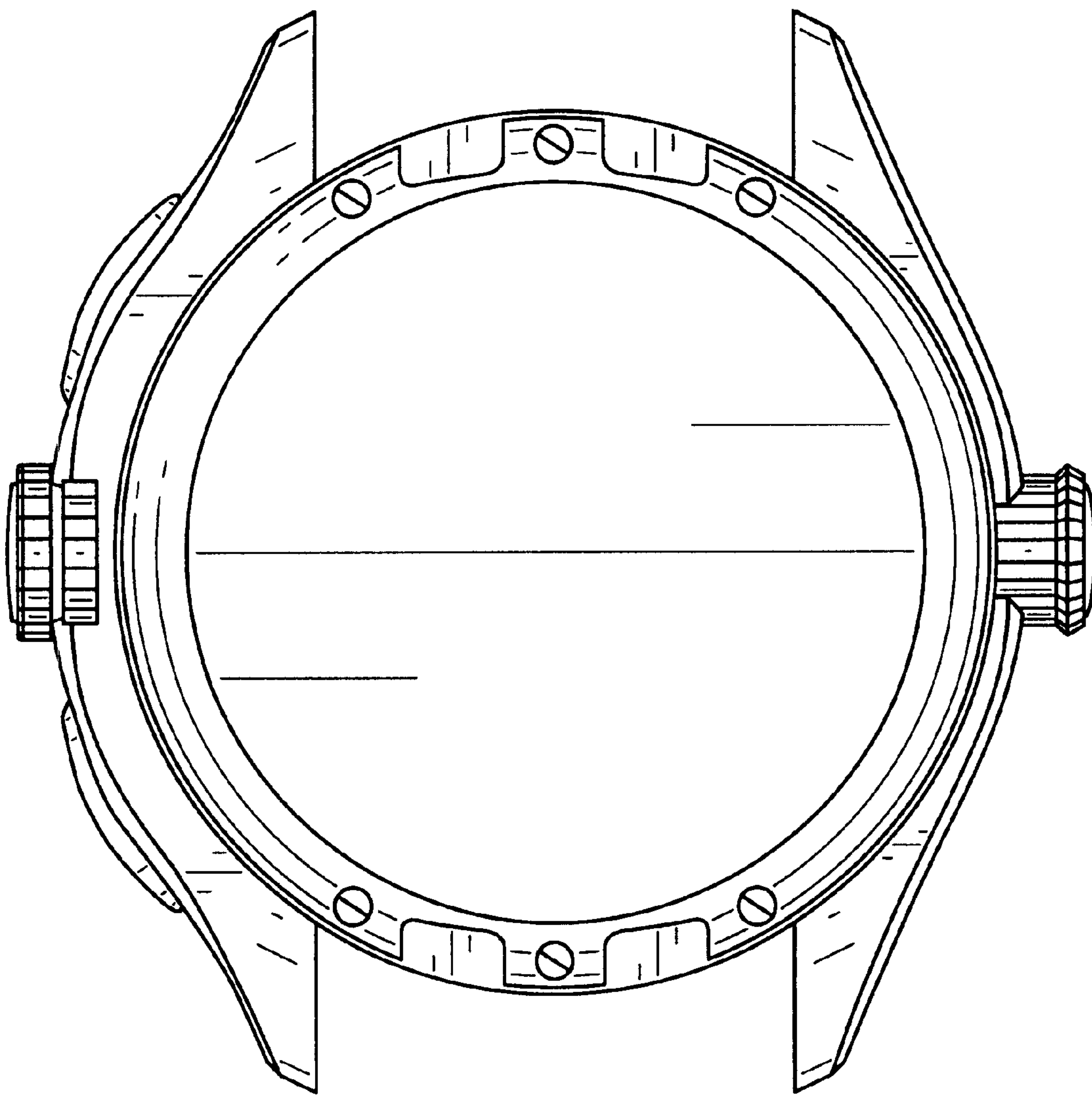

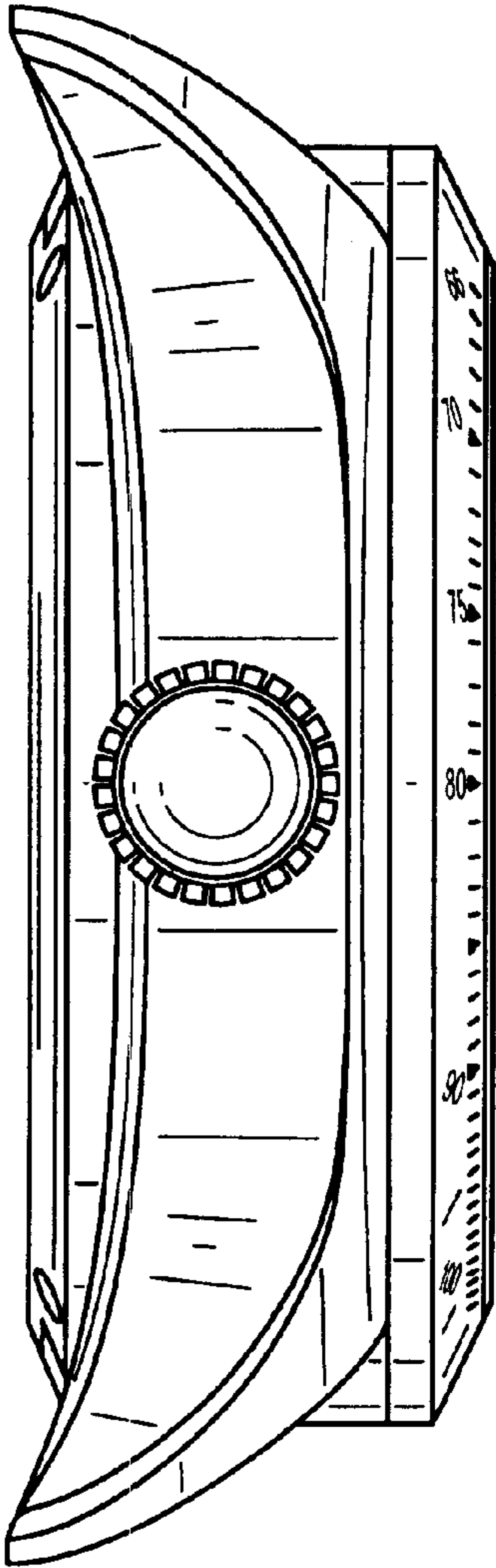

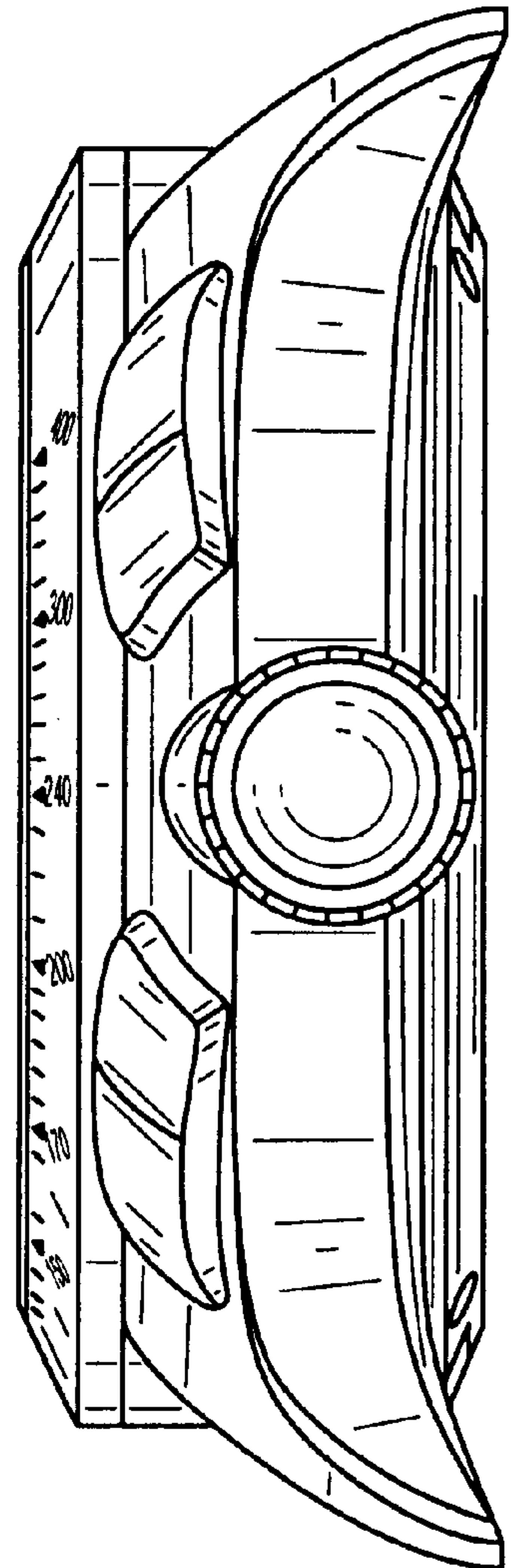

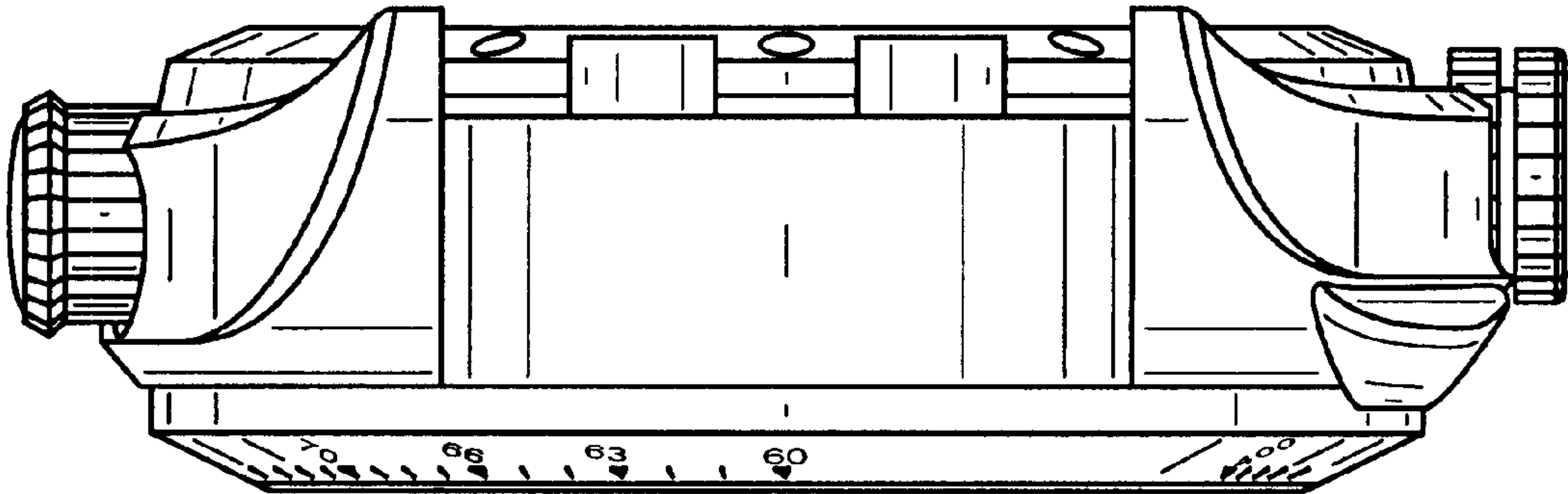

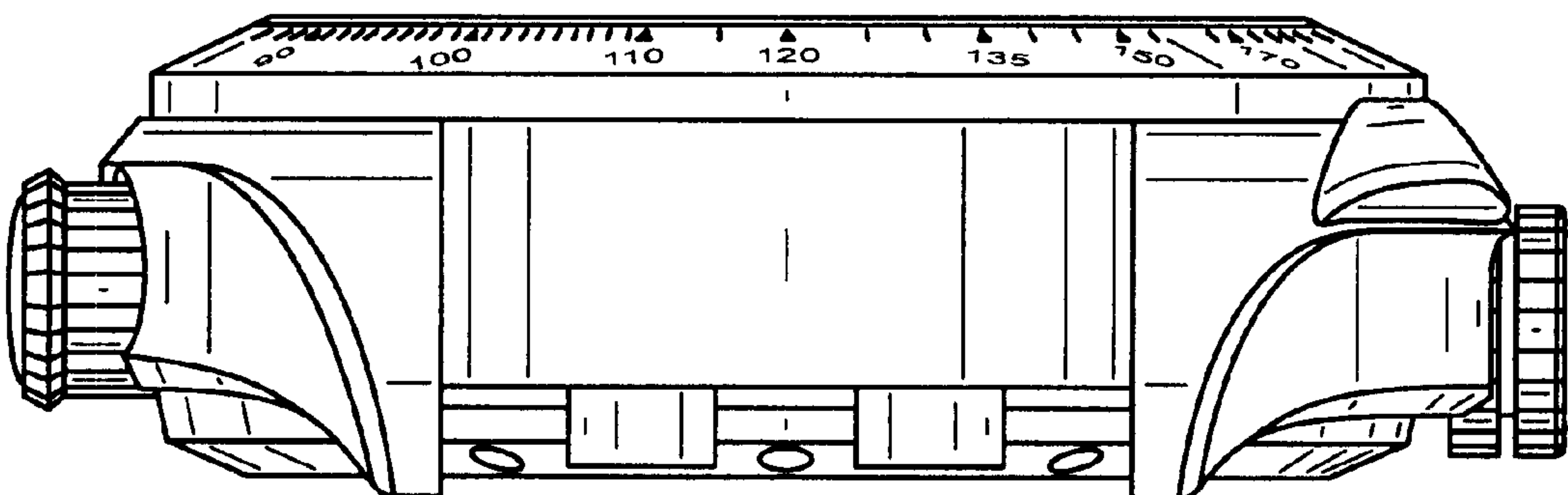
