(57) **CLAIM**

The ornamental design for a vehicle cover with bow/gift wrap design, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle cover with bow/gift wrap design, illustrating the invention as draped over a vehicle;

FIG. 2 is a front elevational view of the invention, illustrating the invention as draped over the vehicle;

FIG. 3 is a rear elevational view of the invention, illustrating the invention as draped over the vehicle;

FIG. 4 is a left-side elevational view of the invention, illustrating the invention as draped over the vehicle, the right-side elevational view of the invention being a mirror image thereof; and,

FIG. 5 is a top plan view of the invention, illustrating the invention as draped over the vehicle.

The bottom plan view of the invention is not visible when draped over the vehicle in use, and forms no part of the claimed design.

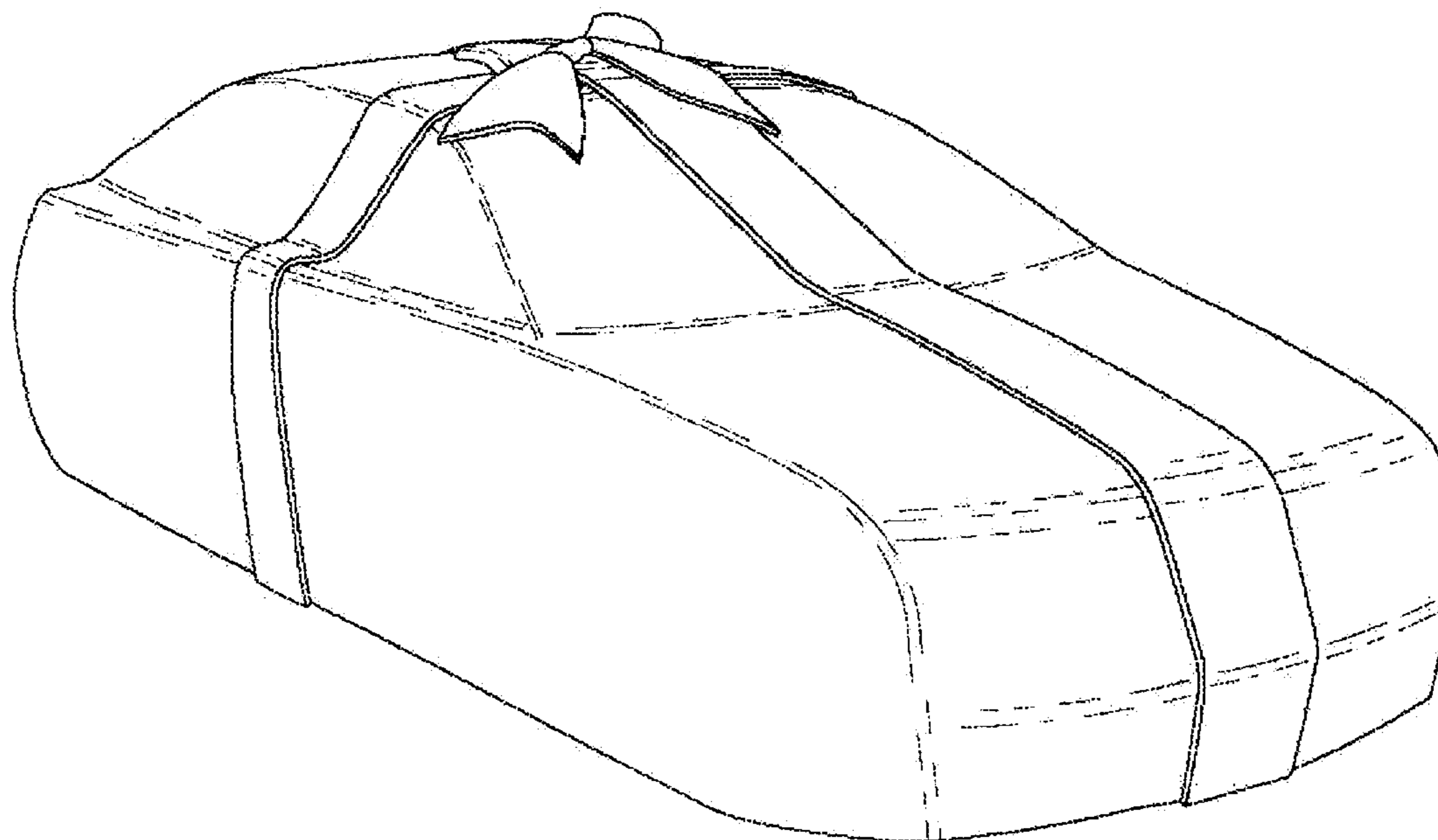

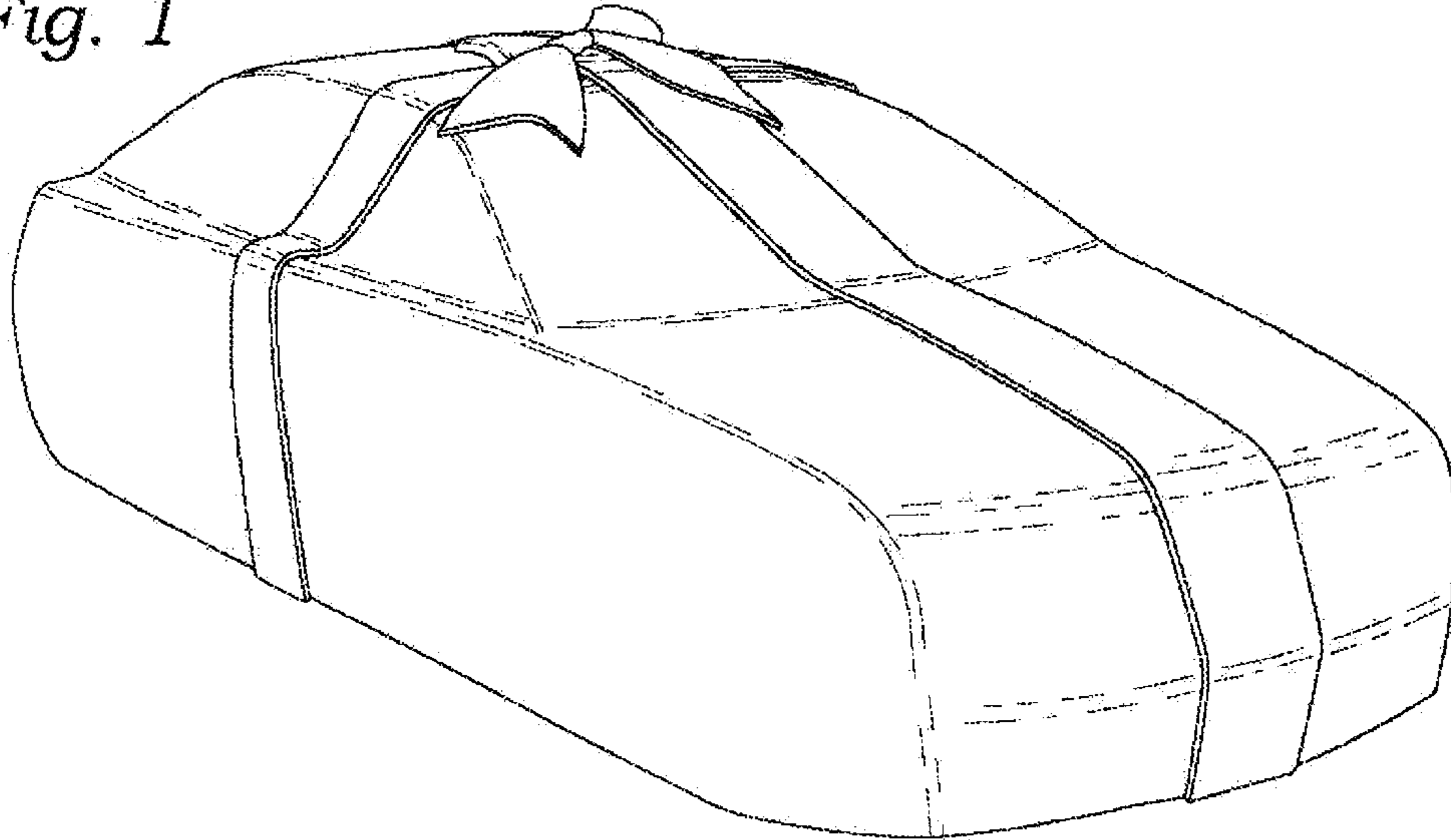

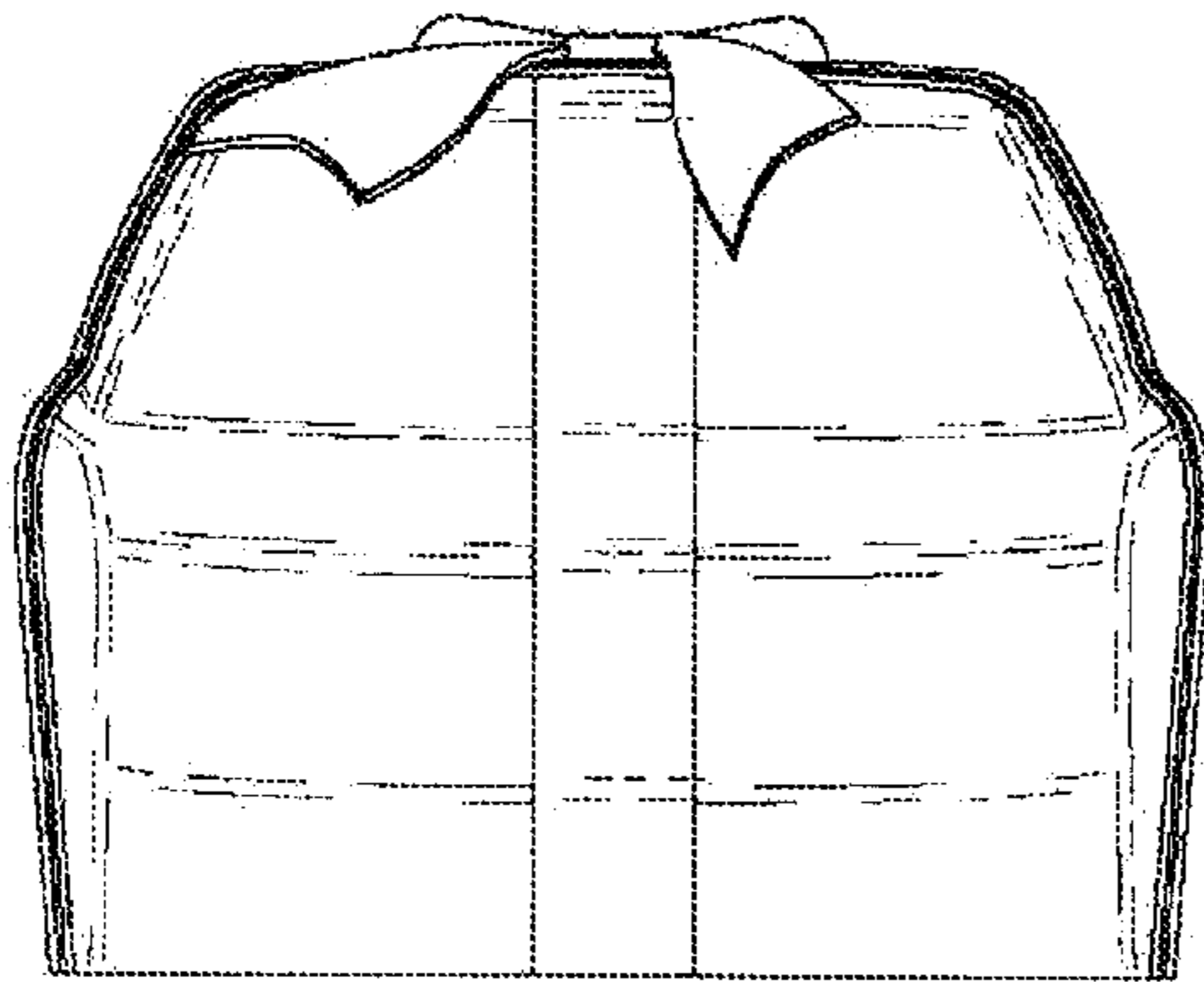
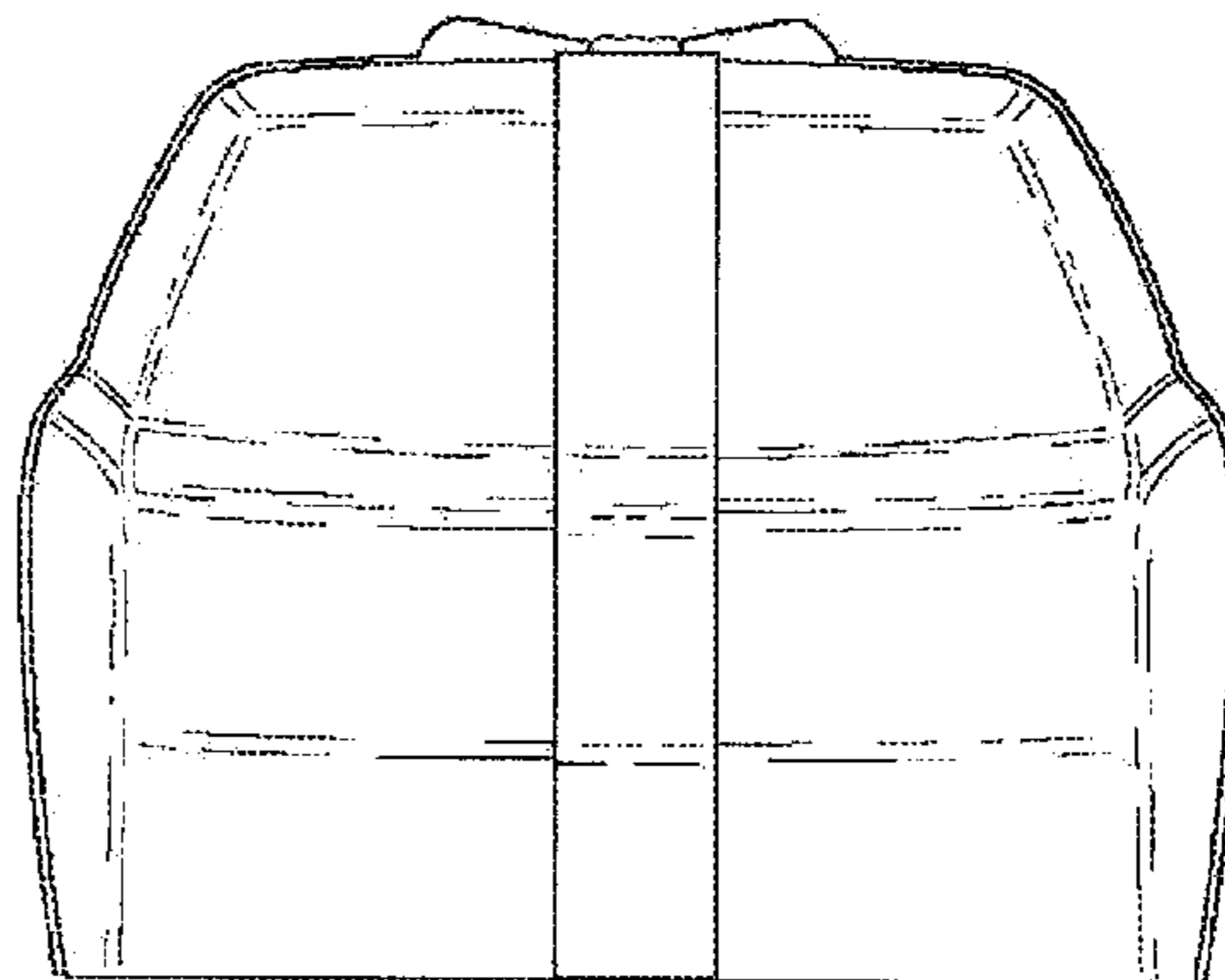

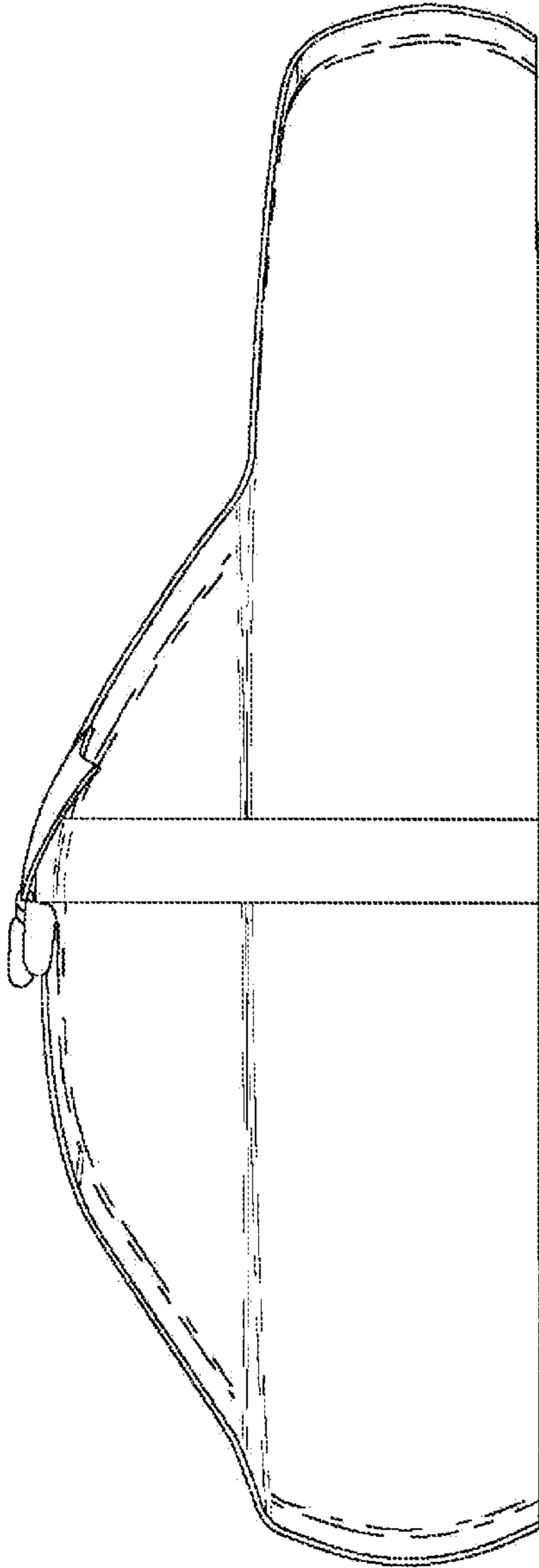

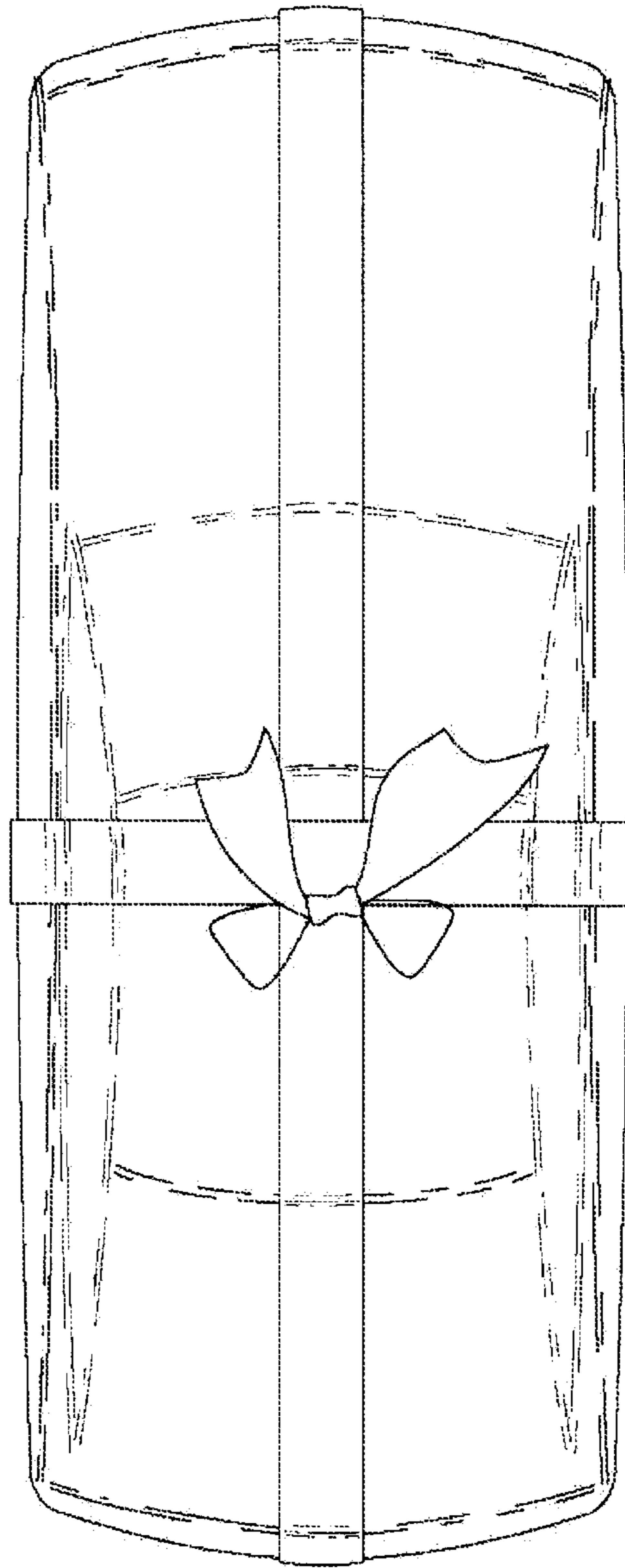
