(57) **CLAIM**

The ornamental design for a tire sidewall, as shown and described.

DESCRIPTION

The sole FIGURE is a side elevational view of a tire sidewall showing our new design. In the drawings, the broken lines defining the tire tread, inner bead, oval in the left side portion of the sidewall design and the peripheral boundary between the tire tread and the sidewall are for illustrative purposes only and forms no part of the claimed design.
