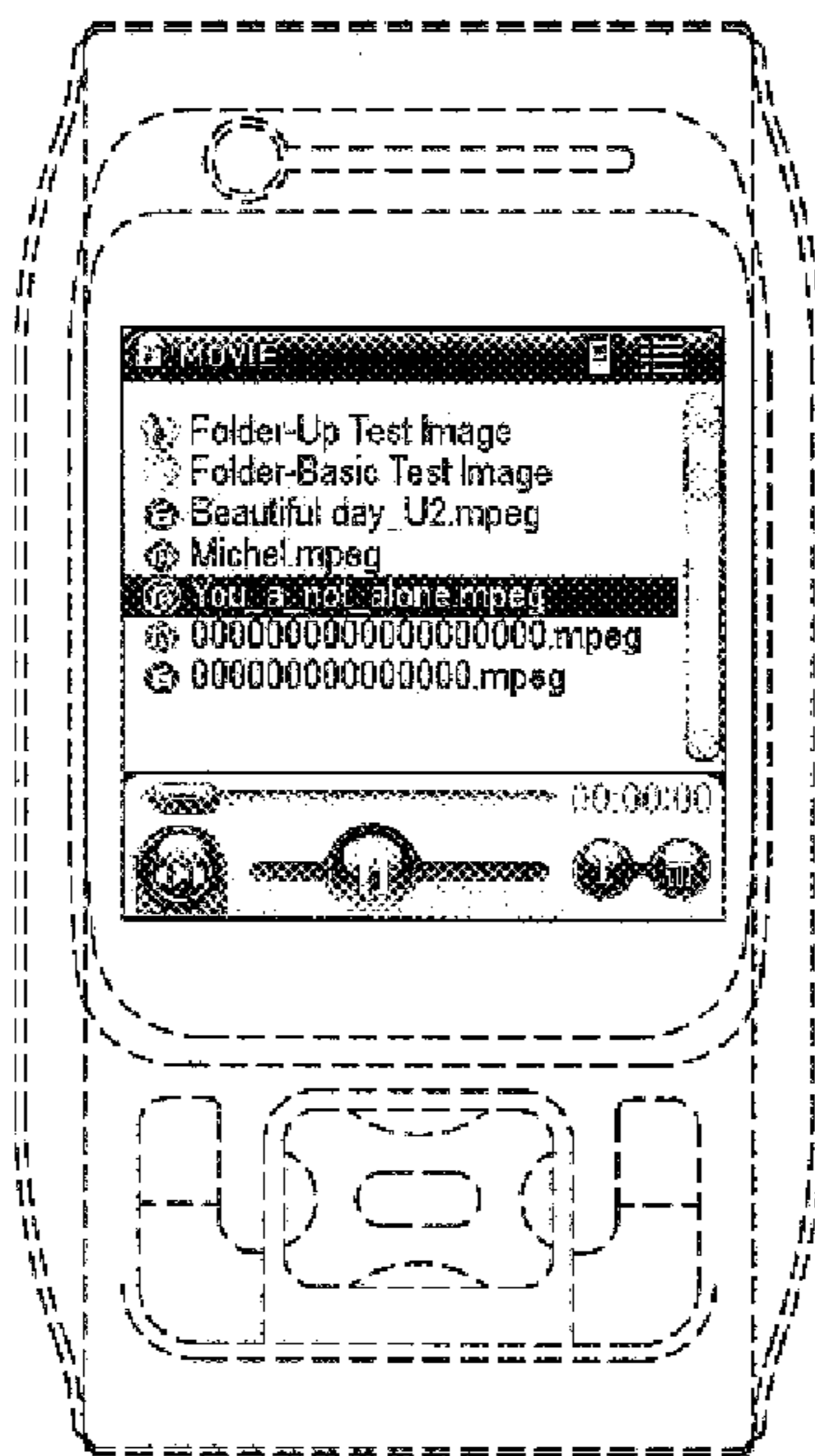
FIG. 1. is a top front perspective view of an indicating image for display on a portable telephone showing our new design; and,

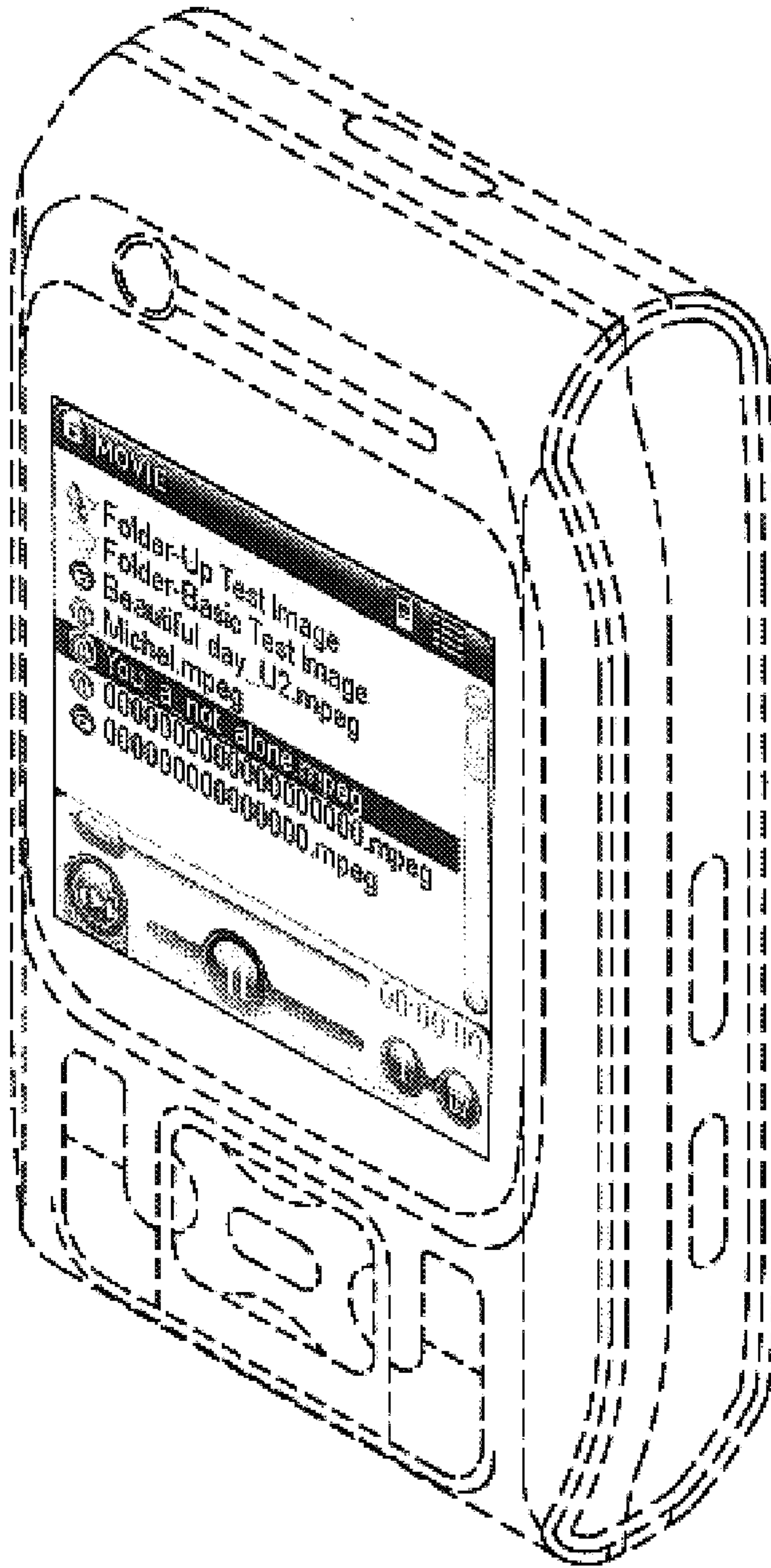

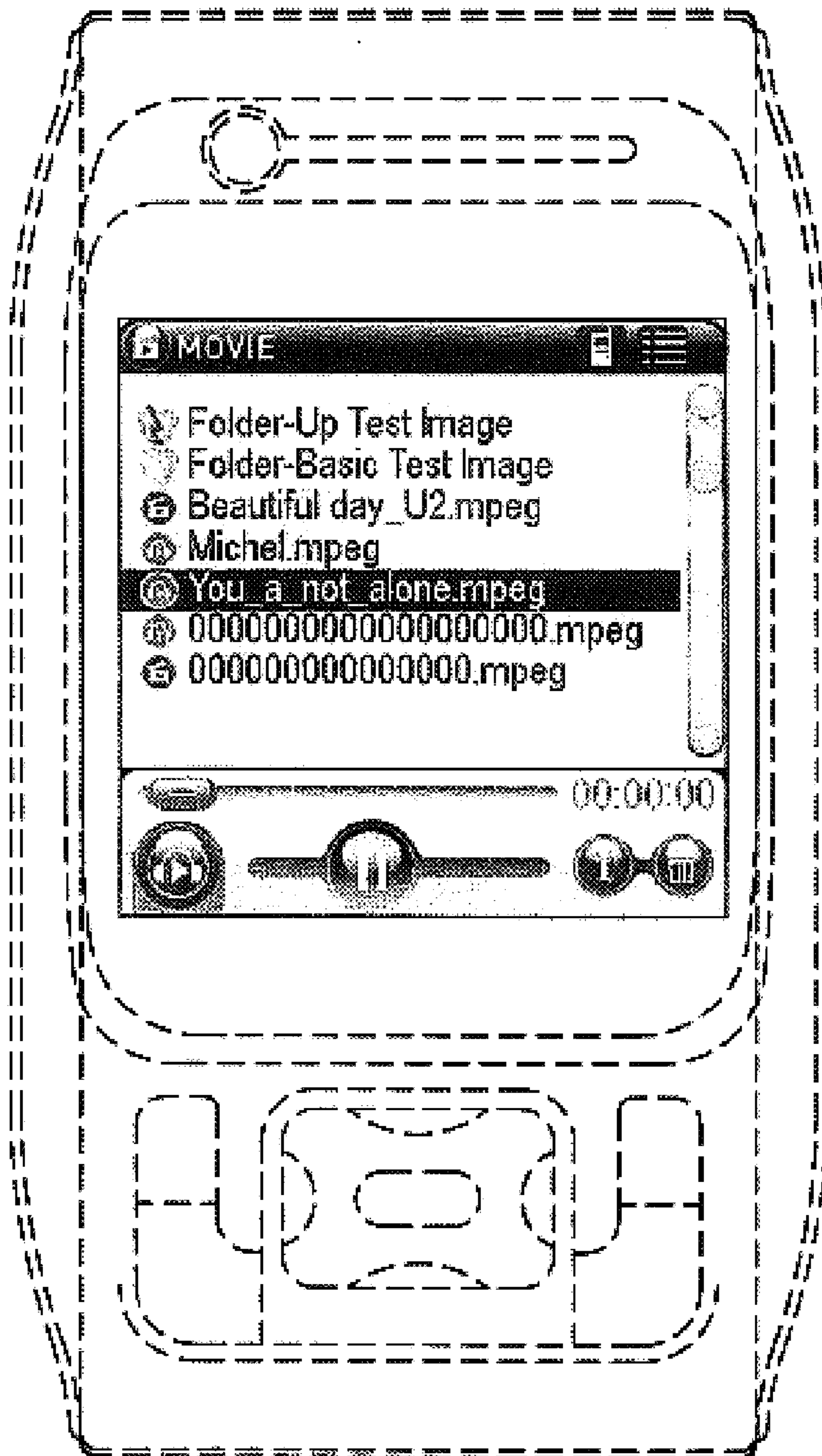
