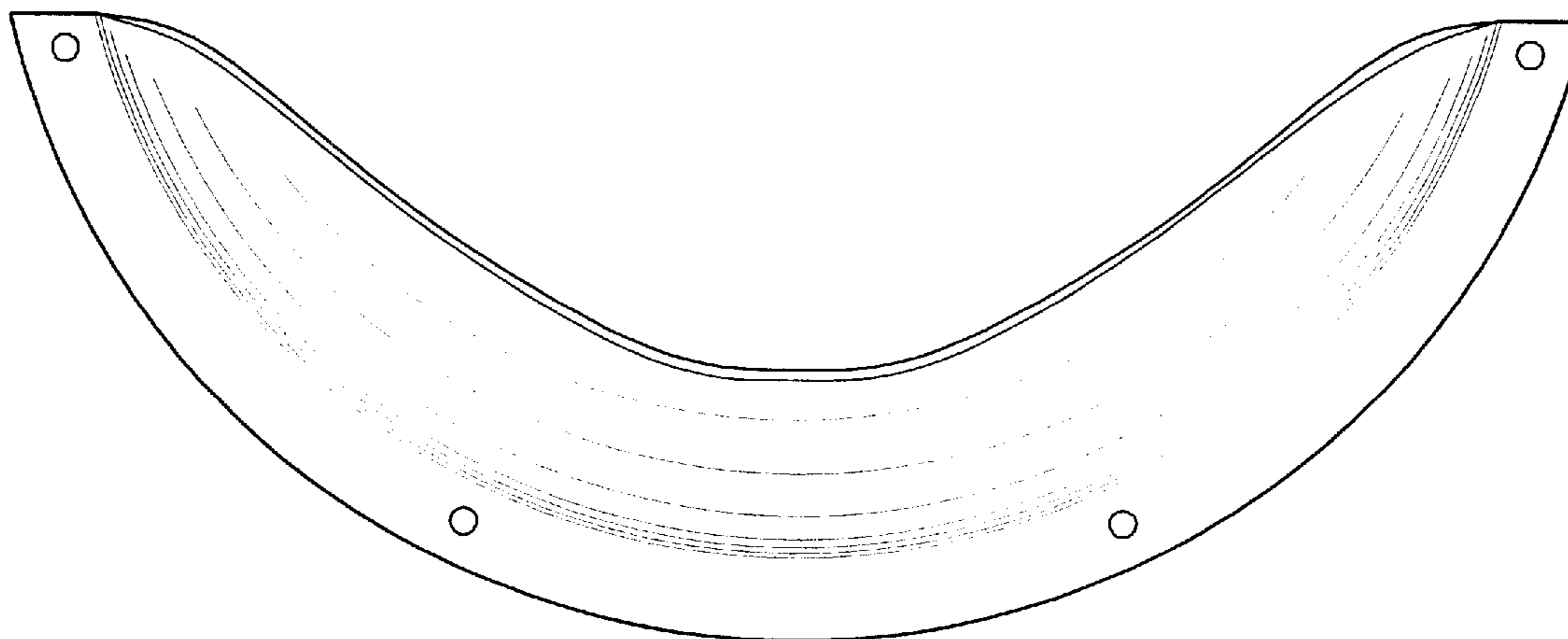
(57) **CLAIM**

The ornamental design for a toilet seat urine shield, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a toilet seat urine shield showing our new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof; and,
FIG. 6 is a perspective view thereof.
The broken line showing of portion of a toilet bowl, tank and seat is for illustrative purposes only and forms no part of the claimed design.

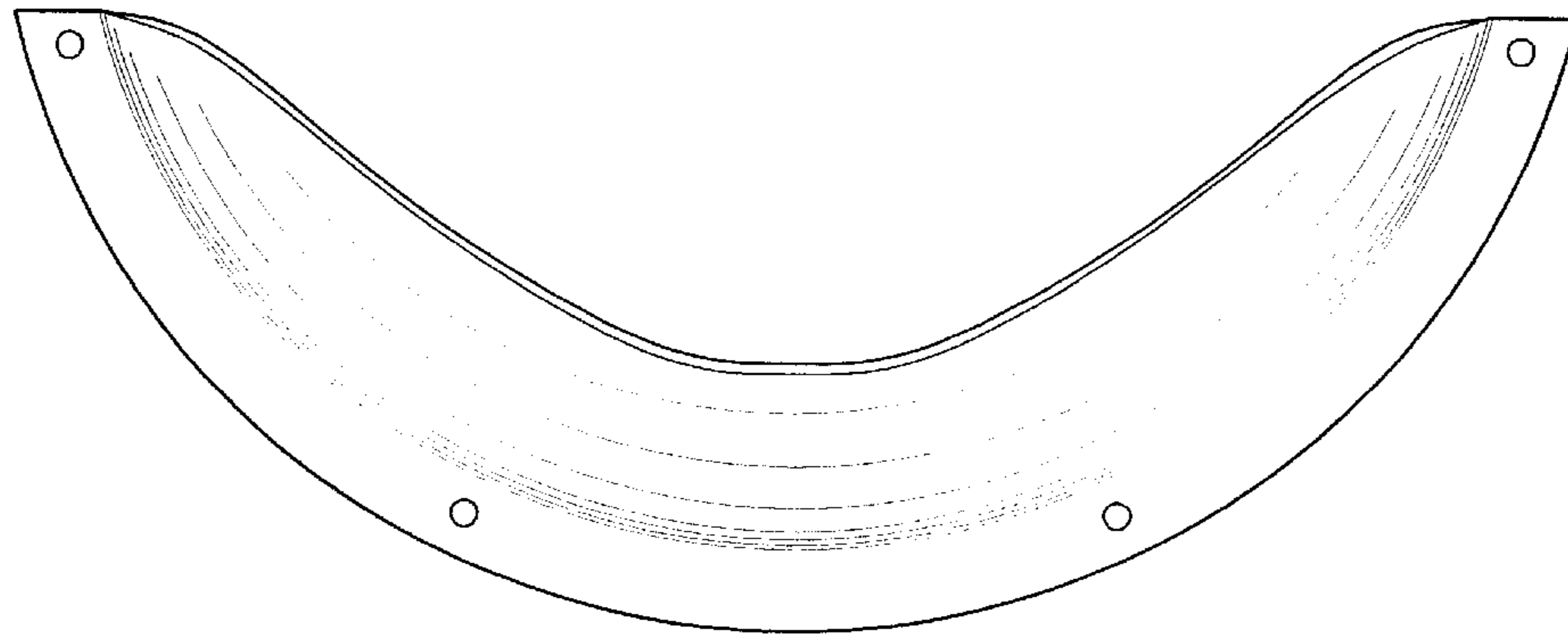

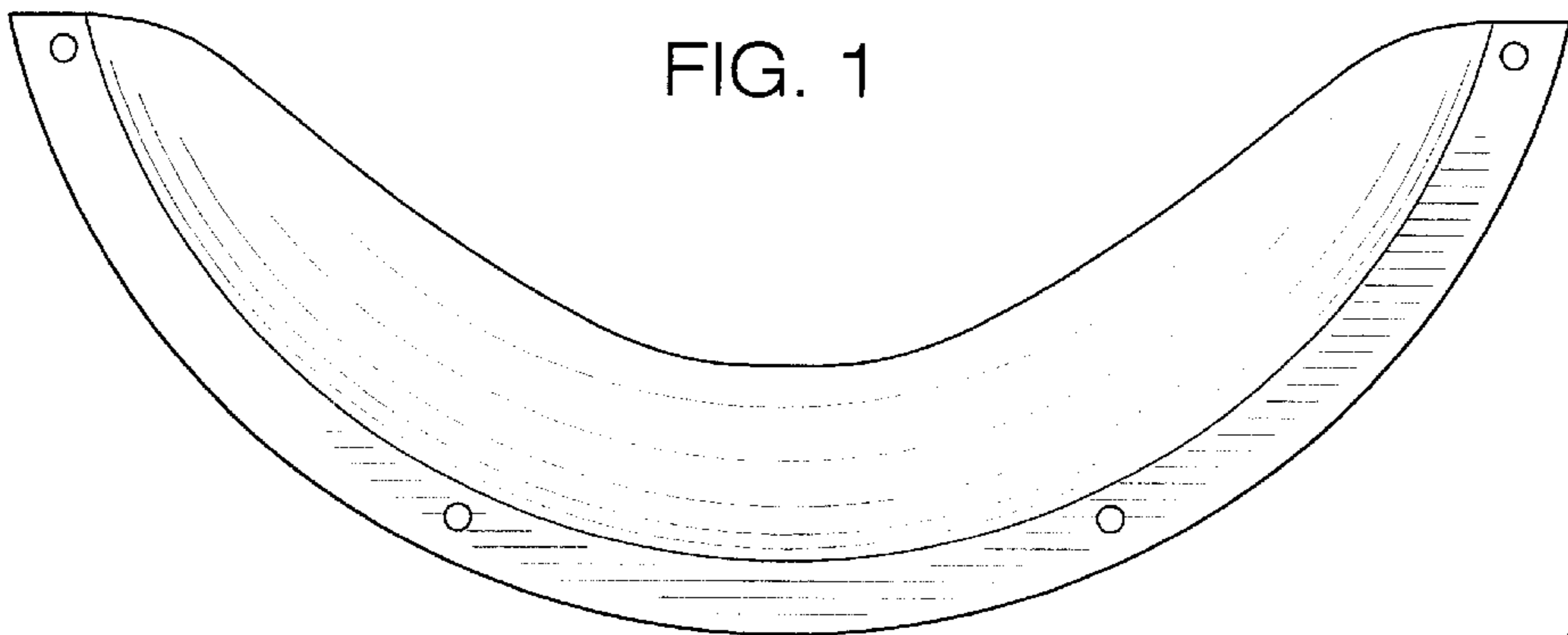

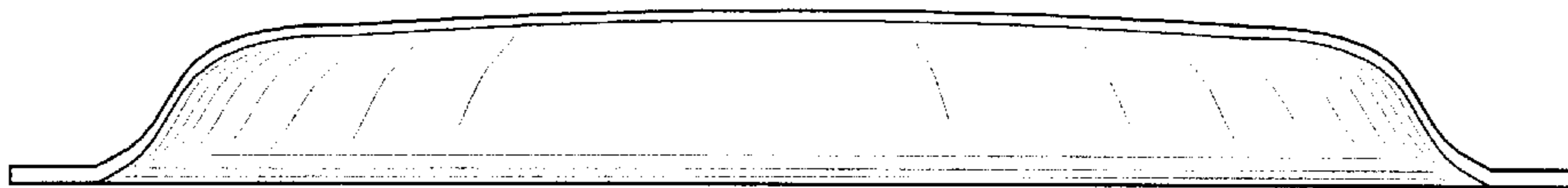
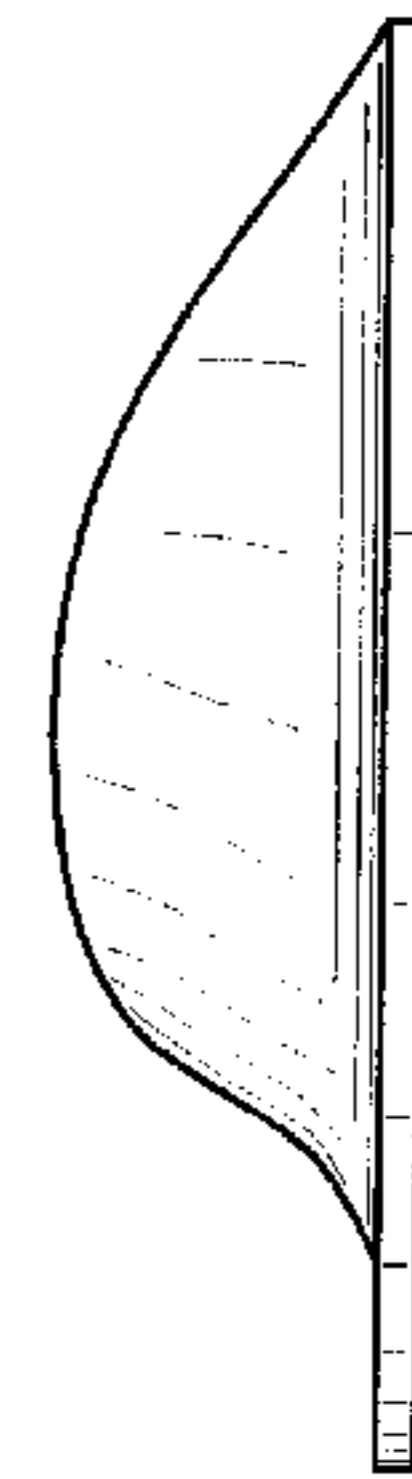

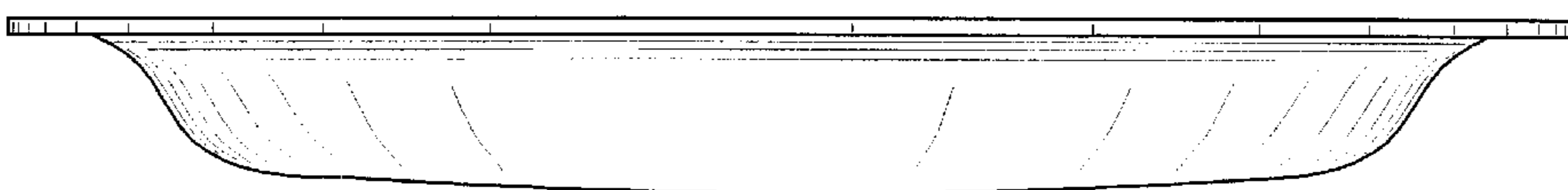
