(57) **CLAIM**

The ornamental design for a door and wall system for changing facilities, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a door and wall system according to this invention;

FIG. 2 is a front view of the door and wall system as shown in FIG. 1 according to this invention;

FIG. 3 is plan view of the door and wall system as shown in FIG. 1 according to this invention;

FIG. 4 is a rear view of the door and wall system as shown in FIG. 1 according to this invention;

FIG. 5 is a bottom view of the door and wall system as shown in FIG. 1 according to this invention;

FIG. 6 is a left side view of the door and wall system as shown in FIG. 1 according to this invention; and,

FIG. 7 is a right side view of the door and wall system as shown in FIG. 1 according to this invention.

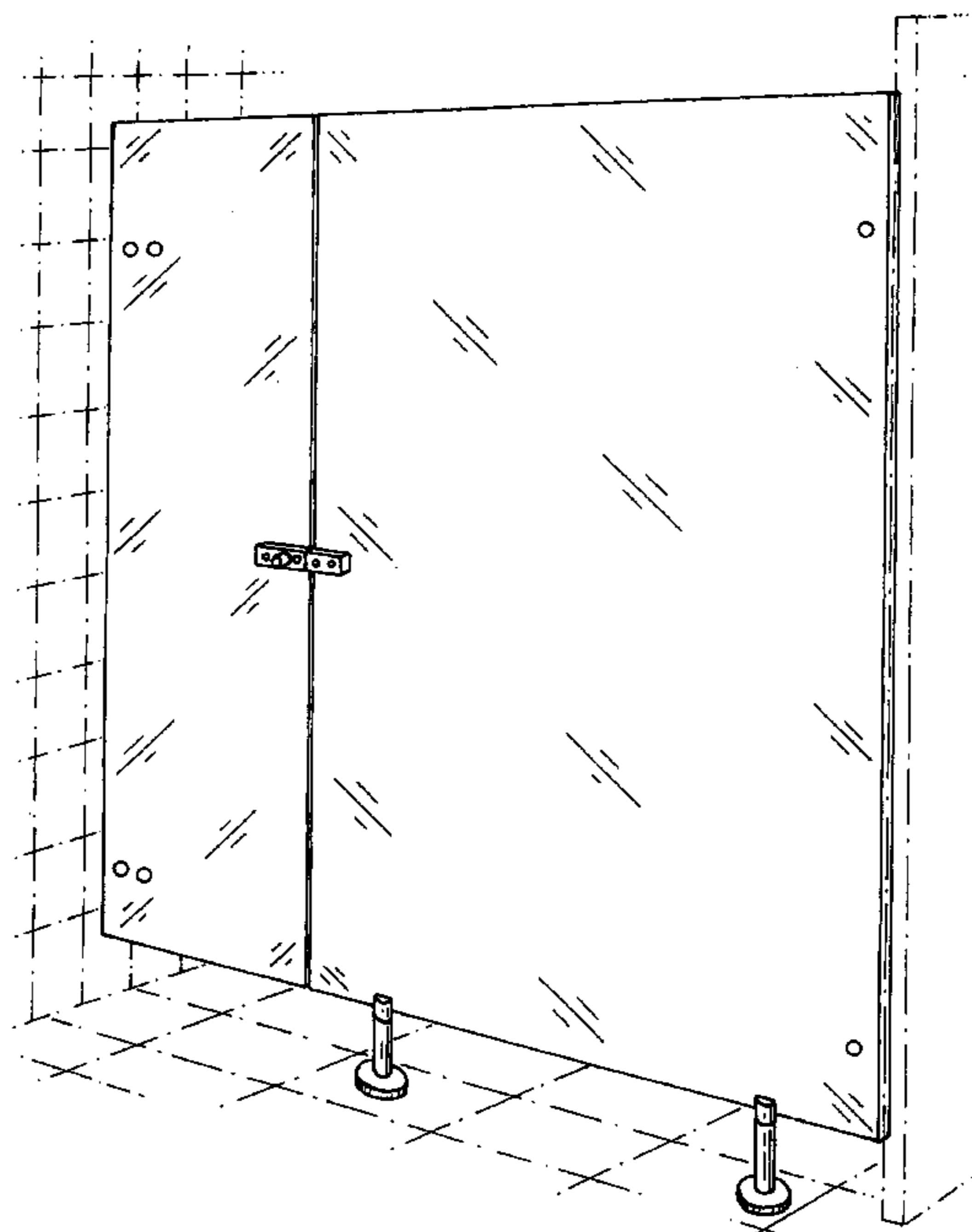

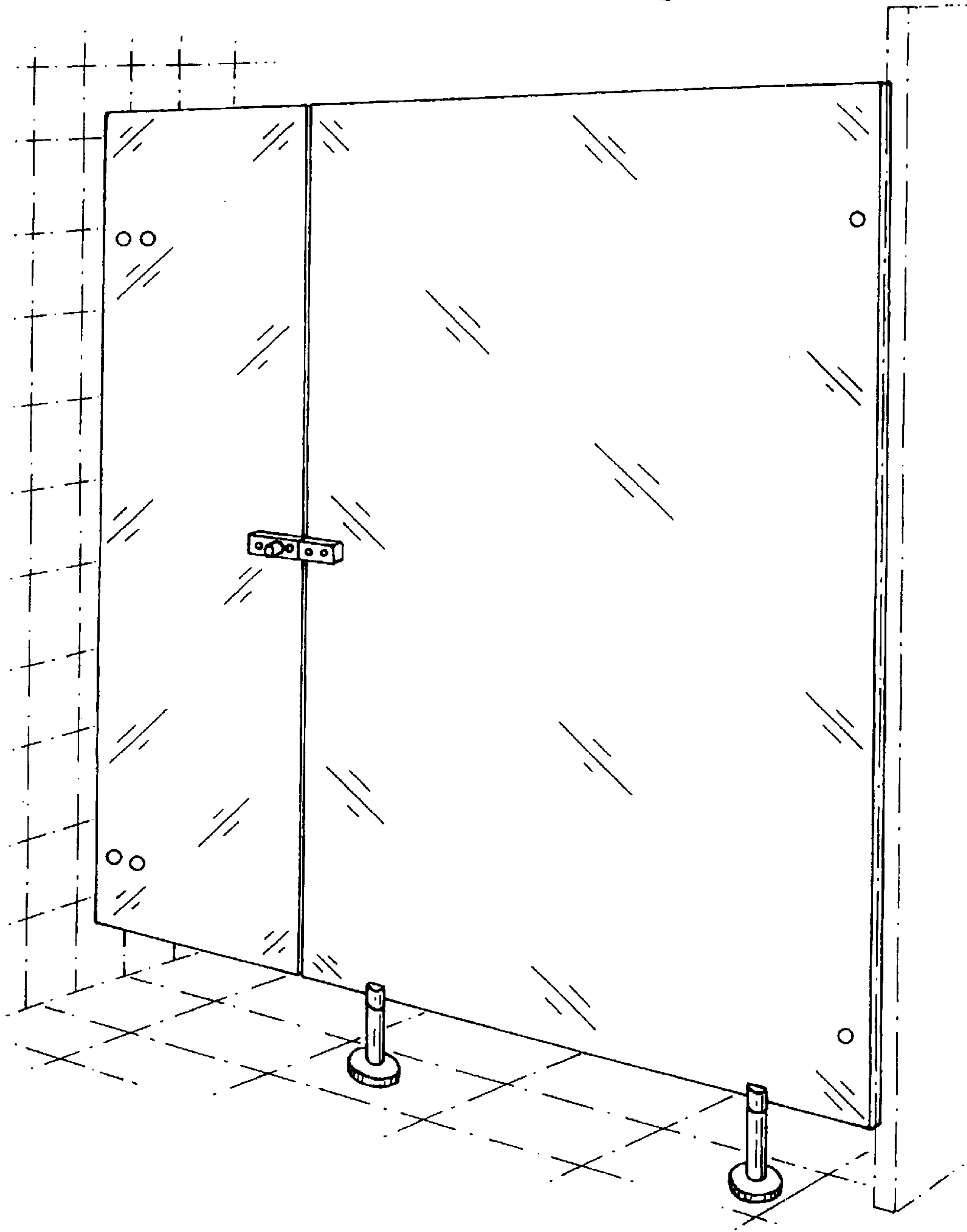

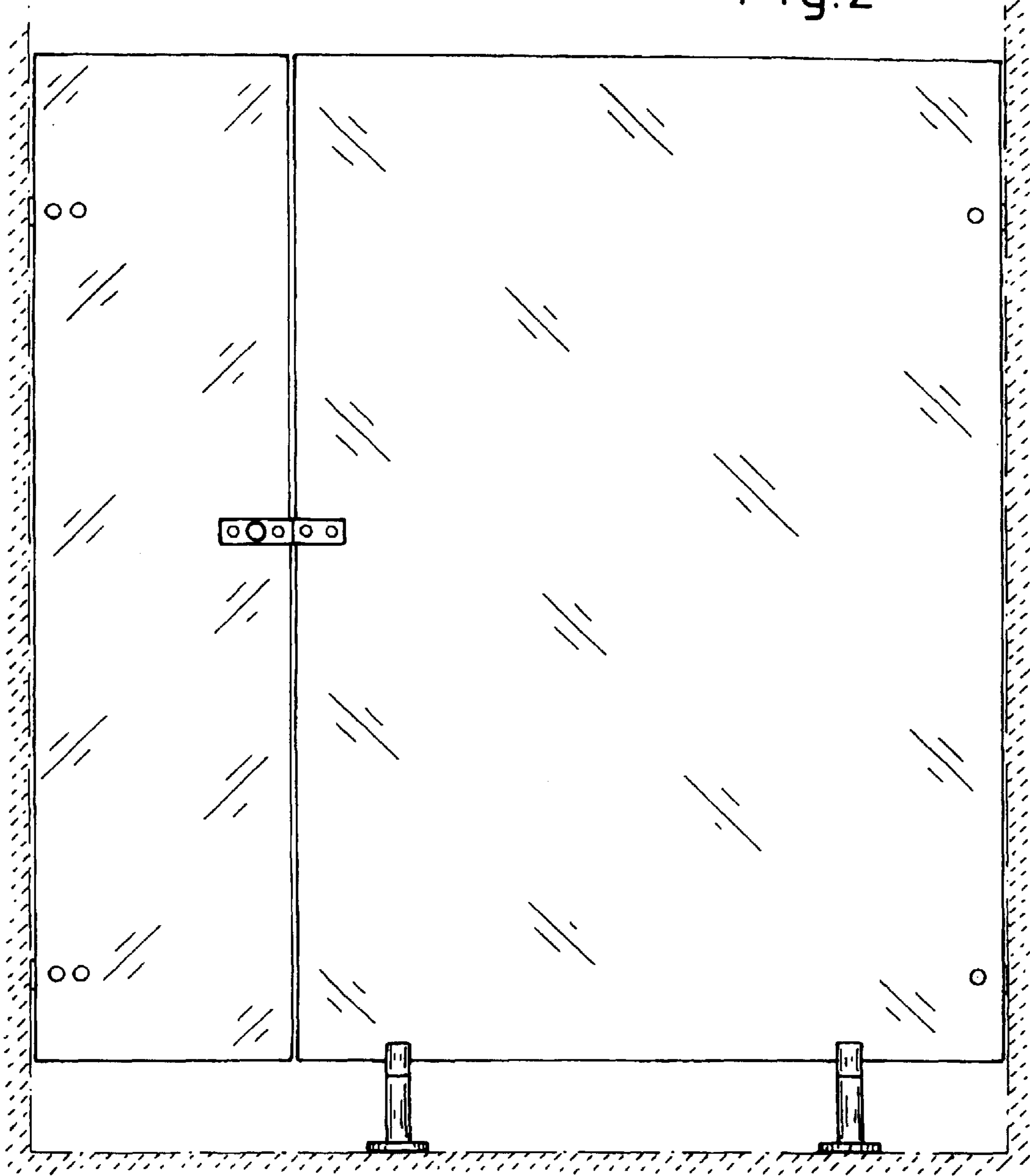

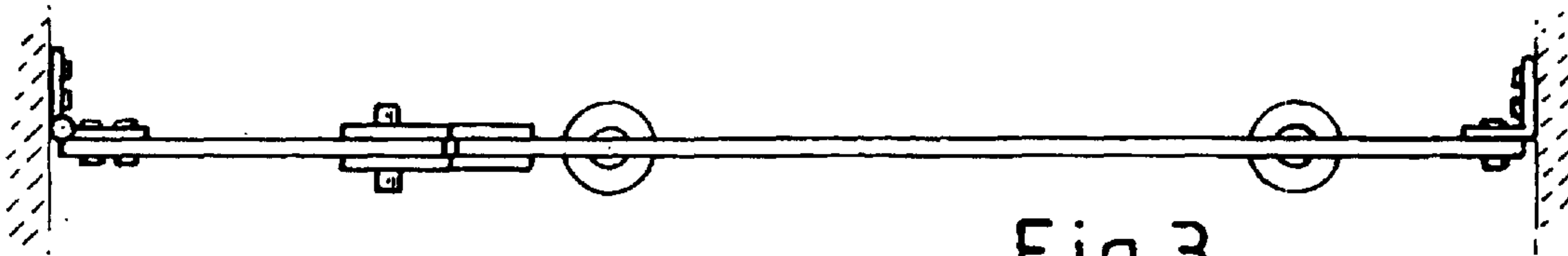

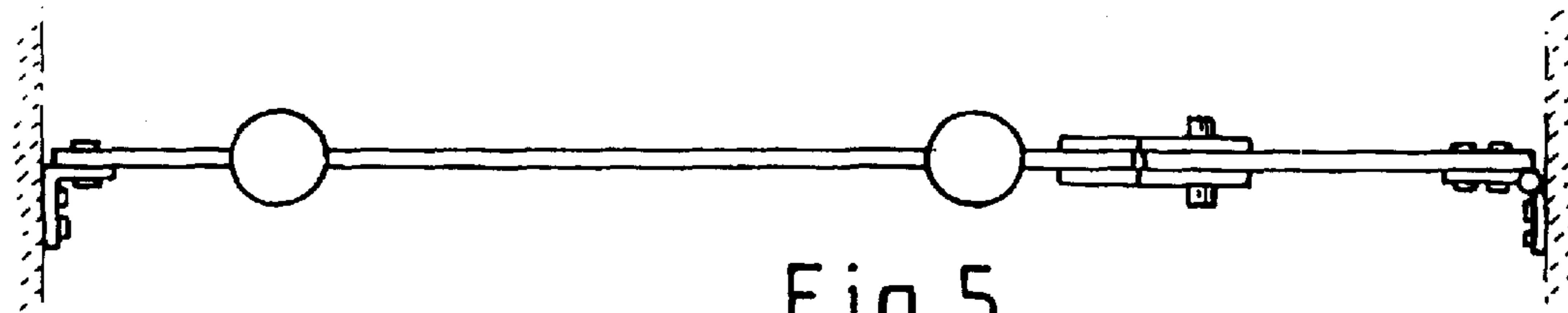
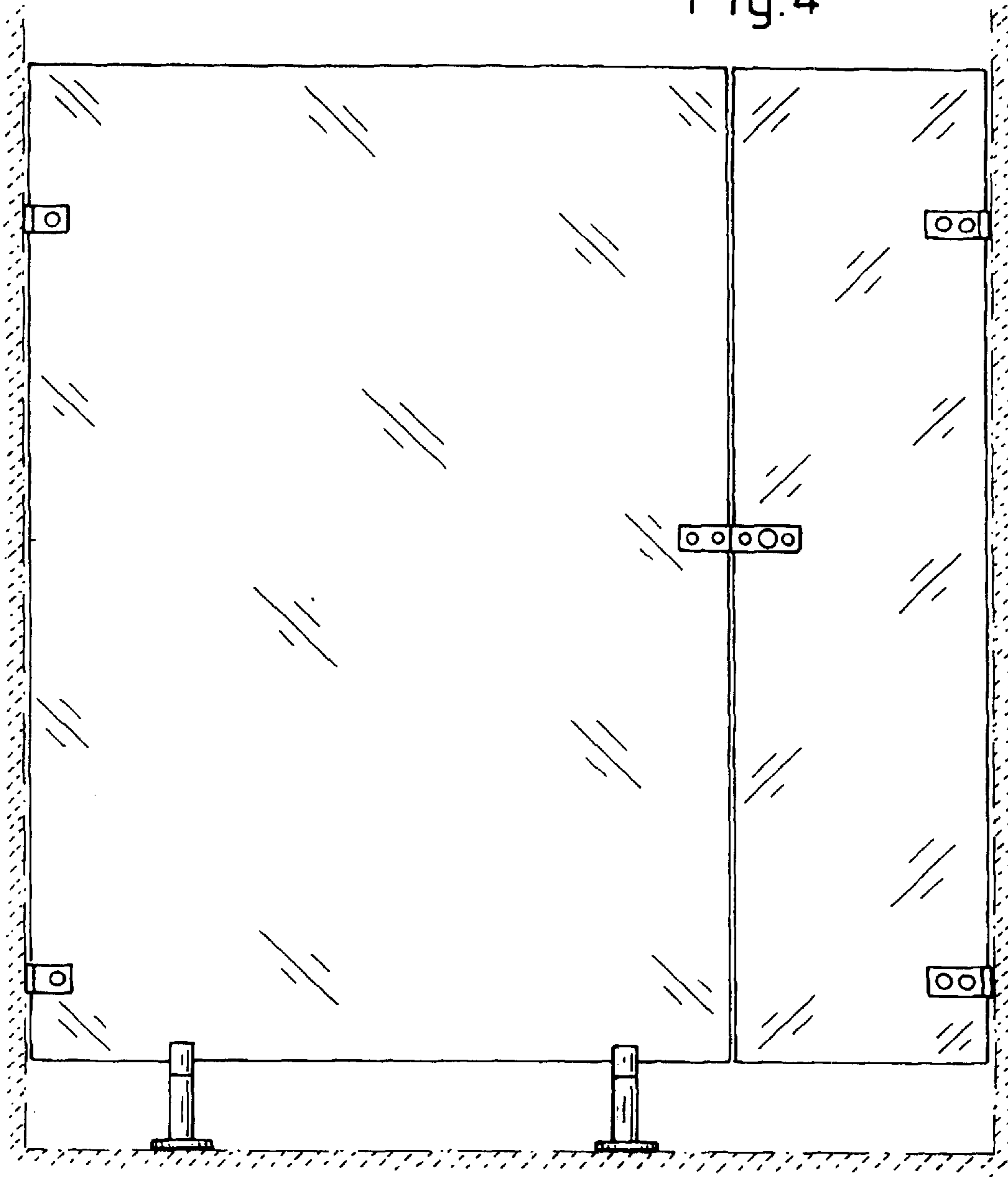

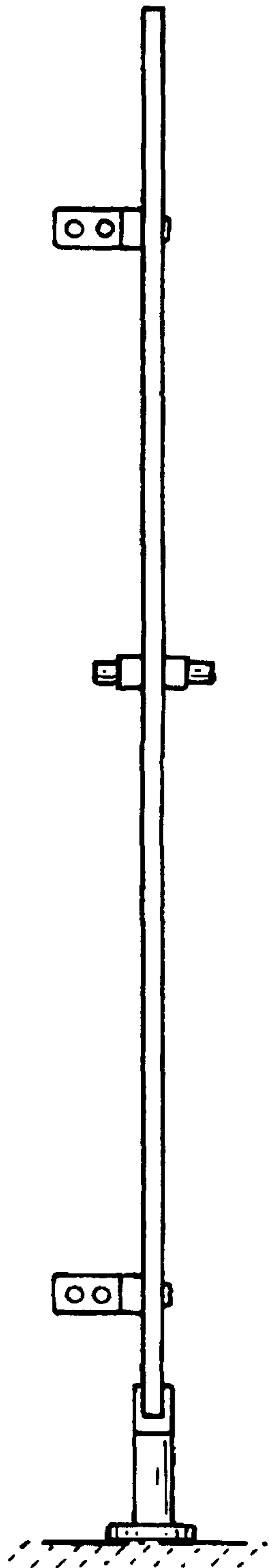
