The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a shoe upper showing a new design;

FIG. 2 is a top view of the shoe upper of FIG. 1;

FIG. 3 is a front view of the shoe upper of FIG. 1;

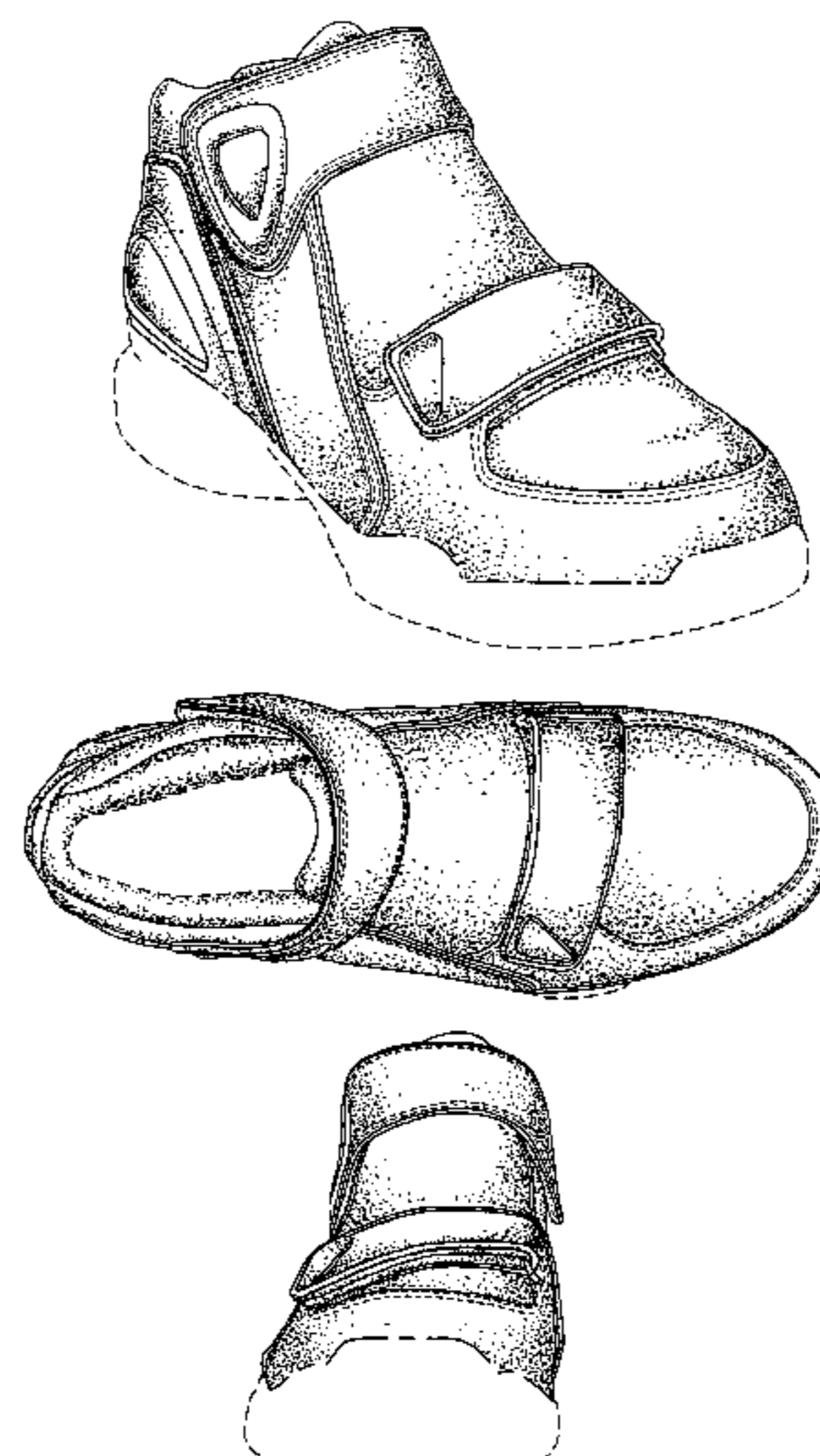
FIG. 4 is a rear view of the shoe upper of FIG. 1;

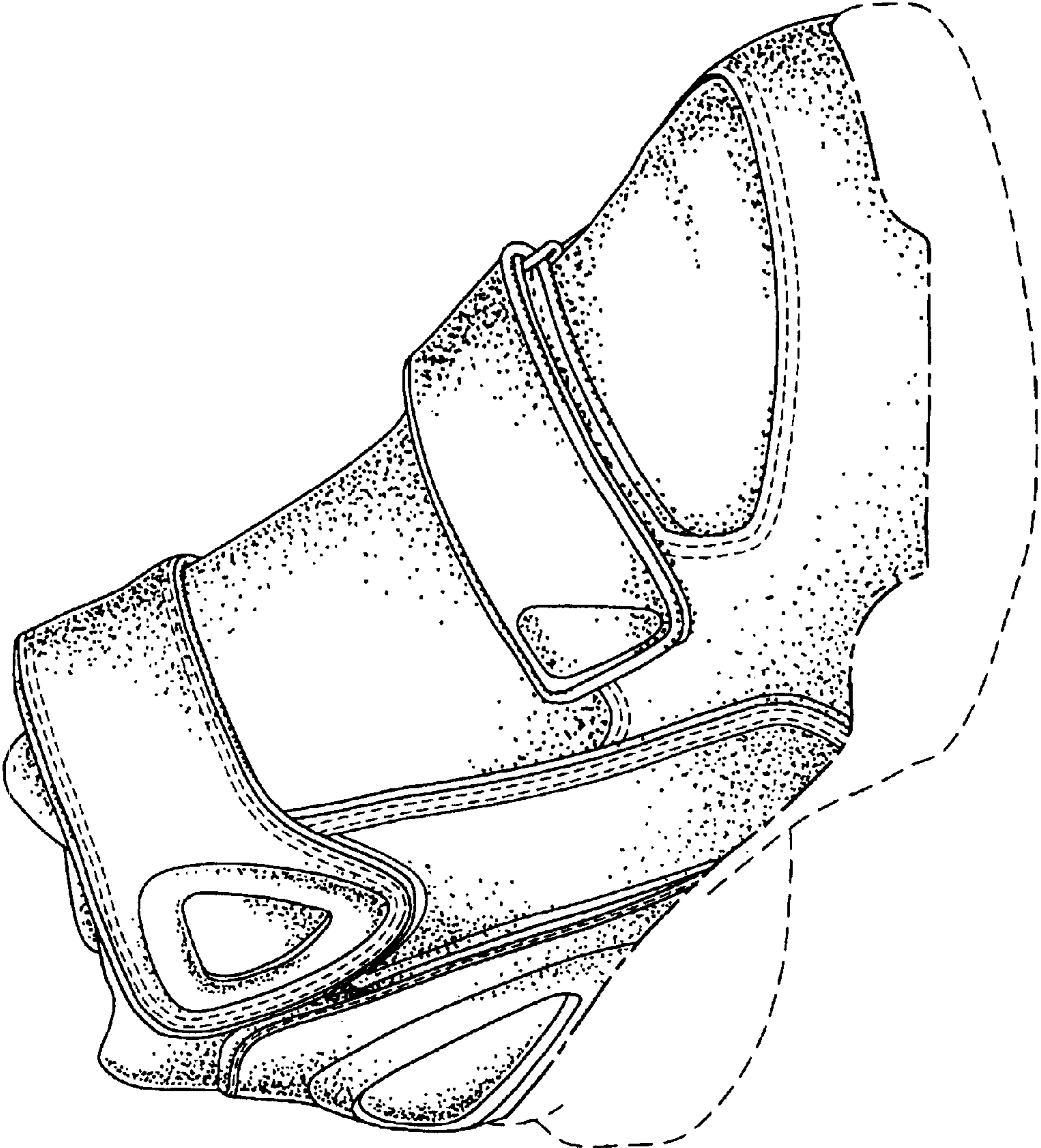

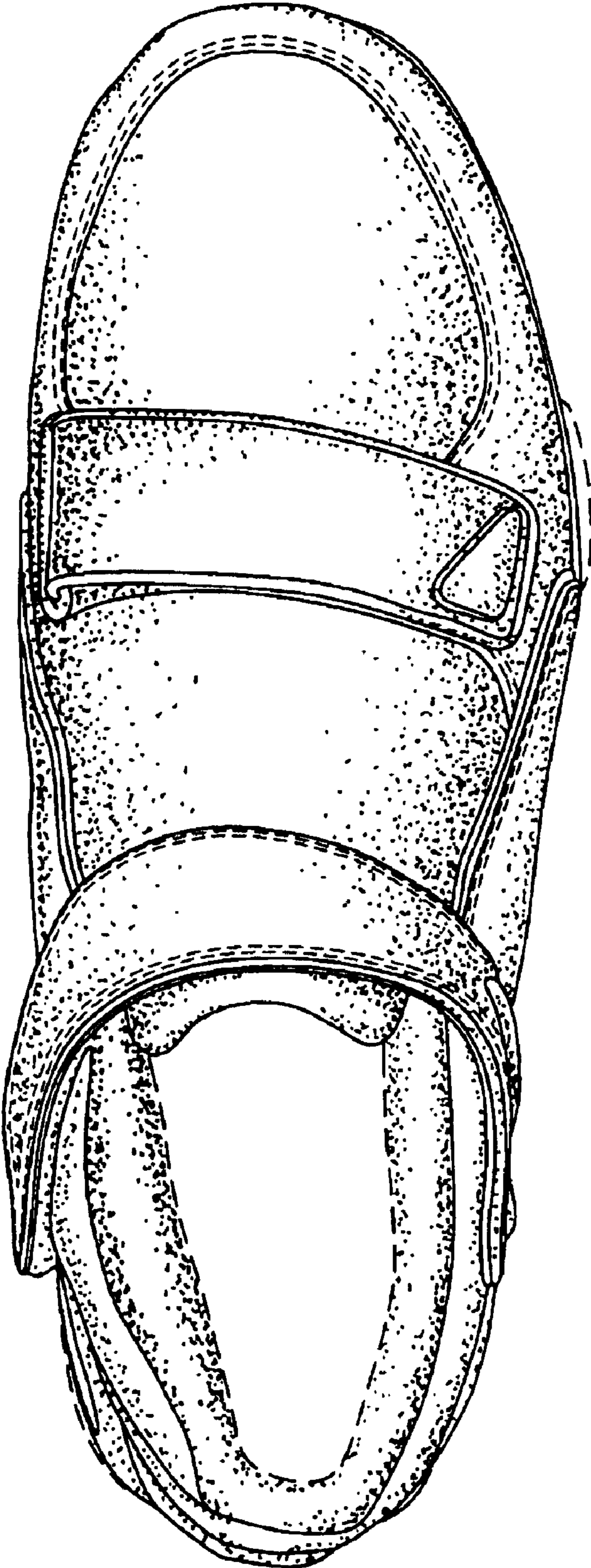

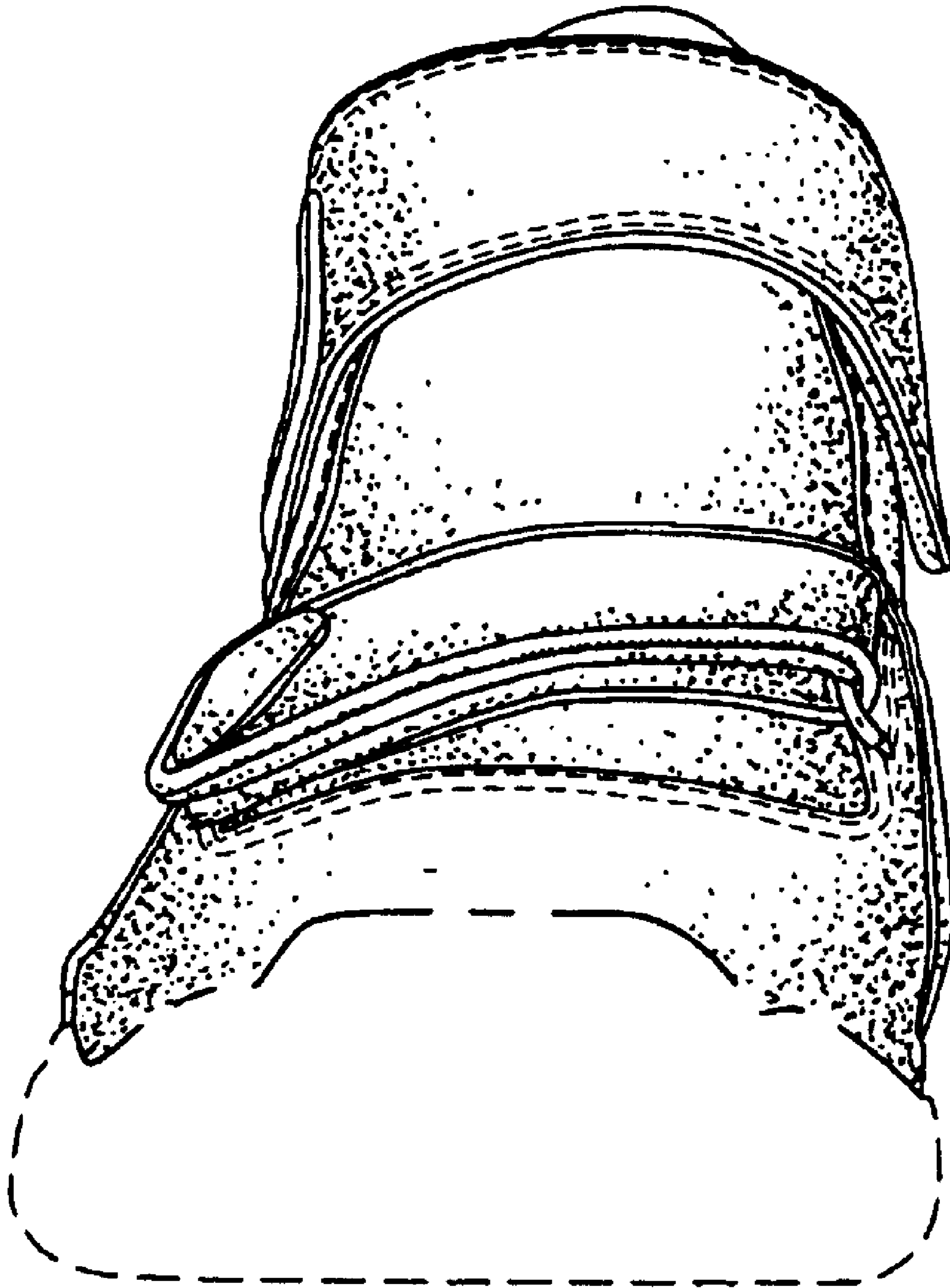

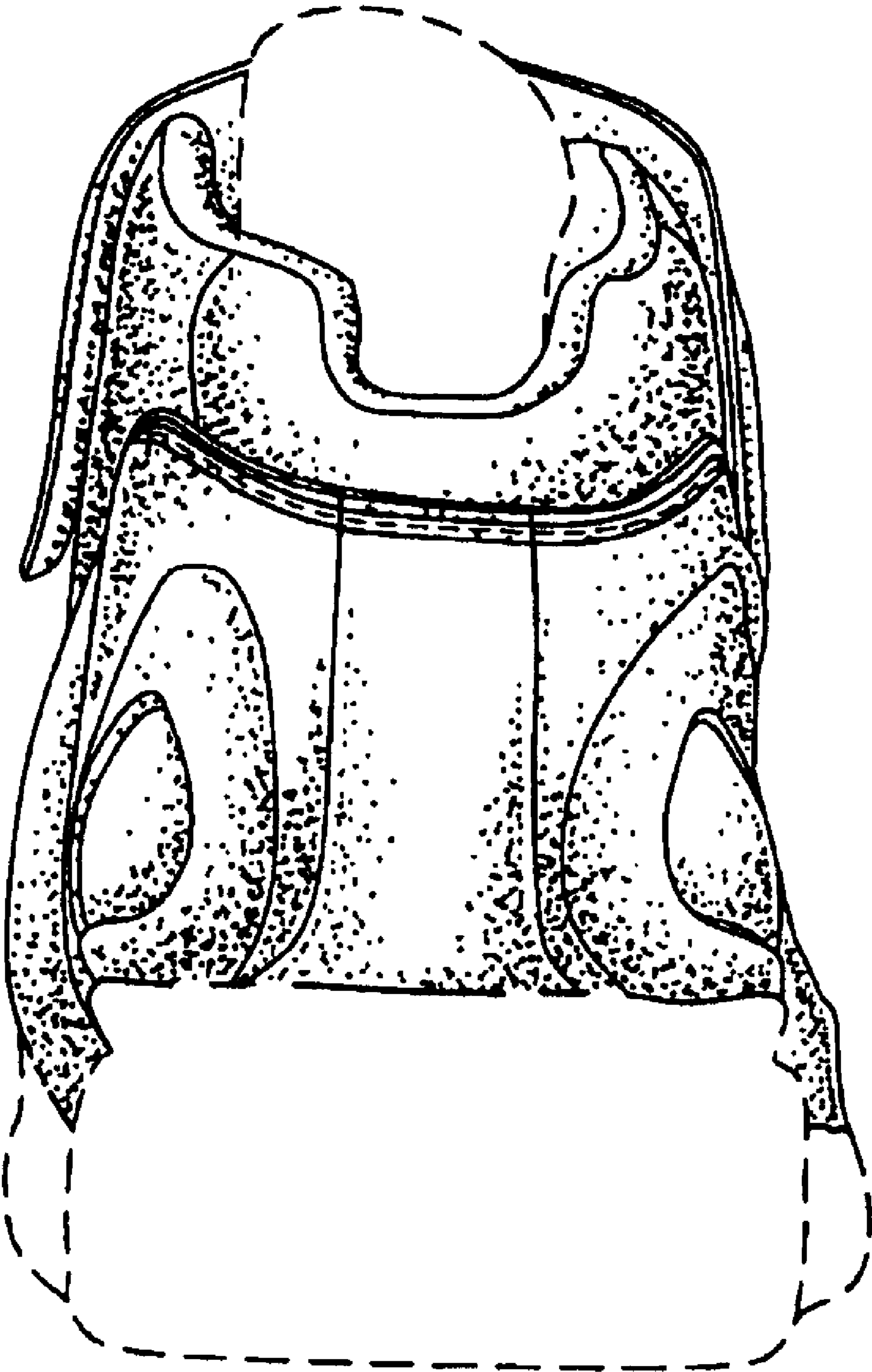

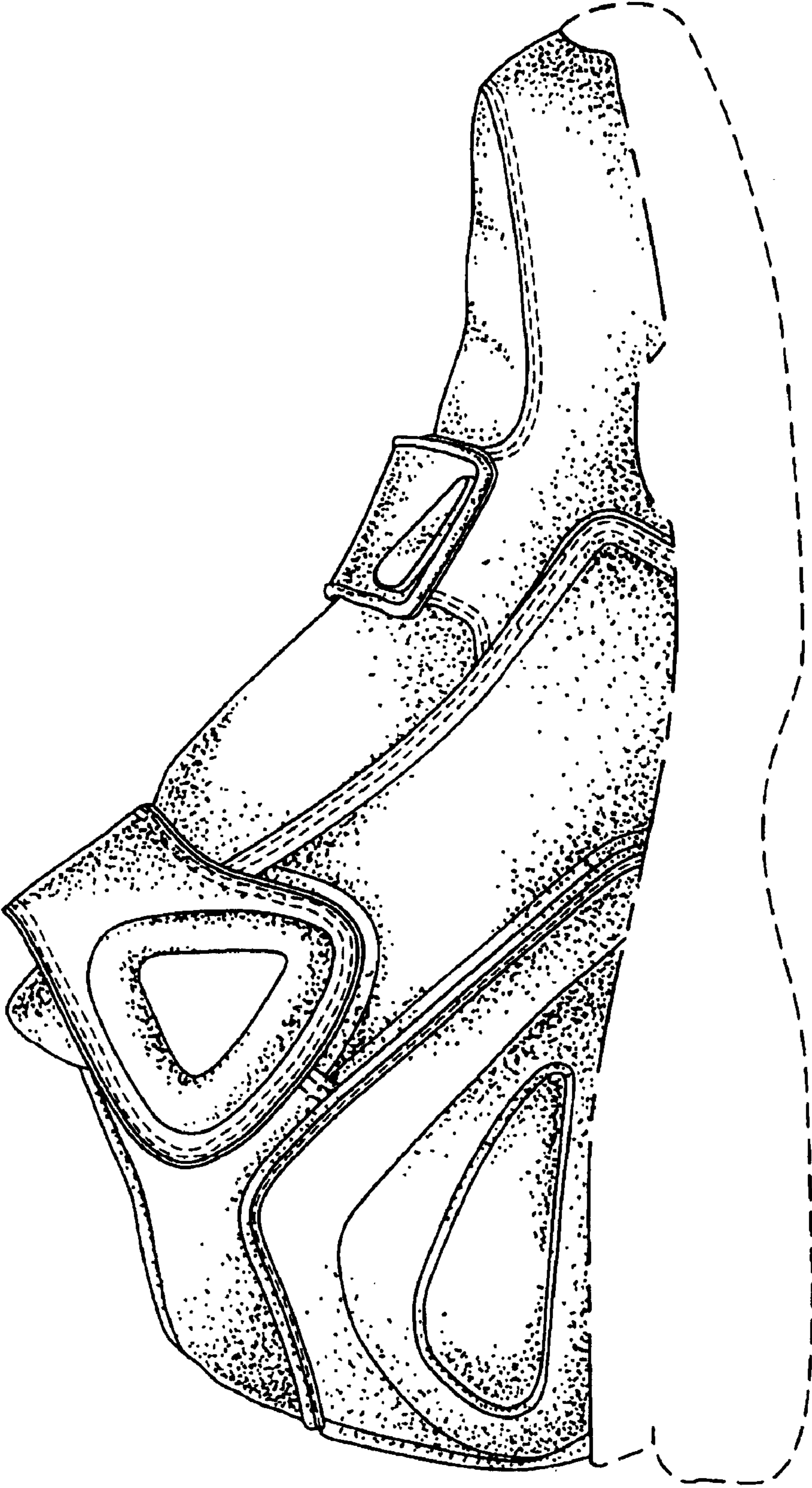

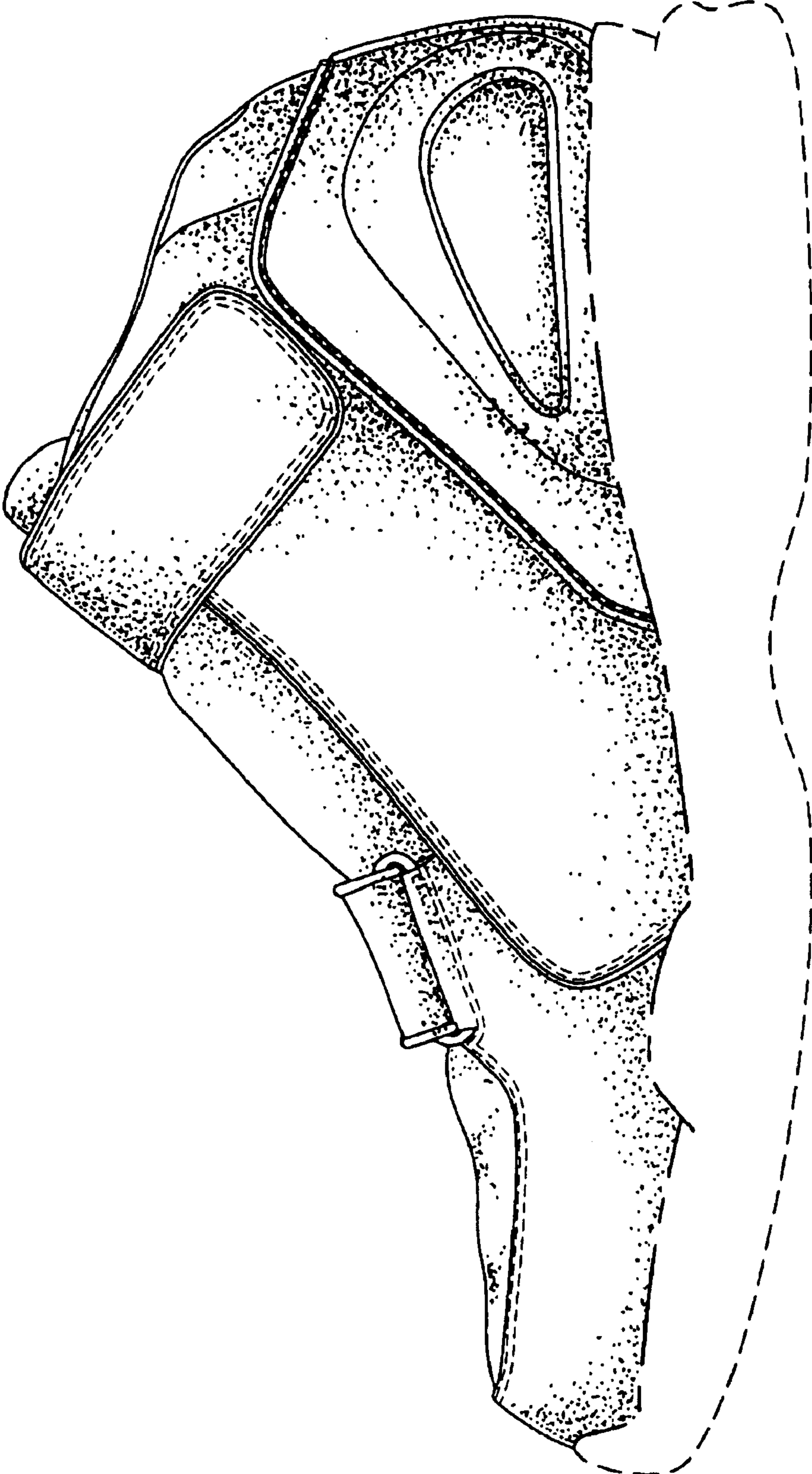
