FIG. 2 is a left side view of the shoe shown in FIG. 1;

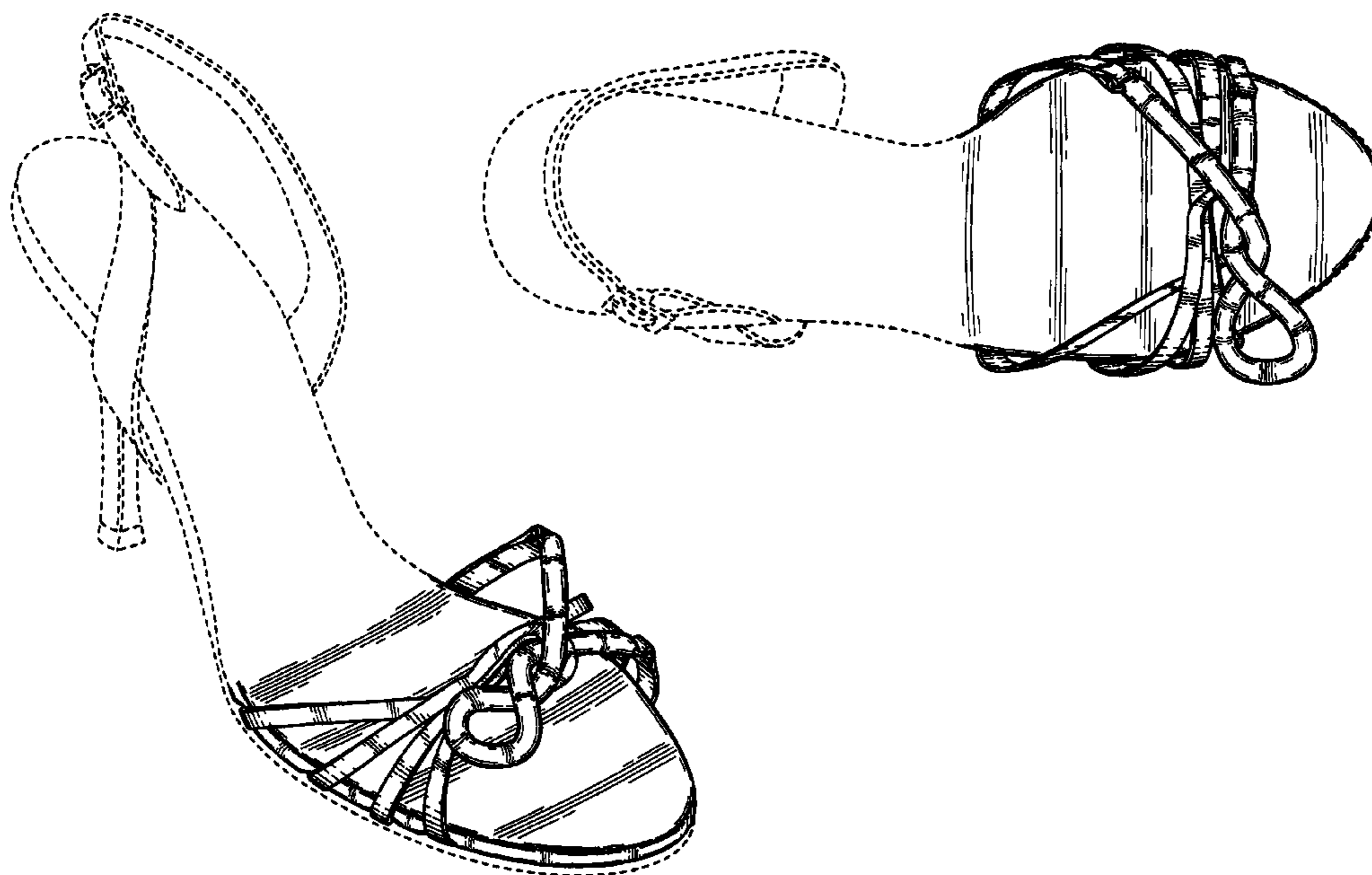
FIG. 3 is a right side view of the shoe shown in FIG. 1;

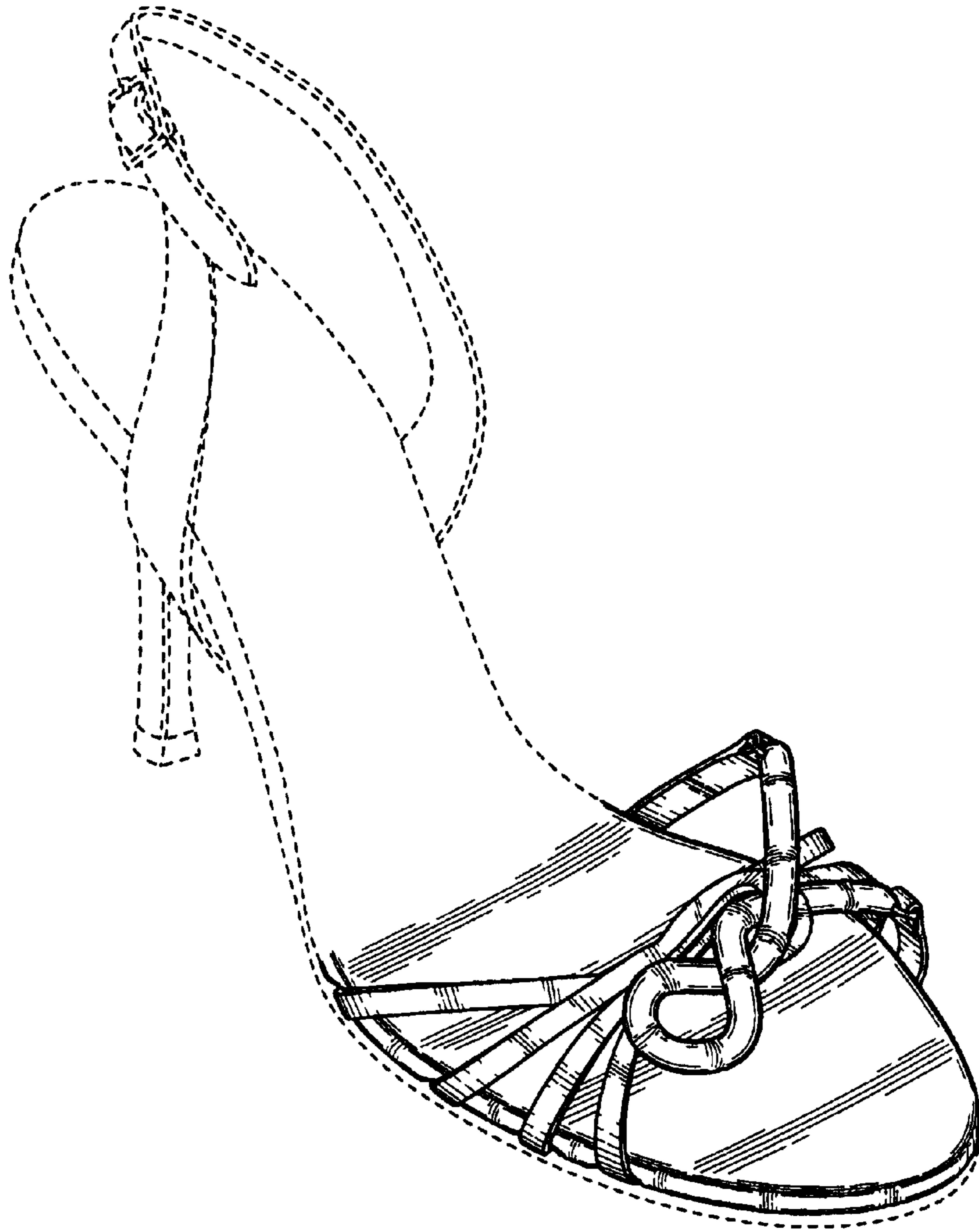

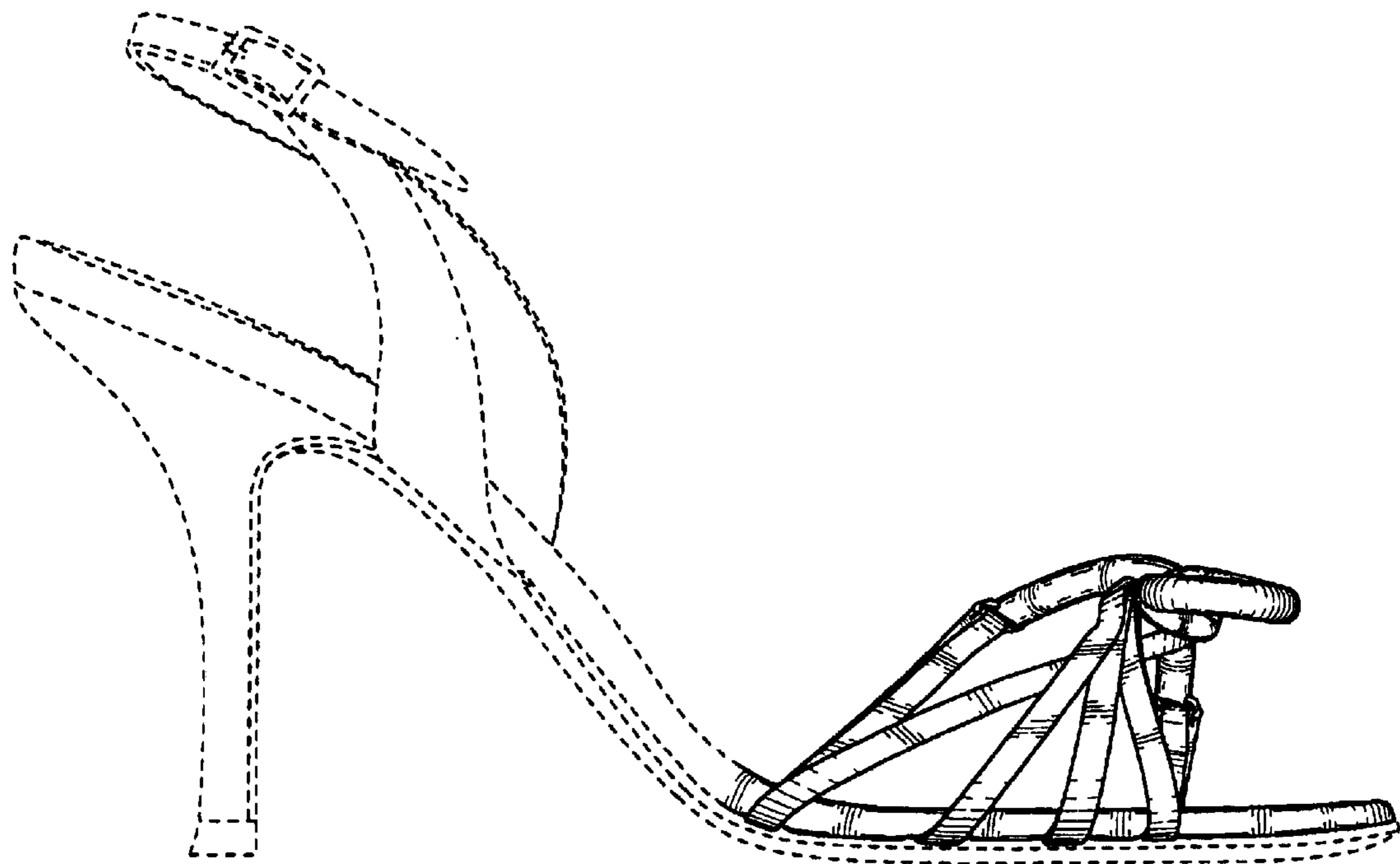

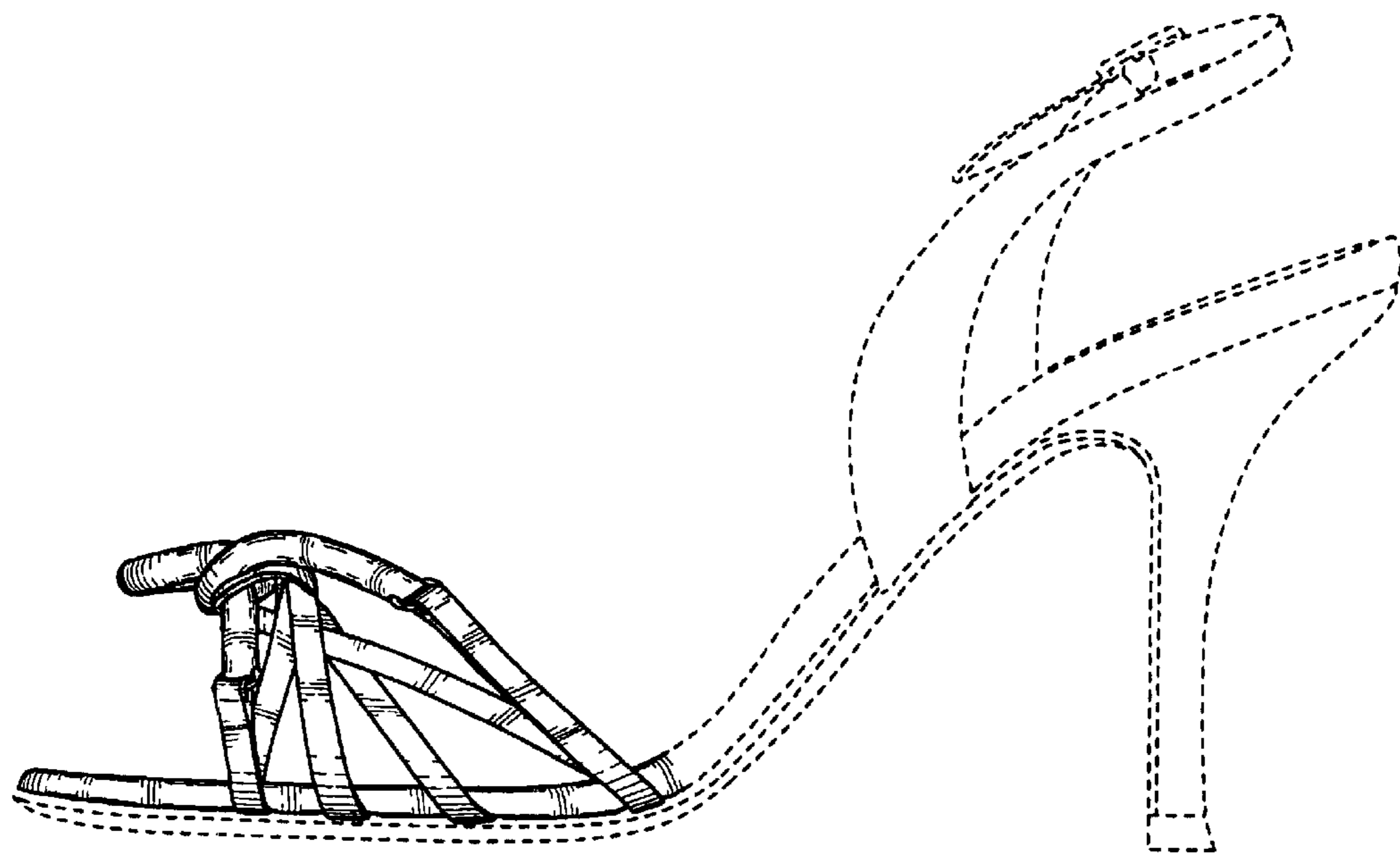

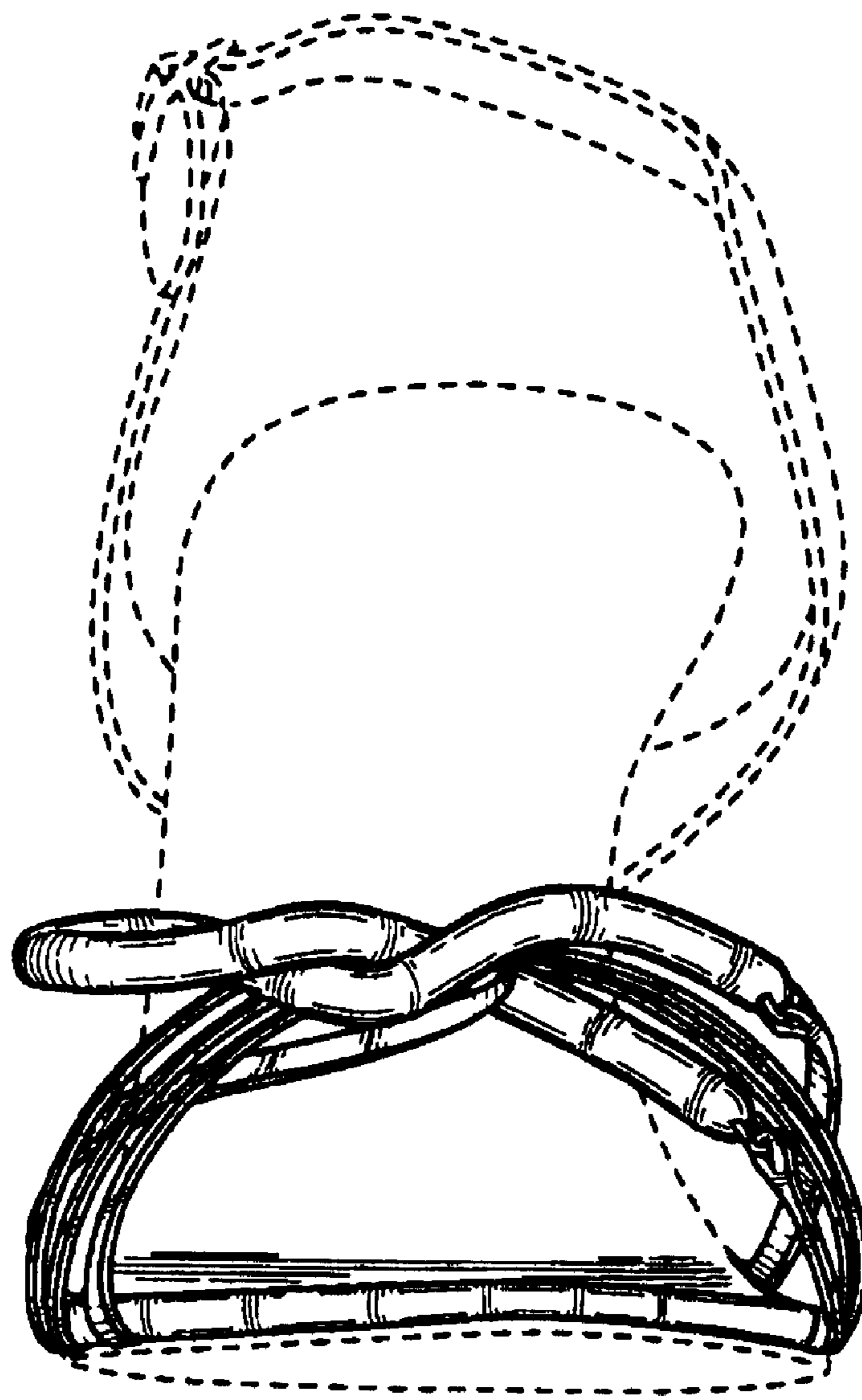

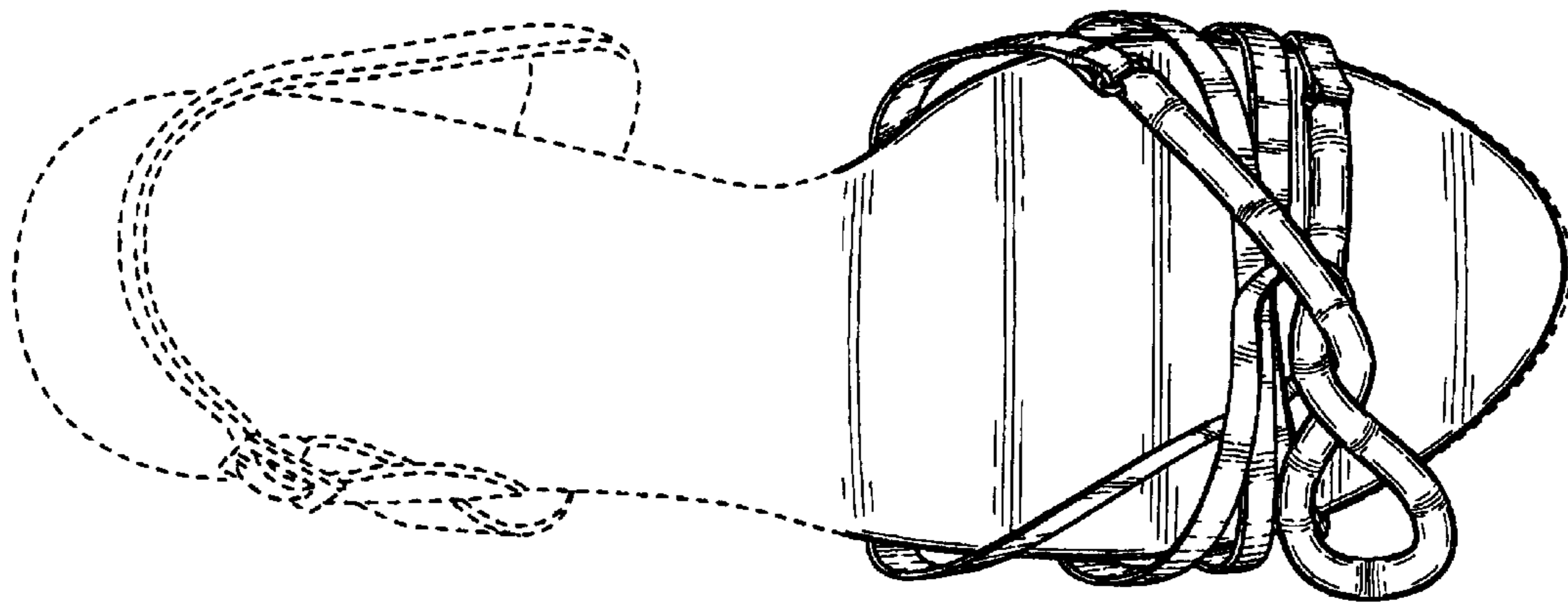
