(57) **CLAIM**

The ornamental design for a “cleaning implement,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing one embodiment of a “cleaning implement” incorporating the design;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a side view thereof;

FIG. 5 is another side view thereof;

FIG. 6 is a front view thereof;

FIG. 7 is a rear view thereof;

FIG. 8 is a perspective view showing another embodiment of a “cleaning implement” incorporating the design;

FIG. 9 is a top view of the cleaning implement shown in FIG. 8;

FIG. 10 is a bottom view of the cleaning implement shown in FIG. 8;

FIG. 11 is a side view of the cleaning implement shown in FIG. 8;

FIG. 12 is another side view of the cleaning implement shown in FIG. 8;

FIG. 13 is a front view of the cleaning implement shown in FIG. 8;

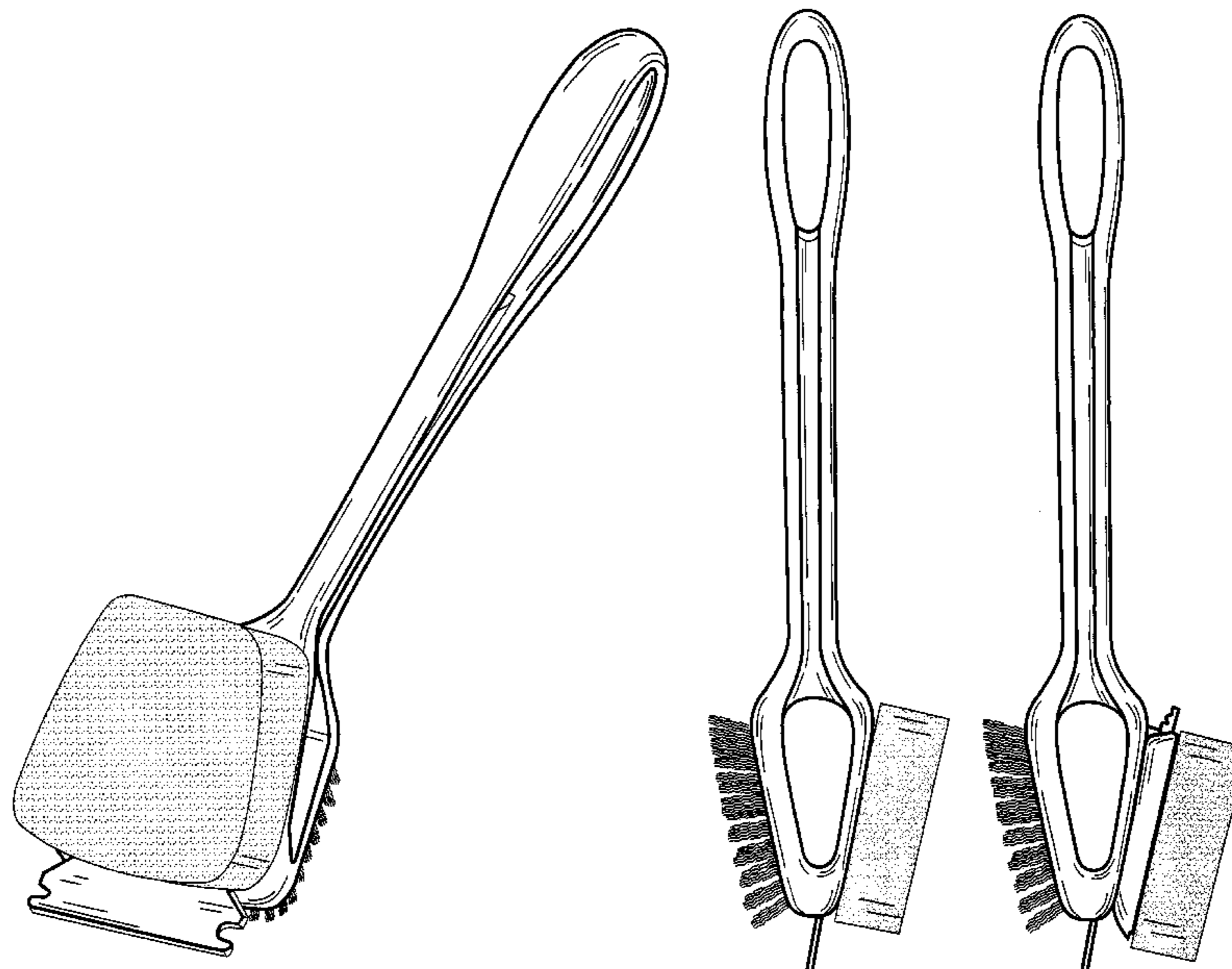
FIG. 14 is a rear view of the cleaning implement shown in FIG. 8;

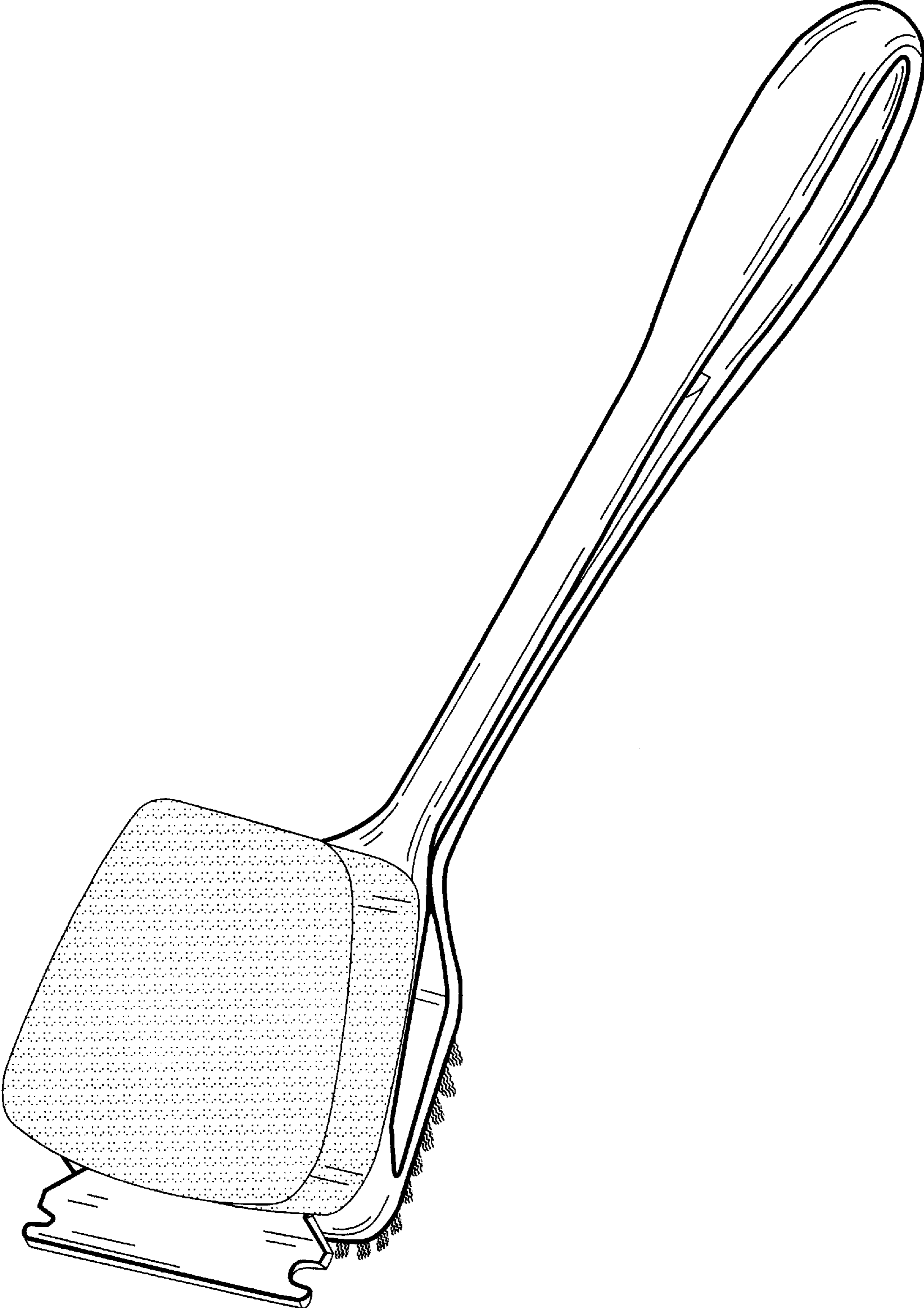

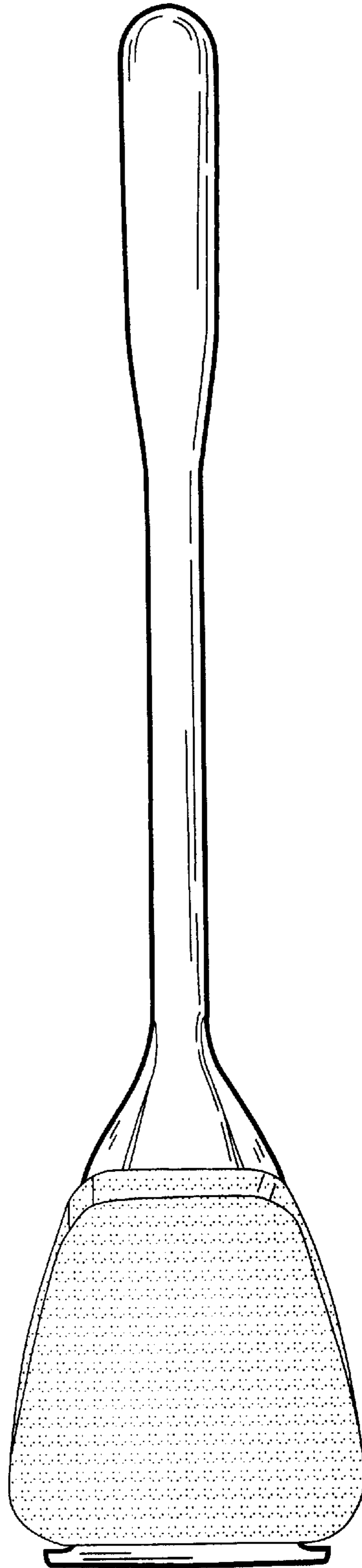

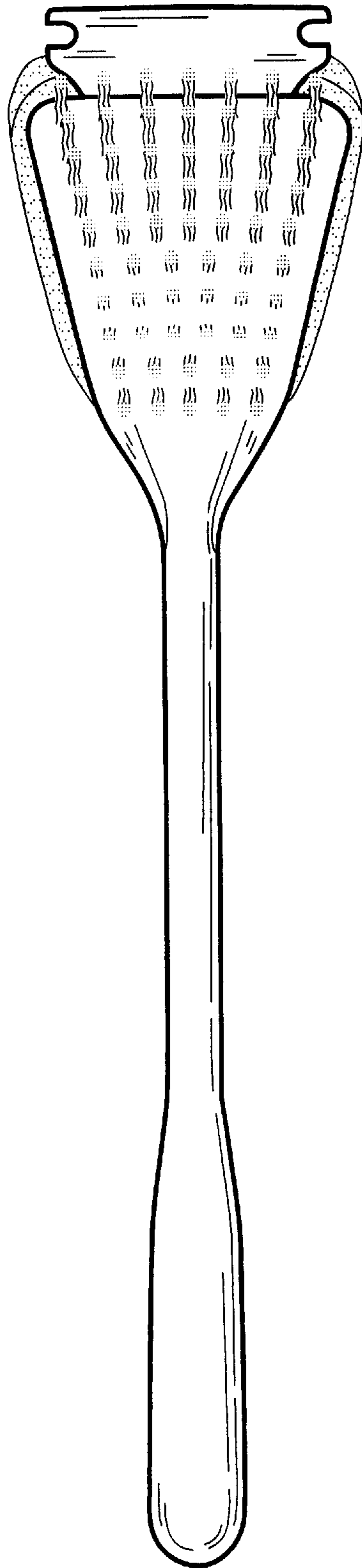

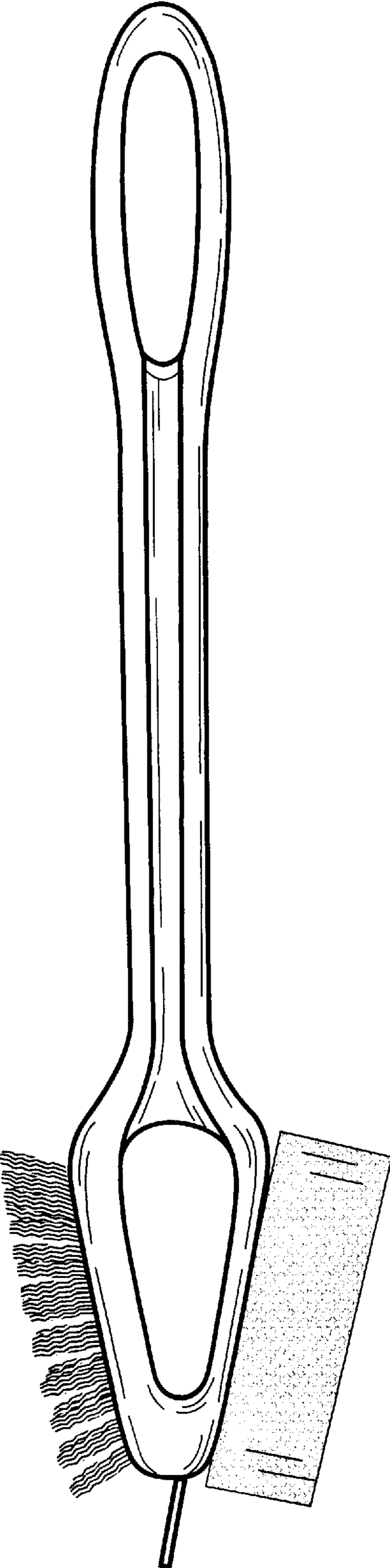

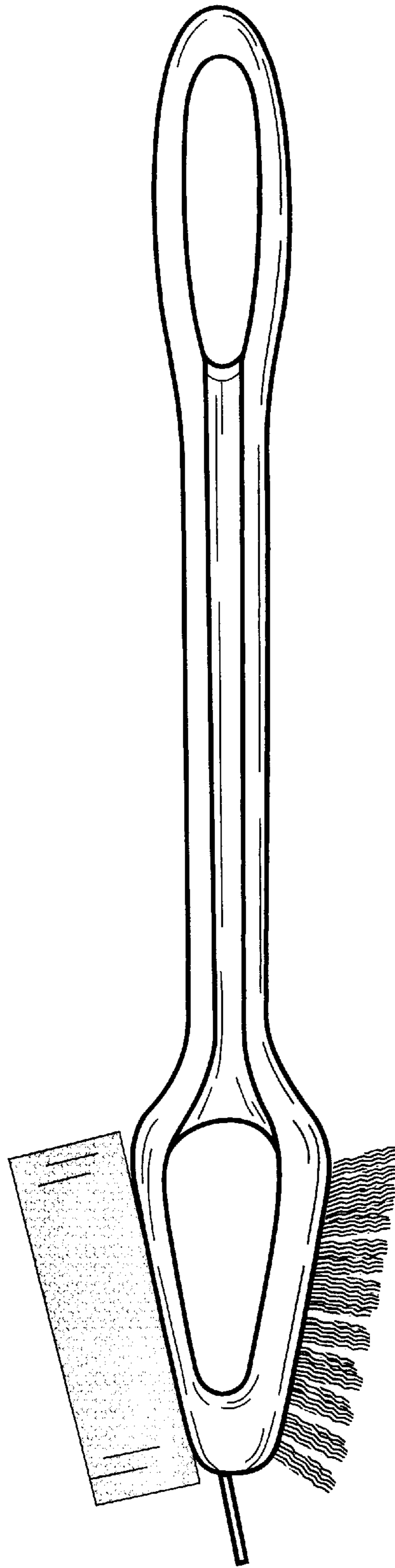

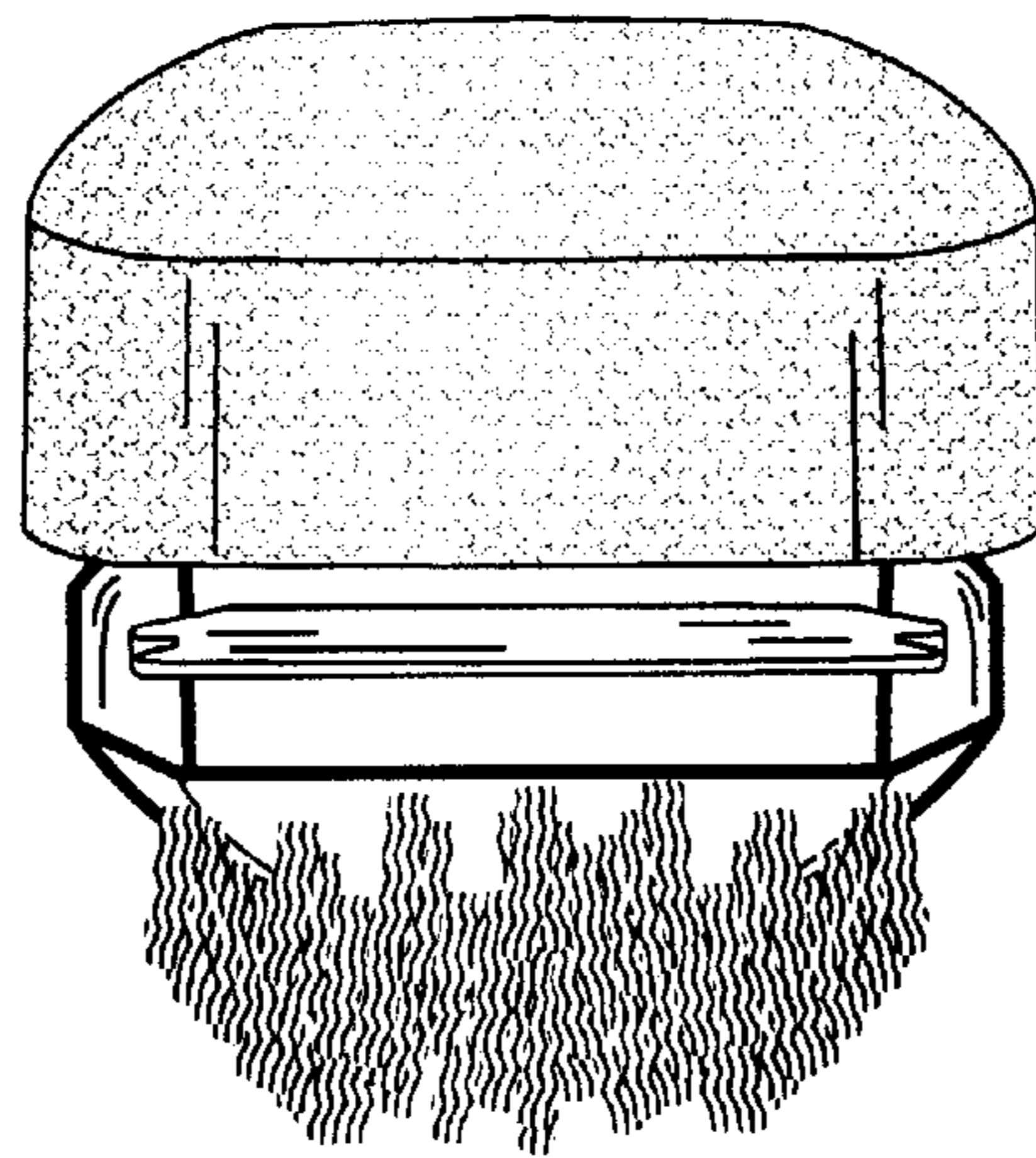

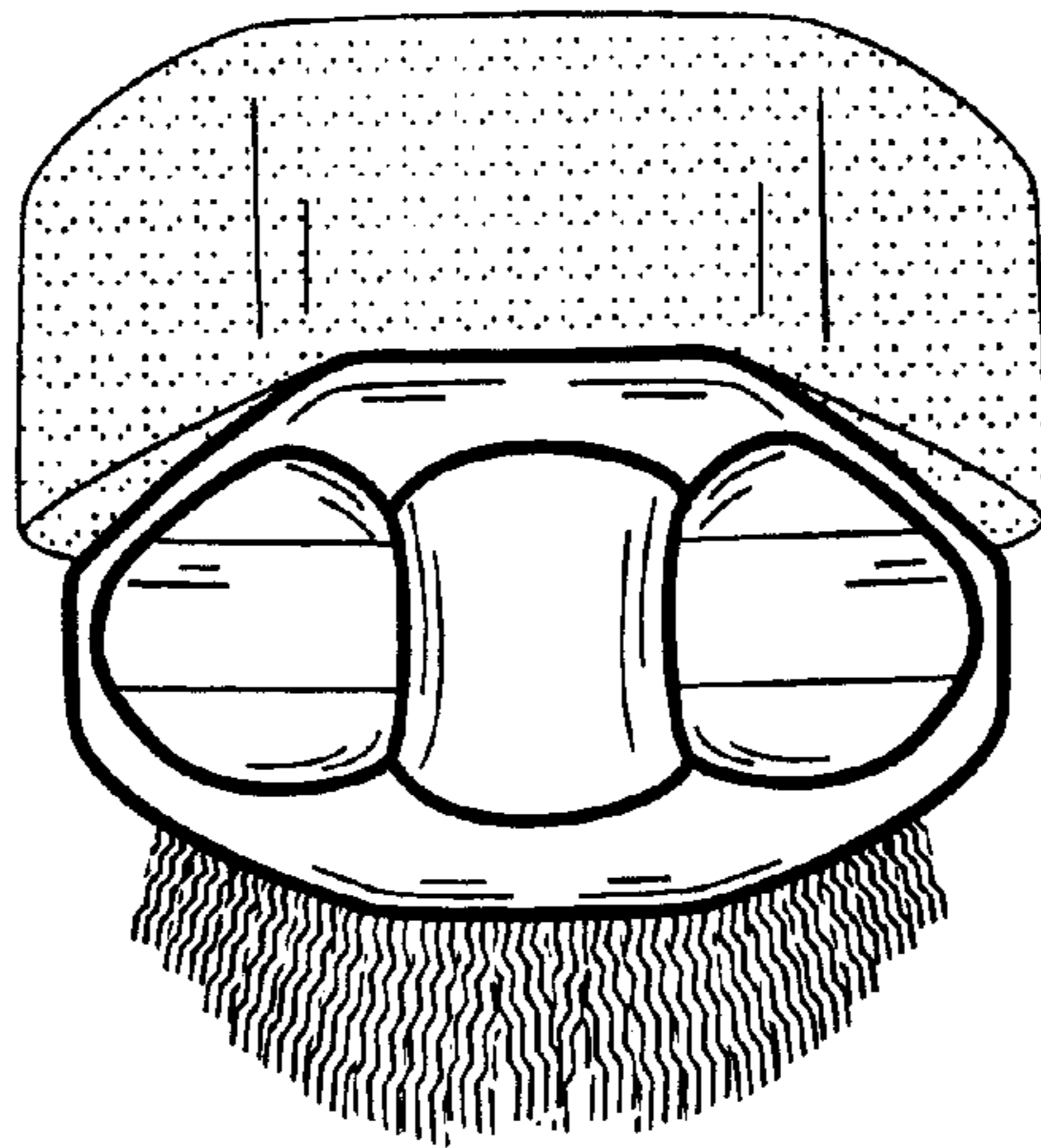

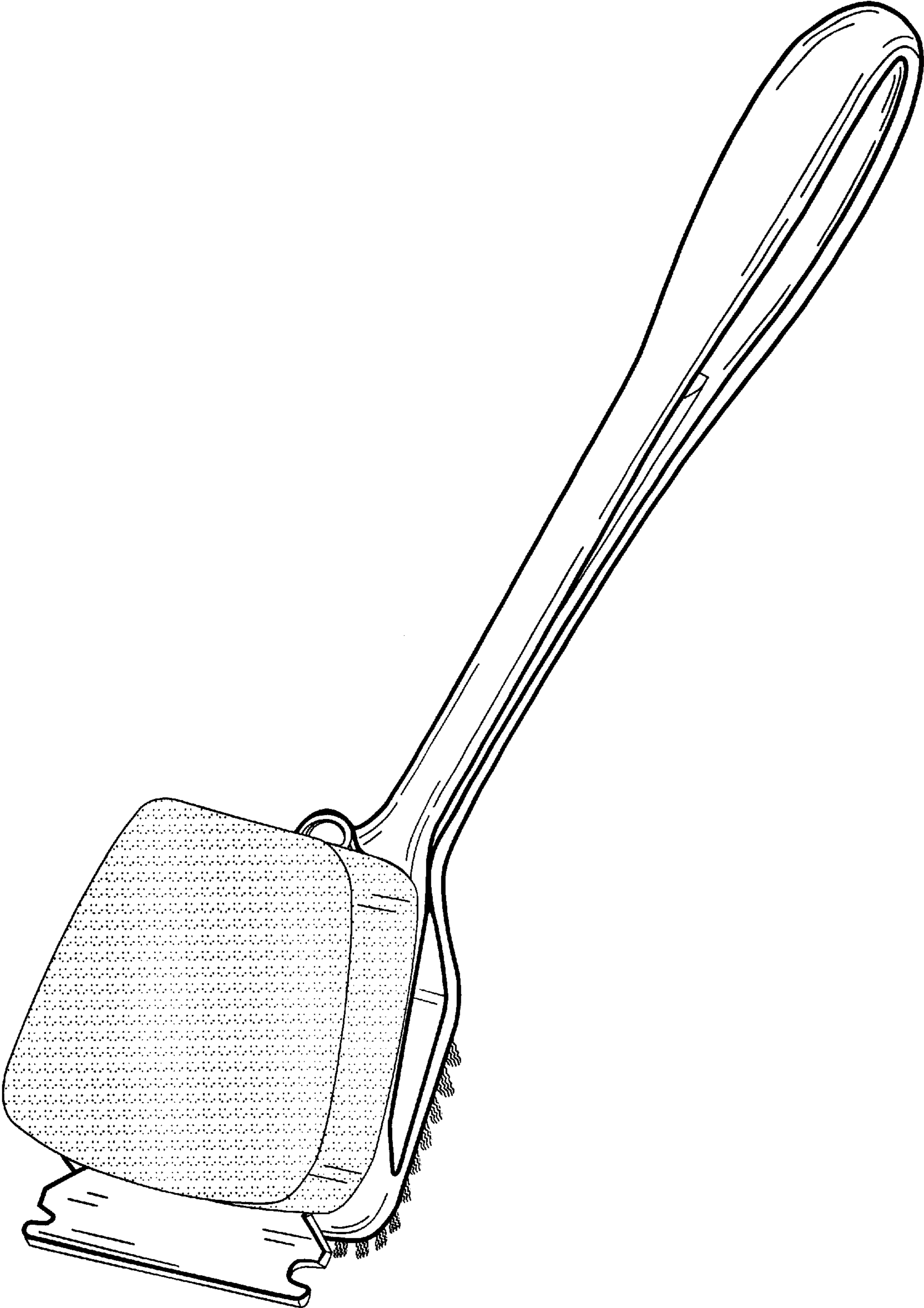

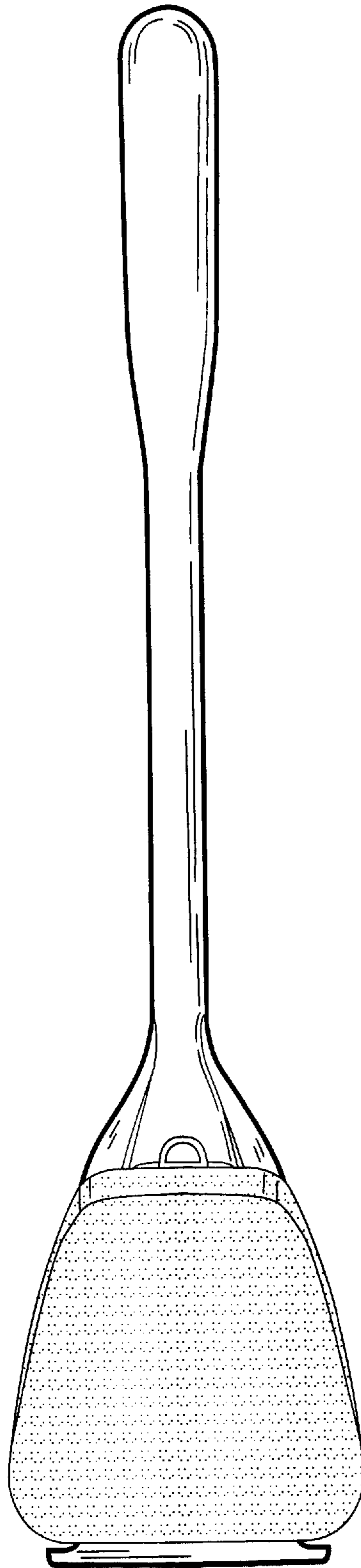

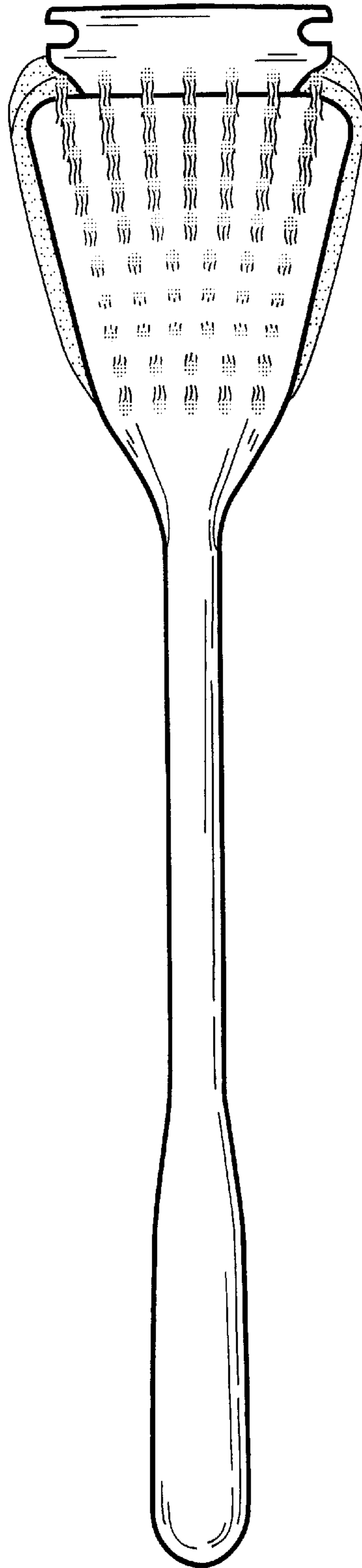

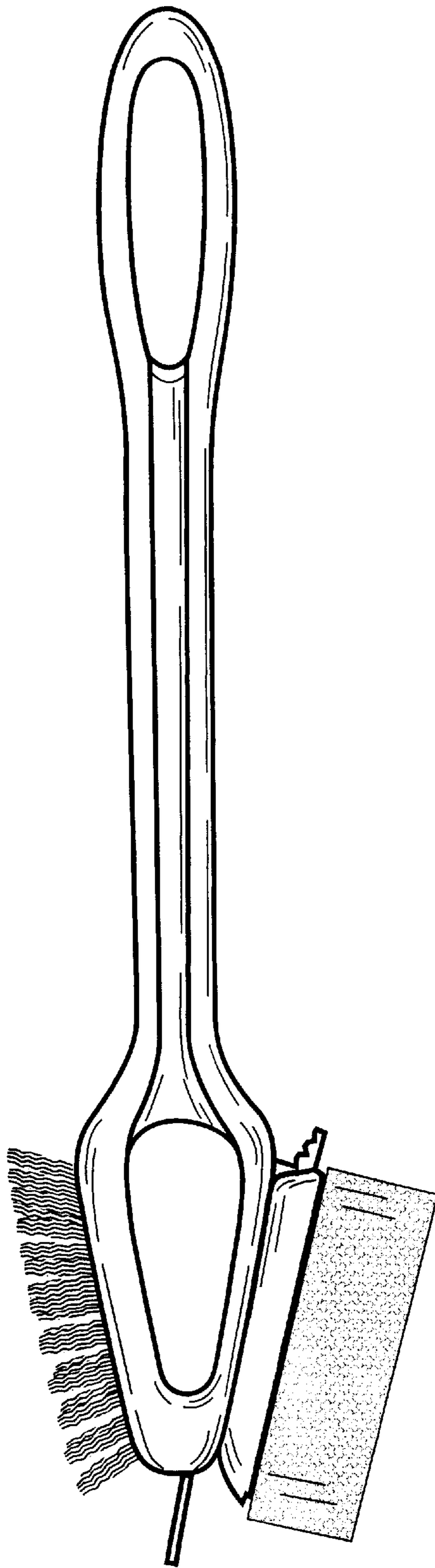

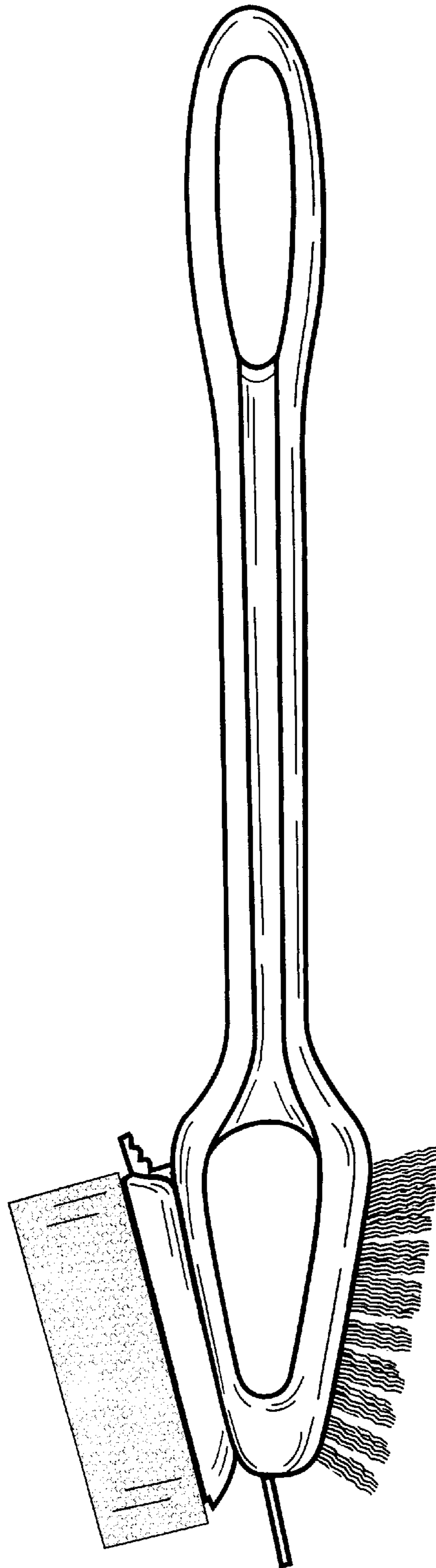

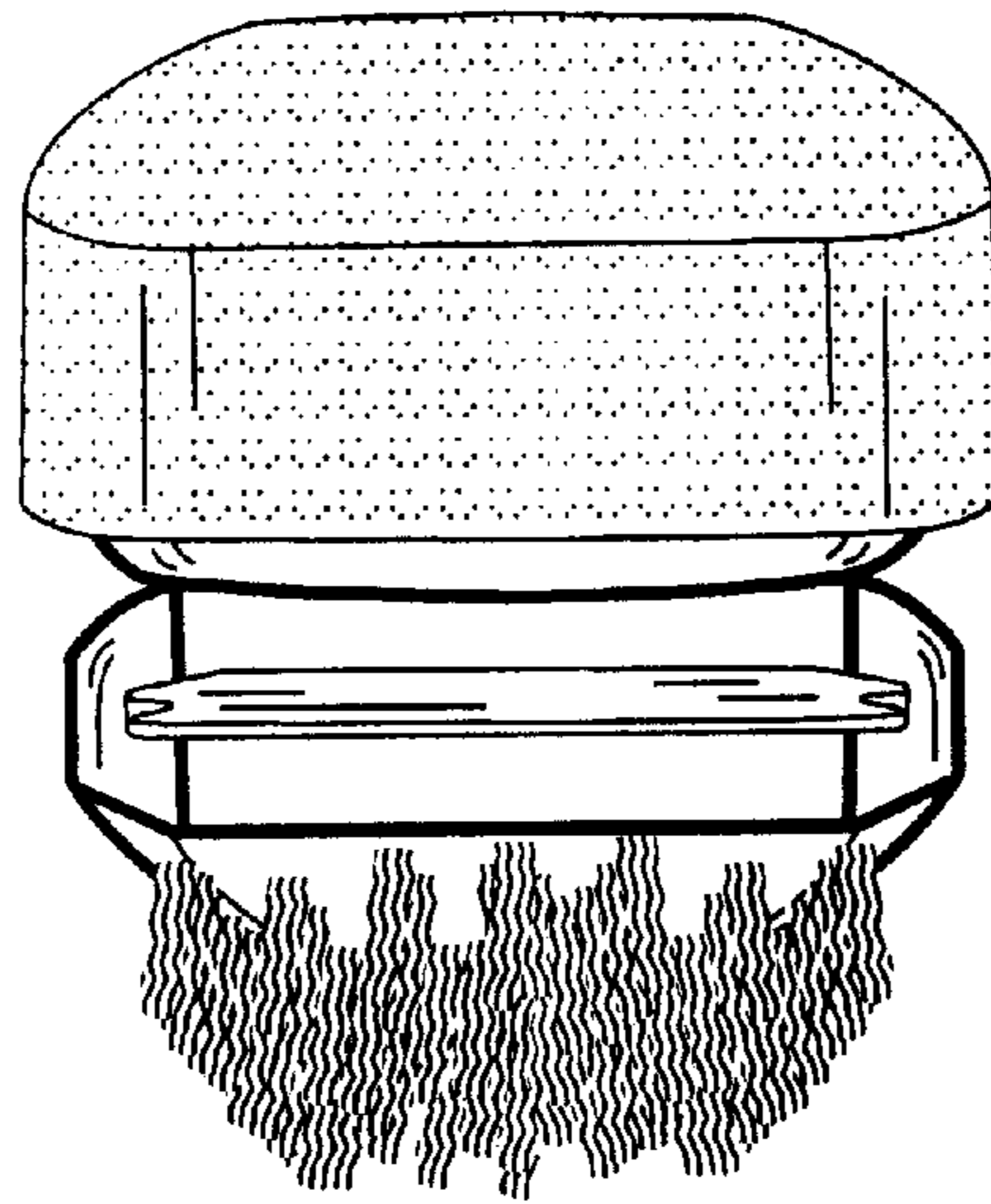

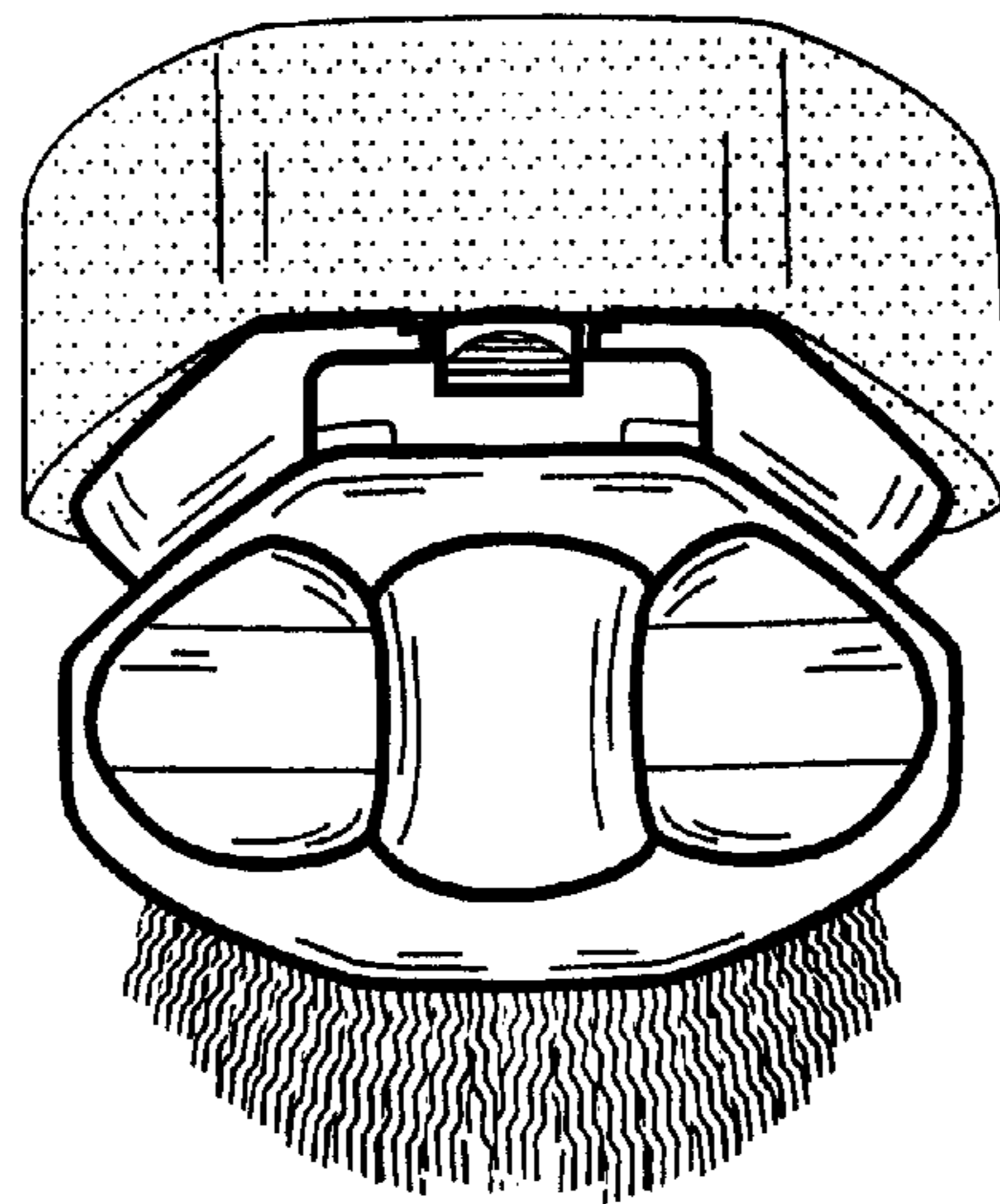

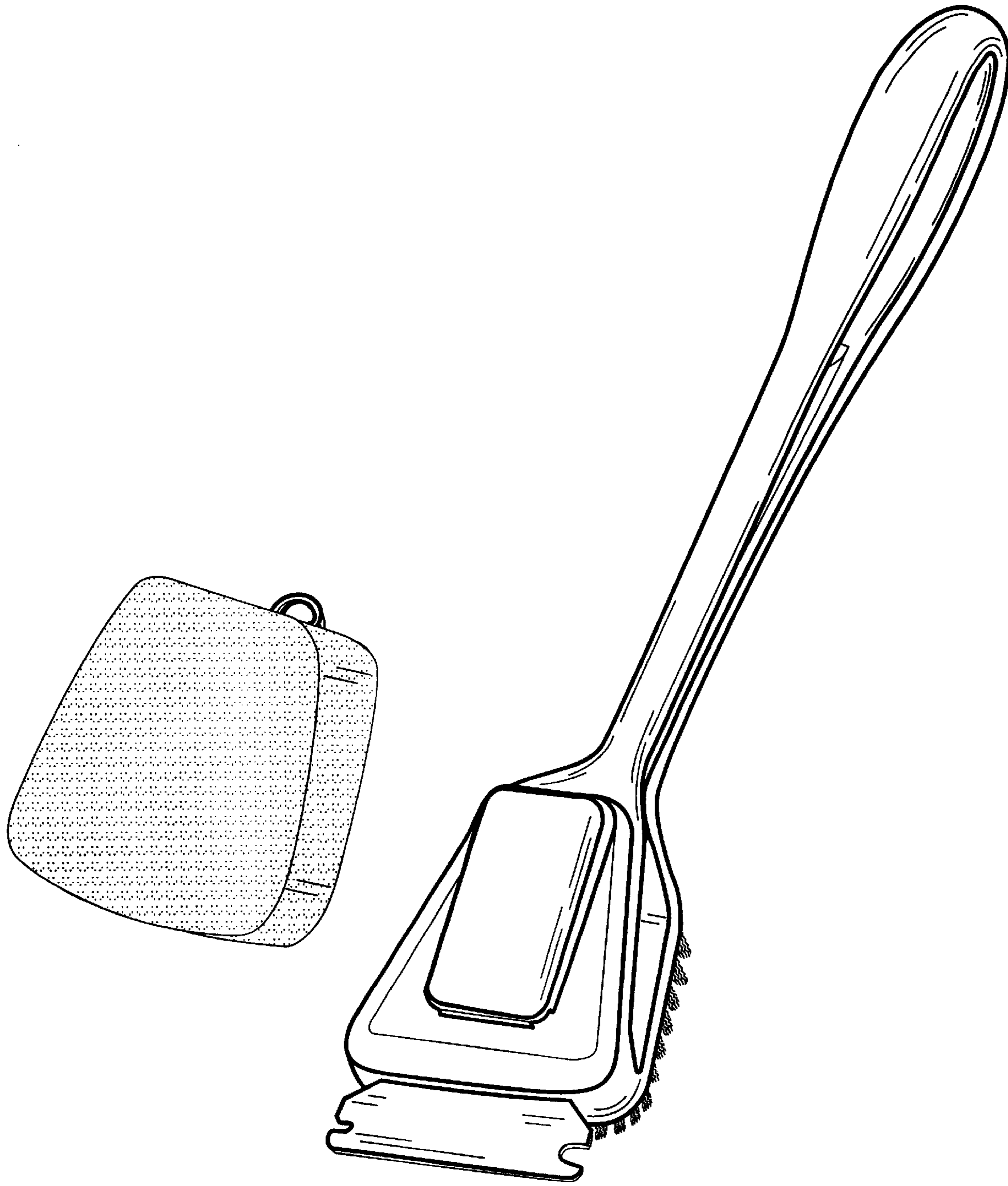

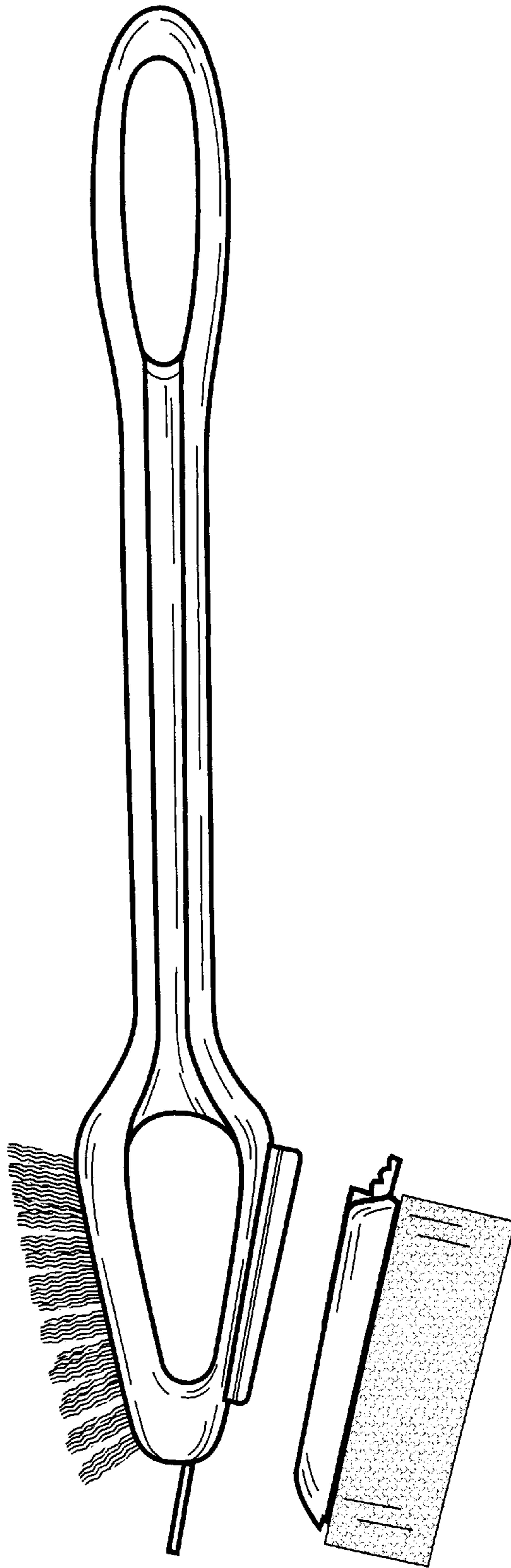
