(57) **CLAIM**

The ornamental design for a brush with handle and circles, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a brush with handle and circles showing my new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image;

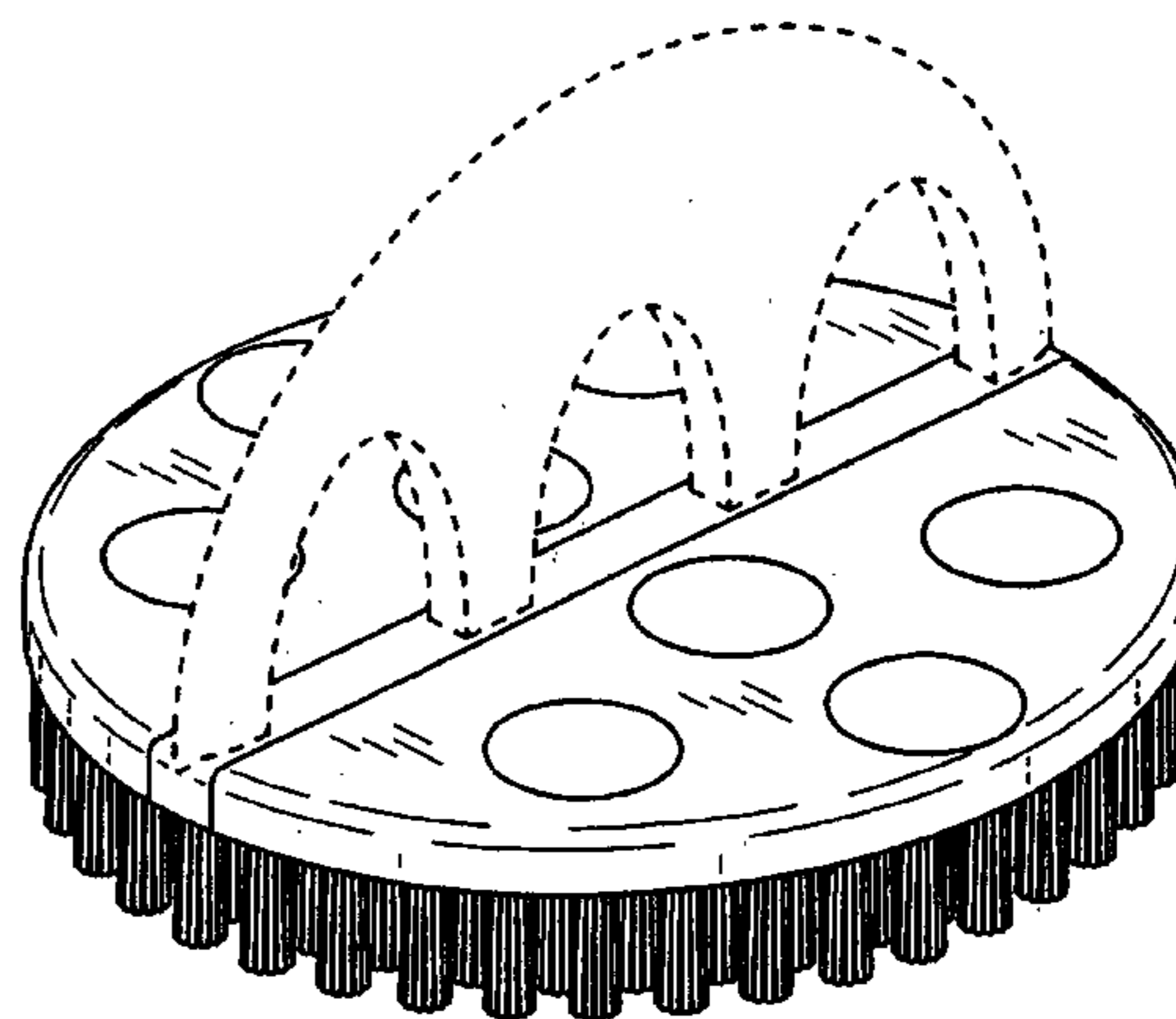
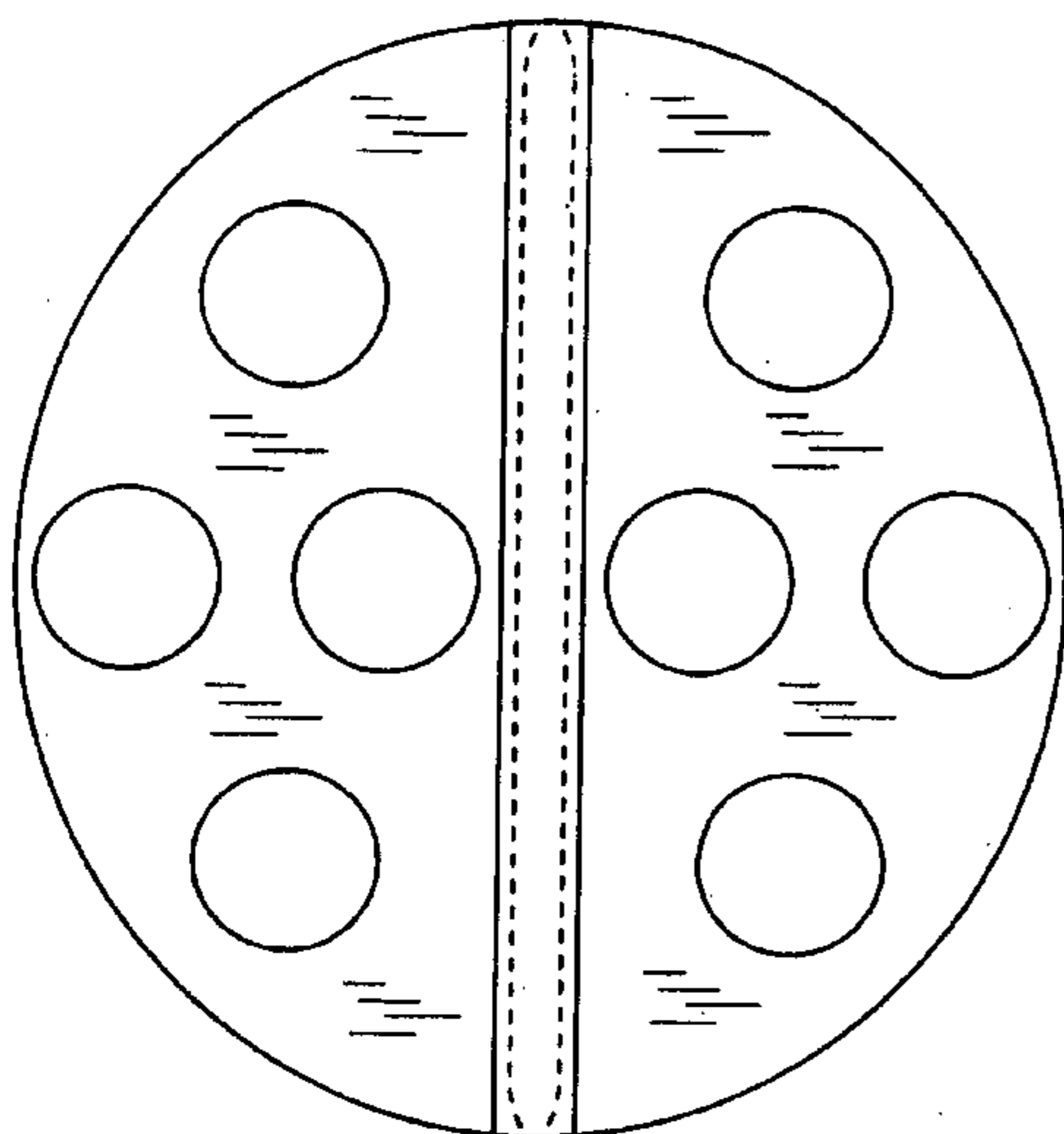
FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image; and,

FIG. 4 is a perspective view thereof.

The claimed brush with handle and circles is used for cleaning shoes and clothing.

The broken line showing of a handle is included for the purpose of illustrating a portion of the brush that forms no part of the claimed design.

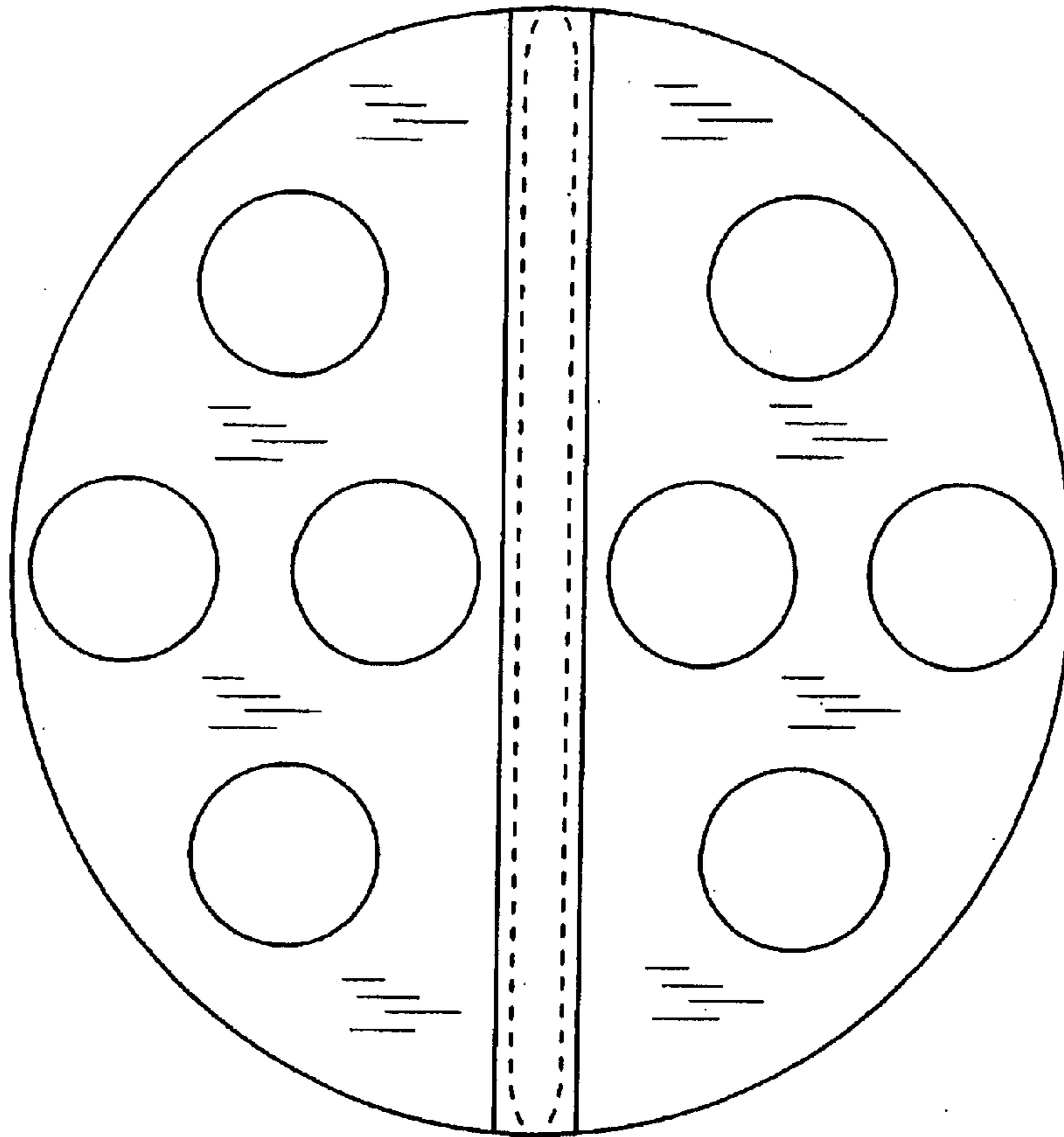

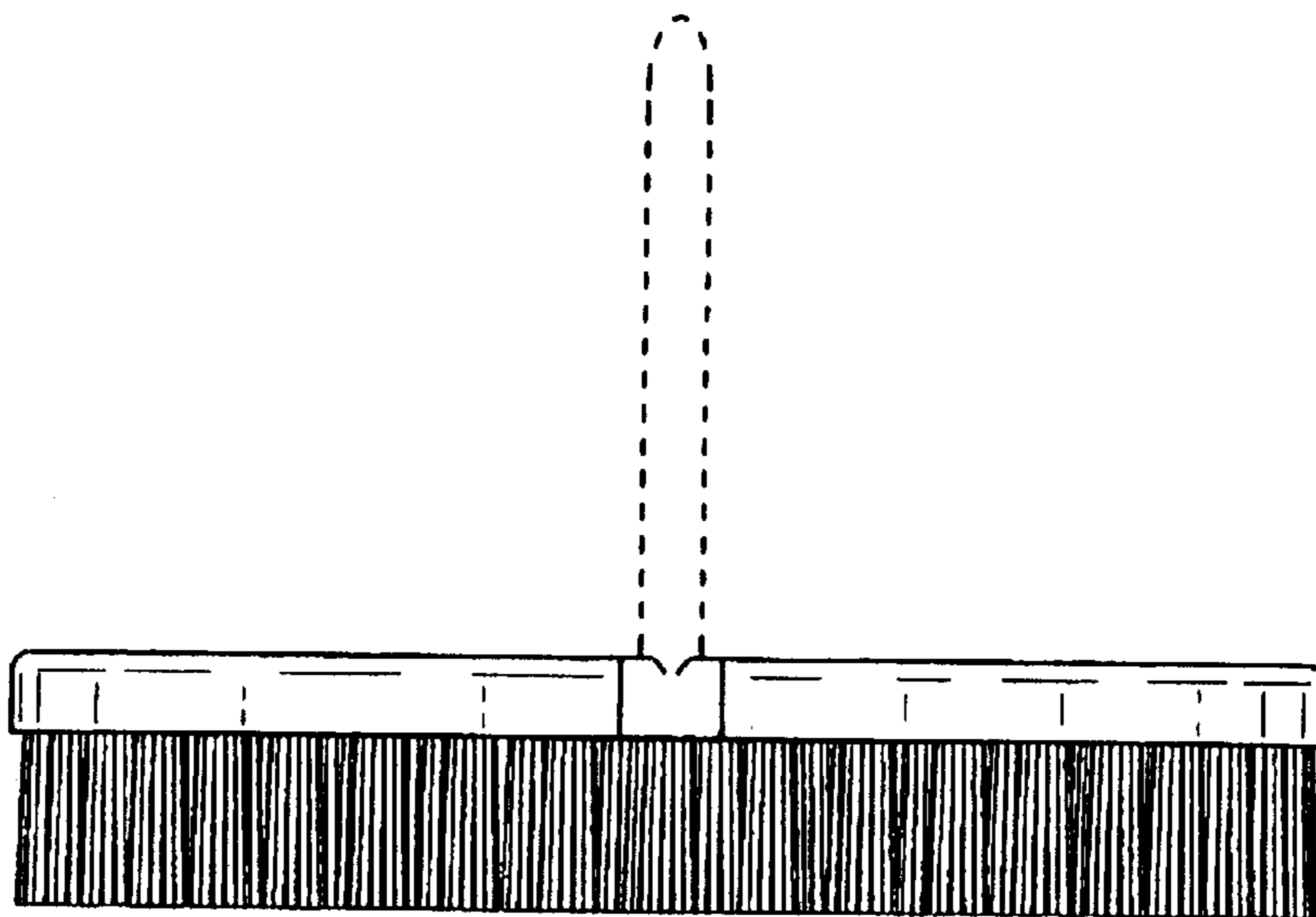

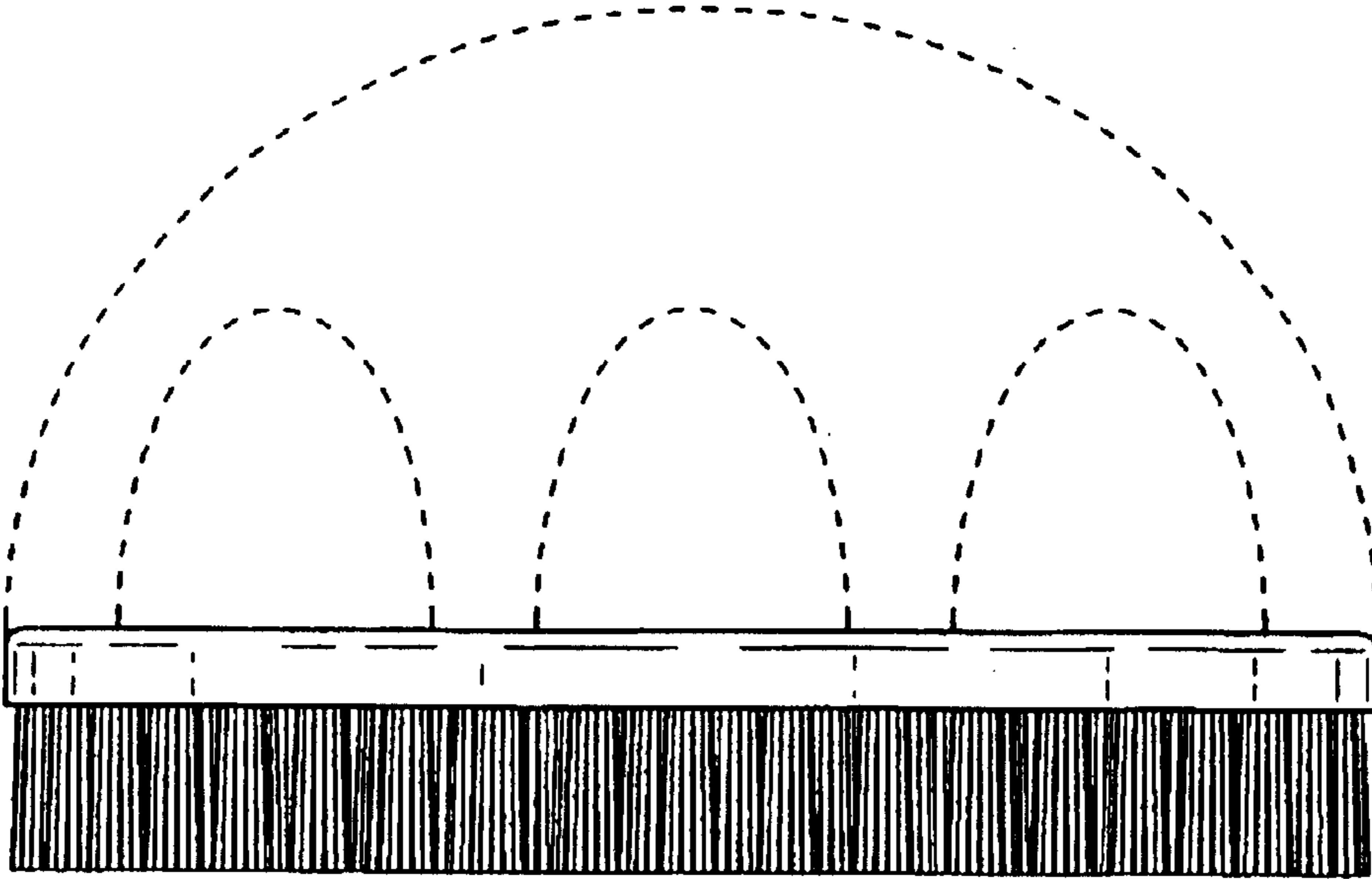

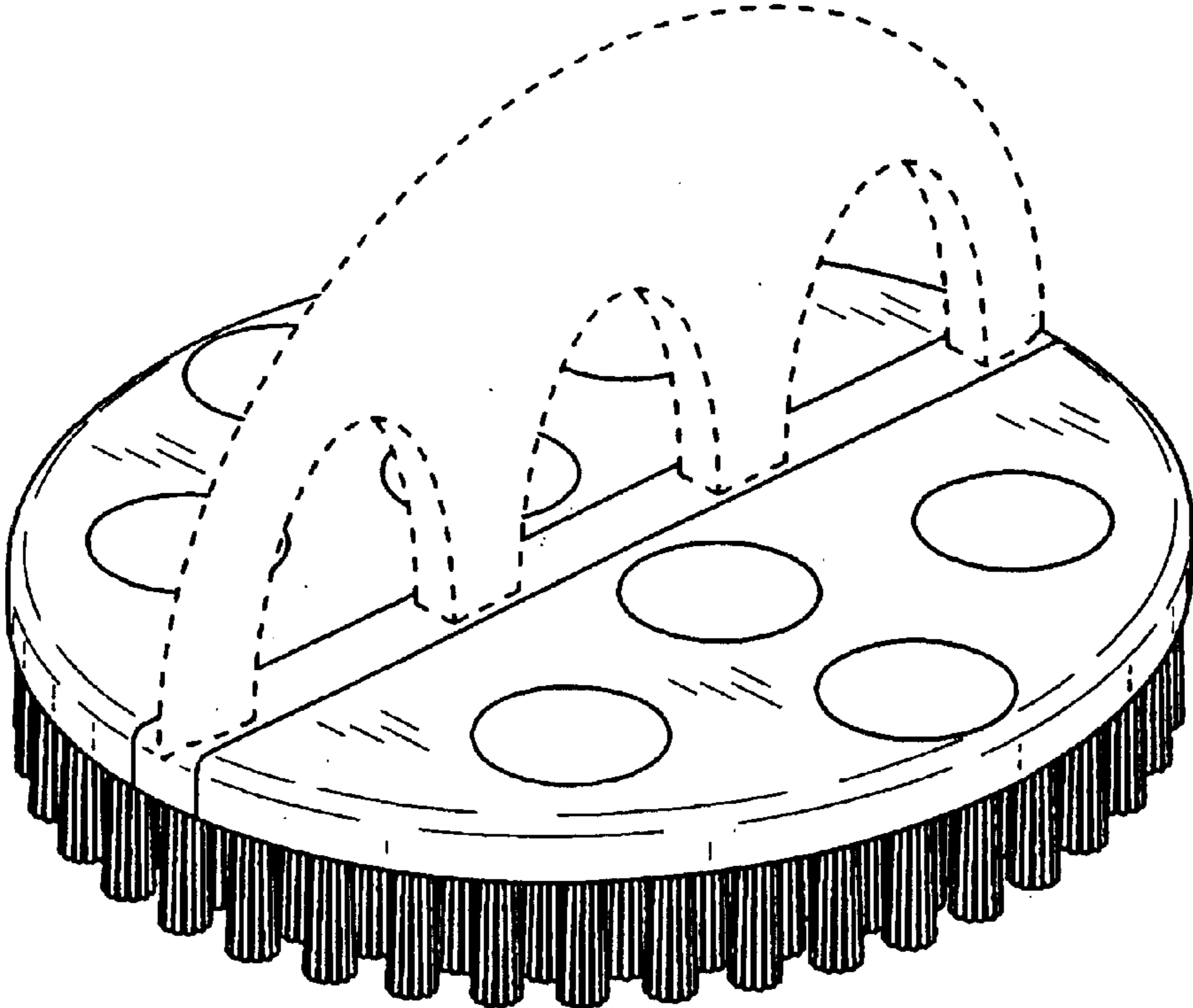
