DESCRIPTION

FIG. 20 is a bottom plan view thereof;

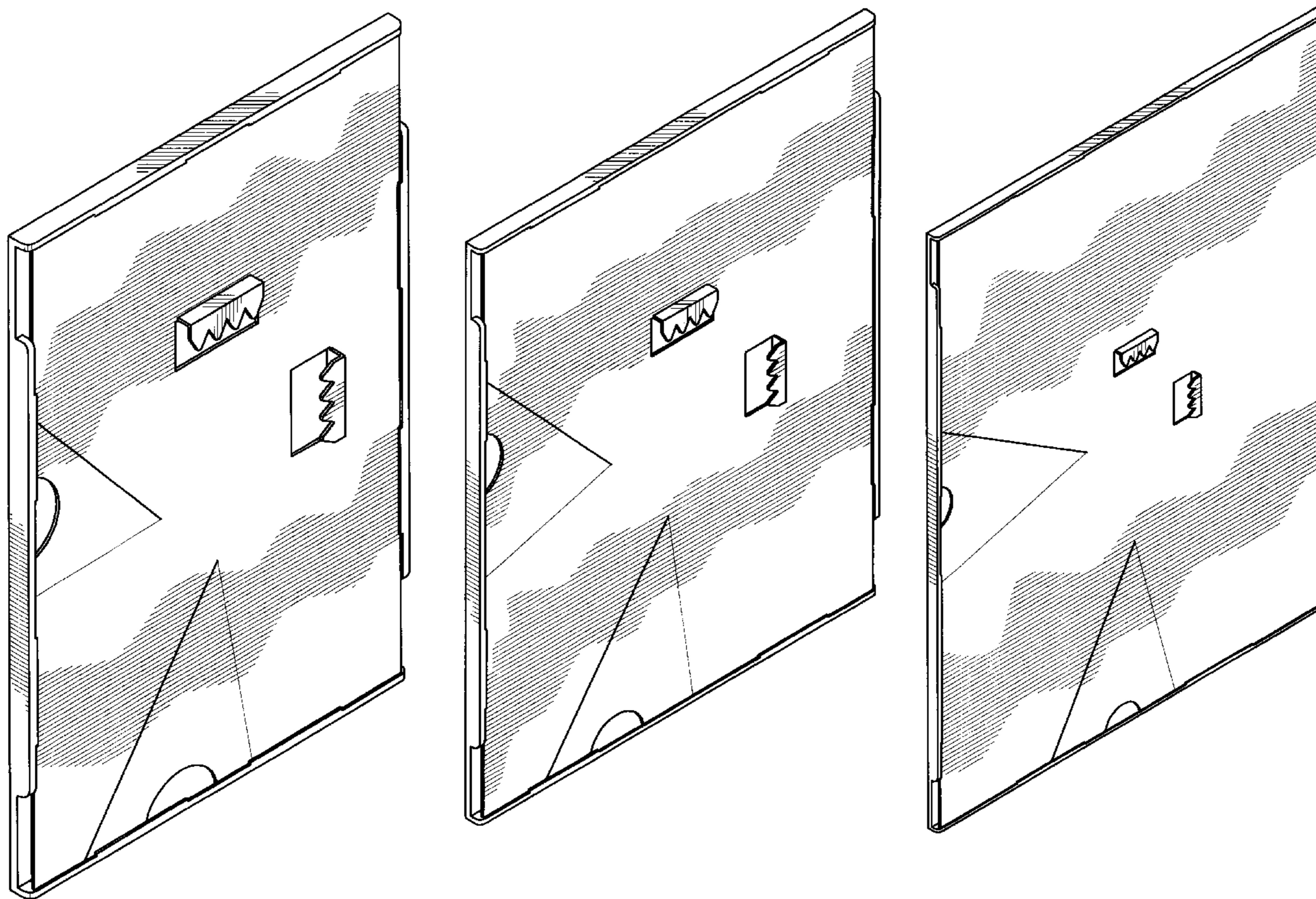
FIG. 21 is a top plan view thereof;

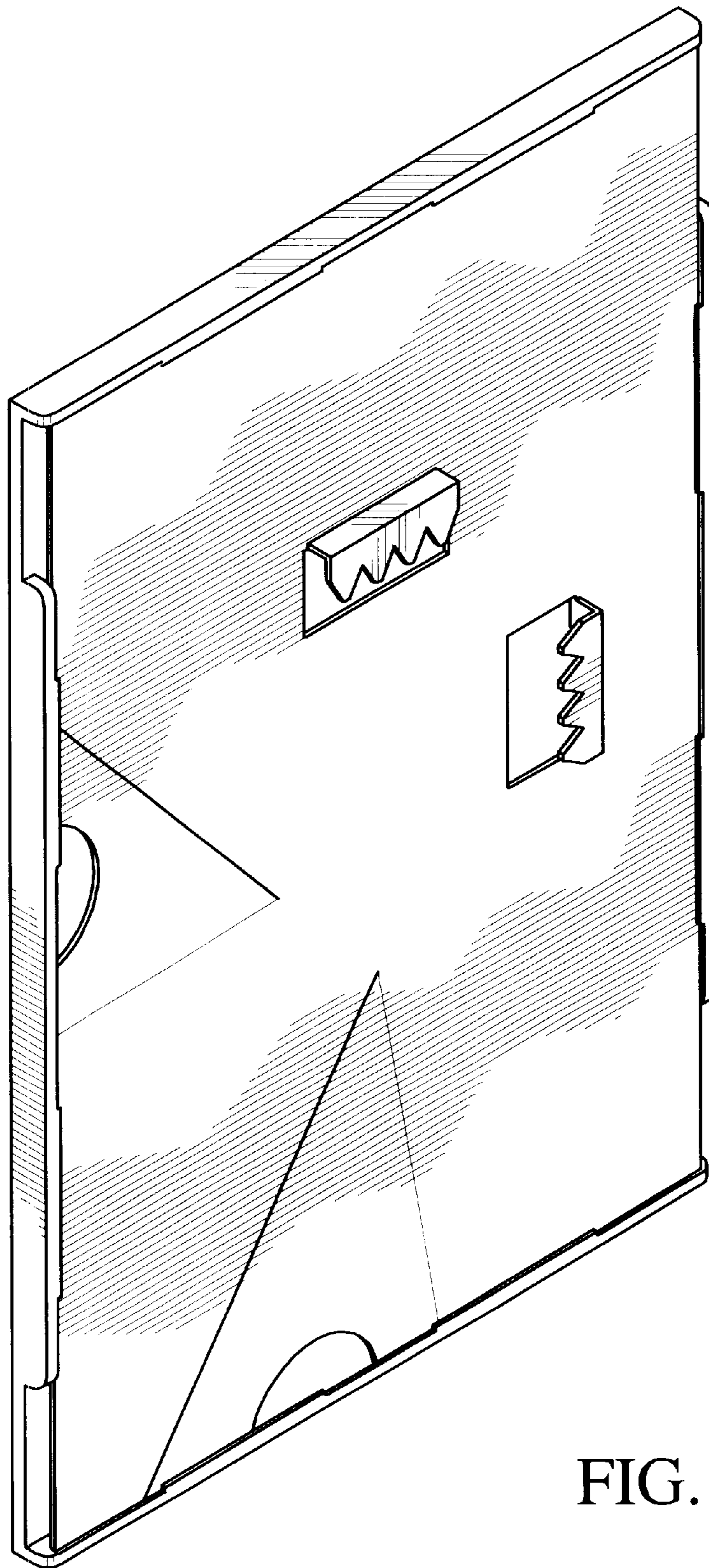

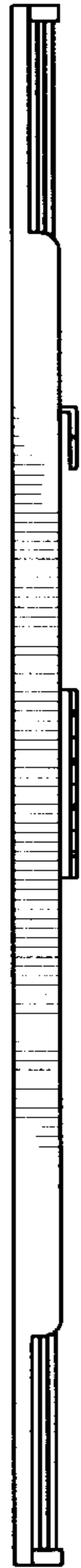

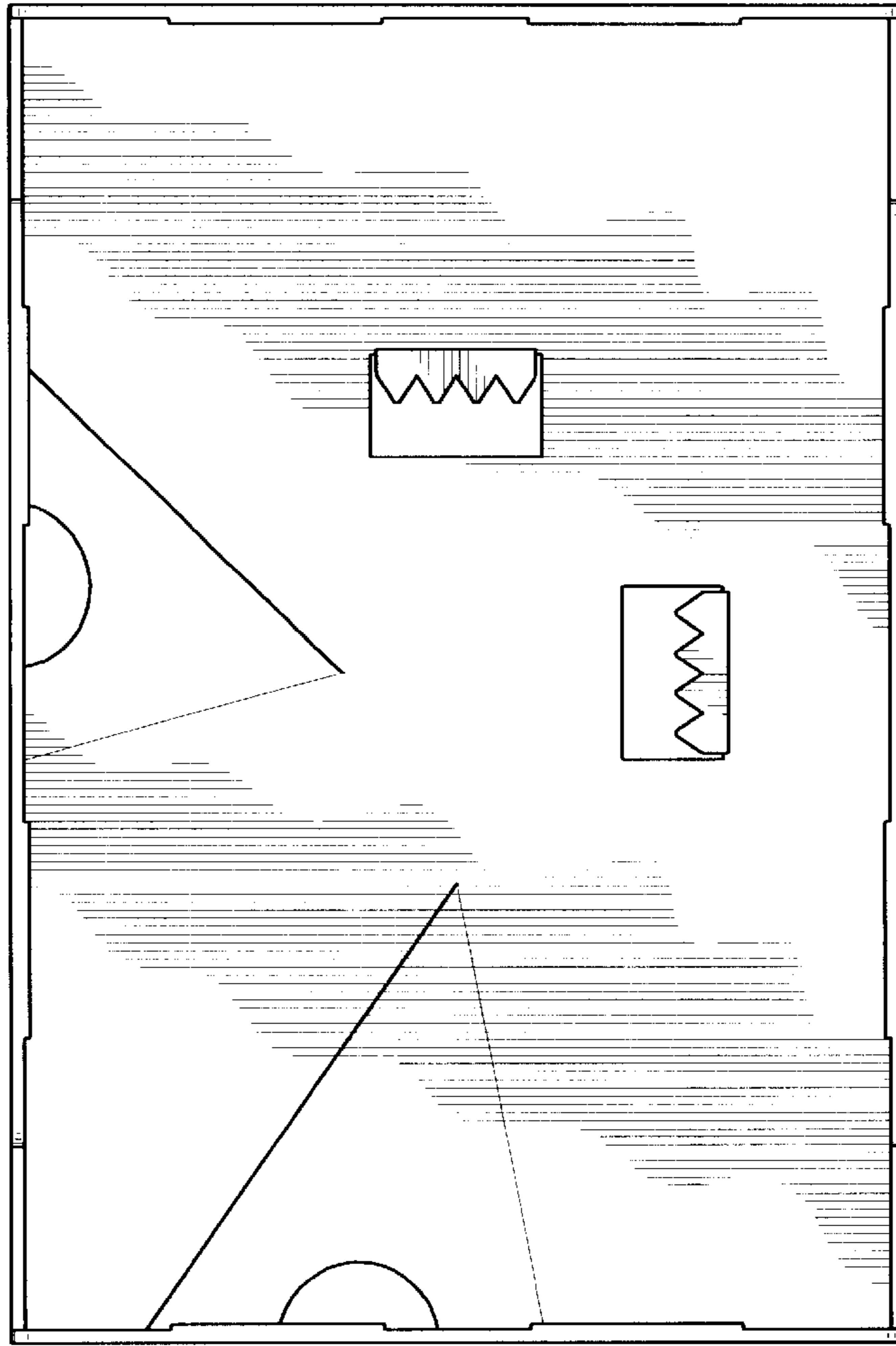

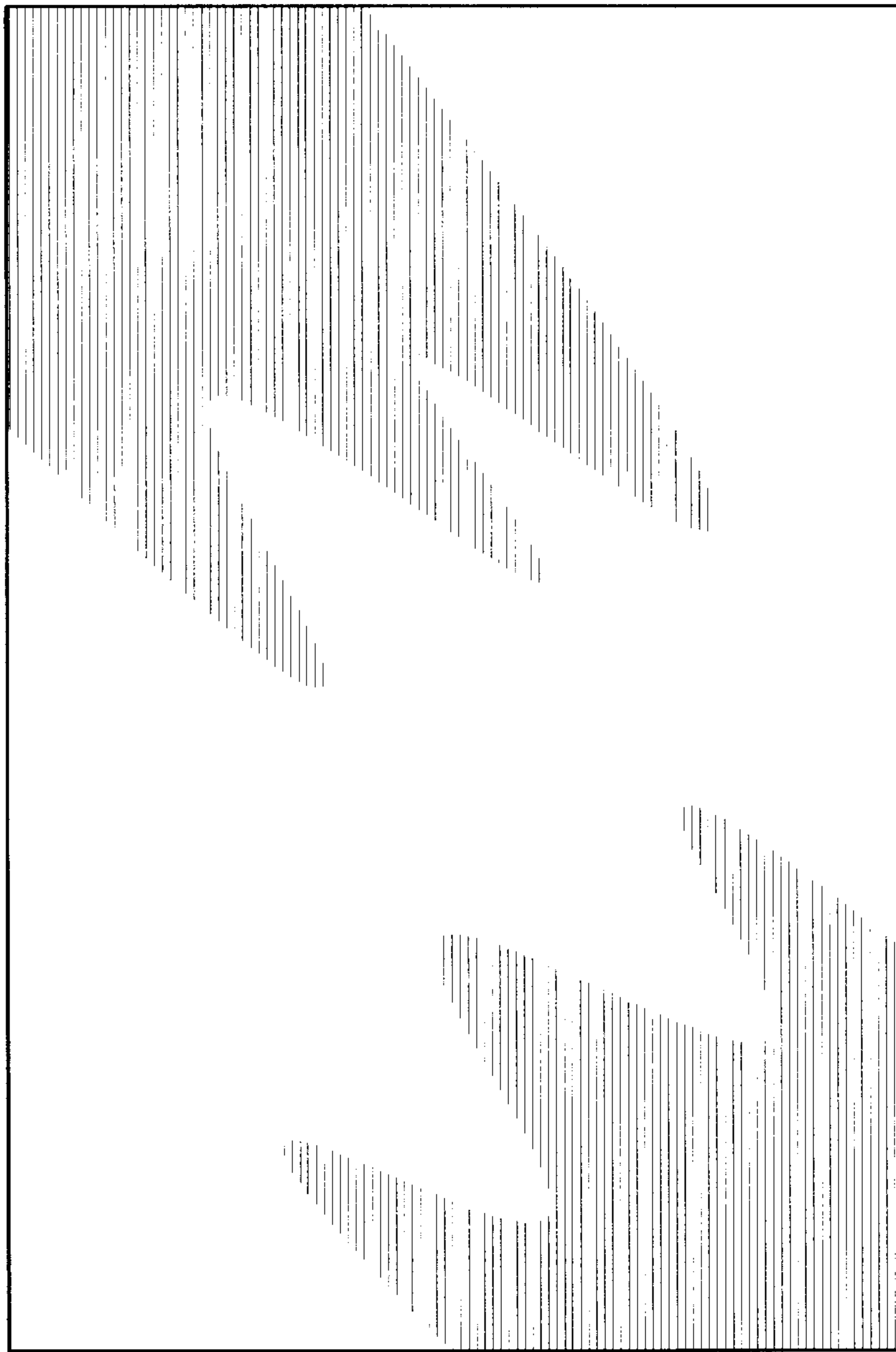

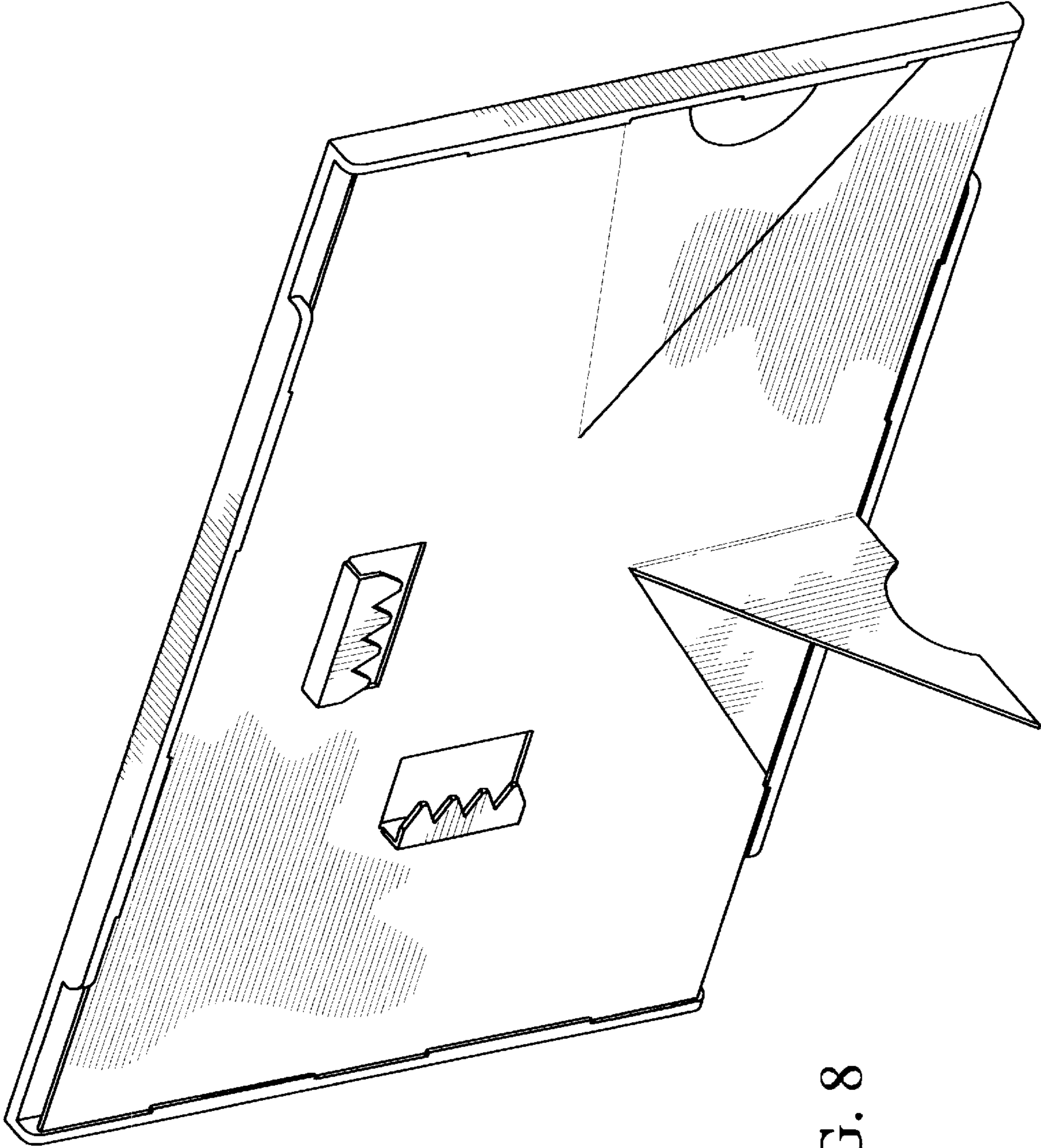

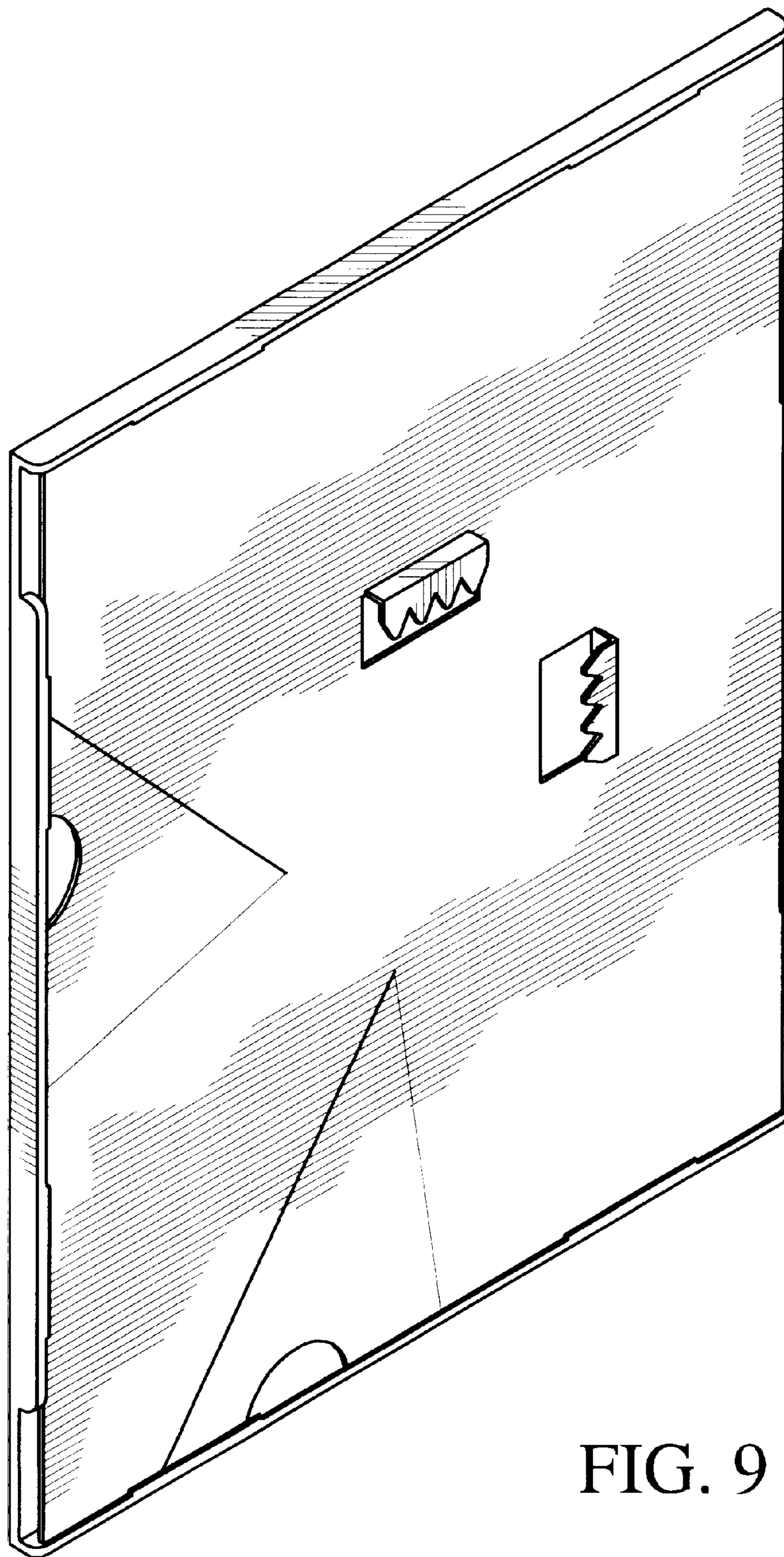

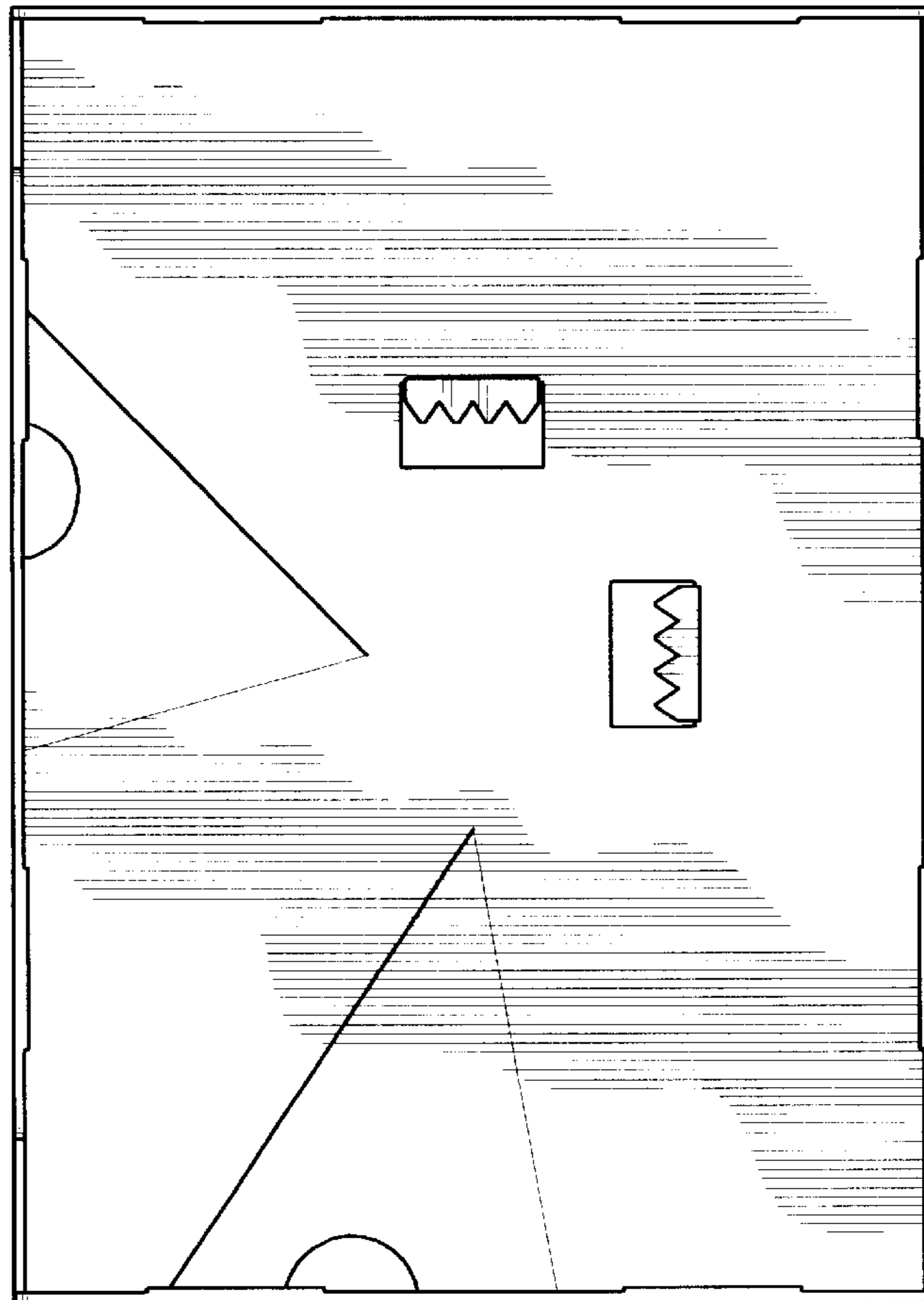

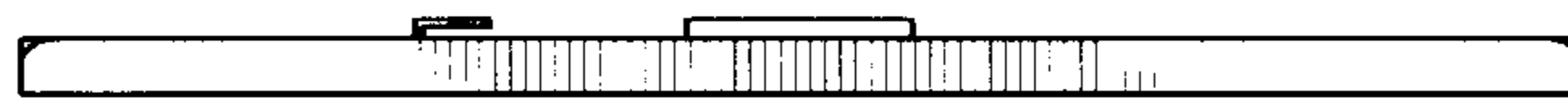

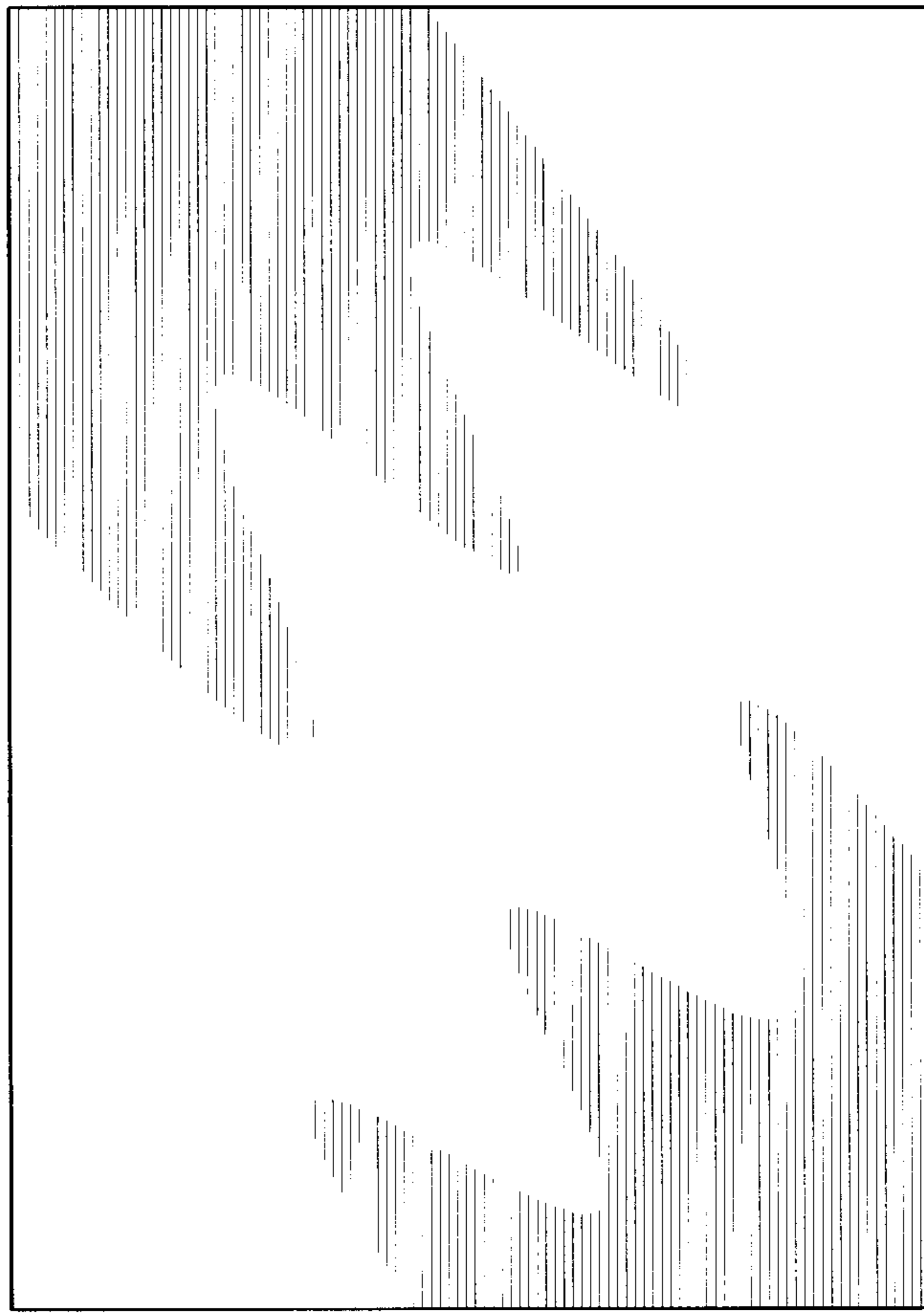

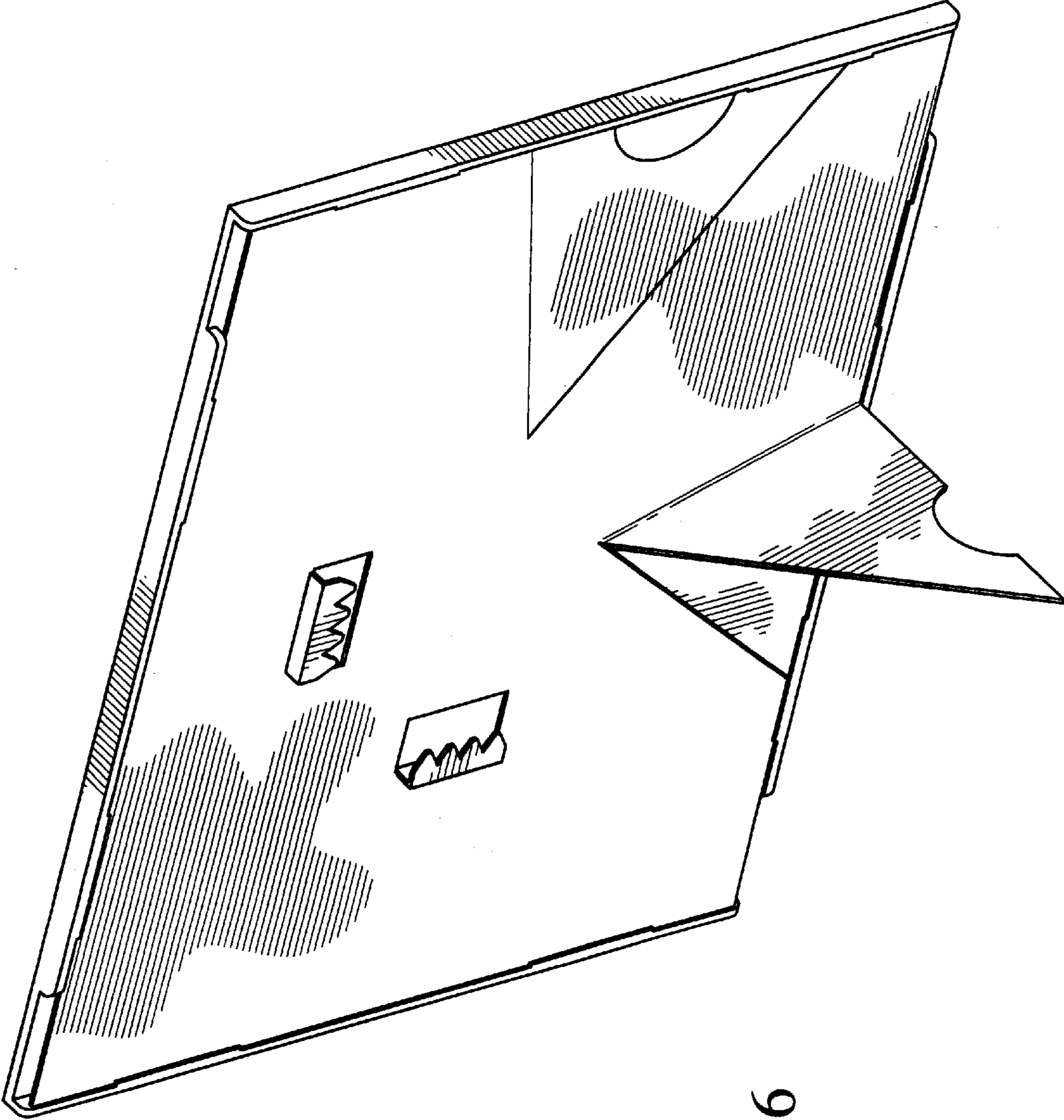

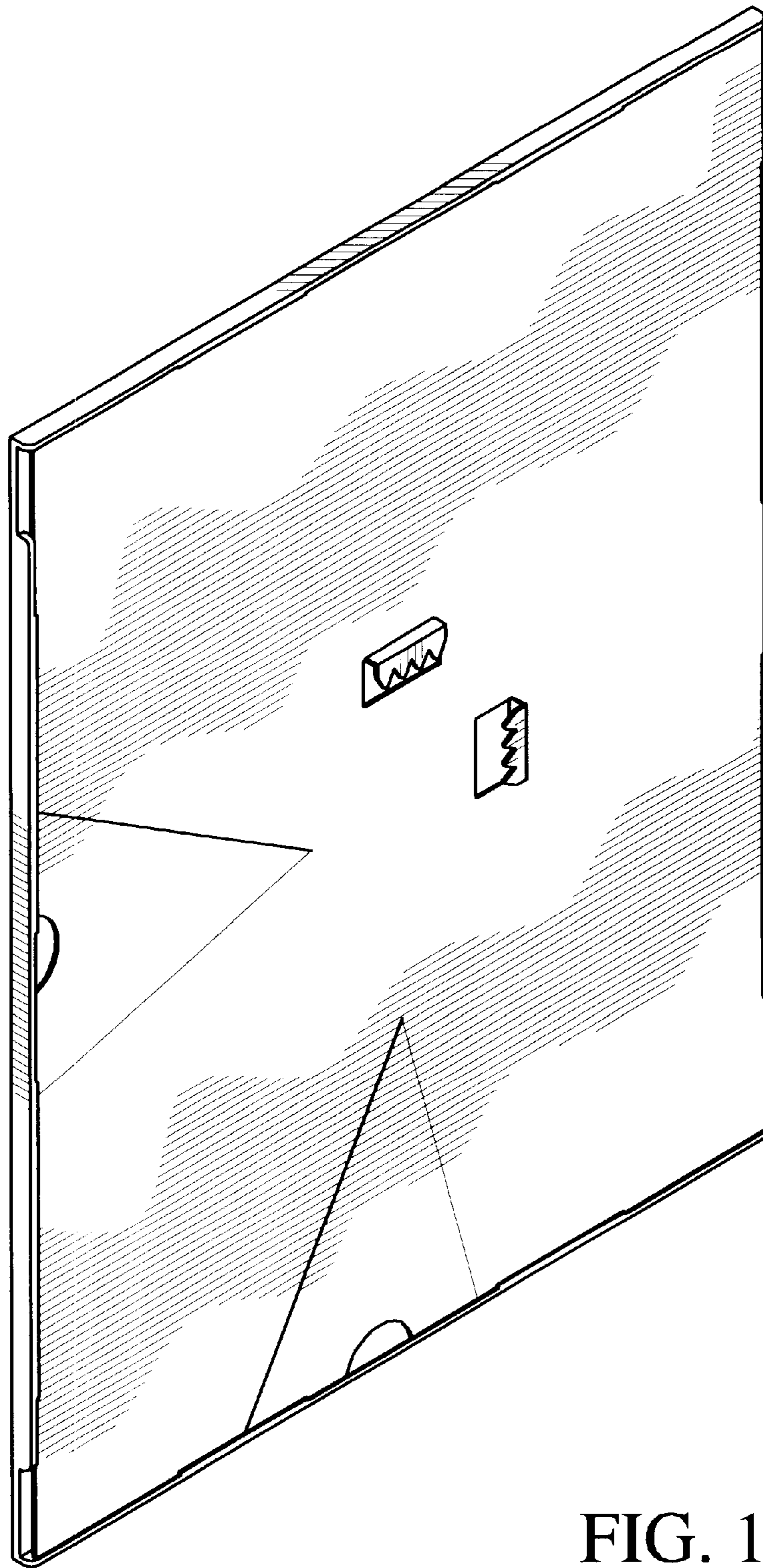

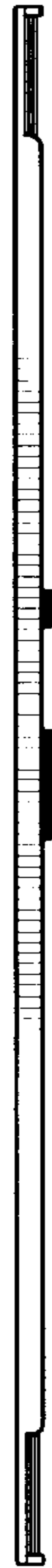

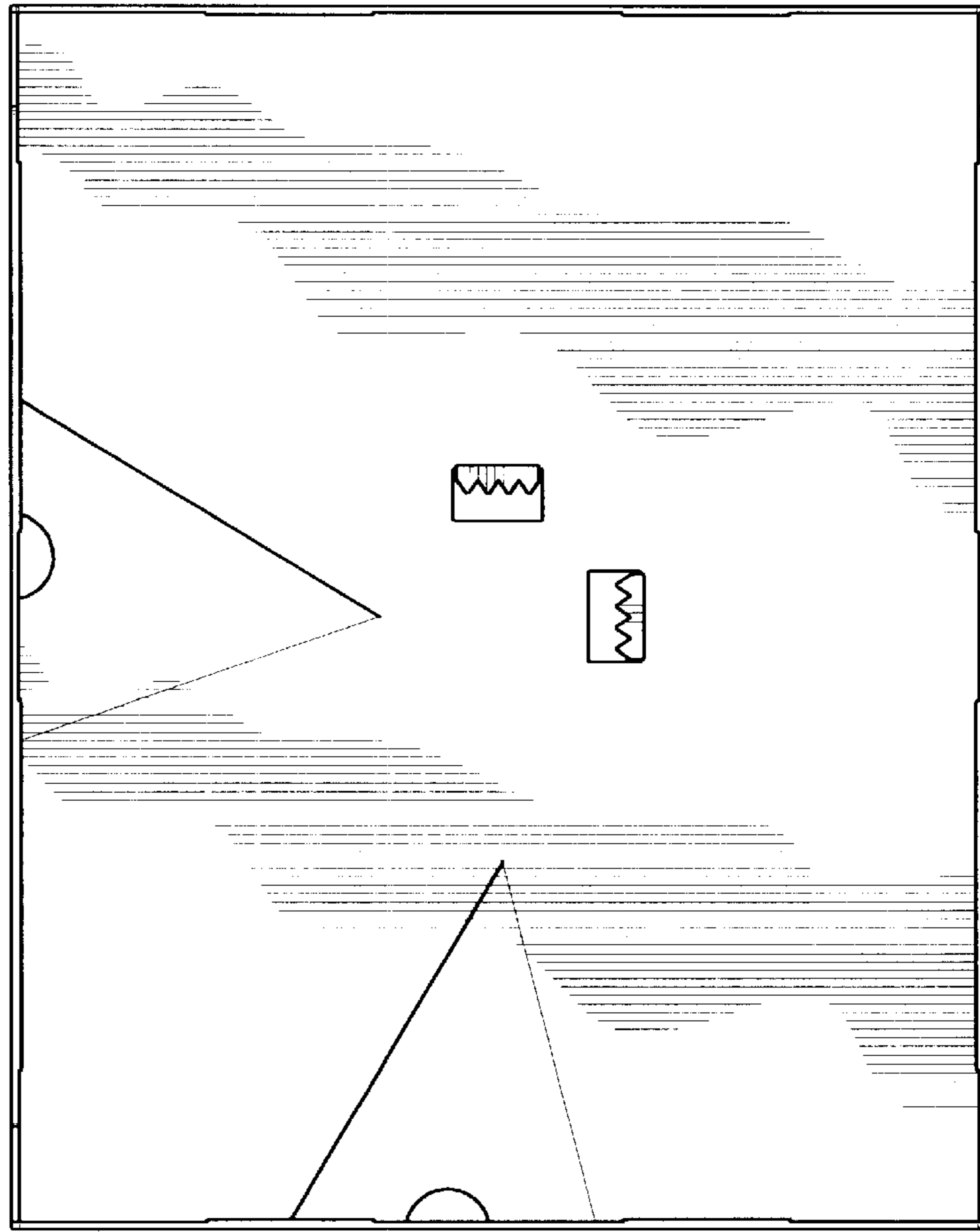

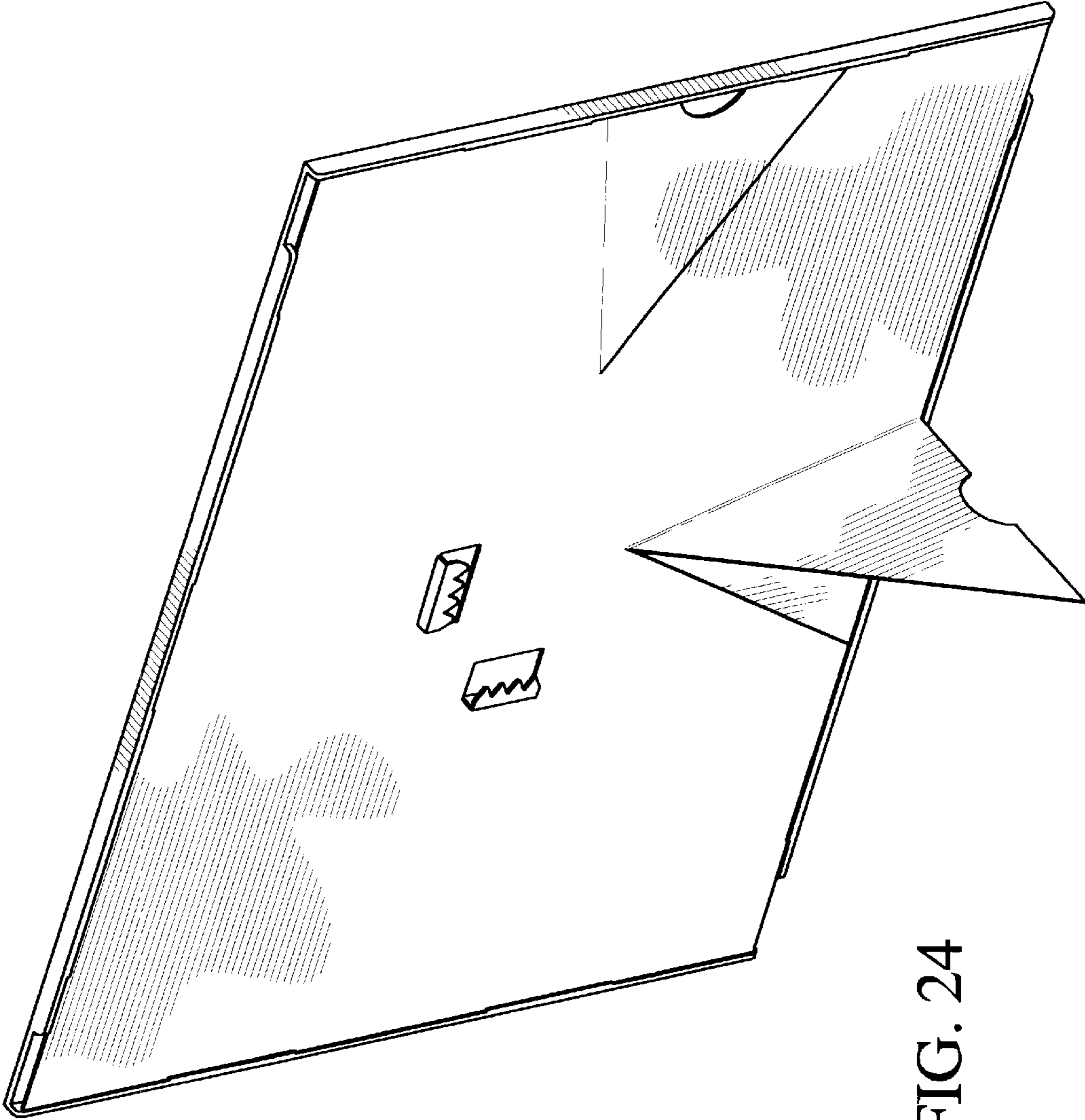
