The ornamental design for a chair arm, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the front, left side and top of a chair arm which forms our new design, the broken lines of a chair and an arm pad being for illustrative purposes only and forming no part of our design;

FIG. 2 is an enlarged left side elevational view thereof;

FIG. 3 is an enlarged top plan view thereof;

FIG. 4 is an enlarged right side elevational view thereof;

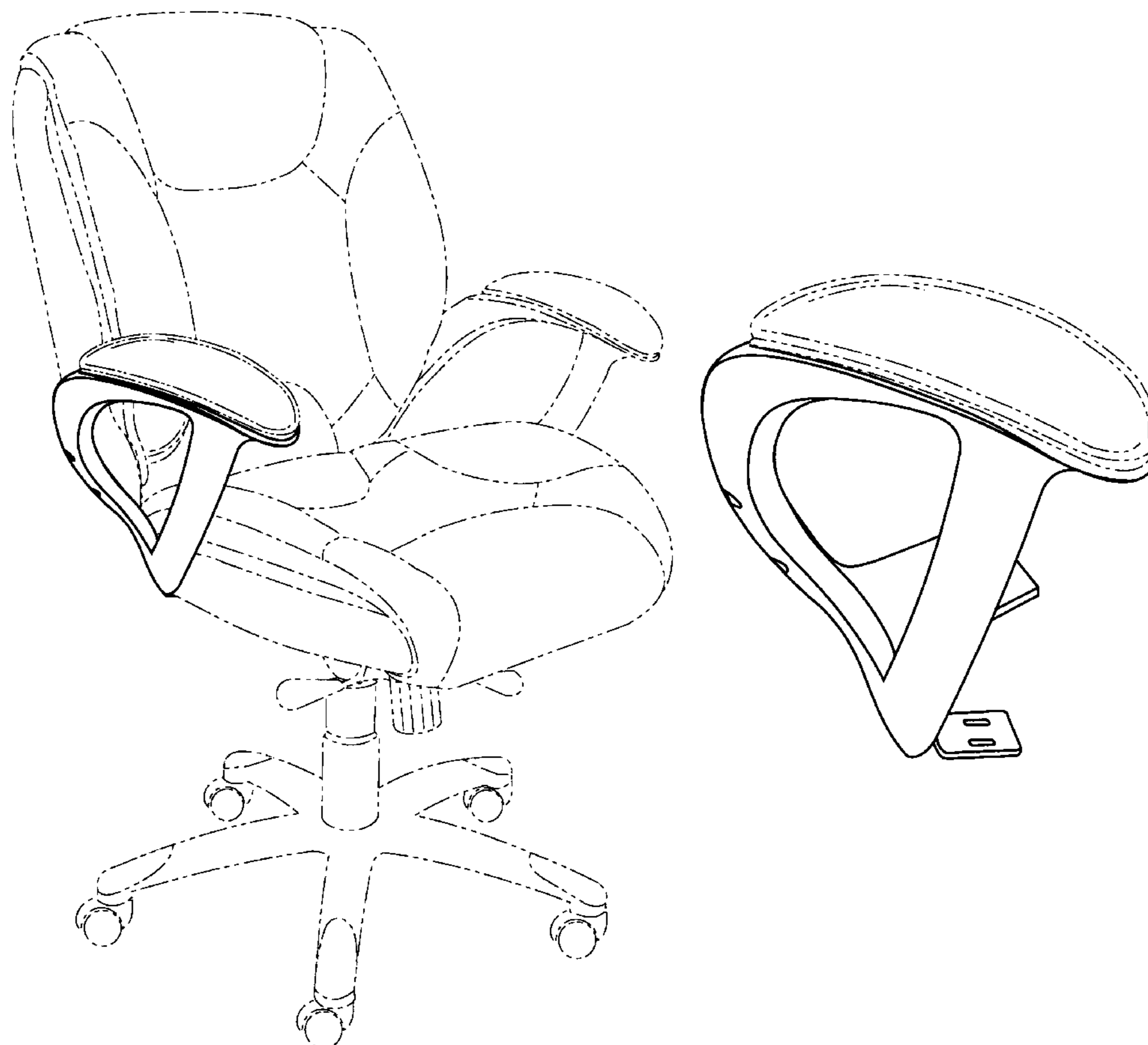
FIG. 5 is an enlarged bottom plan view thereof;

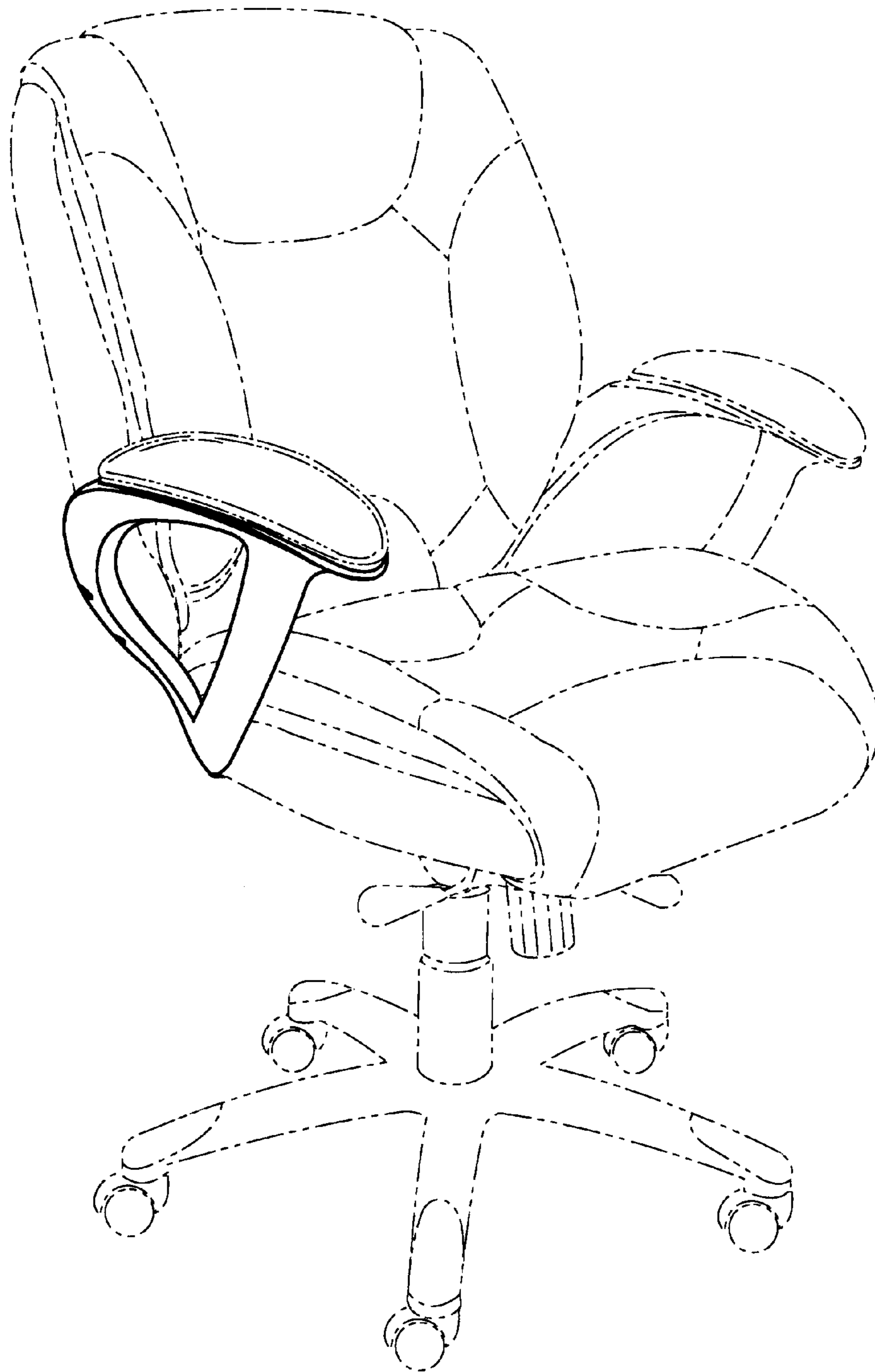

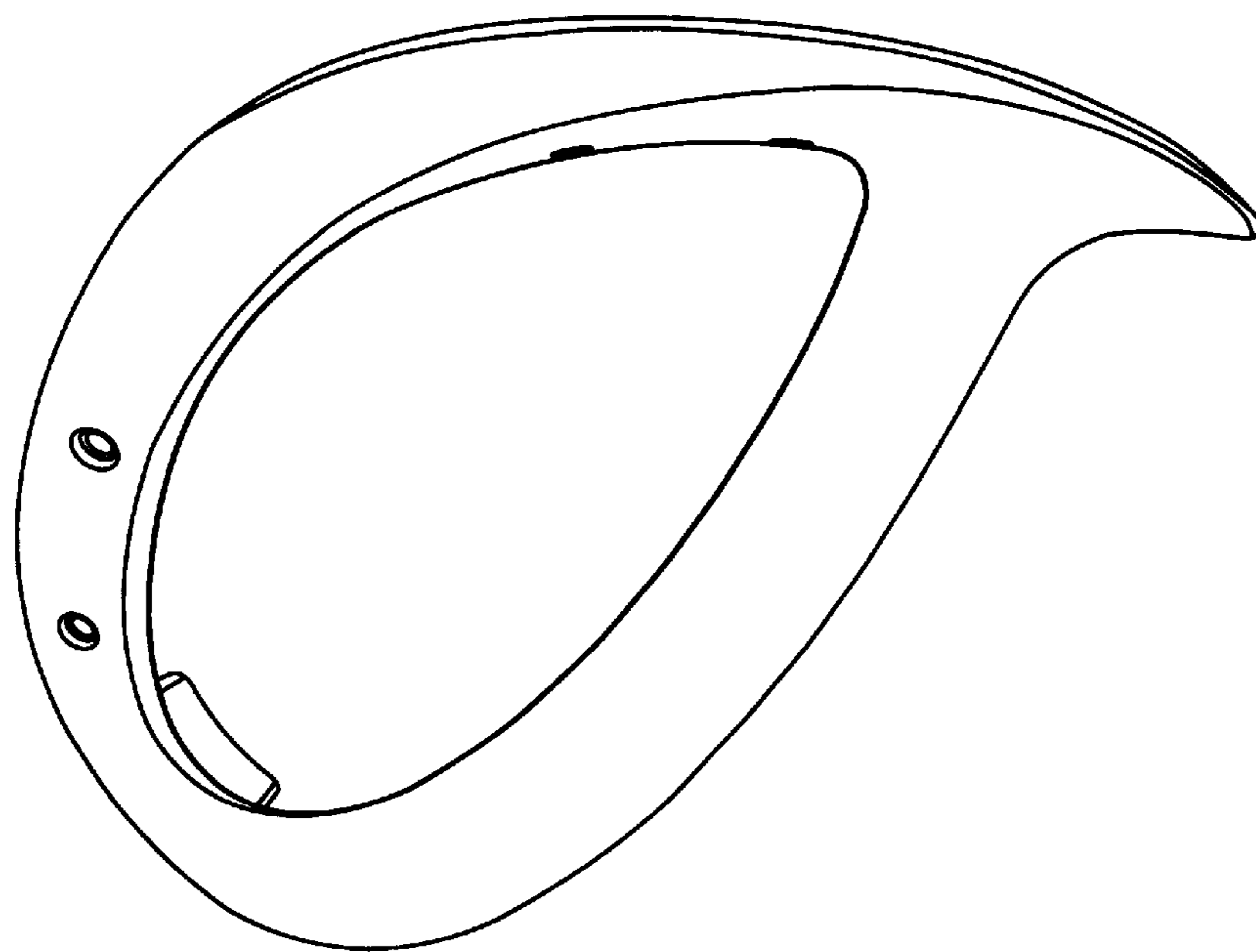

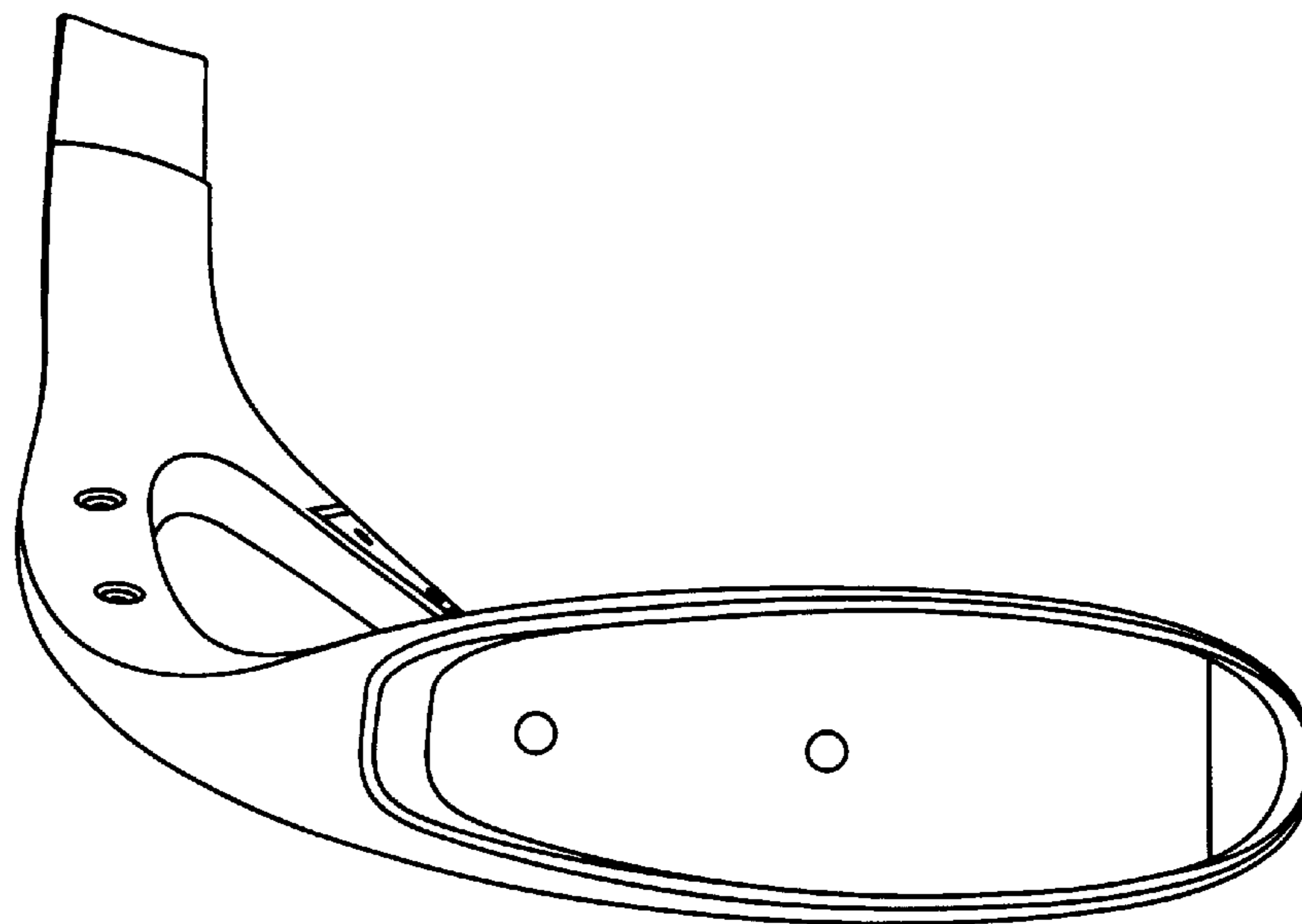

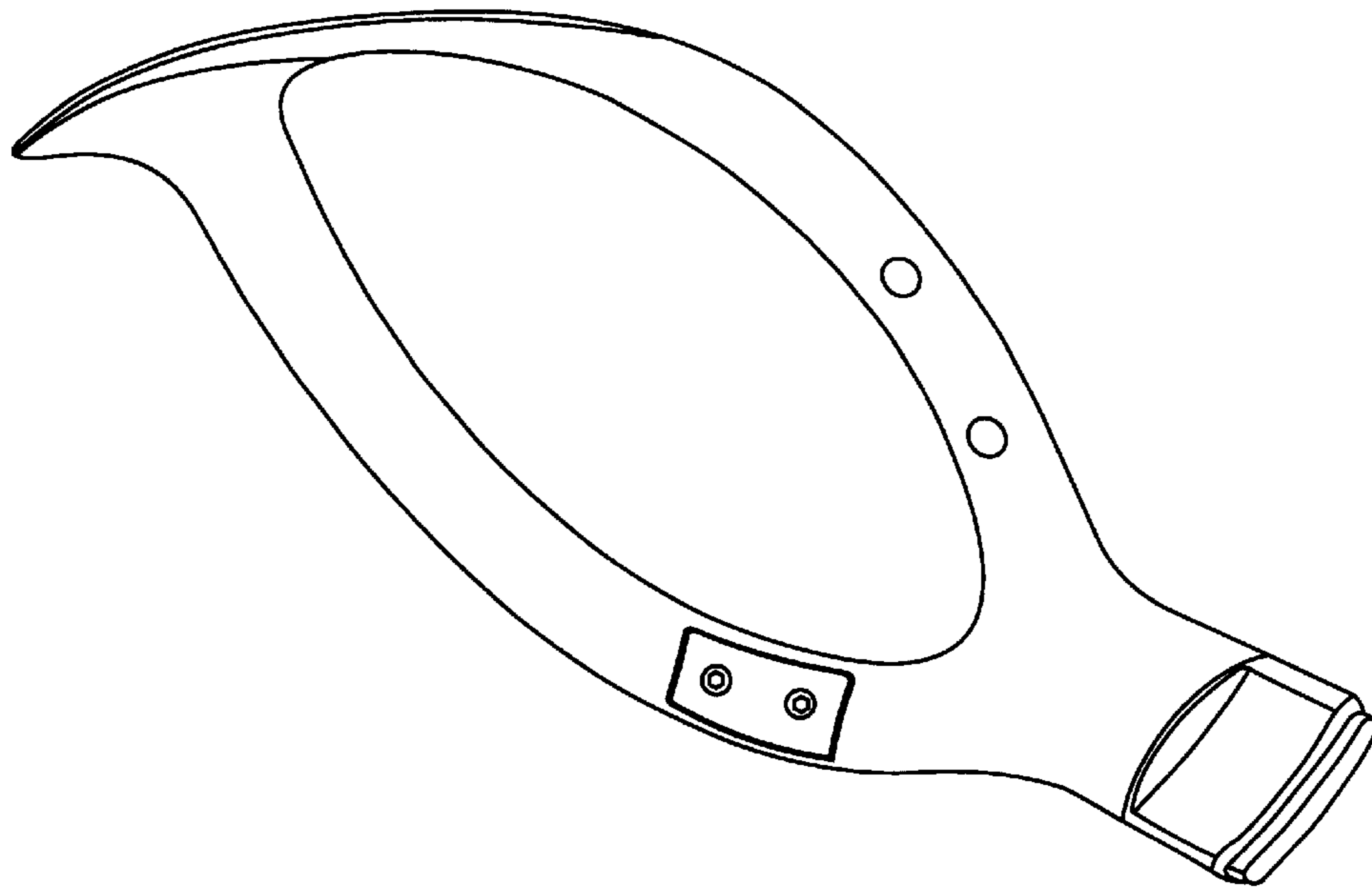

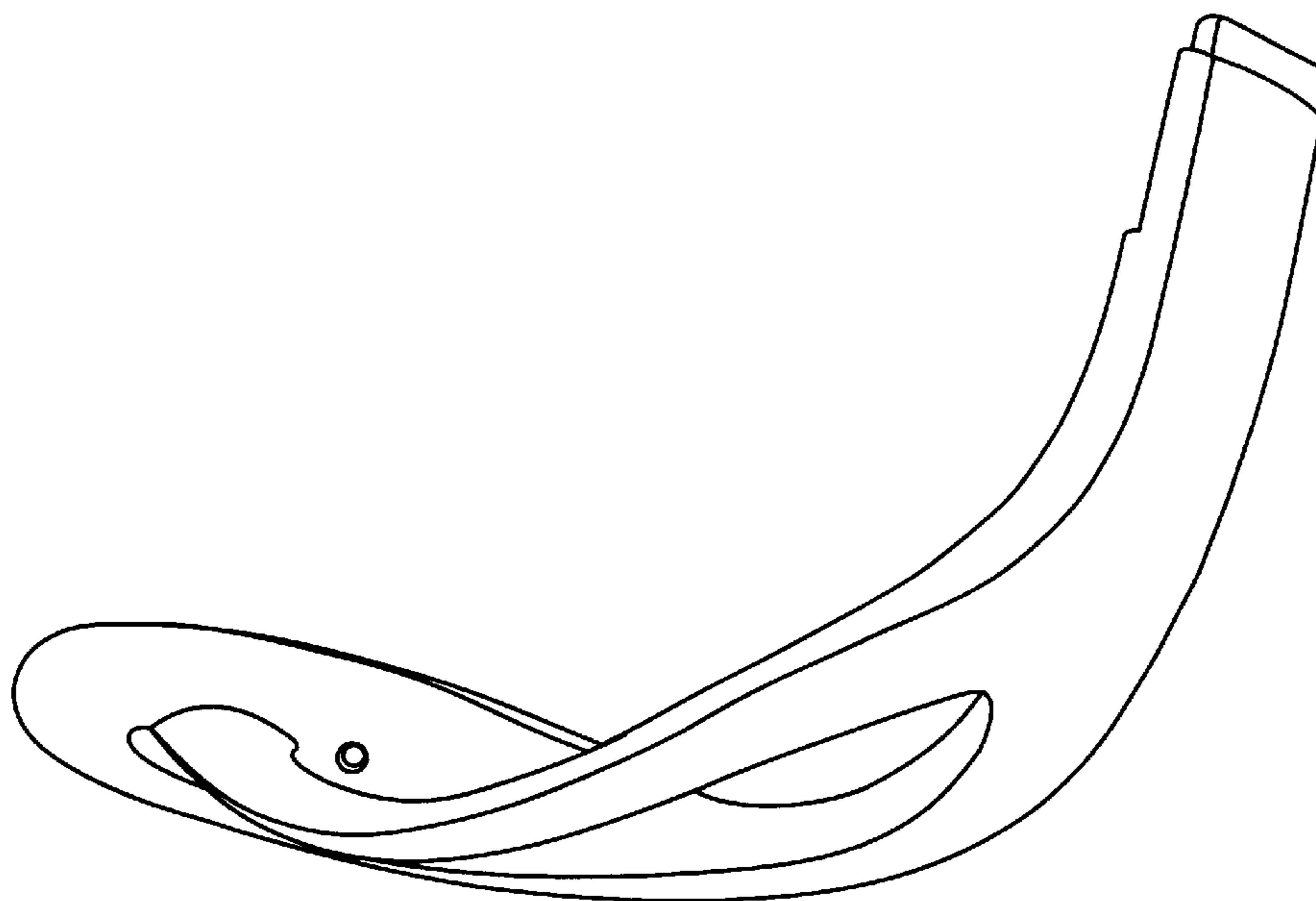

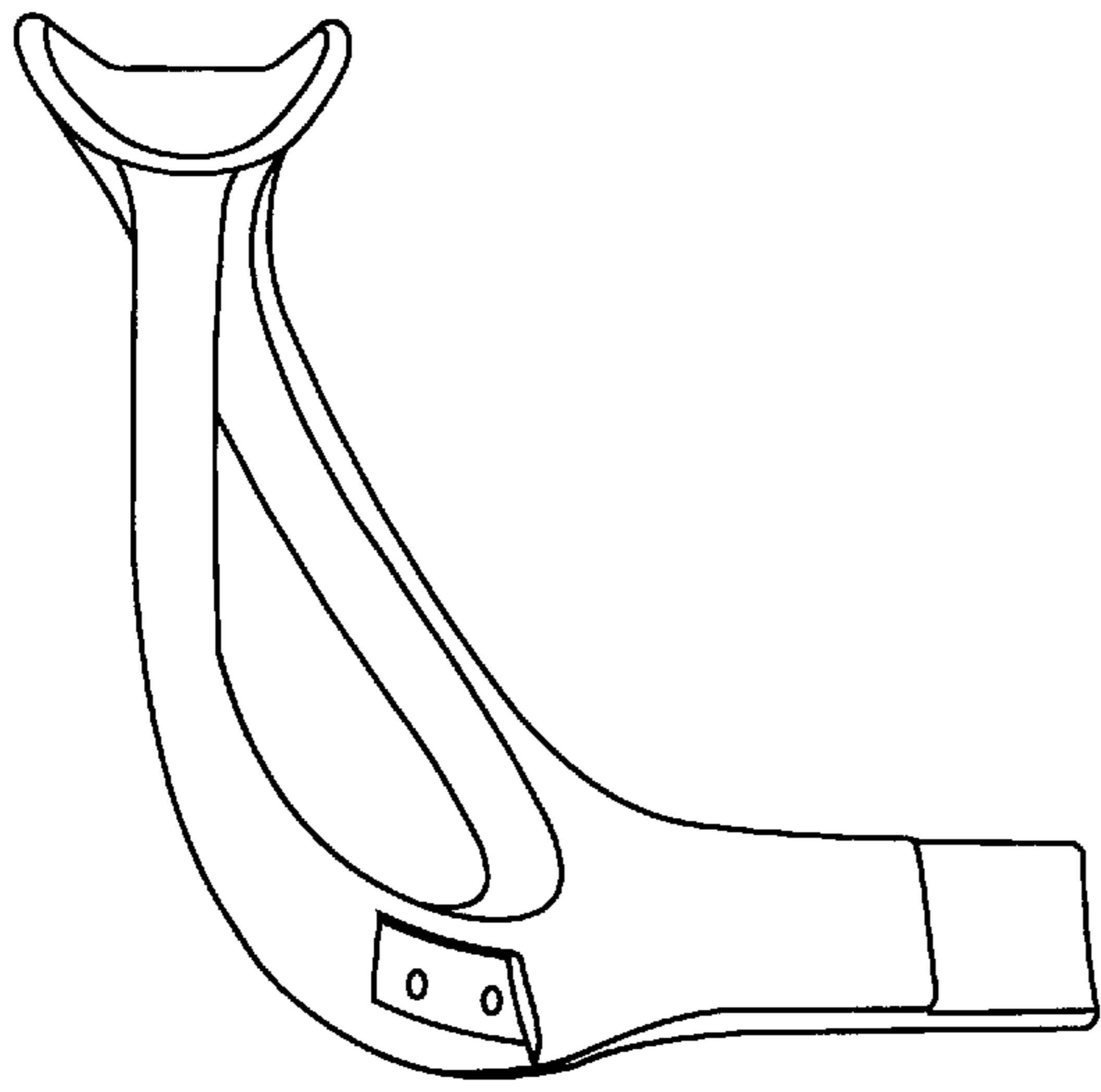

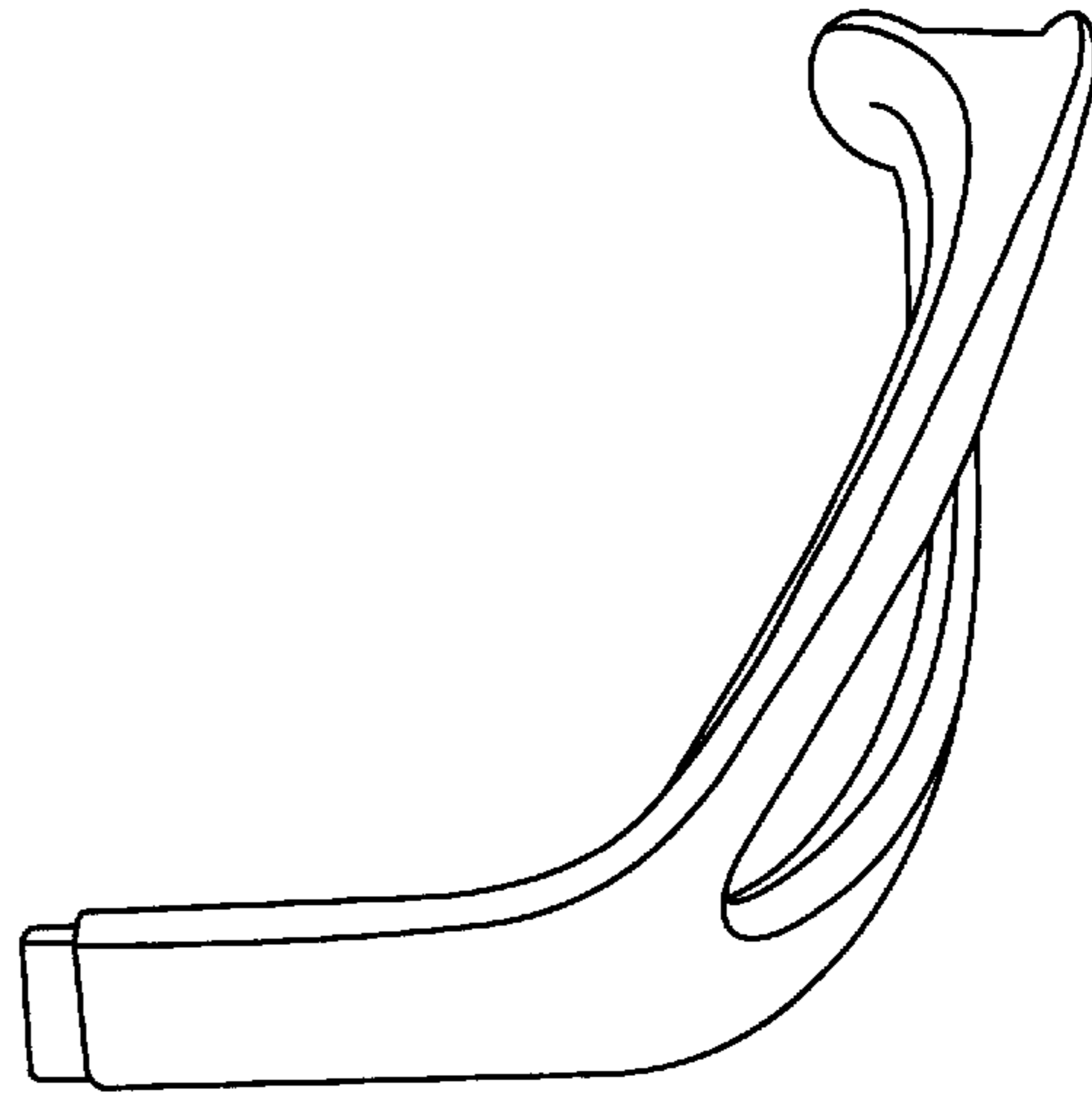

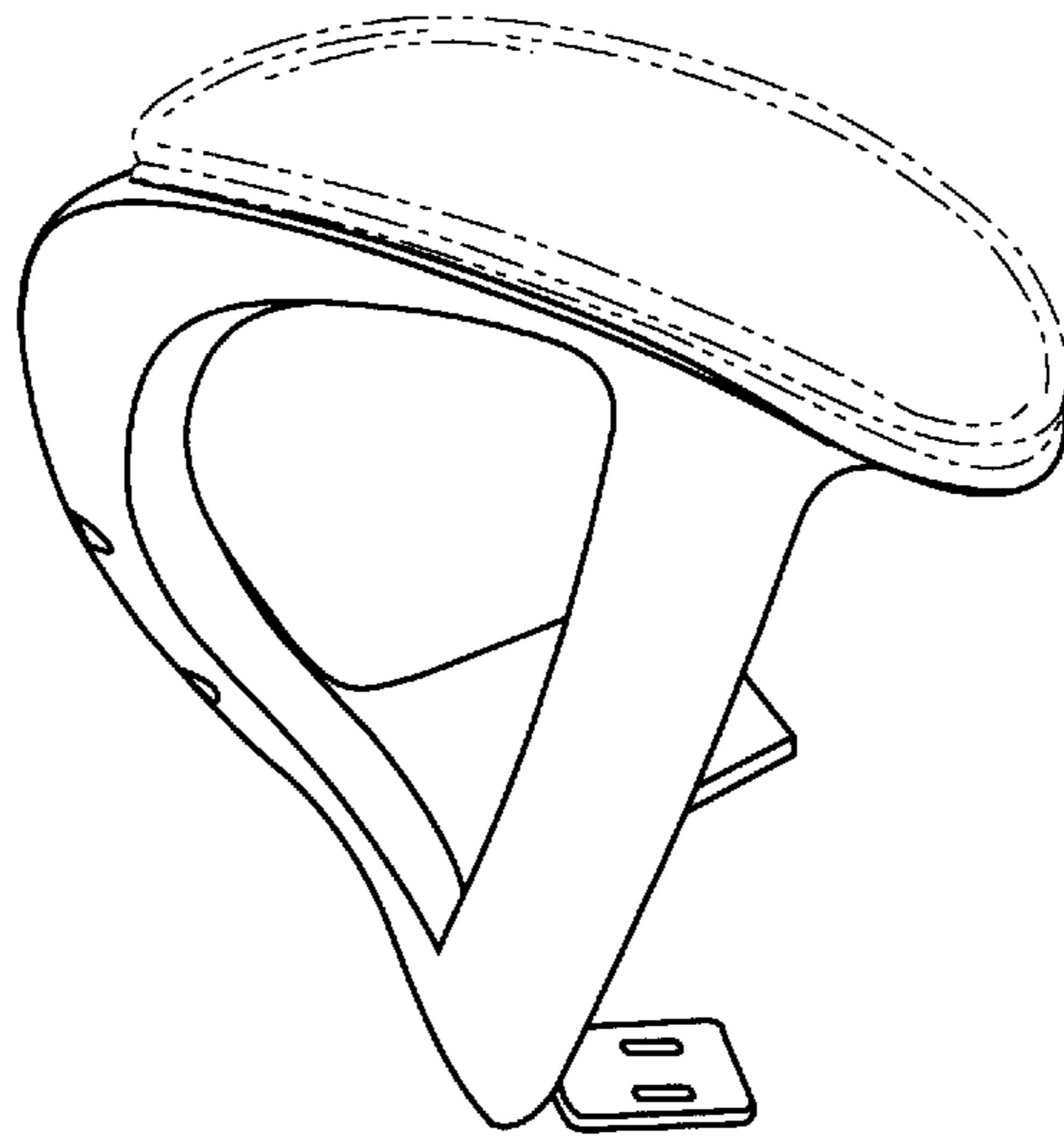
