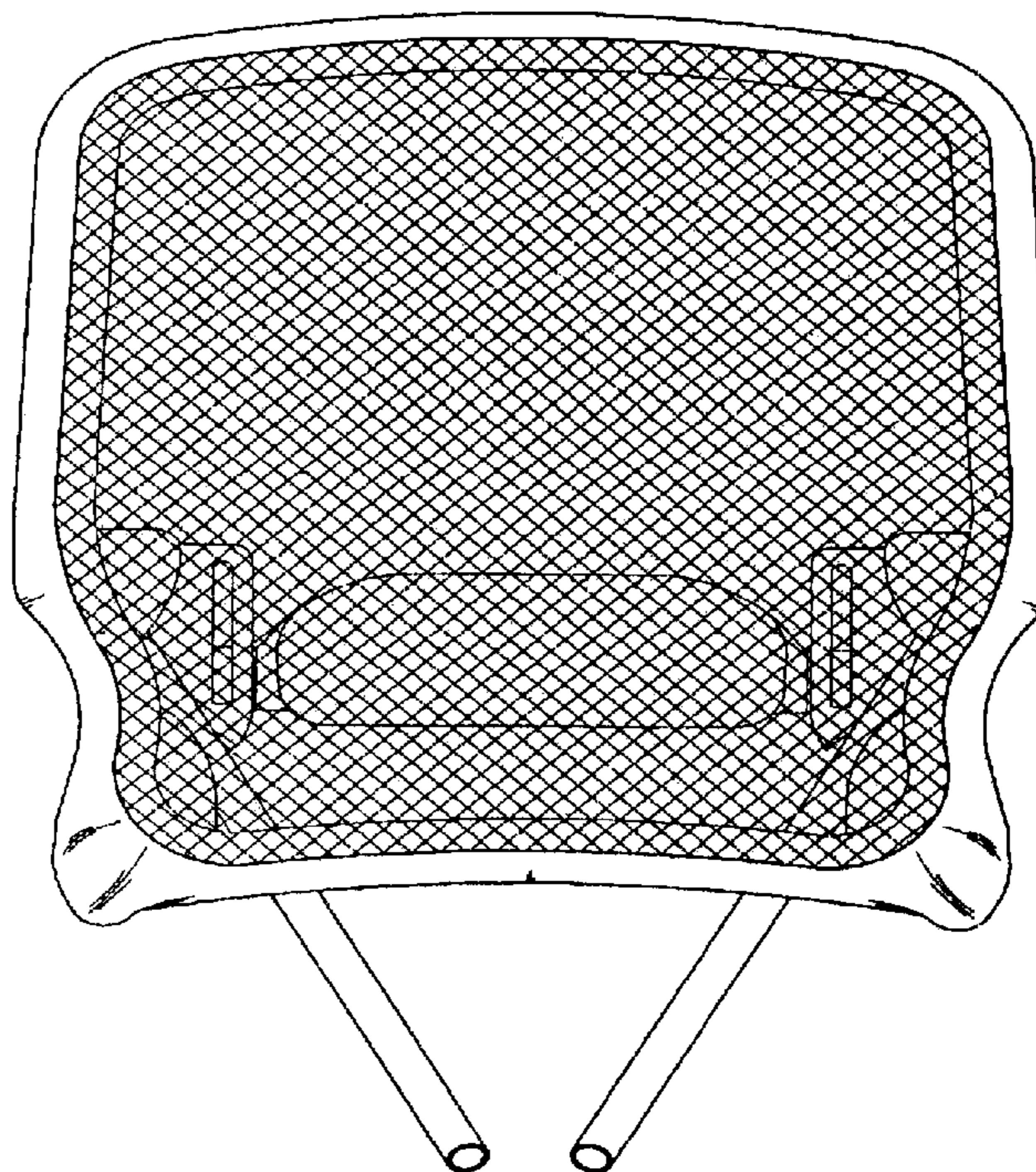
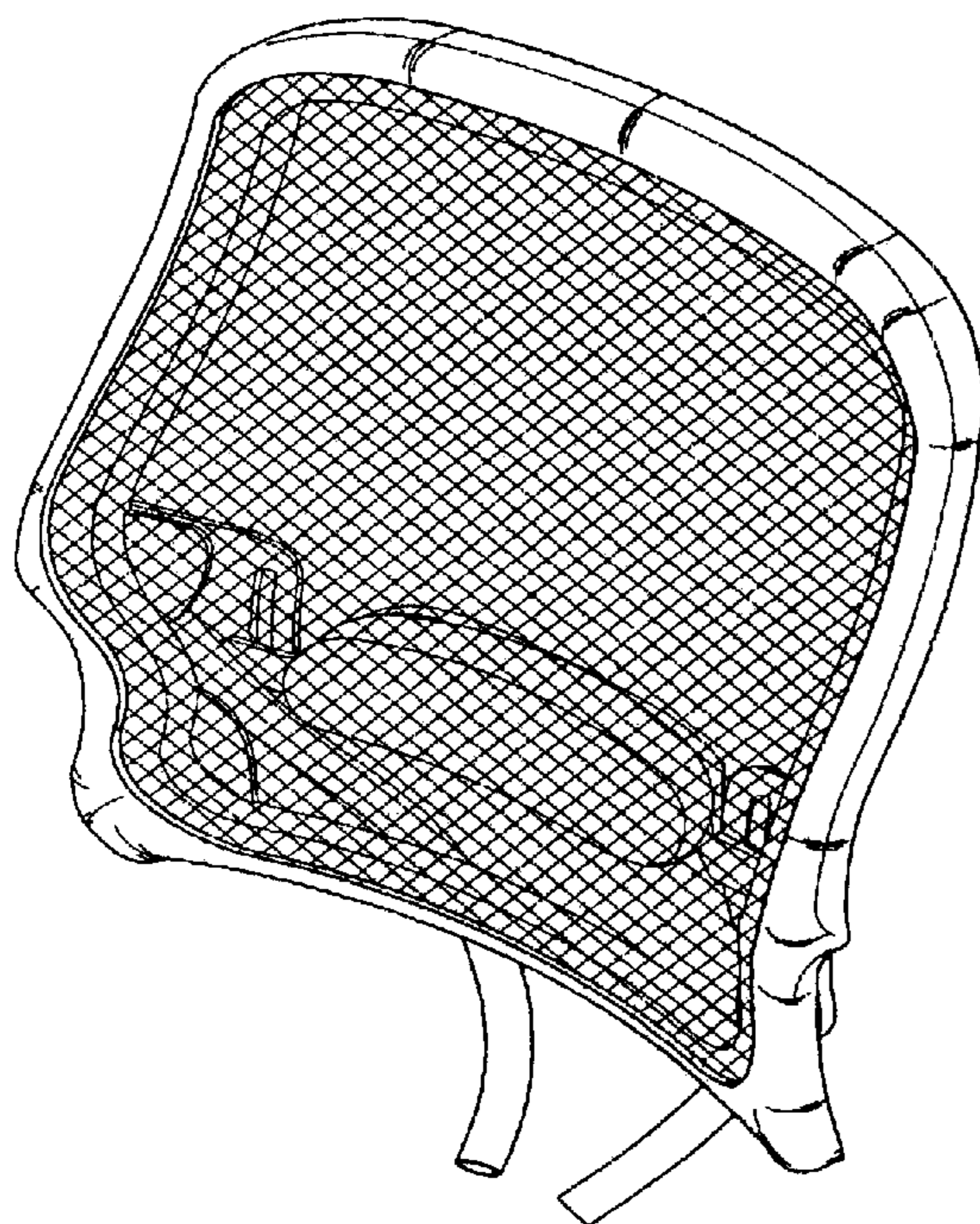

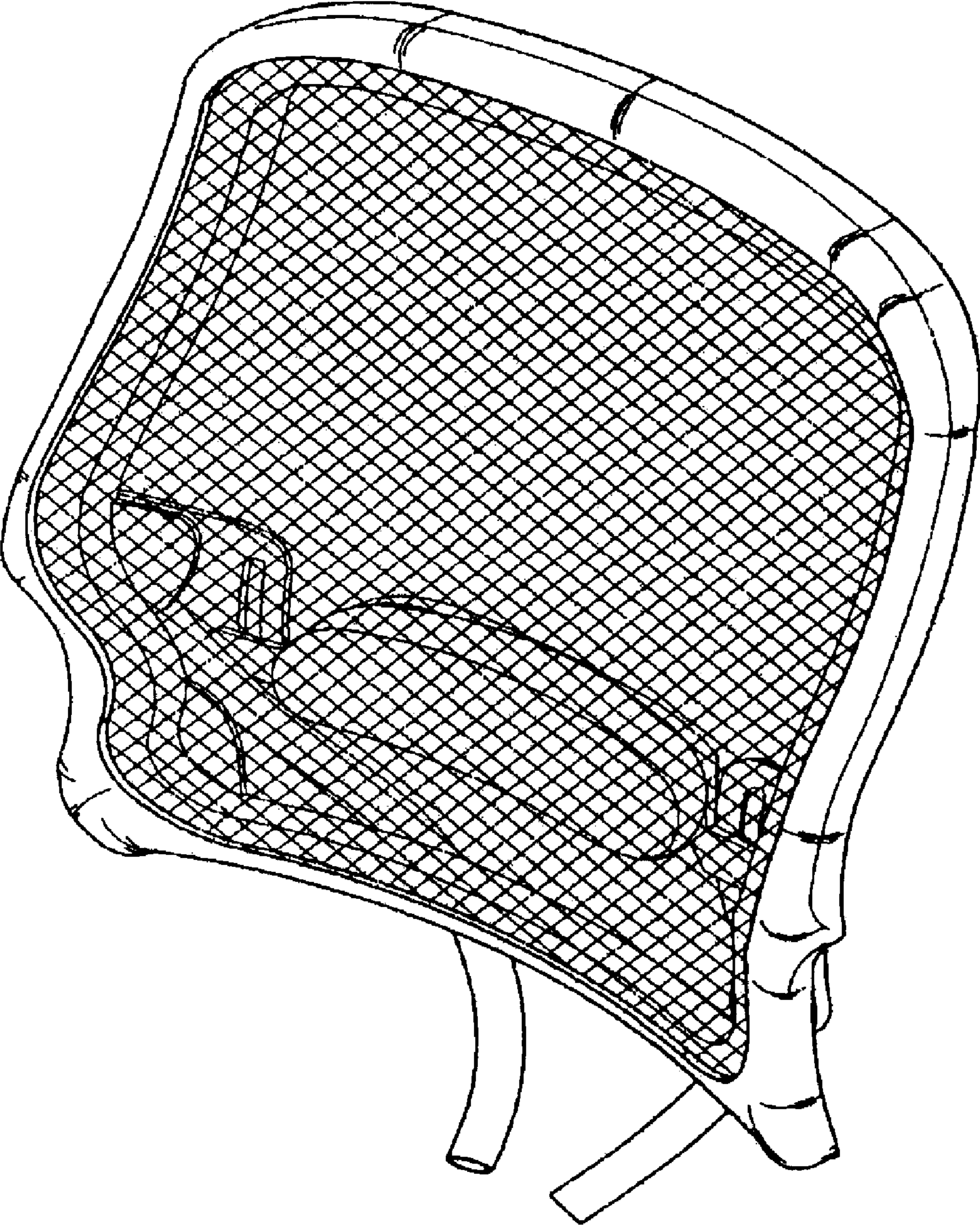
The ornamental design for a chair backrest, as shown.

DESCRIPTION

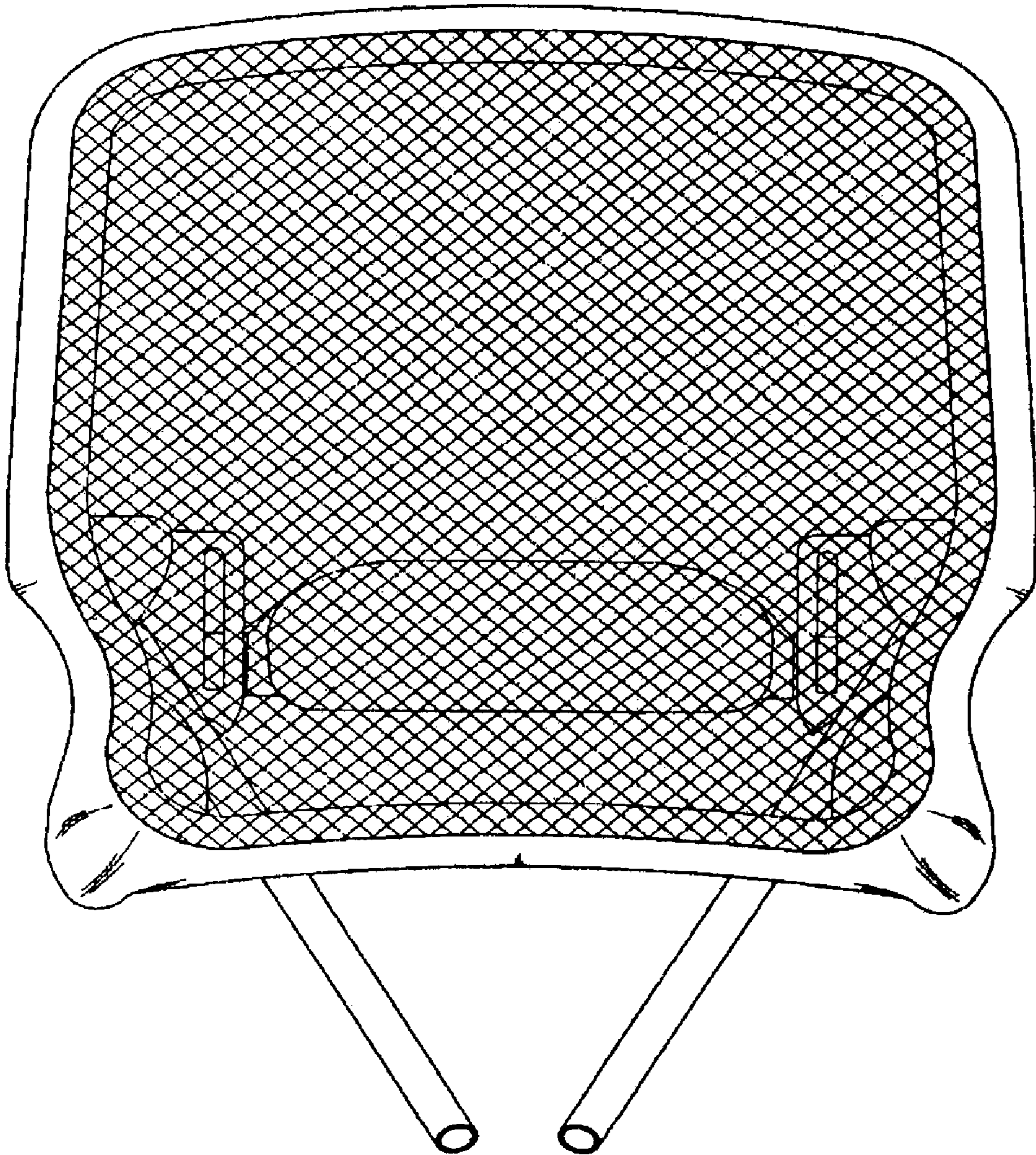
FIG. 1 is a perspective view of a chair backrest showing my new design;

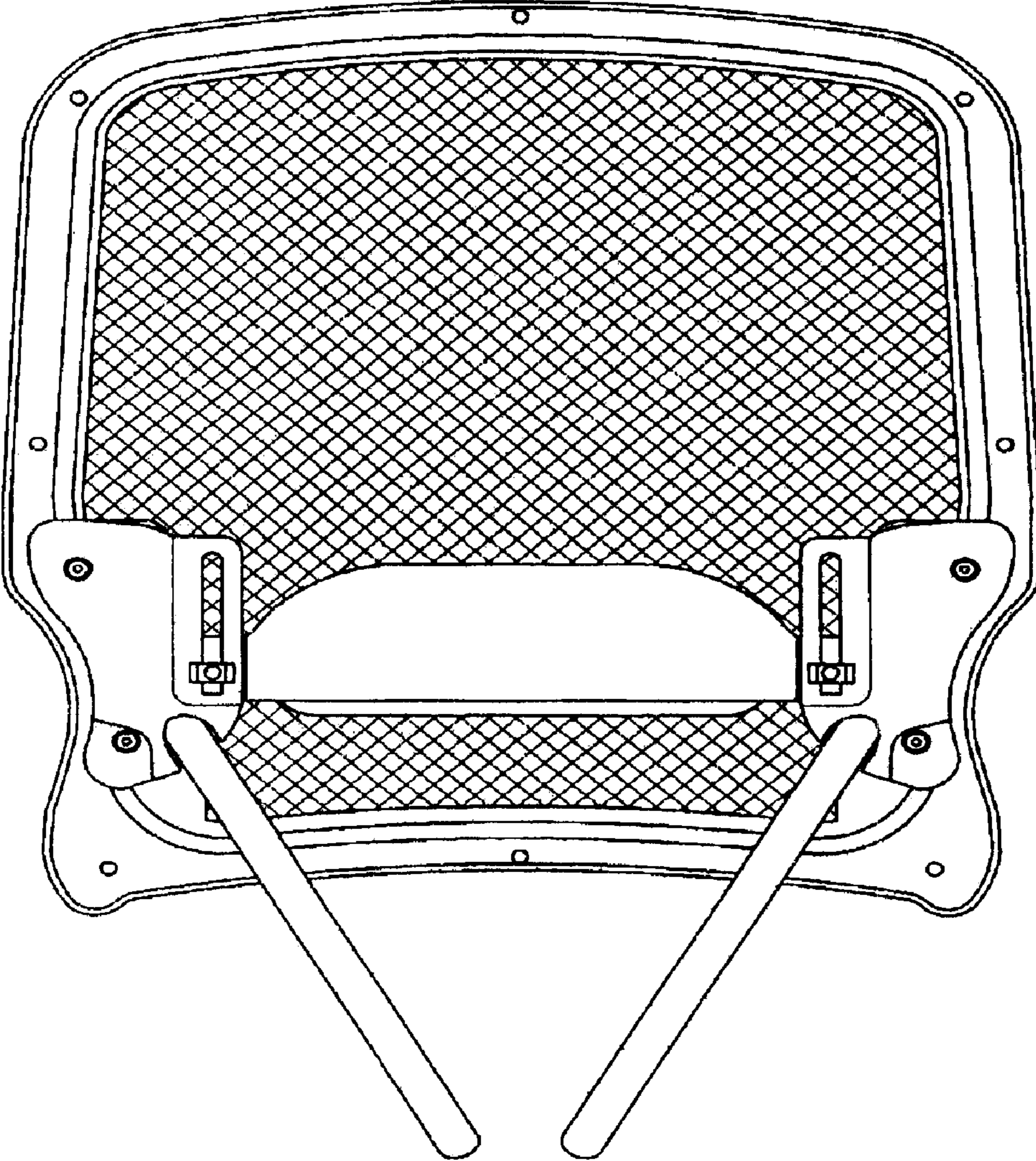




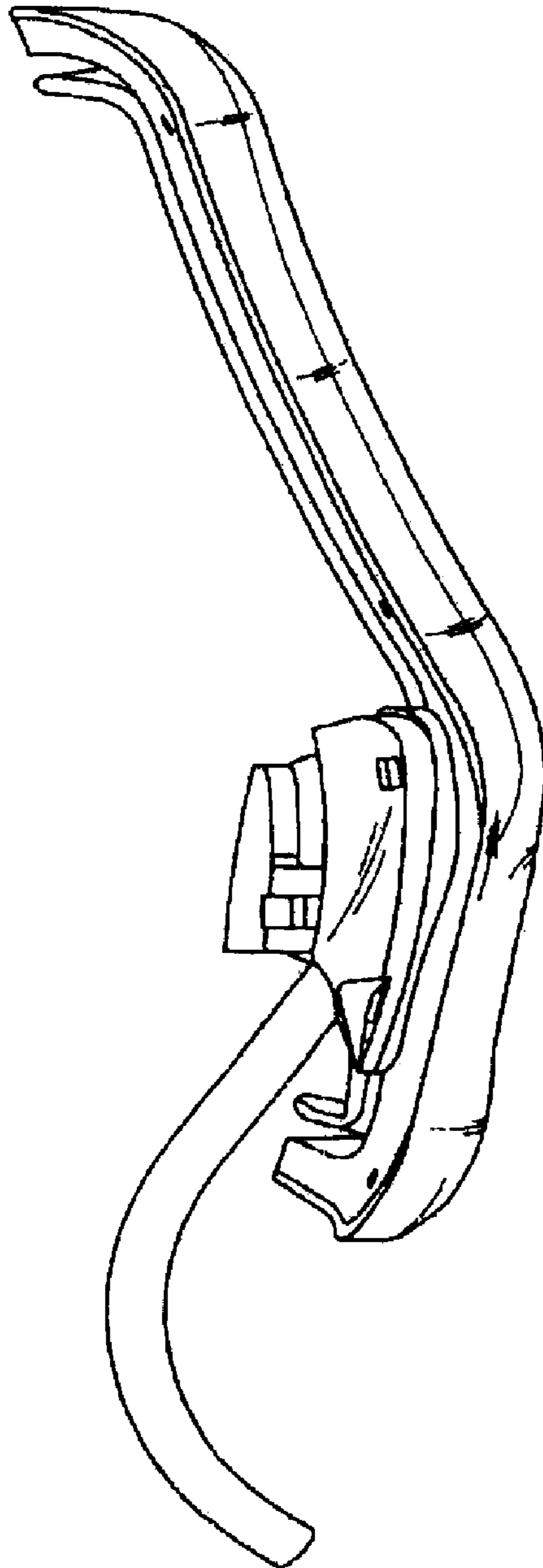

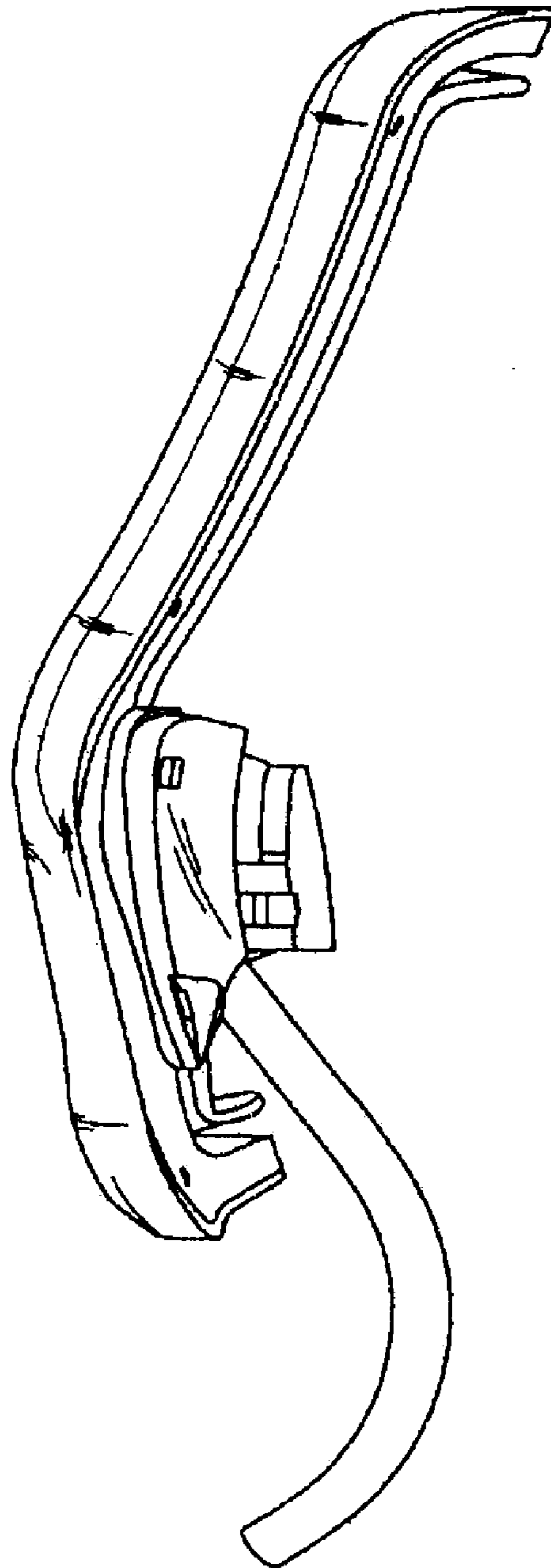
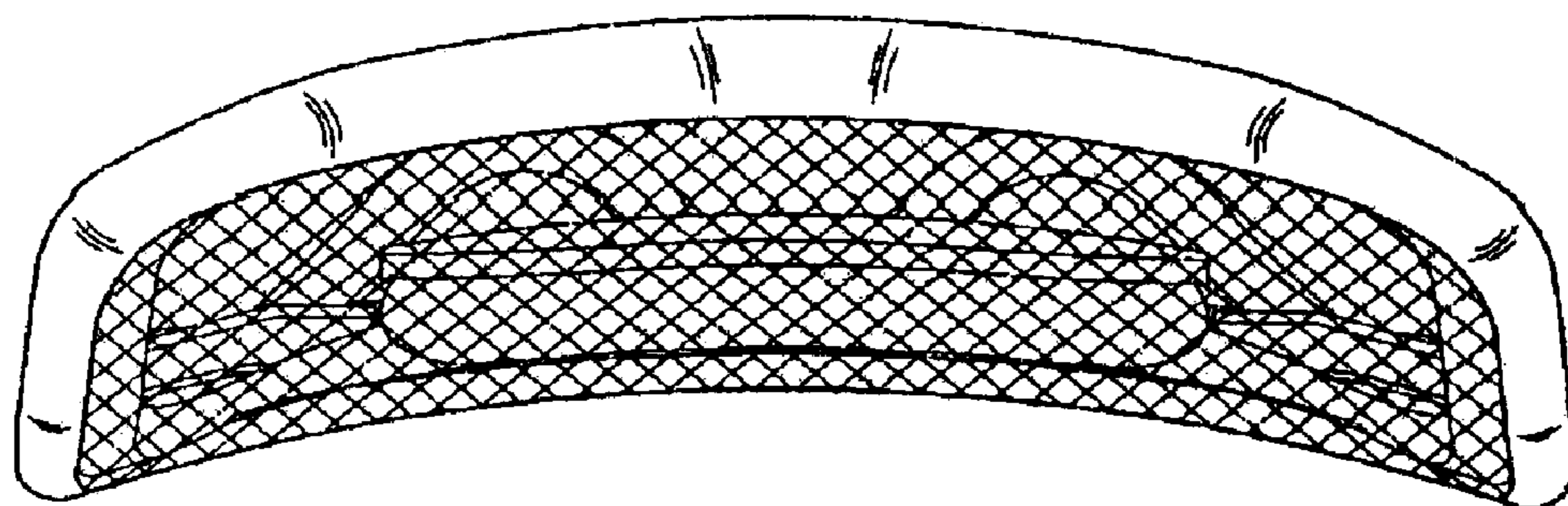
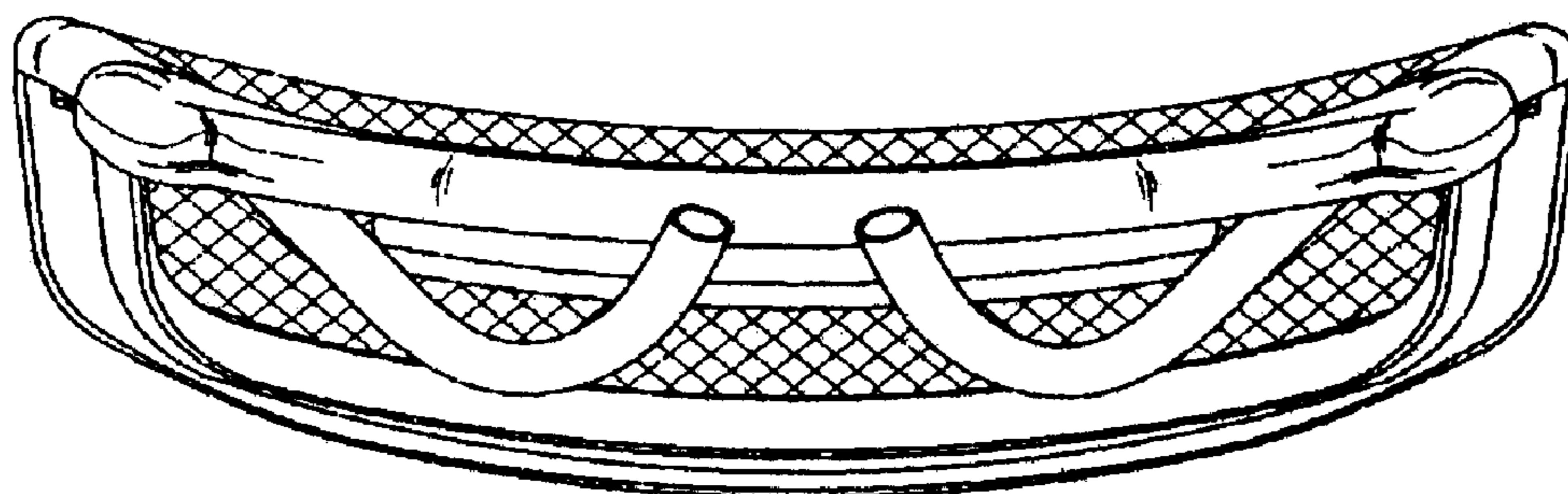
