This application claims relation to U.S. D522,298 S, issued Jun. 6, 2006.

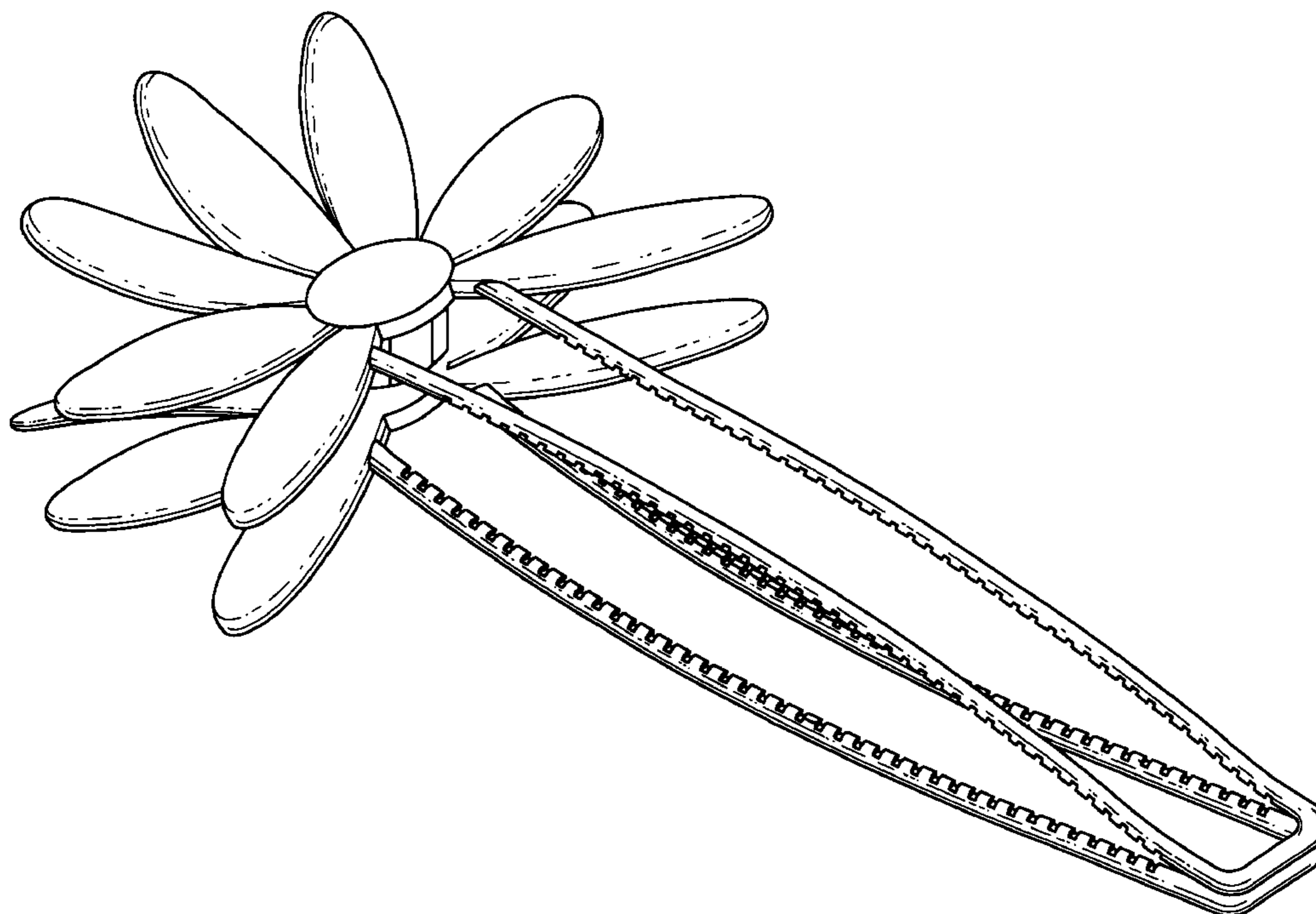
FIG. 1 is a perspective view of the curtain clip showing my new design;

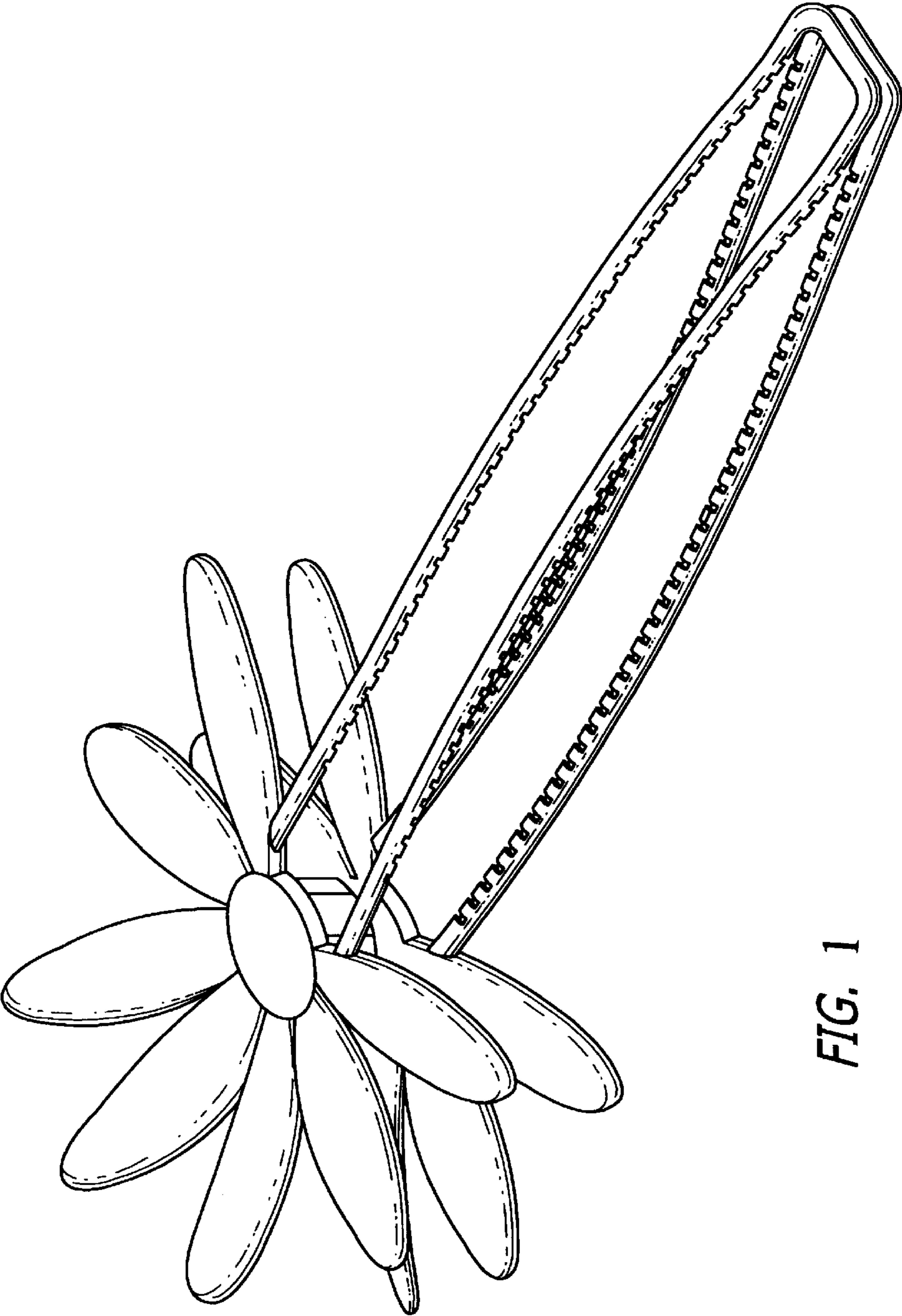

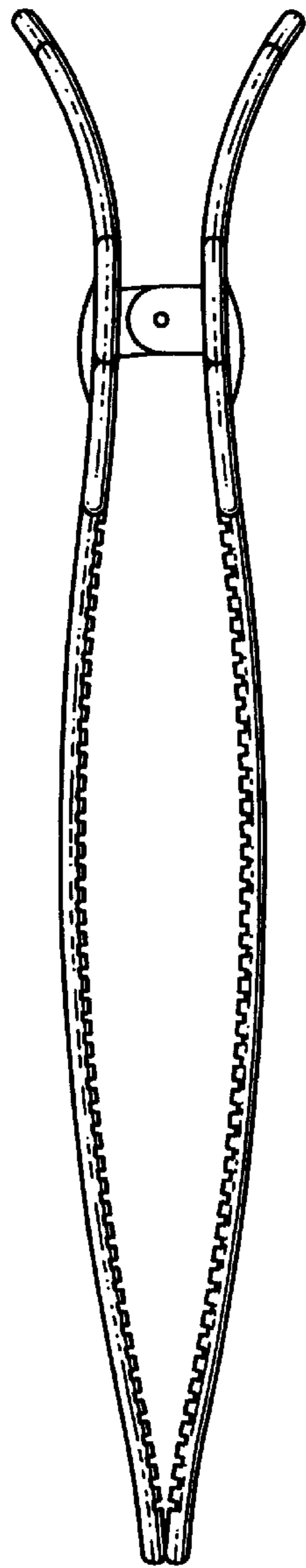

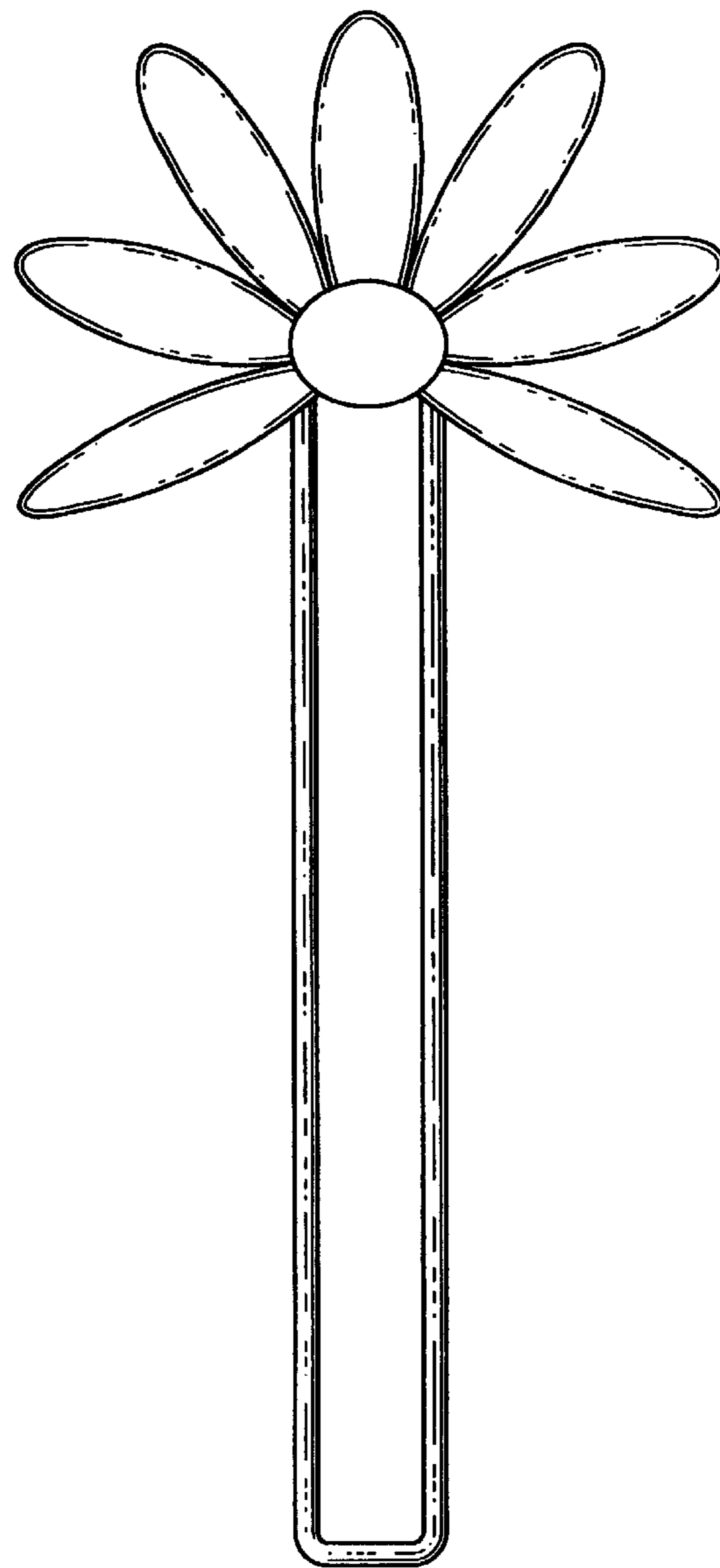
