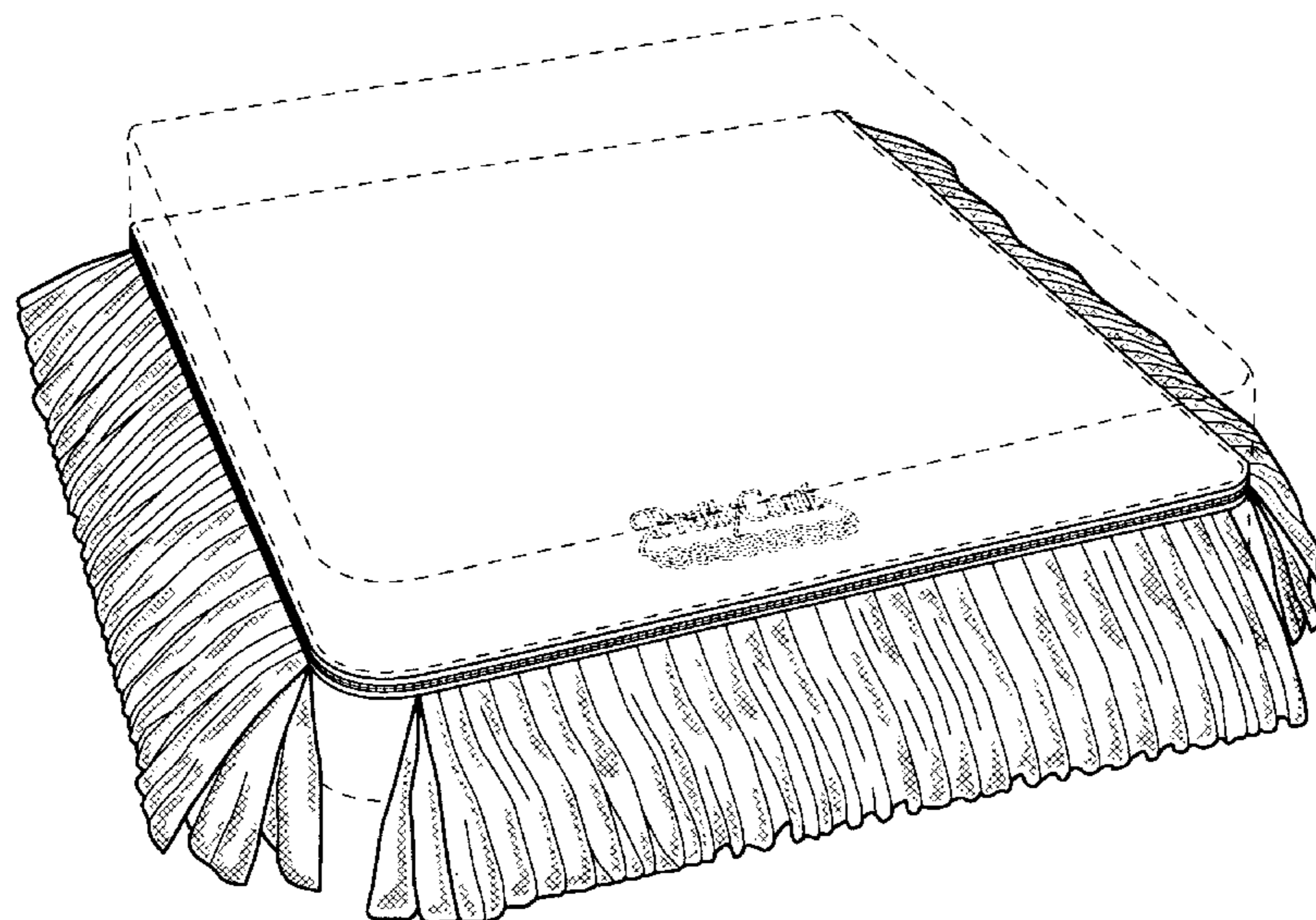
(57) **CLAIM**

I claim the ornamental design for a bed skirt support, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a bed skirt support according to the present invention; FIG. 2 is a front view of the bed skirt support of FIG. 1; FIG. 3 is a back view of the bed skirt support of FIG. 1; FIG. 4 is a right side view of the bed skirt support of FIG. 1; FIG. 5 is a left side view of the bed skirt support of FIG. 1. FIG. 6 is a top view of the bed skirt support of FIG. 1; FIG. 7 is a bottom view of the bed skirt support of FIG. 1; FIG. 8 is a perspective view of a second embodiment of a bed skirt support of the present invention; FIG. 9 is a front view of the bed skirt support of FIG. 8; FIG. 10 is a back view of the bed skirt support of FIG. 8; FIG. 11 is a right side view of the bed skirt support of FIG. 8, the left side view being a mirror image thereof; FIG. 12 is a top view of the bed skirt support of FIG. 8; and, FIG. 13 is a bottom view of the bed skirt support of FIG. 8. The broken lines included in FIGS. 1 and 8 illustrate a mattress and/or a box spring and form no part of the claimed design. The broken lines in the remaining figures illustrate a central portion of the bed skirt support and a zipper pull and likewise form no part of the claimed design.

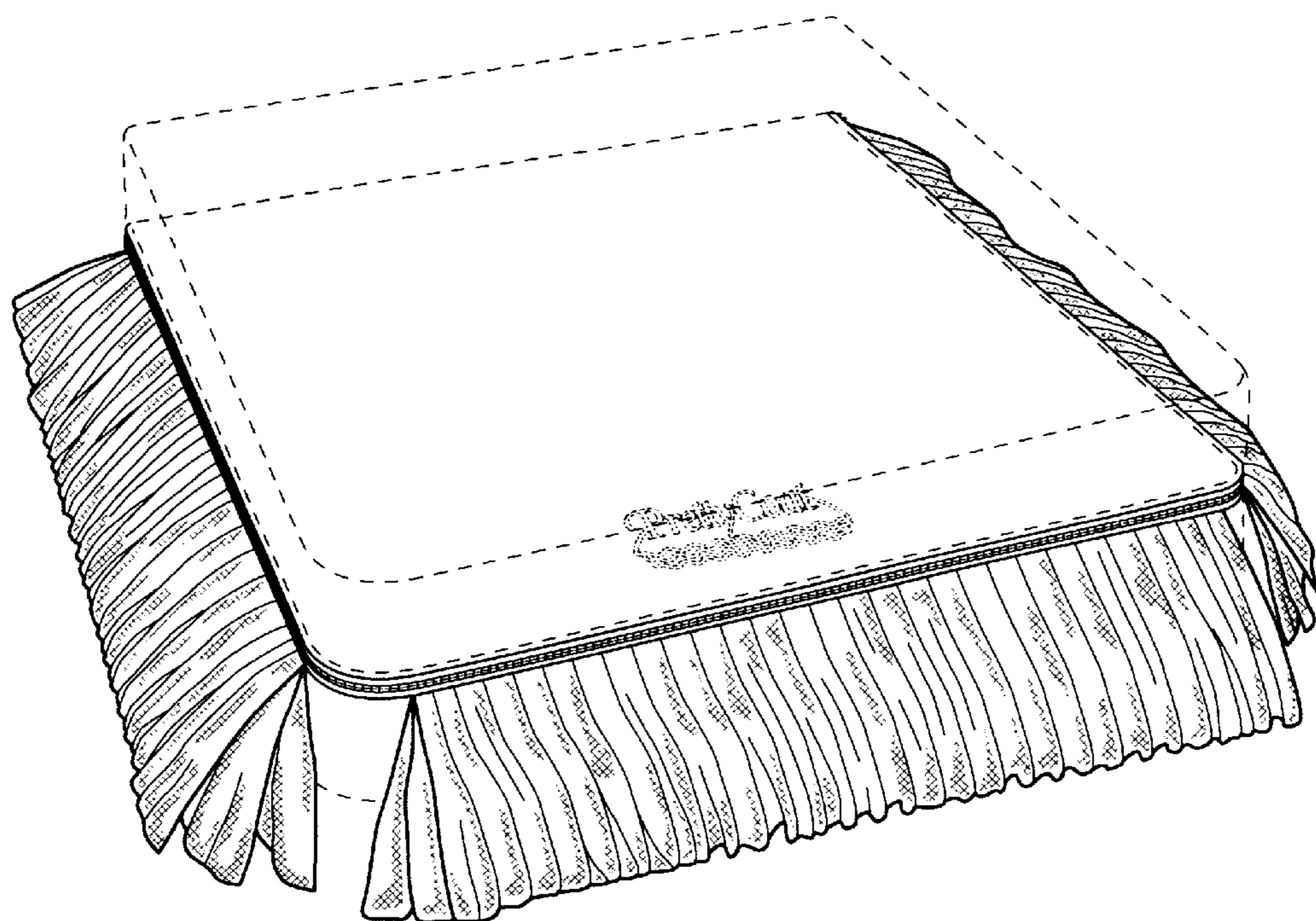

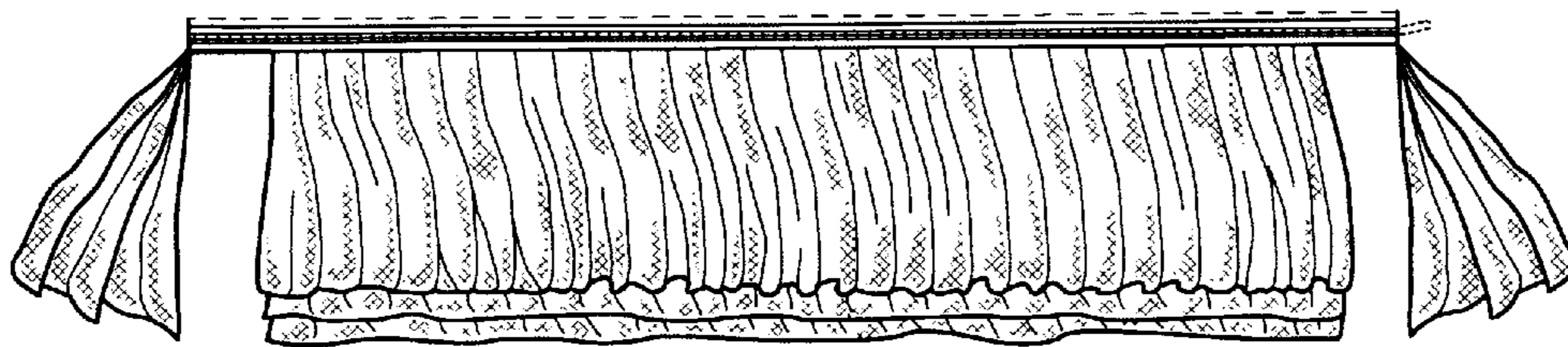

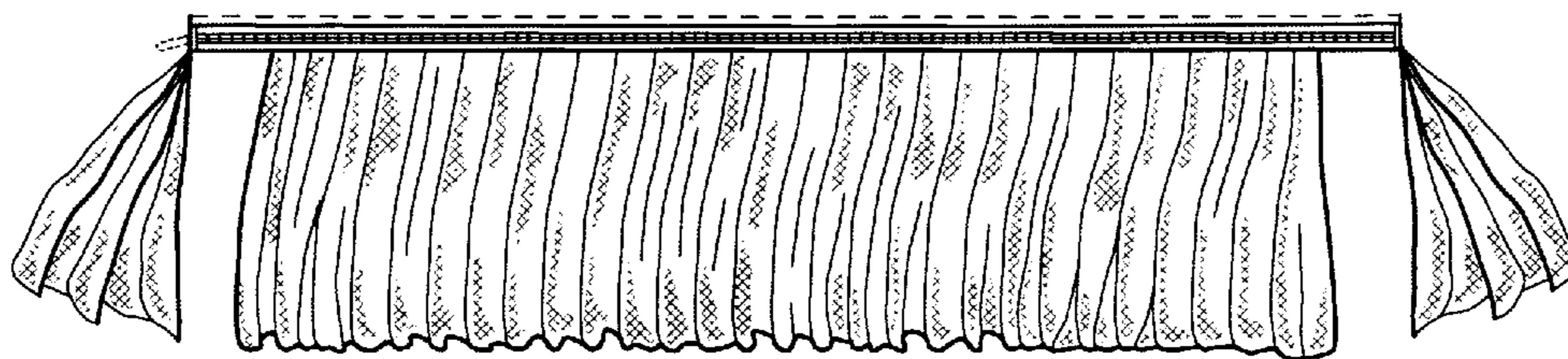

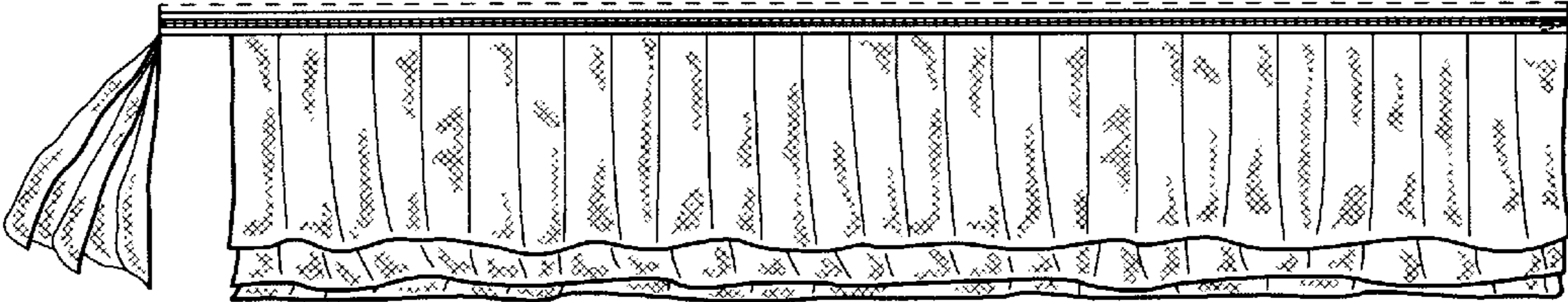

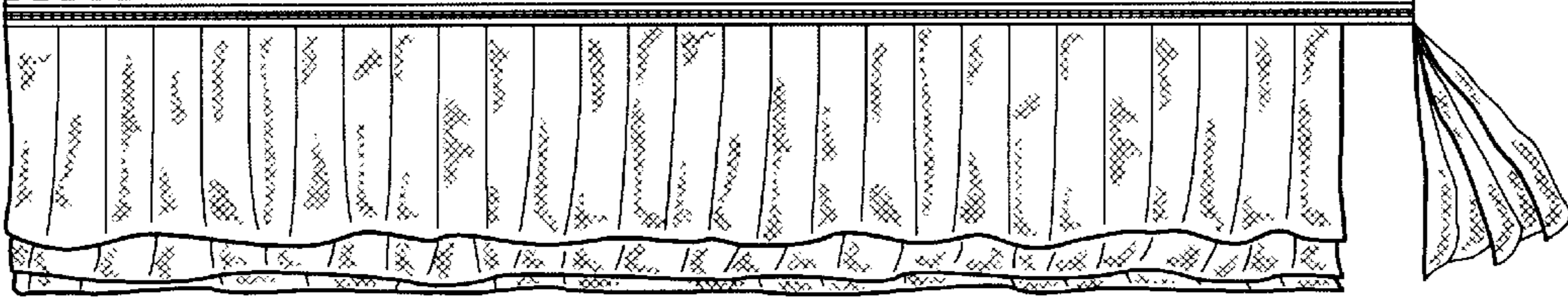

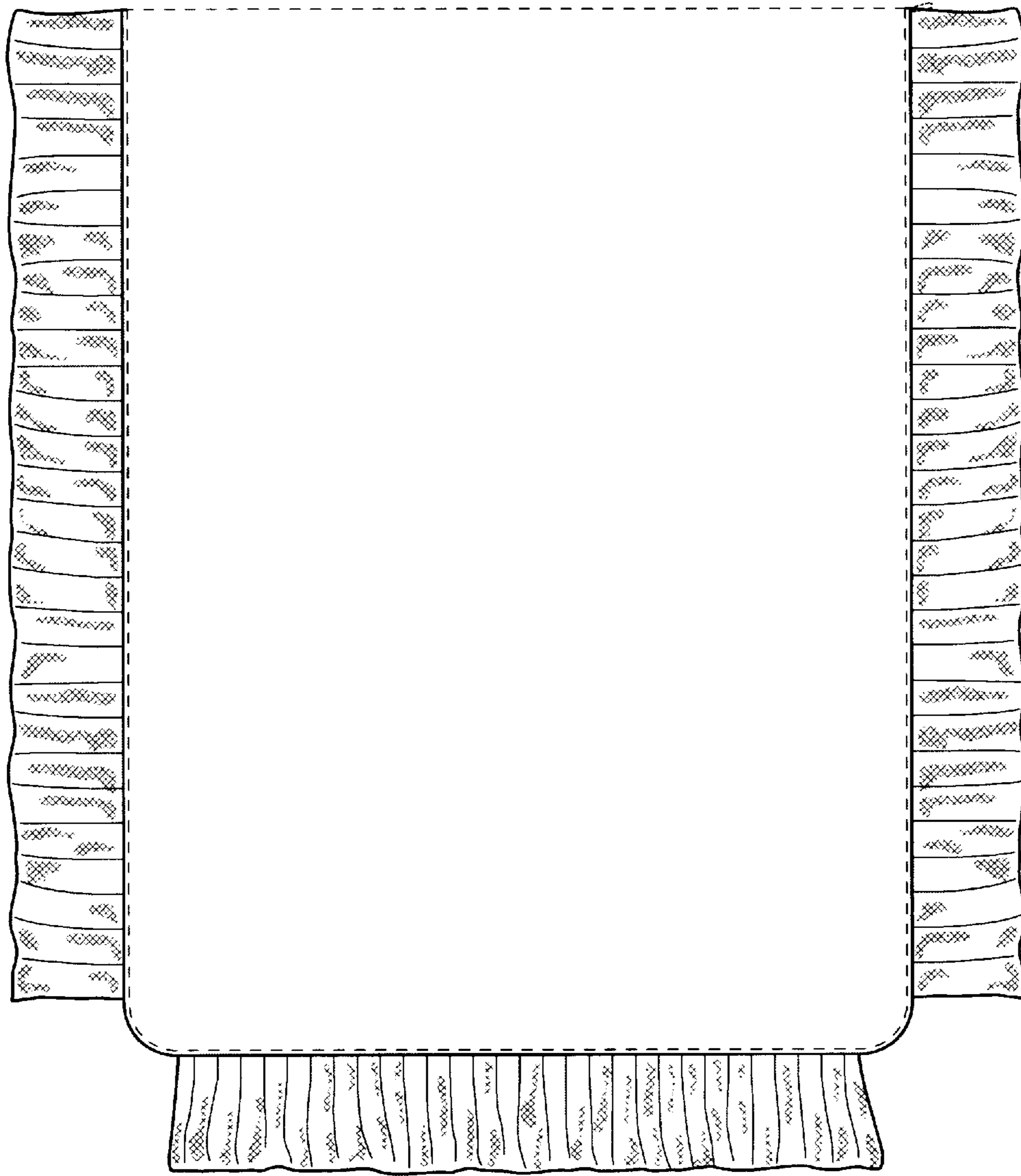

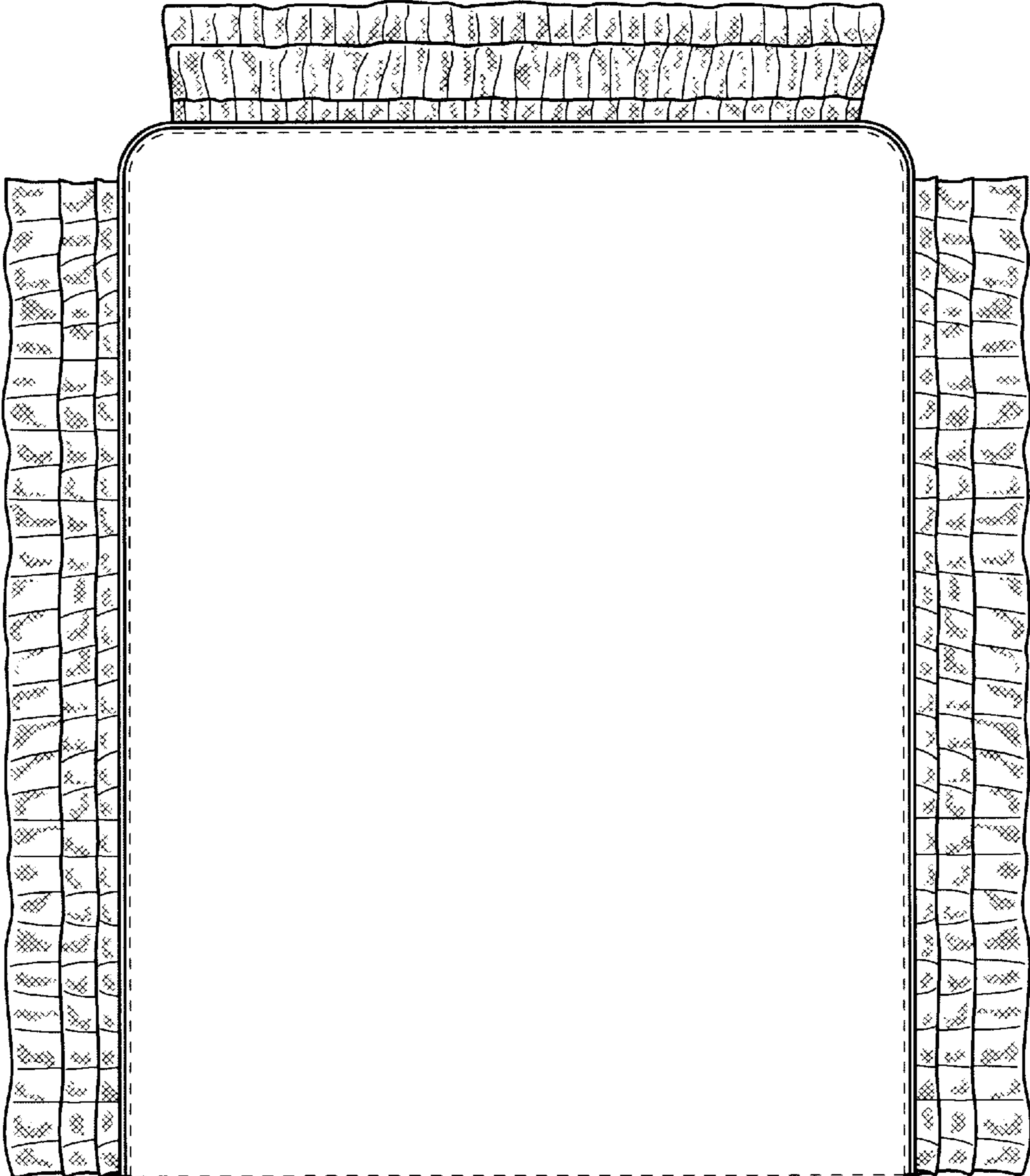

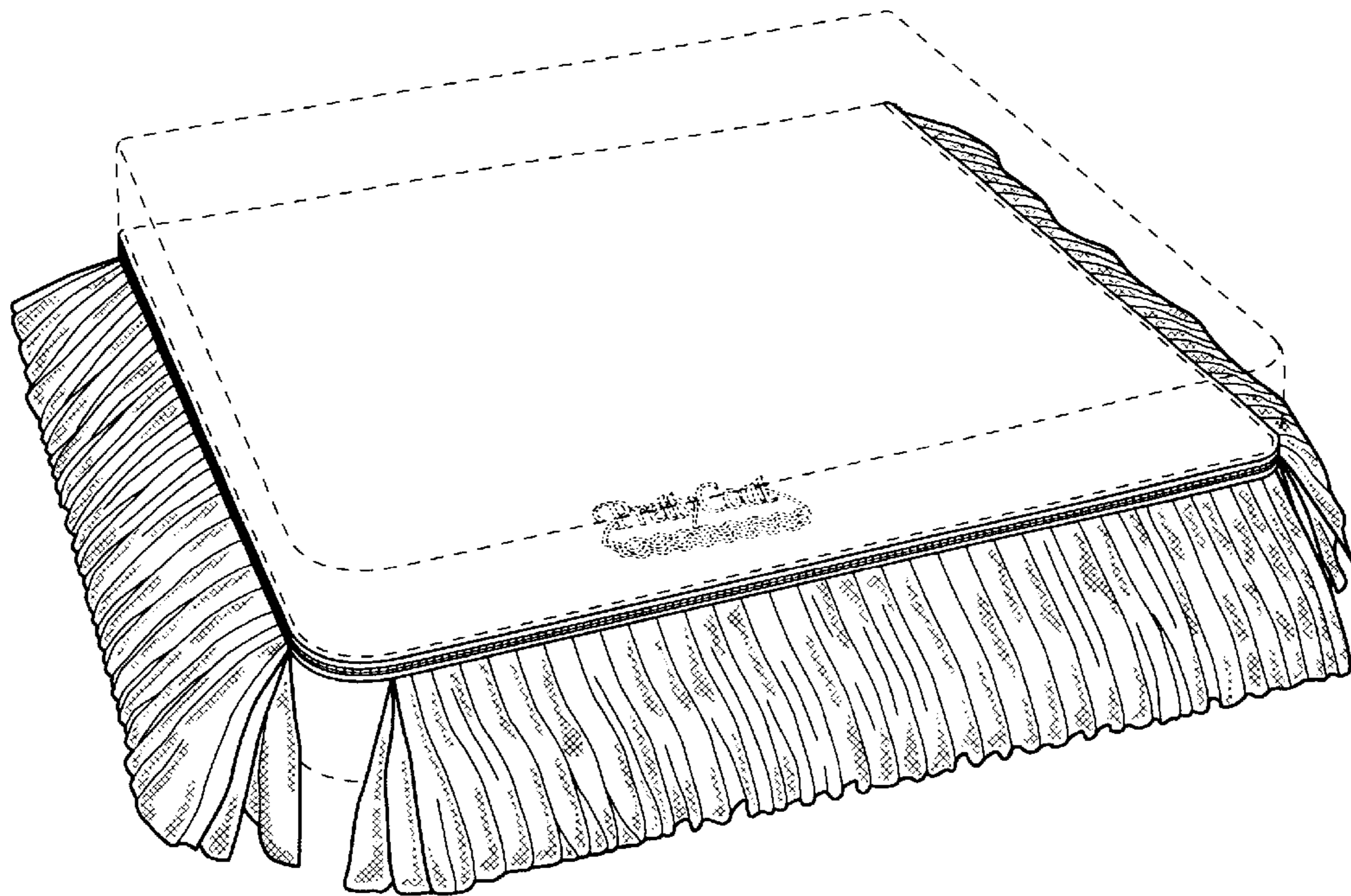

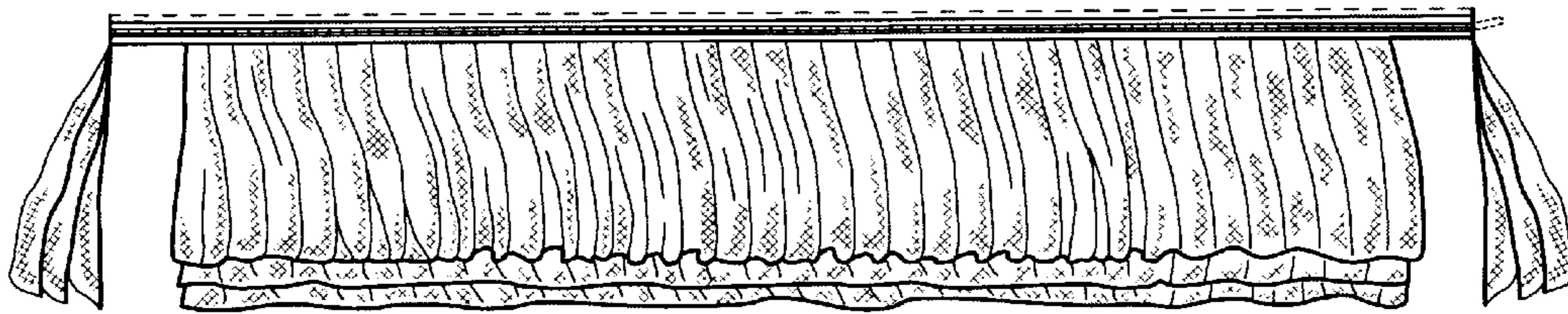

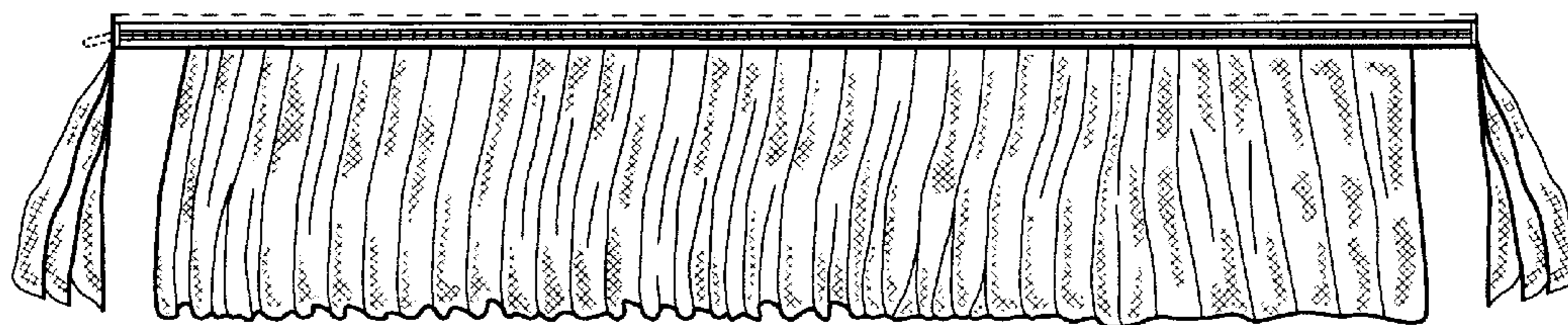

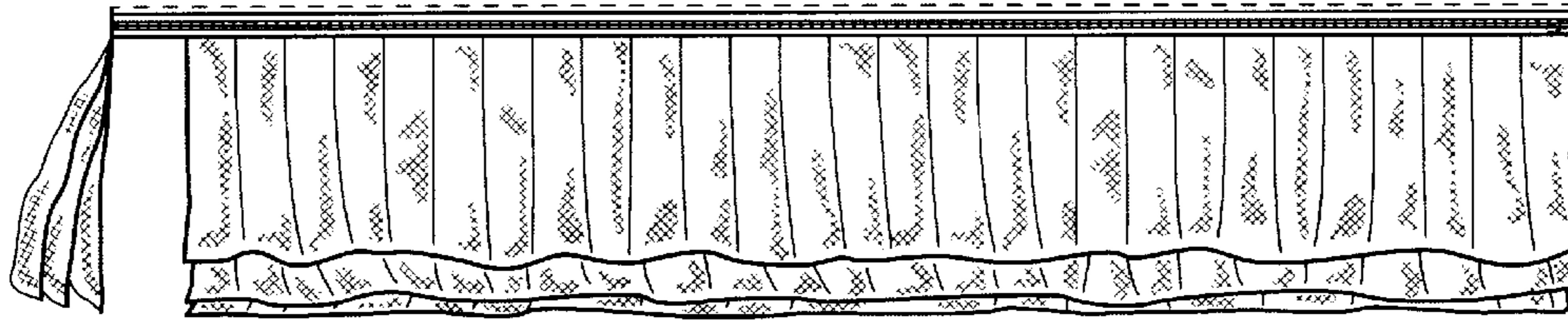

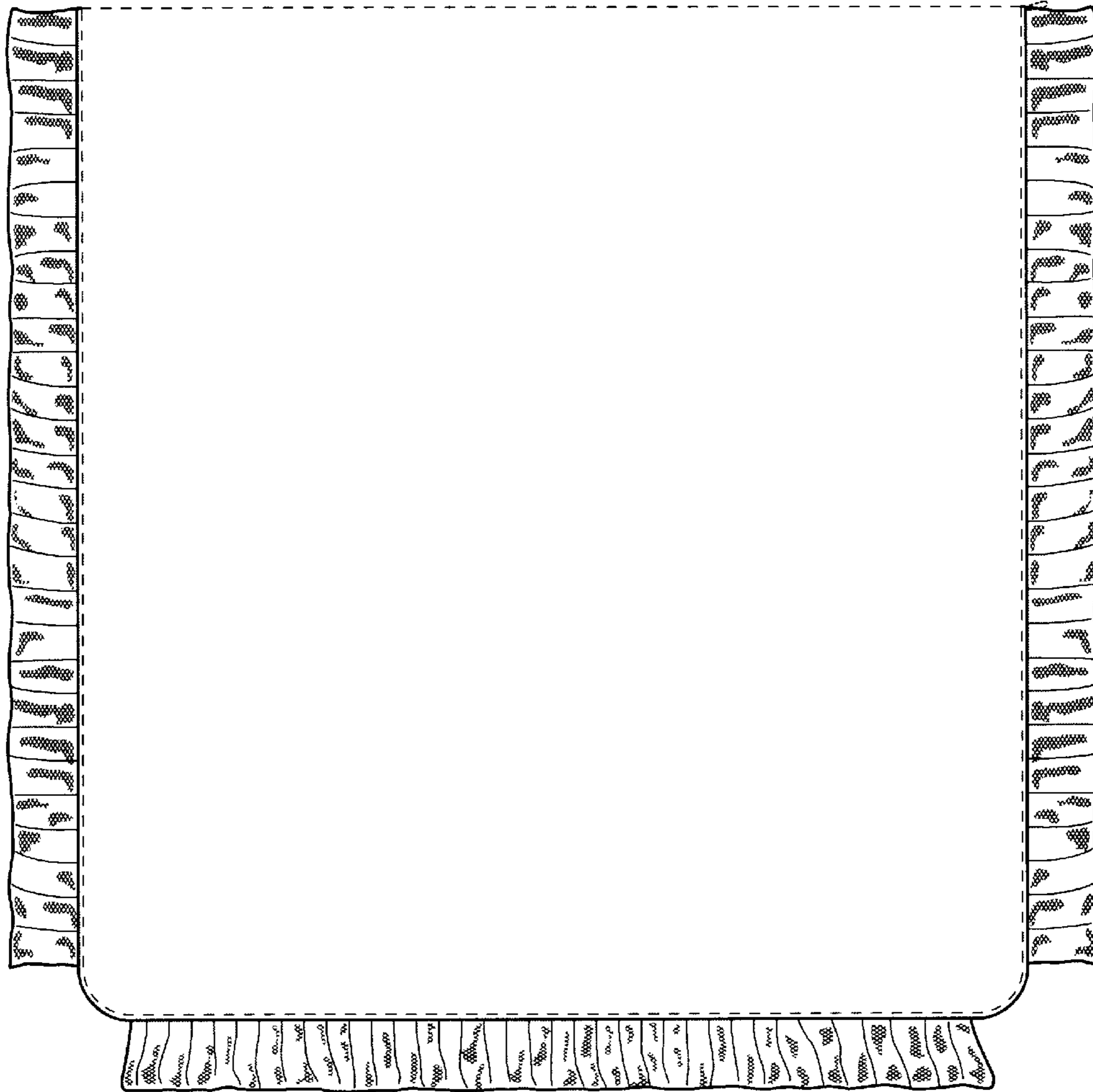

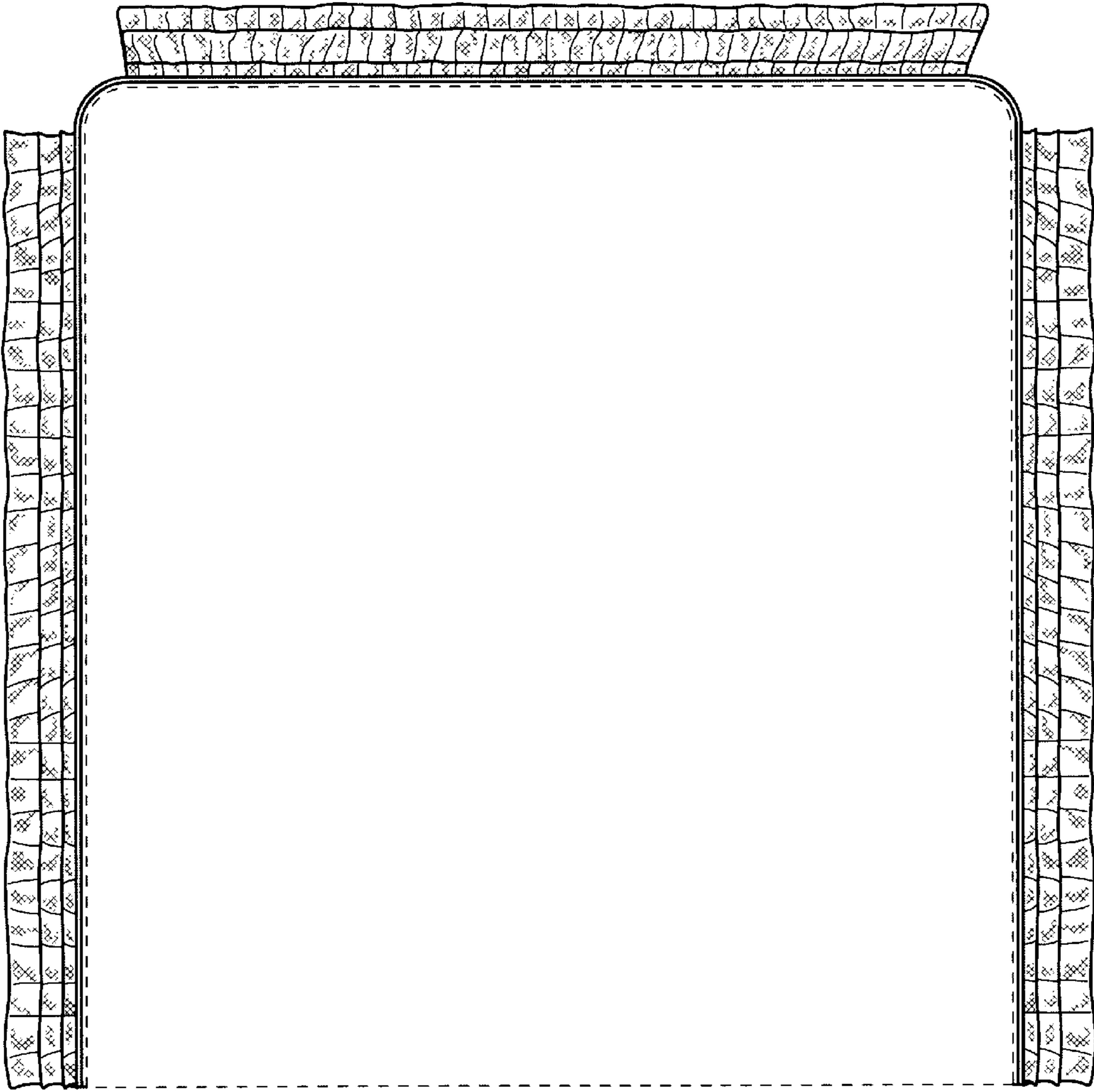
