The ornamental design for a cooktop, as shown and described.

**DESCRIPTION**

FIG. 3 is a bottom view of the cooktop.

FIG. 4 is a rear view of the cooktop with the cooking array extended.

FIG. 7 is a left side view of the cooktop with the cooking array extended.

FIG. 8 is a perspective view of the cooktop shown with the cooking array retracted.

FIG. 10 is a bottom view of the cooktop.

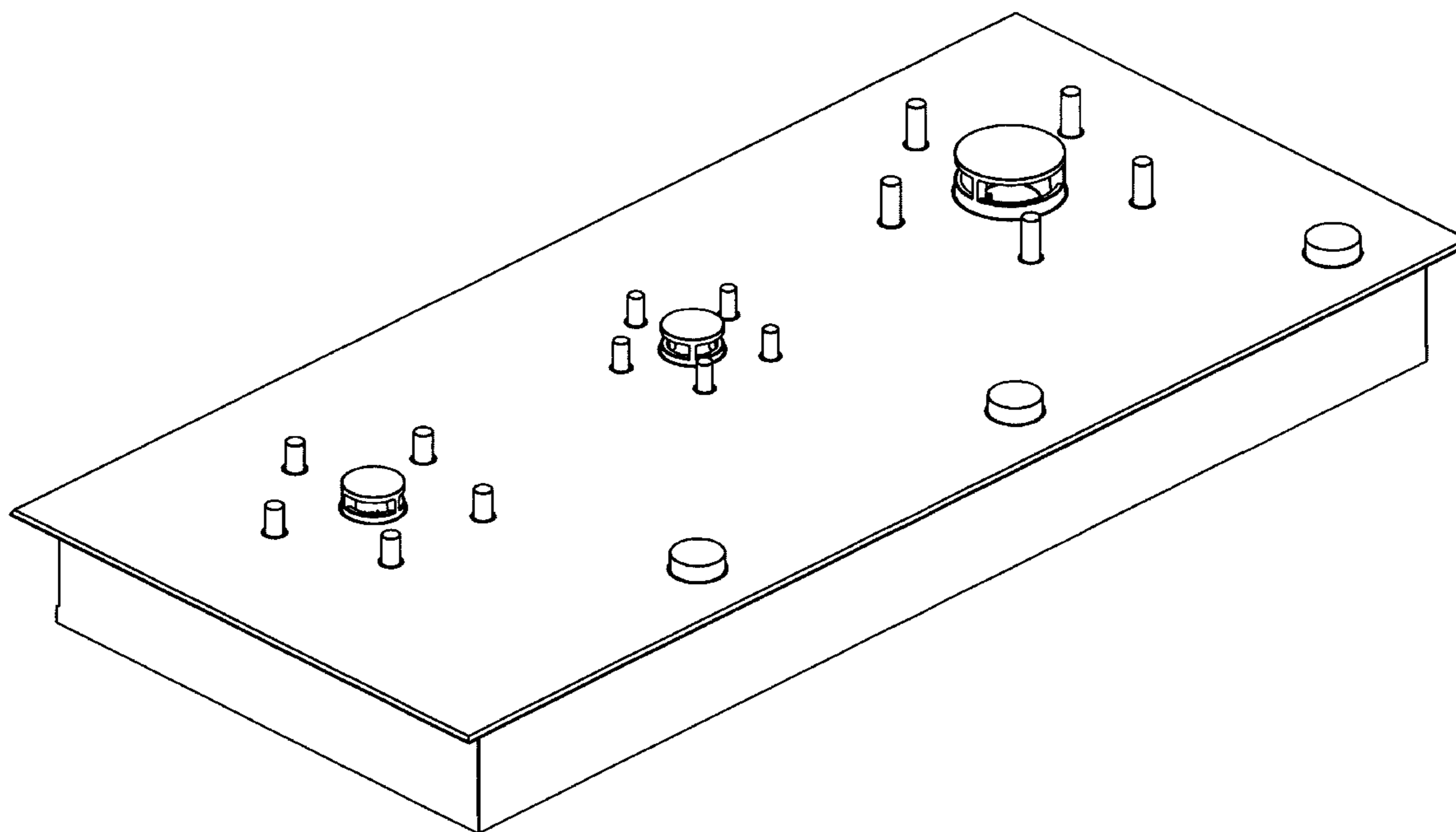
FIG. 11 is a rear view of the cooktop with the cooking array retracted.

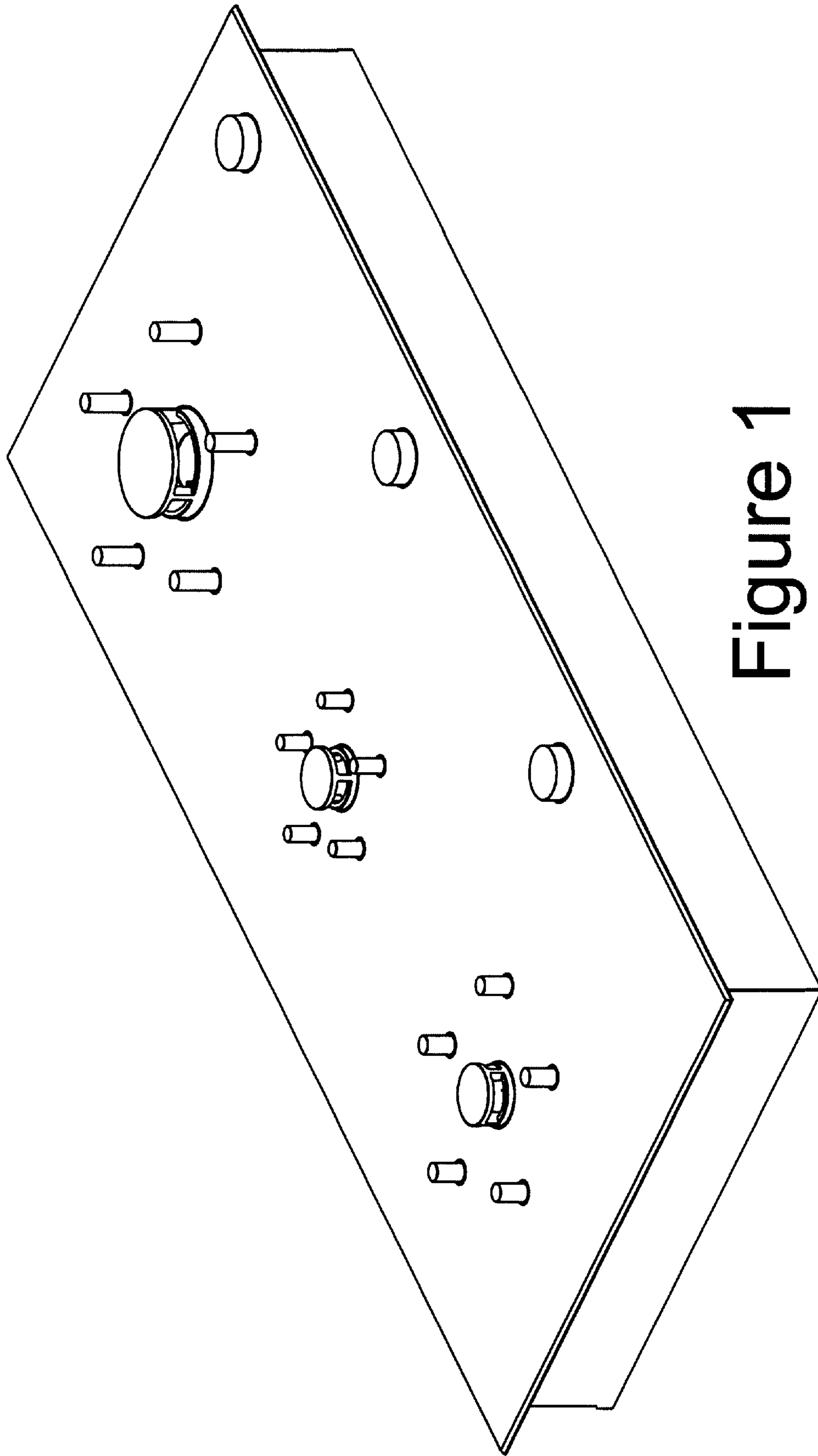

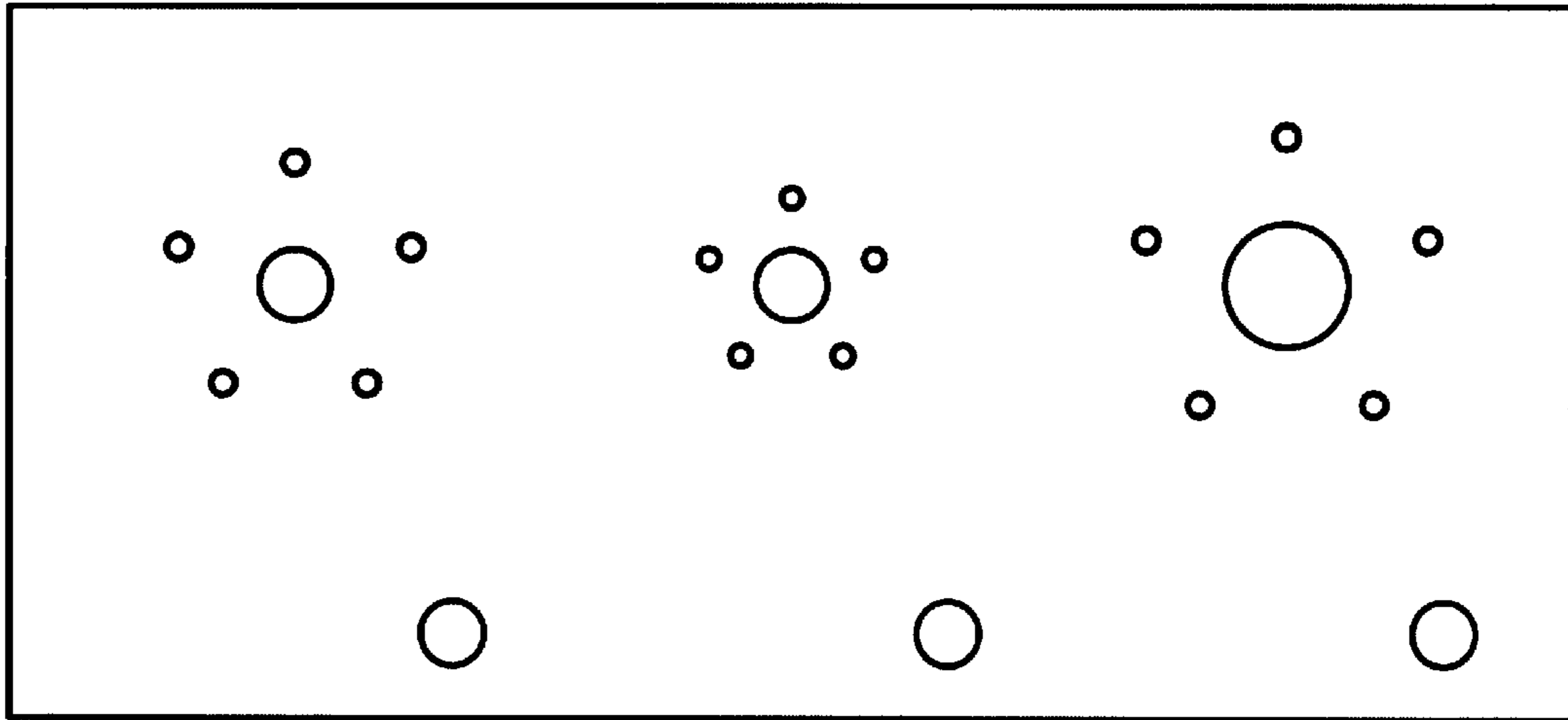

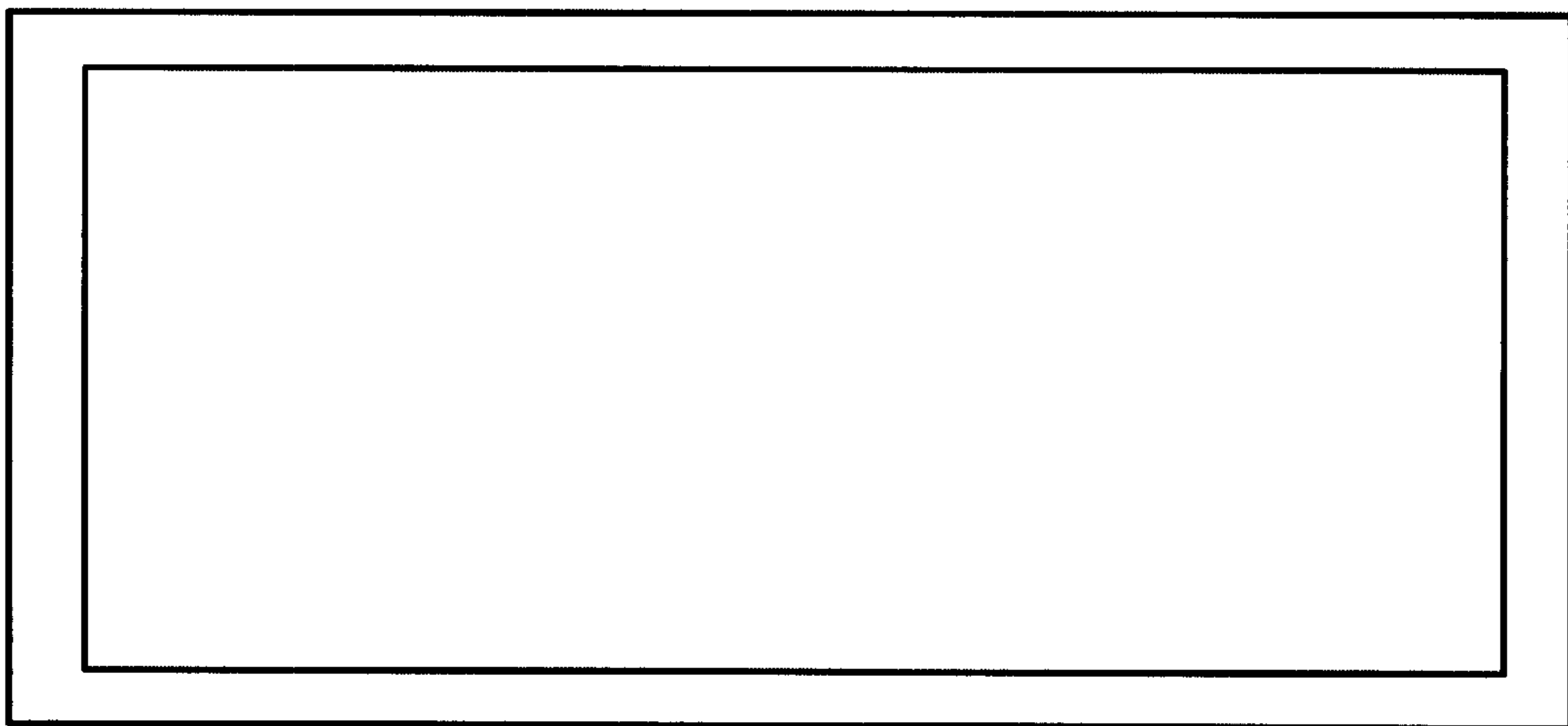

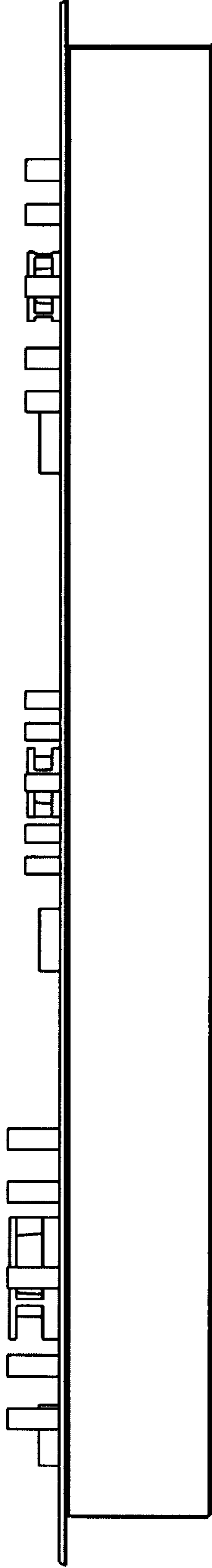

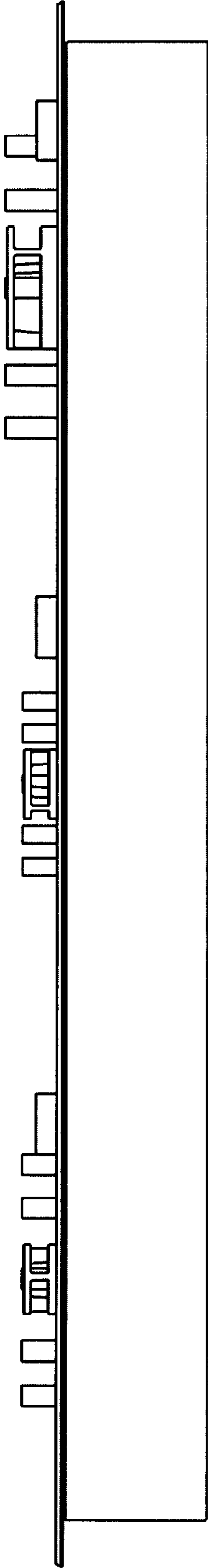

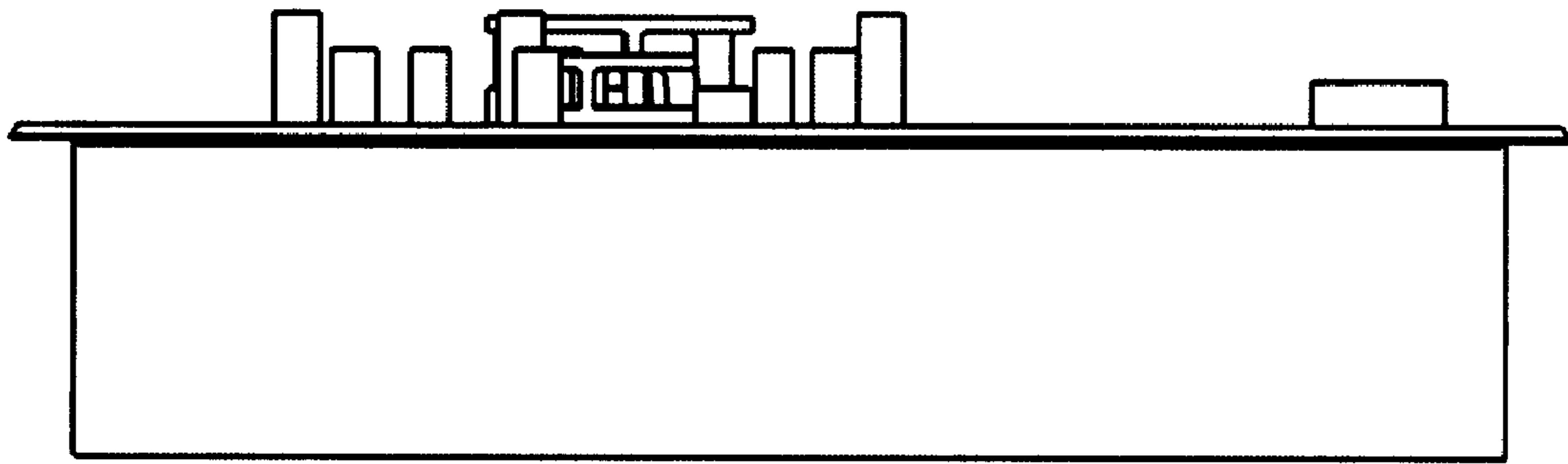

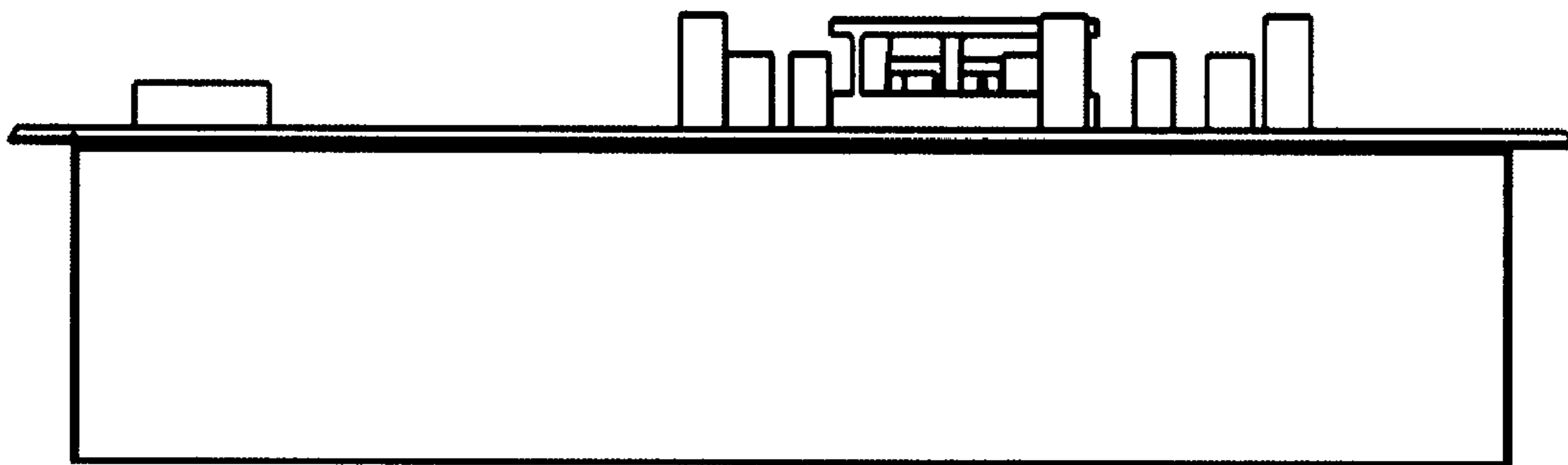

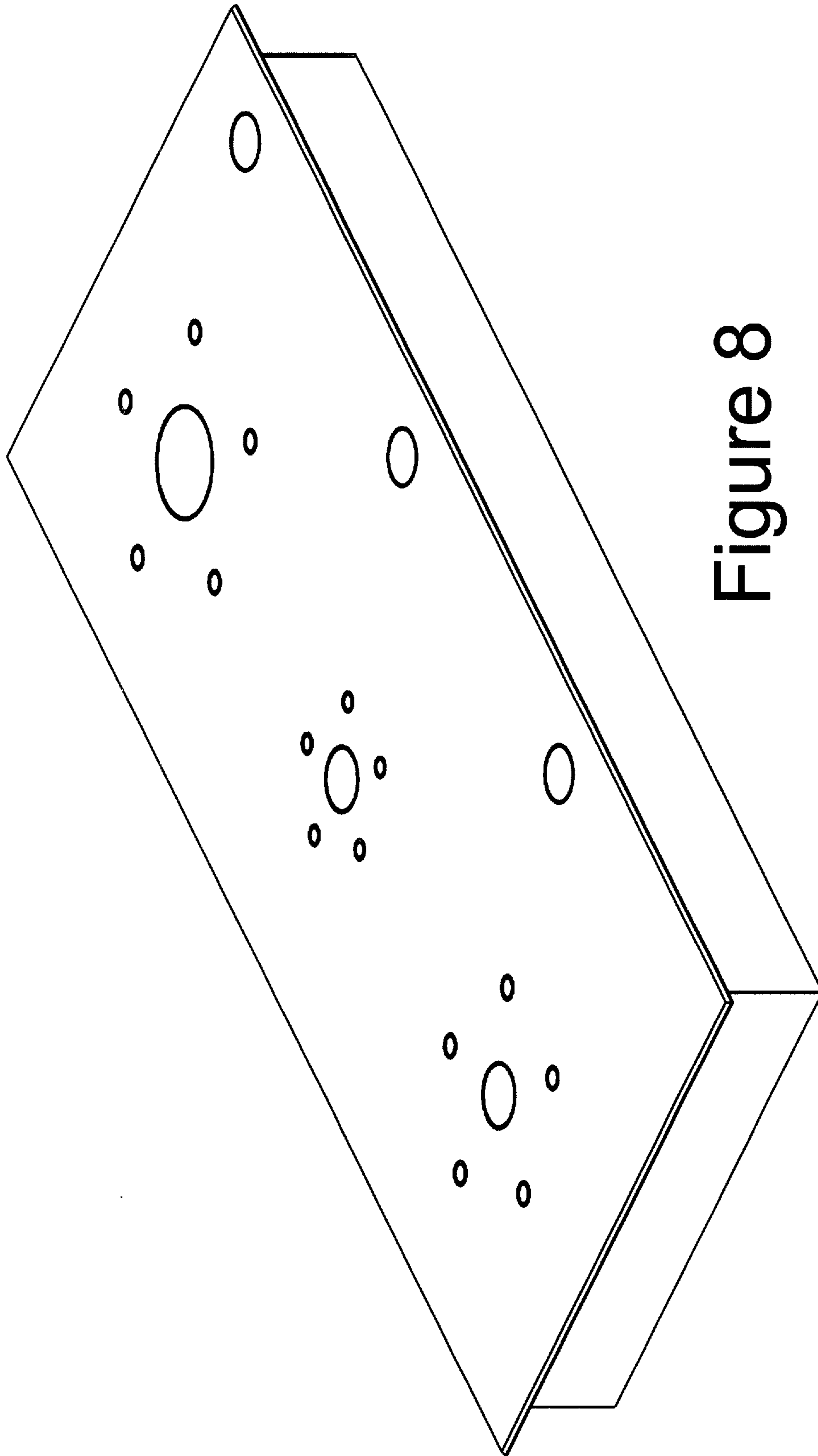

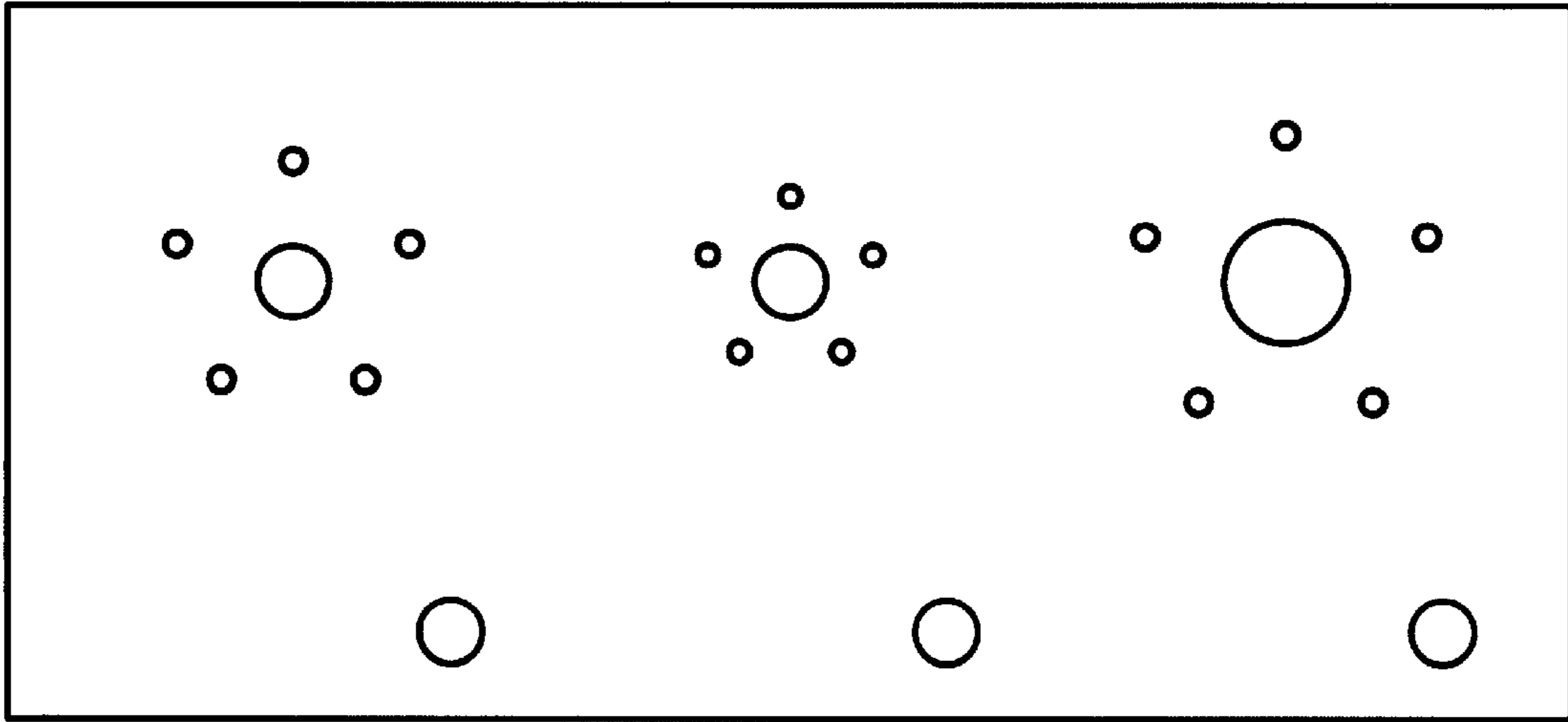

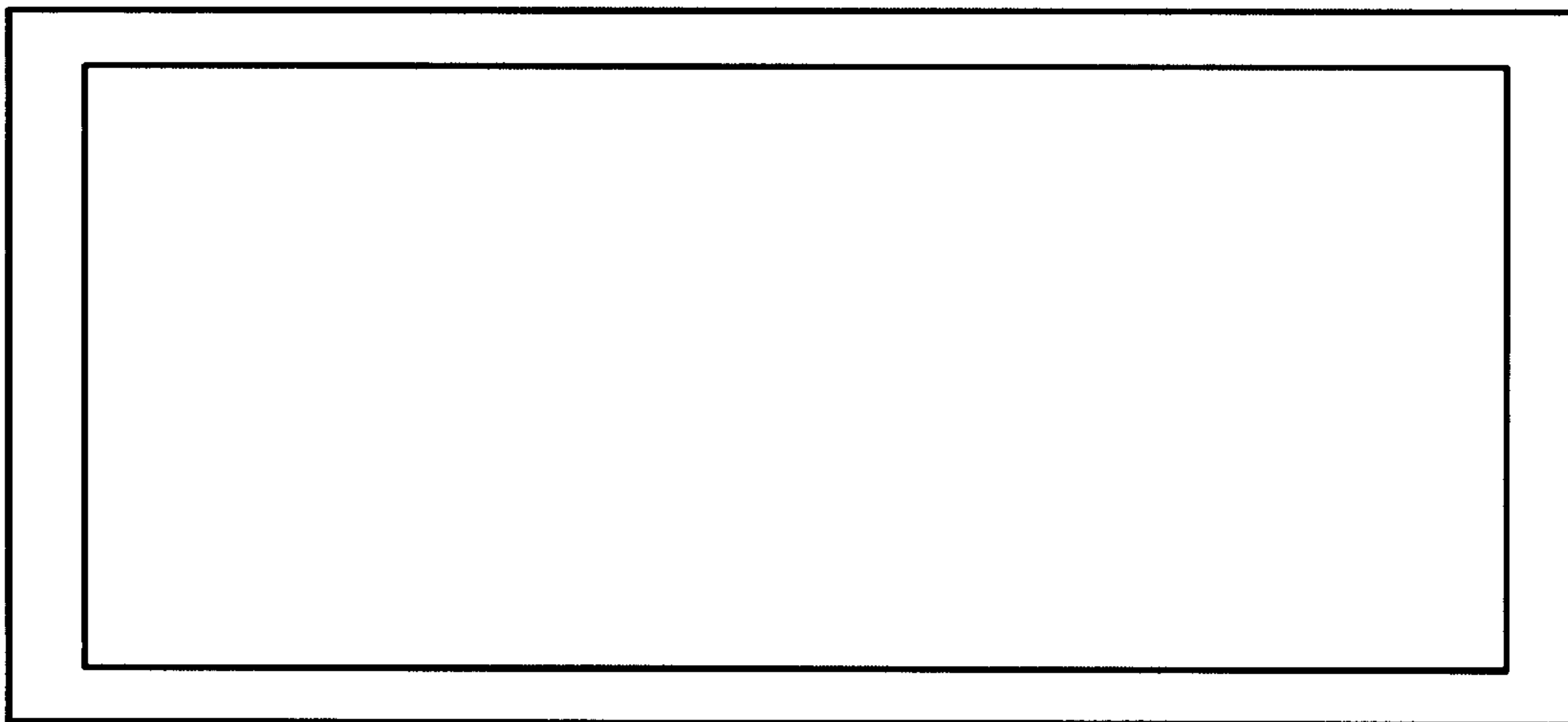

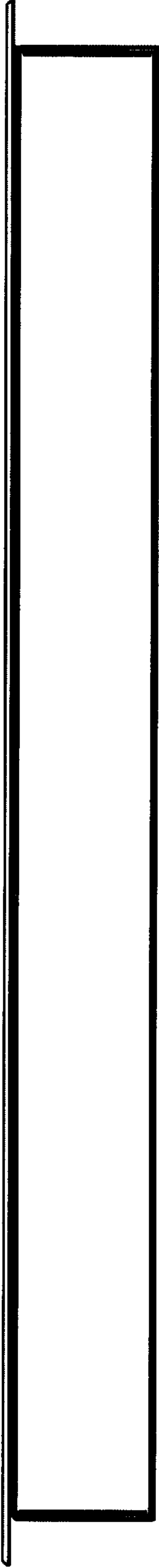

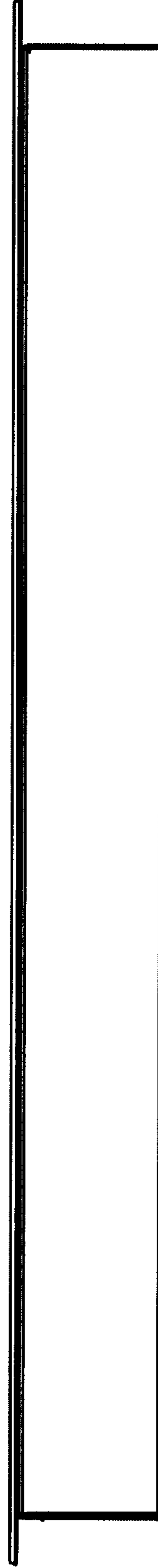

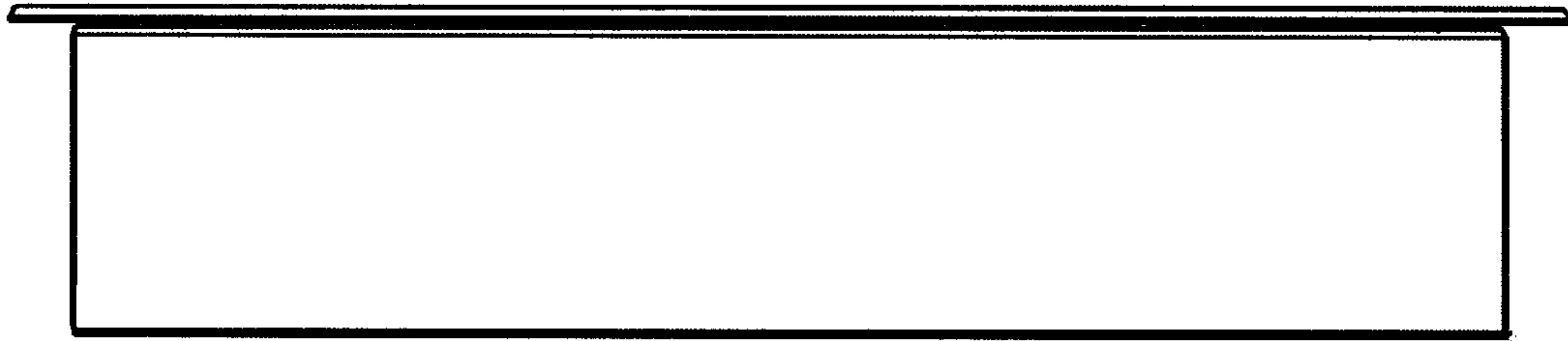

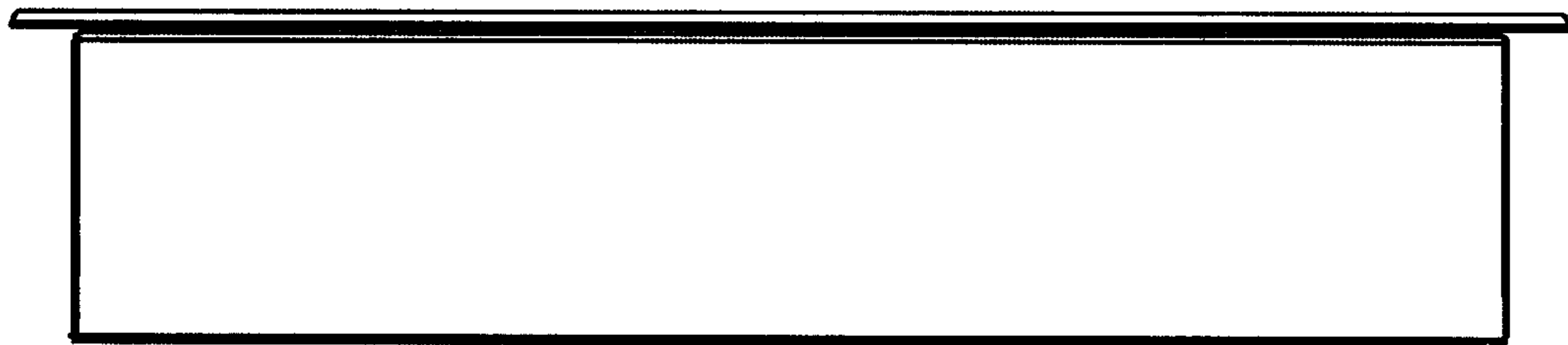
