**DESCRIPTION**

FIG. 3 is a top plan view thereof;

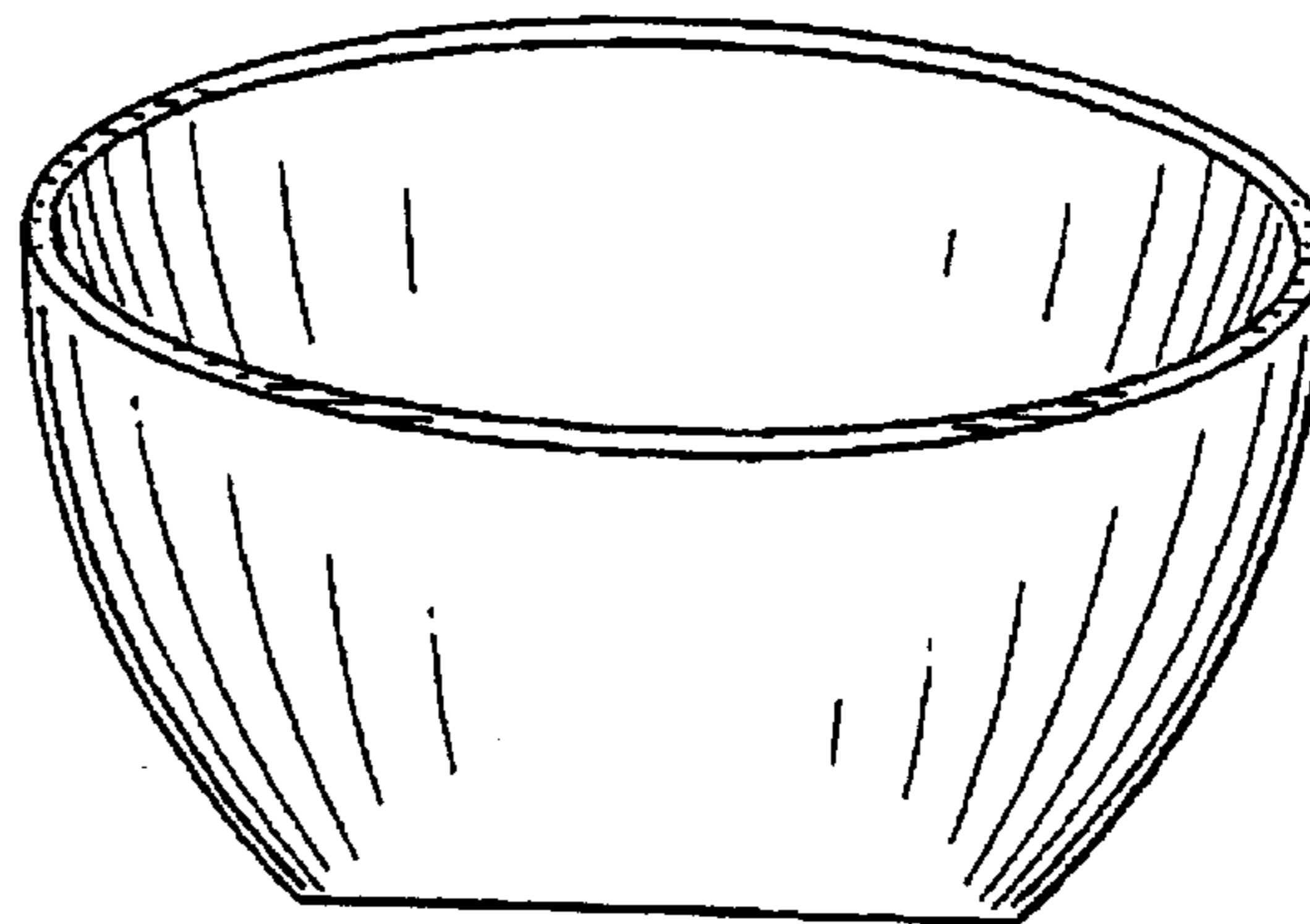
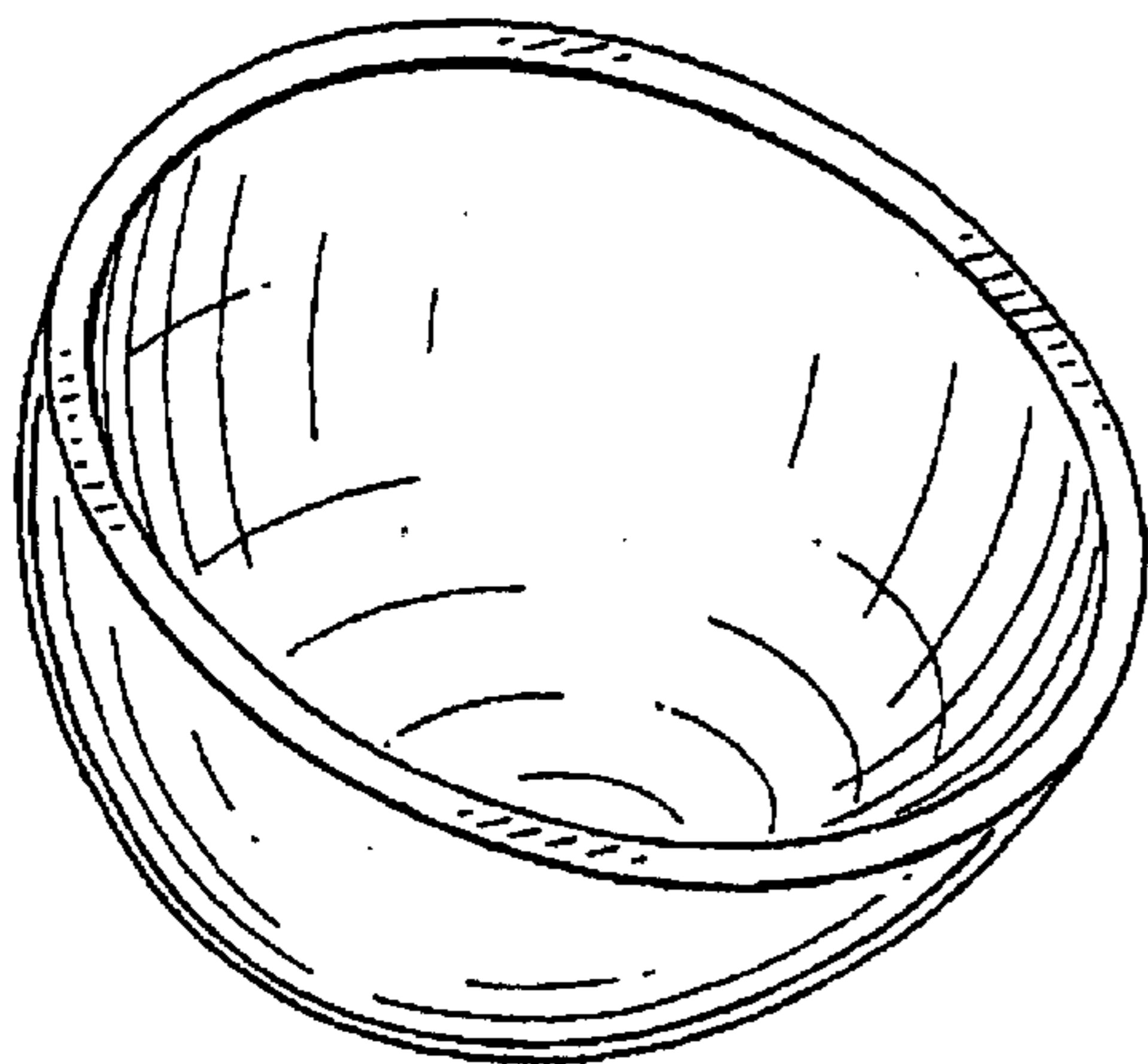
FIG. 4 is a left end elevational view thereof, the right end elevation view being a mirror image of the left end elevation view shown;

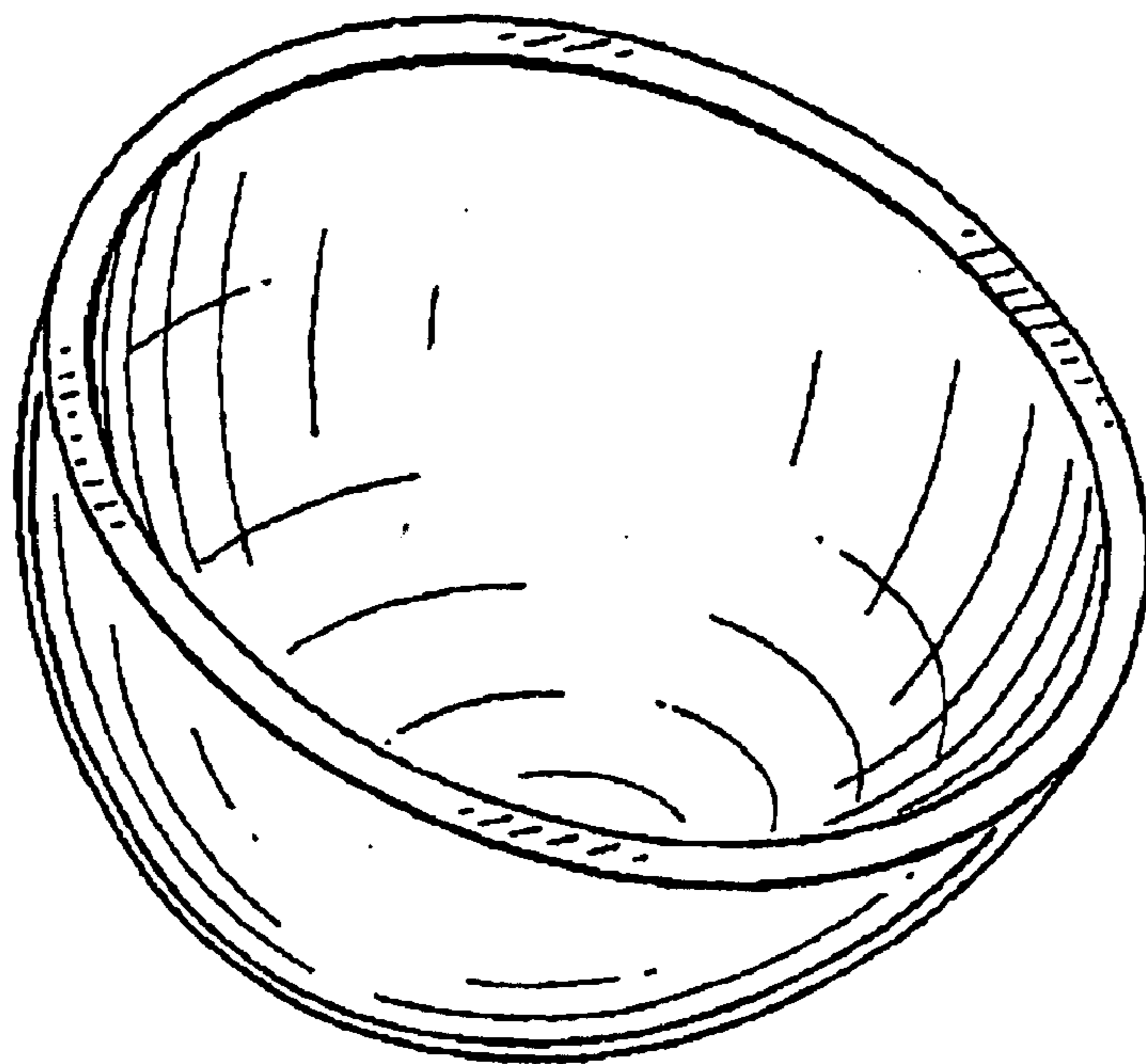

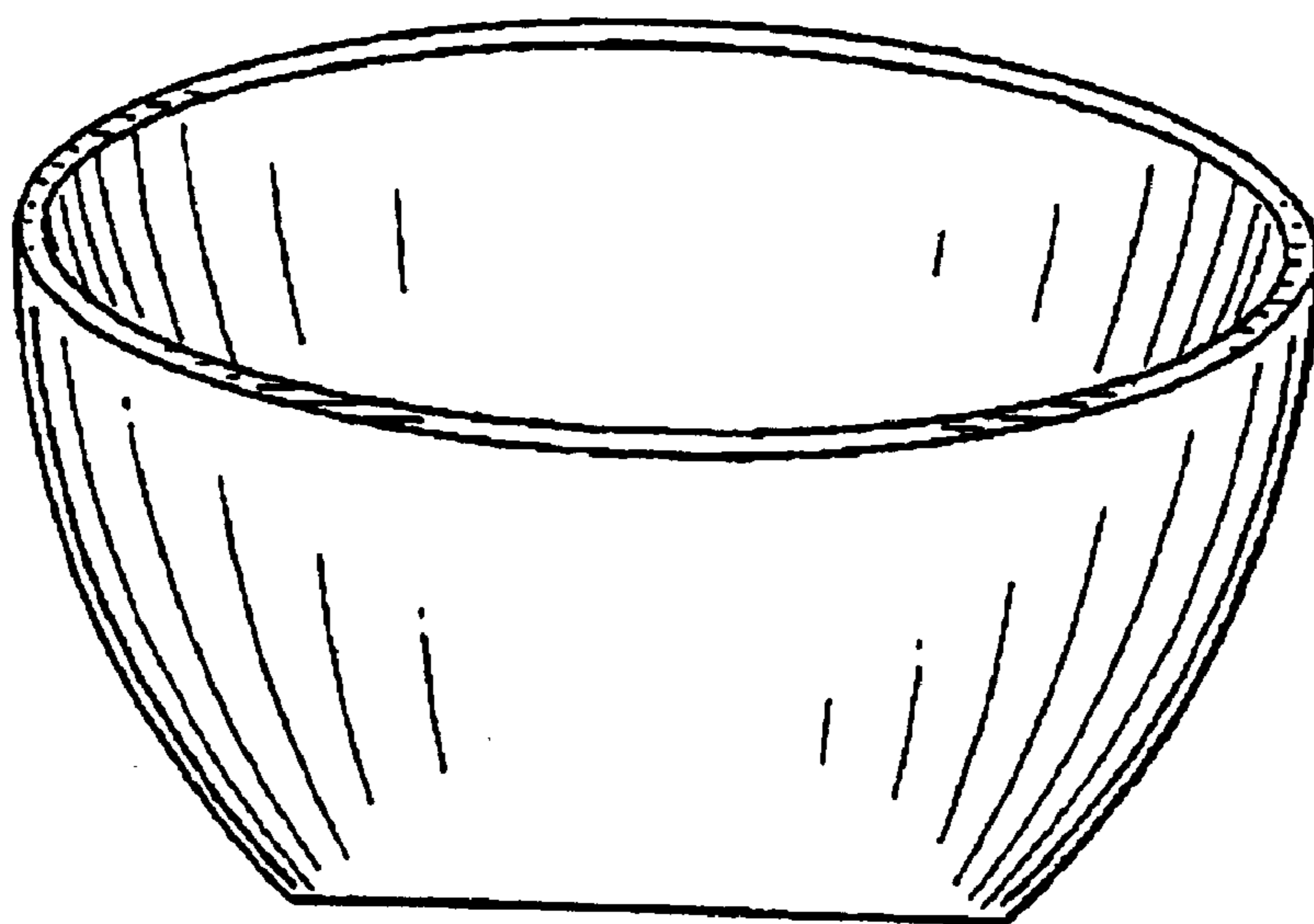

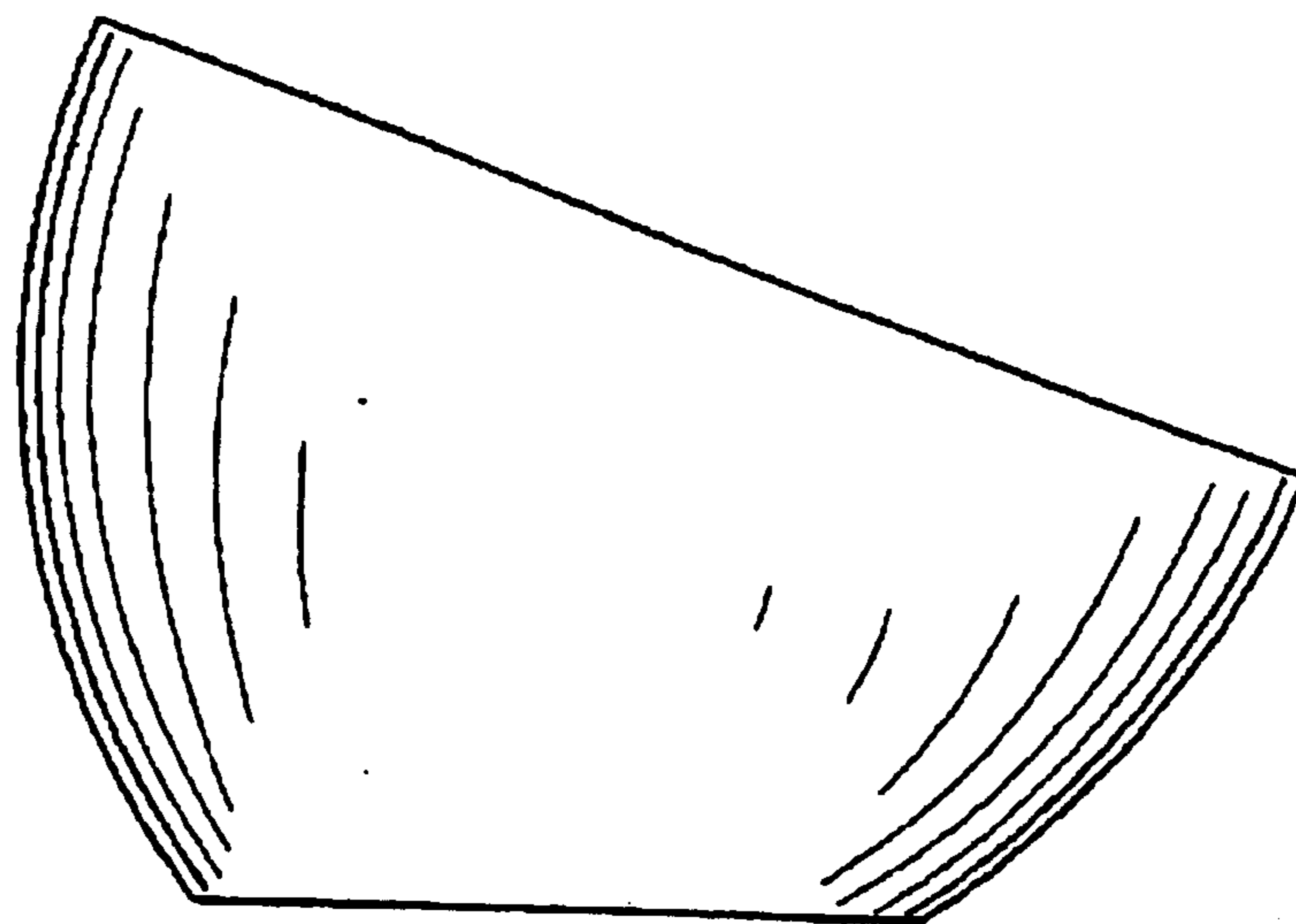
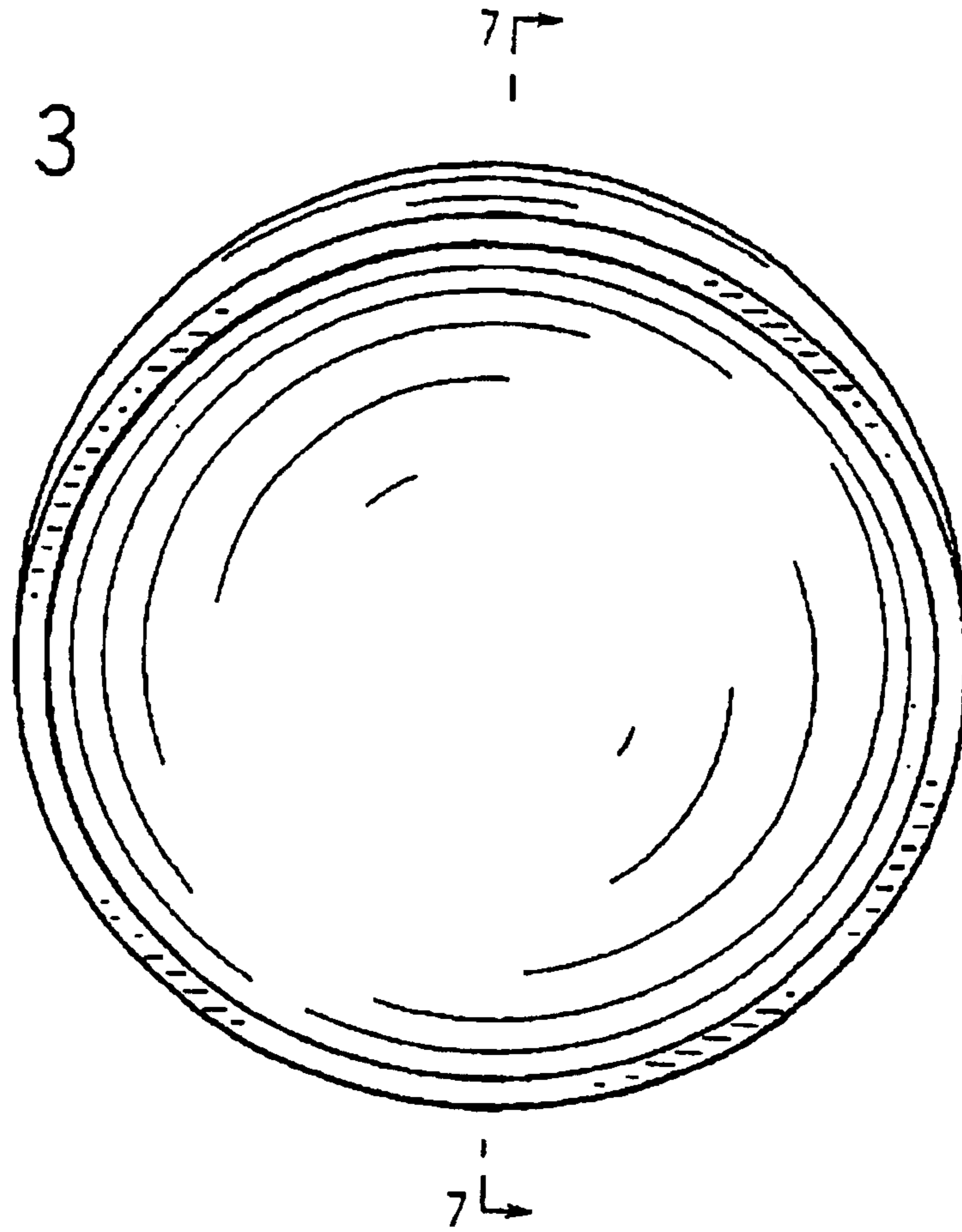

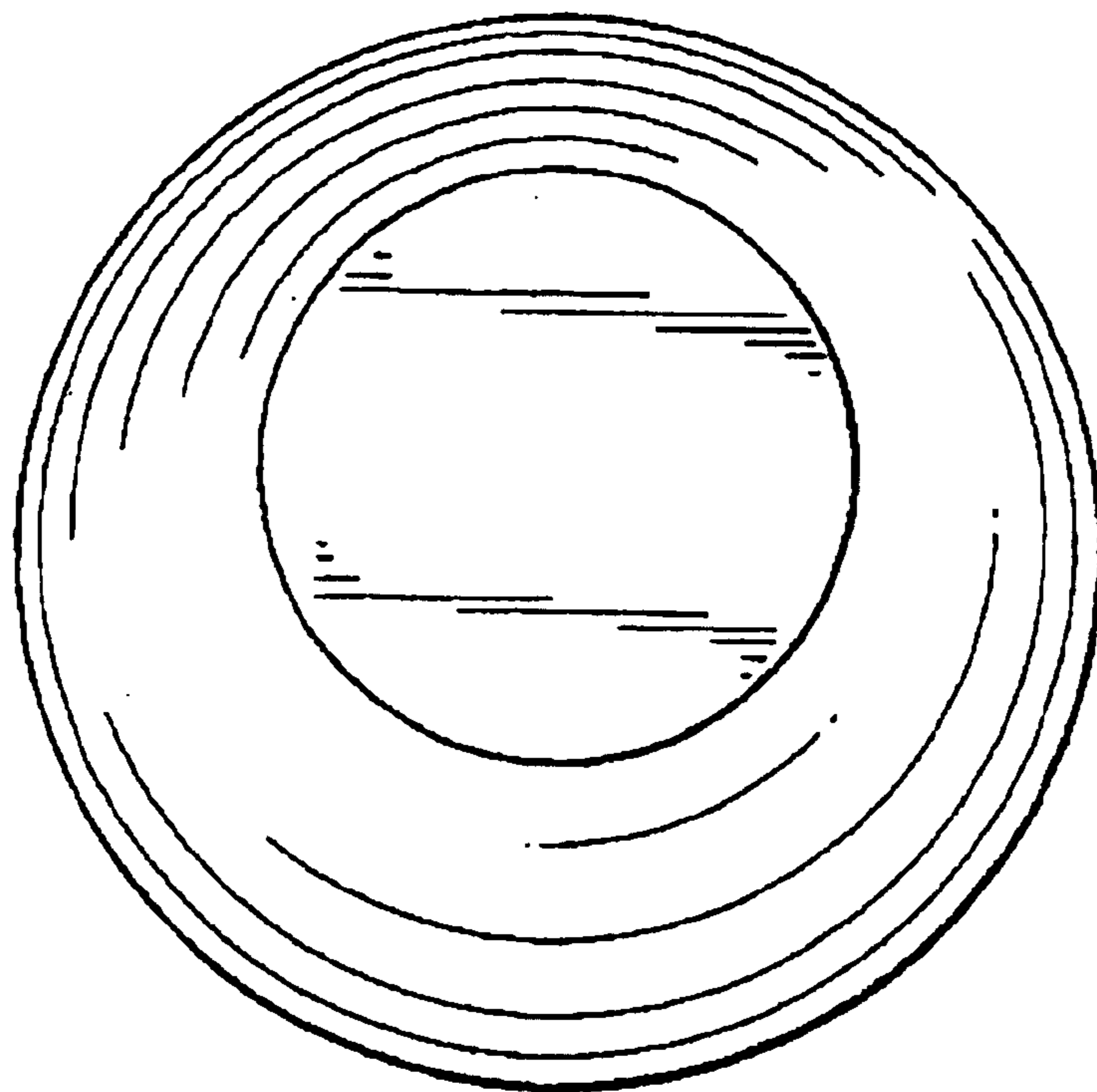
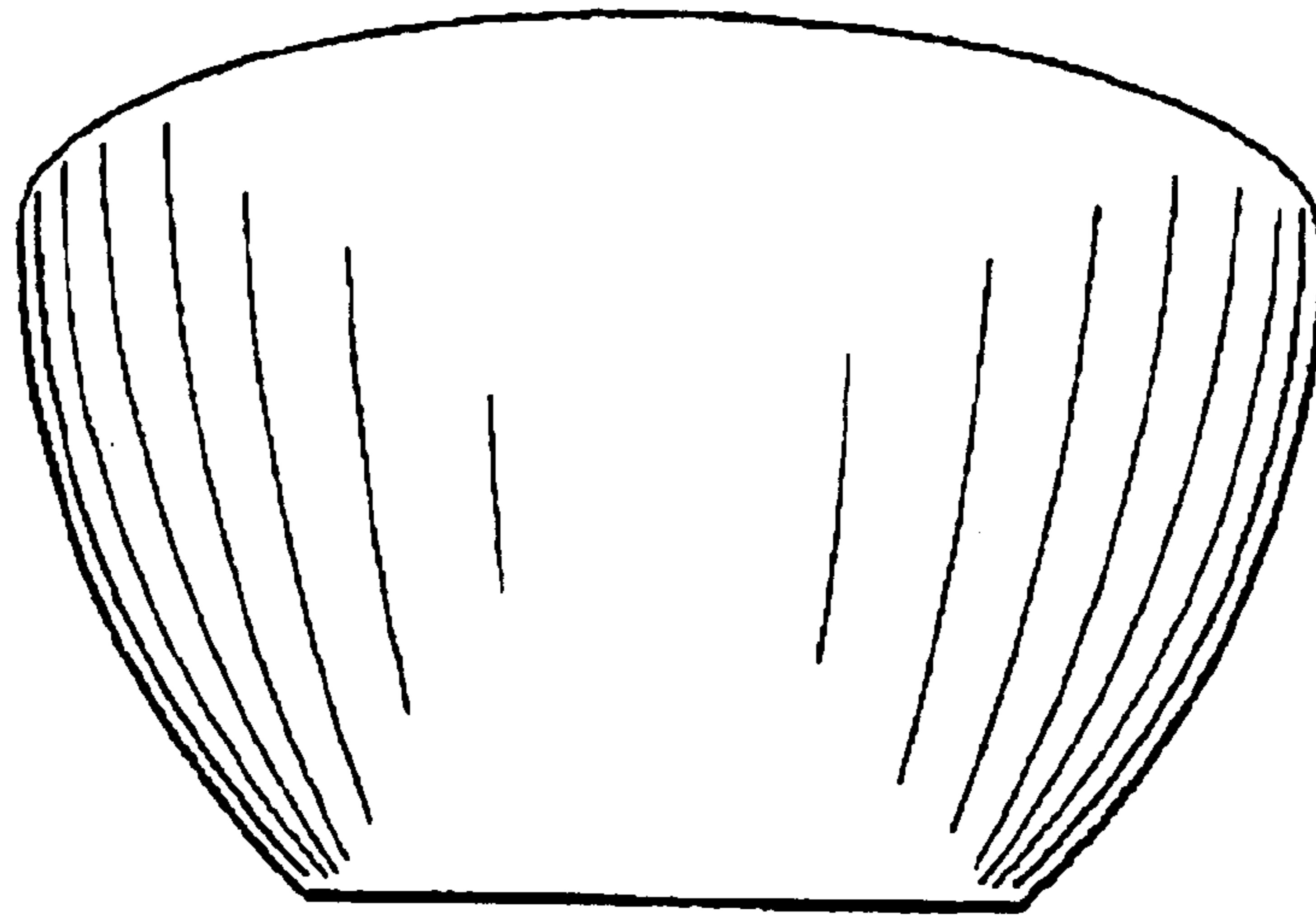

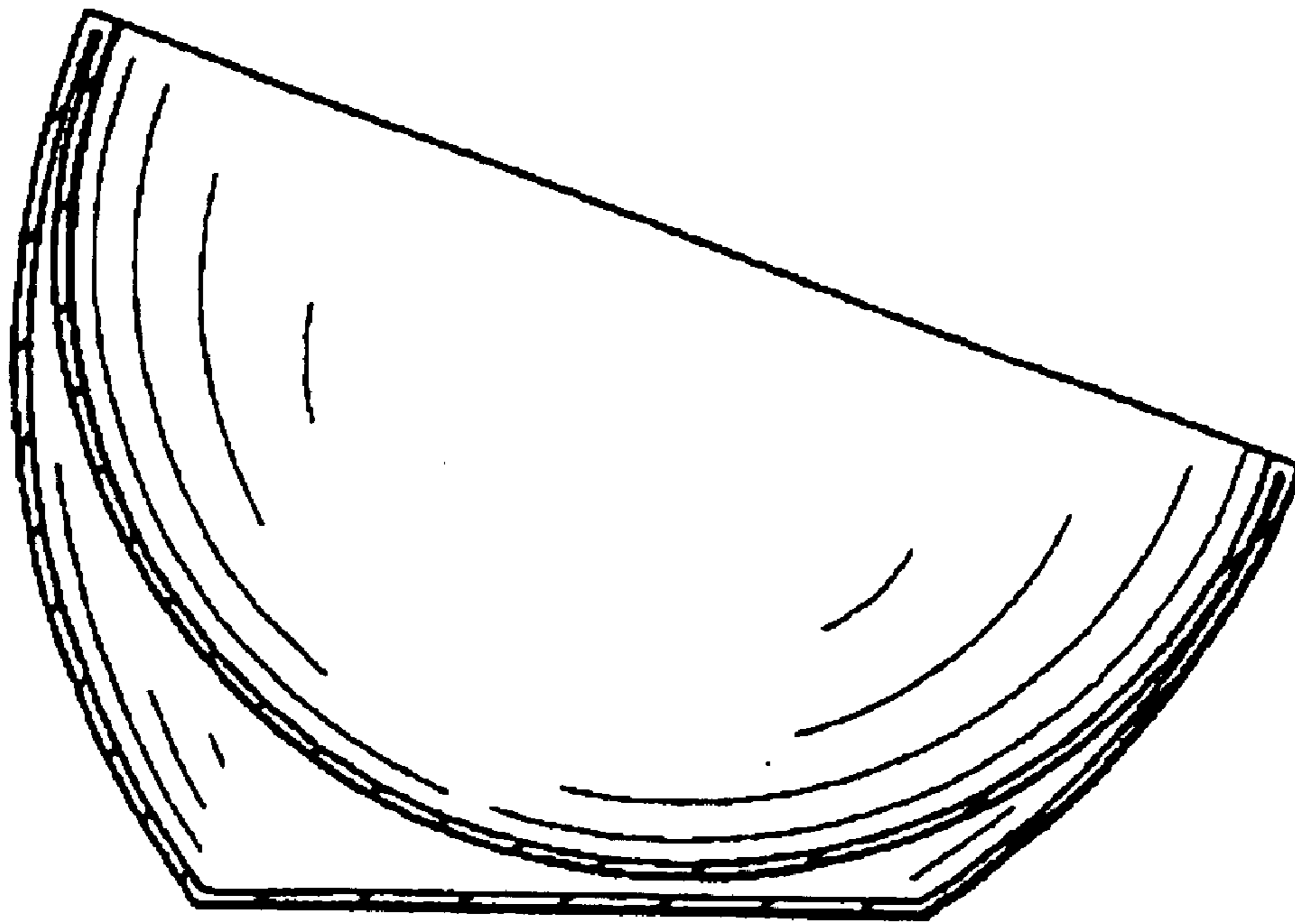
