DESCRIPTION

FIG. 1 is a perspective view of a container that emphasizes the front of the container.

FIG. 2 is a perspective view of the container that emphasizes the bottom of the container.

FIG. 3 is a top view of the container.

FIG. 4 is a bottom view of the container.

FIG. 5 is a view of the container as viewed along arrow 5 depicted in FIG. 4.

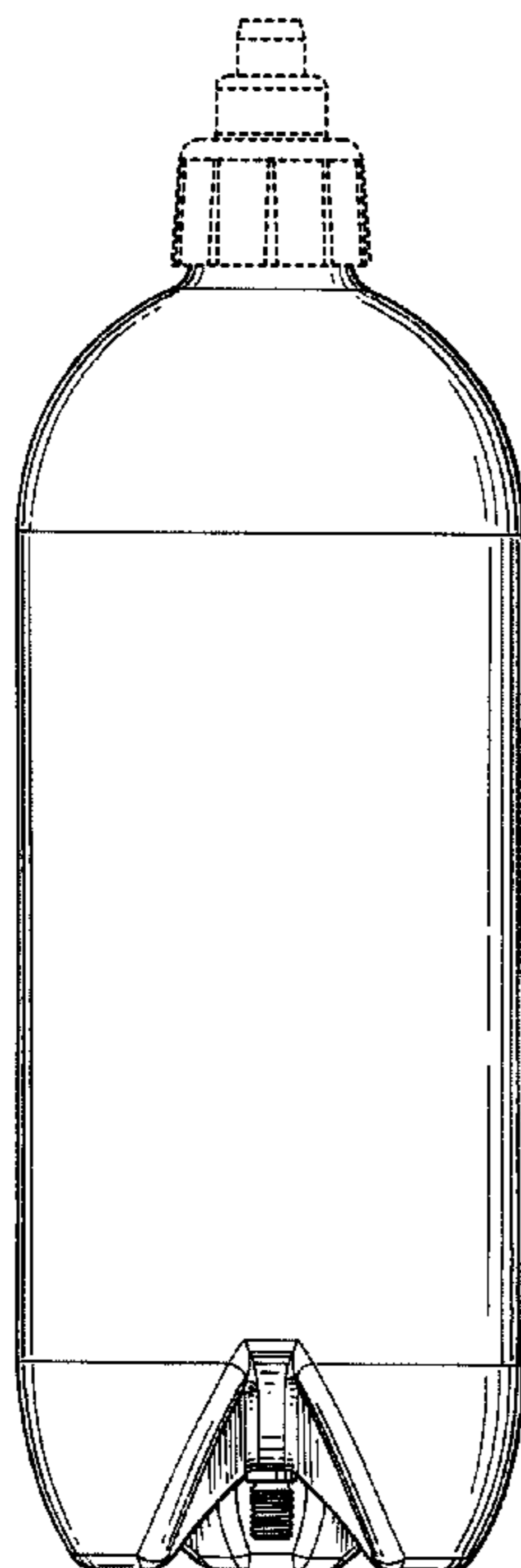
FIG. 6 is a view of the container as viewed along arrow 6 depicted in FIG. 4.

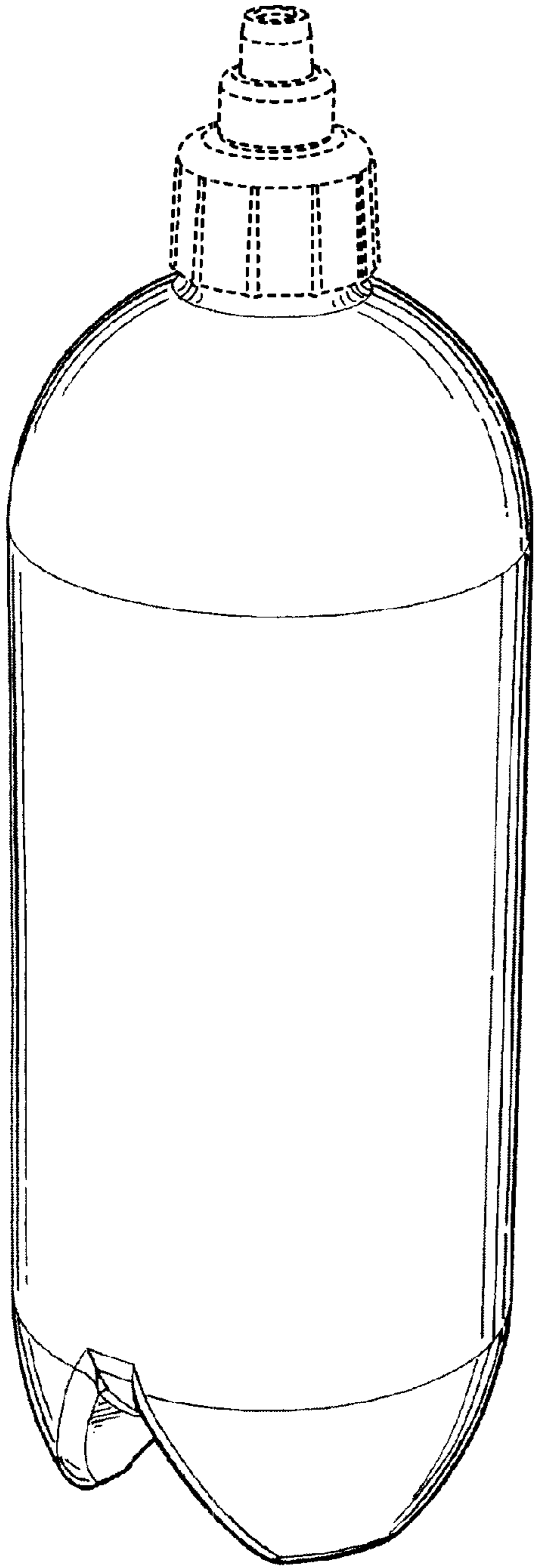

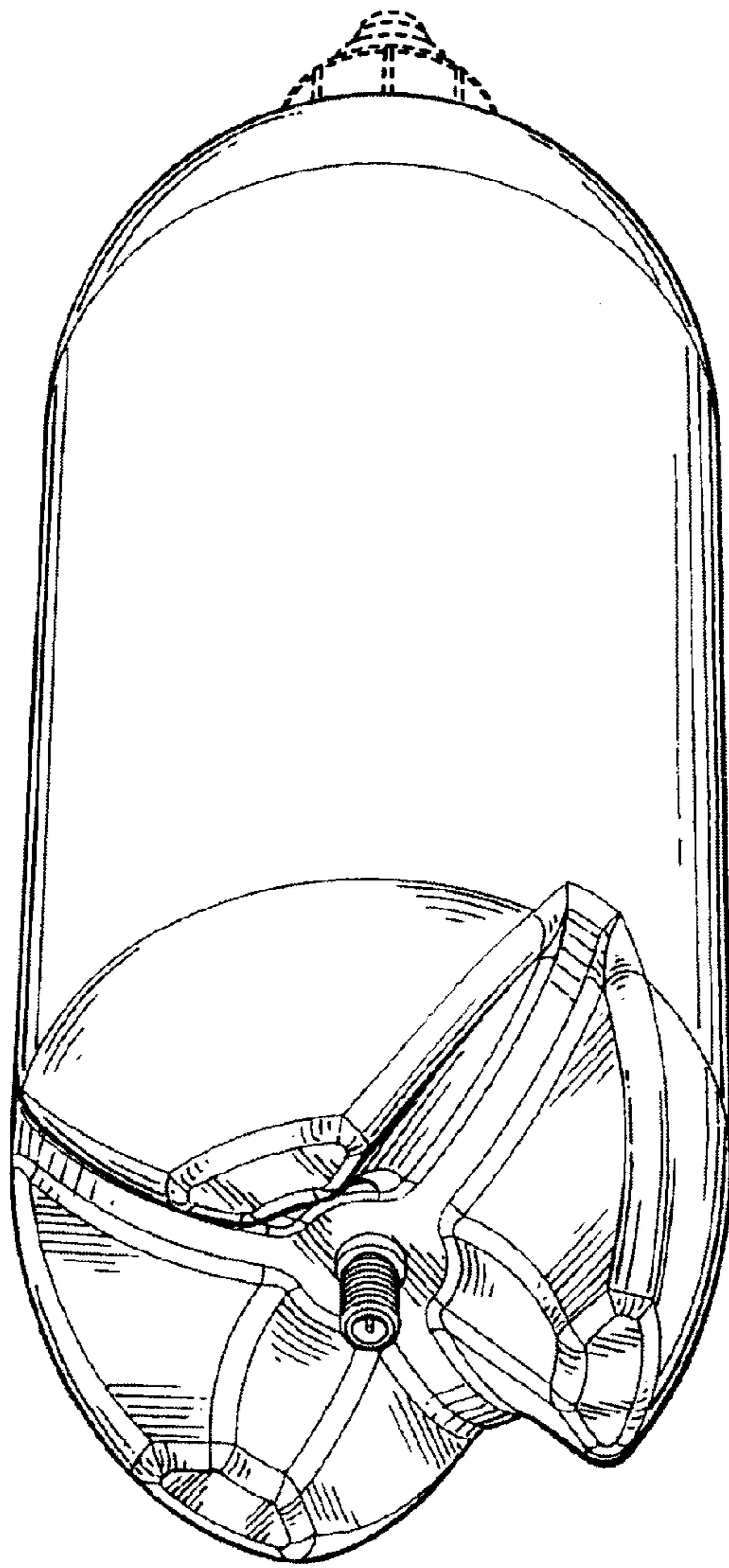

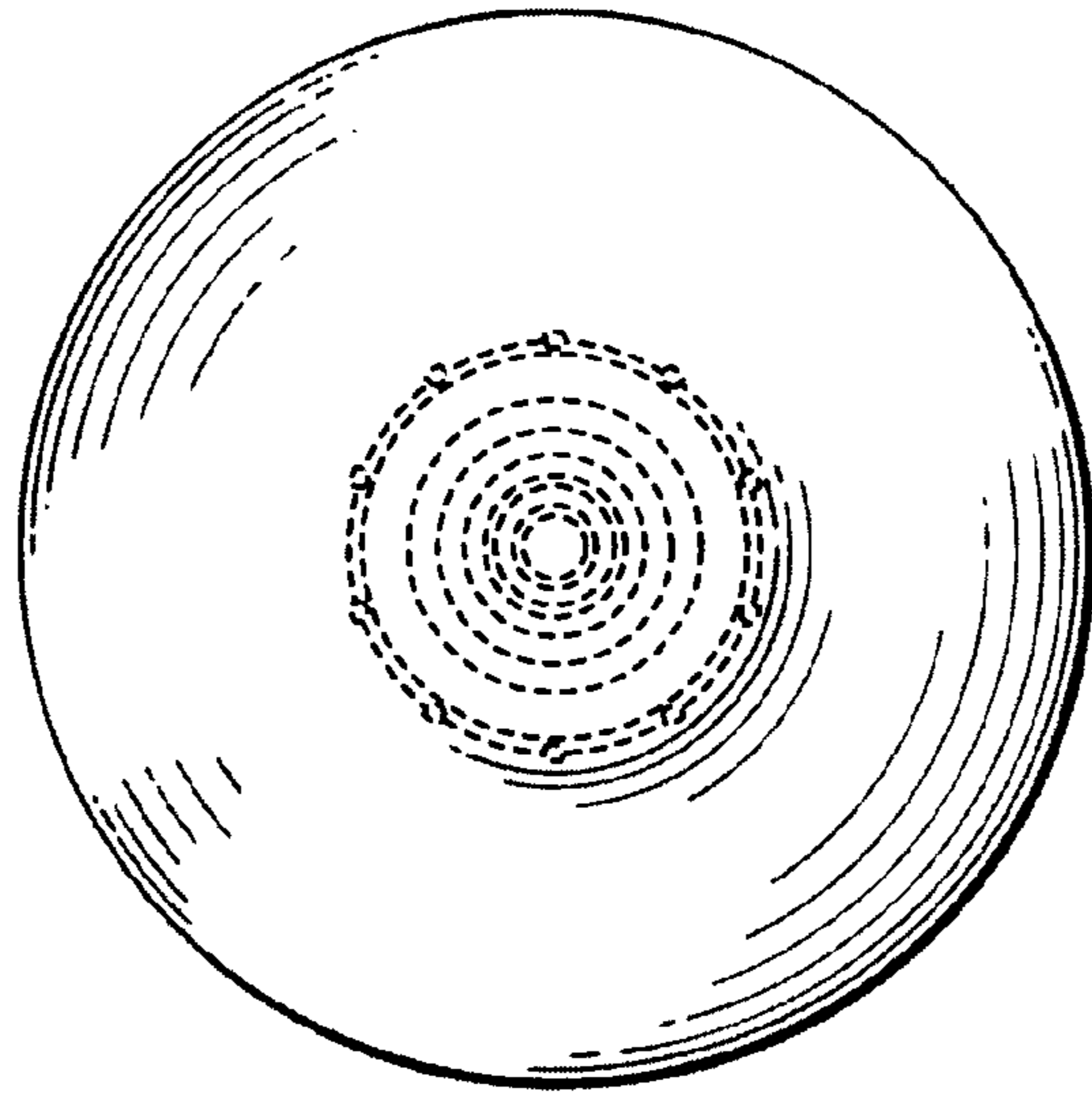

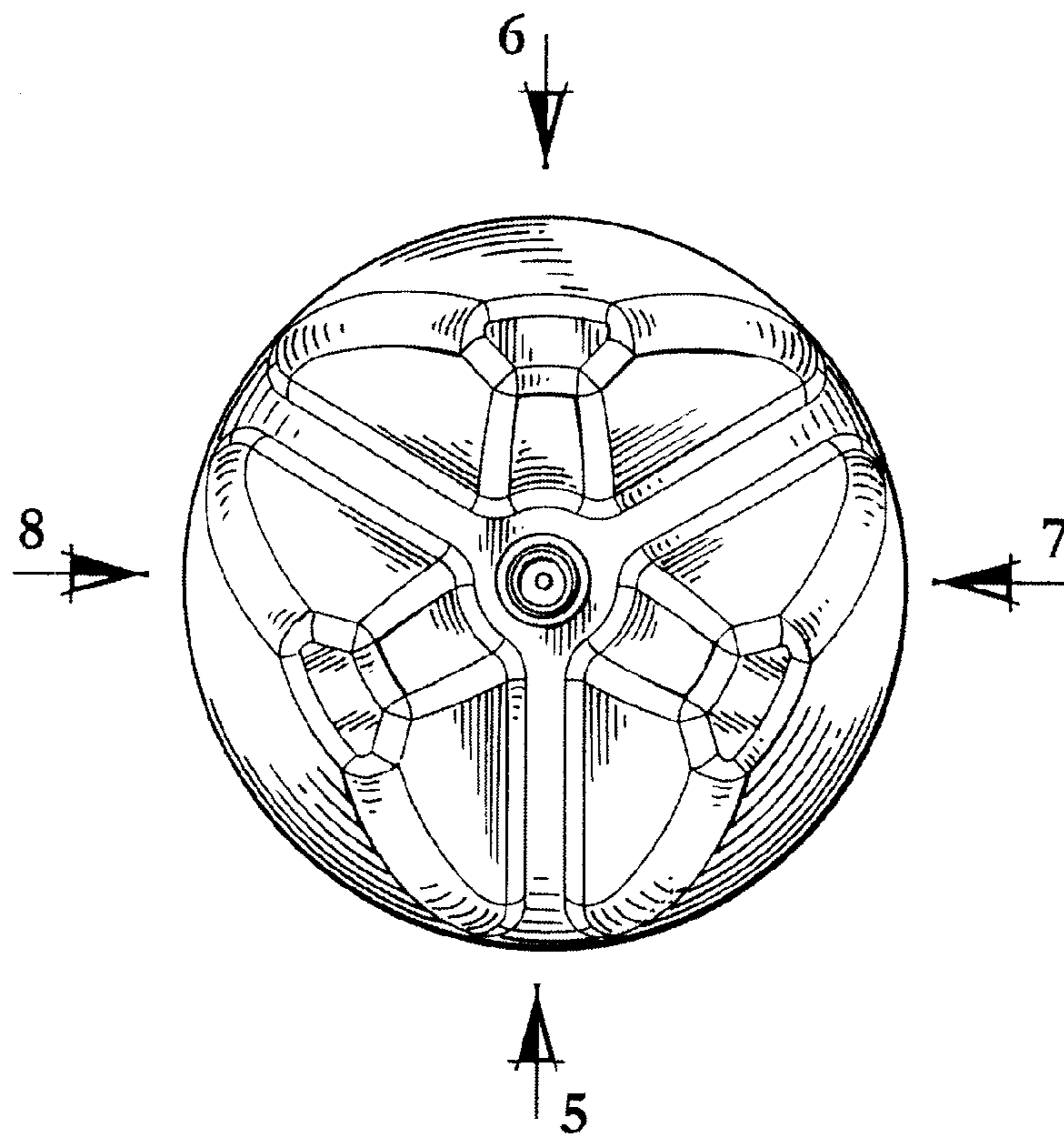

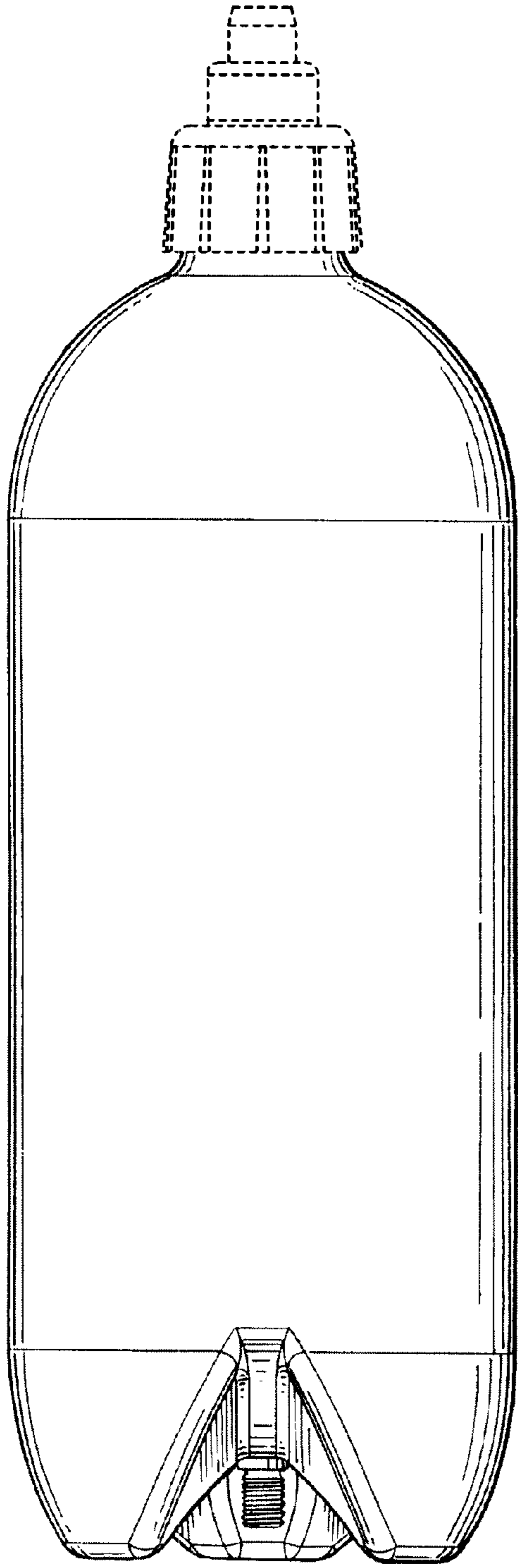

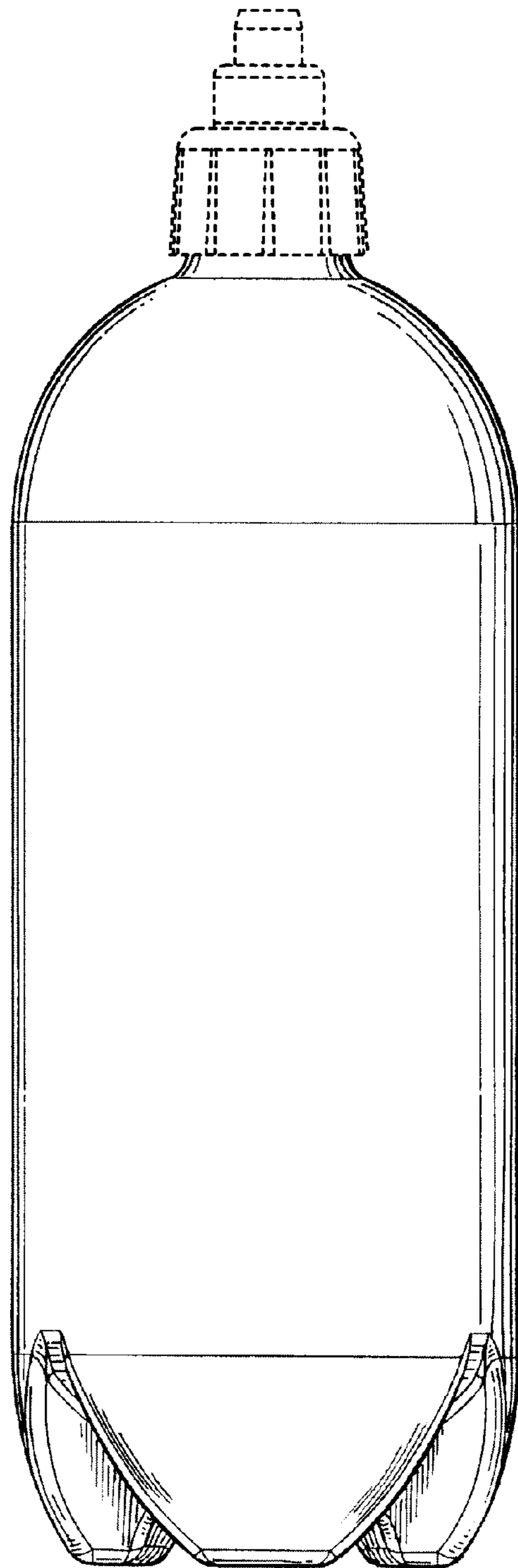

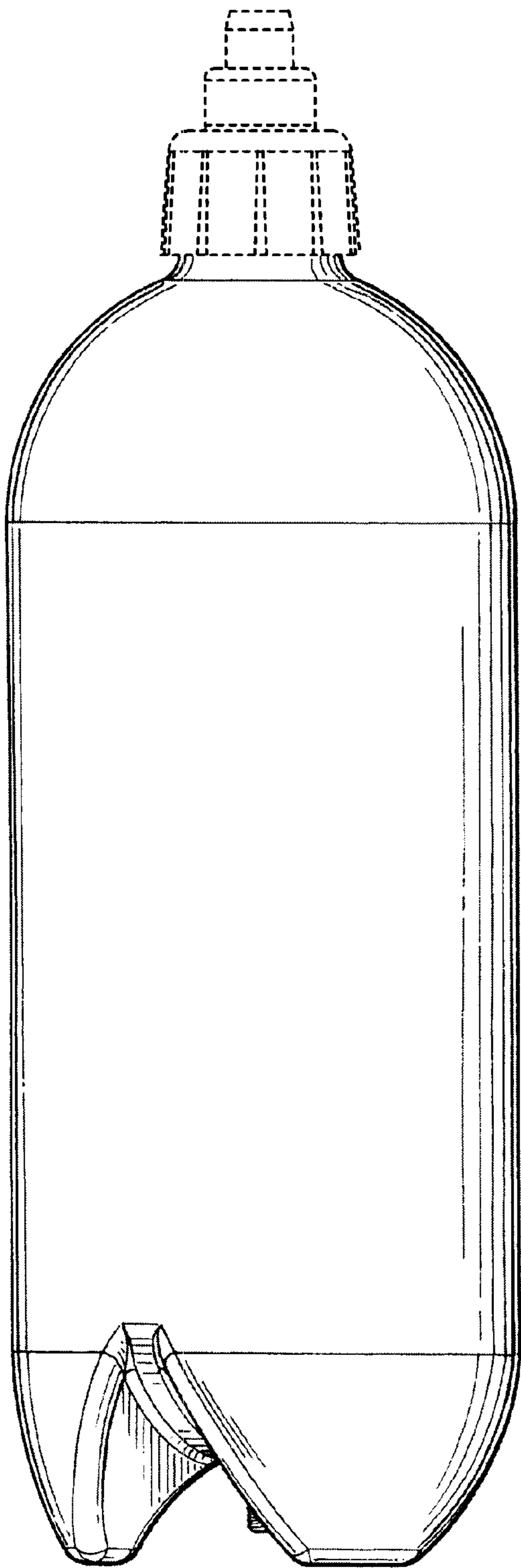

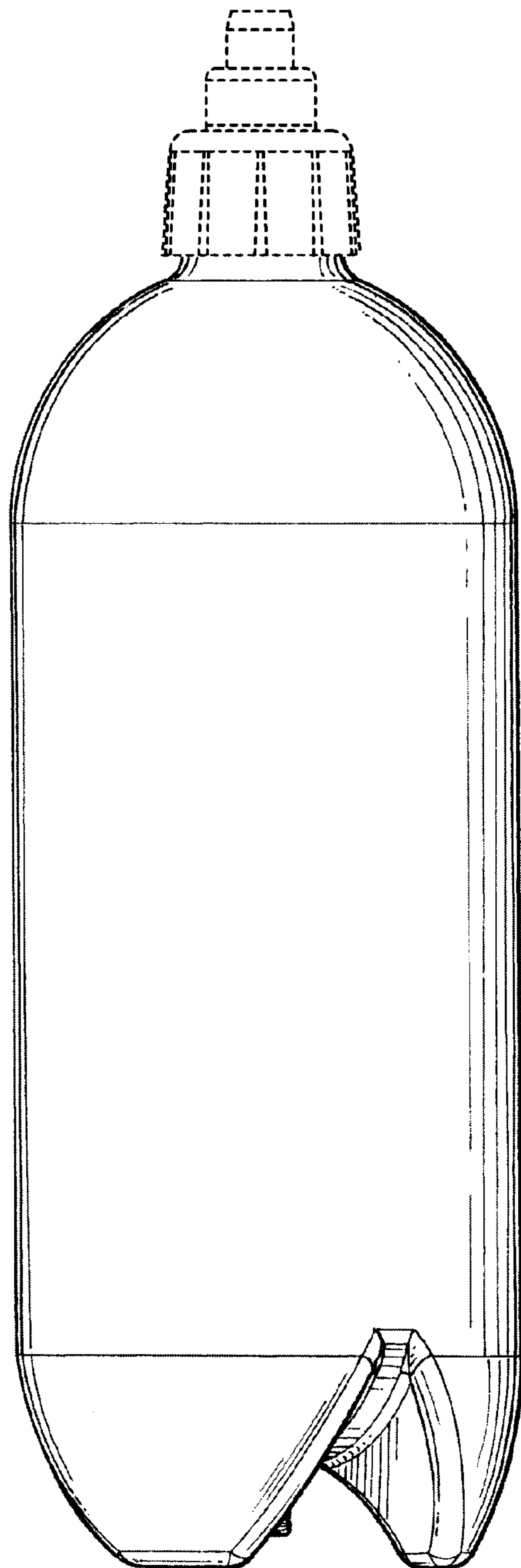
