**DESCRIPTION**

The claimed watch with pulse sensor is a small portable timepiece with the function of measuring pulse rate.

FIG. 3 is a right side view thereof;

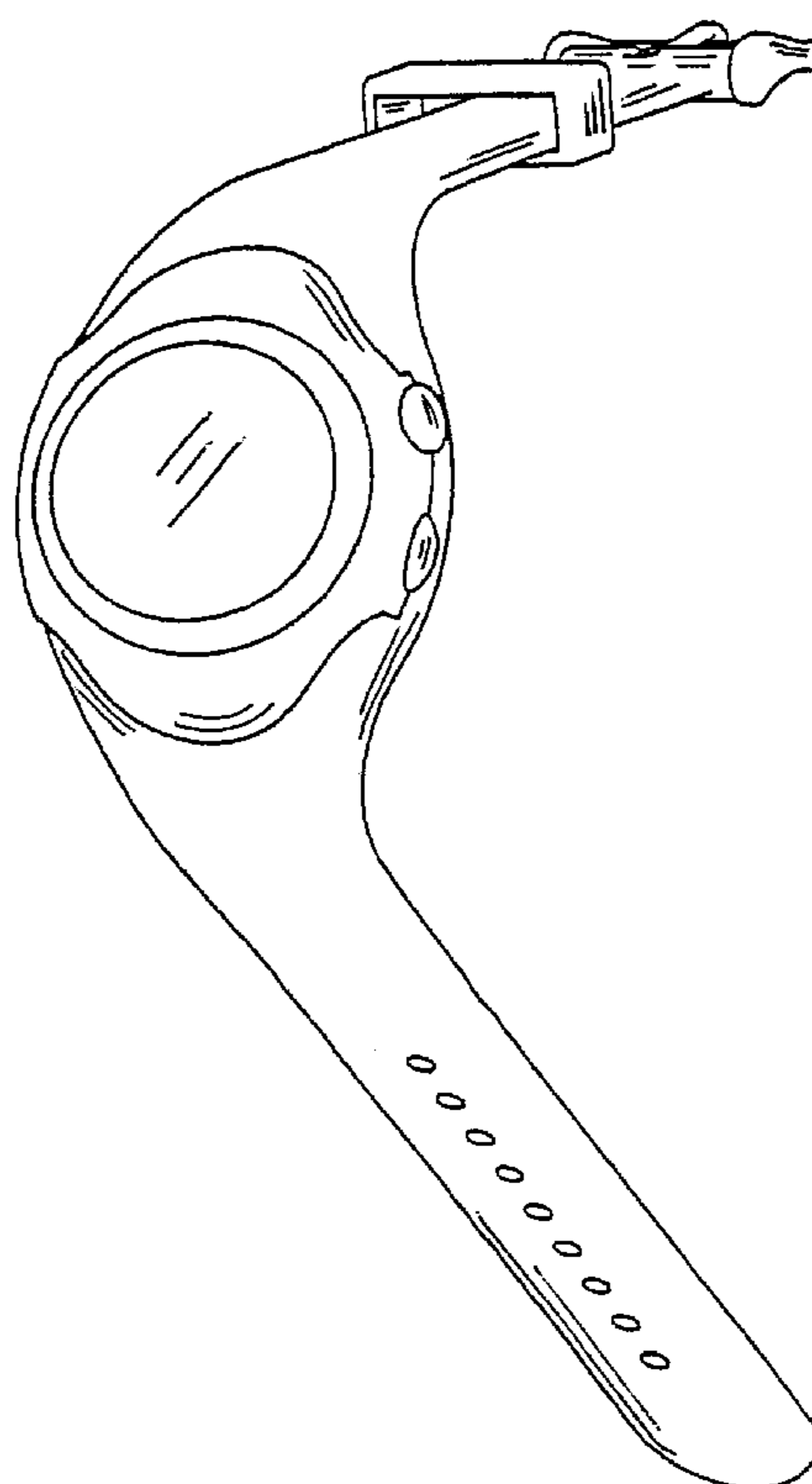
FIG. 4 is a left side view thereof;

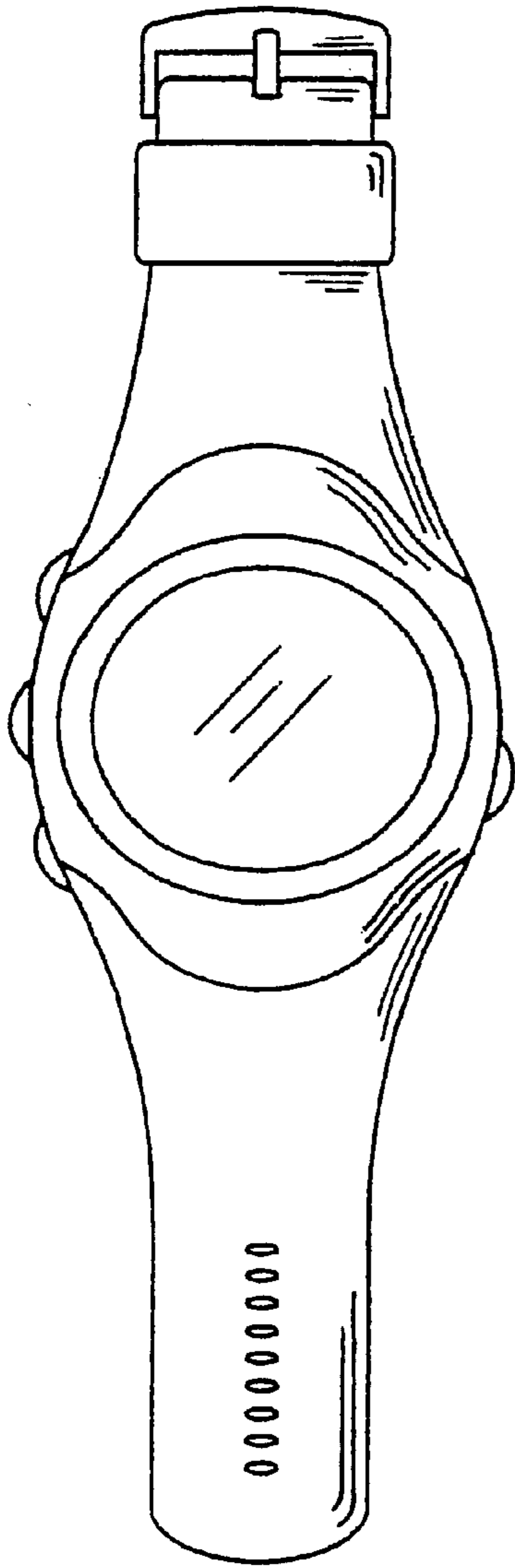

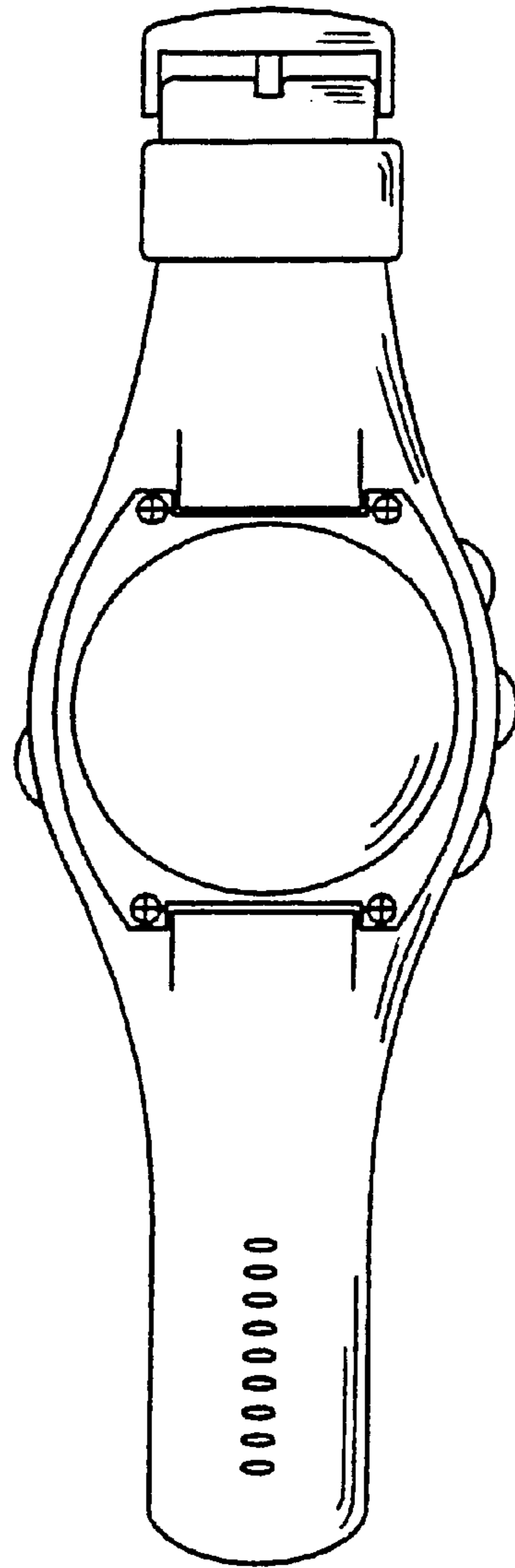

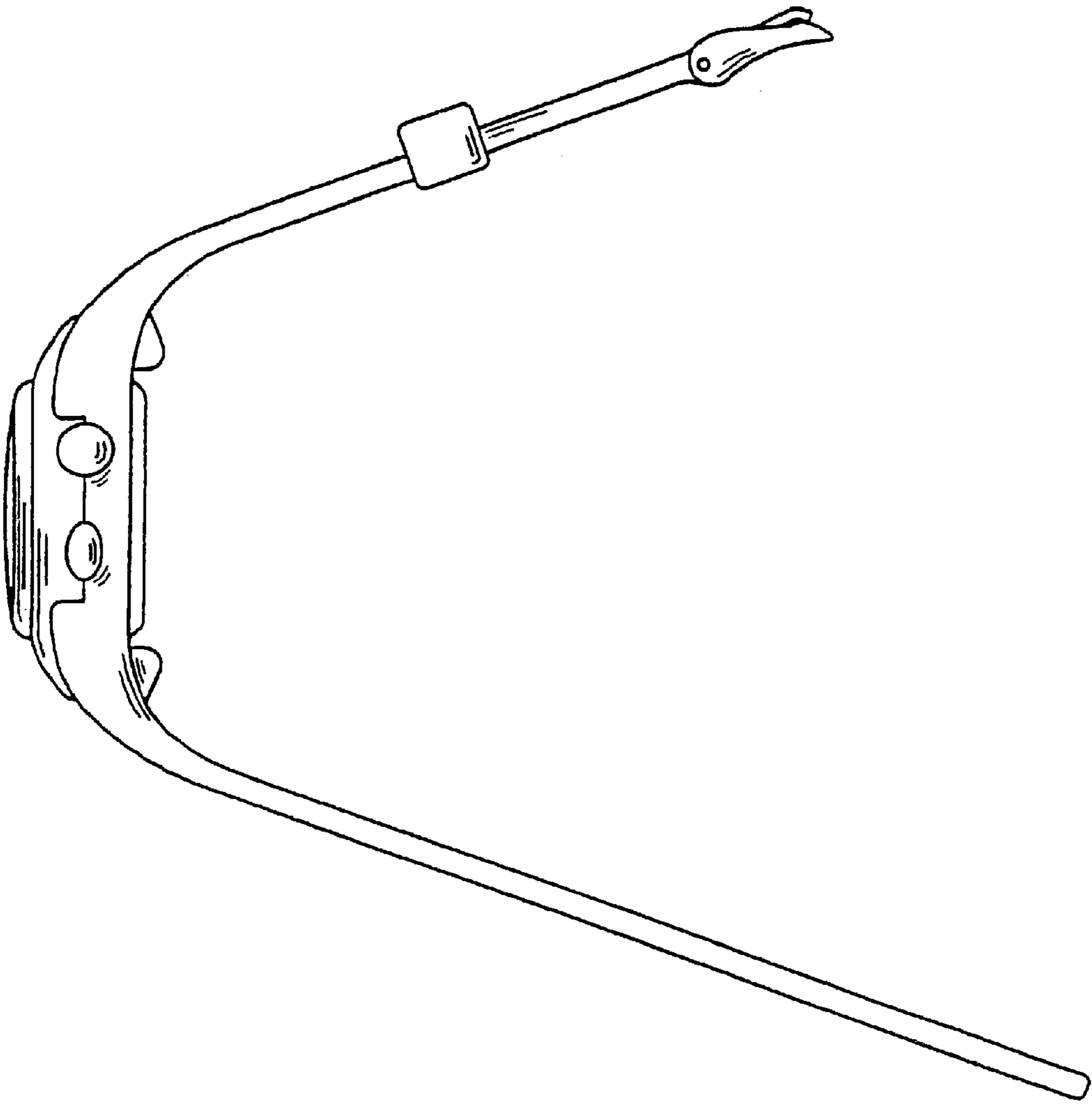

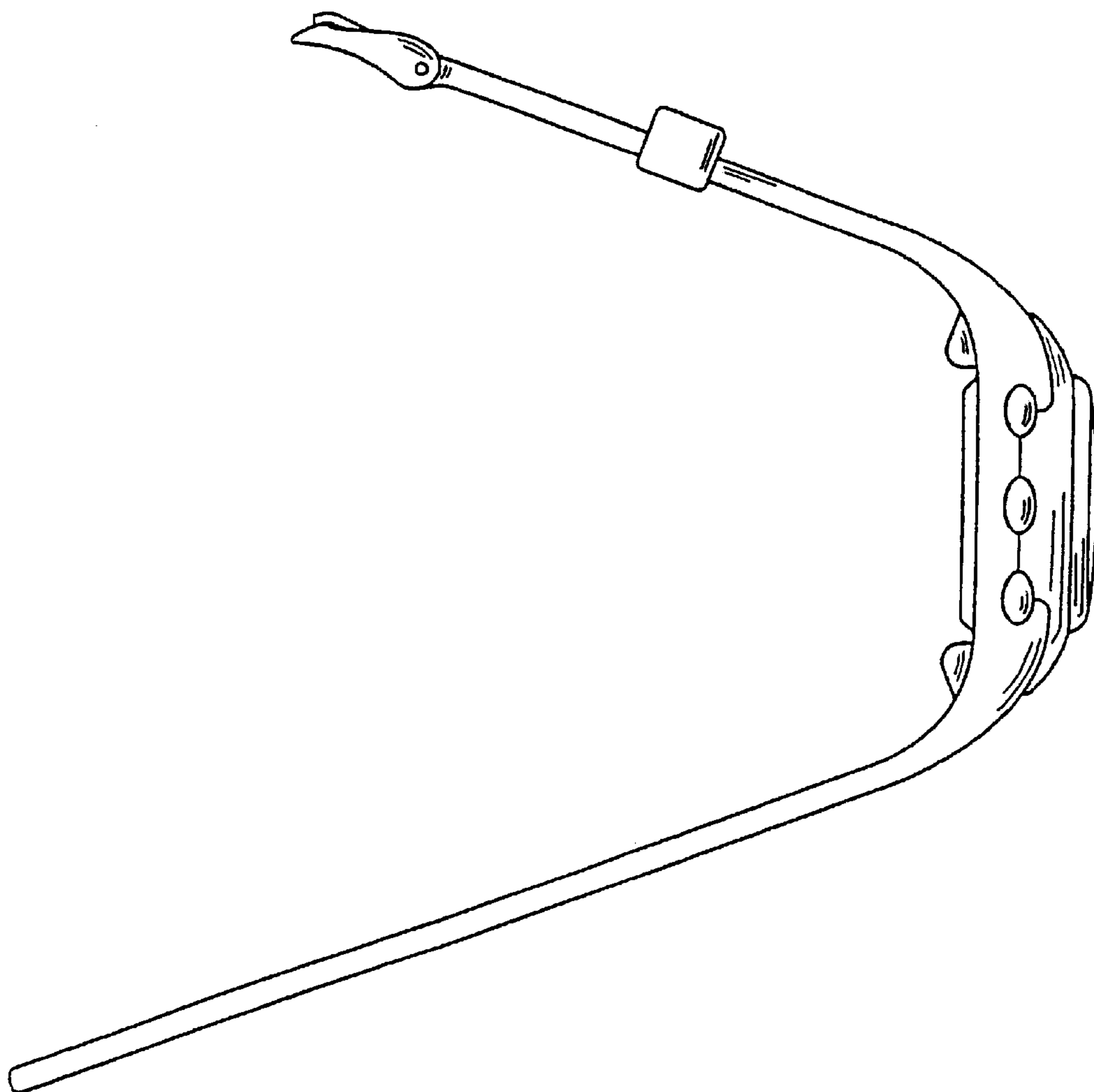

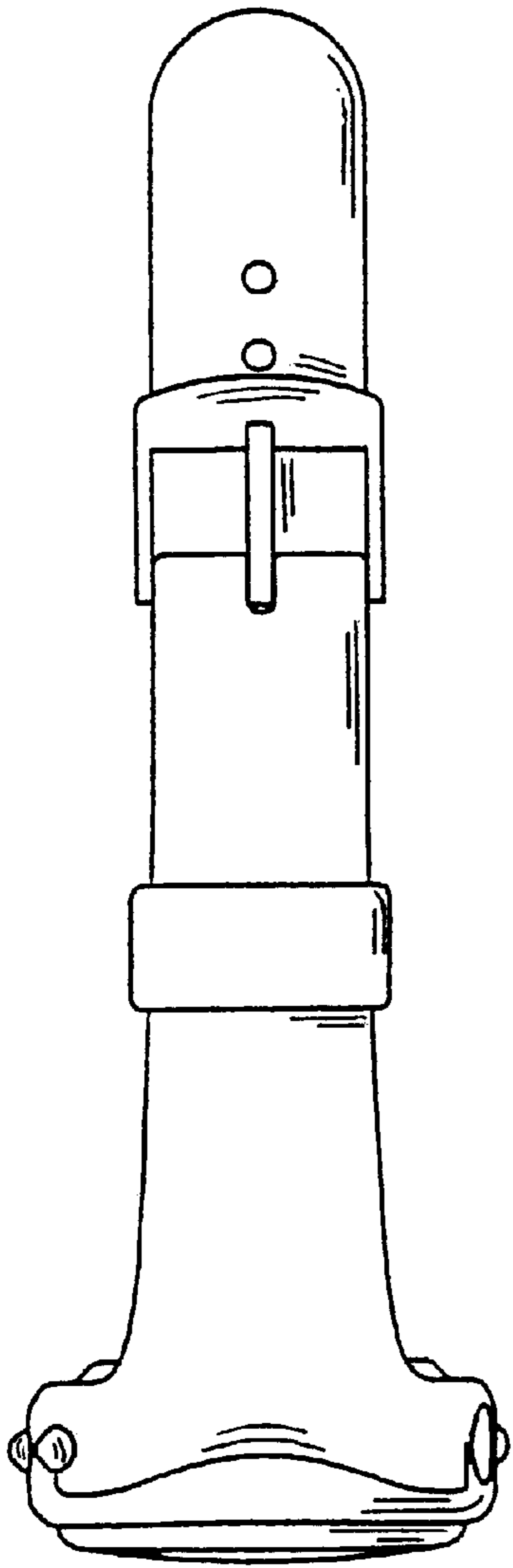

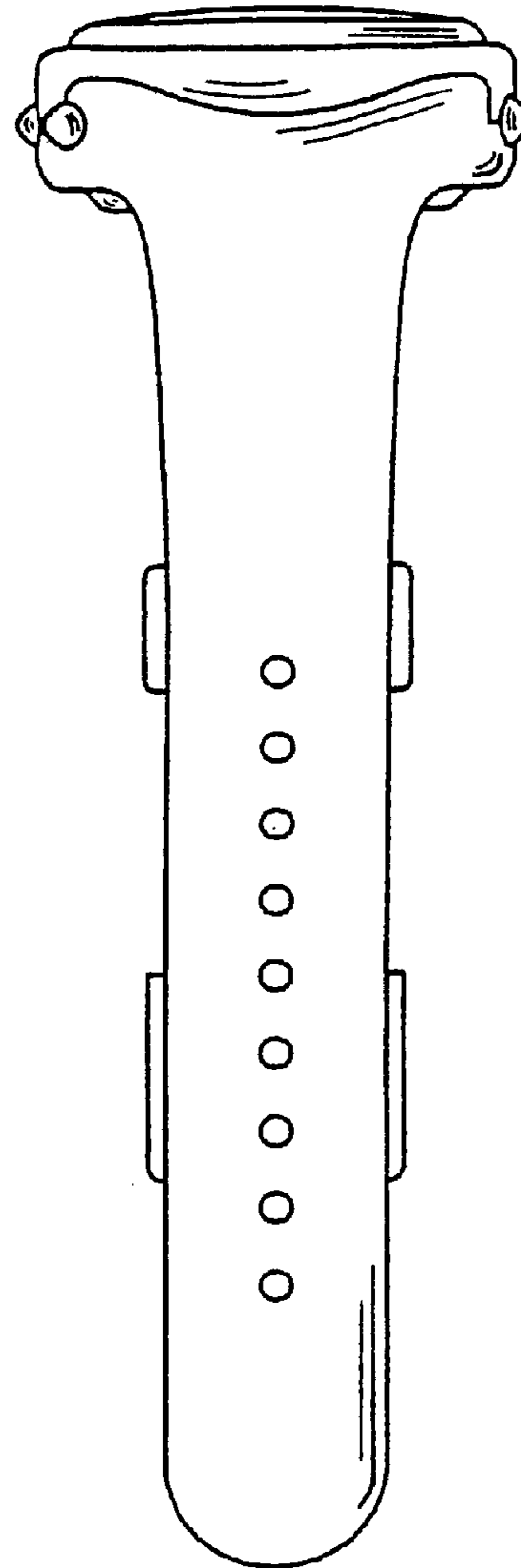
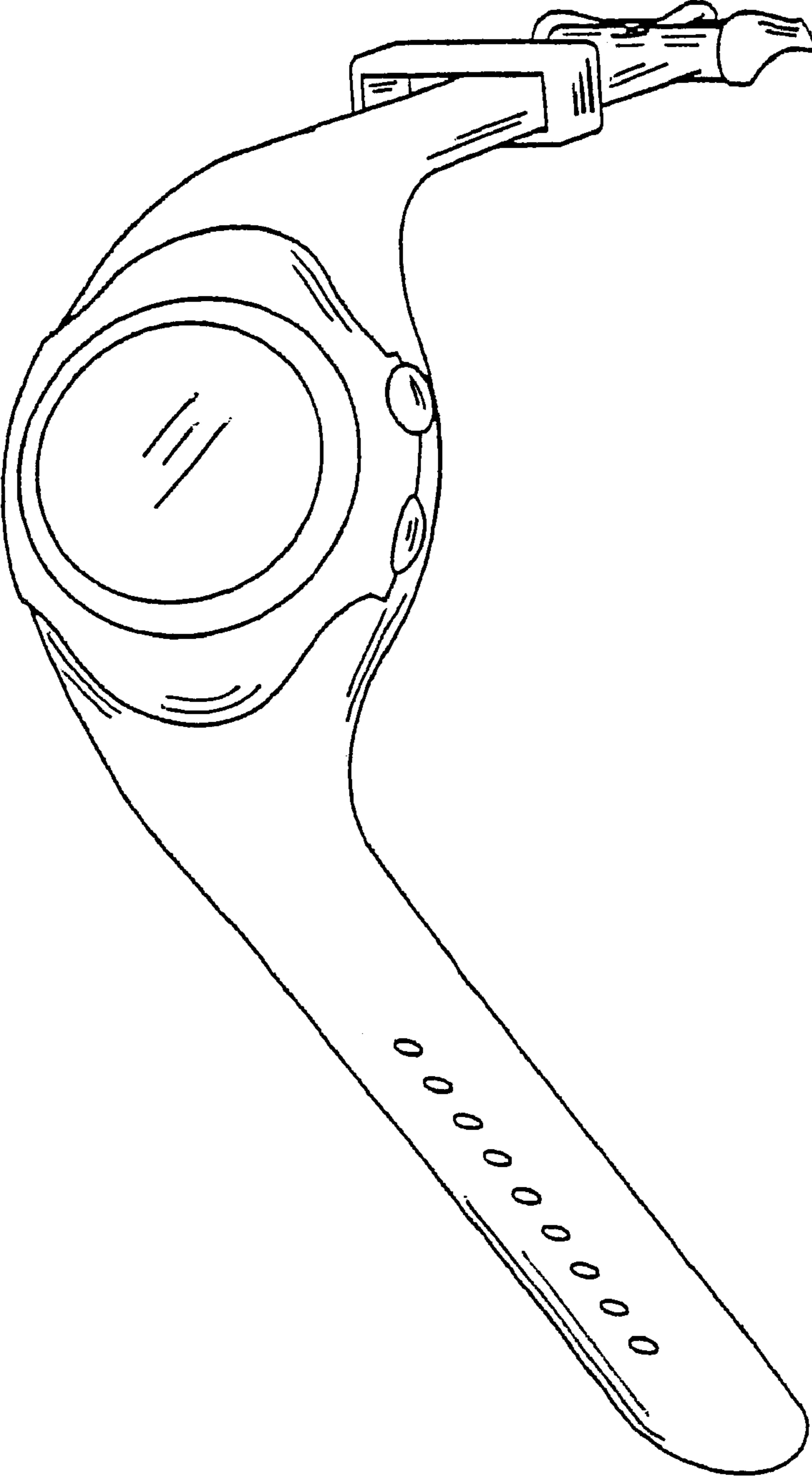
