(57) **CLAIM**

The ornamental design for a bracelet, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevated perspective view of a bracelet showing my new design;

FIG. 2 is a front view of the bracelet of FIG. 1;

FIG. 3 is a rear view of the bracelet of FIG. 1;

FIG. 4 is a side view, taken from the right, of the bracelet of FIG. 1;

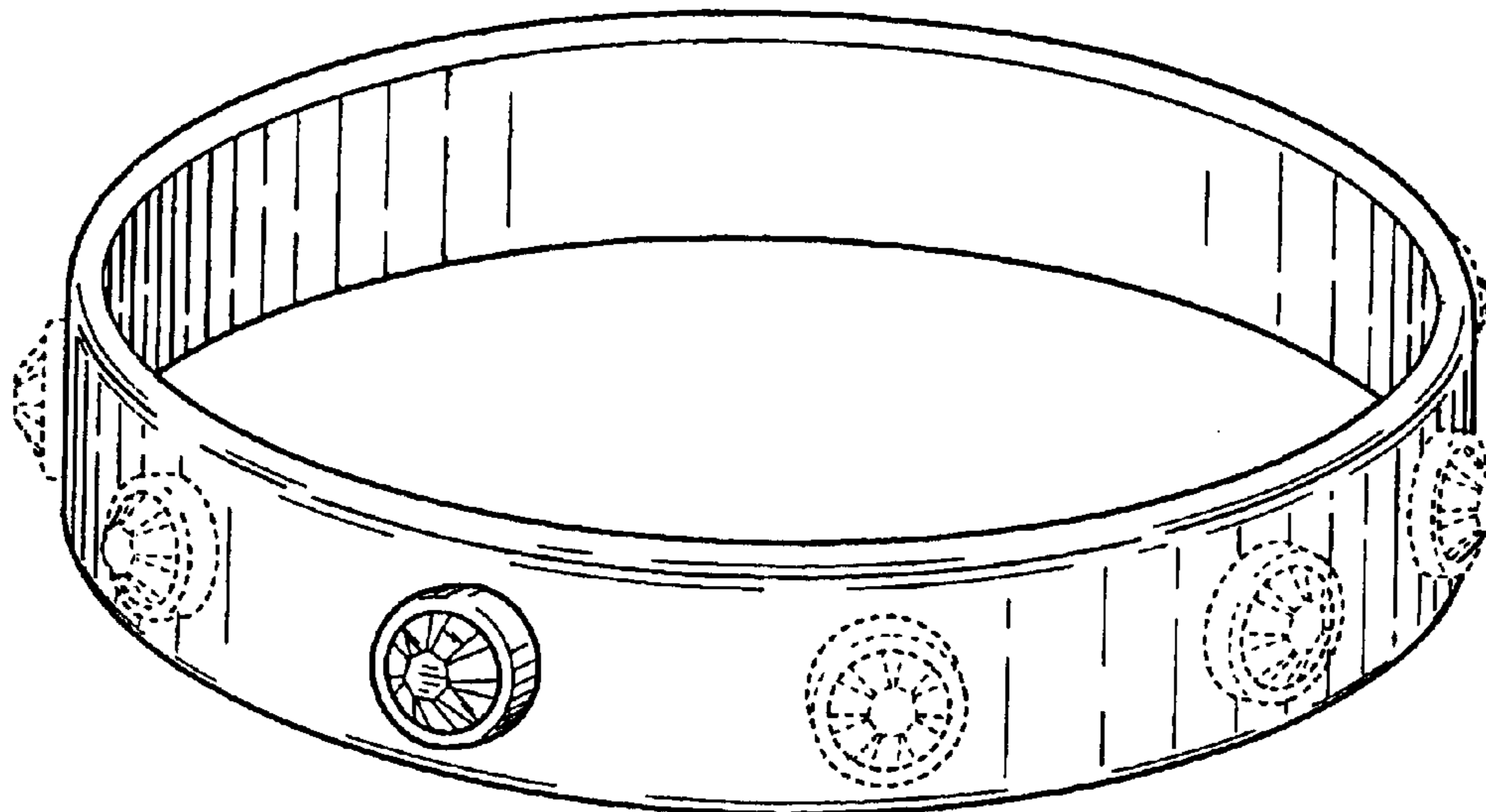
FIG. 5 is a side view, taken from the left, of the bracelet of FIG. 1;

FIG. 6 is a top view of the bracelet of FIG. 1; and,

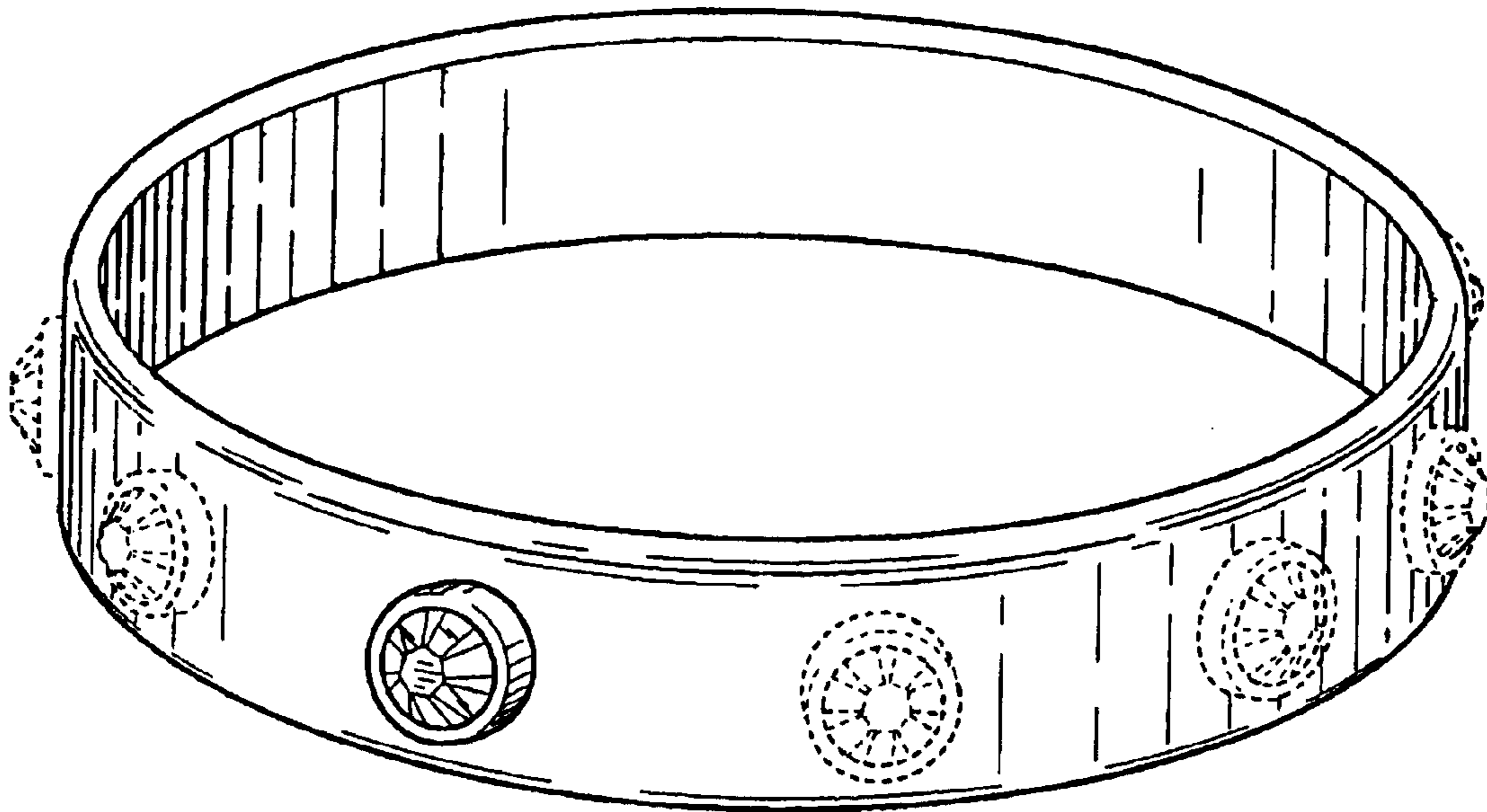
FIG. 7 is a bottom view of the bracelet of FIG. 1.

The objects shown in broken lines form no part of the claimed design and are shown for illustrative purposes.

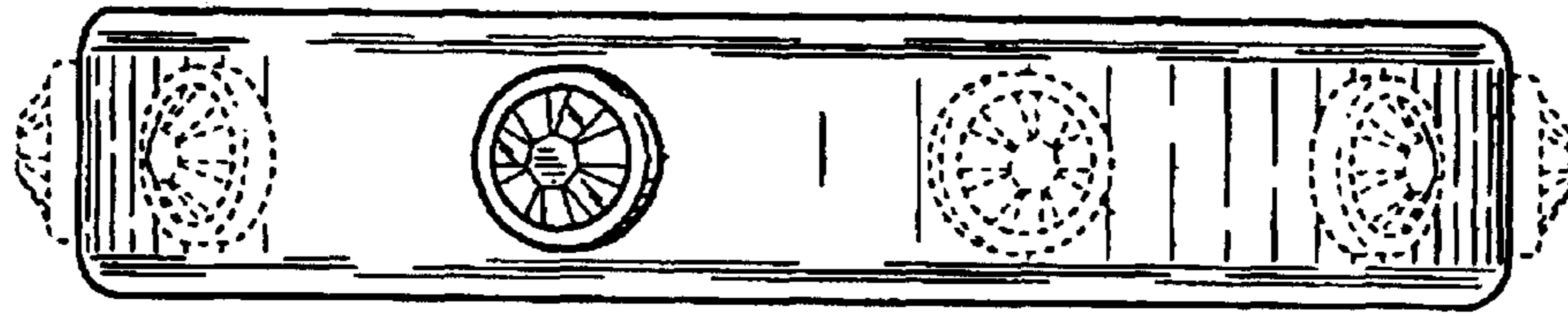

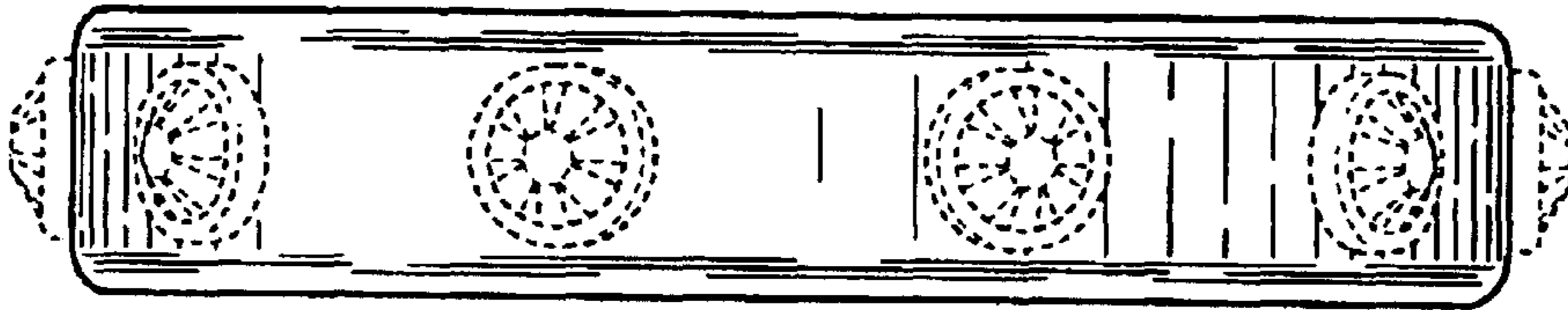

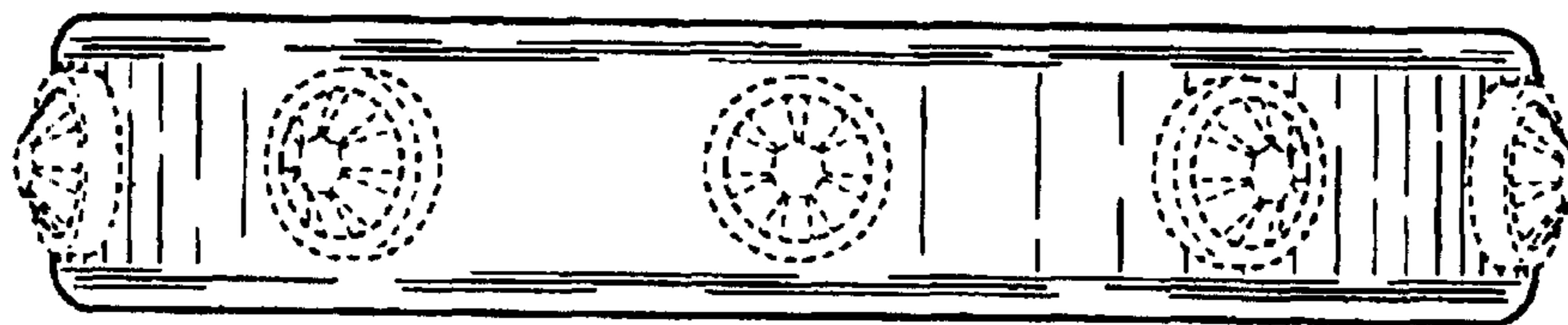

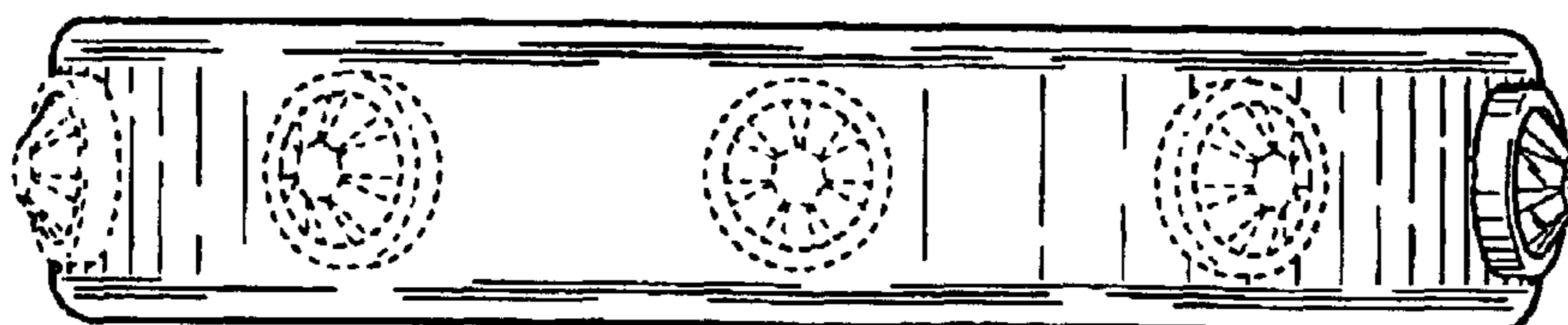

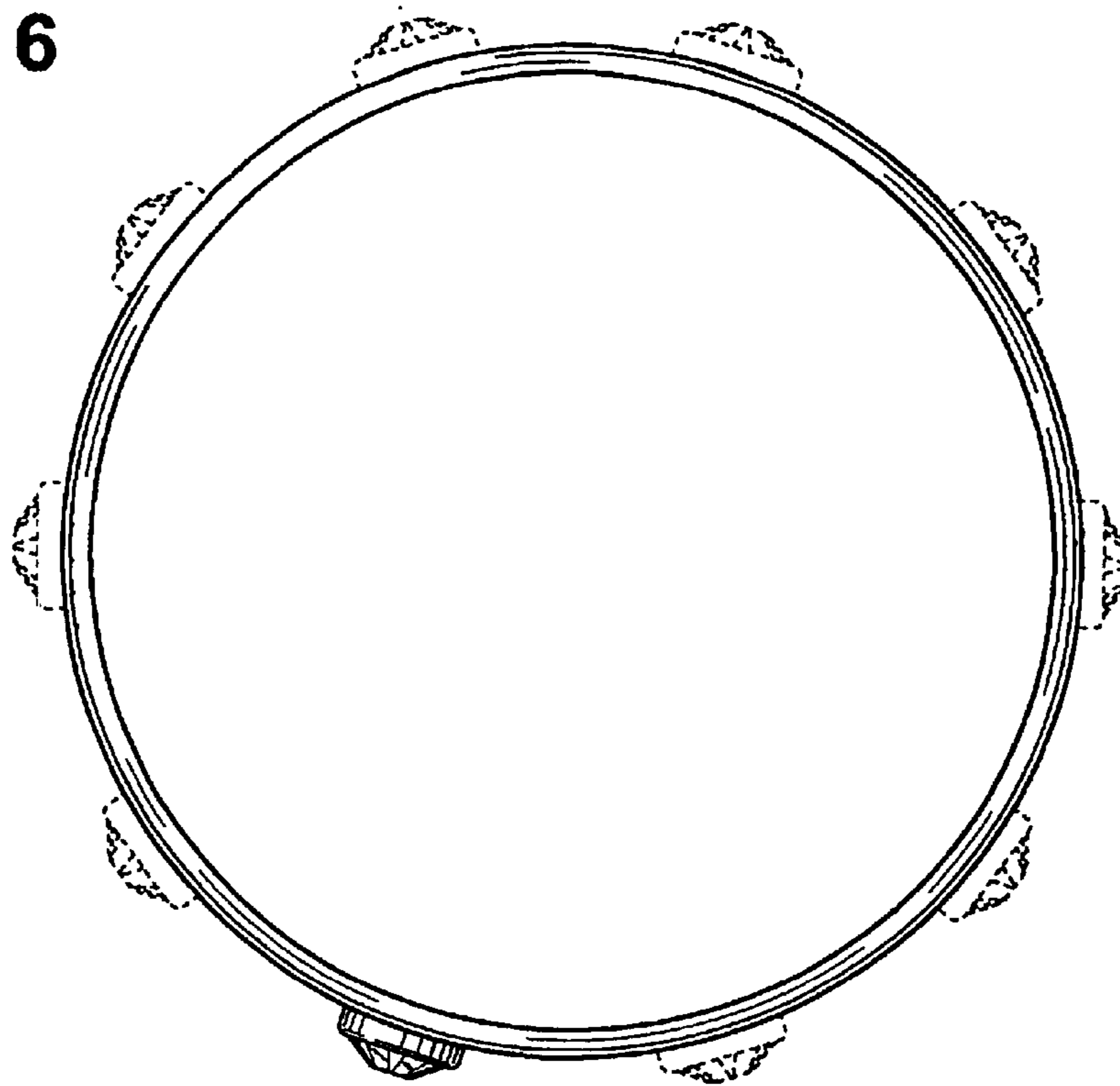
