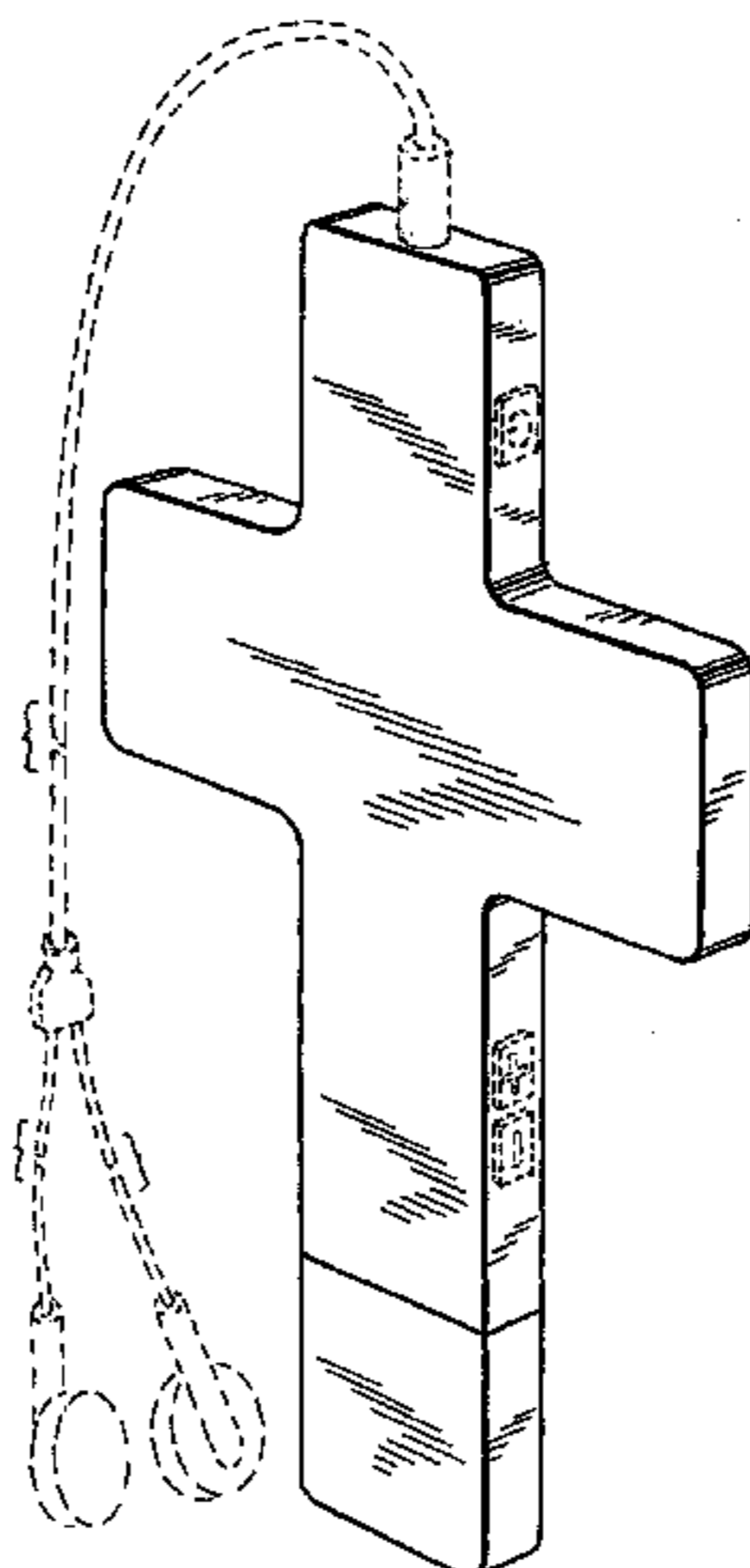
(57) **CLAIM**

I claim the ornamental design for a MP3 cross, as shown and described.

DESCRIPTION

FIG. 1 illustrates a perspective view of a MP3 cross of the present invention;
FIG. 2 illustrates a front view of the MP3 cross of the present invention;
FIG. 3 illustrates a top view of the MP3 cross of the present invention;
FIG. 4 illustrates a left side view of the MP3 cross of the present invention;
FIG. 5 illustrates a right side view of the MP3 cross of the present invention;
FIG. 6 illustrates a bottom view of the MP3 cross of the present invention; and,
FIG. 7 illustrates a front view of the MP3 cross of the present invention showing the cap removed.
The broken lines of FIGS. 1-7 are for illustrative purposes only and form no part of the claimed design.

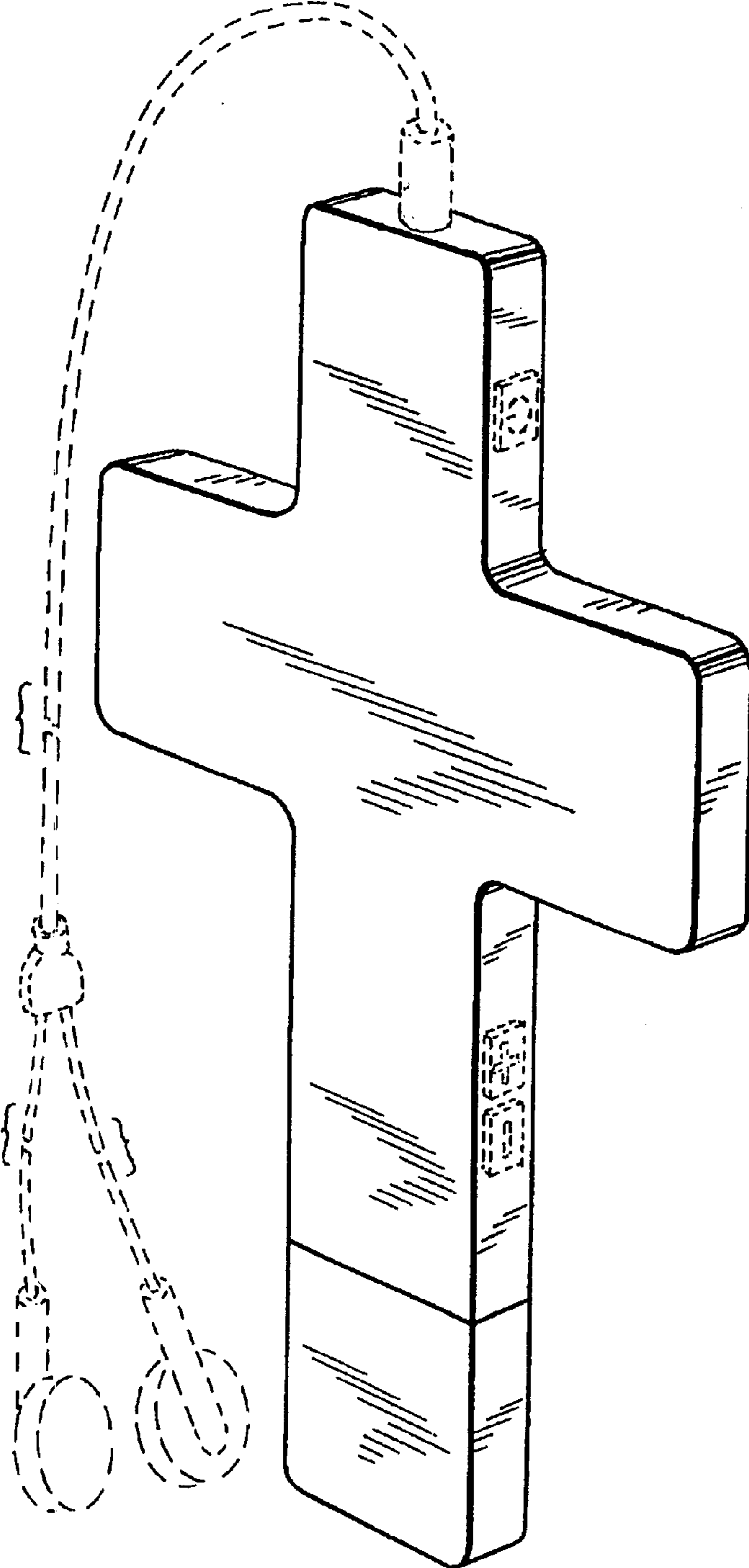

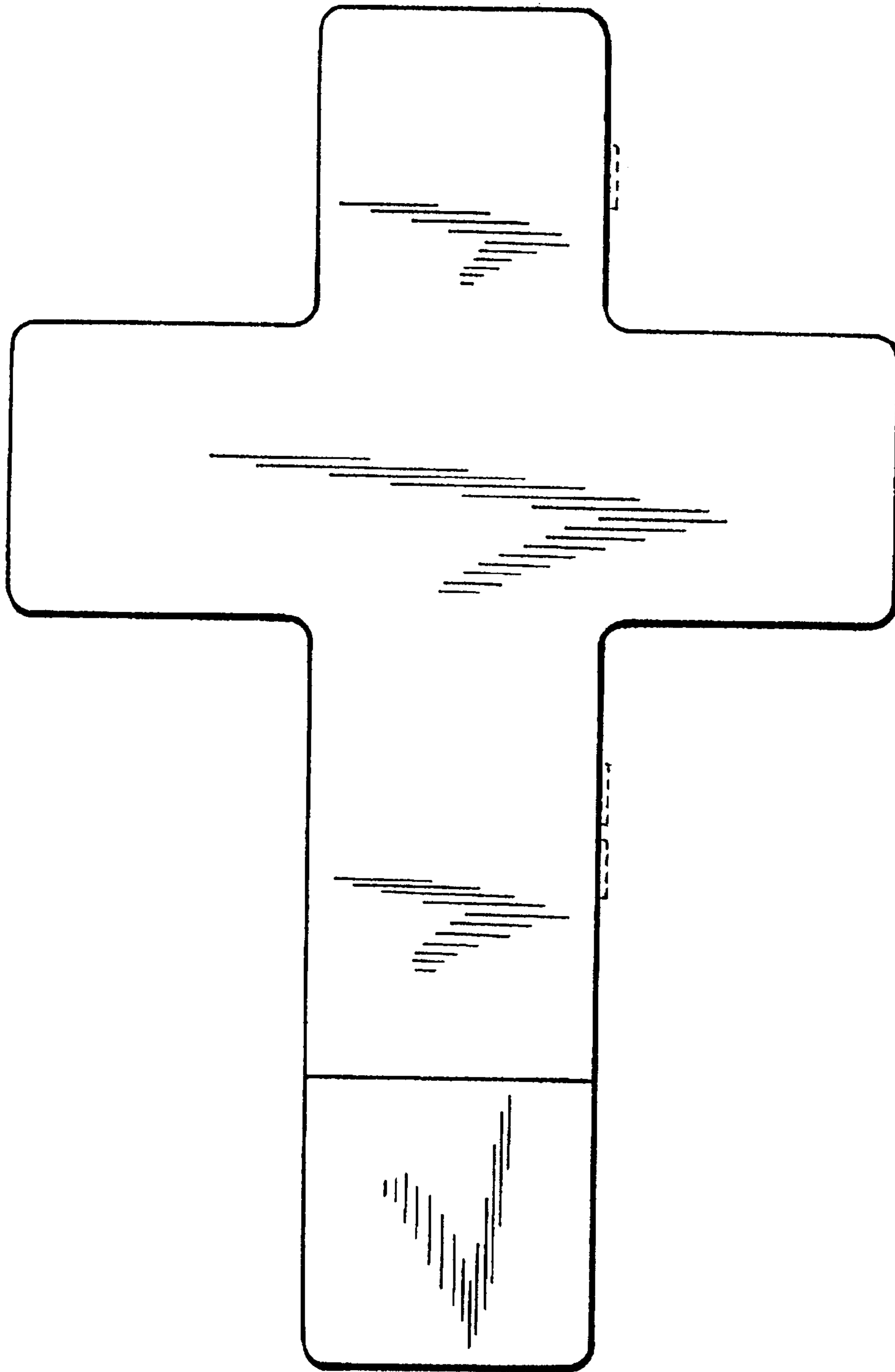

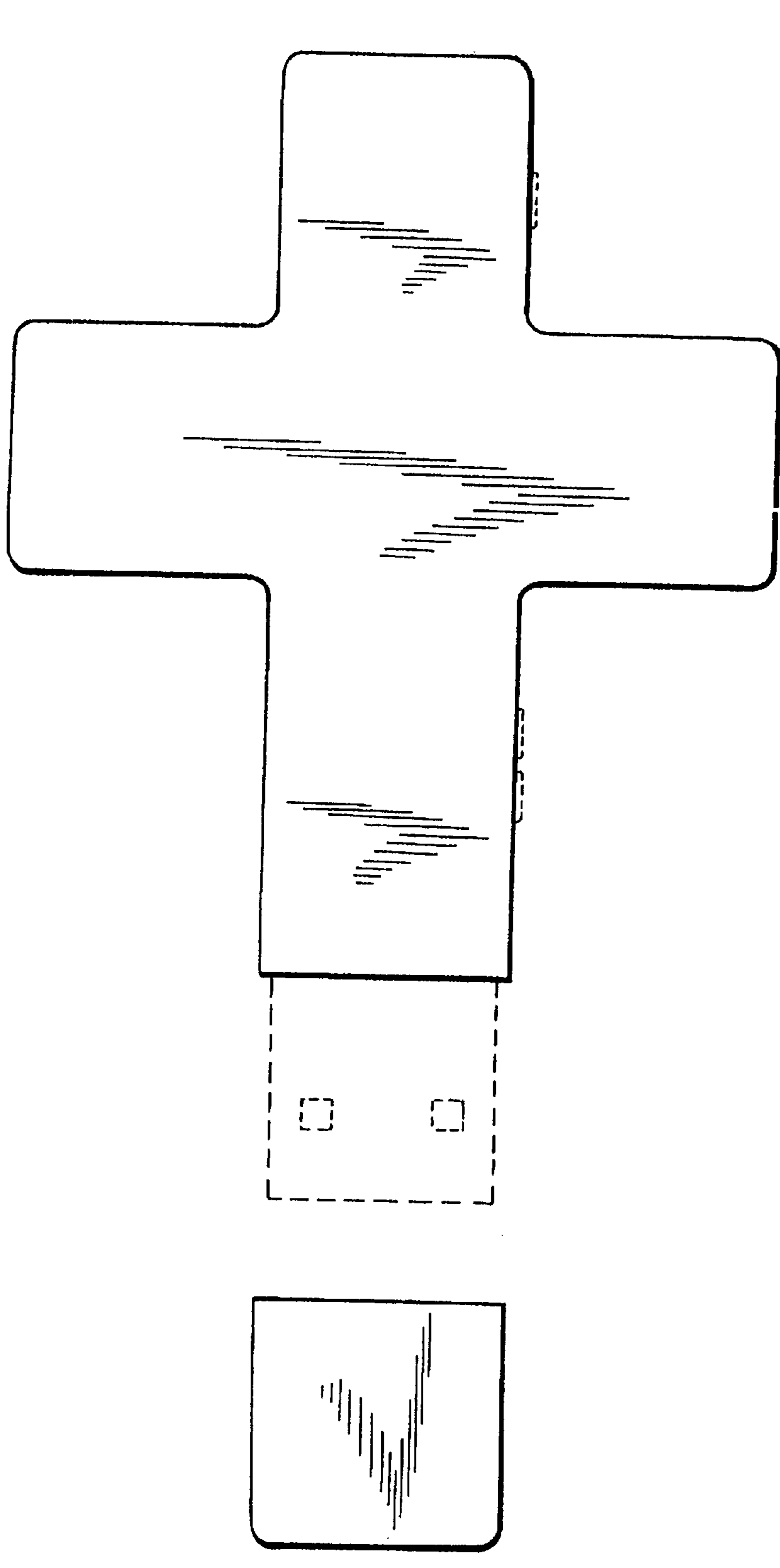
