DESCRIPTION

FIG. 1 is a perspective view of a combined sound generating toy and speaker;

FIG. 2 is a front view thereof;

FIG. 3 is a right side view thereof (the left side view being a mirror image to the right side view);

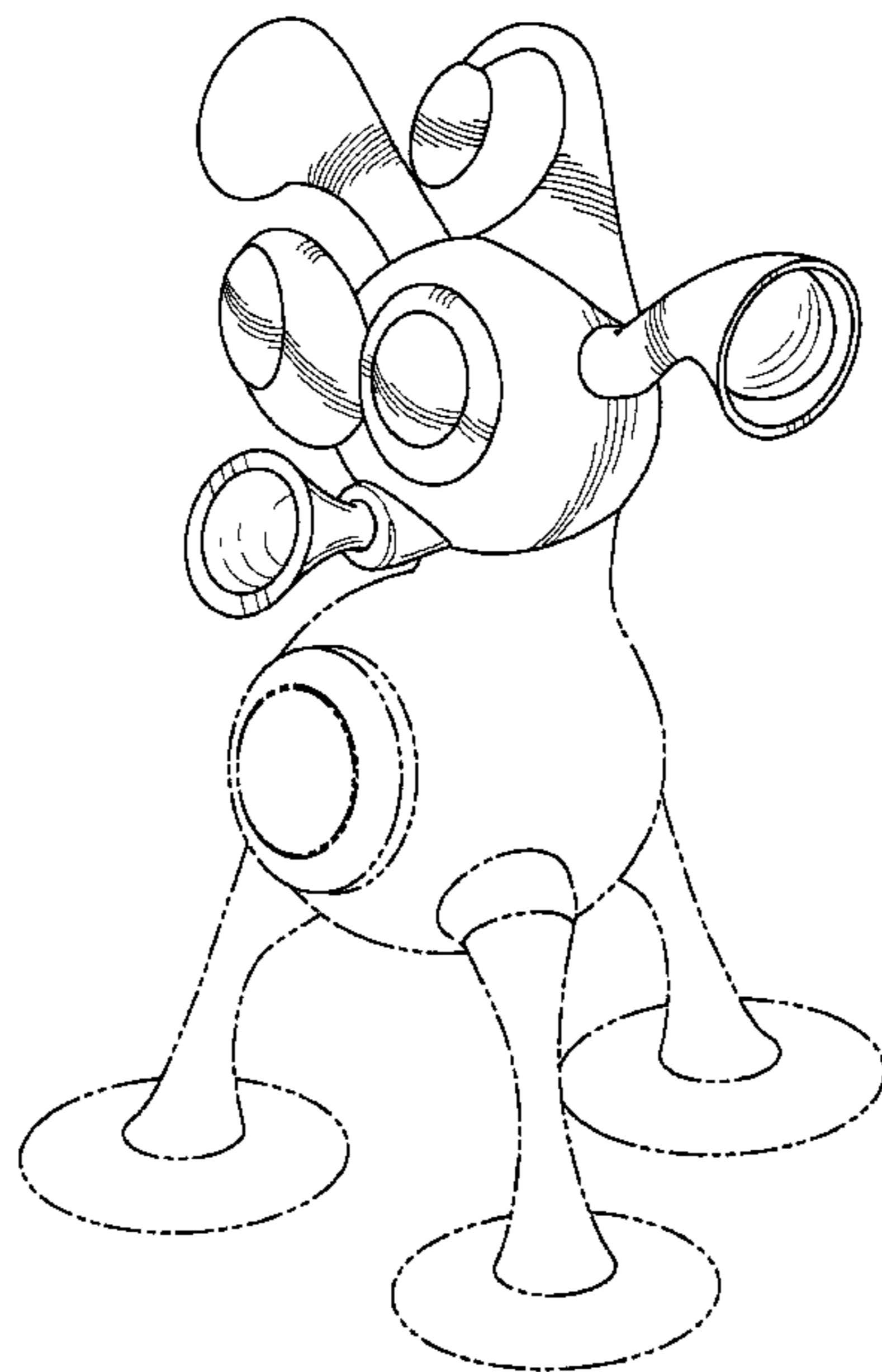
FIG. 4 is a rear view thereof;

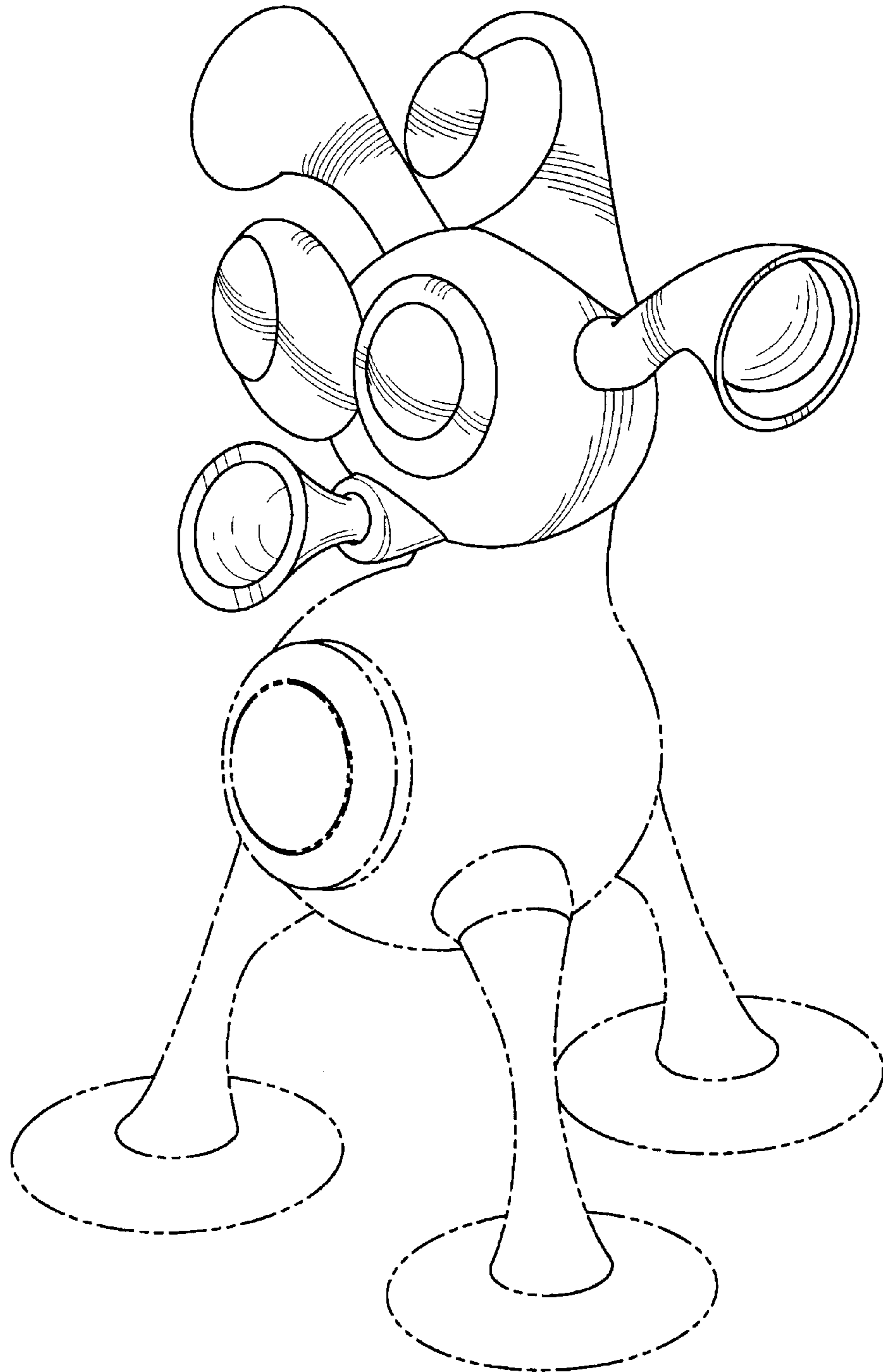

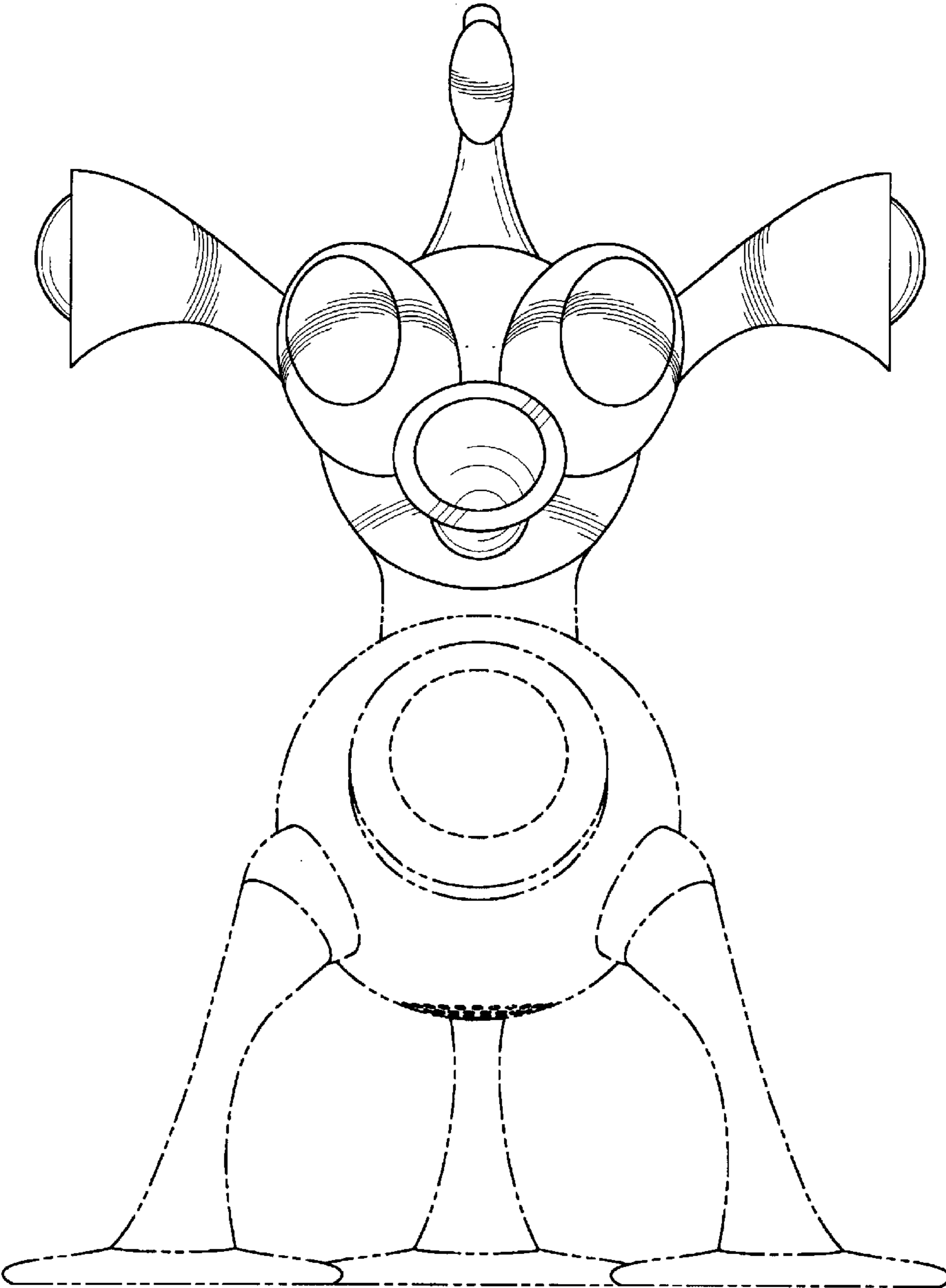

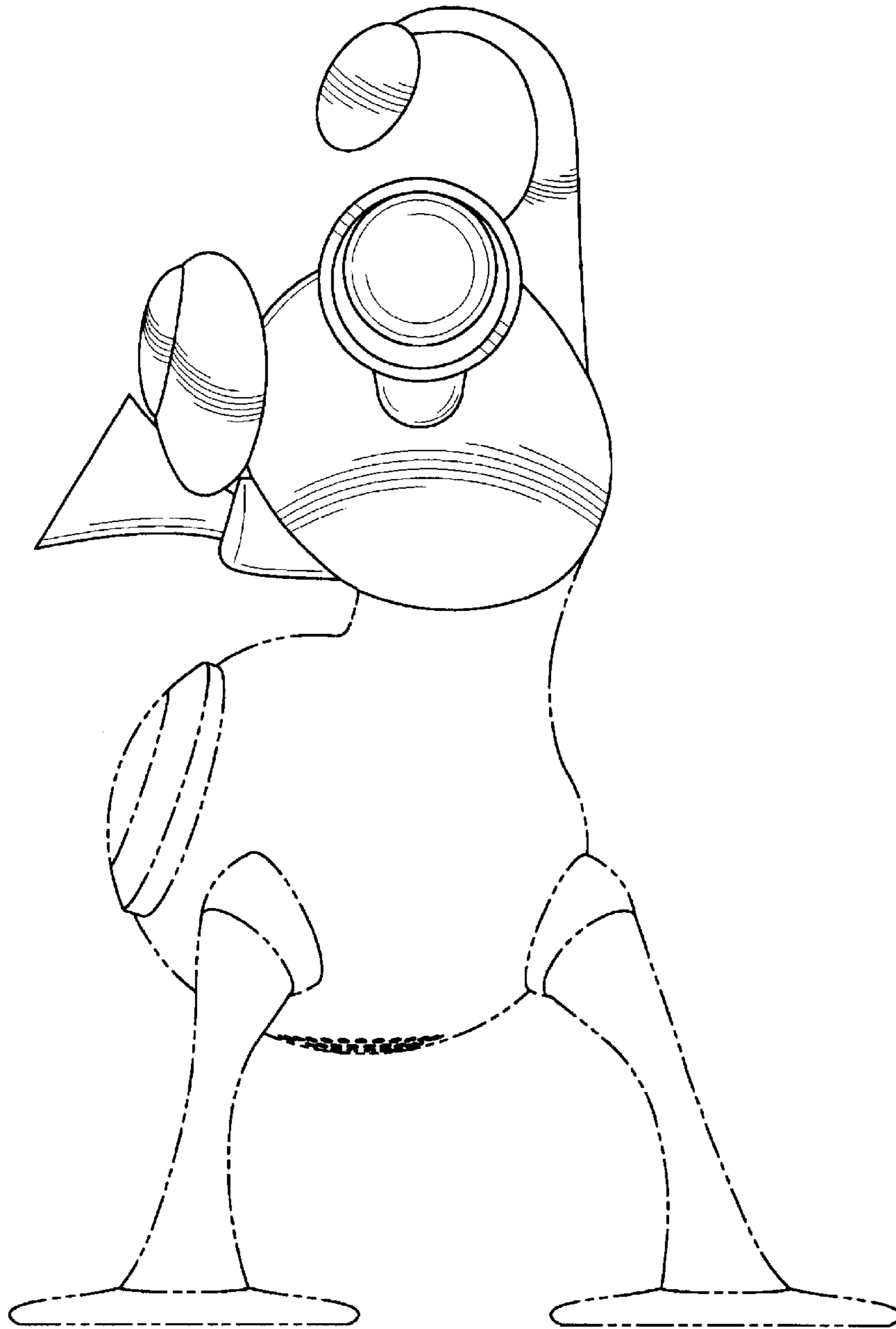

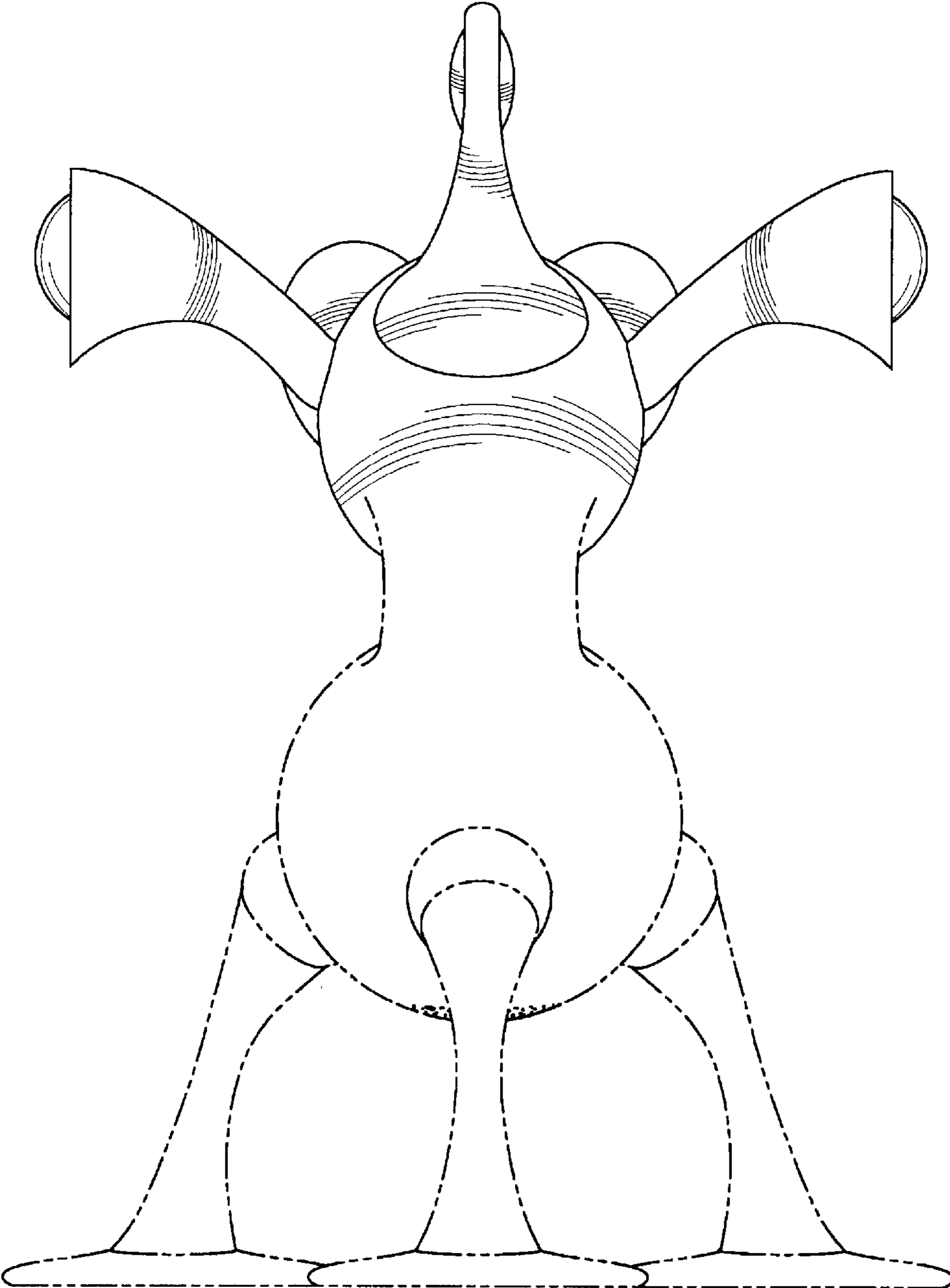

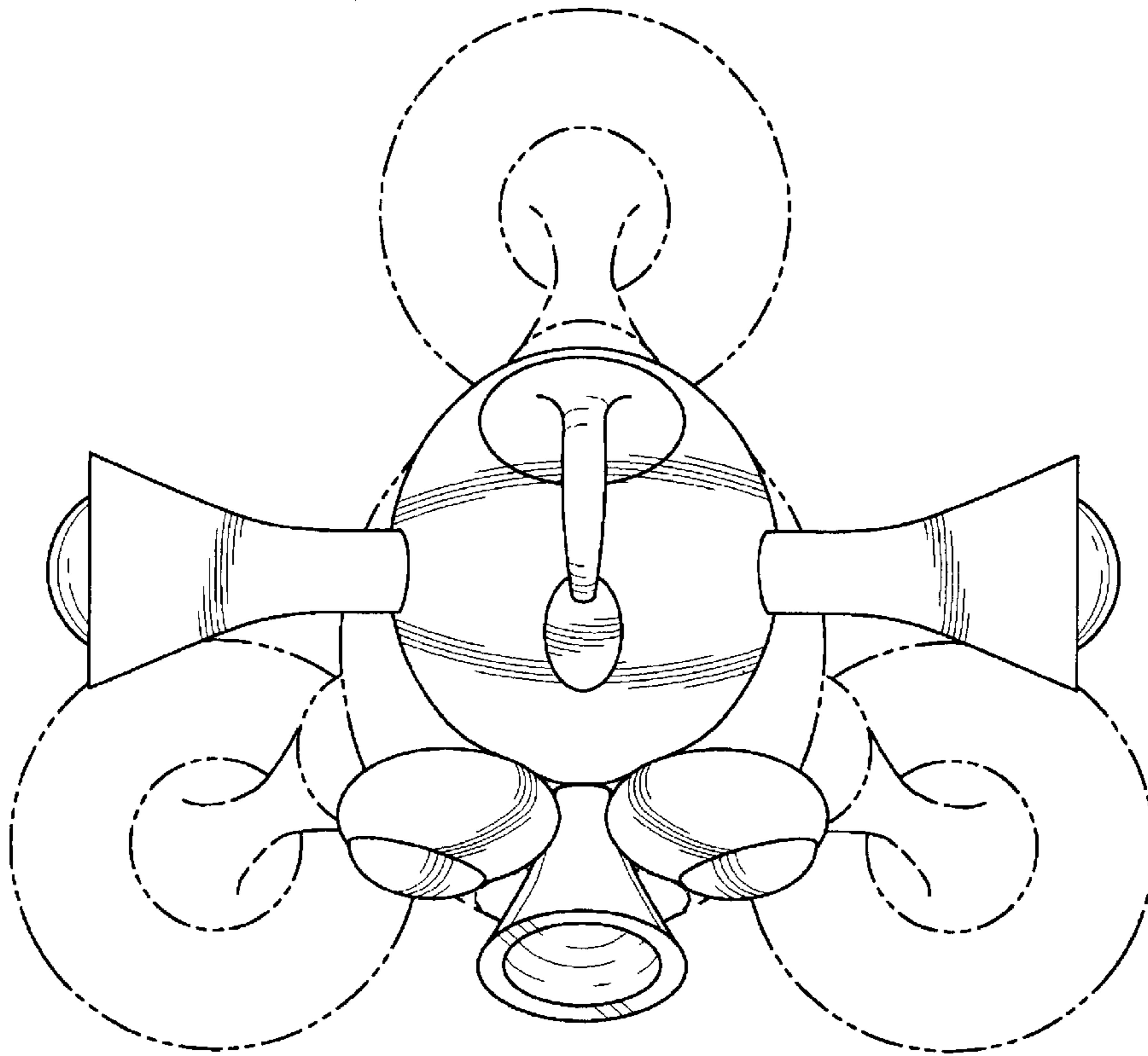

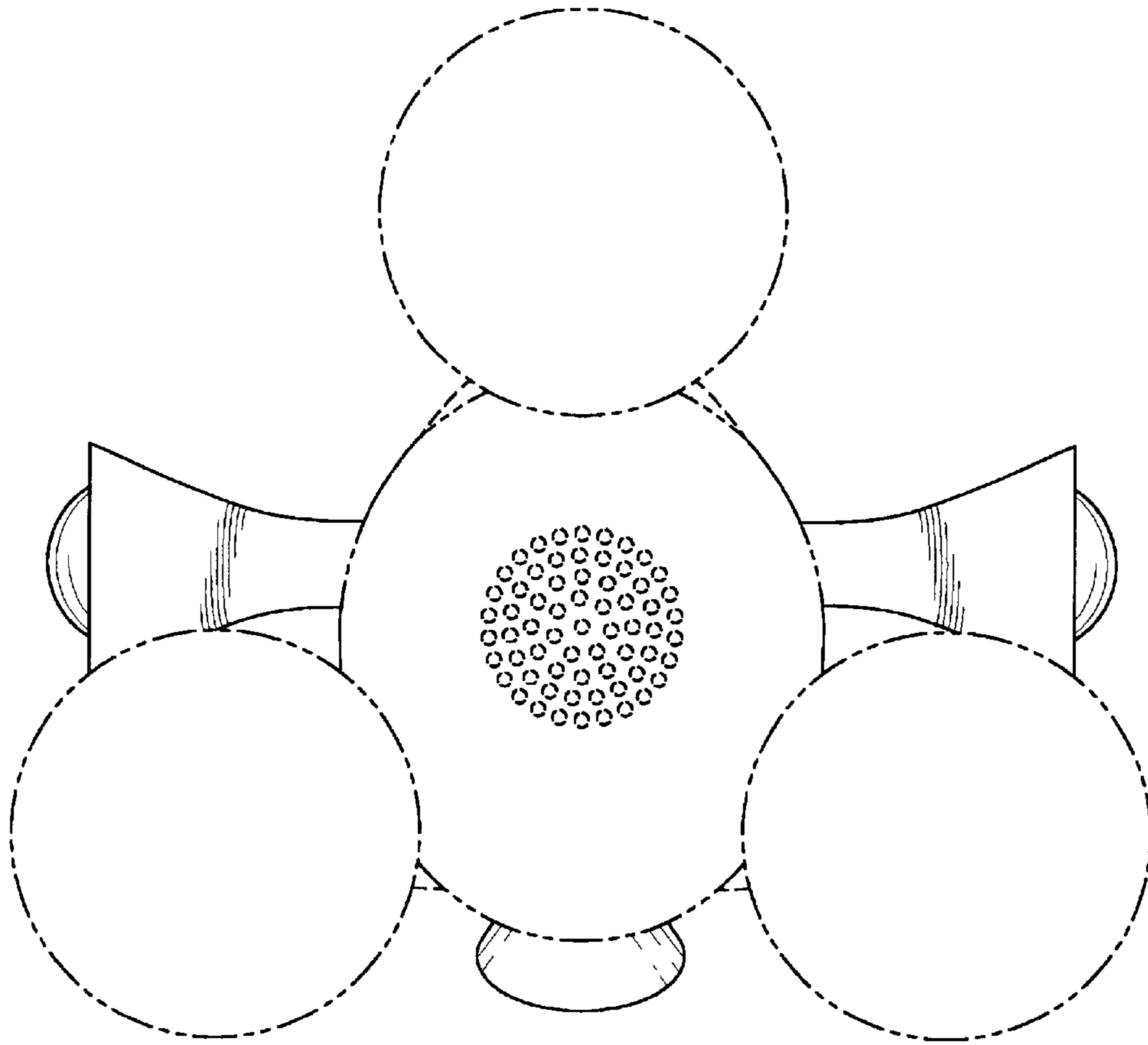
