The ornamental design for a hair comb, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hair comb showing my new design;

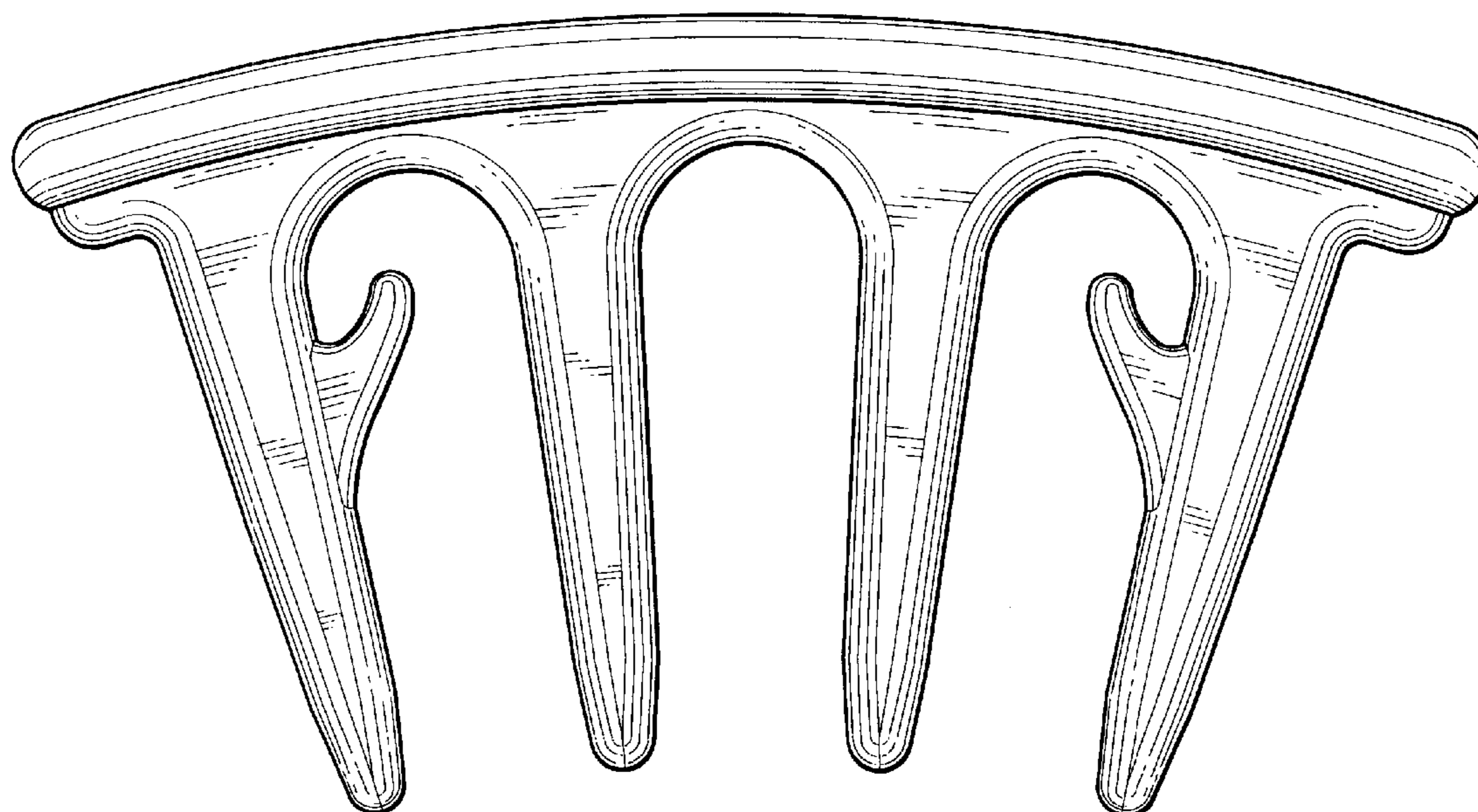

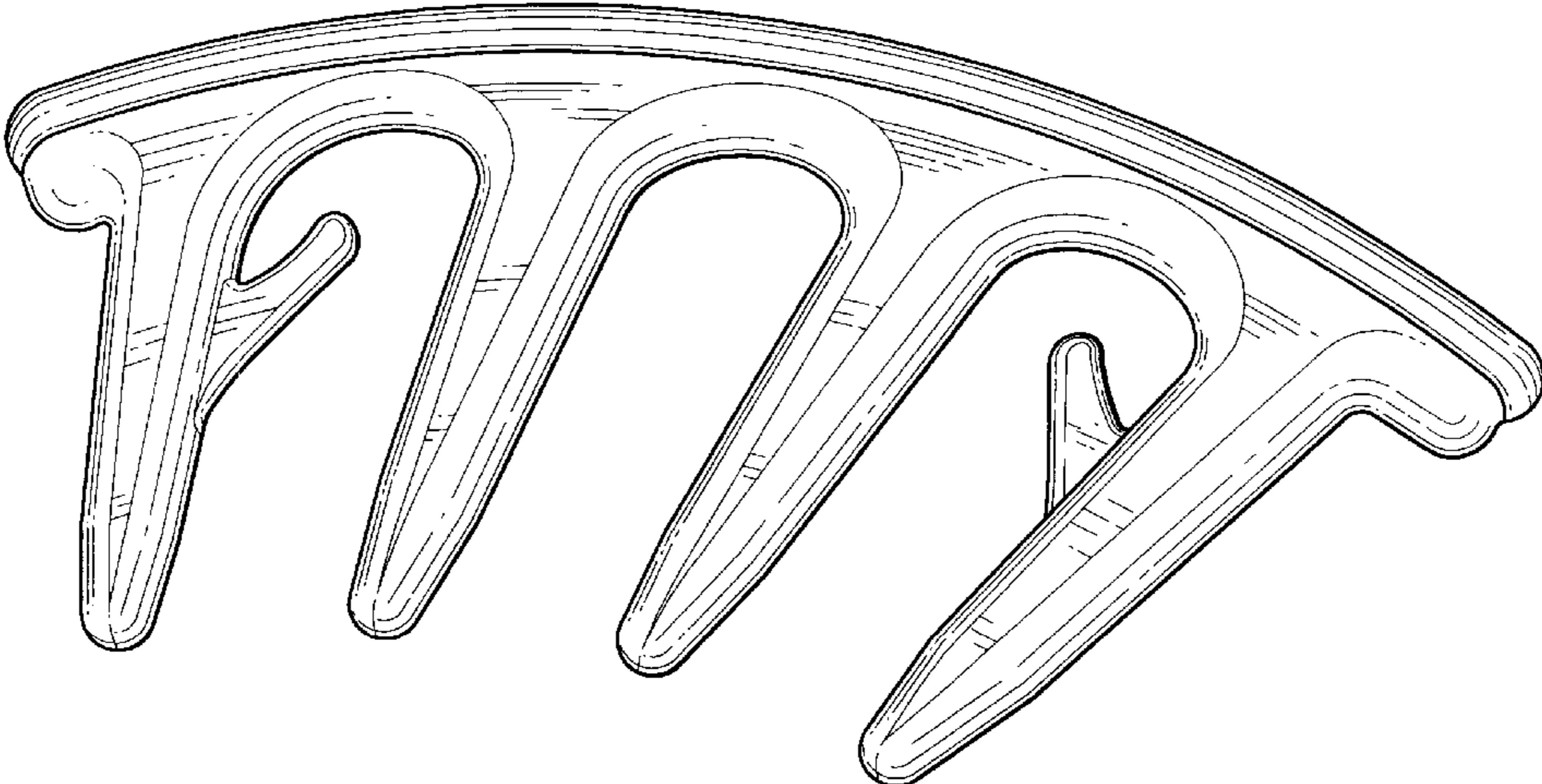

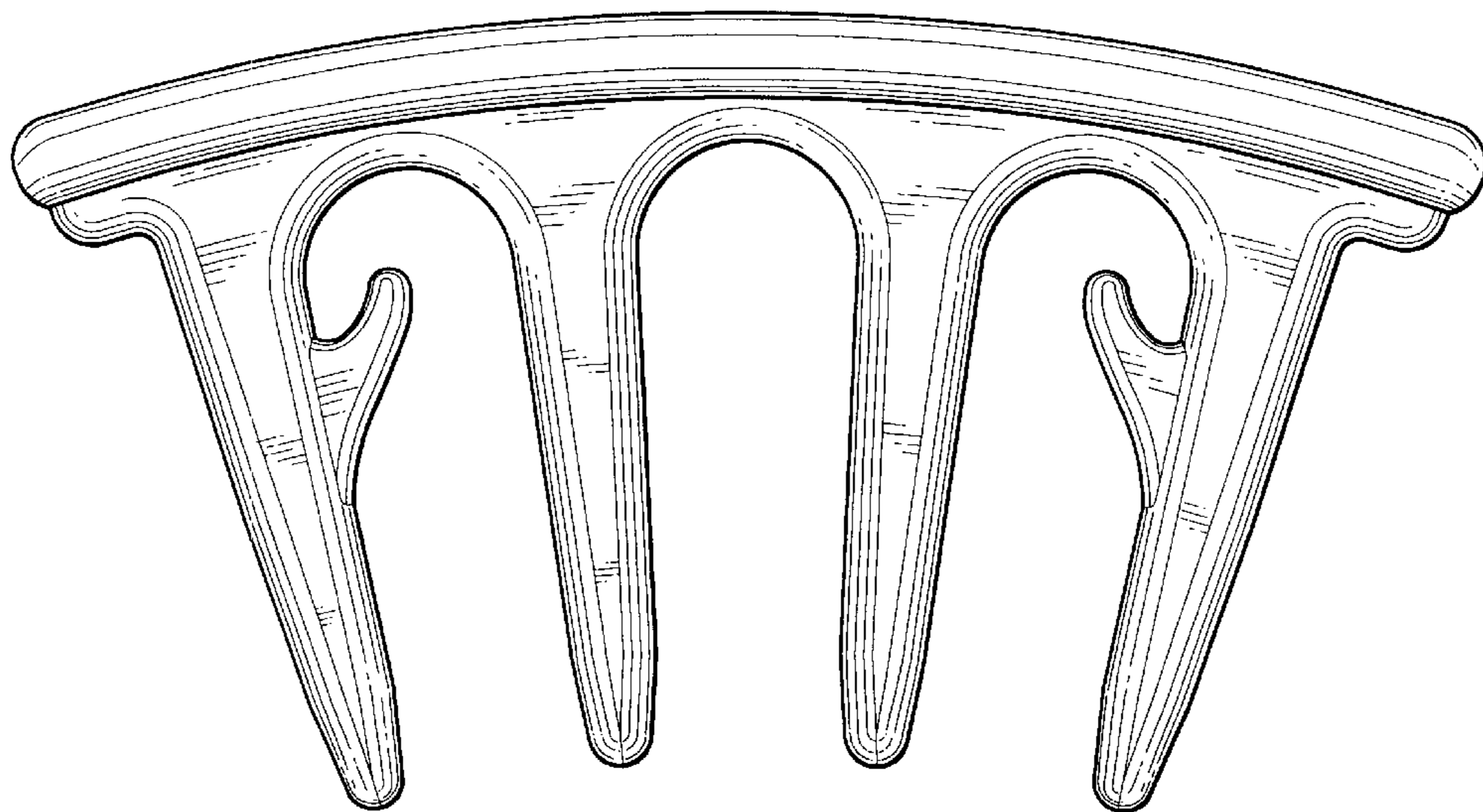

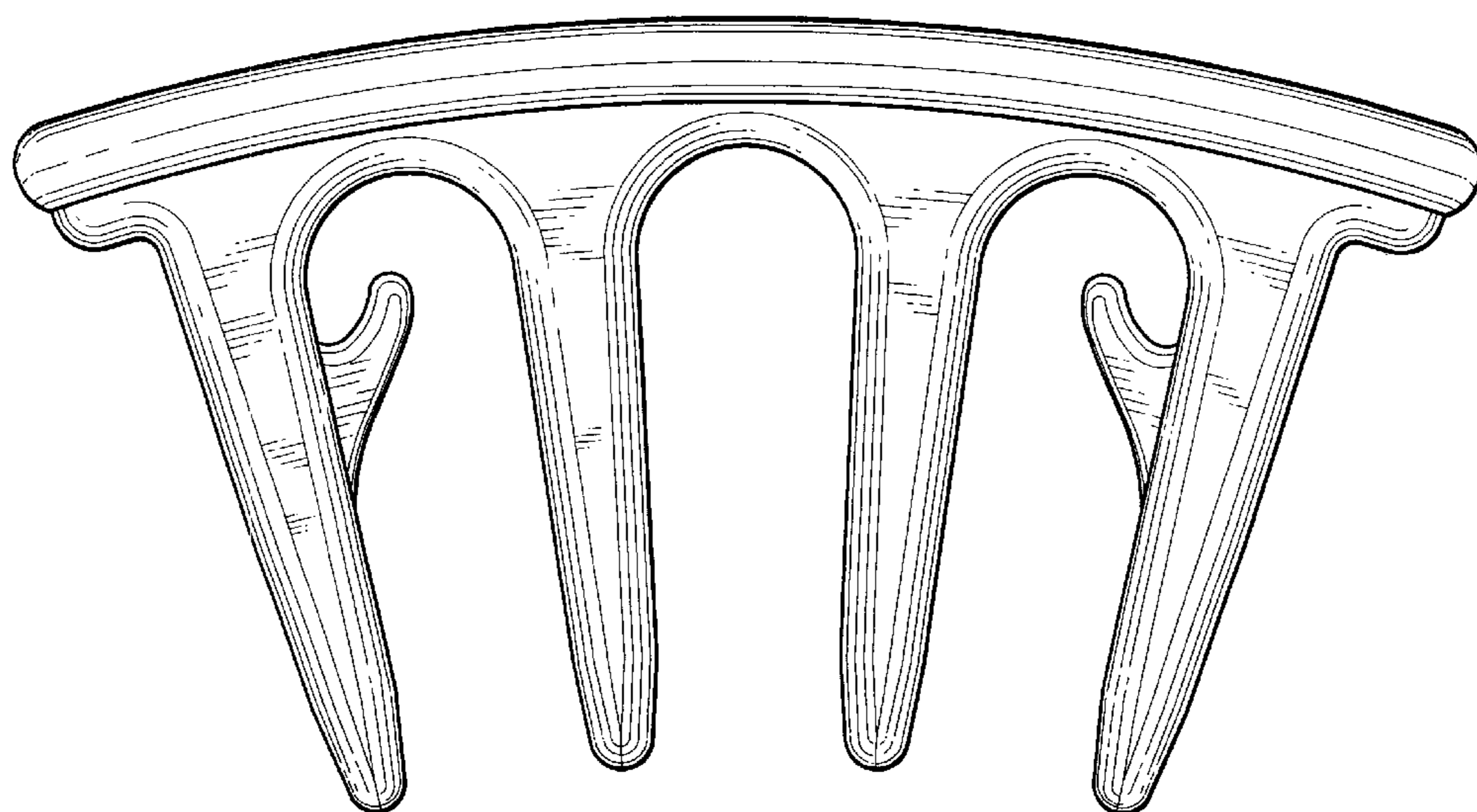

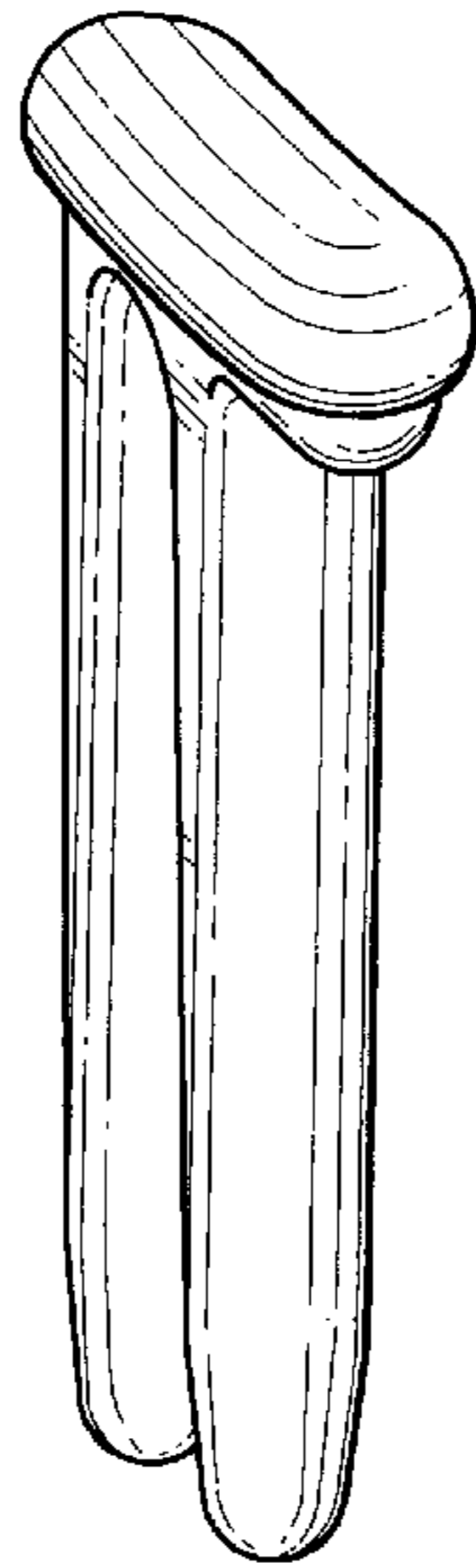
