FIG. 1;

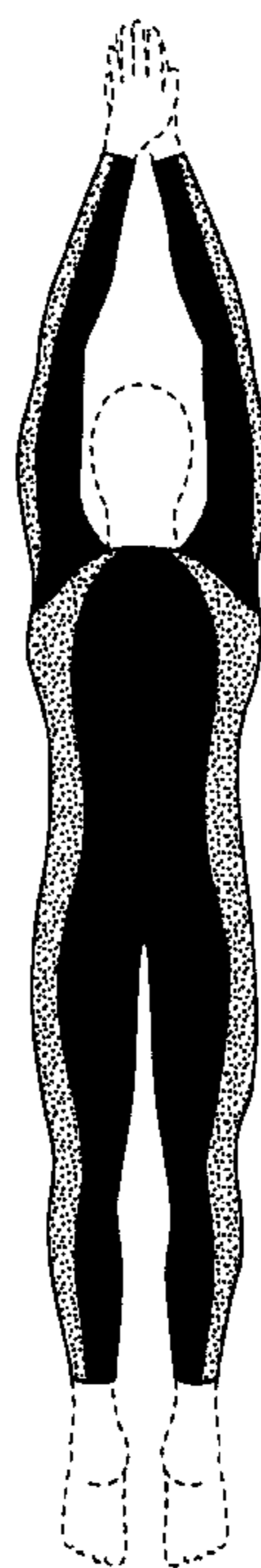
FIG. 3 is a side view of the swimming costume shown in

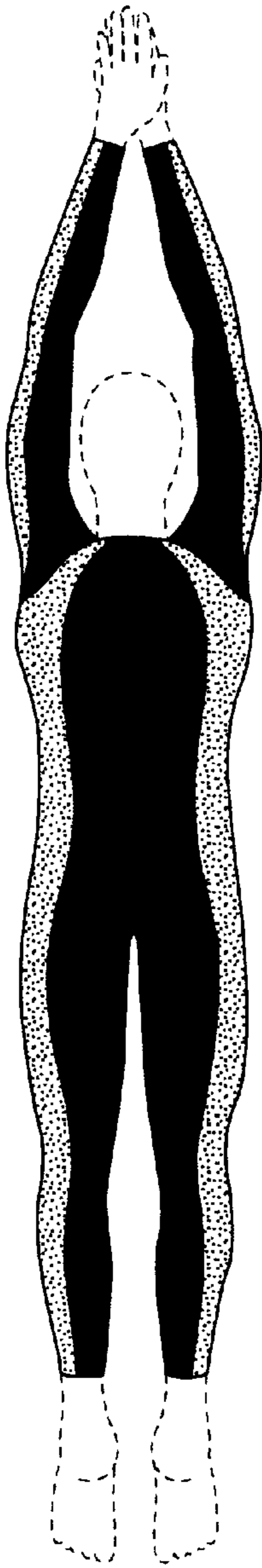

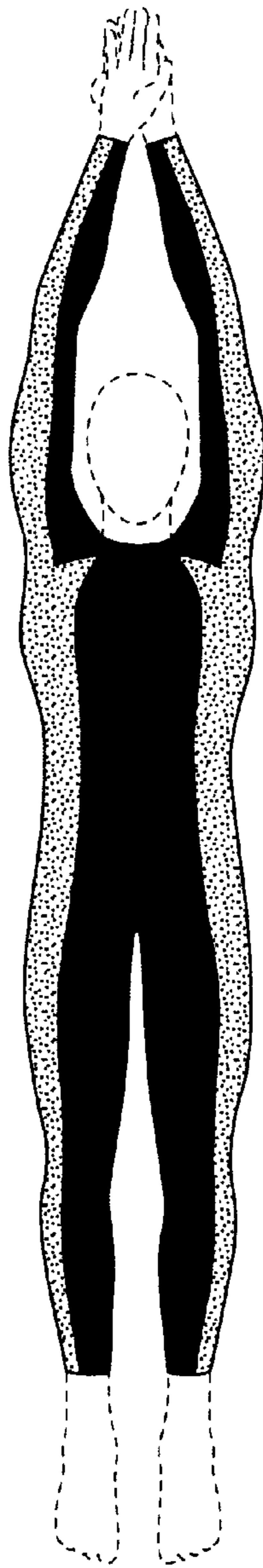

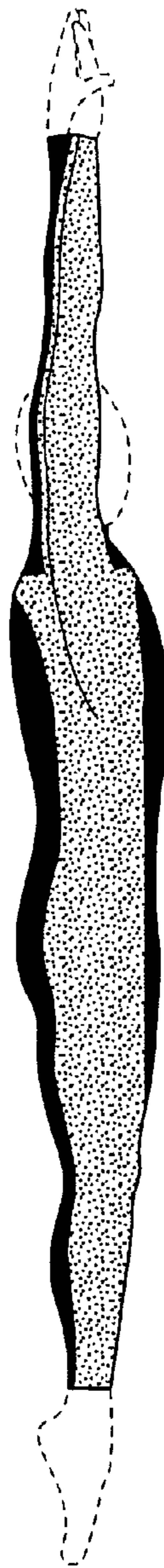

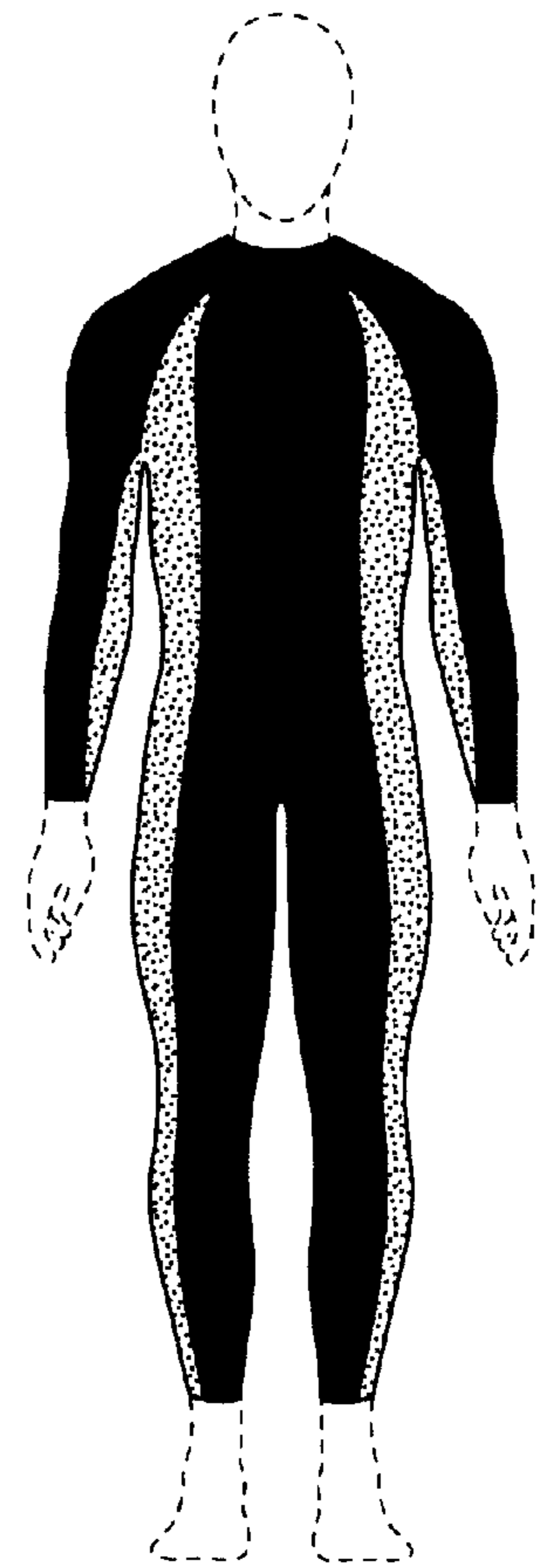
