(57) **CLAIM**

The ornamental design for a protective garment, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a protective garment showing my new design in use;

FIG. 2 is a rear elevational view thereof; and,

FIG. 3 is a right side elevational view thereof.

The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

The broken lines shown on the surface of the garment represent stitching.

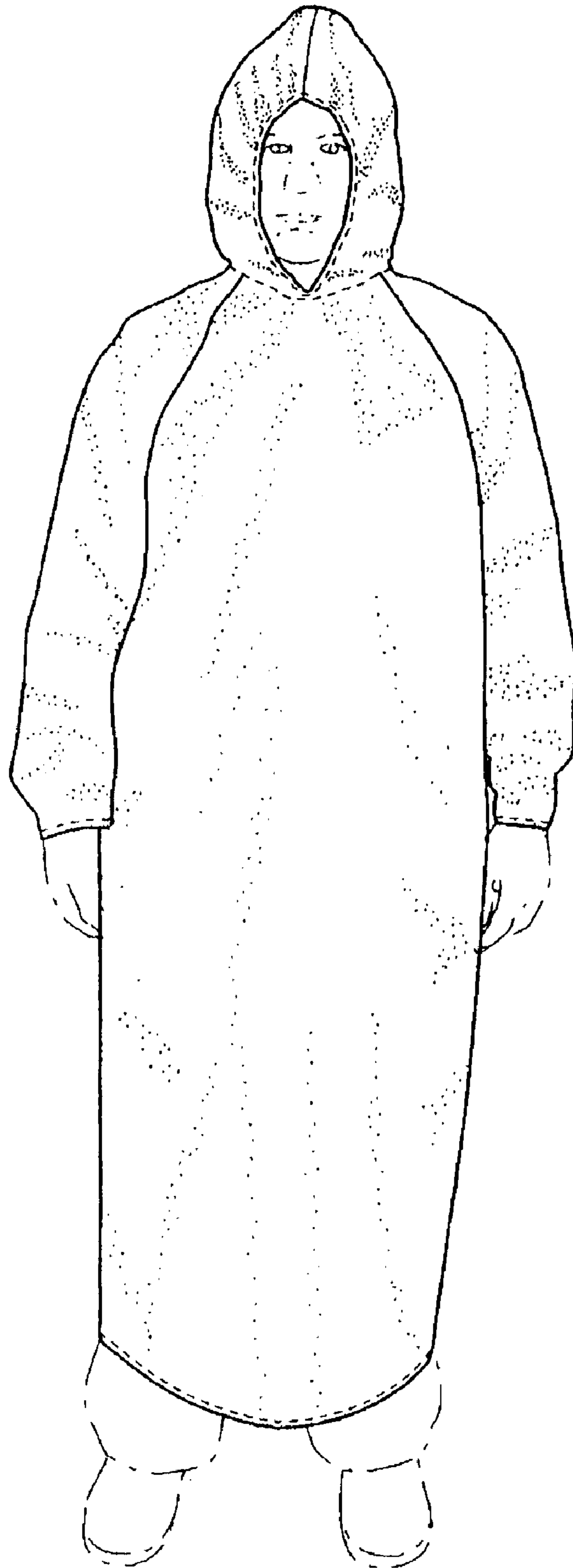

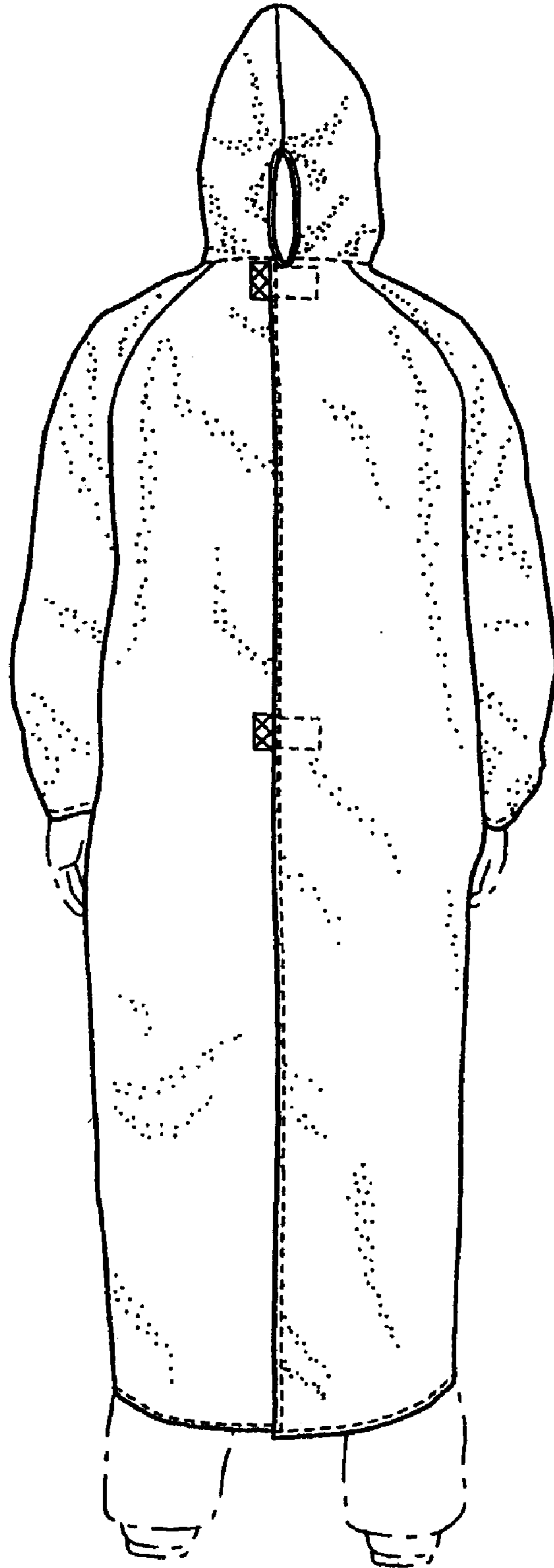

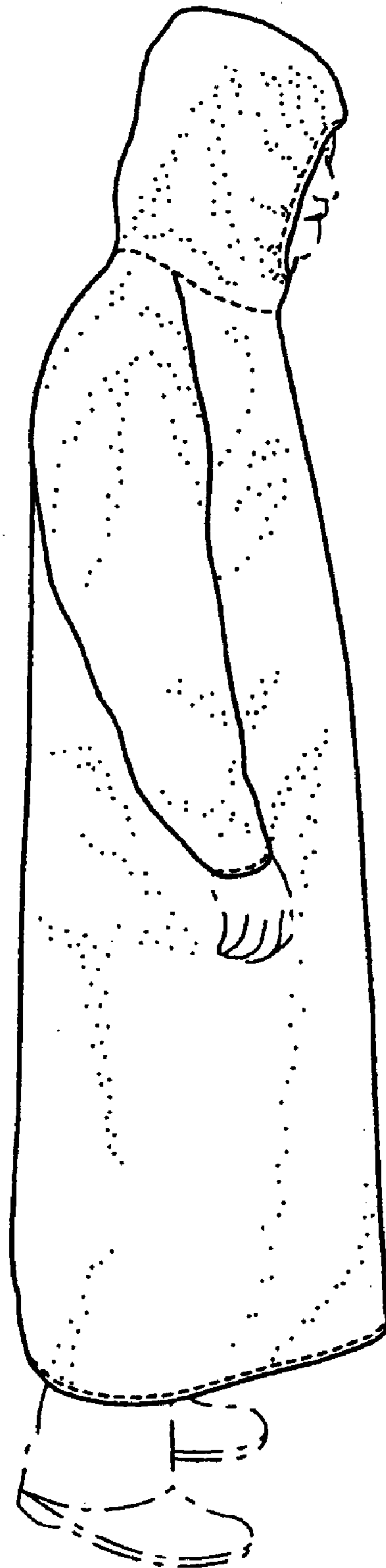
