FIG. 3 is a rear elevational view thereof;

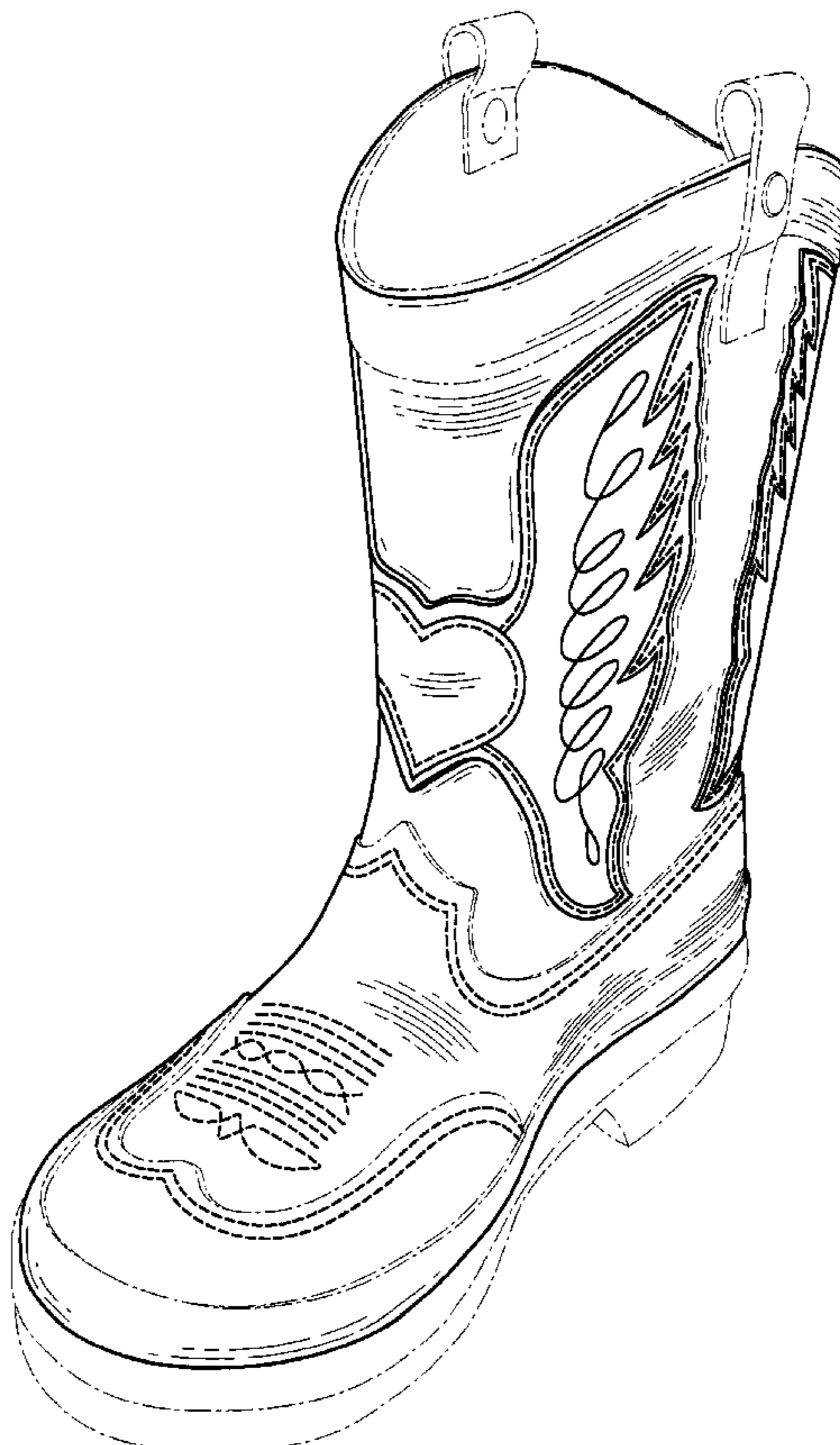
FIG. 4 is a top plan view thereof;

FIG. 6 is a right side elevational view thereof.

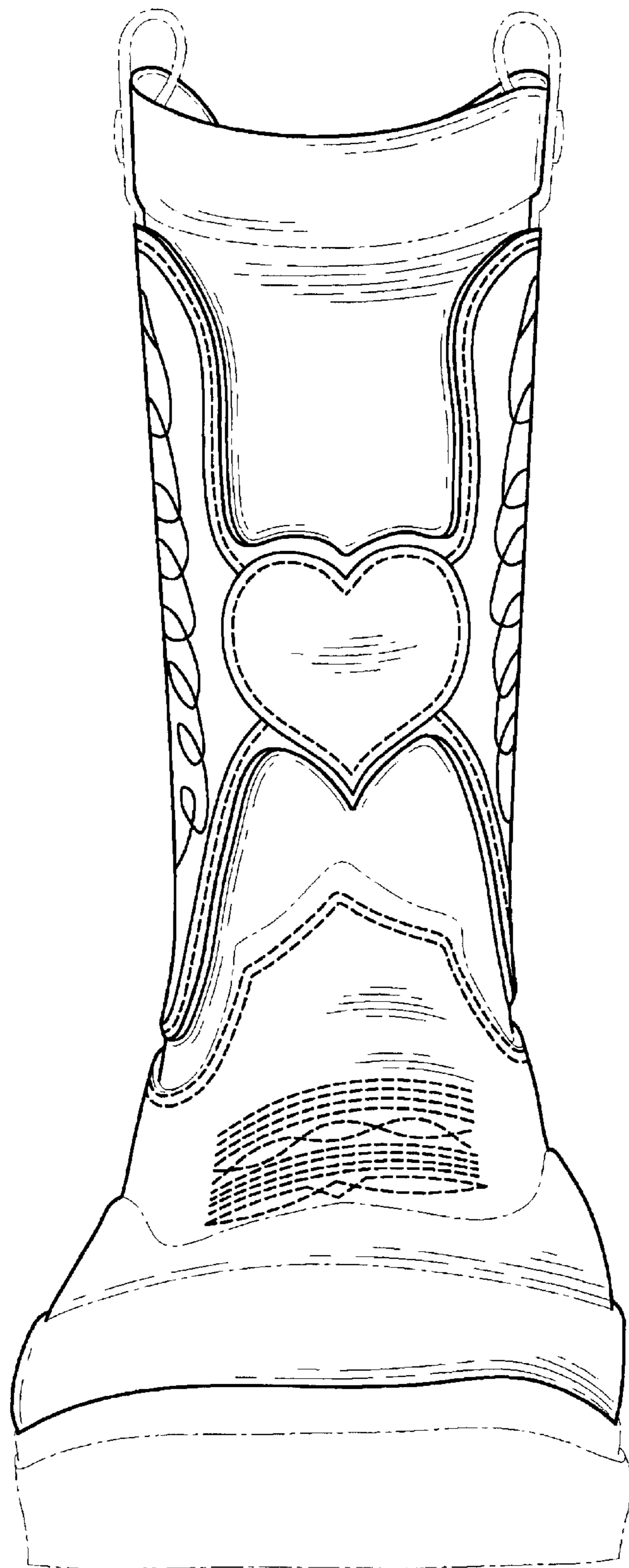

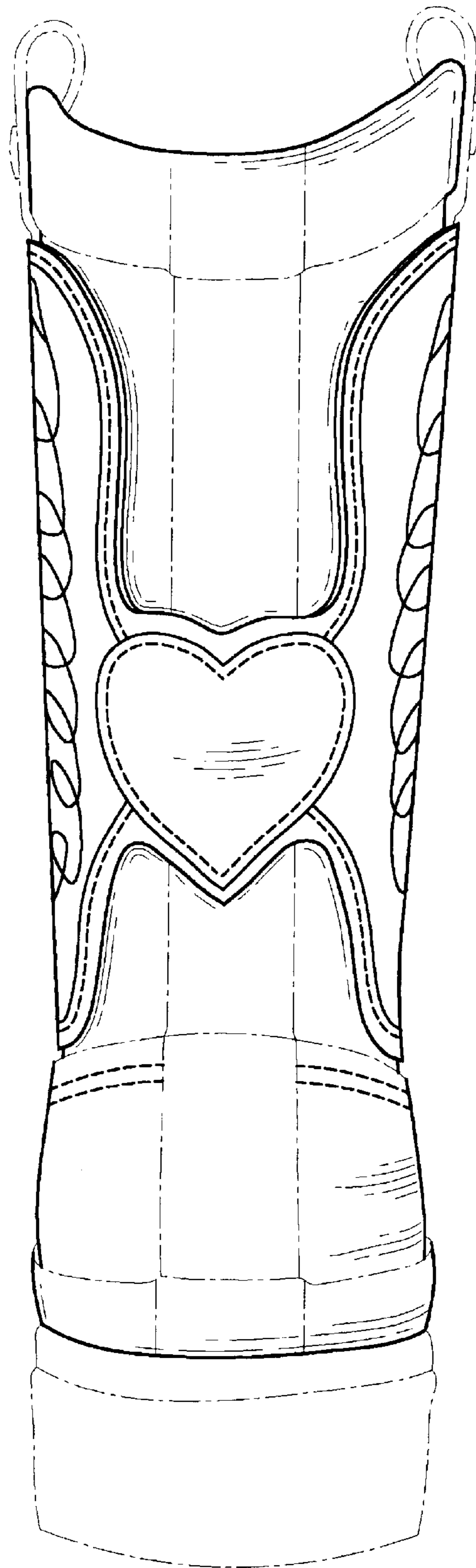




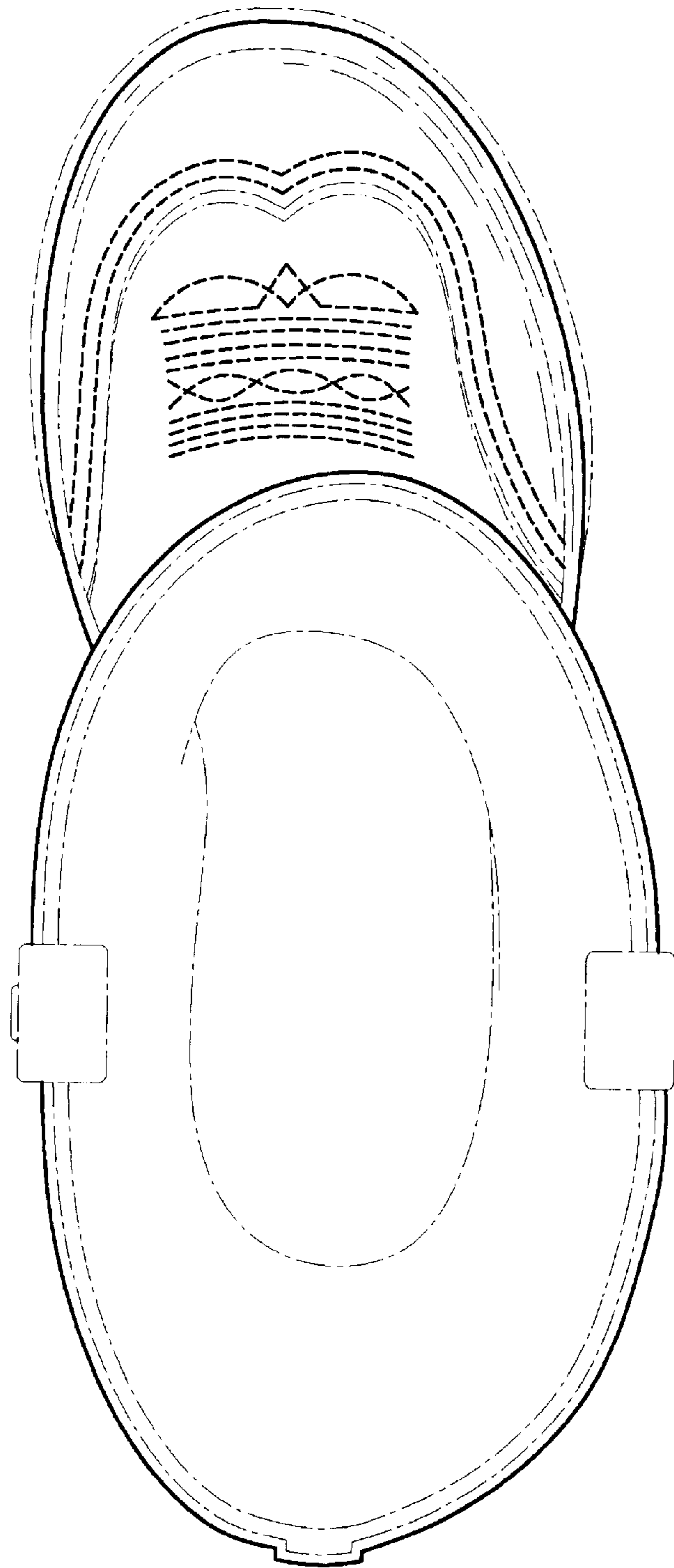
