DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my shoe design;

FIG. 2 is a right side view of the shoe shown in FIG. 1;

FIG. 3 is a left side view of the shoe shown in FIG. 1;

FIG. 4 is a front view of the shoe shown in FIG. 1;

FIG. 7 is a right side view of the alternative embodiment of the shoe shown in FIG. 6;

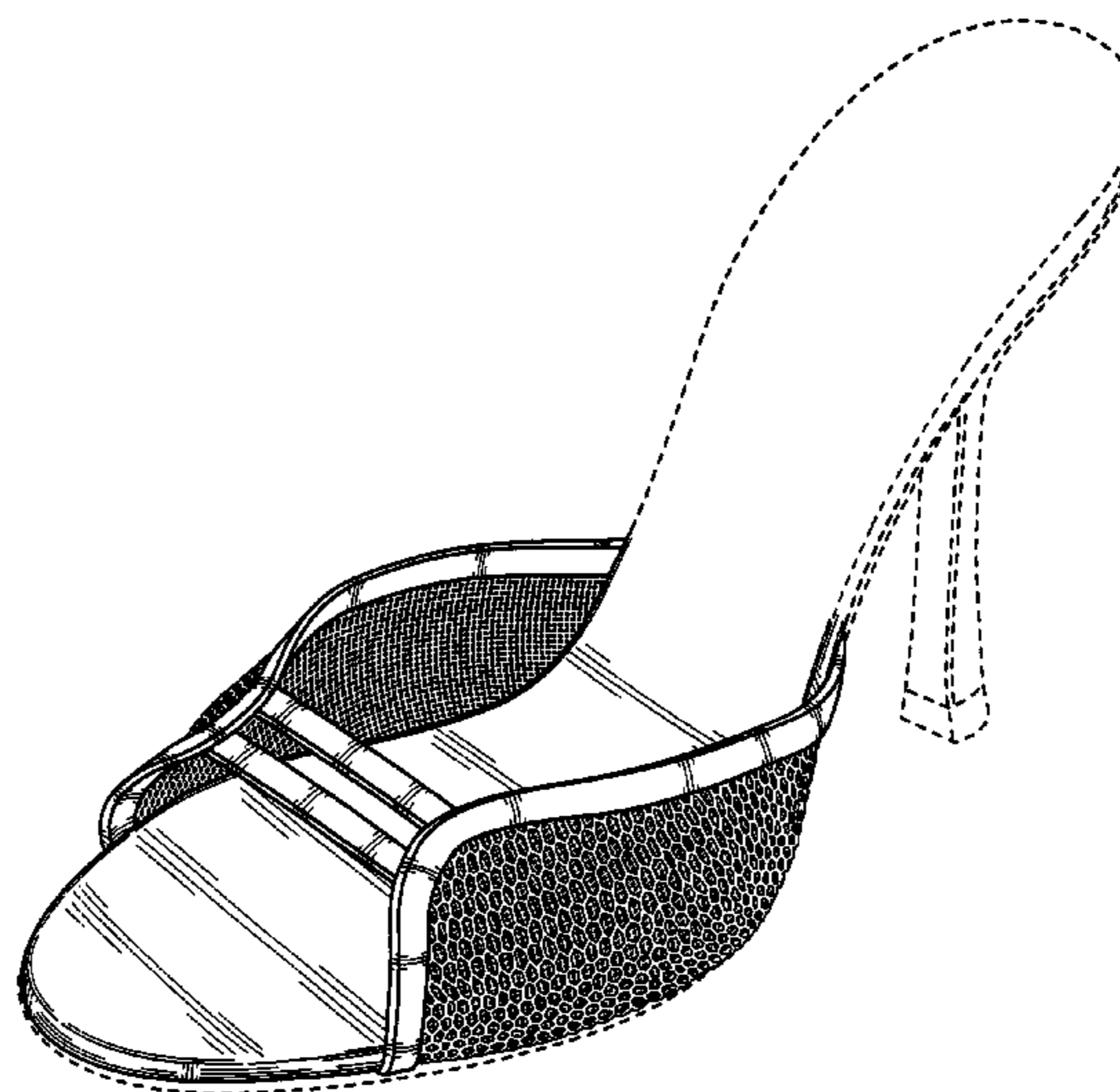
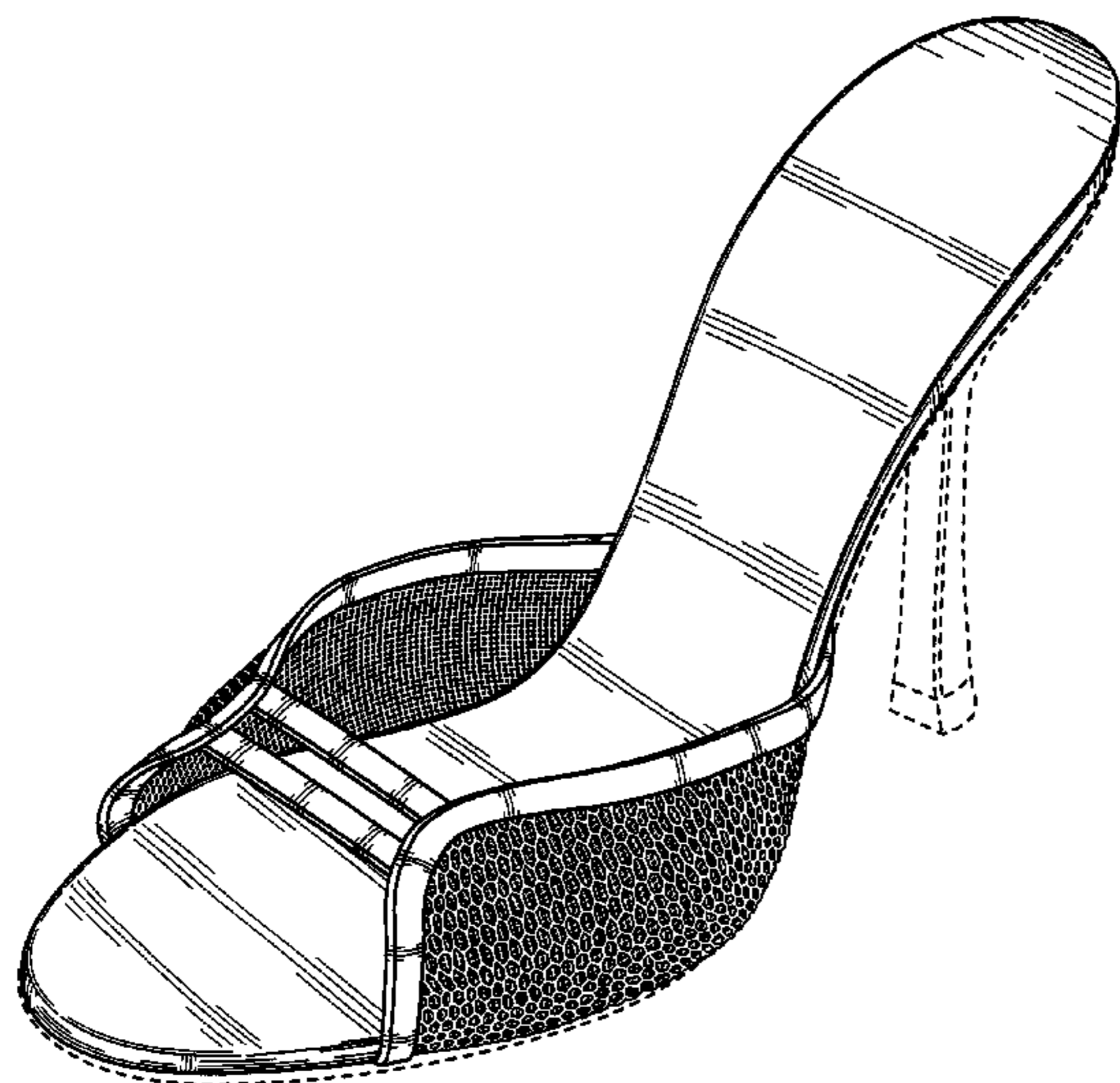
FIG. 8 is a left side view of the alternative embodiment of the shoe shown in FIG. 6;

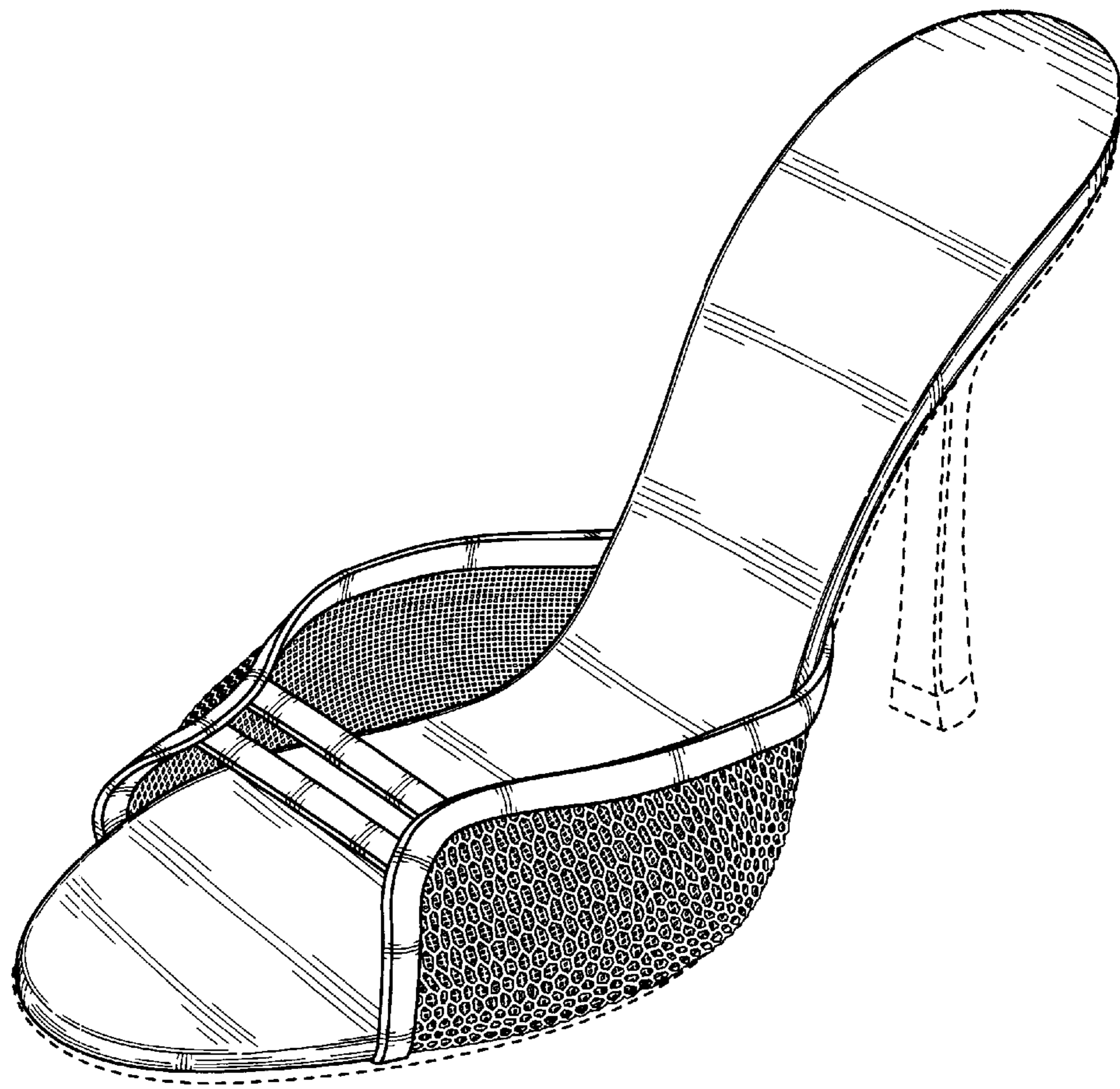

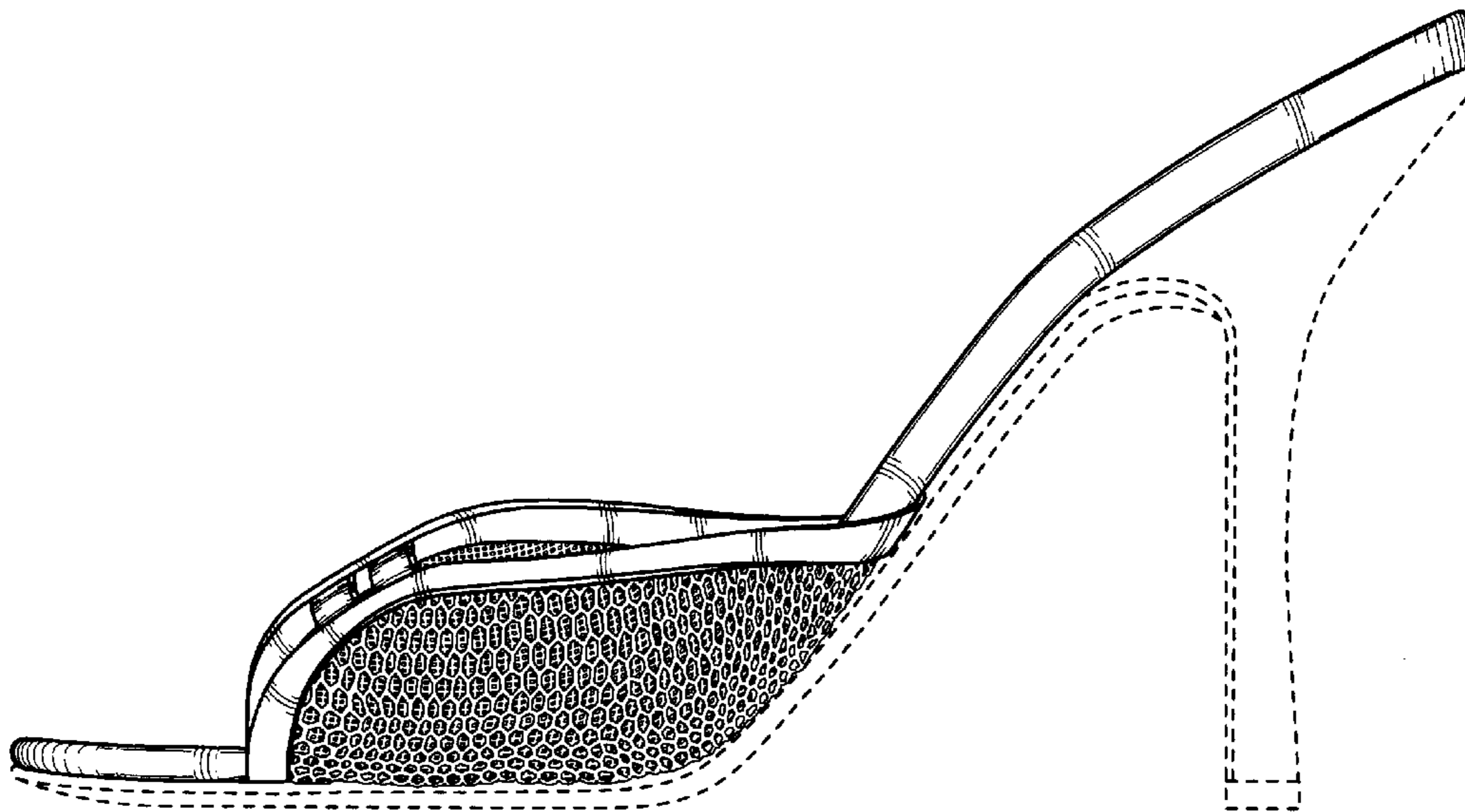

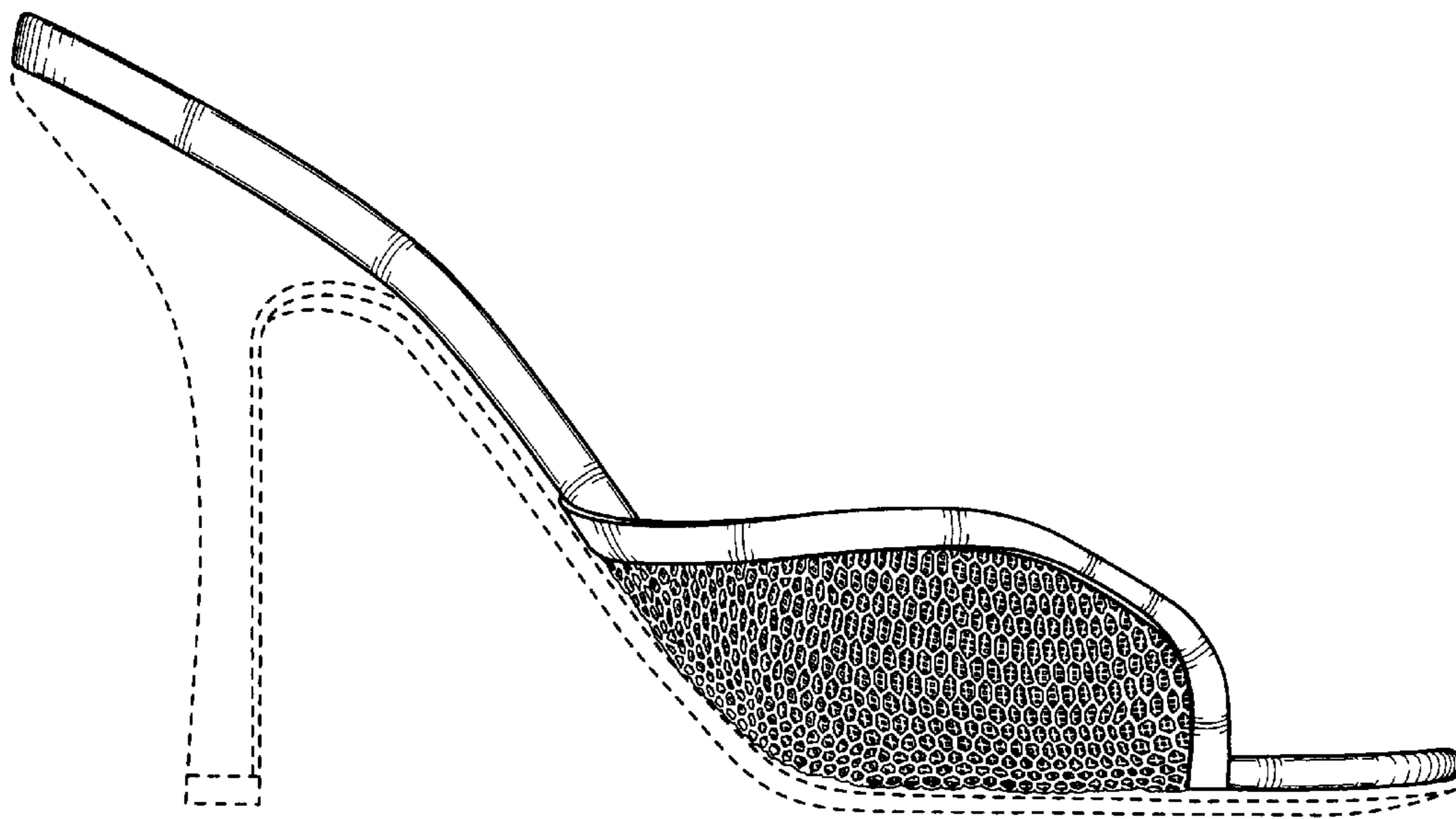

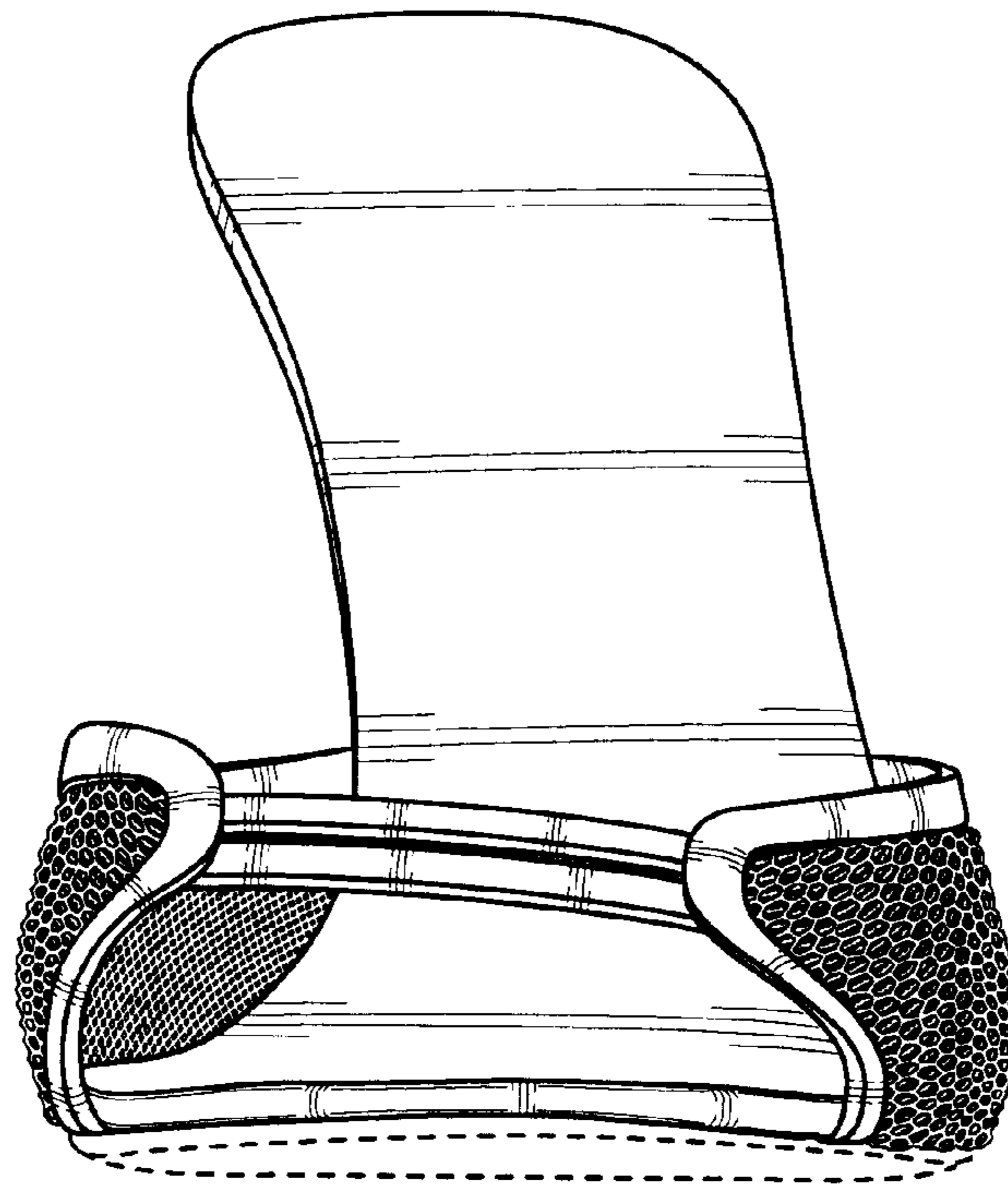

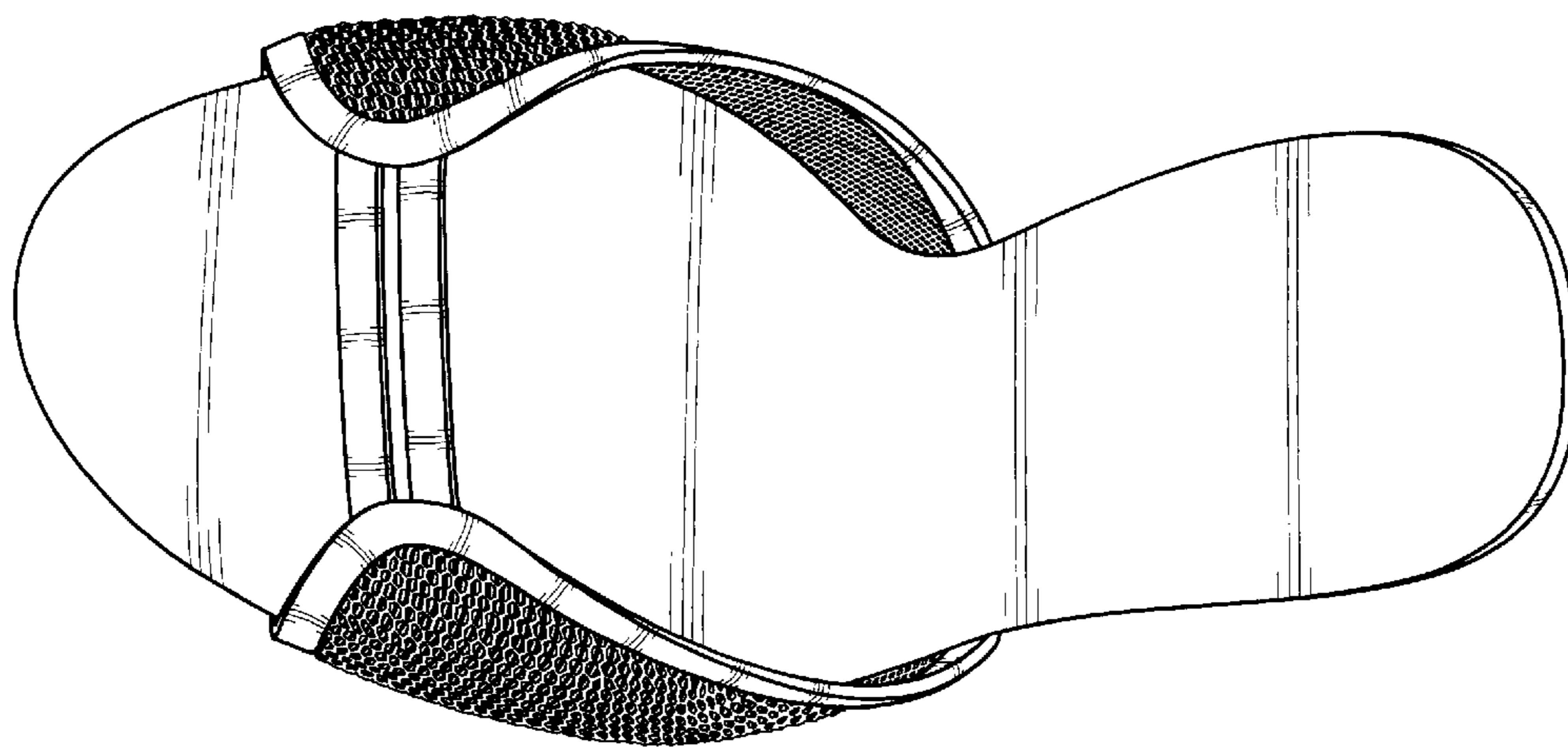

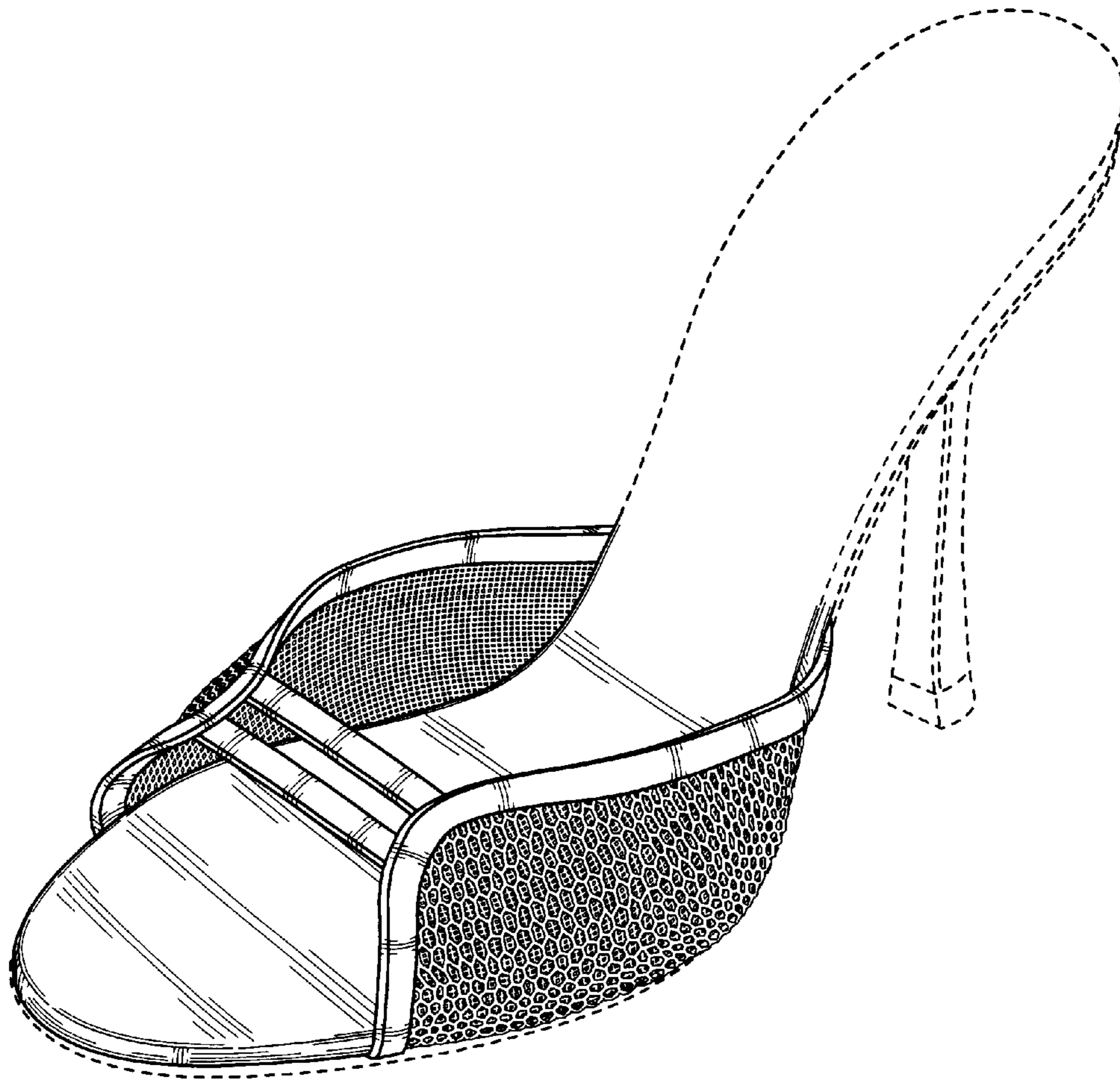

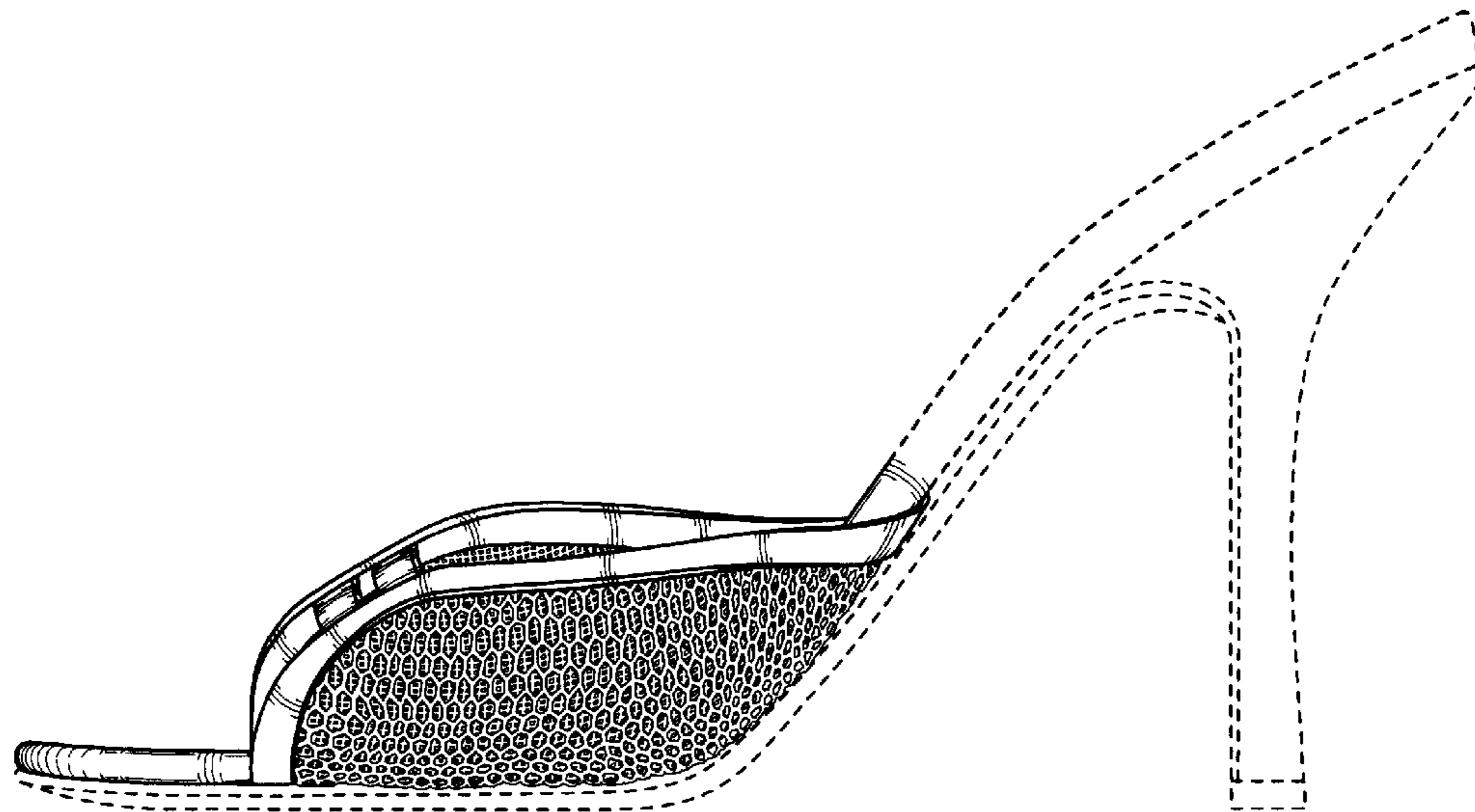

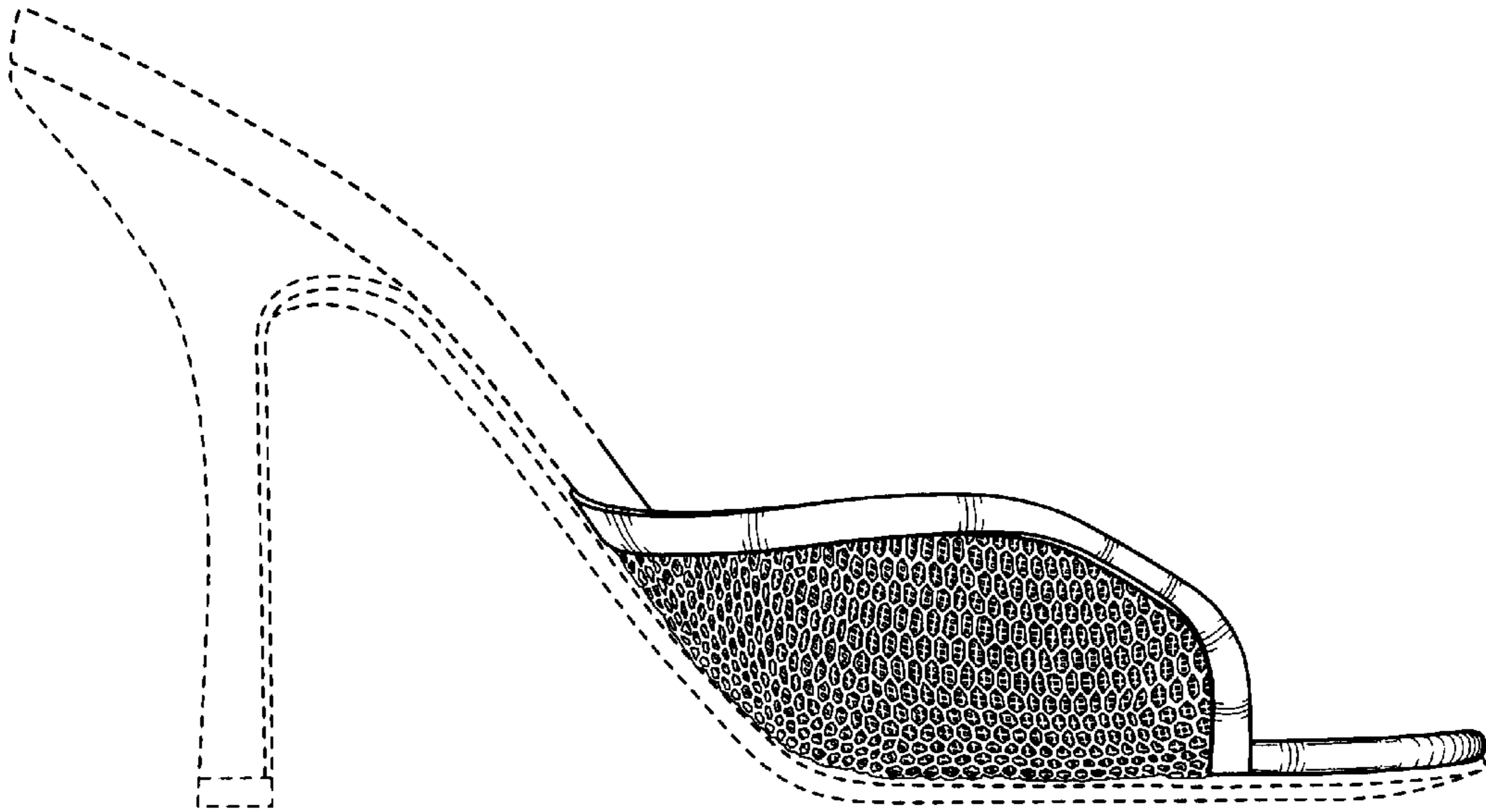

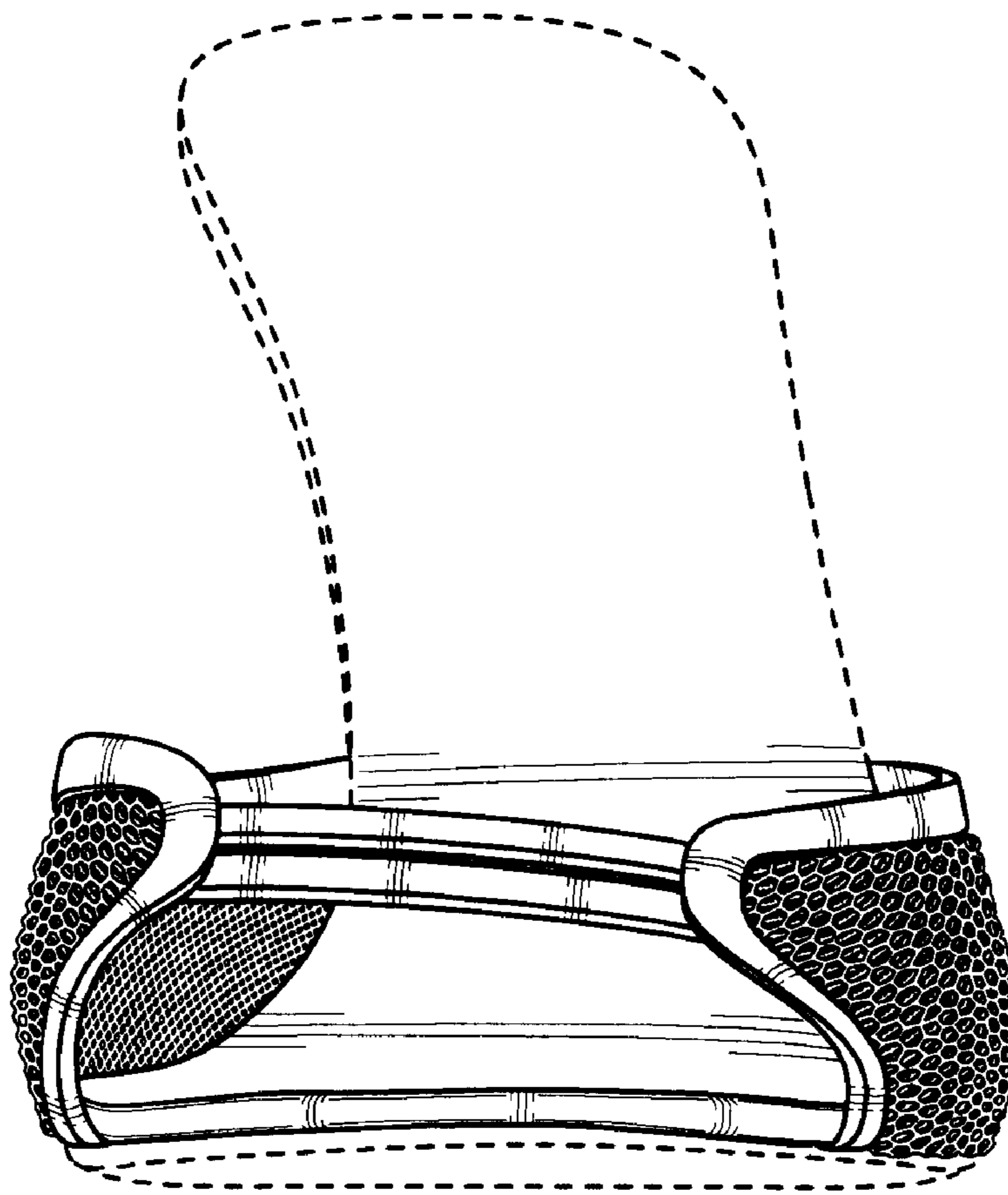

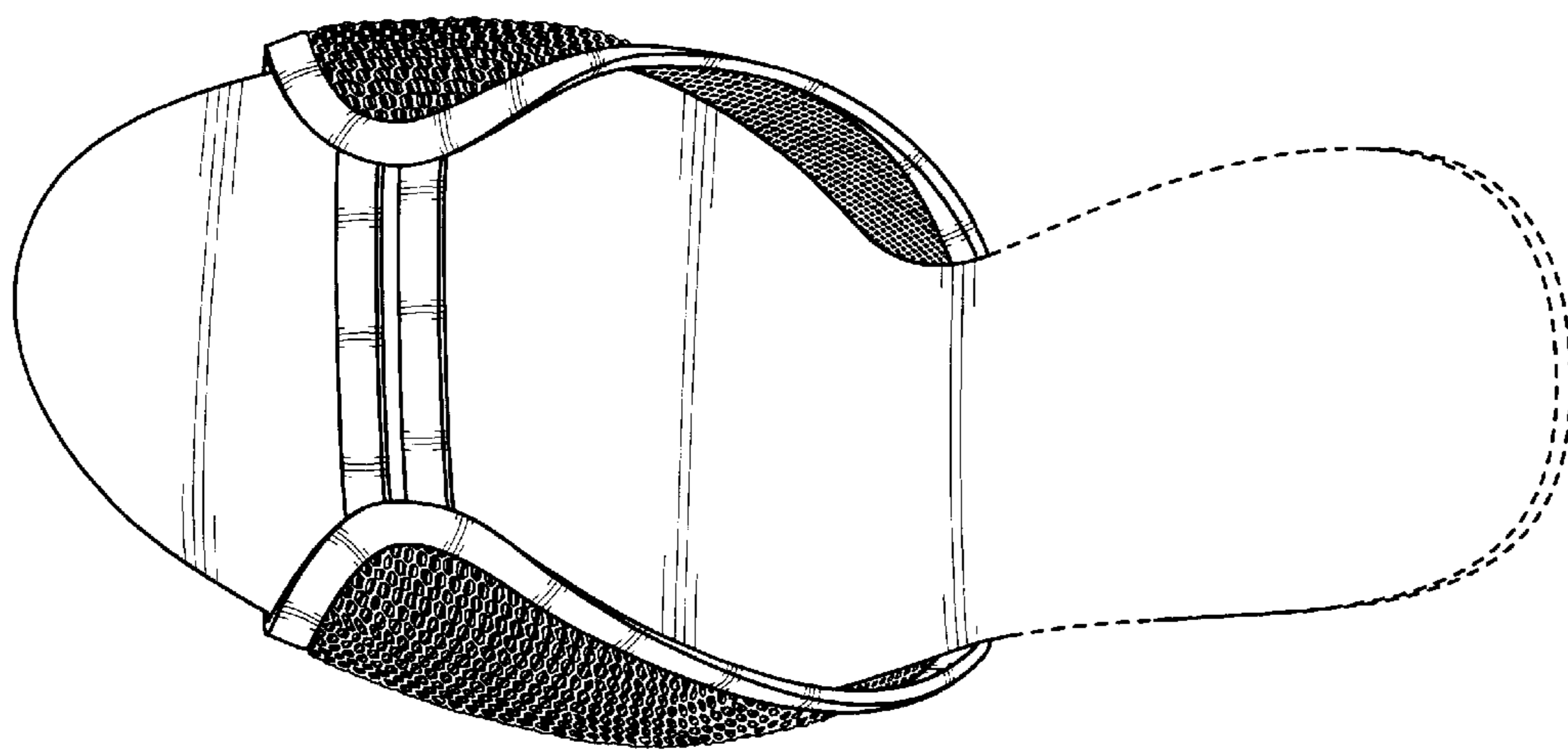
