(57) **CLAIM**

The ornamental design for “picture frame systems”, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the “picture frame systems”;

FIG. 2 is a top plan view of the “picture frame systems”, showing my new design;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a back elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof; and

FIG. 7 is a front elevational view showing an alternate embodiment of the “picture frame systems” shown in FIG. 1;

FIG. 8 is a top plan view showing the alternate embodiment of the “picture frame systems” shown in FIG. 7;

FIG. 9 is a bottom plan view showing the alternate embodiment of the “picture frame systems” shown in FIG. 7; and

FIG. 10 is a back elevational view showing the alternate embodiment of the “picture frame systems” shown in FIG. 7; and

FIG. 11 is a left side elevational view showing the alternate embodiment of the “picture frame systems” shown in FIG. 7;

FIG. 12 is a right side elevational view showing the alternate embodiment of the “picture frame systems” shown in FIG. 7; and

FIG. 13 is a front elevational view showing an alternate embodiment of the “picture frame systems” shown in FIG. 1;

FIG. 14 is a top plan view showing the alternate embodiment of the “picture frame systems” shown in FIG. 13;

FIG. 15 is a bottom plan view showing the alternate embodiment of the “picture frame systems” shown in FIG. 13;

FIG. 16 is a back elevational view showing the alternate embodiment of the “picture frame systems” shown in FIG. 13;

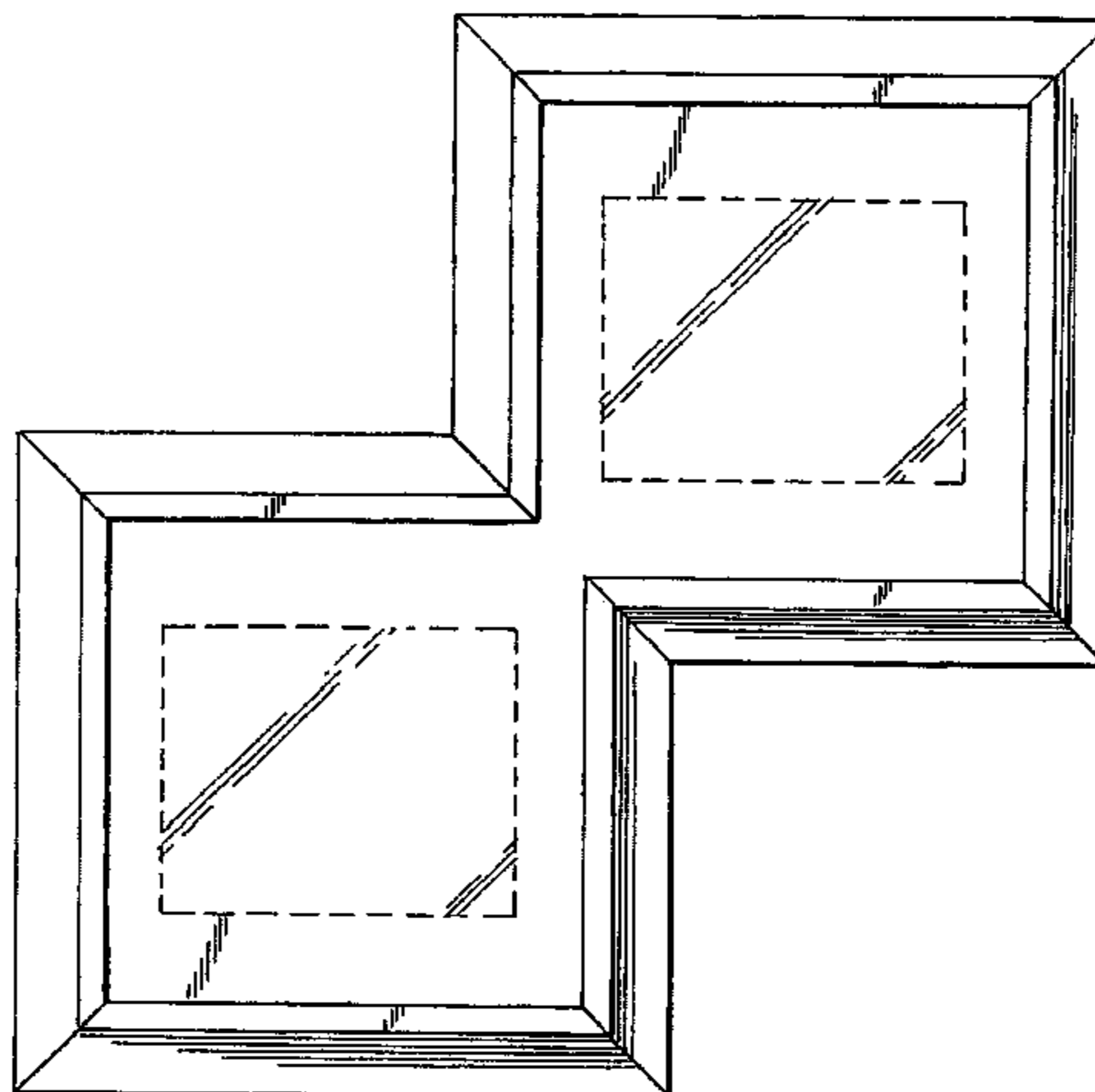
FIG. 17 is a right side elevational view showing the alternate embodiment of the “picture frame systems” shown in FIG. 13; and,

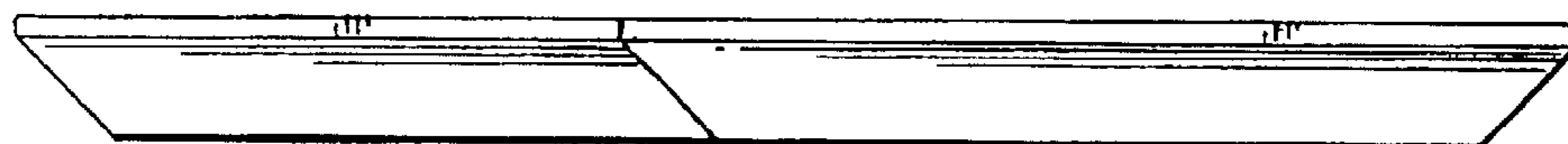
FIG. 18 is a left side elevational view showing the alternate embodiment of the “picture frame systems” shown in FIG. 13.

The claimed design does not include any depth for the ornamental details shown within the perimeter moldings.

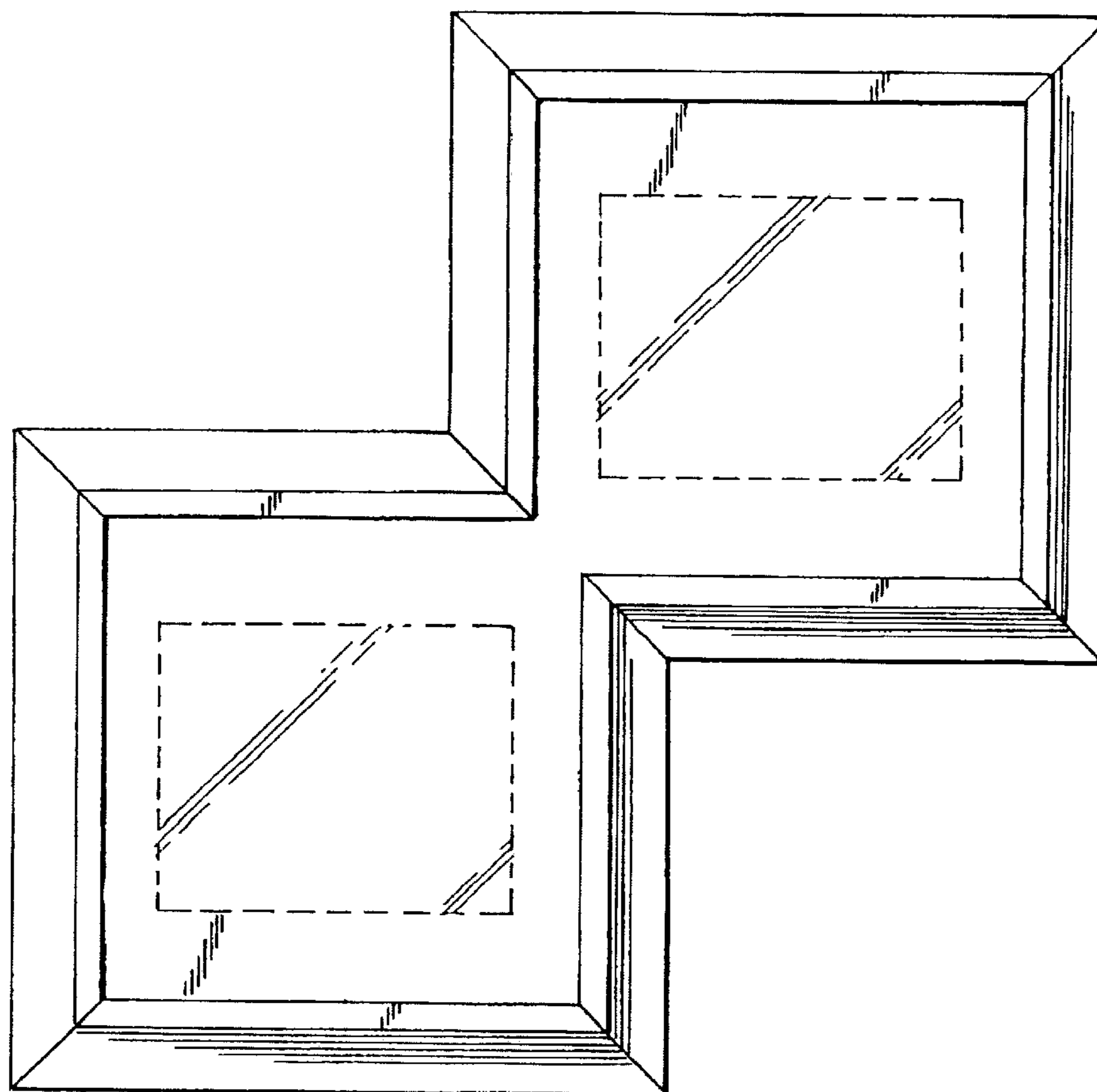
The broken lines are for illustrative purposes only and form no part of the claimed design.

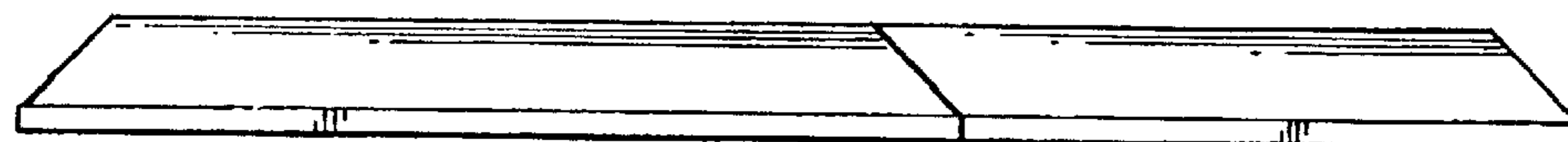




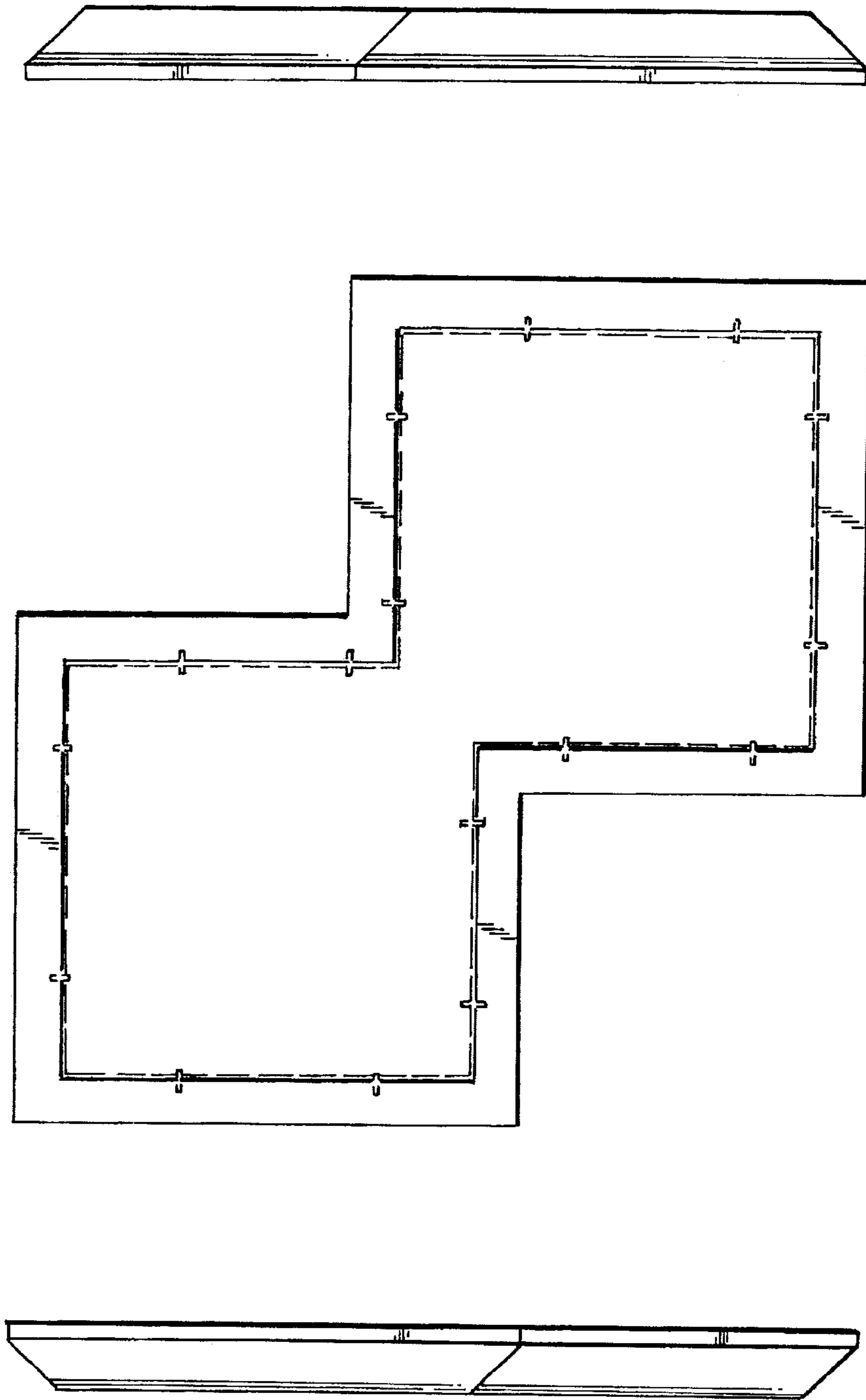

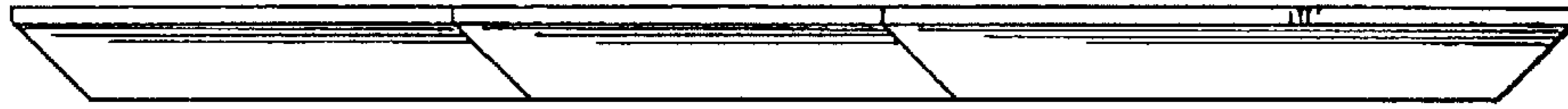

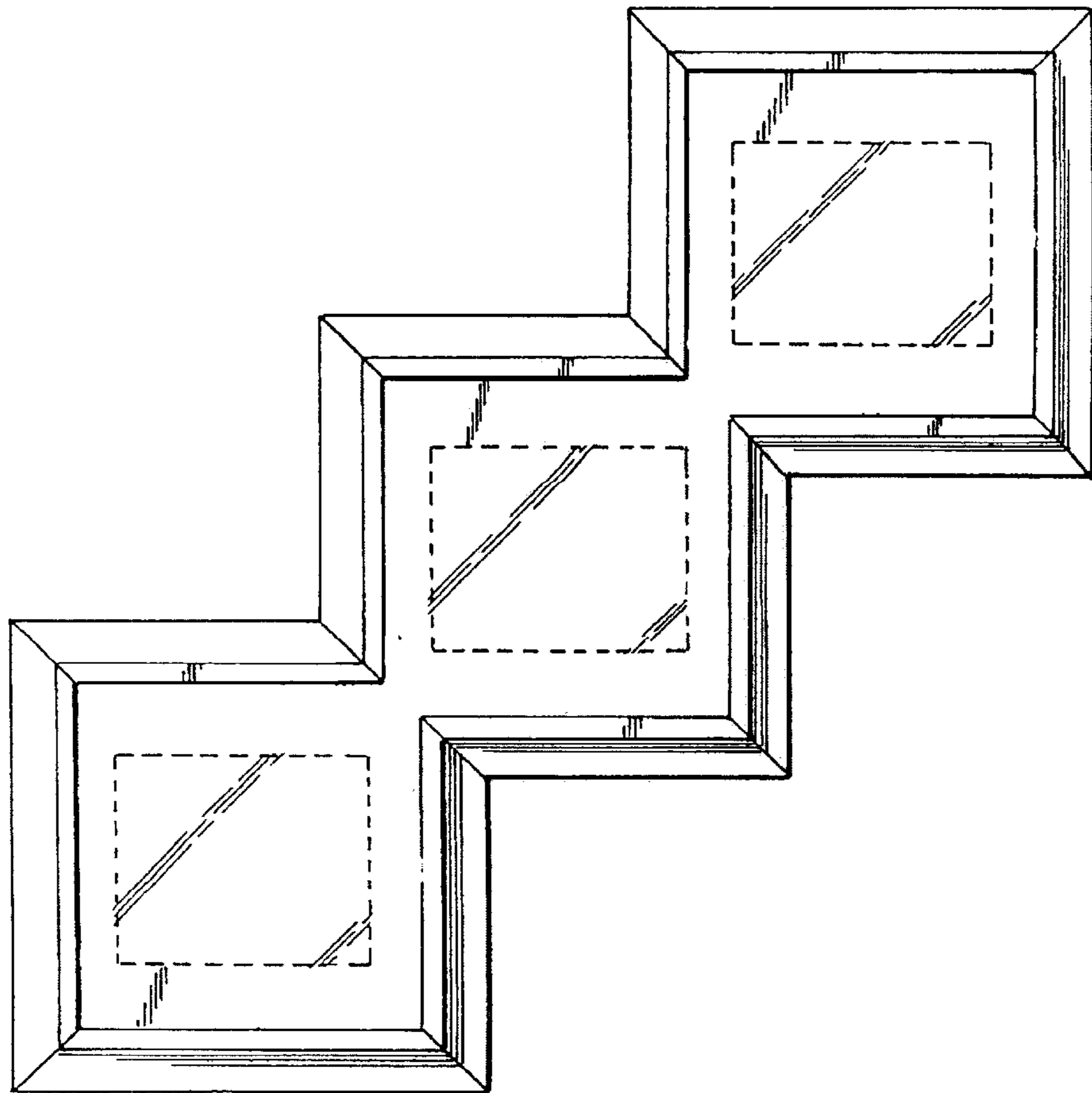

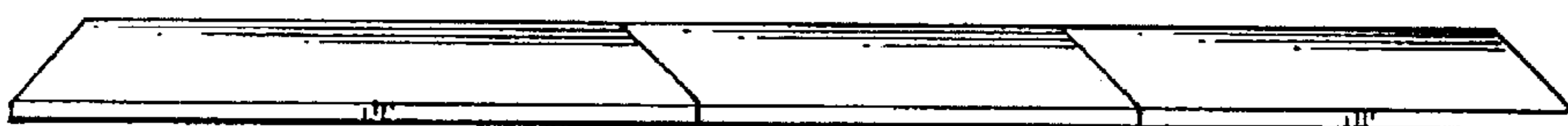

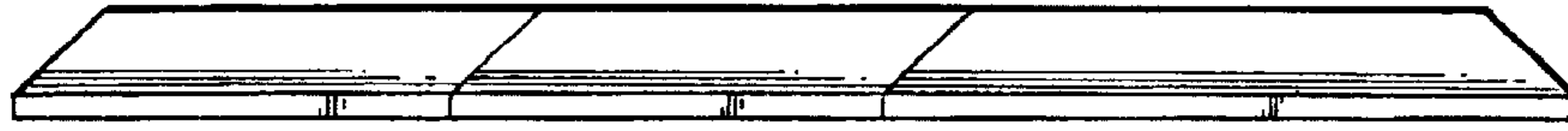

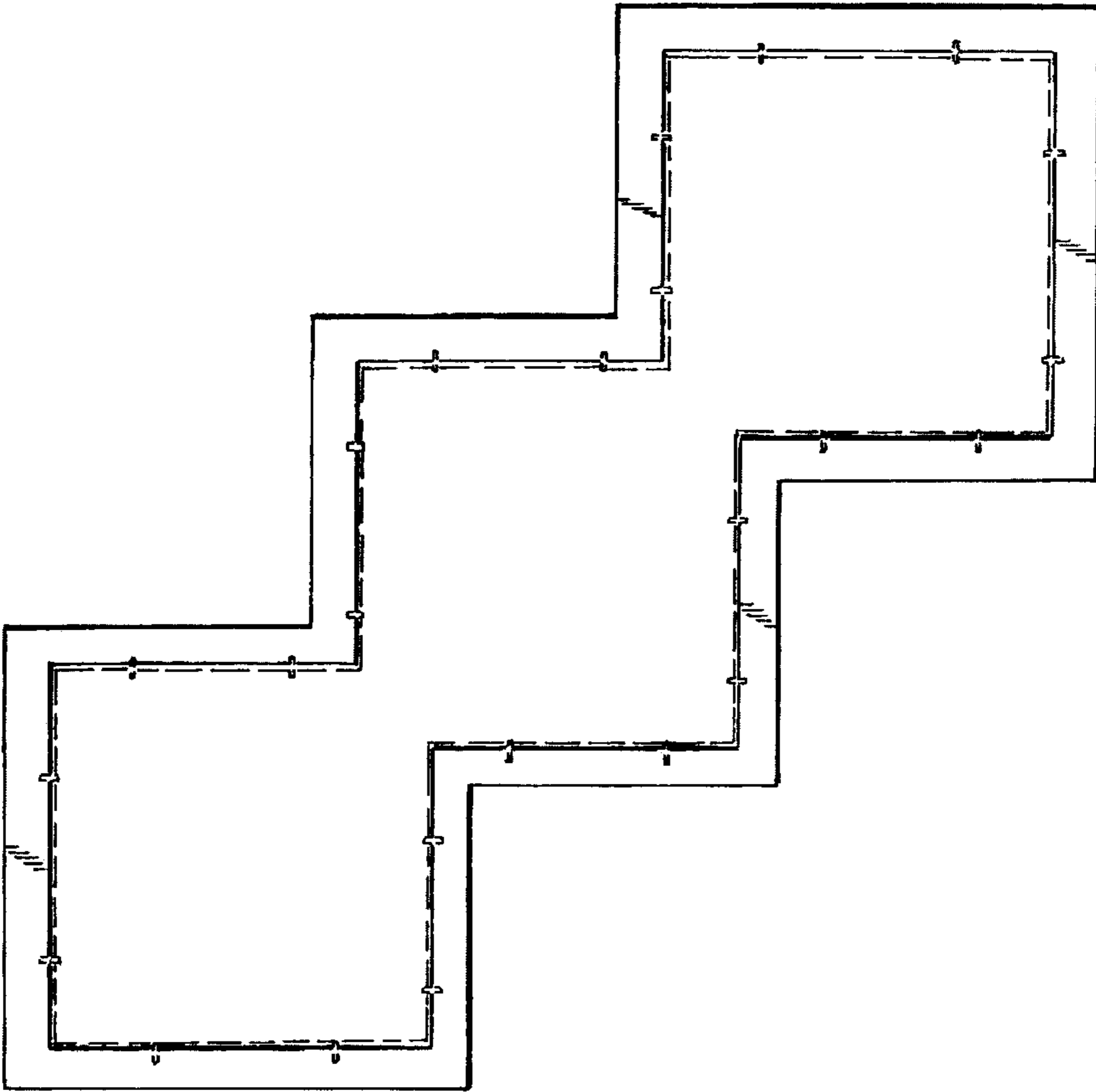

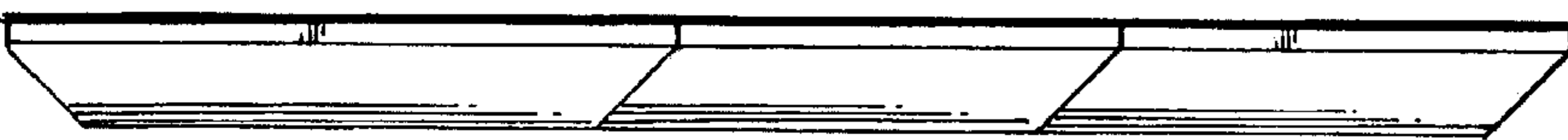

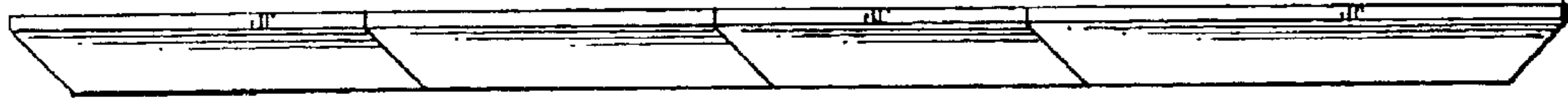

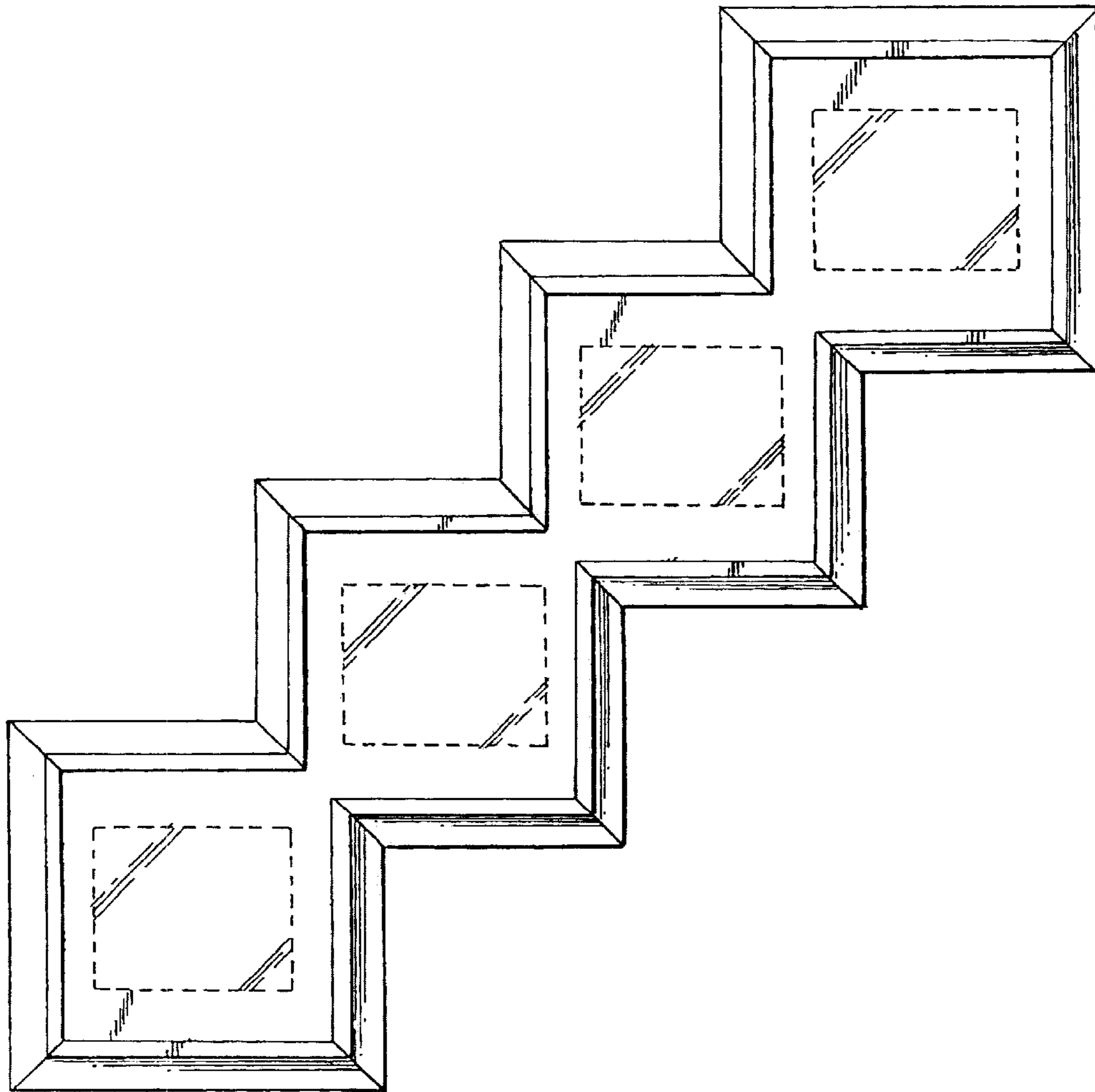

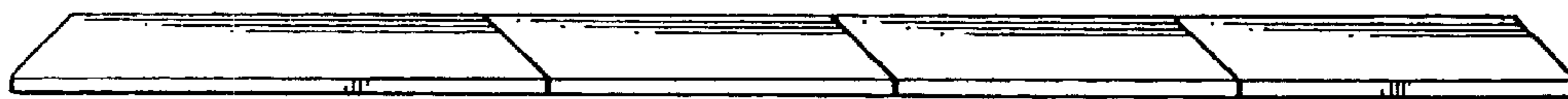

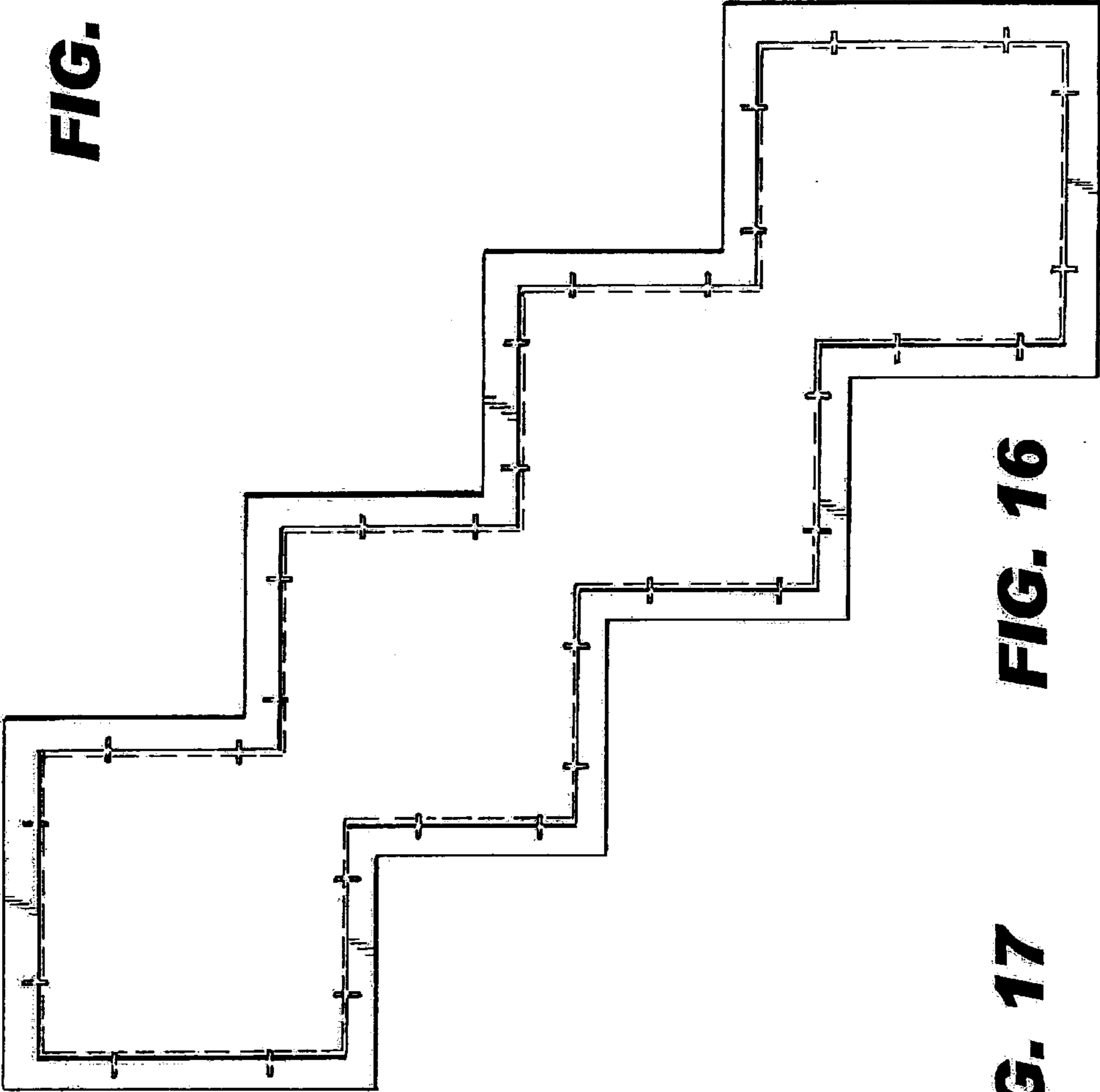
