FIG. 3 is a reduced rear view thereof;

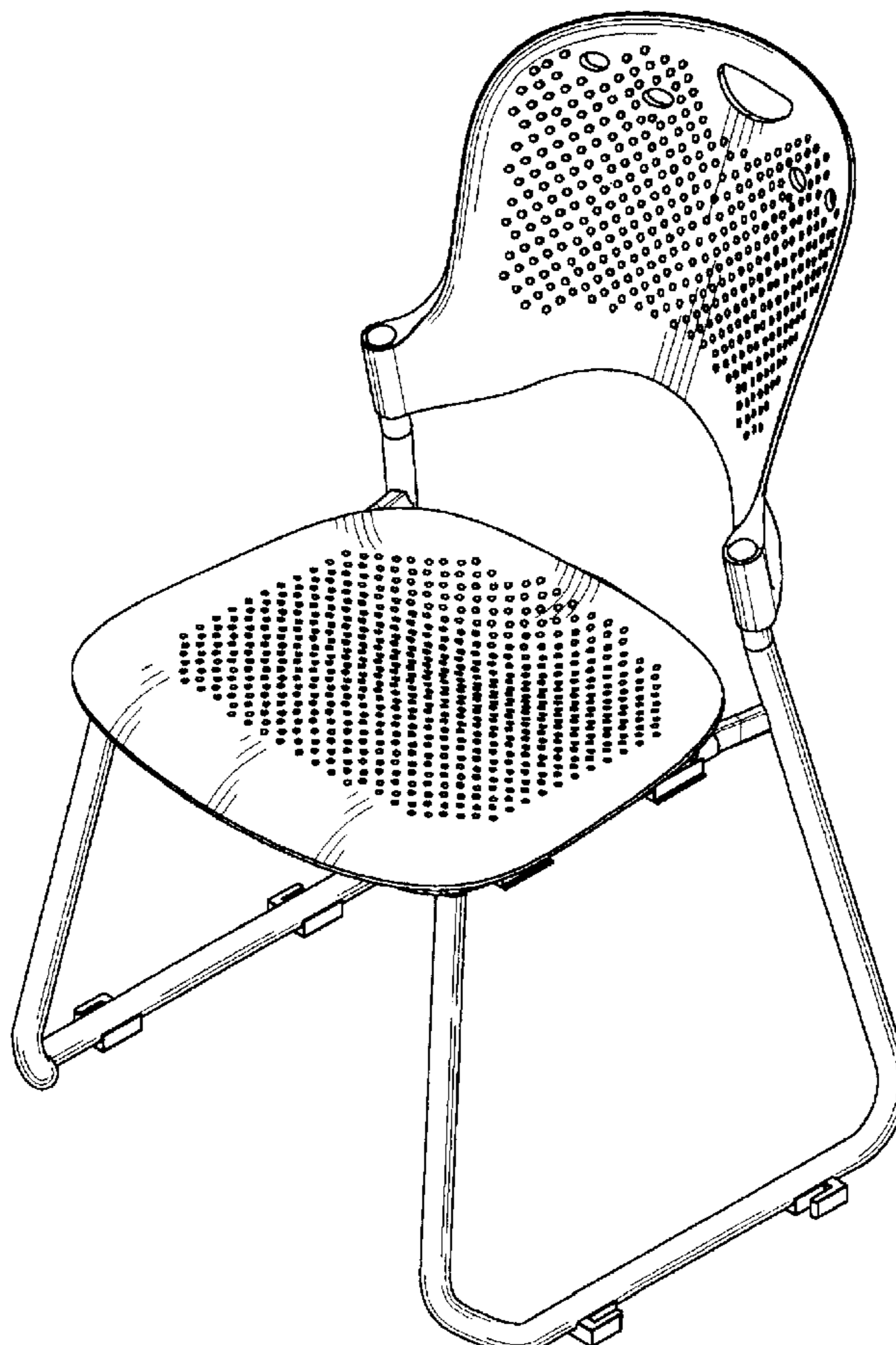
FIG. 4 is a reduced left view thereof;

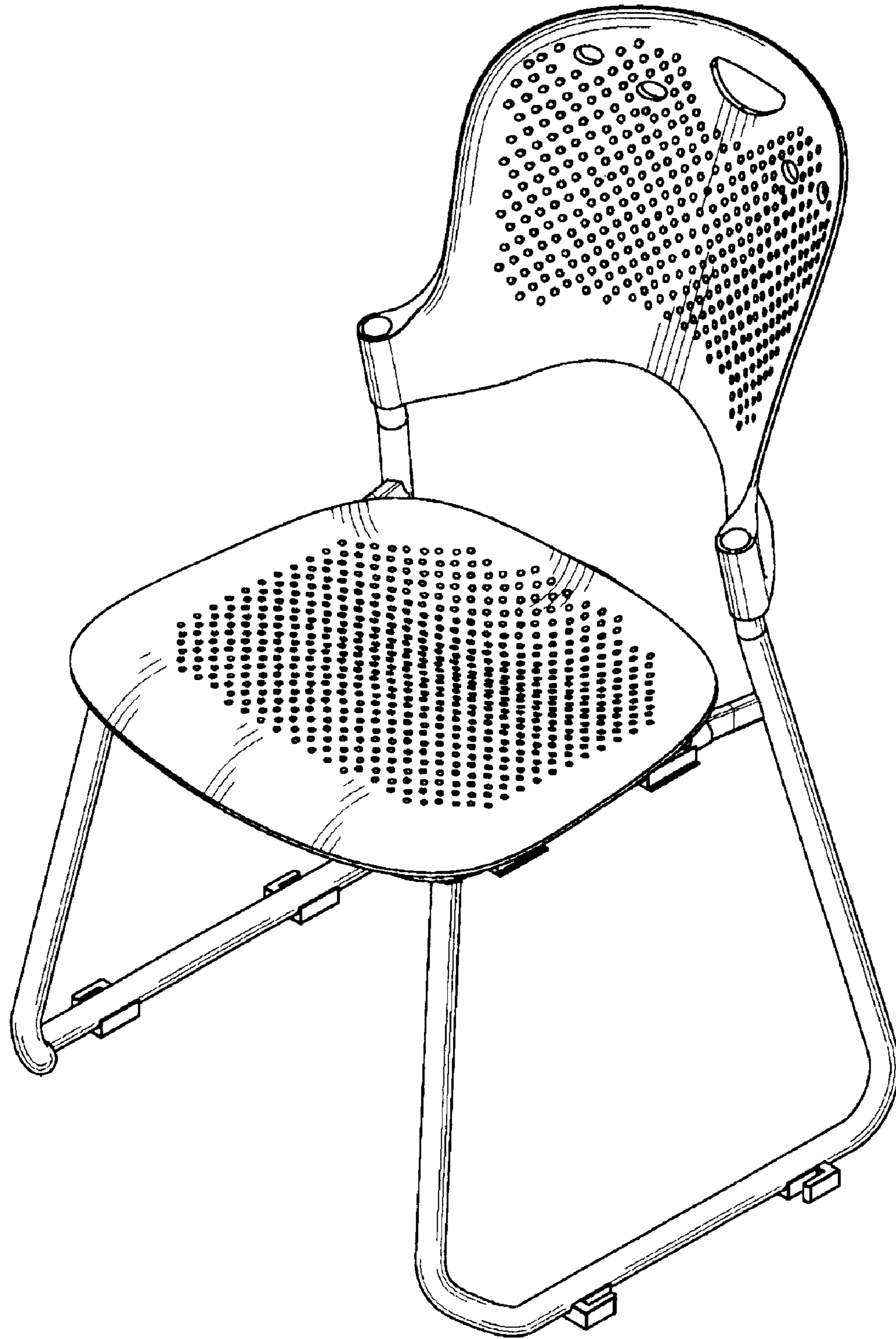

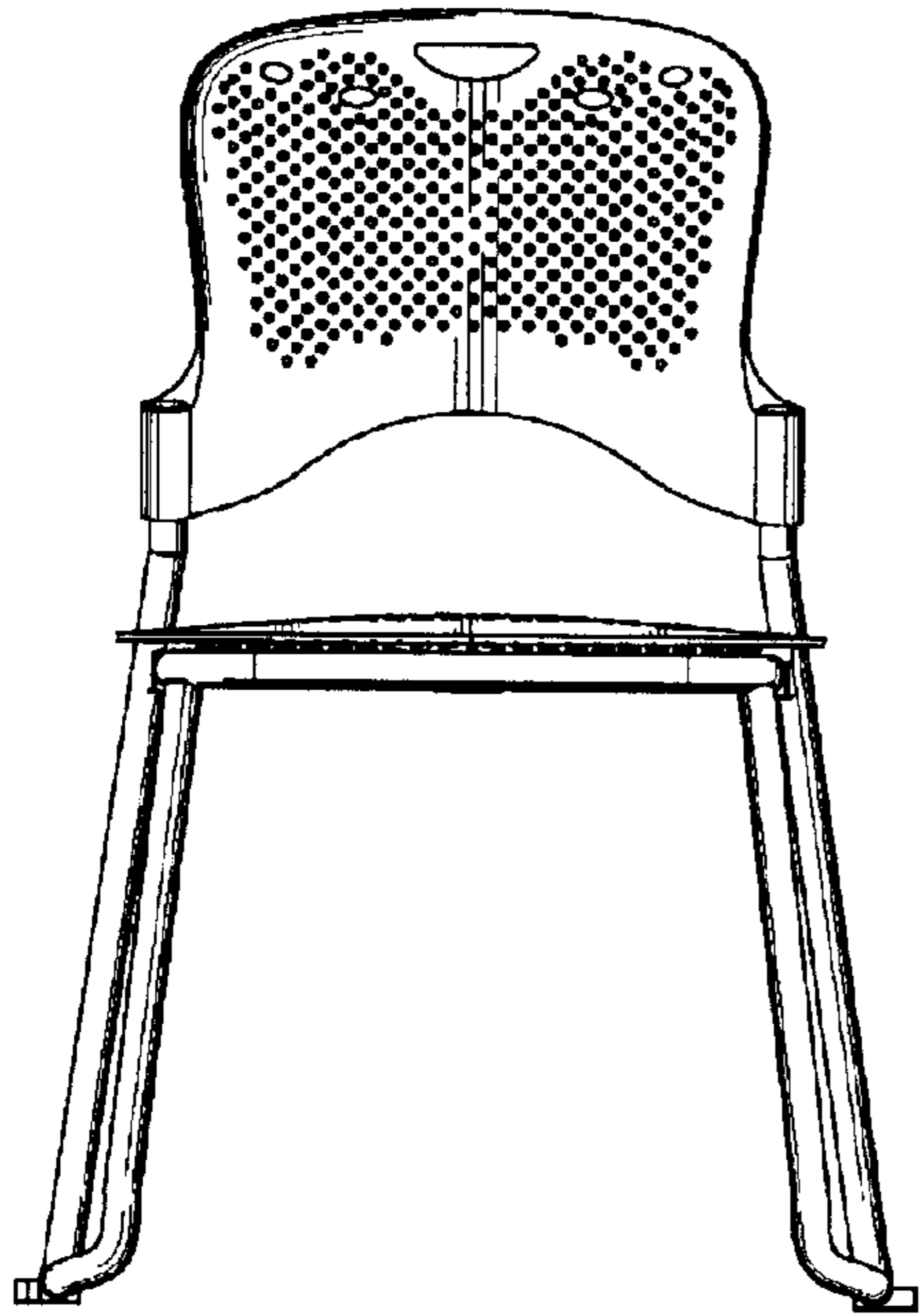

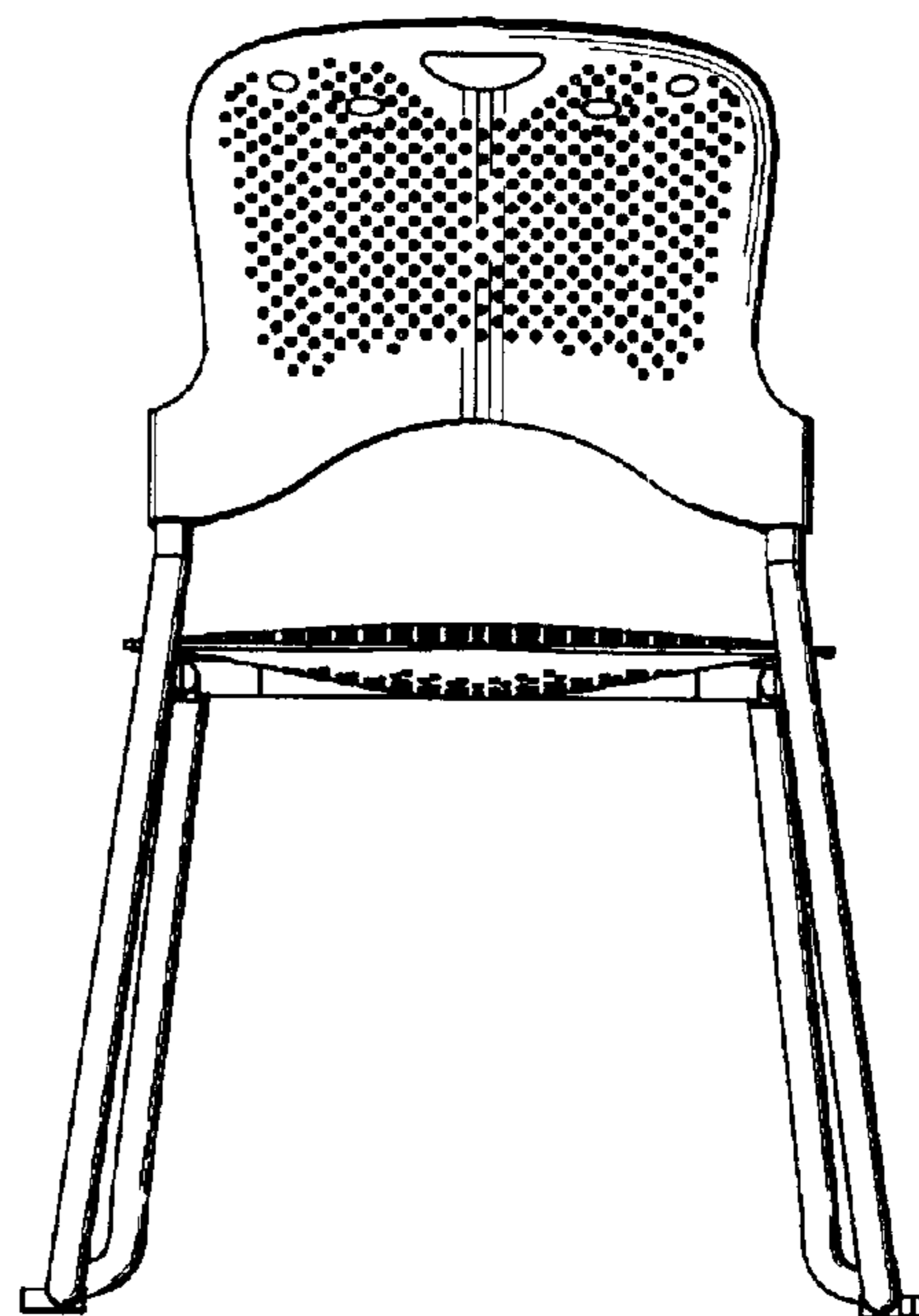

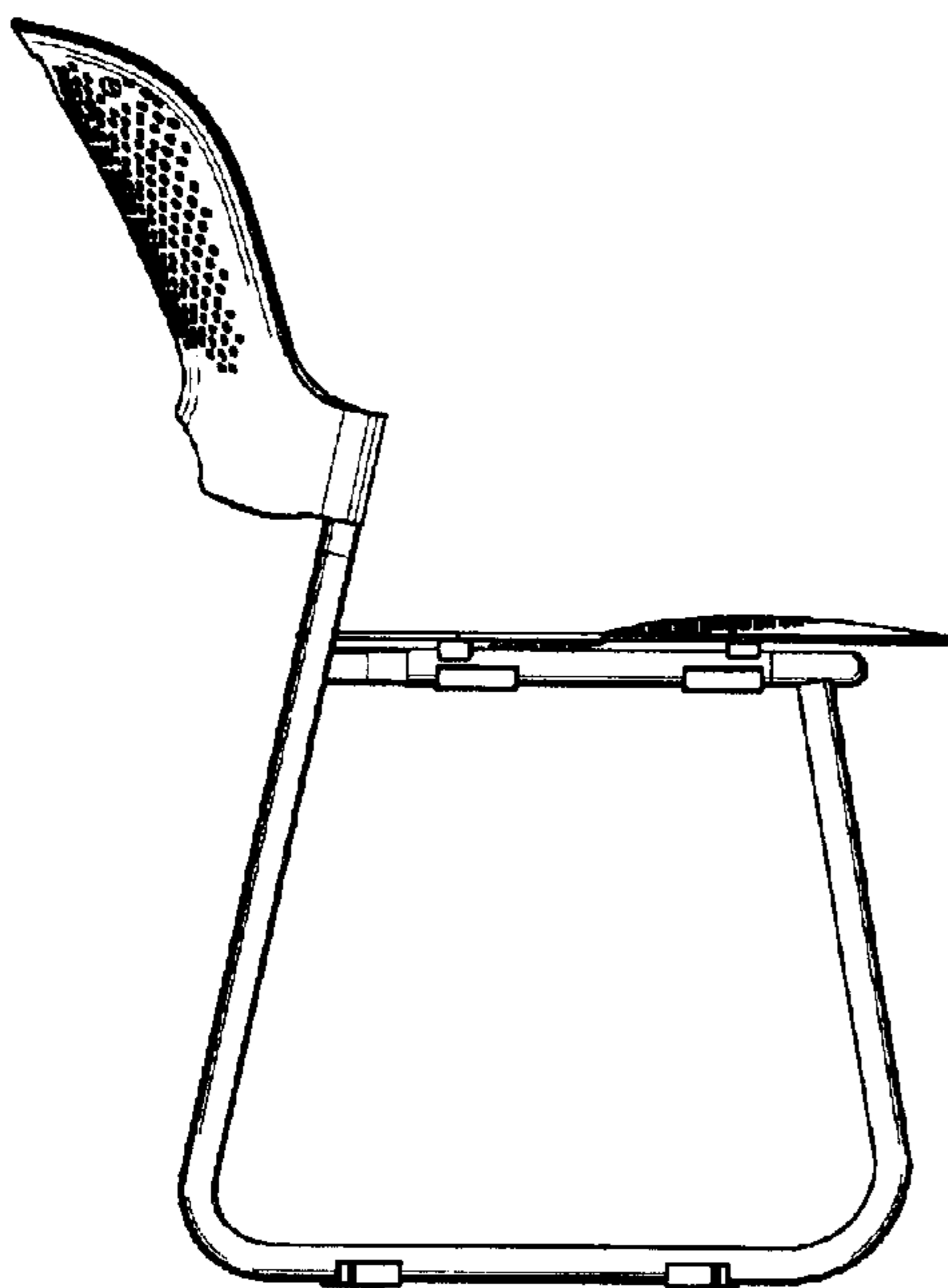

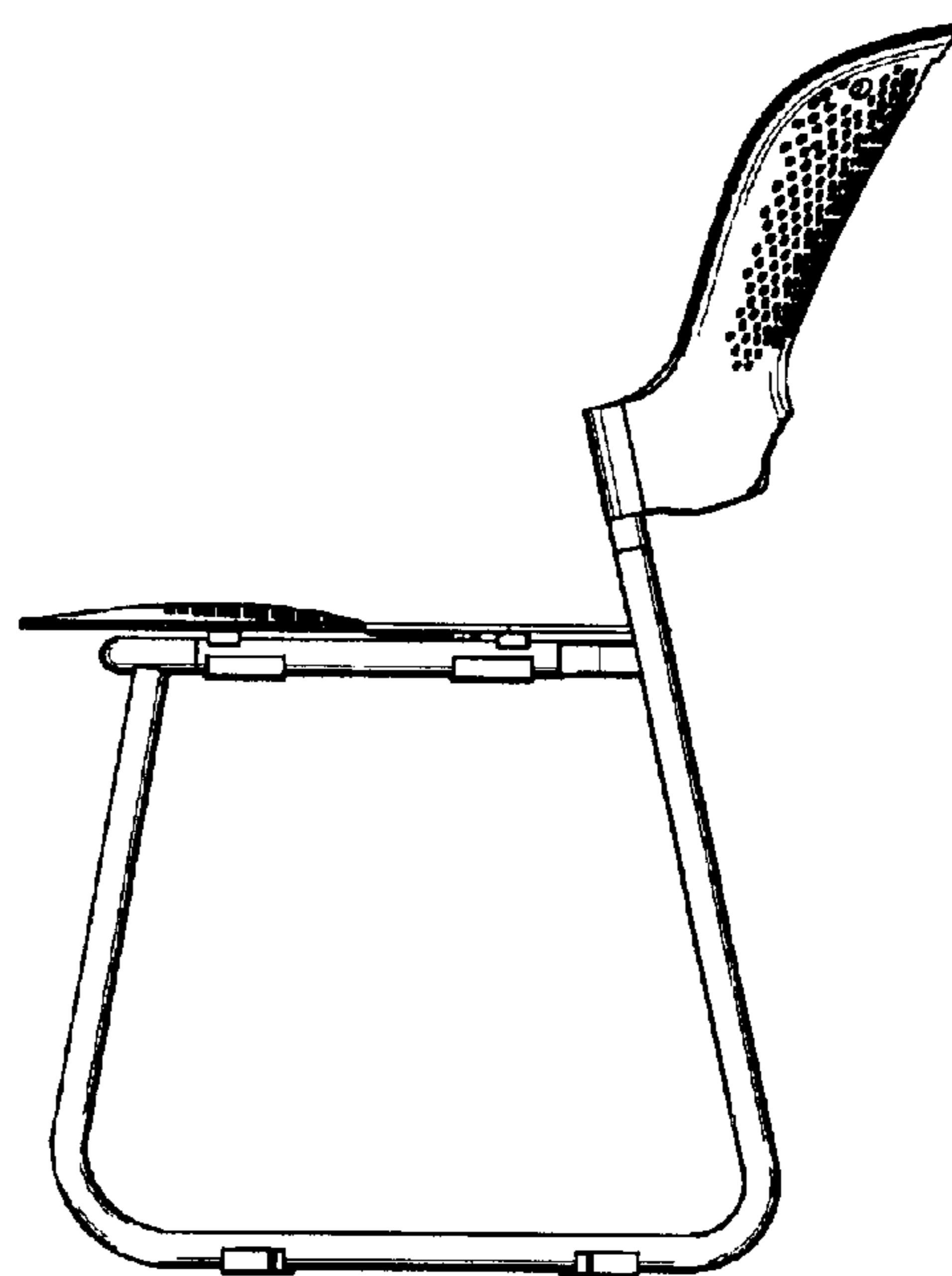

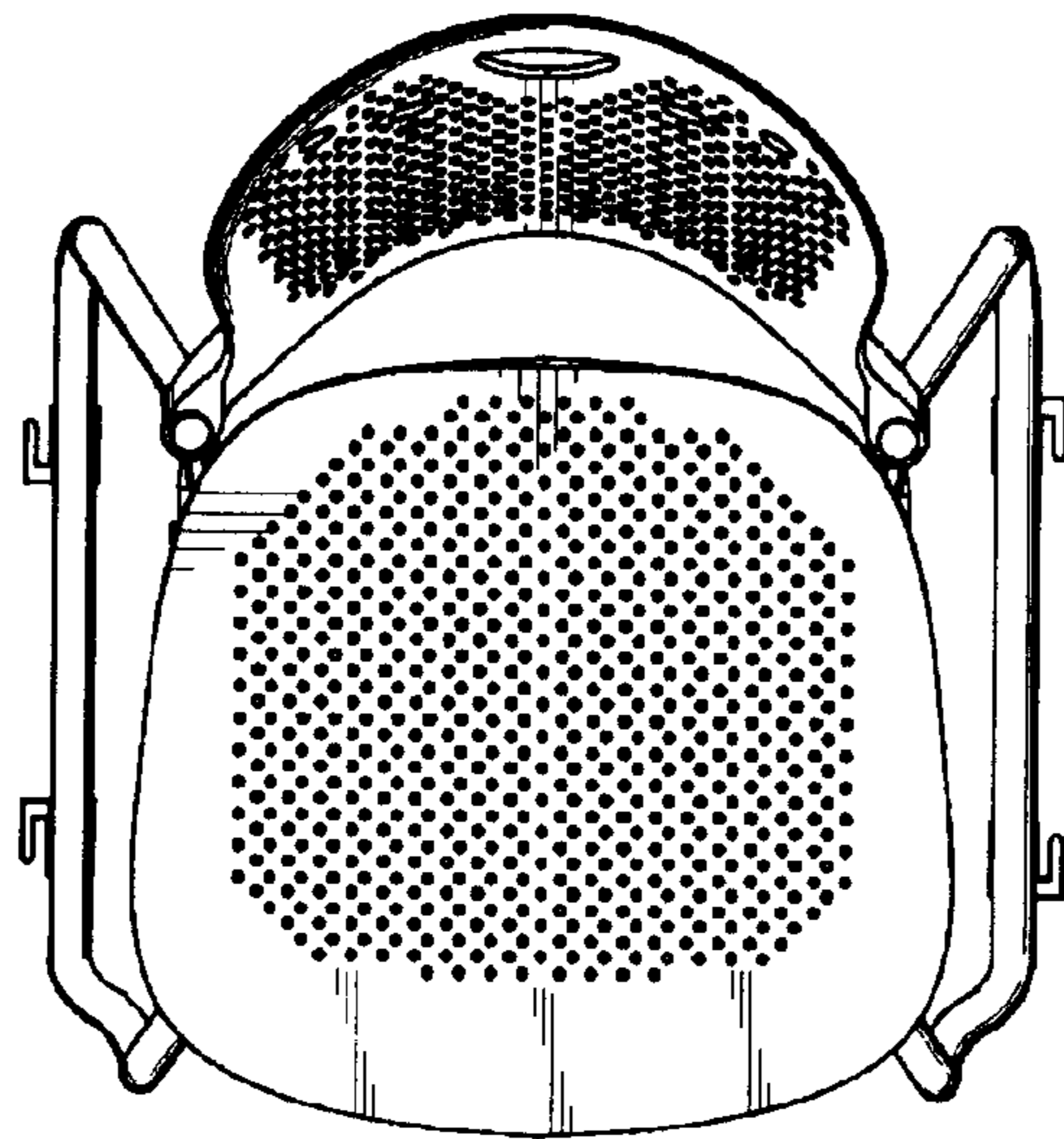

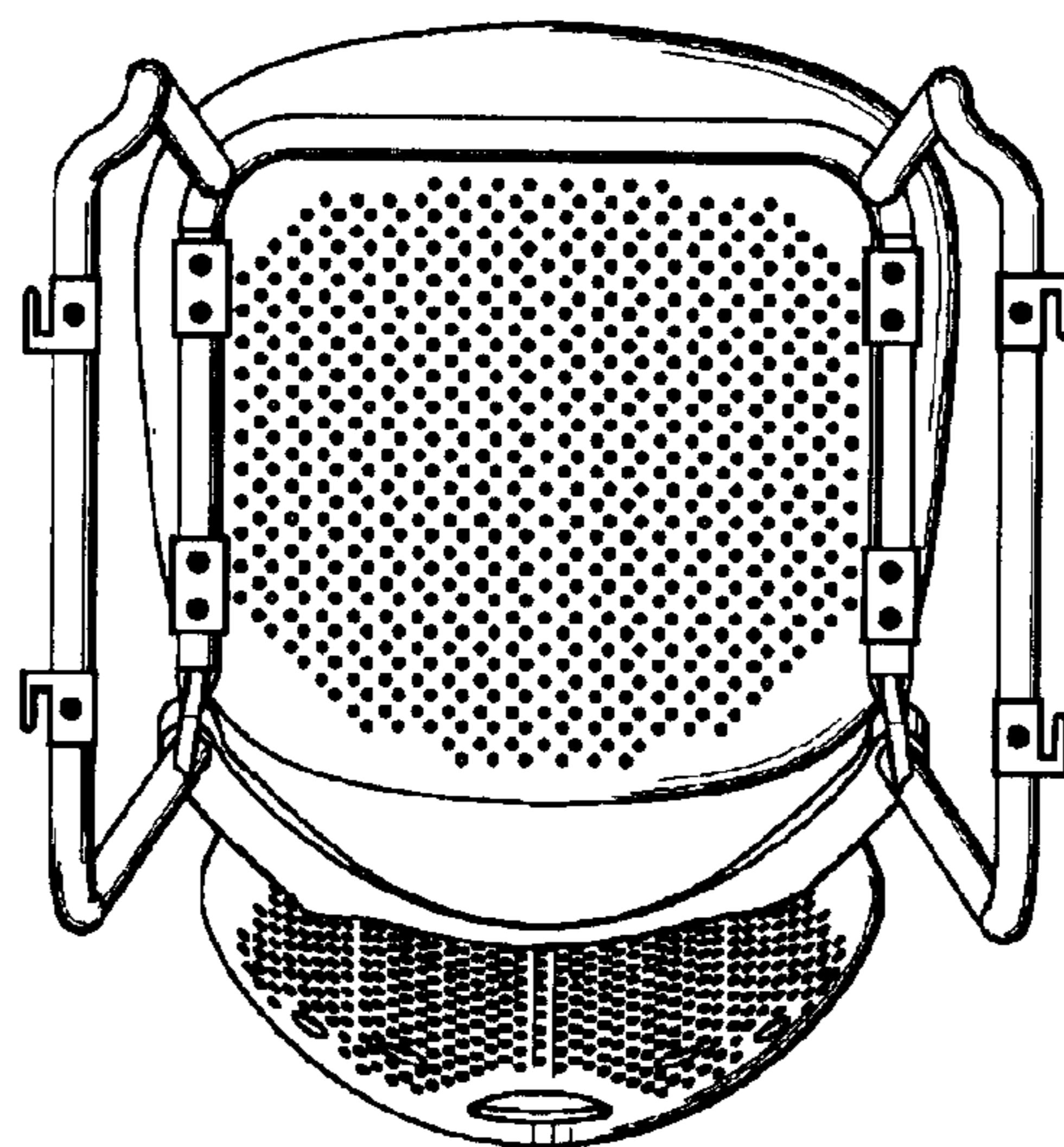
