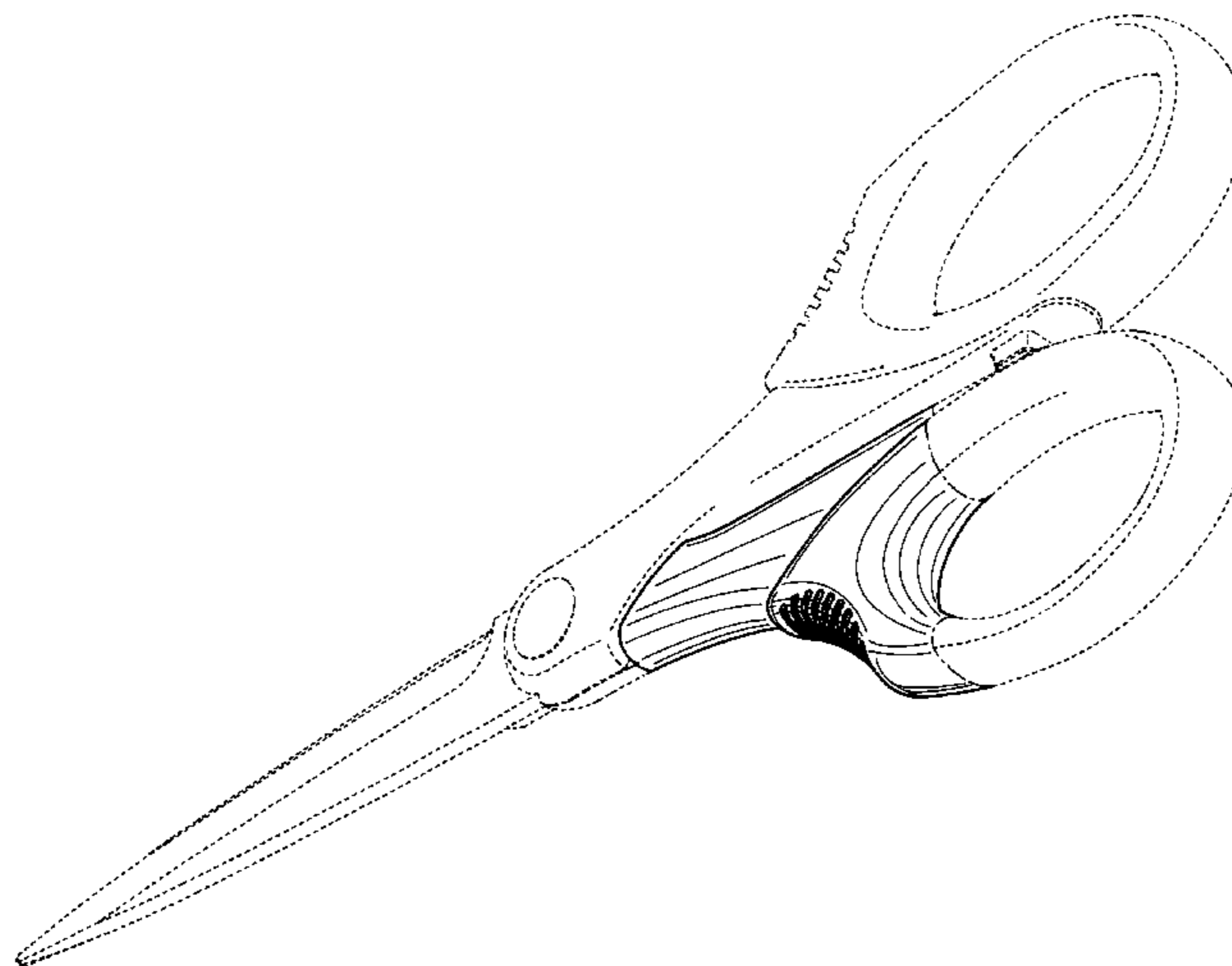
The ornamental design for a pair of scissors, as shown and described.

**DESCRIPTION**

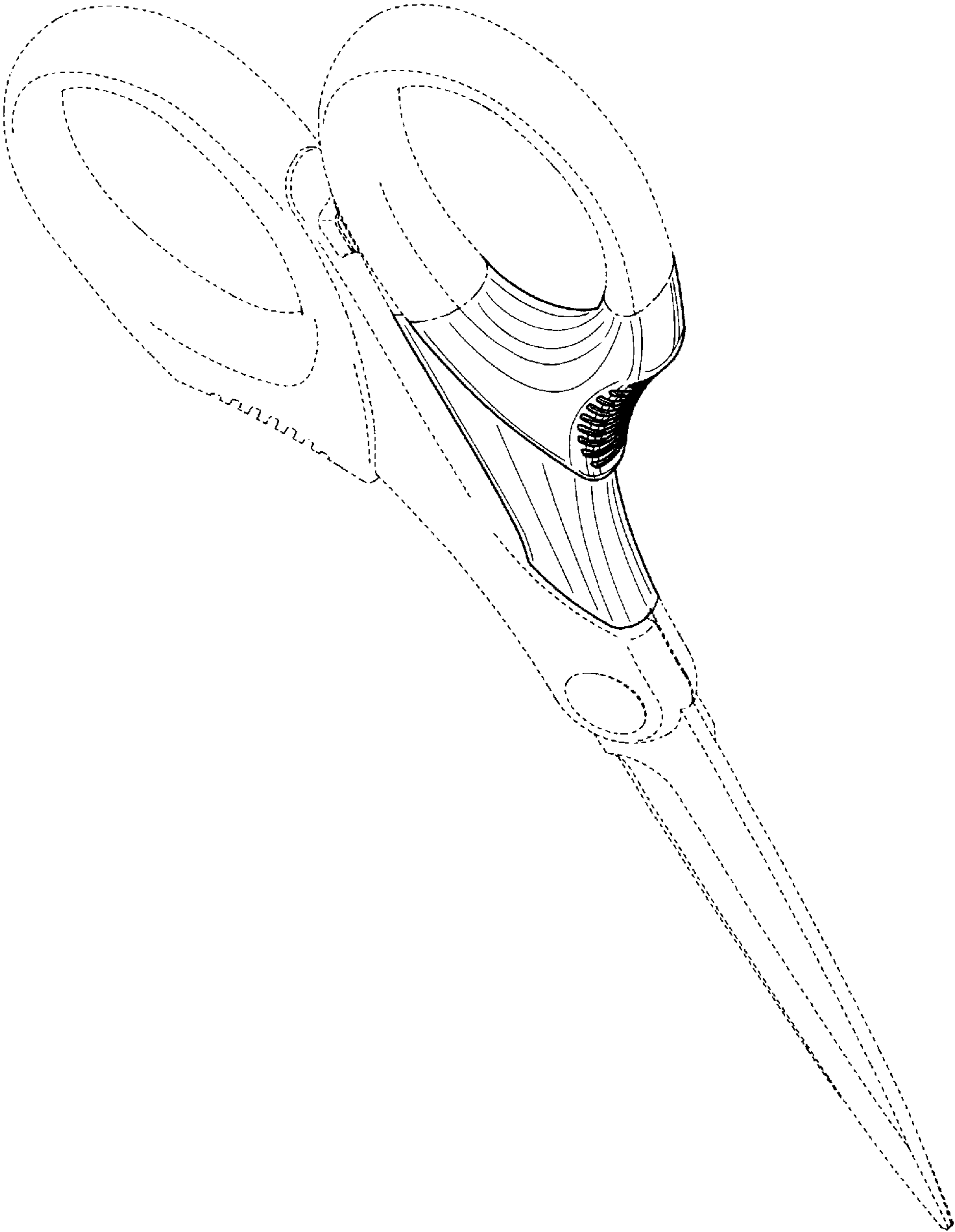
FIG. 1 is a perspective view of a pair of scissors according to a first embodiment of my new design;

The broken lines in FIGS. 1 through 16 are shown for illustrative purposes only and form no part of the claimed design.

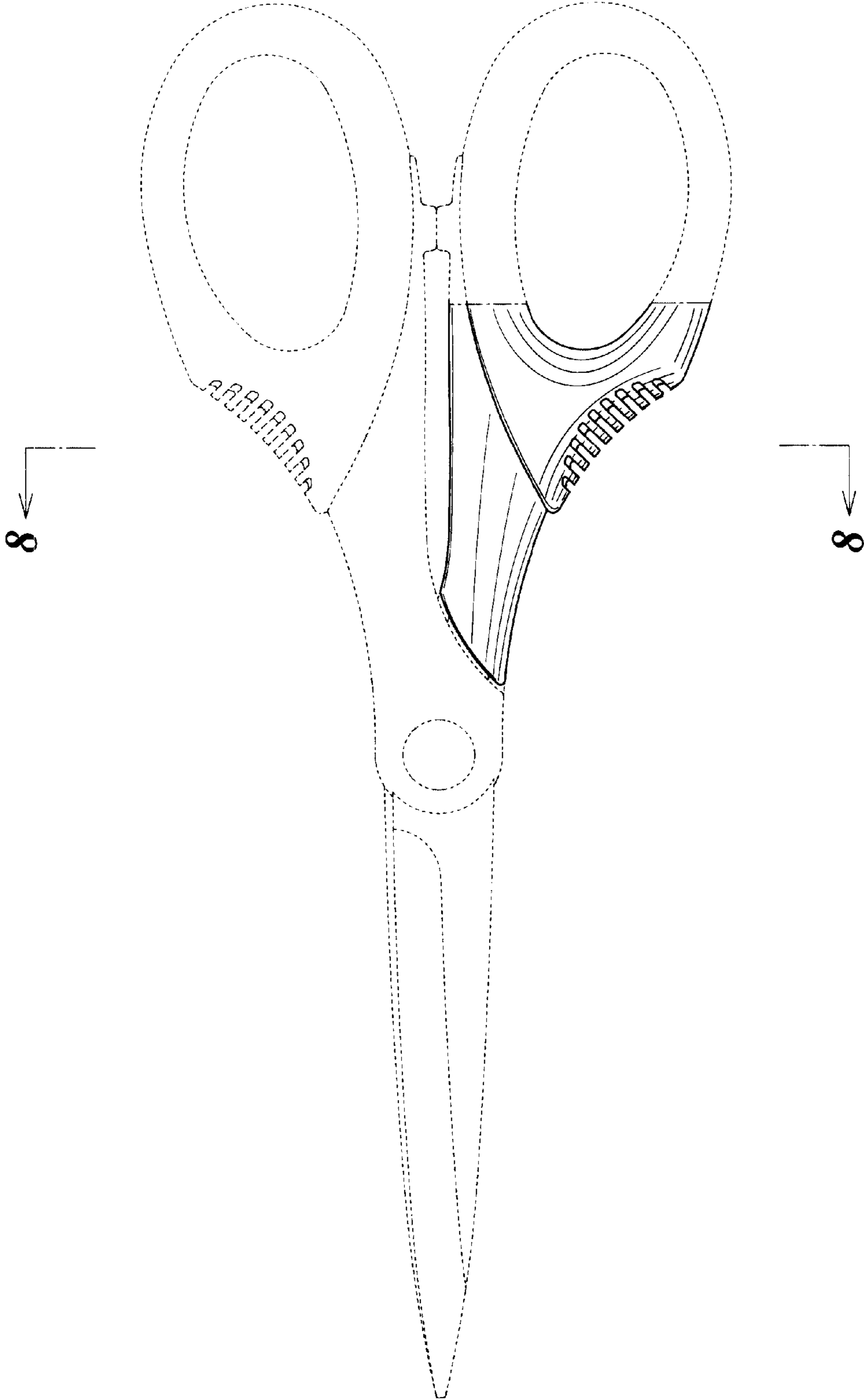

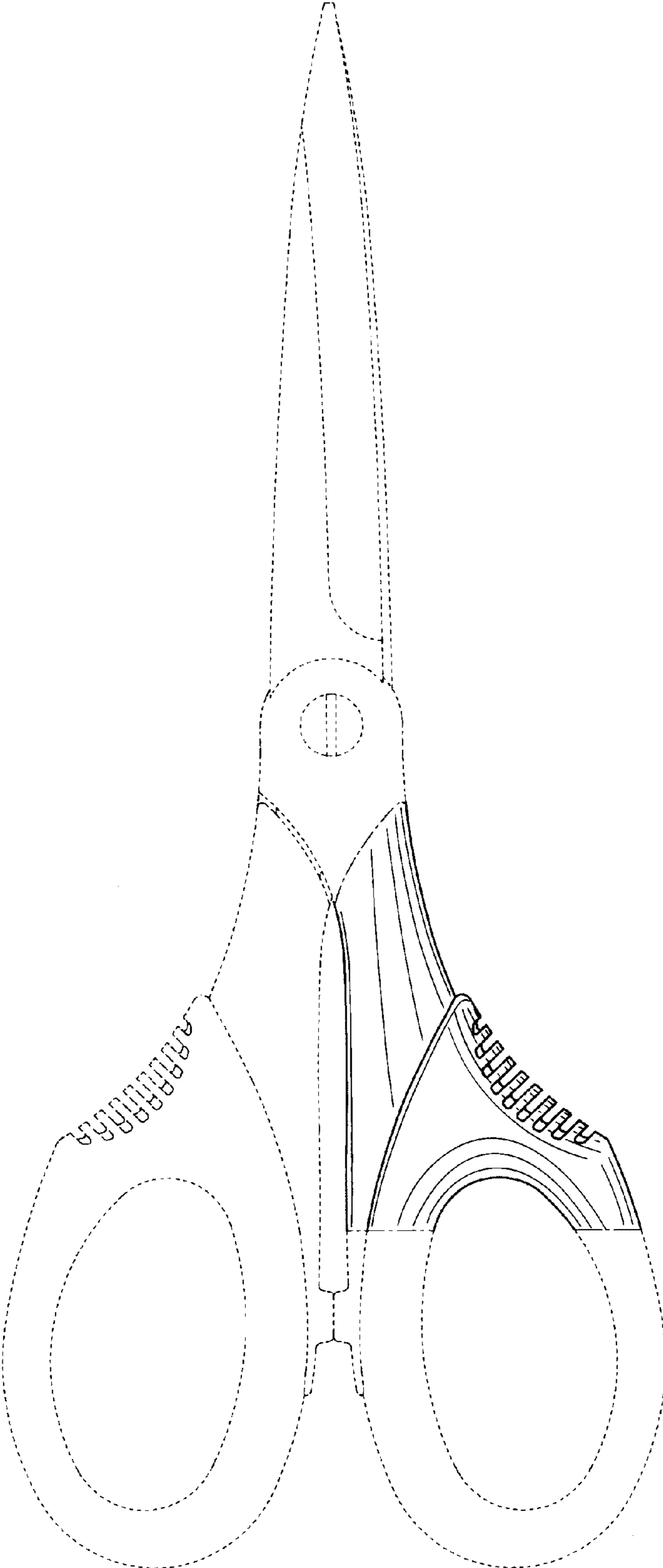

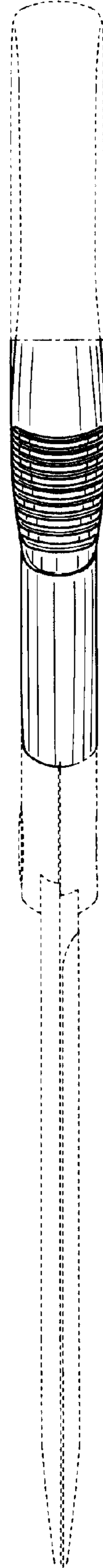

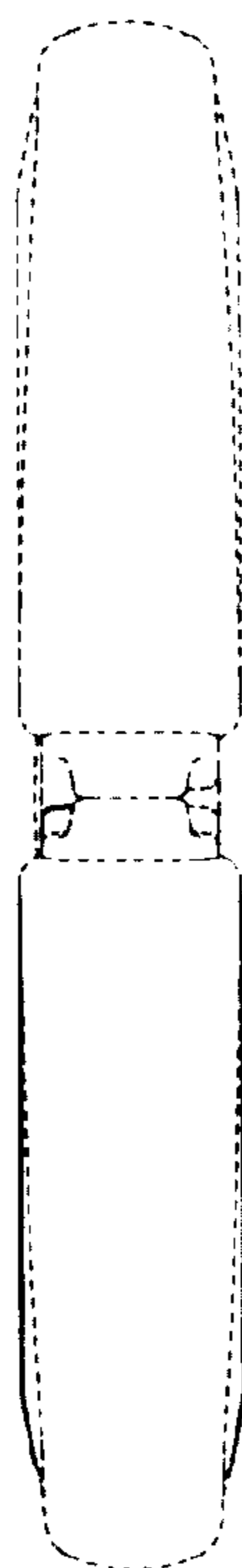

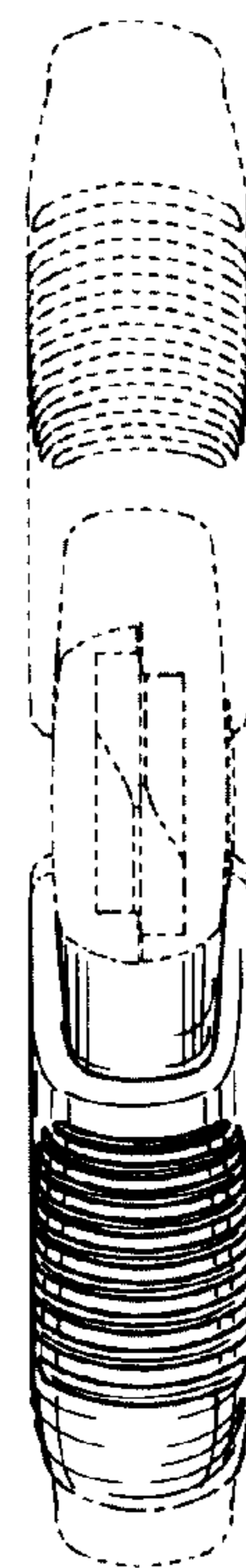

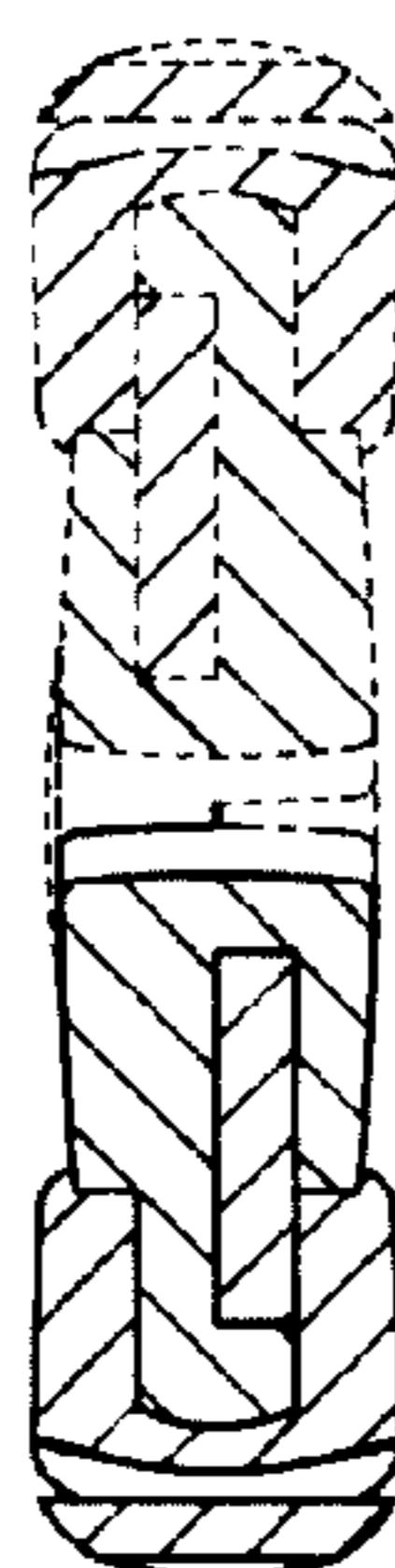

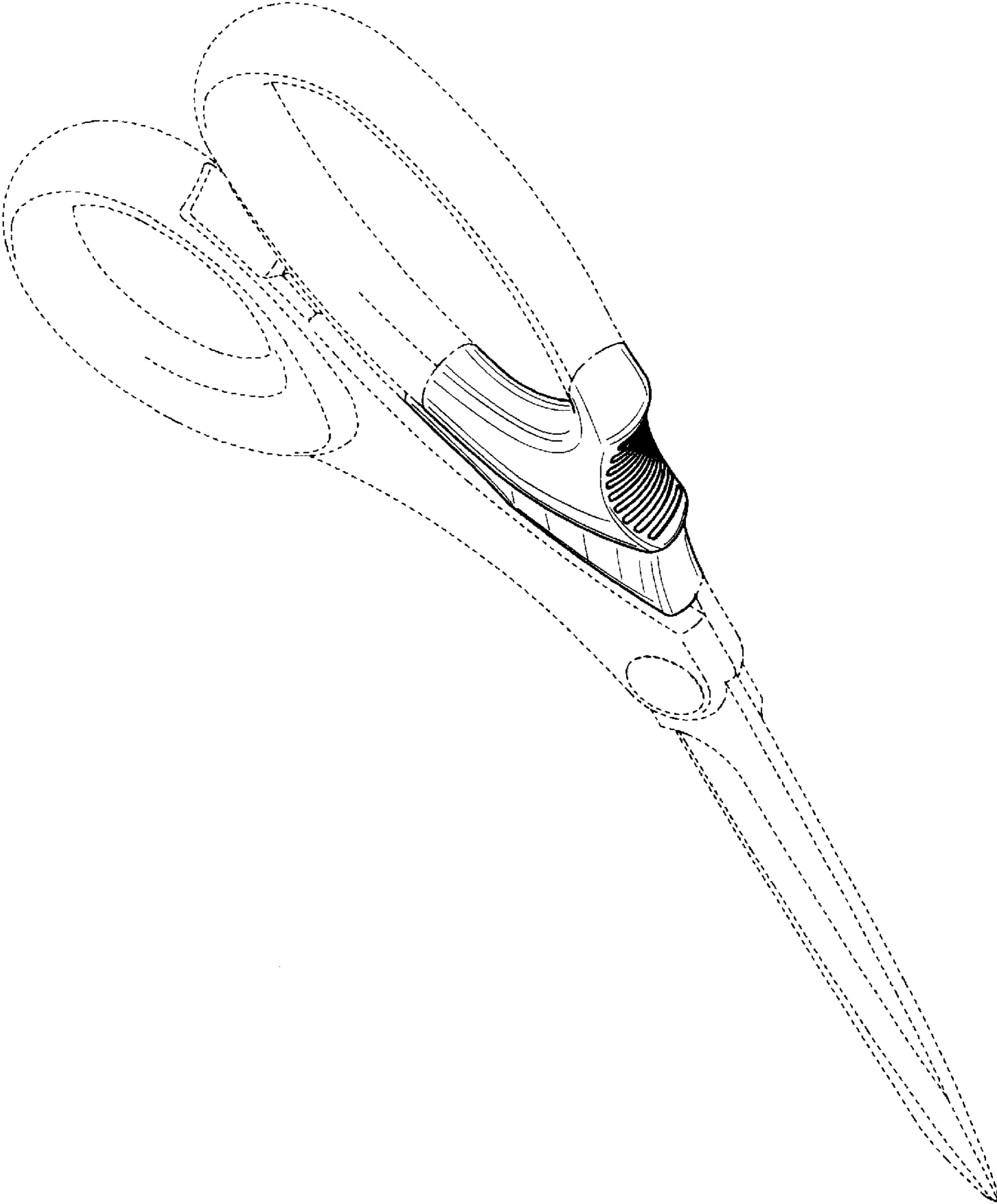

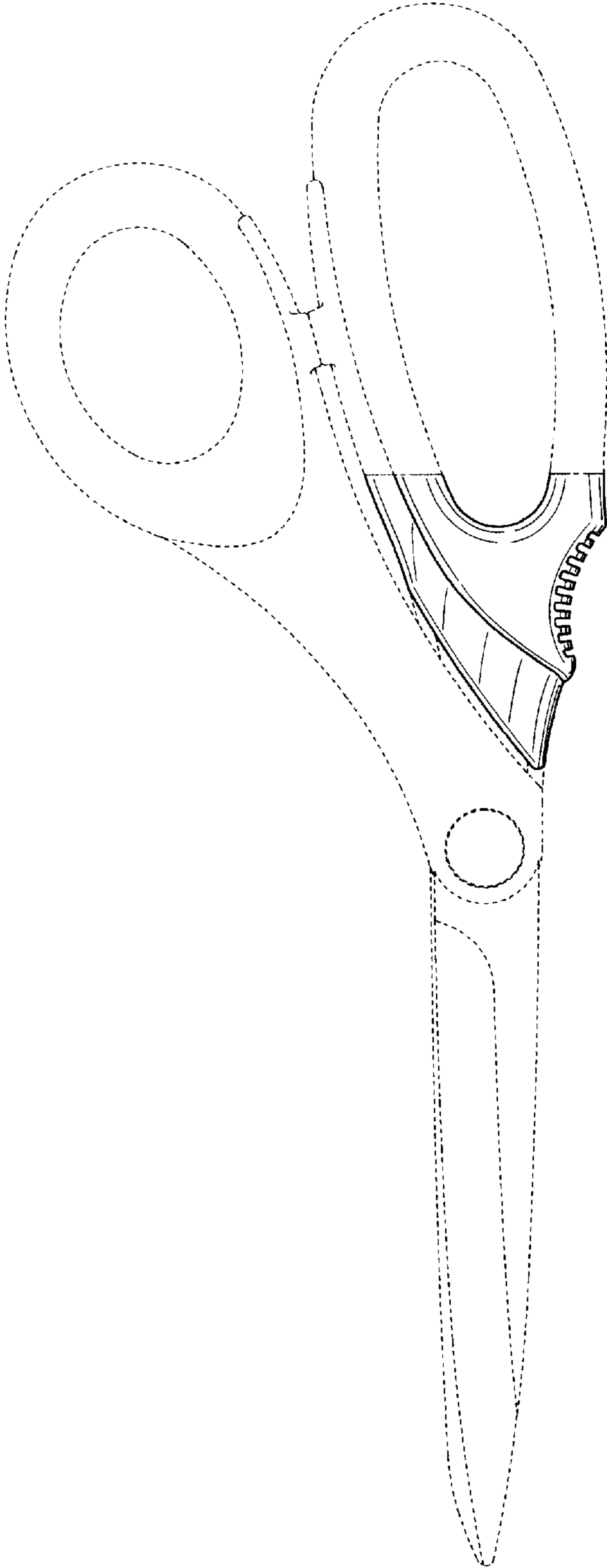

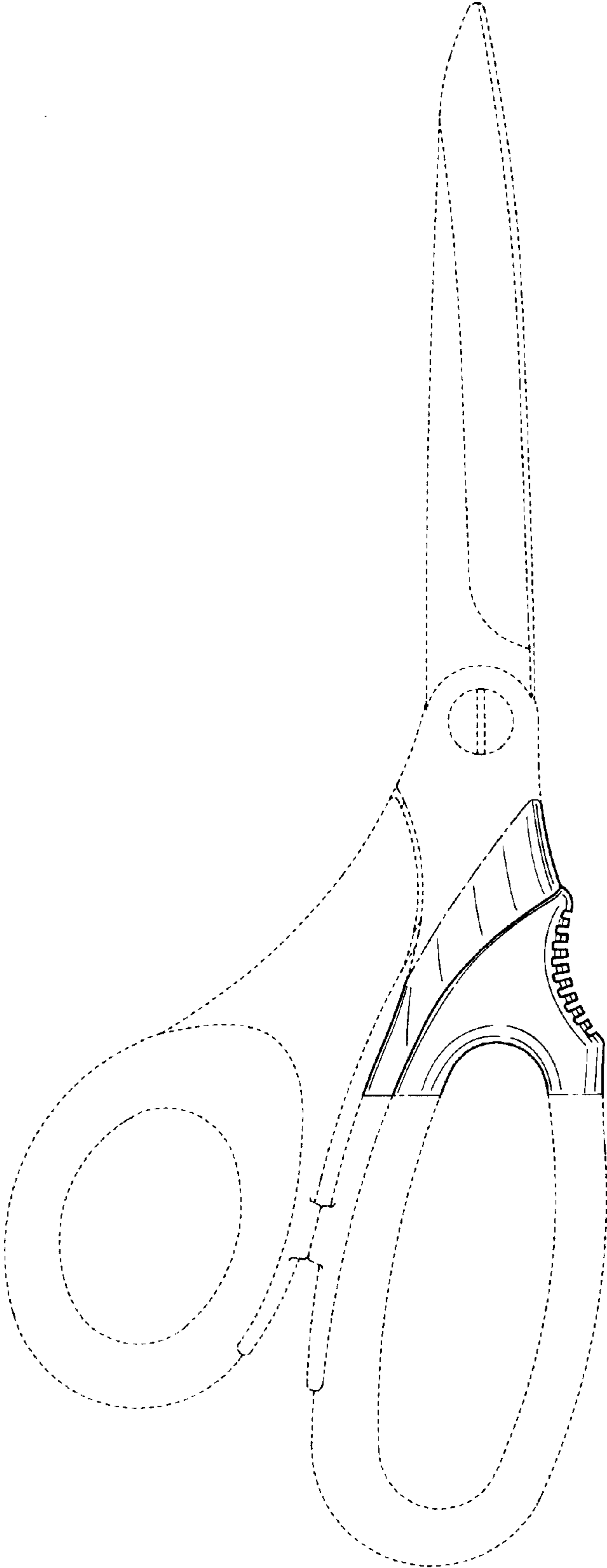

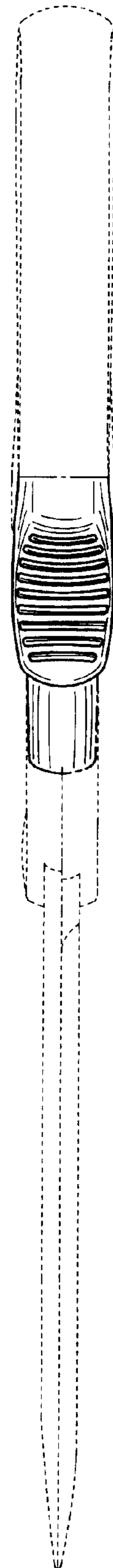

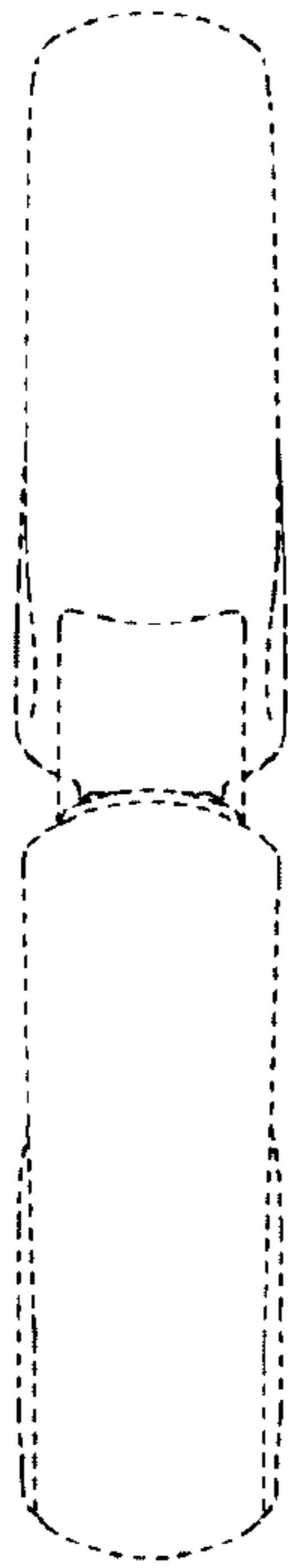
