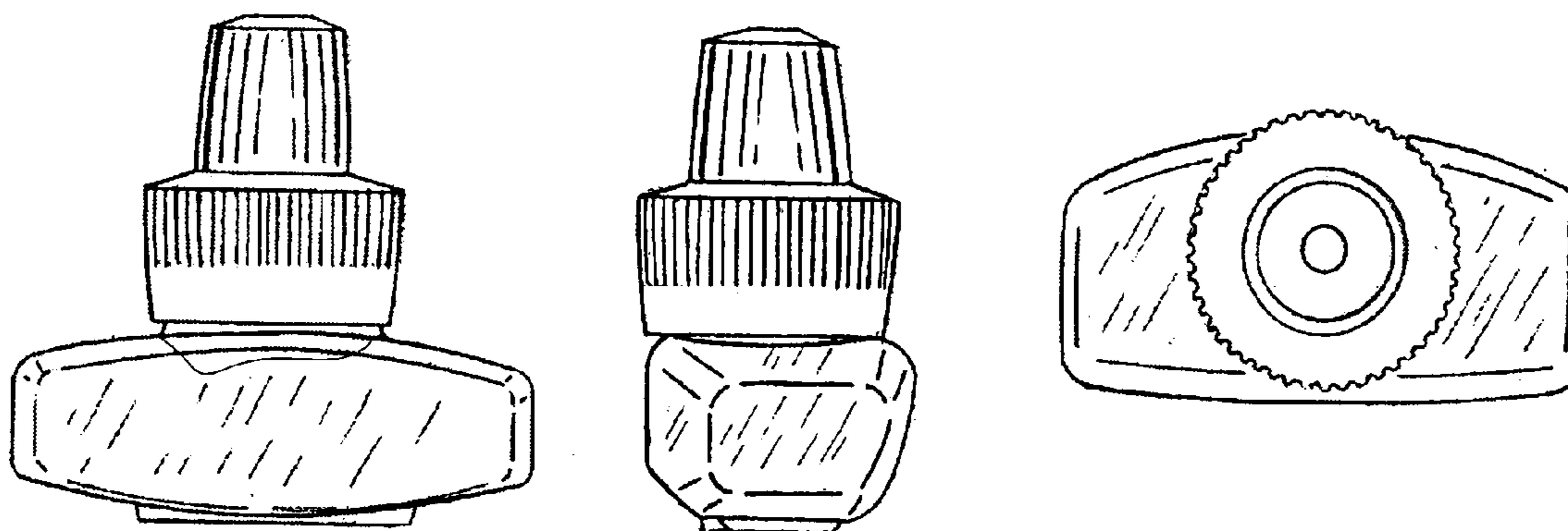
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a bottle comprising the present invention;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a side elevational view thereof;
FIG. 5 is an opposite side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

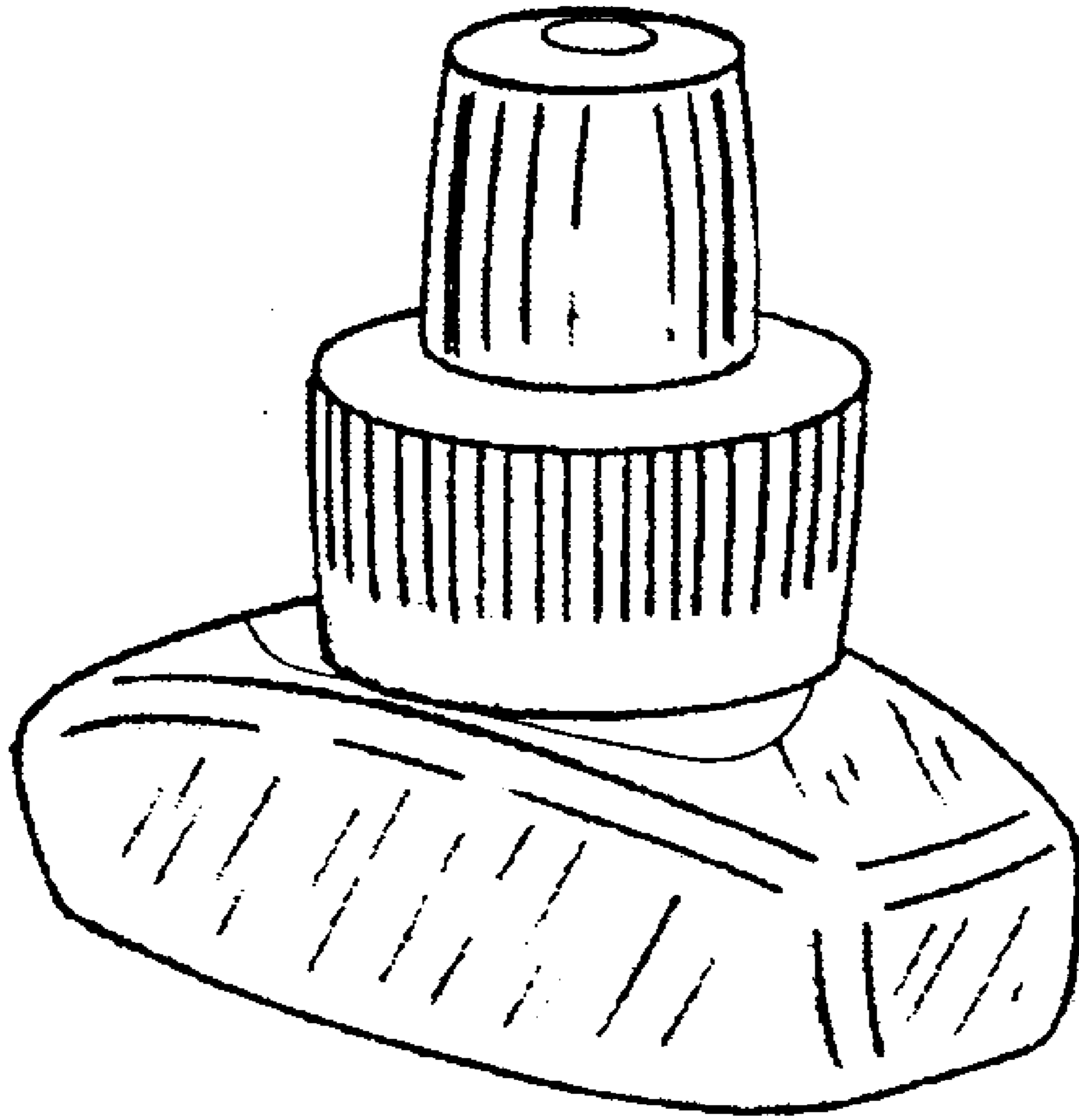

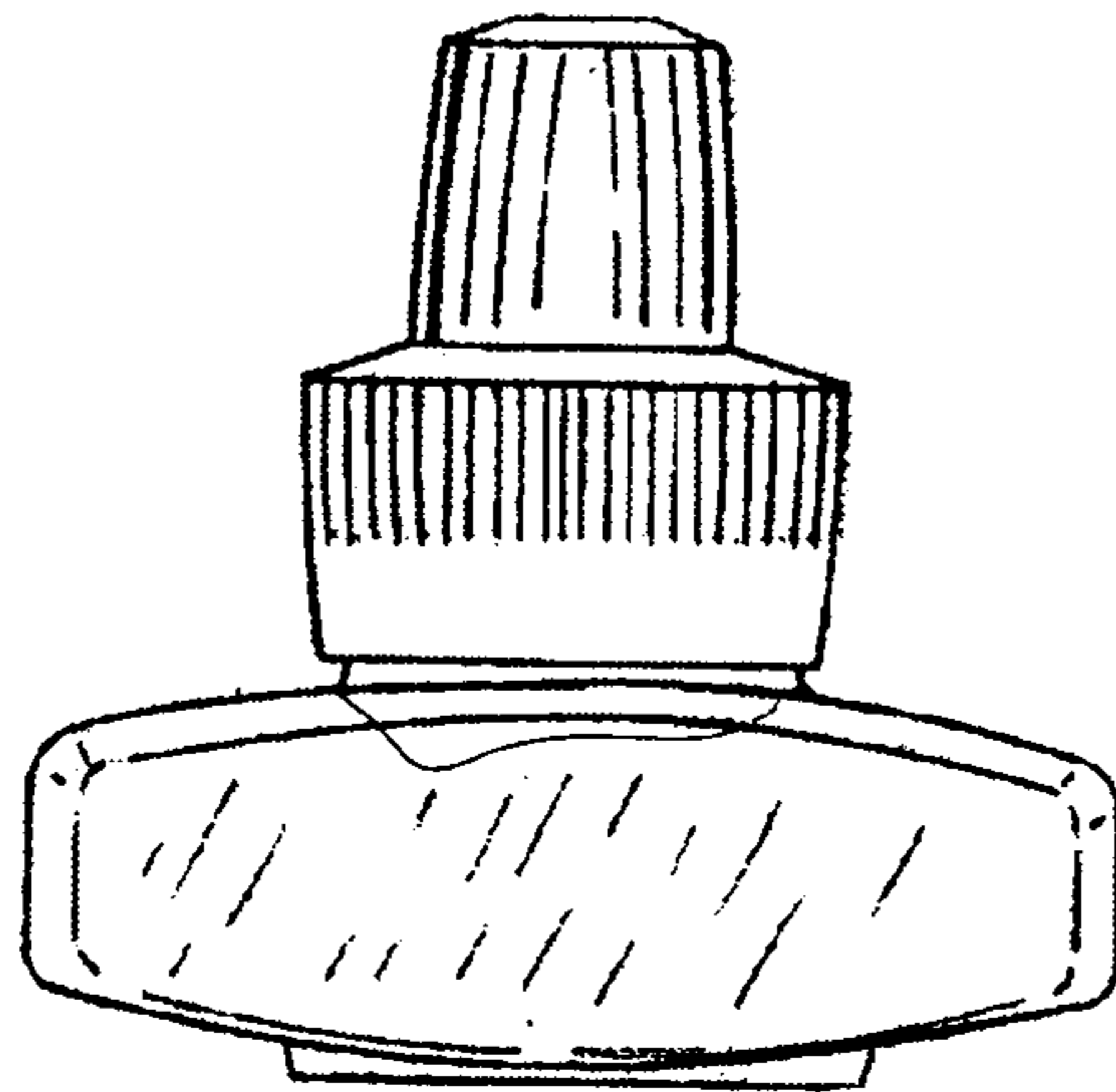

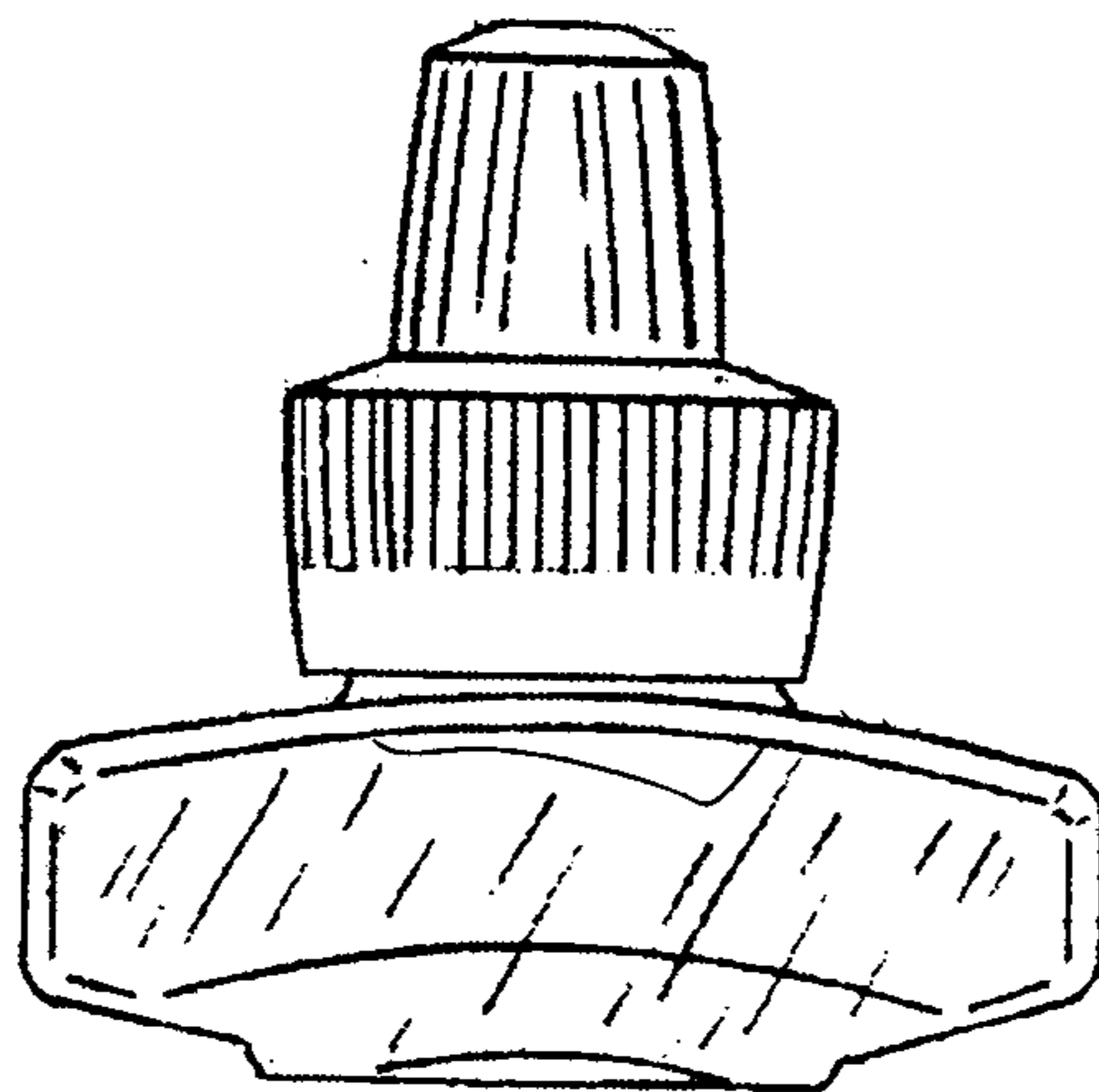

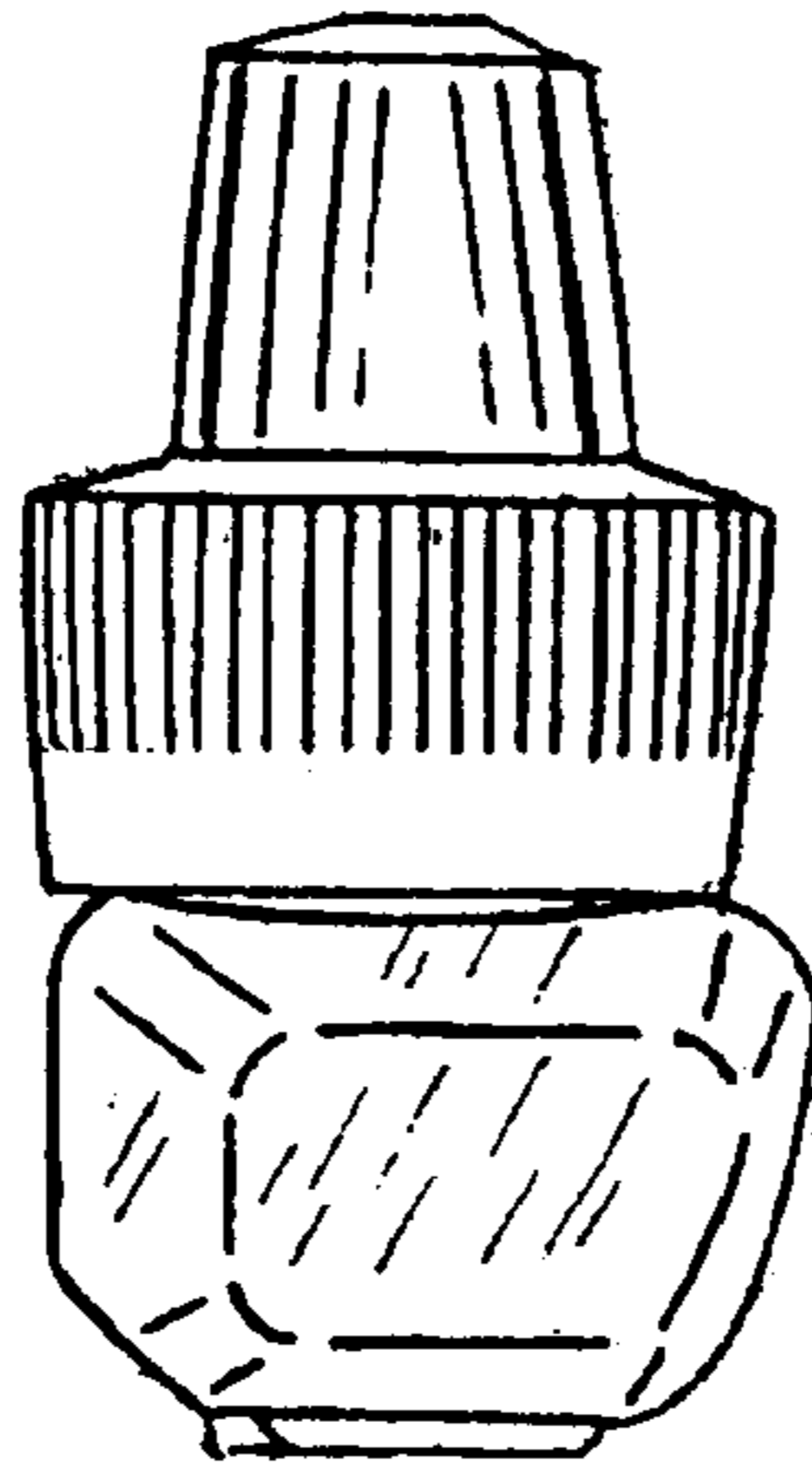

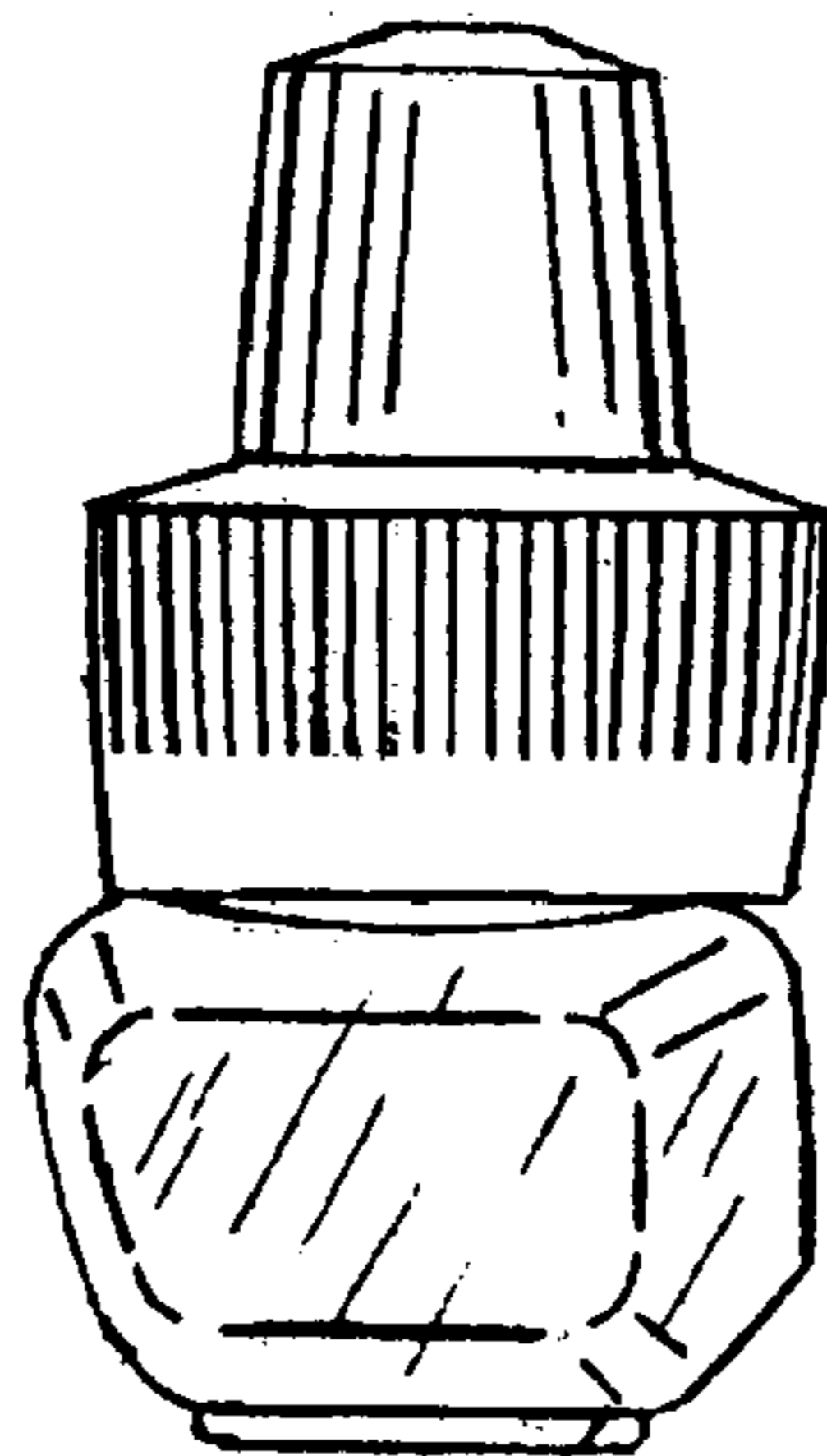

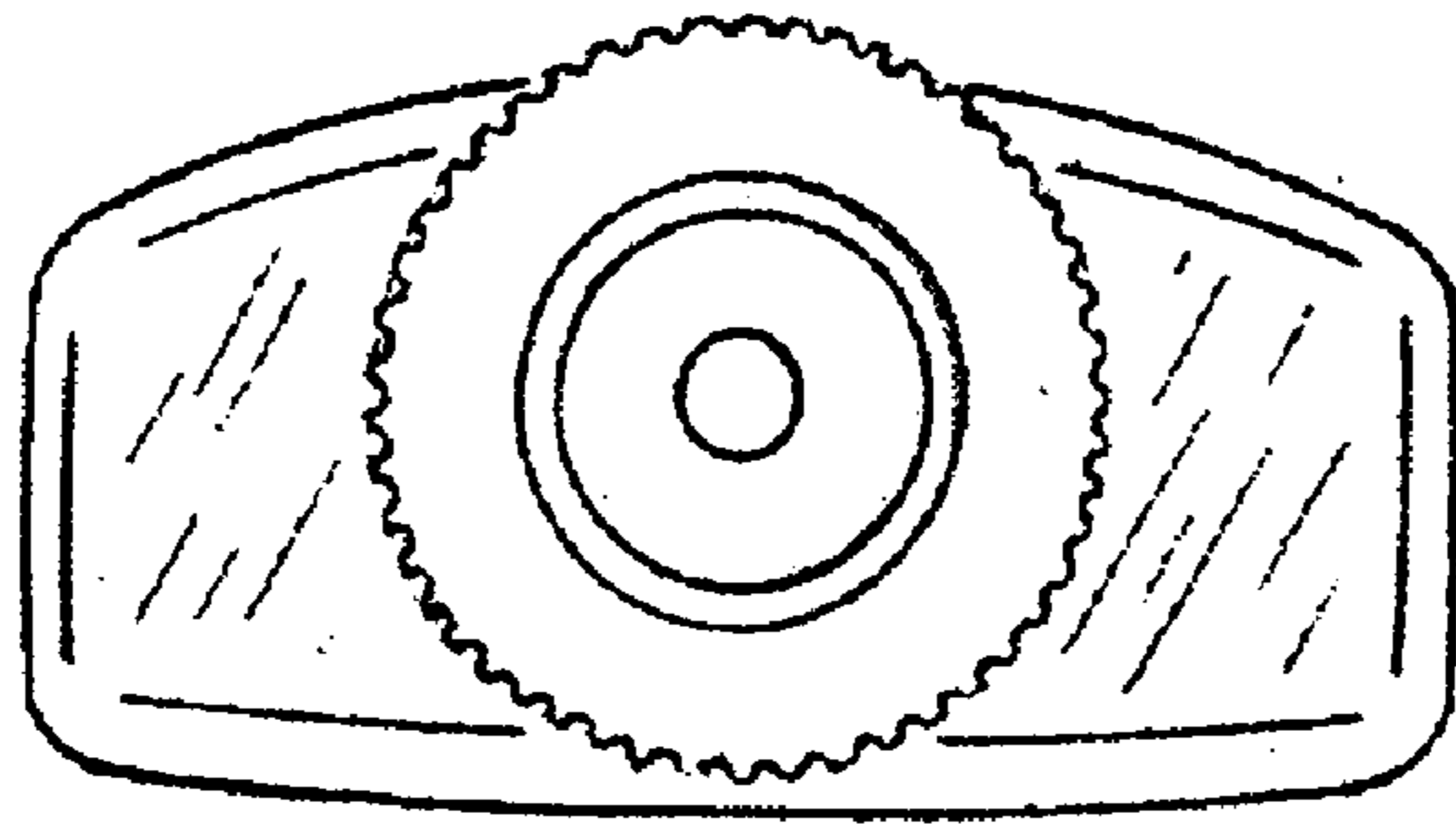

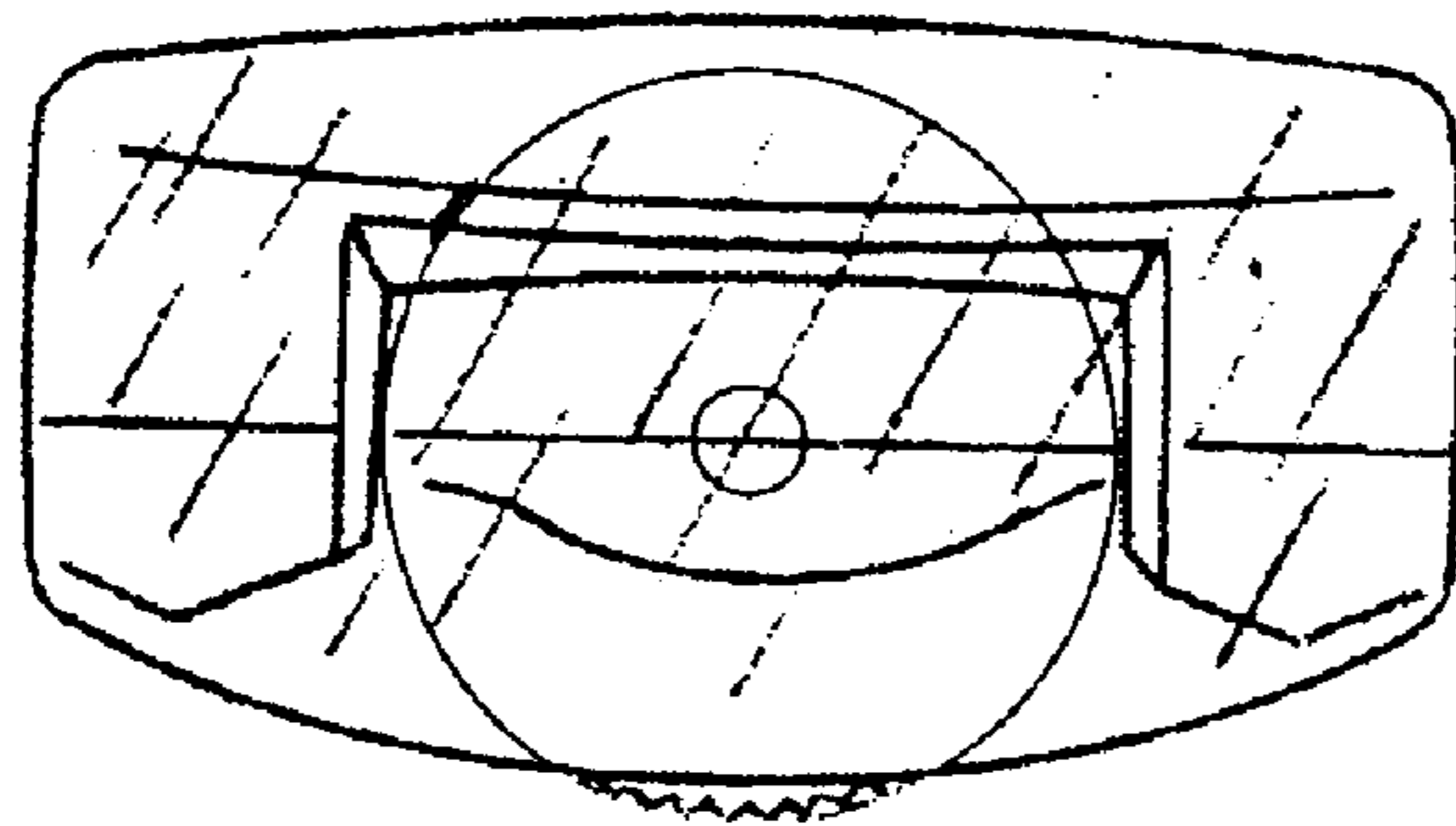
