DESCRIPTION

FIG. 1 is a perspective view of a combined bottle and cap embodying the new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a side elevational view thereof, opposite the side elevational view shown in FIG. 2; and,
FIG. 4 is a top plan view thereof.

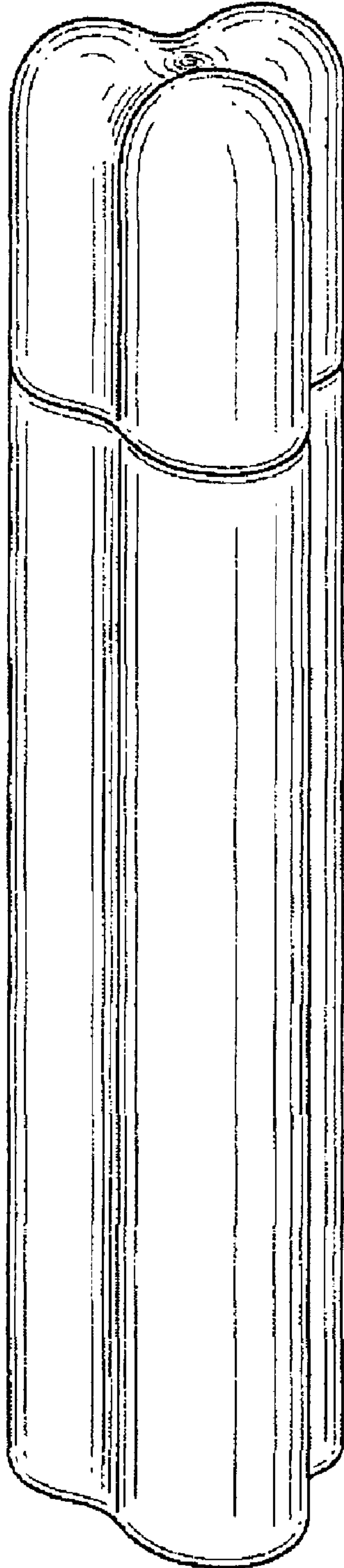

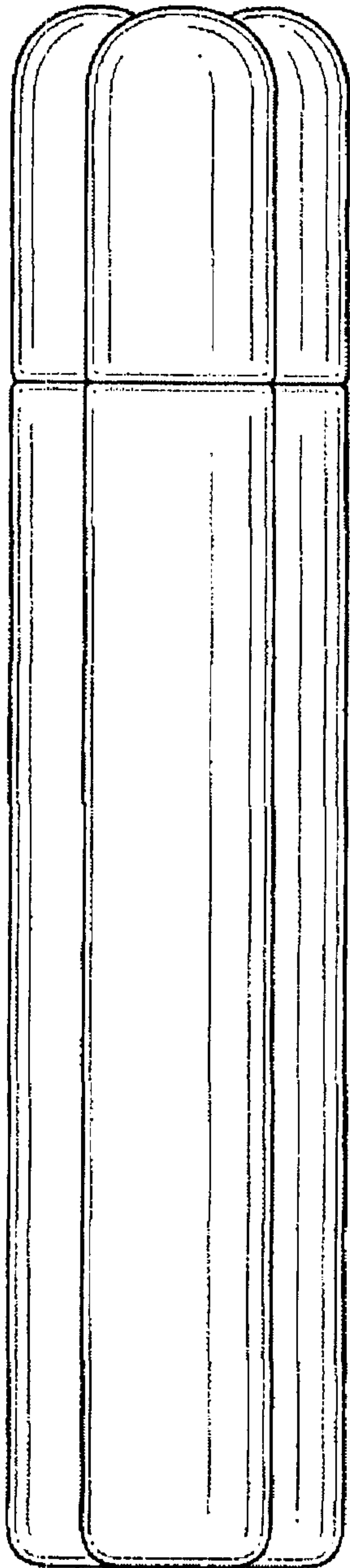

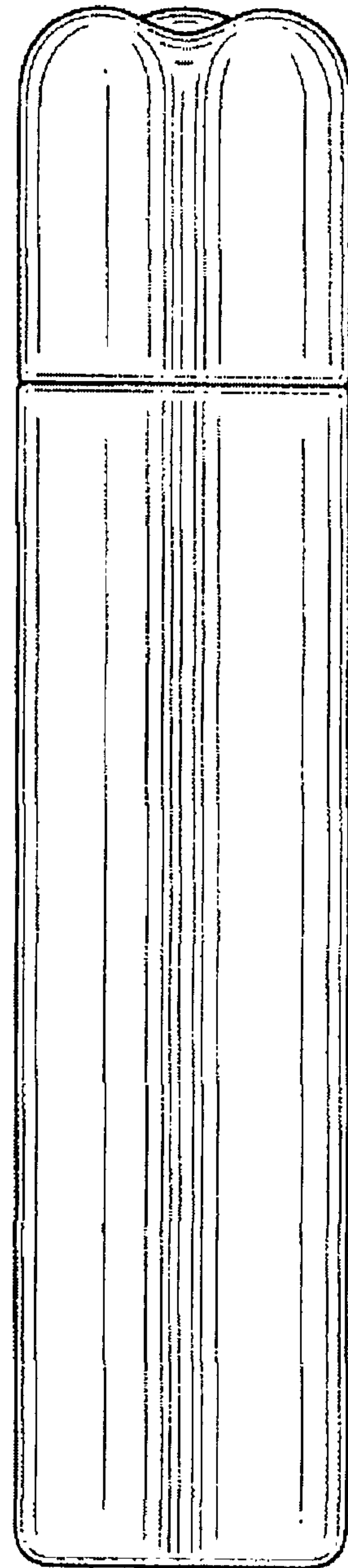
